**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a pontoon guard showing my new design;

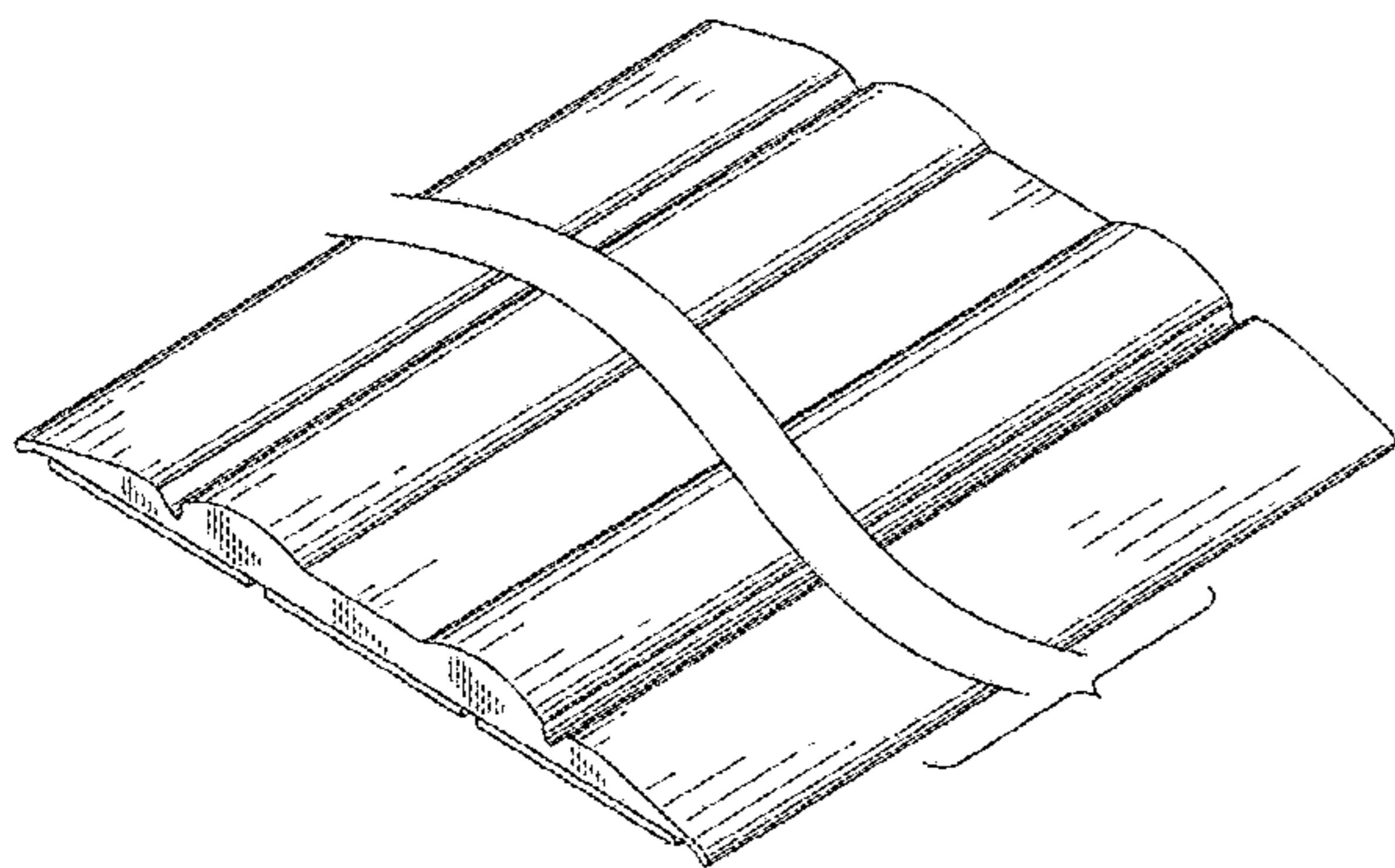
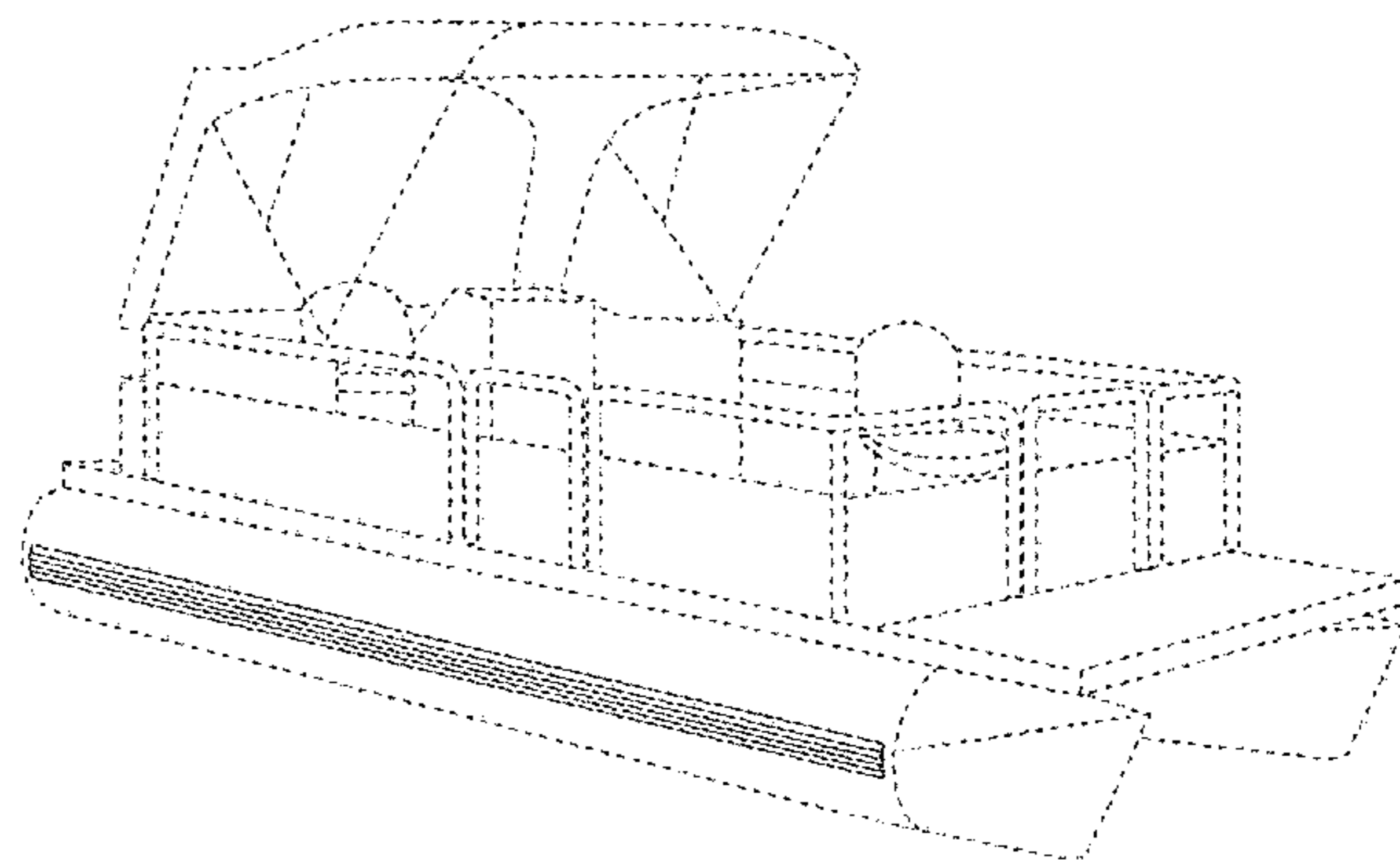


FIG. 2 is a left elevation view of the pontoon guard shown in FIG. 1;  
 FIG. 3 is a right elevation view of the pontoon guard shown in FIG. 1;  
 FIG. 4 is a front elevation view of the pontoon guard shown in FIG. 1;  
 FIG. 5 is a rear elevation view of the pontoon guard shown in FIG. 1;  
 FIG. 6 is a top plan view of the pontoon guard shown in FIG. 1;  
 FIG. 7 is a bottom plan view of the pontoon guard shown in FIG. 1;  
 FIG. 8 is a reduced perspective view of the pontoon guard as shown in FIG. 1 applied to a portion of an outer surface of a pontoon;  
 FIG. 9 is a front perspective view of a second embodiment of a pontoon guard showing my new design having a reflective center strip along the outer surface;  
 FIG. 10 is a left elevation view of the pontoon guard shown in FIG. 9;  
 FIG. 11 is a right elevation view of the pontoon guard shown in FIG. 9;  
 FIG. 12 is a front elevation view of the pontoon guard shown in FIG. 9;  
 FIG. 13 is a rear elevation view of the pontoon guard shown in FIG. 9;  
 FIG. 14 is a top plan view of the pontoon guard shown in FIG. 9;  
 FIG. 15 is a bottom plan view of the pontoon guard shown in FIG. 9; and,  
 FIG. 16 is a reduced perspective view of the pontoon guard as shown in FIG. 9 applied to a portion of an outer surface of a pontoon.  
 FIGS. 1-3, 6, 7, 9-11, 14 & 15 are shown separated for ease and clarity of illustration.  
 The broken lines in FIGS. 8 & 16 represent the environment in which the article resides and forms no part of the claimed design.

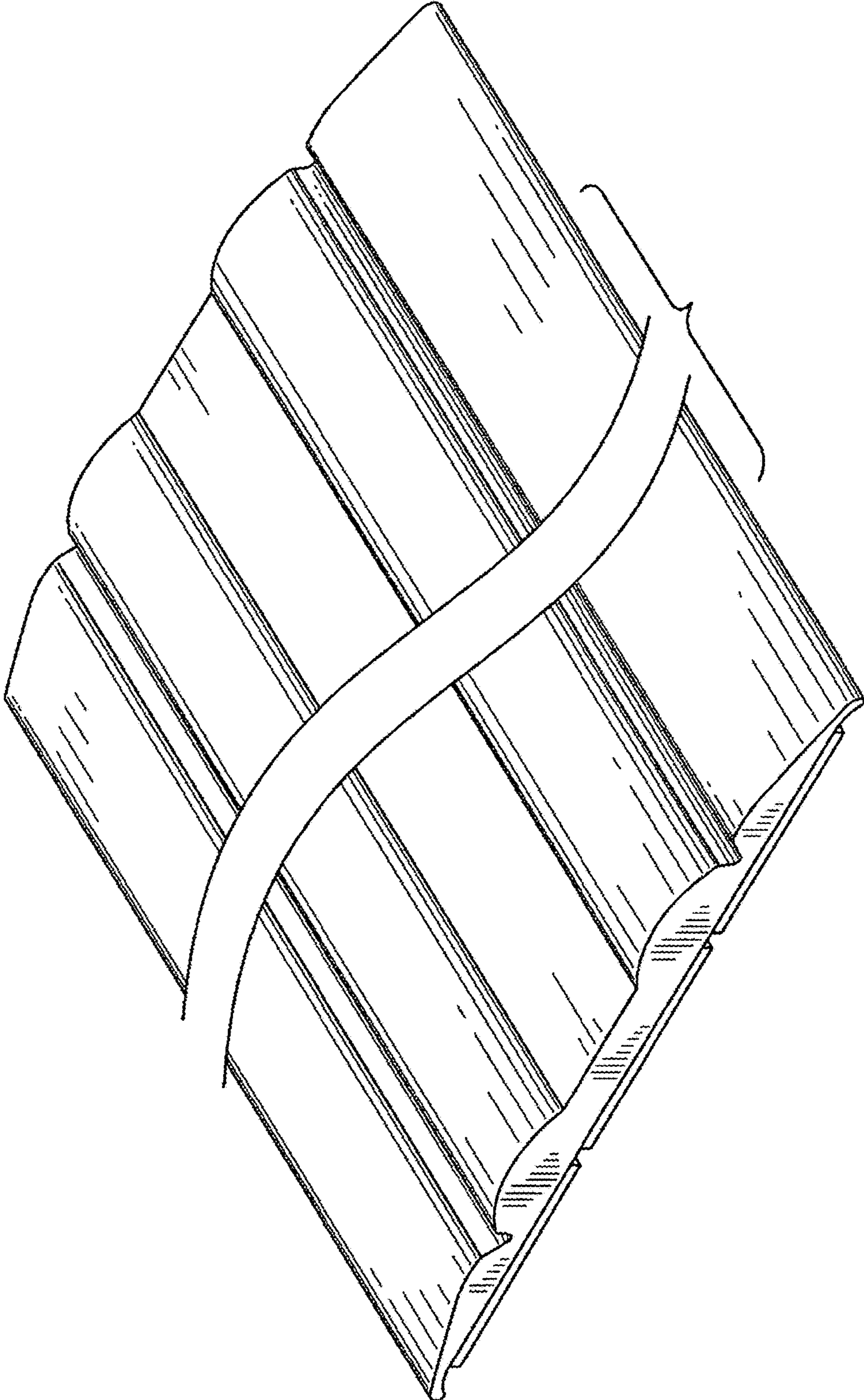

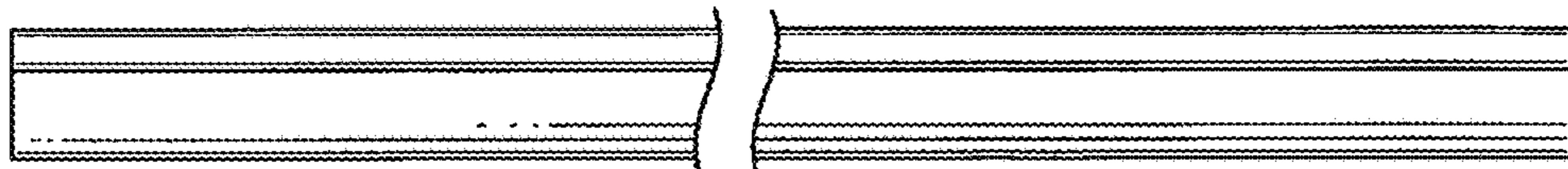

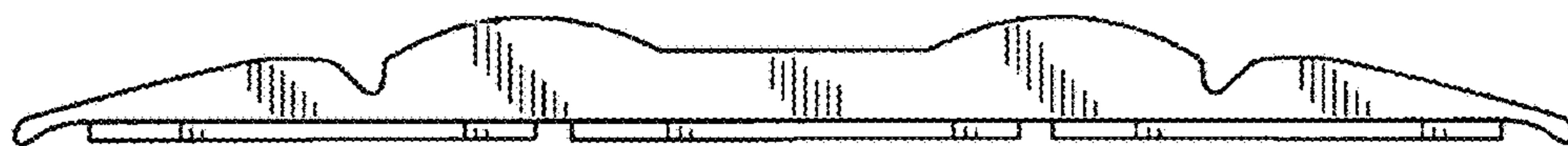

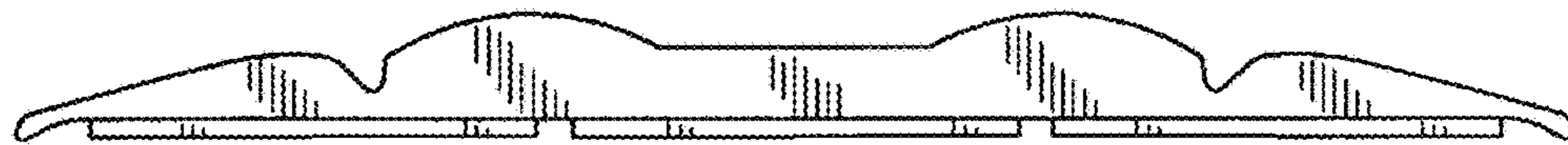

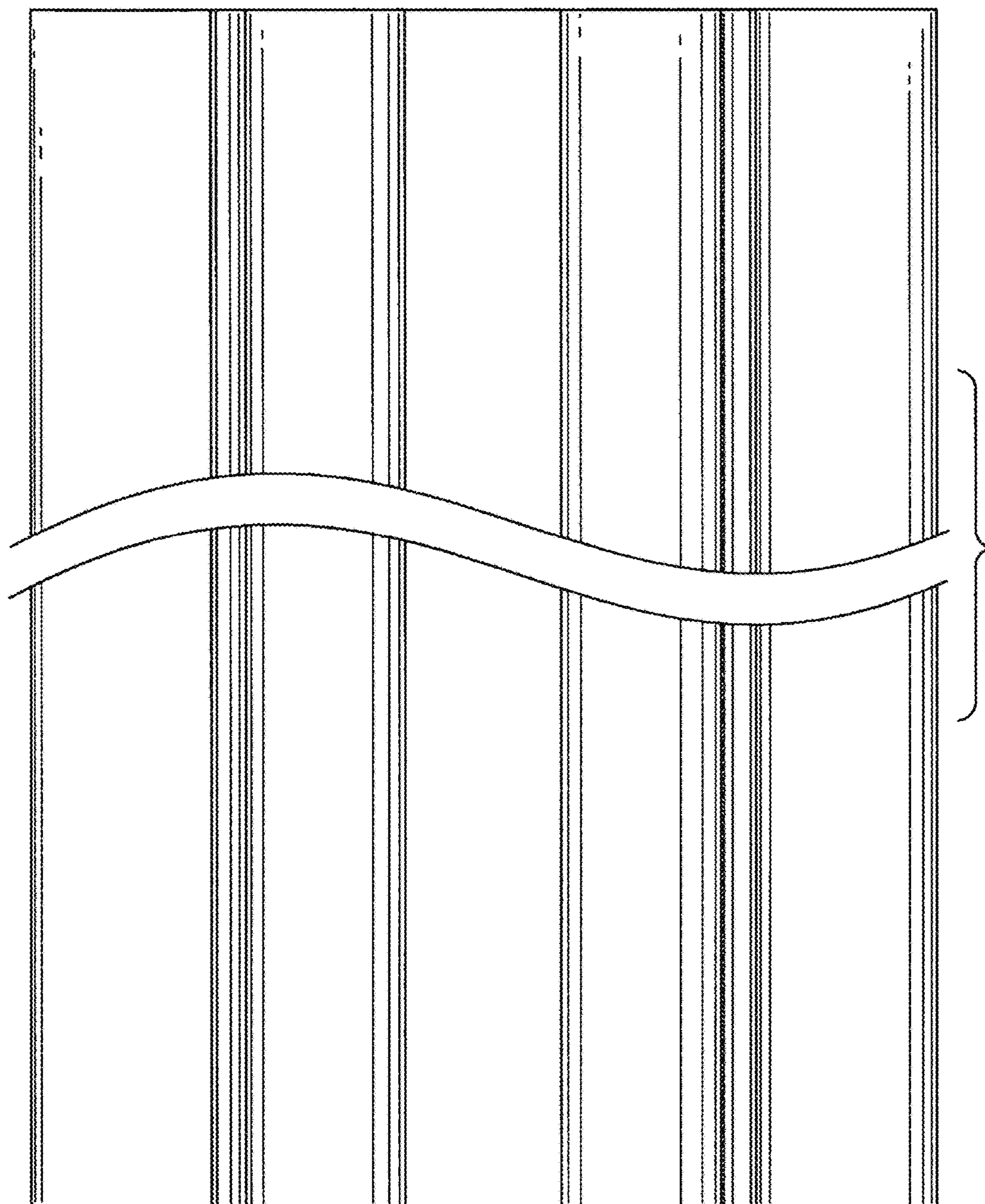

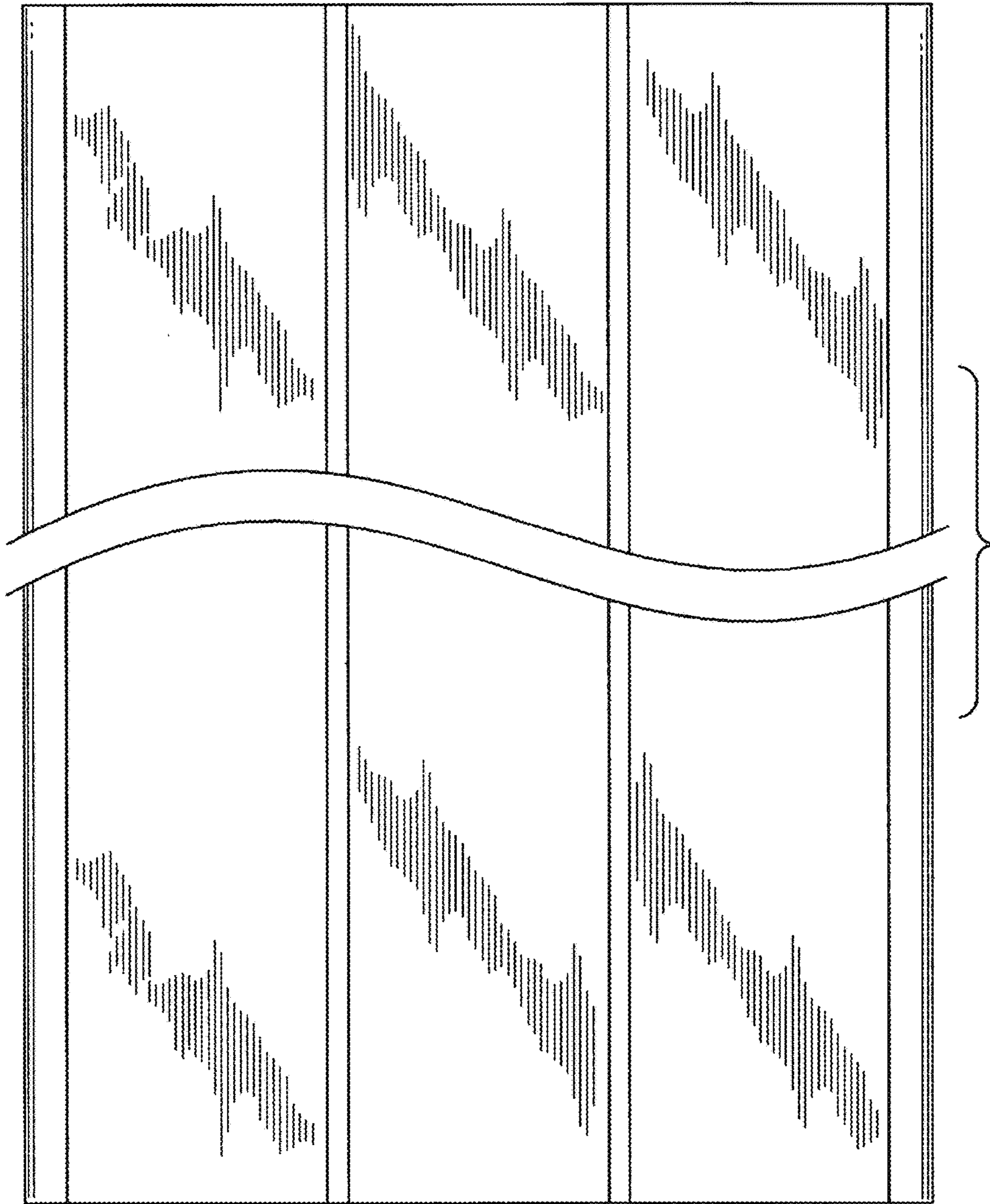

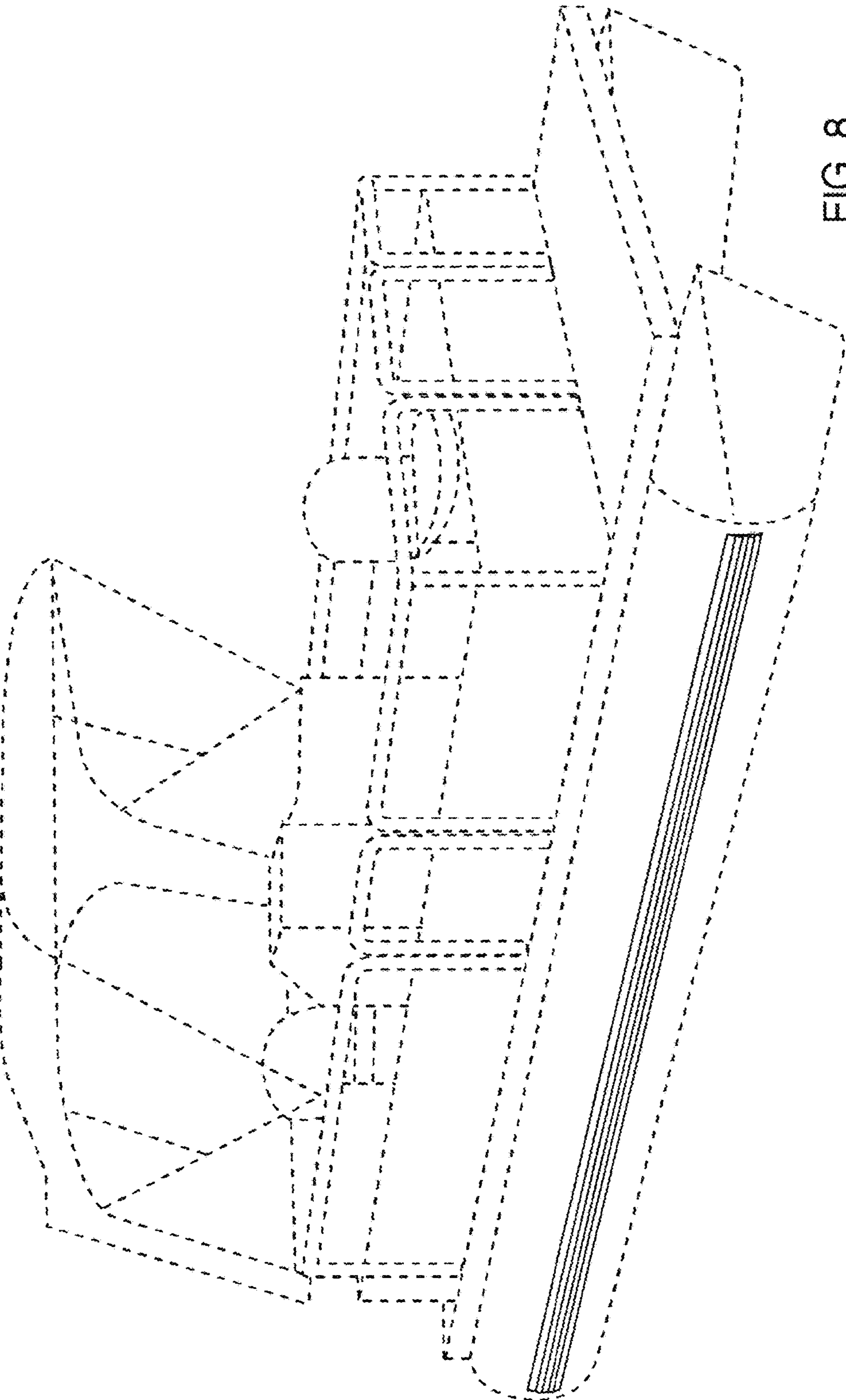

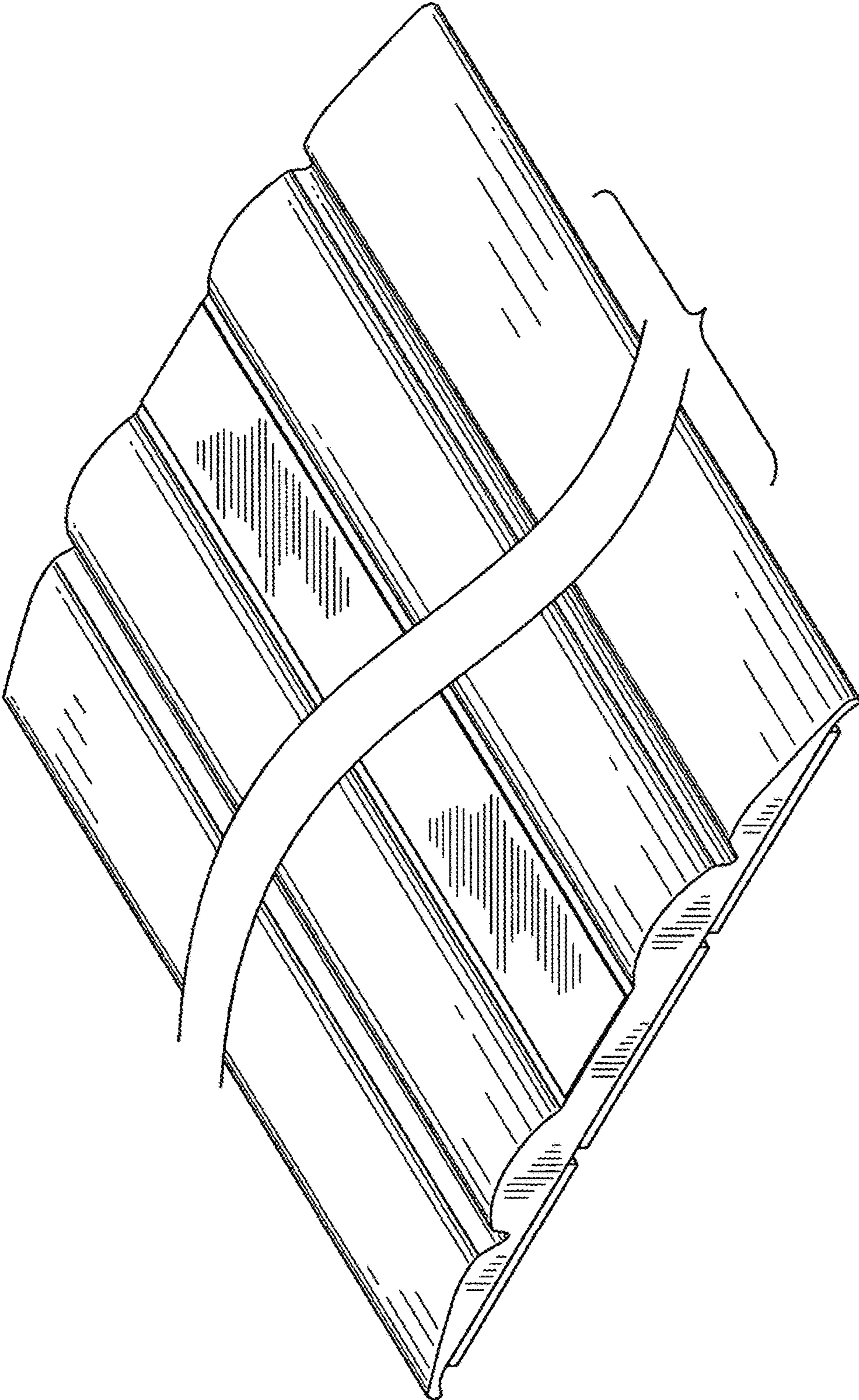

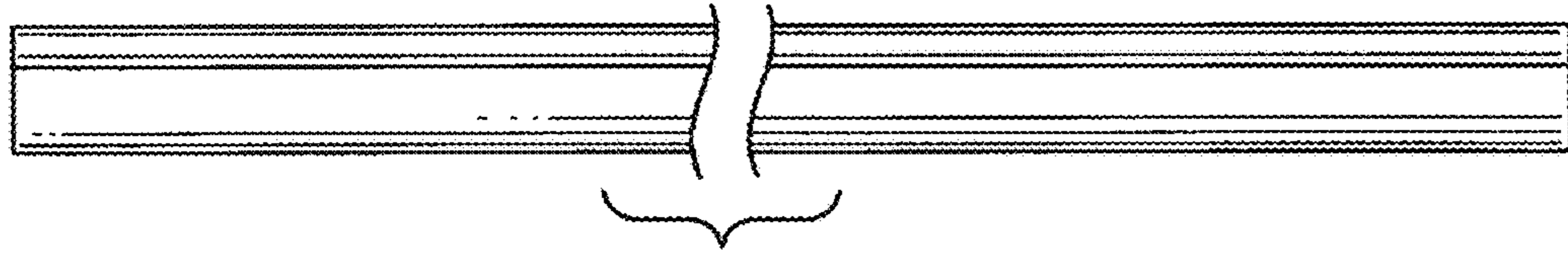

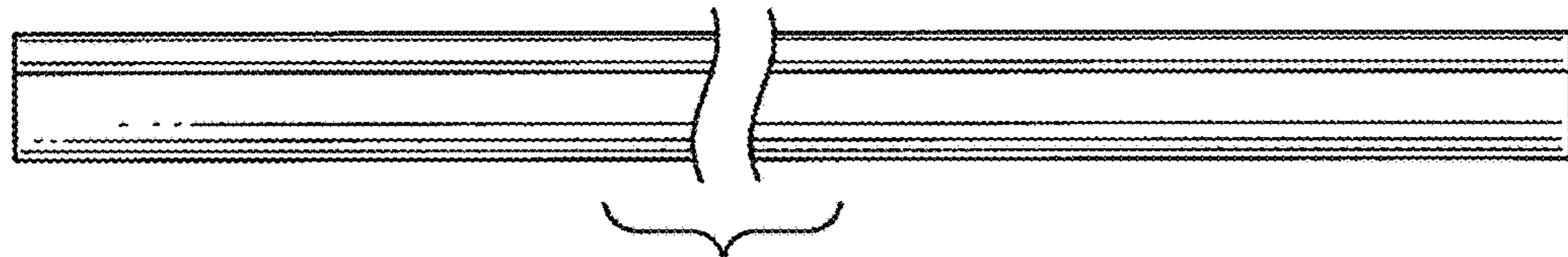

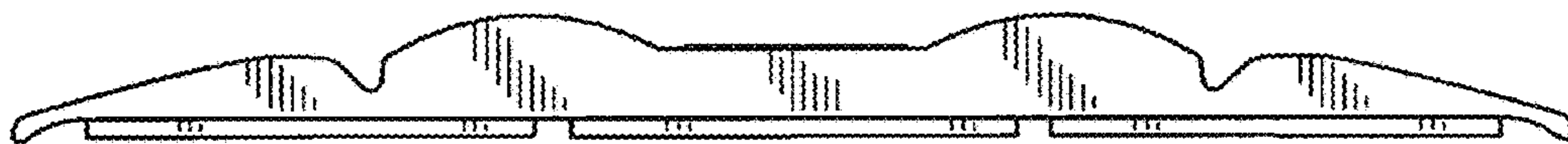

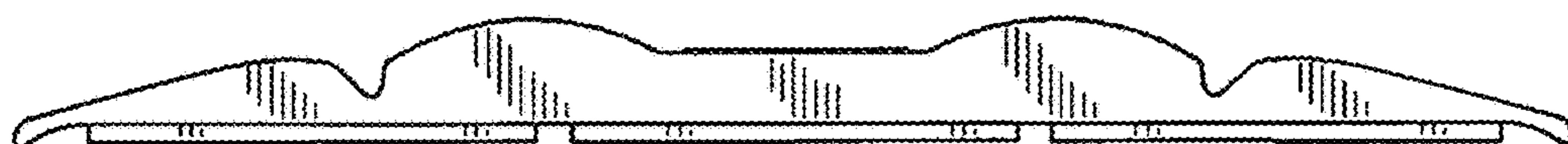

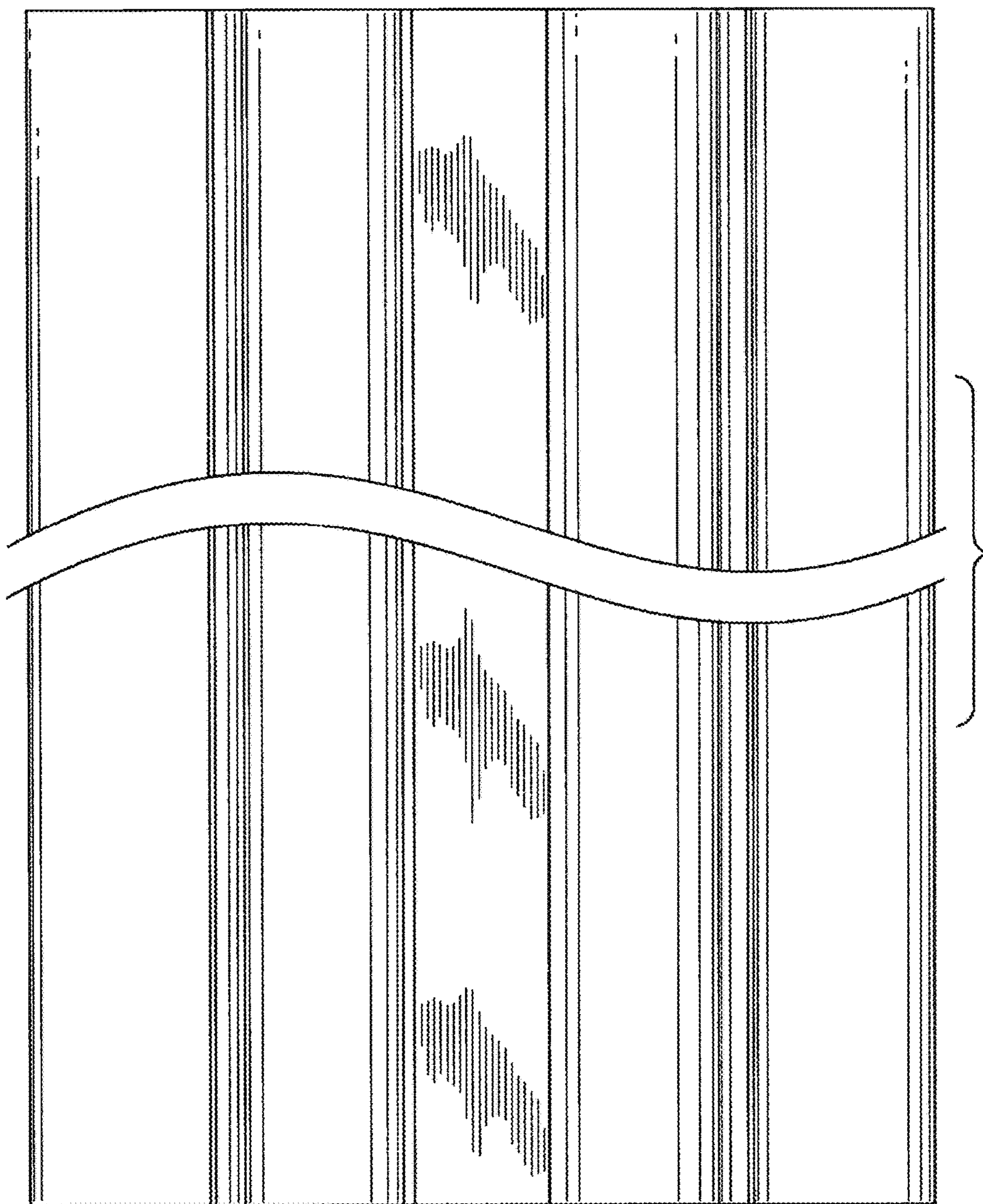

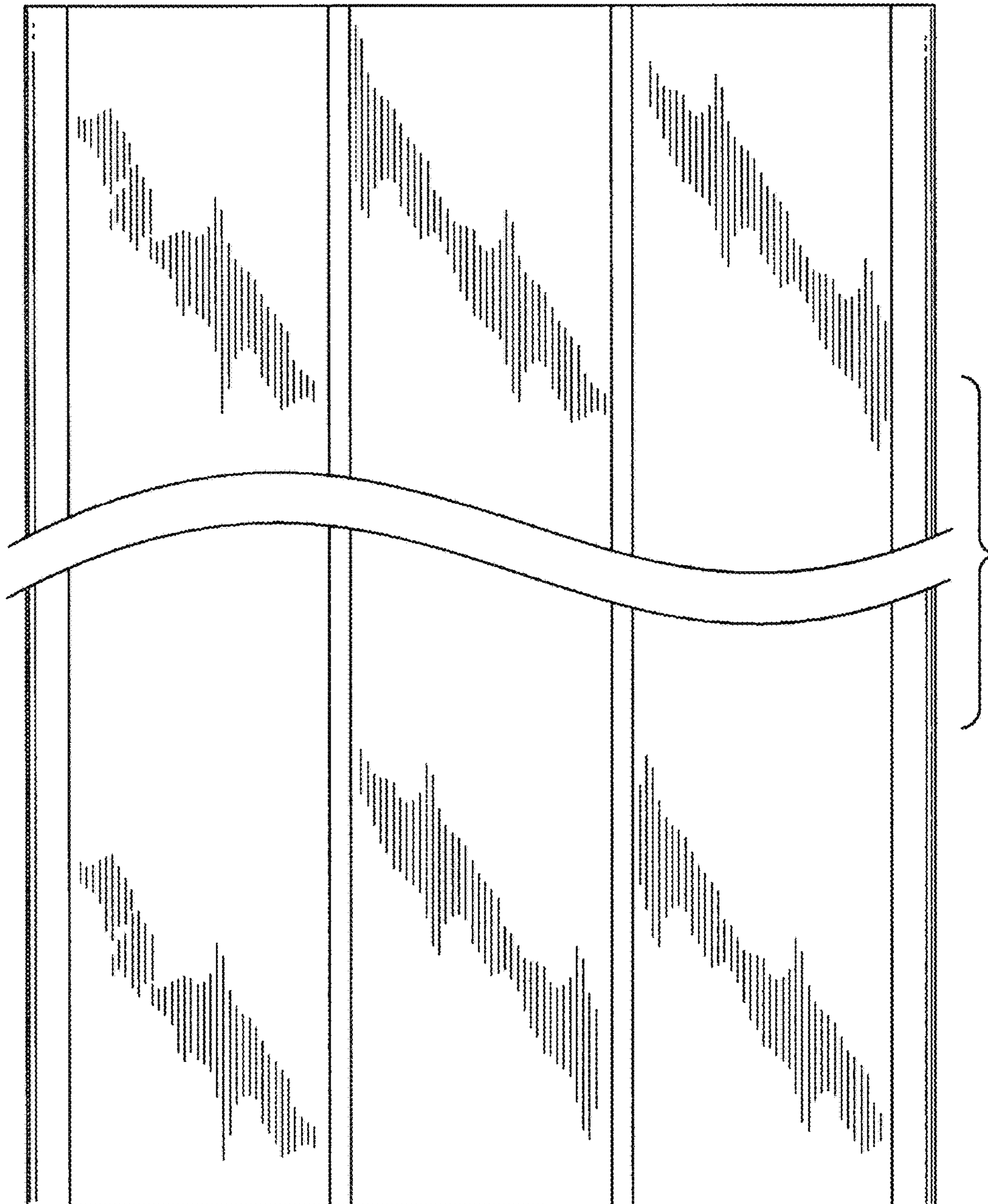

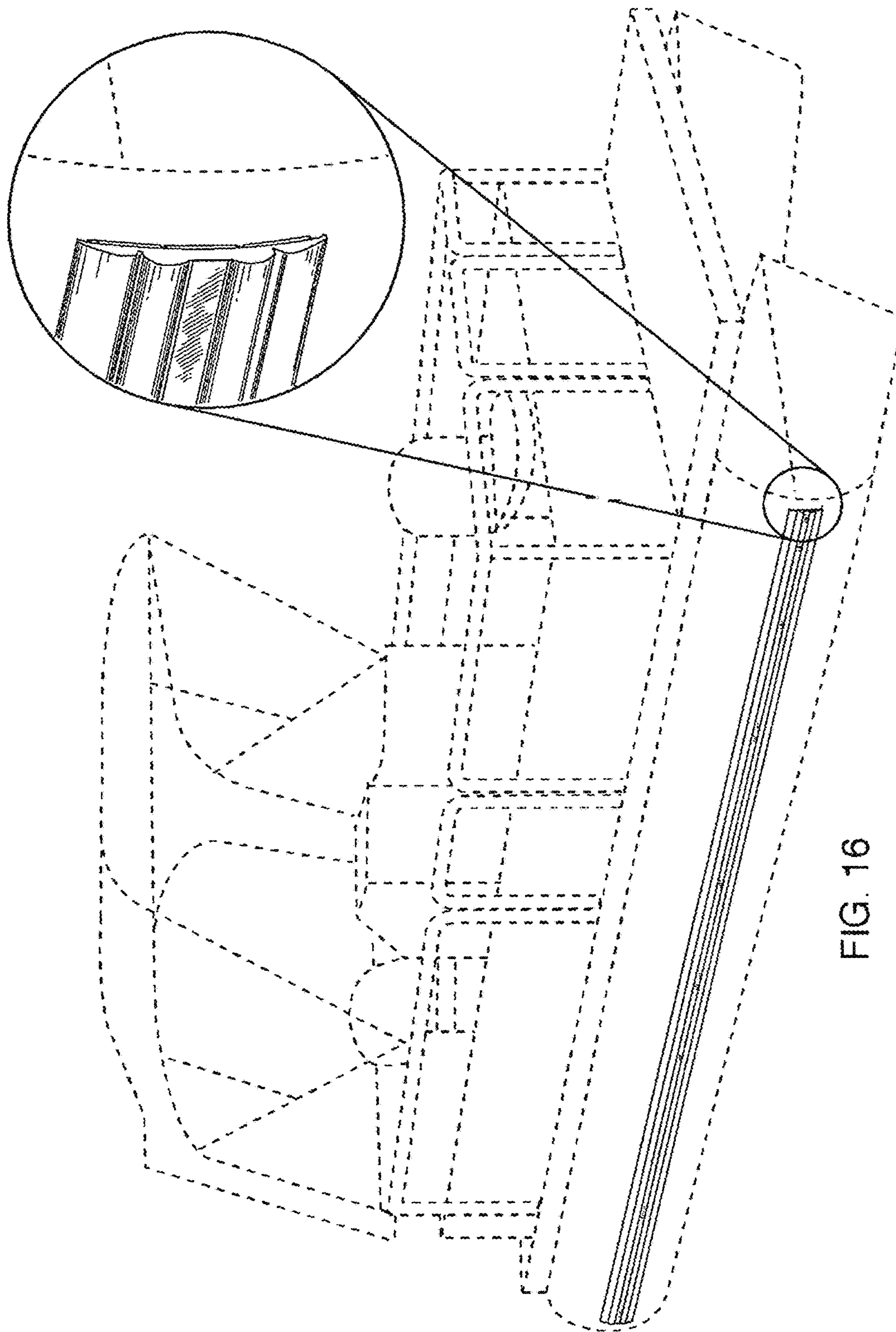
