The broken lines shown in the views are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

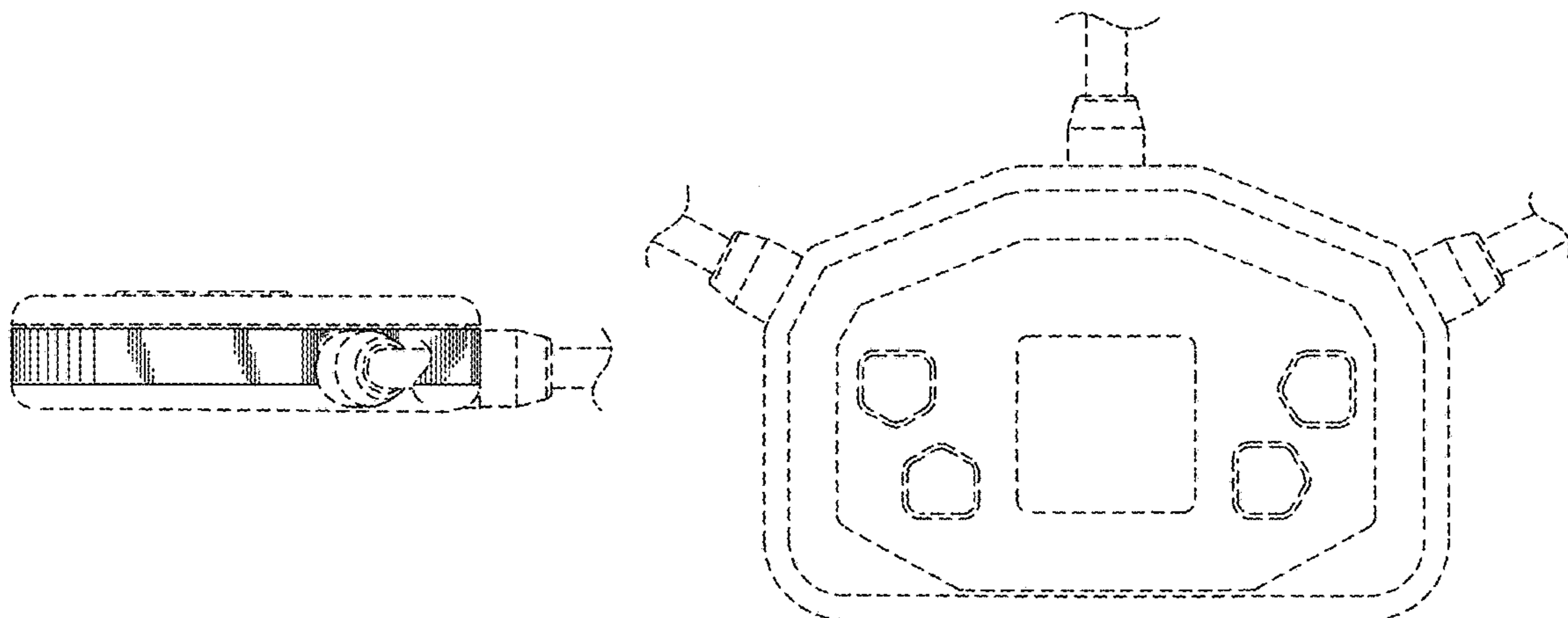

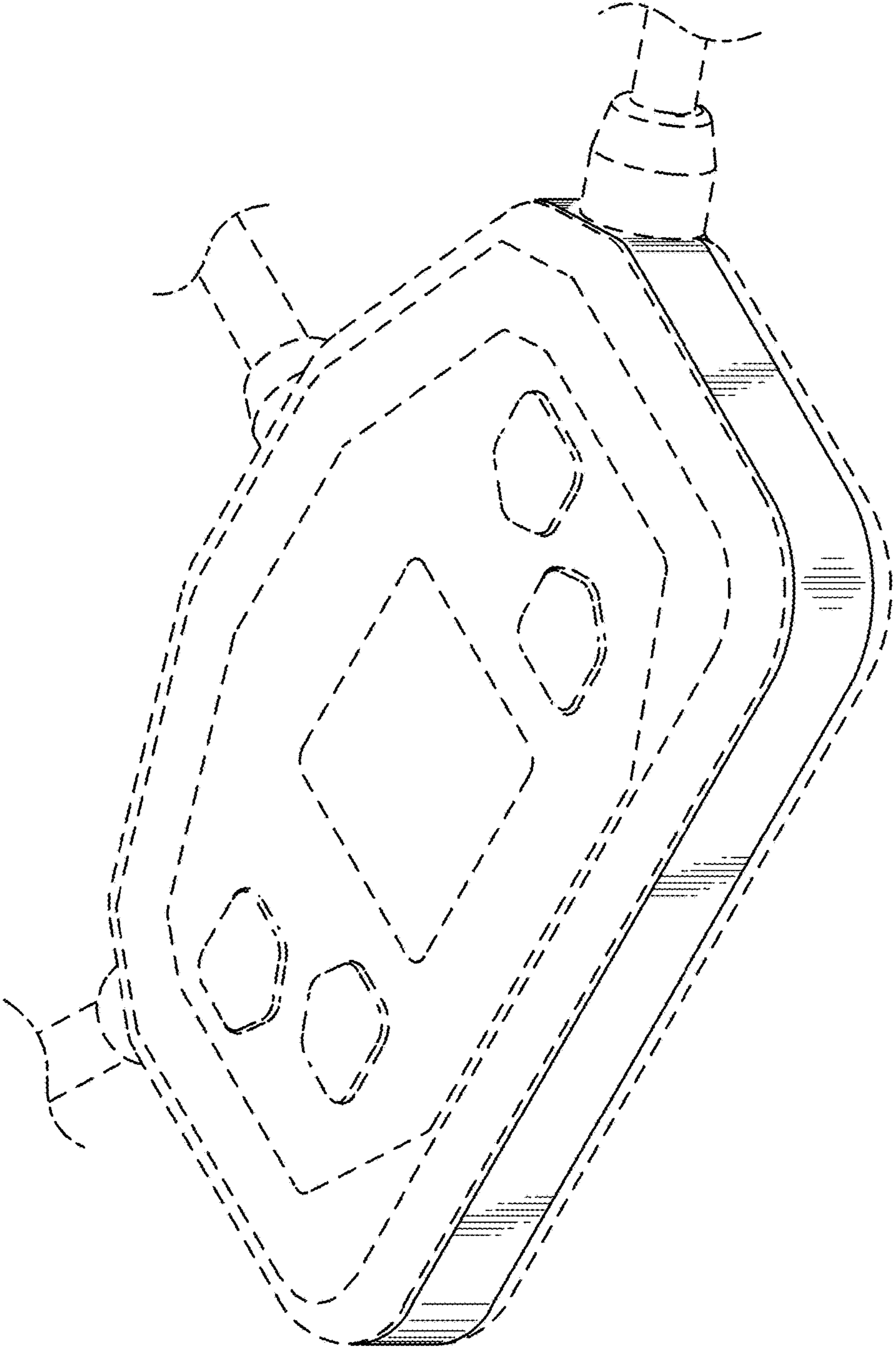

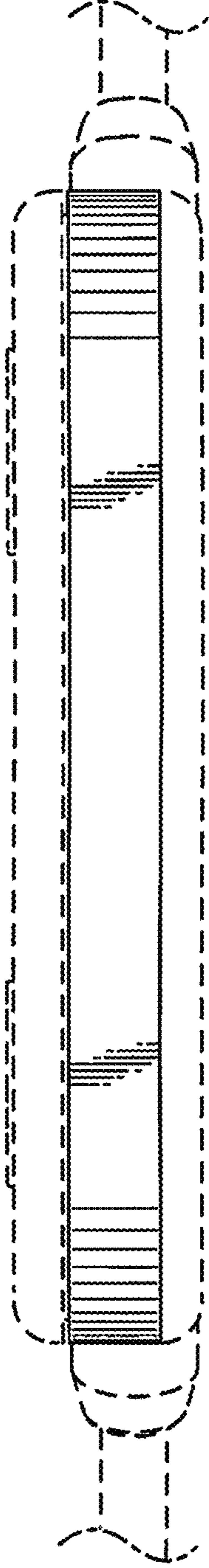

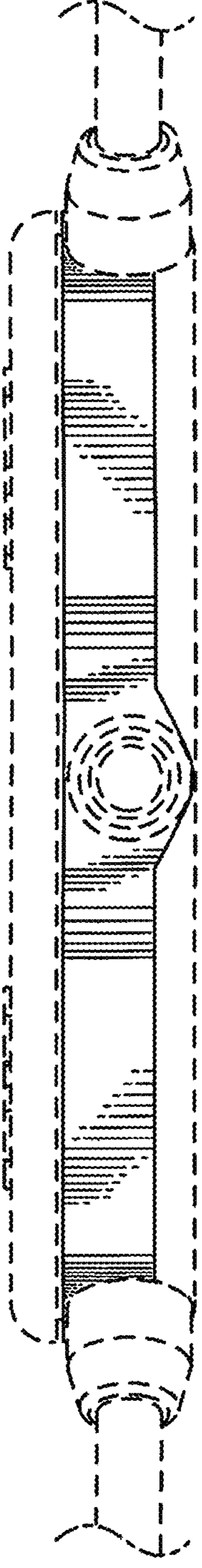

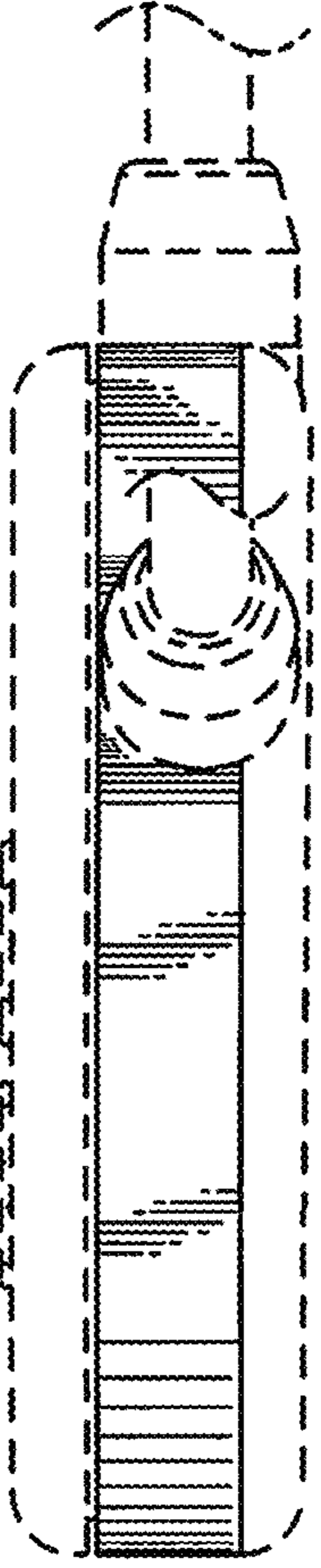

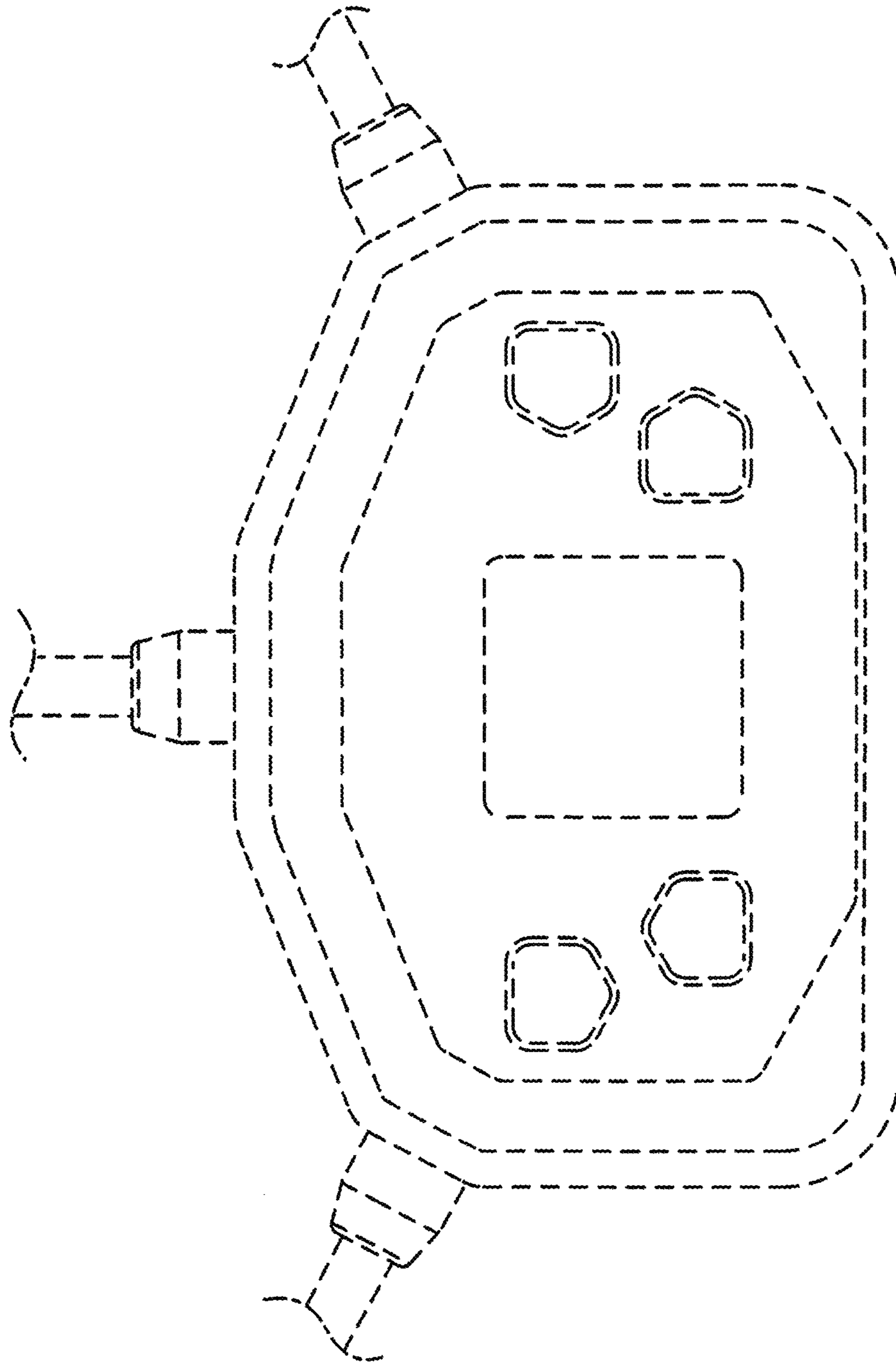

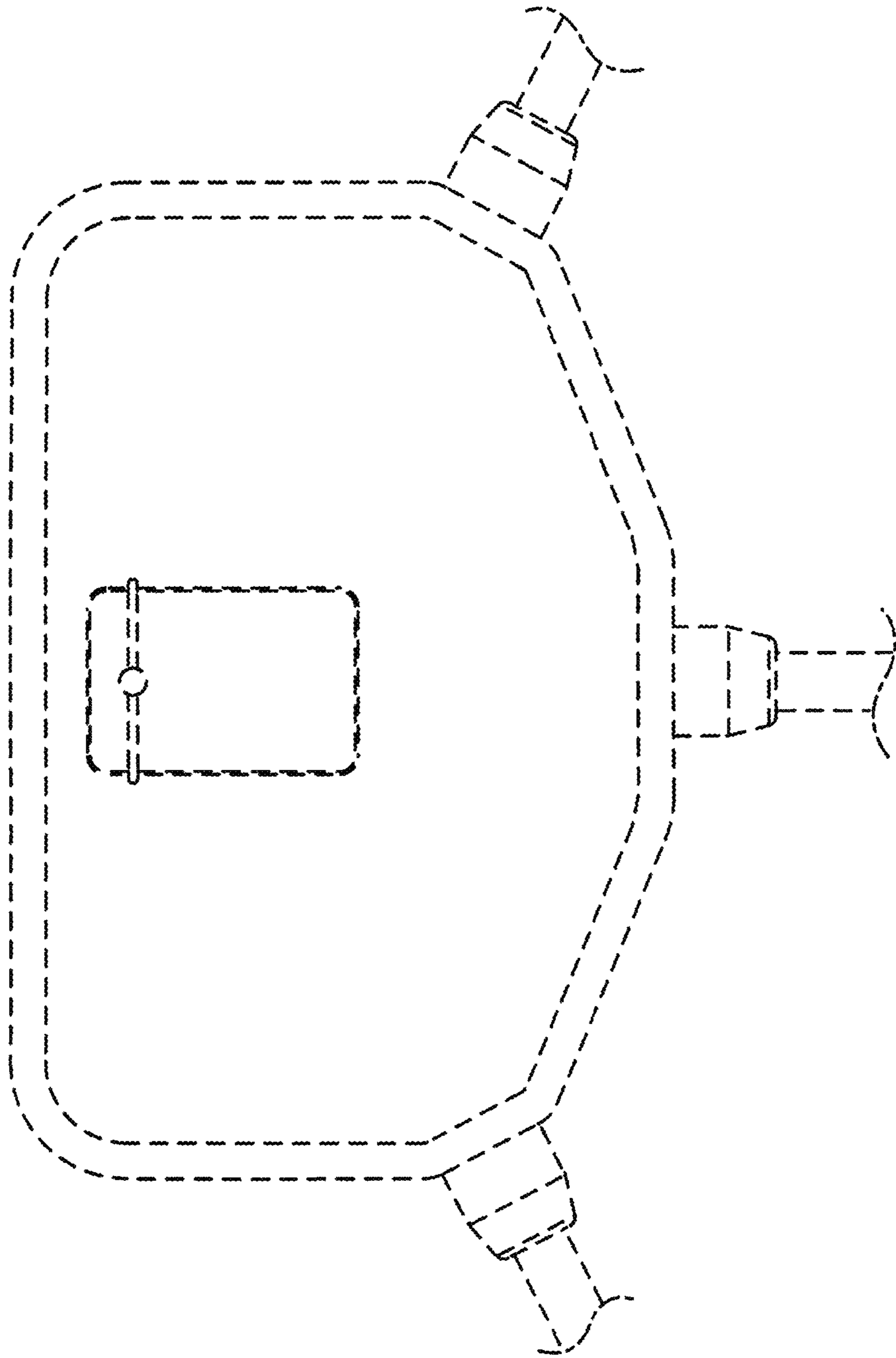
