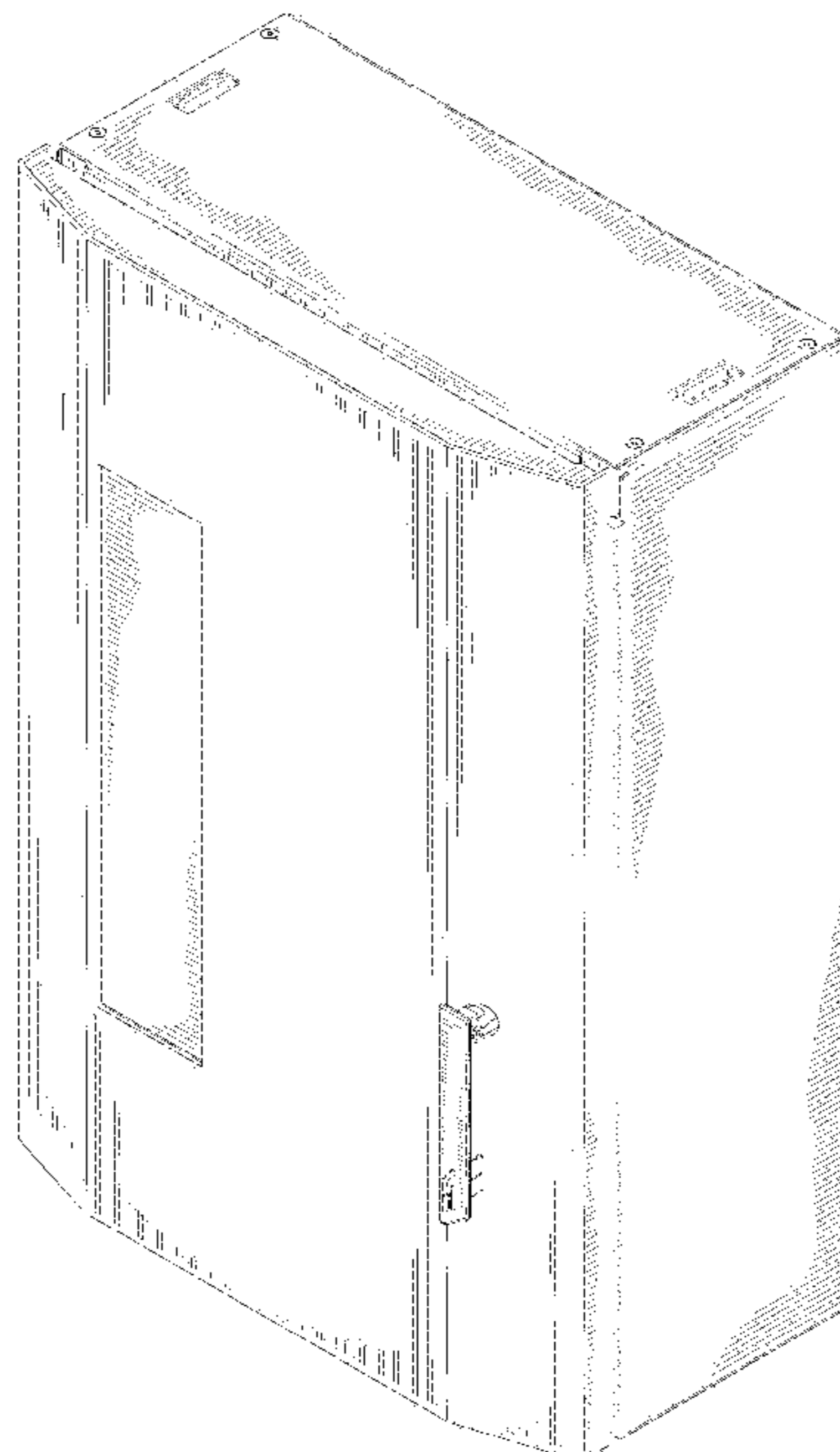

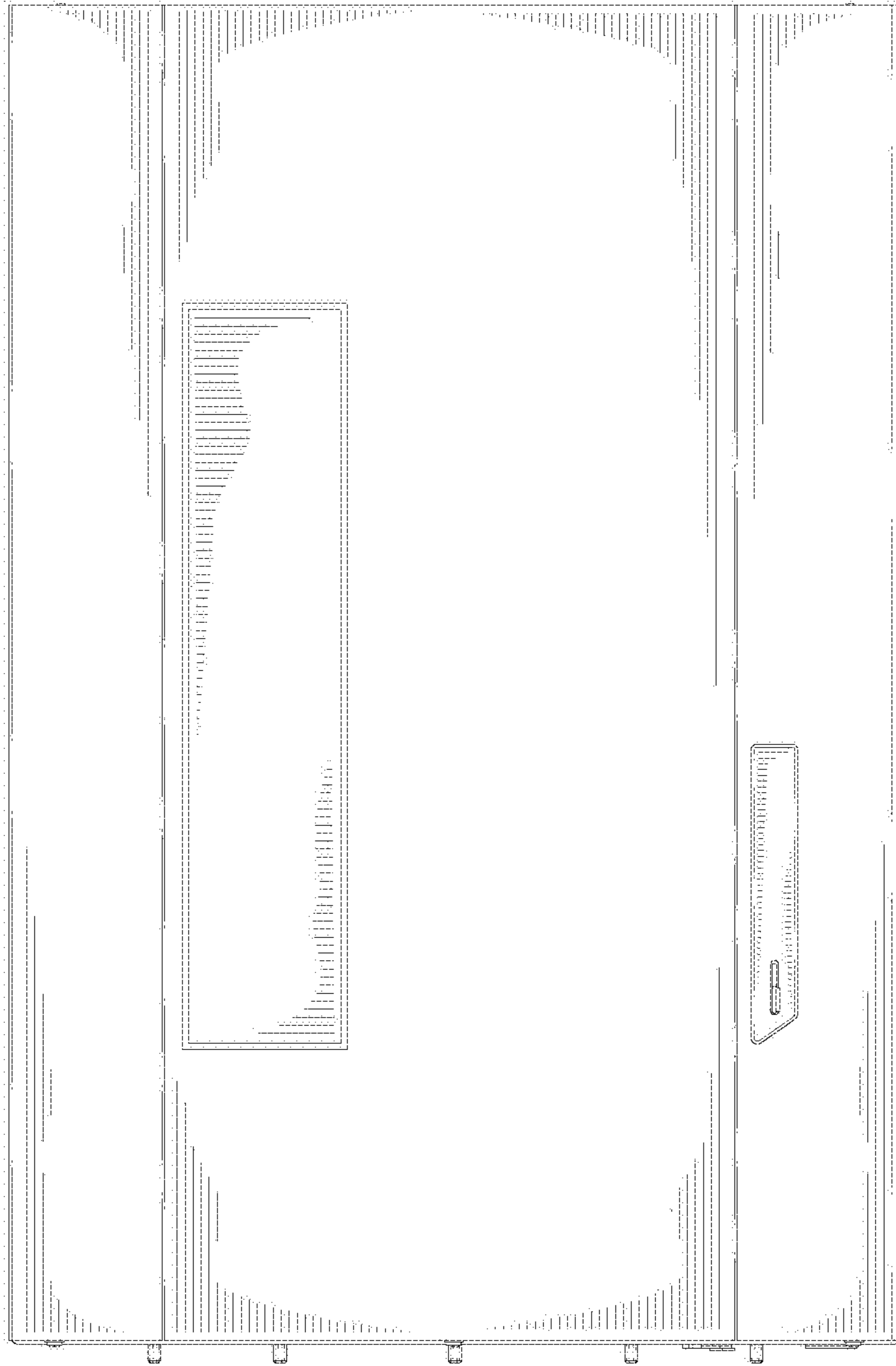
The ornamental design for a switch cabinet, as shown and described.

DESCRIPTION

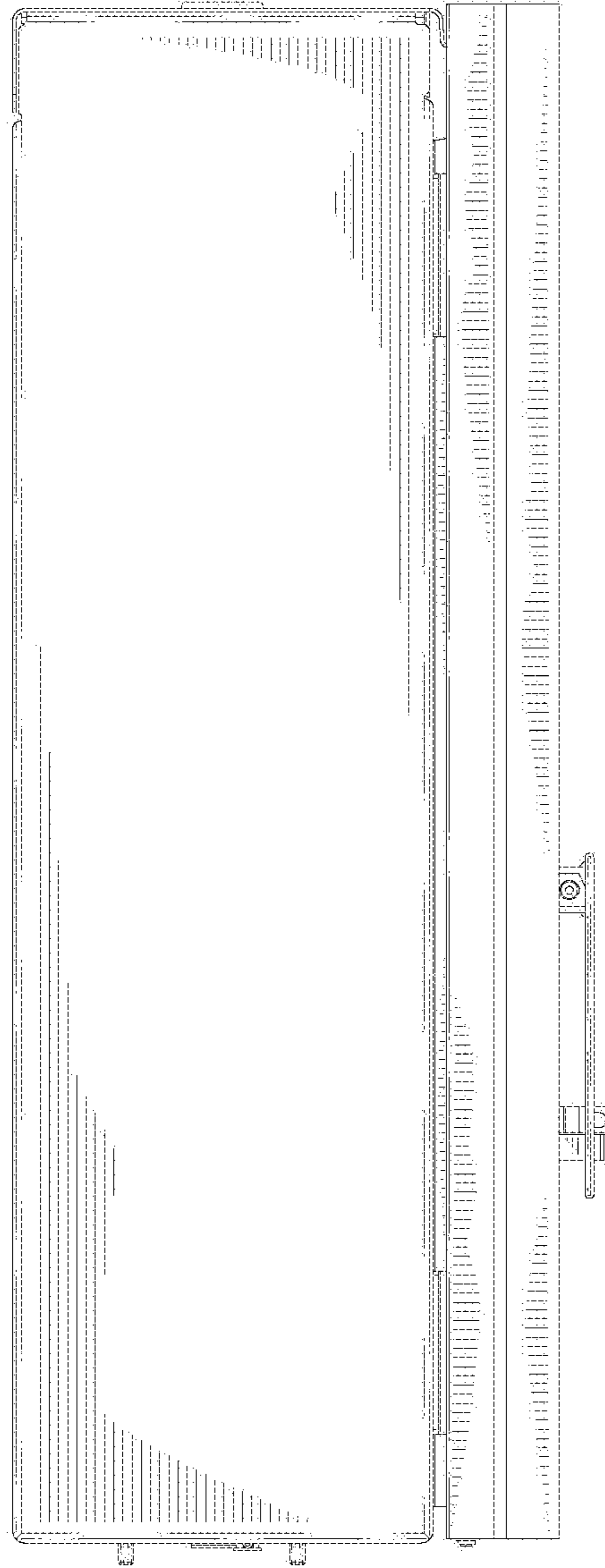
1.1 is a front elevation view of a switch cabinet showing my new design;

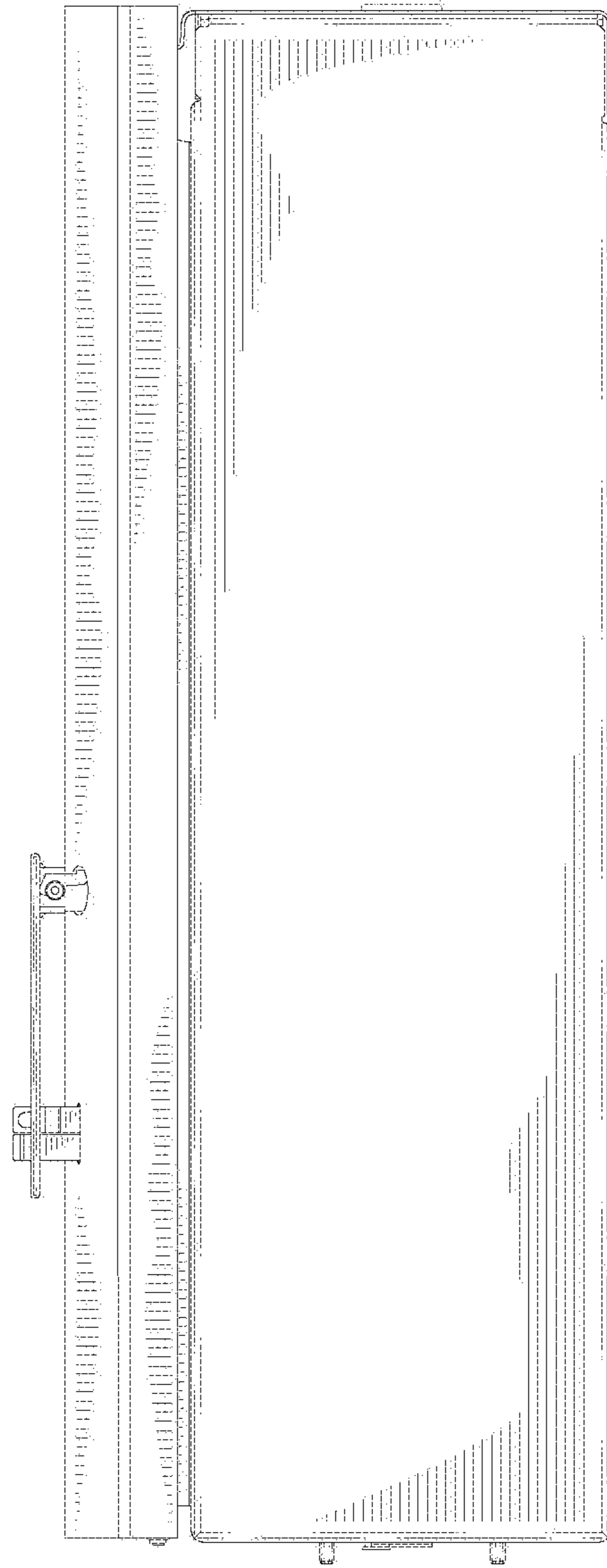

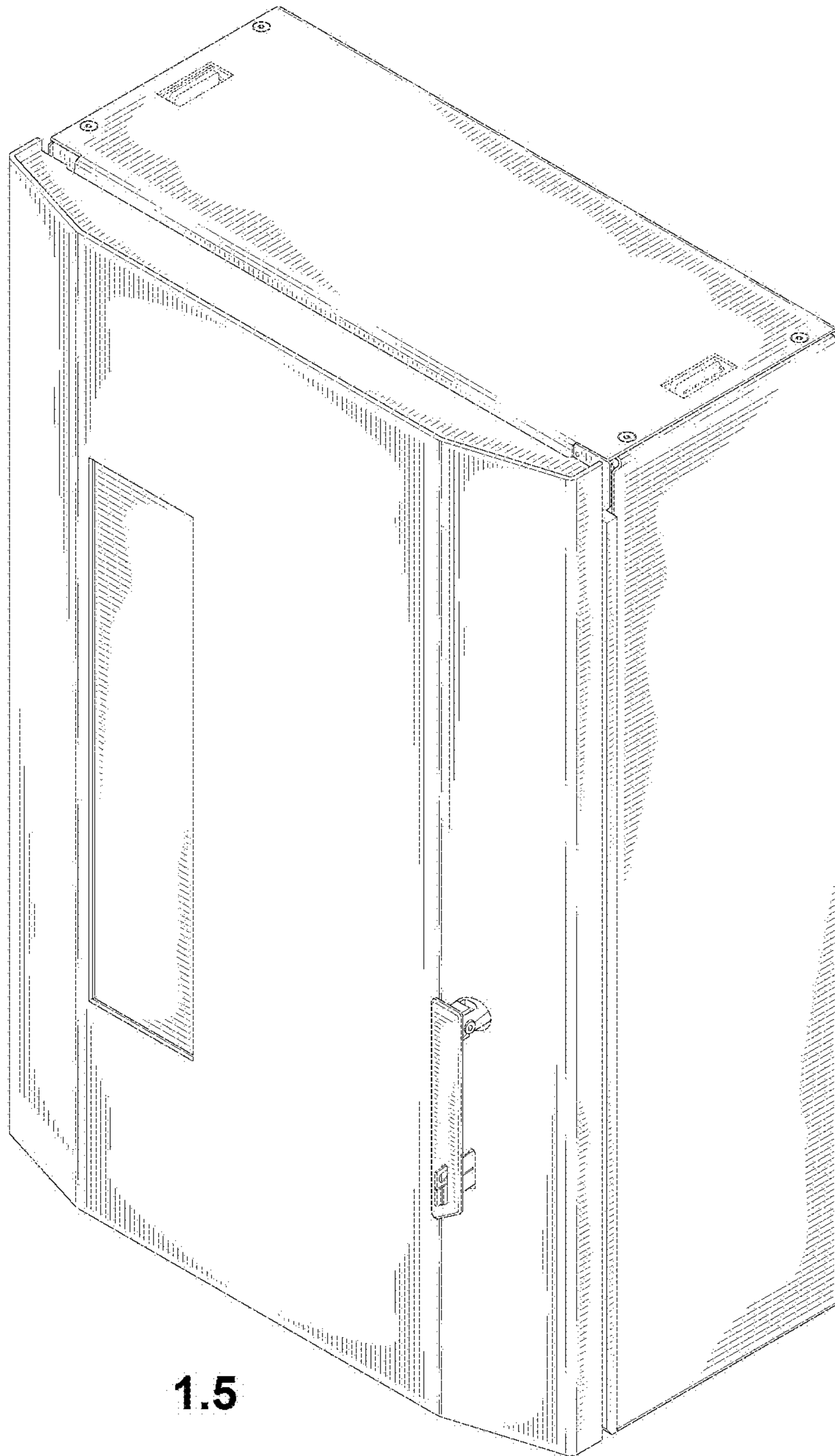
