(57) **CLAIM**

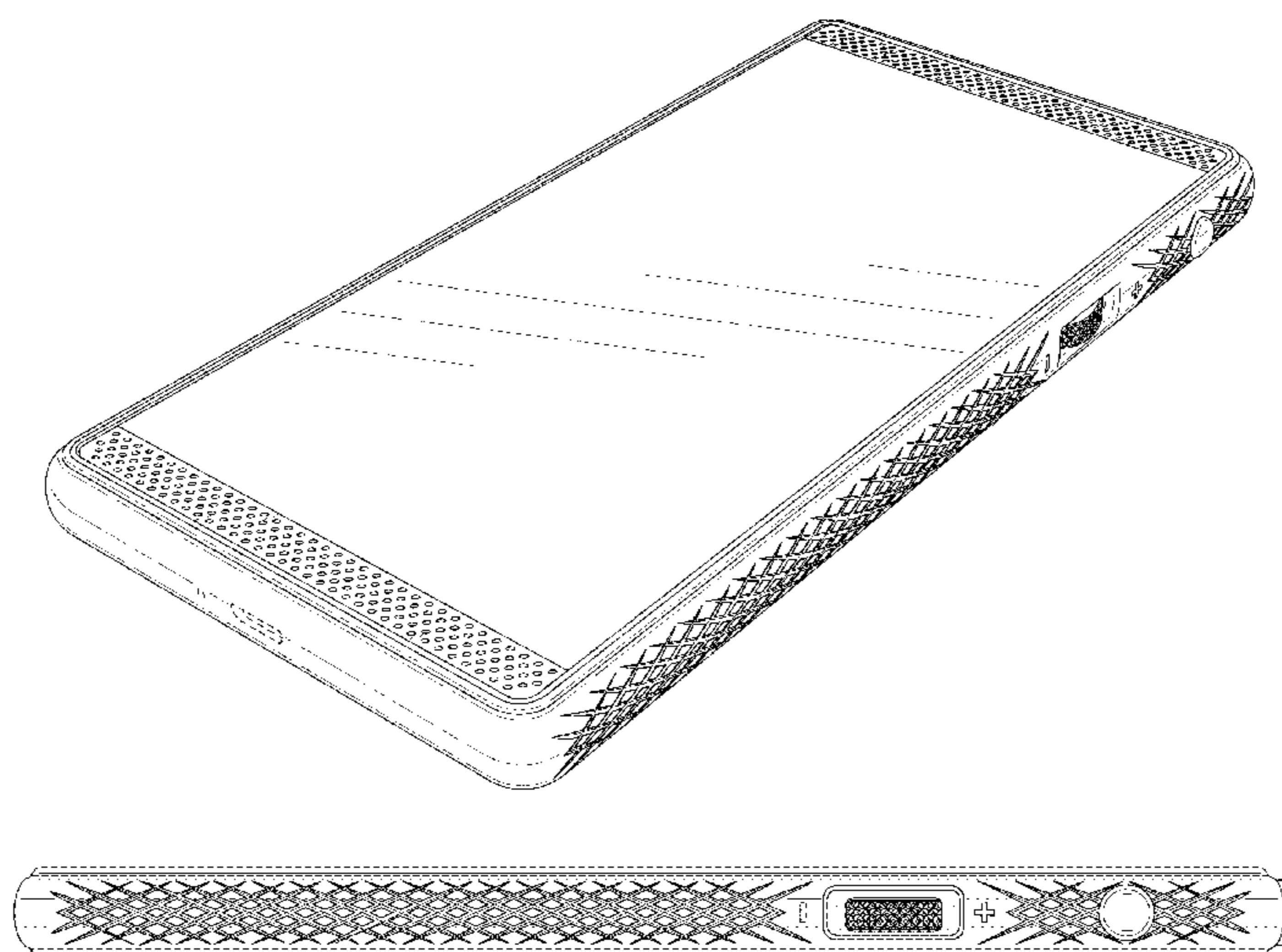
The ornamental design for a smartphone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom, and right side perspective view of a smartphone showing my new design;  
FIG. 2 is a top view thereof;

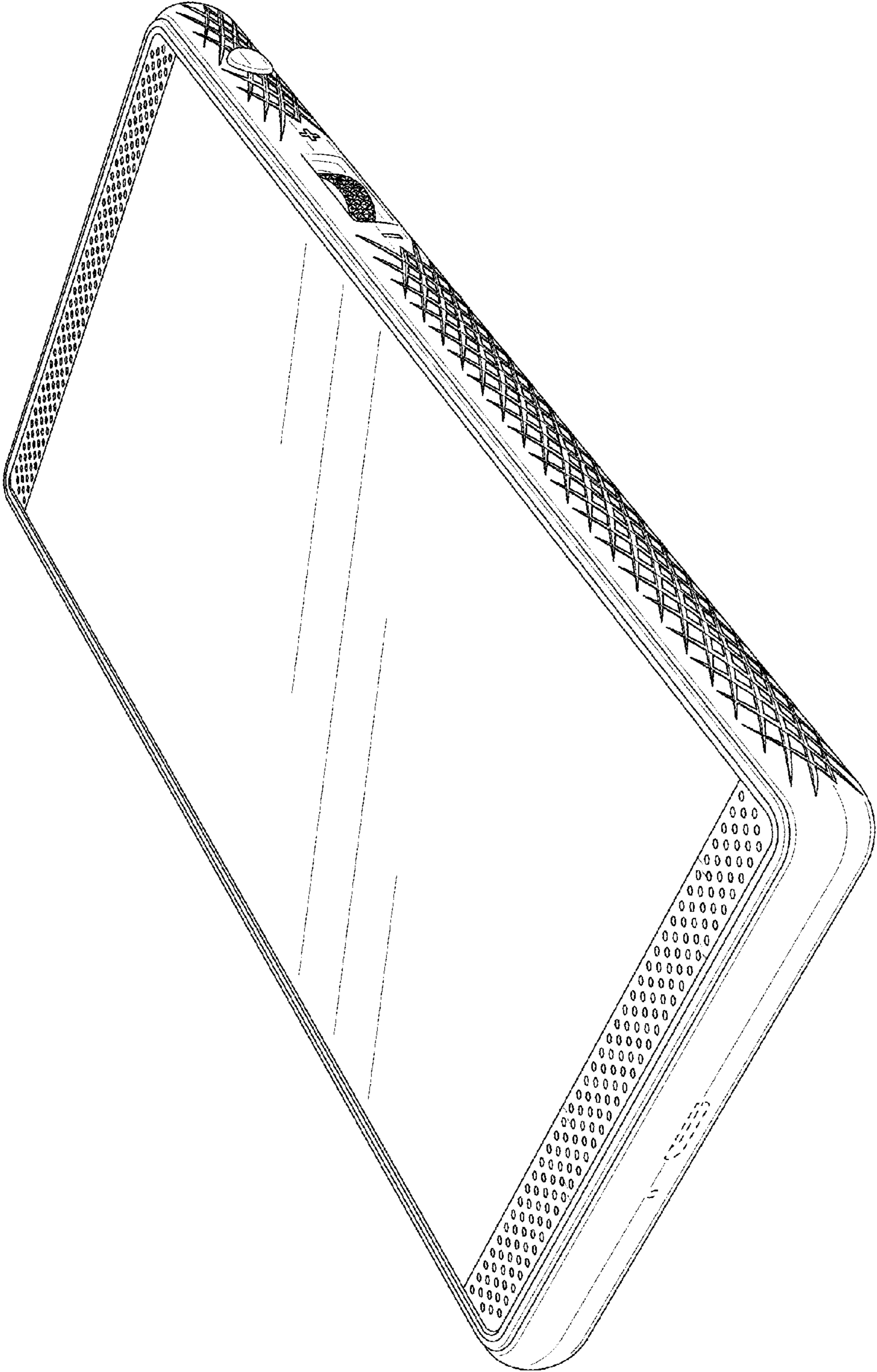

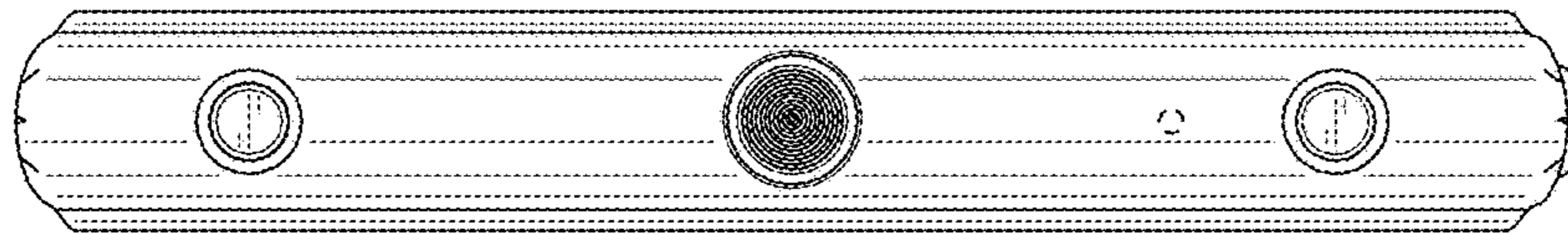

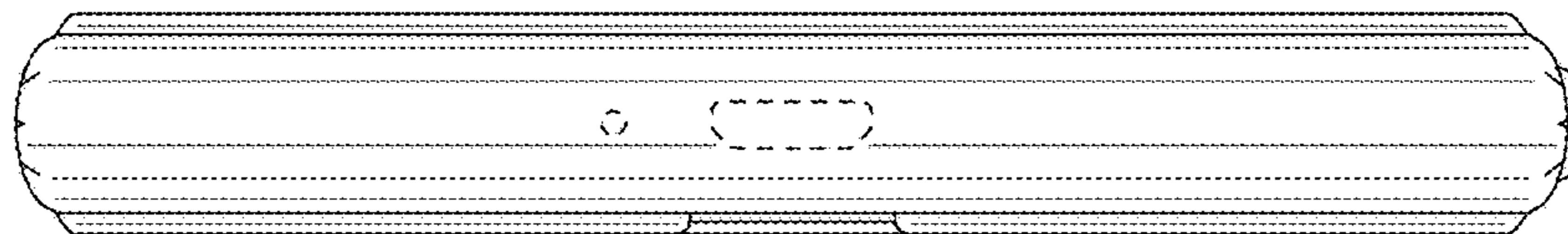

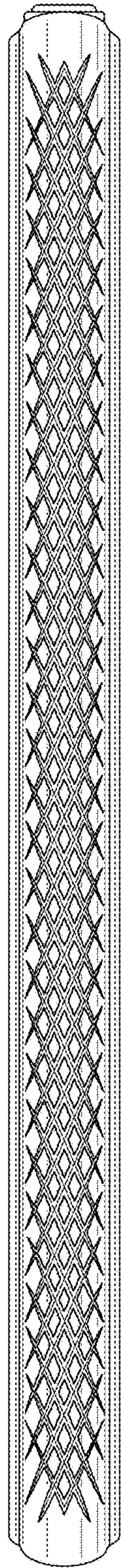

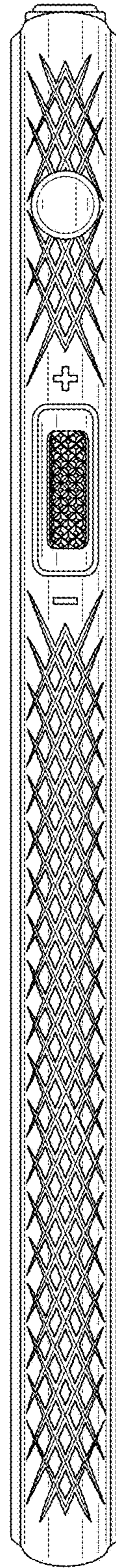

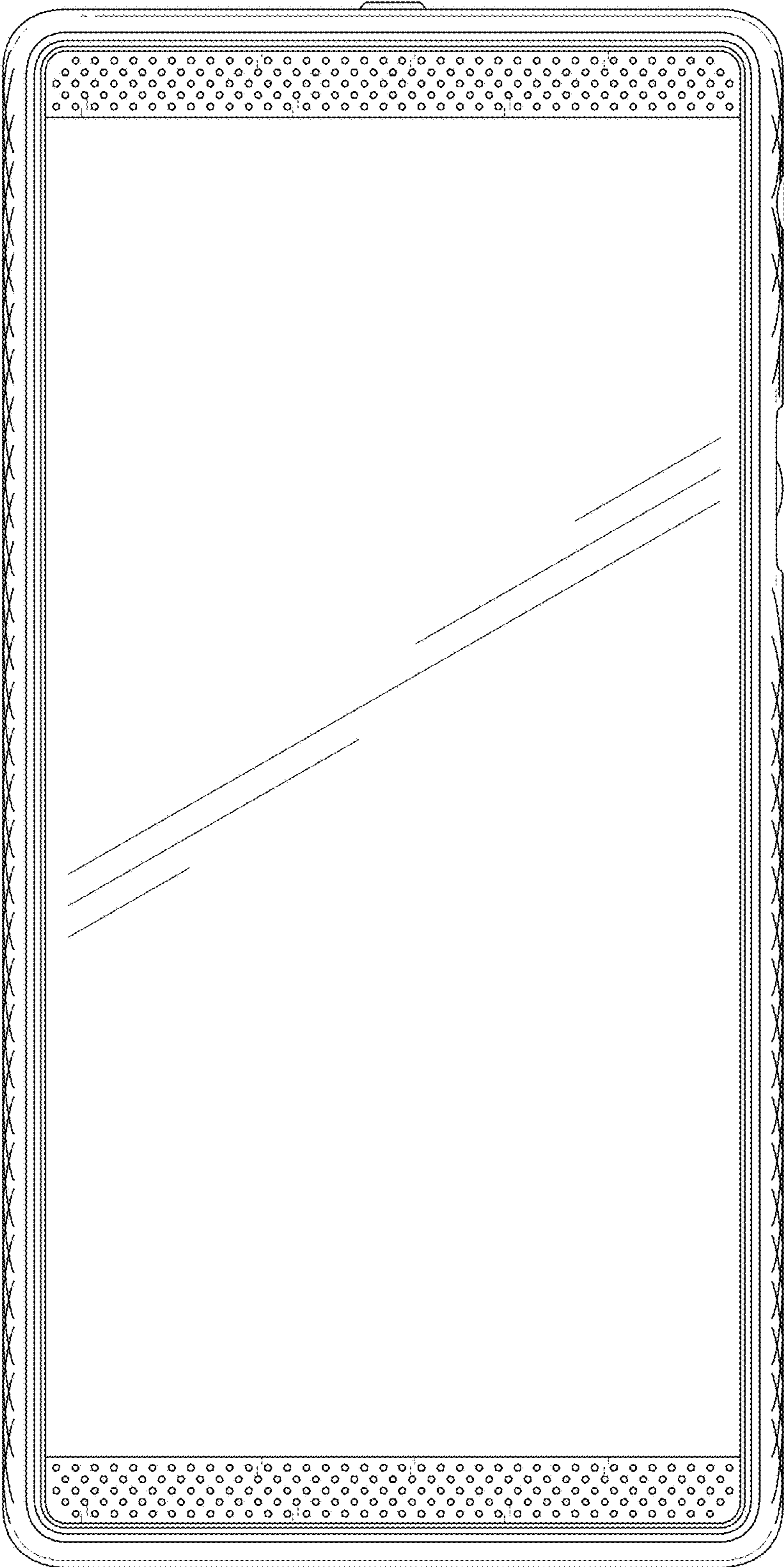

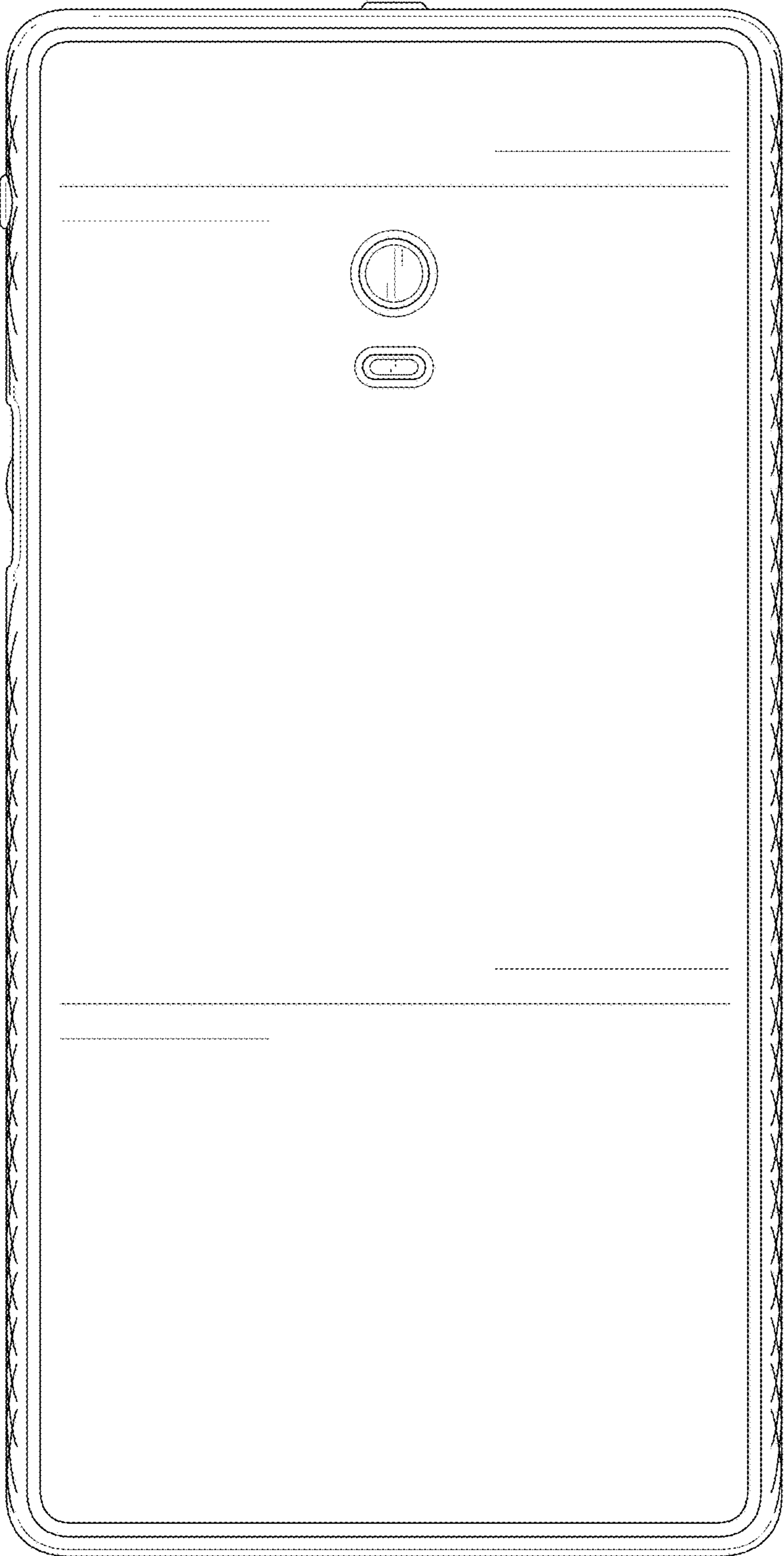
