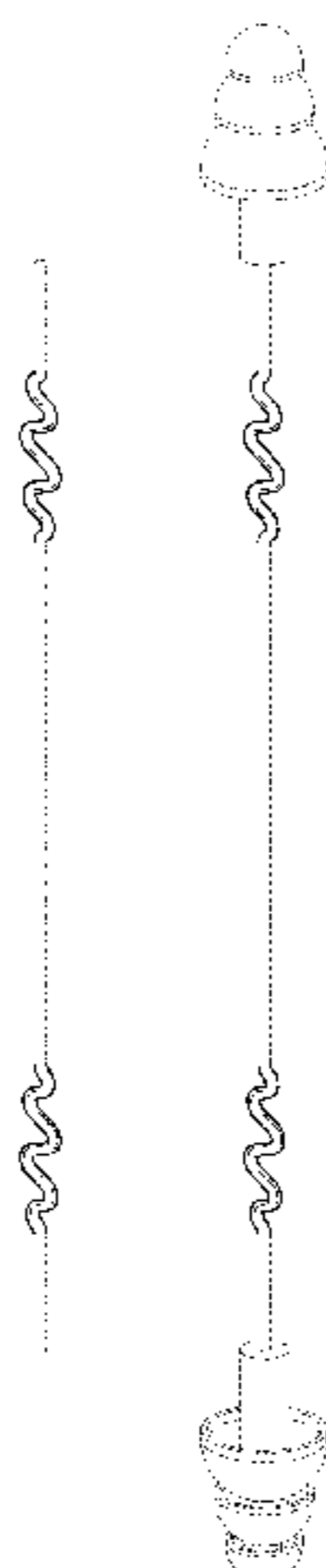


FIG. 10 is a top view, the bottom view is a mirror image thereof.

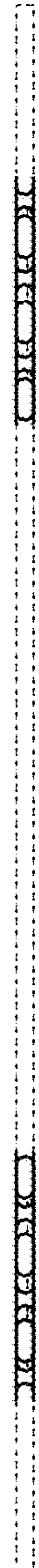
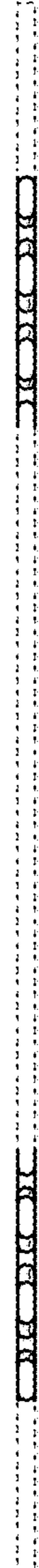
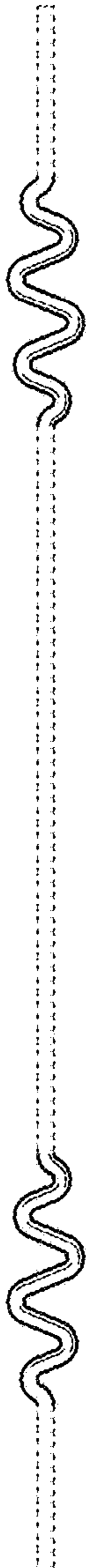
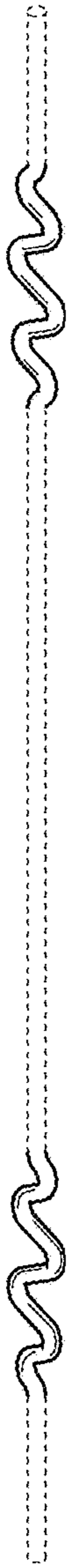

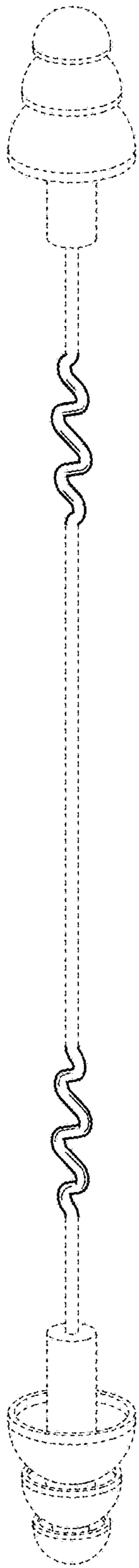

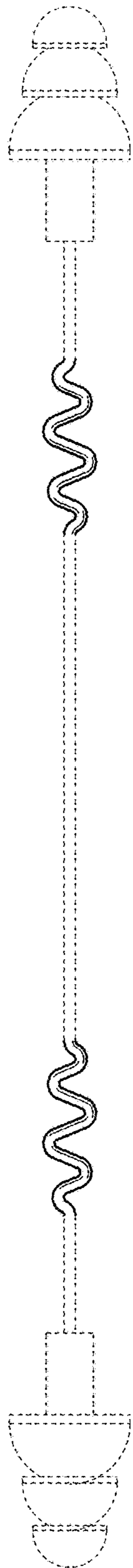

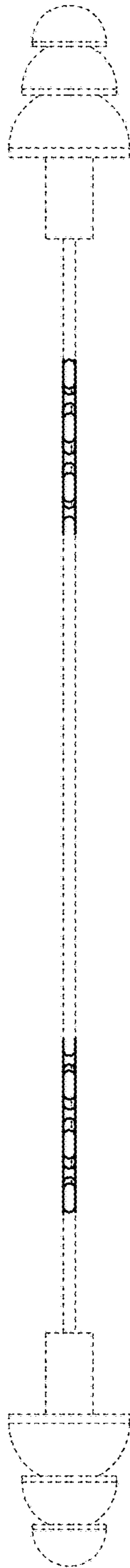

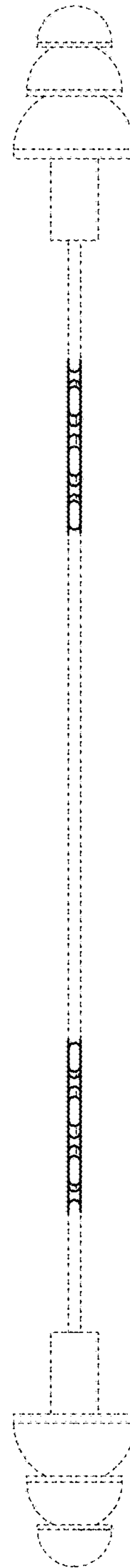

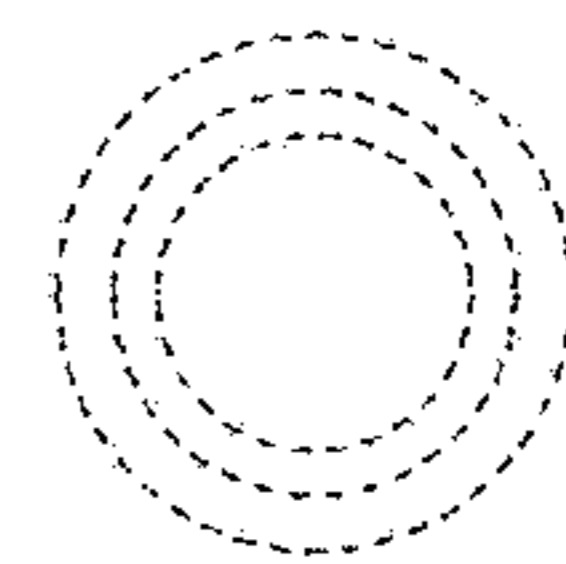
