The ornamental design for a phone case, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a phone case showing my new design with a component of the case in an extended position.

FIG. 2 is a front perspective view of the phone case of FIG. 1.

FIG. 3 is a rear view of the phone case of FIG. 1.

FIG. 13 is a front view of the phone case of FIG. 9.

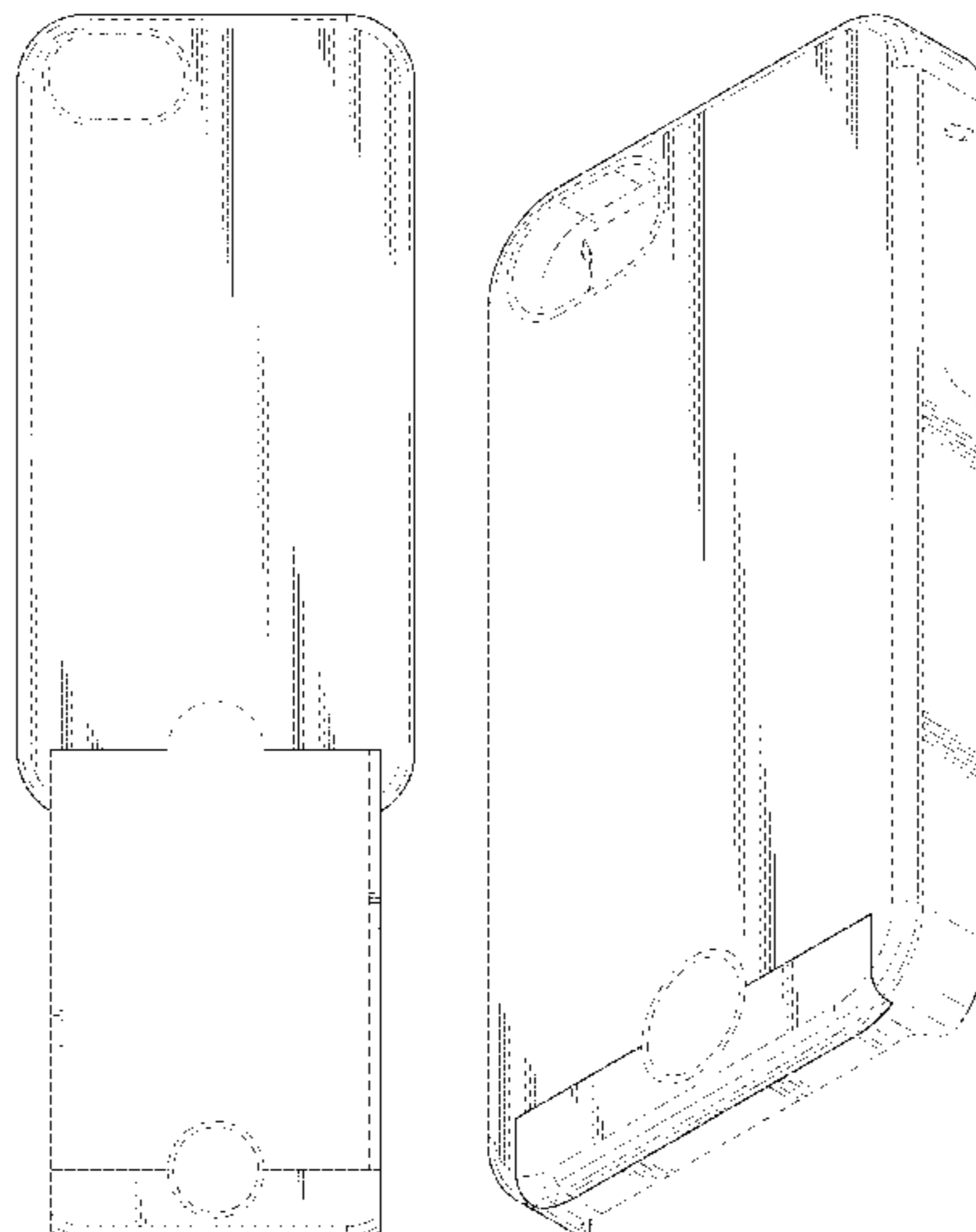
FIG. 14 is a left side view of the phone case of FIG. 9.

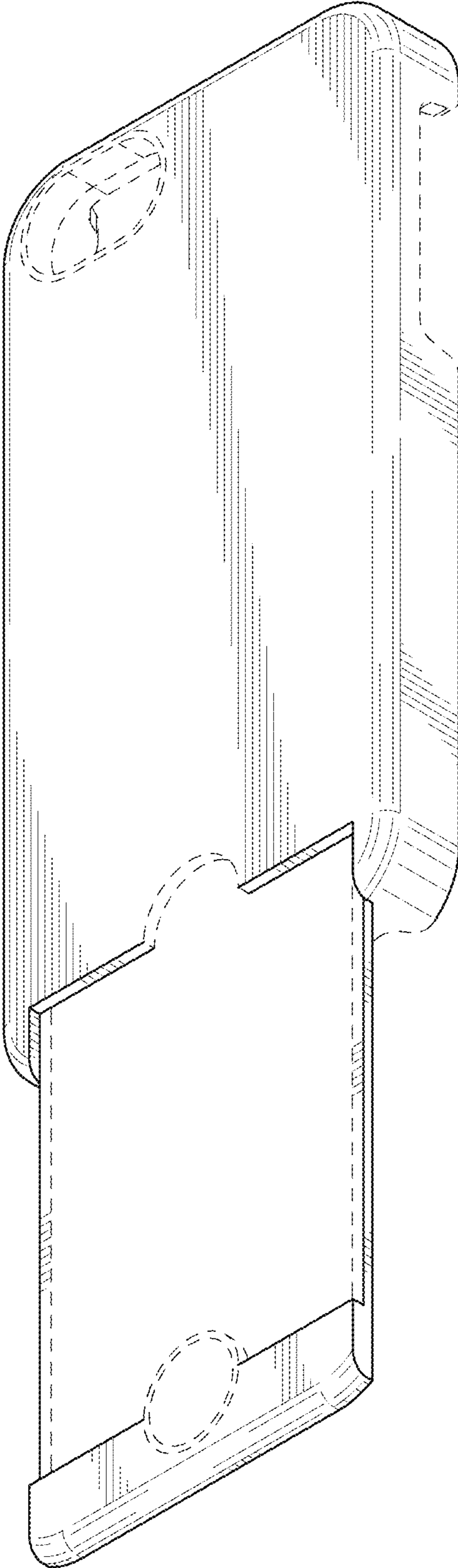

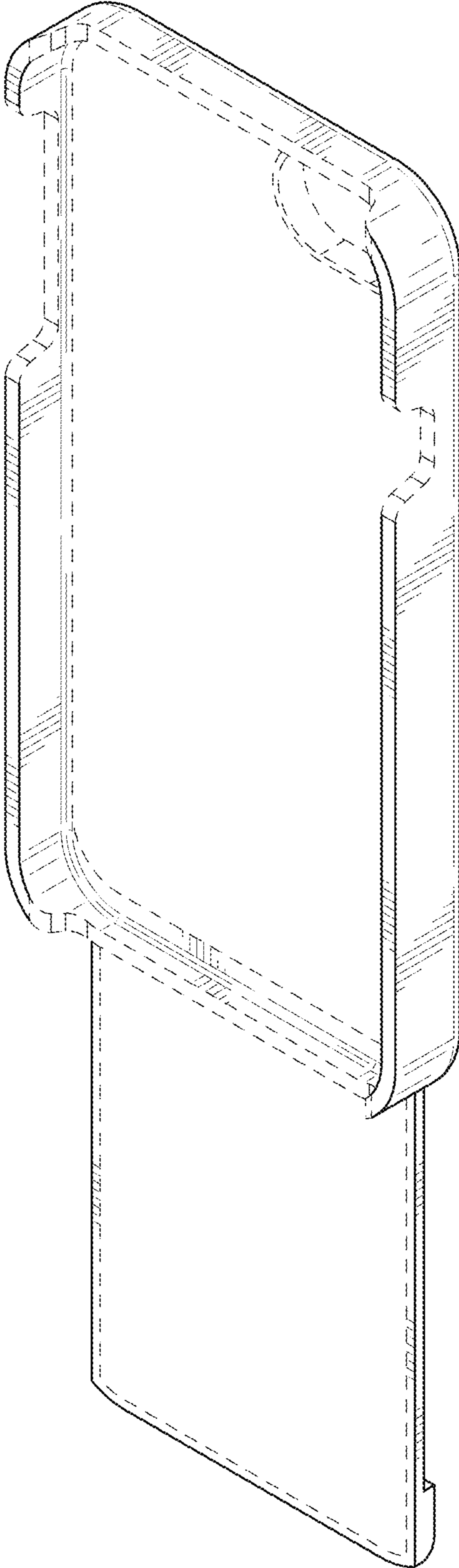

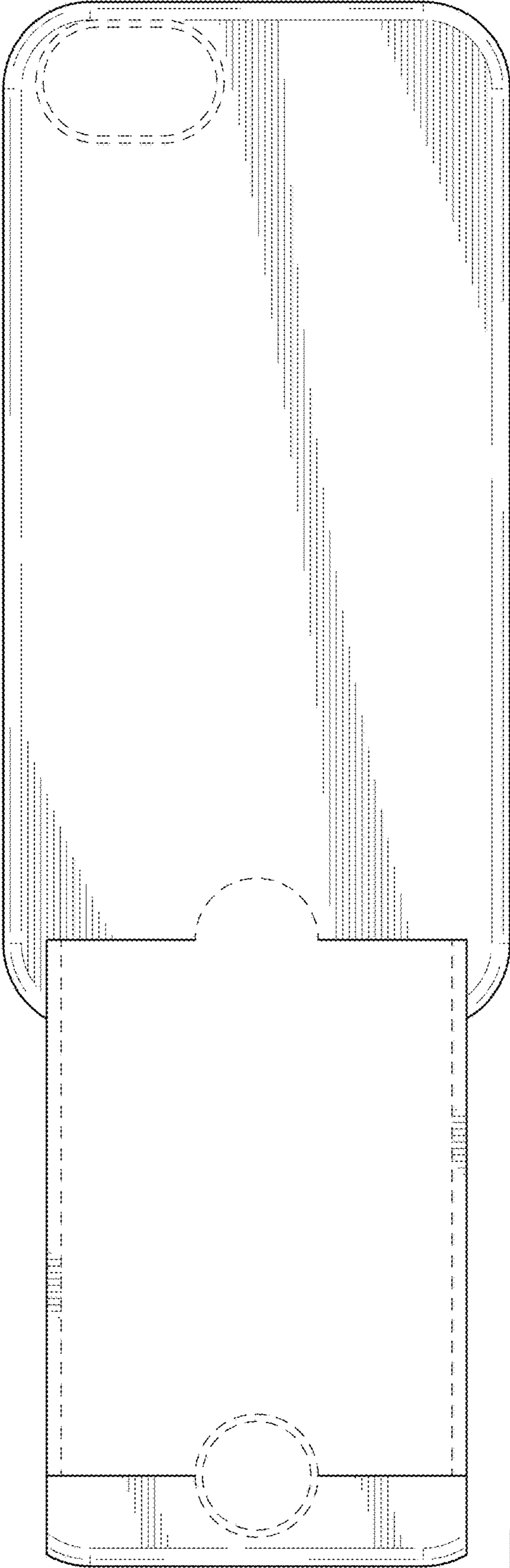

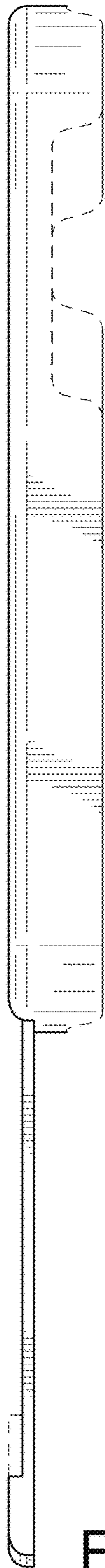

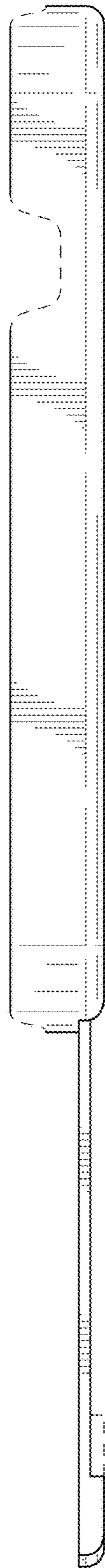

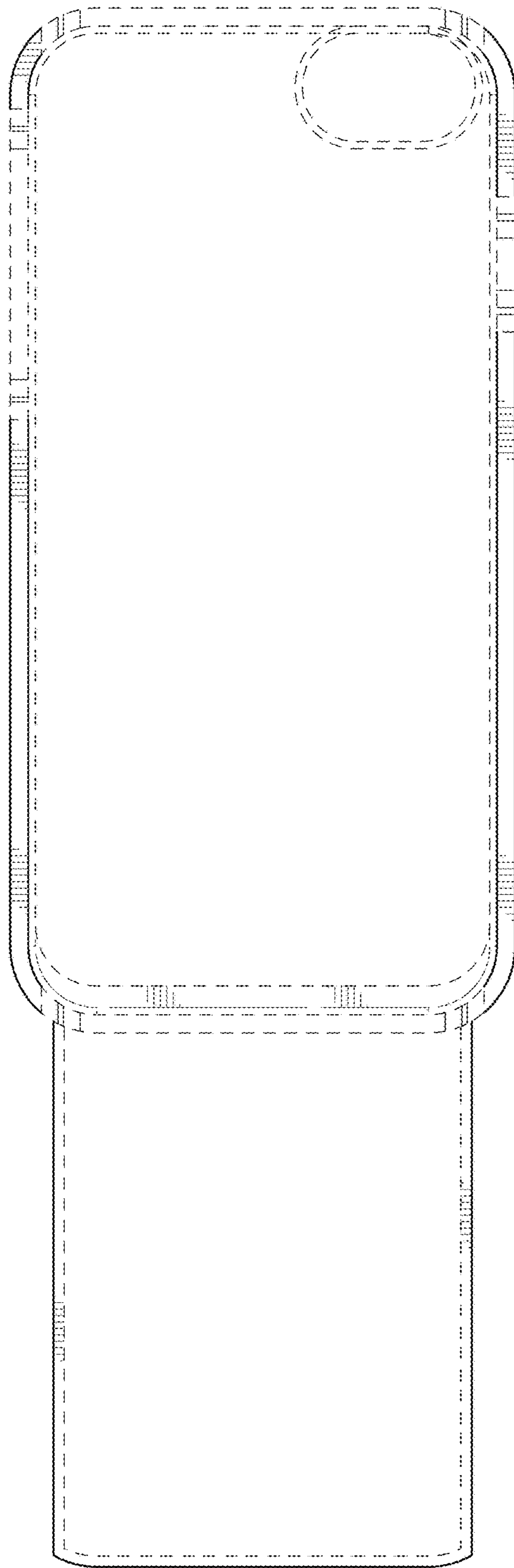

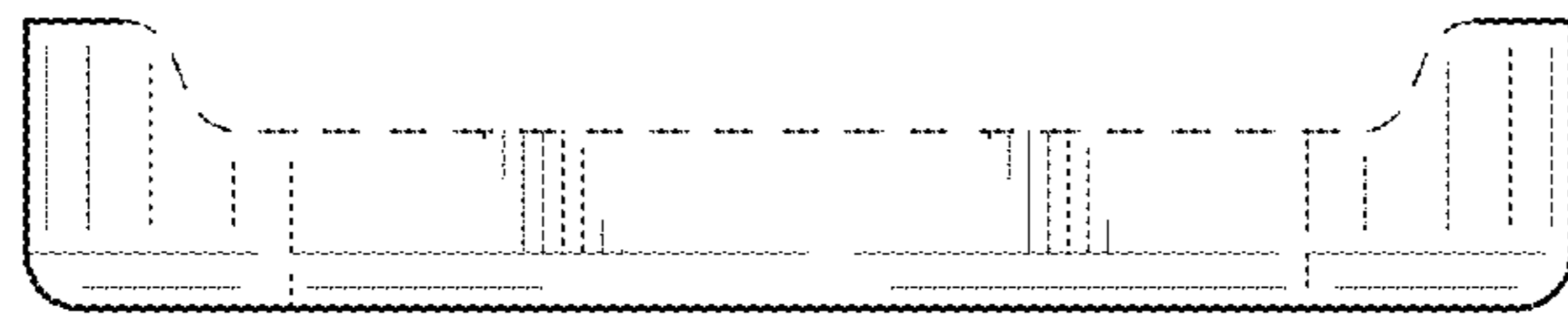

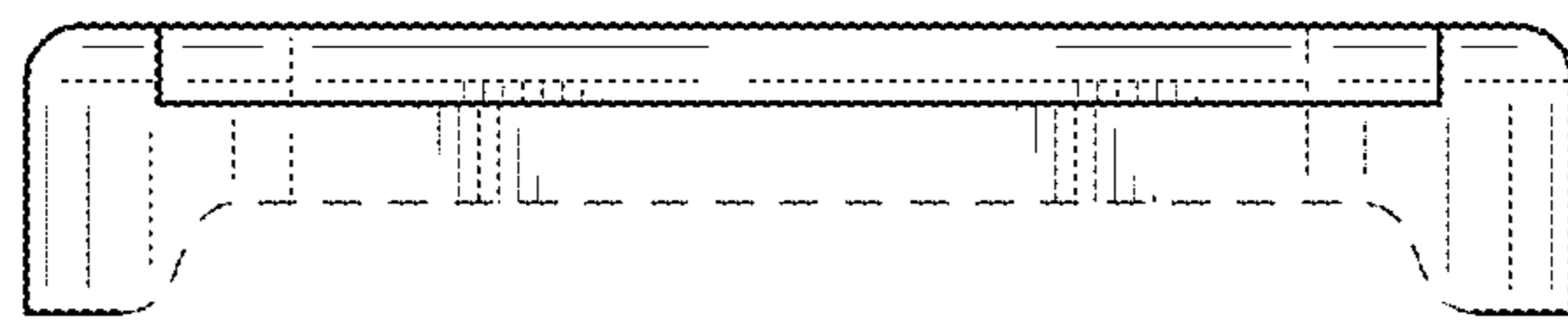

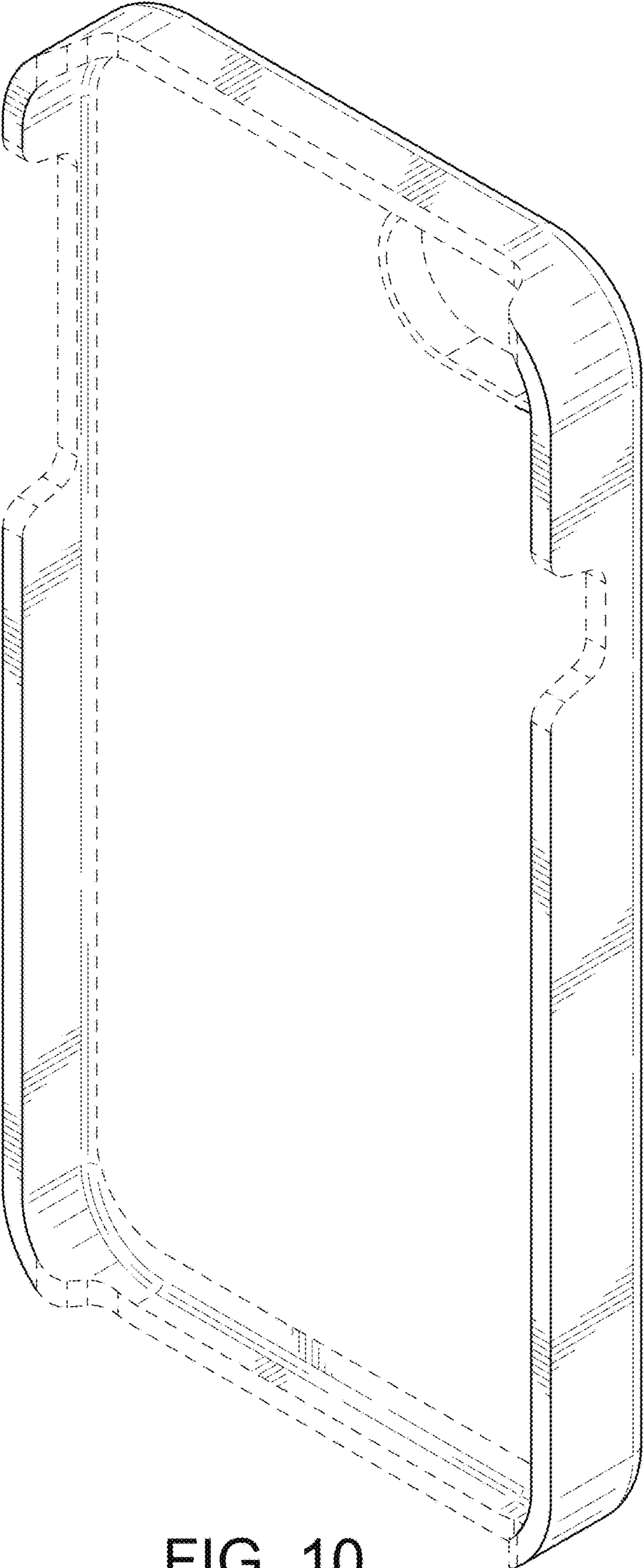

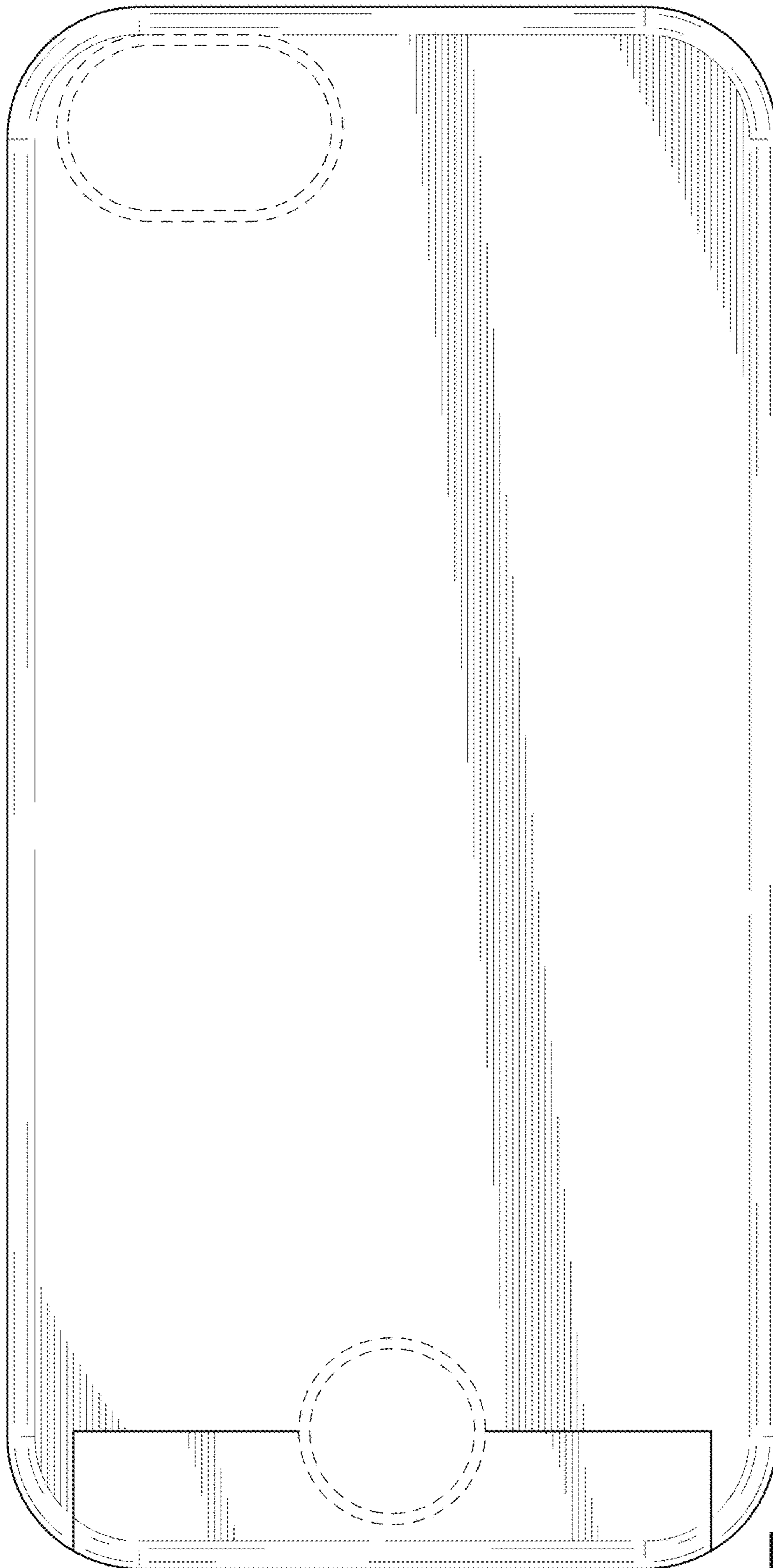

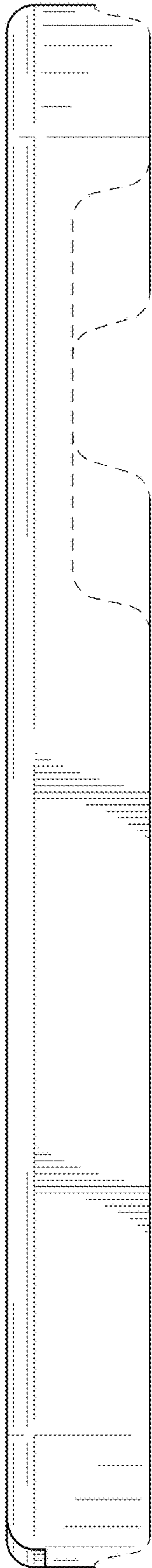

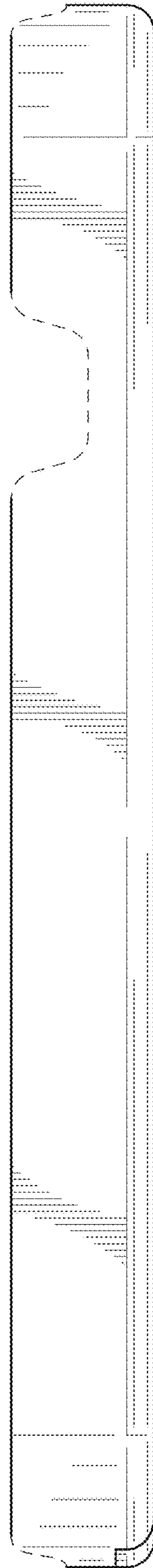

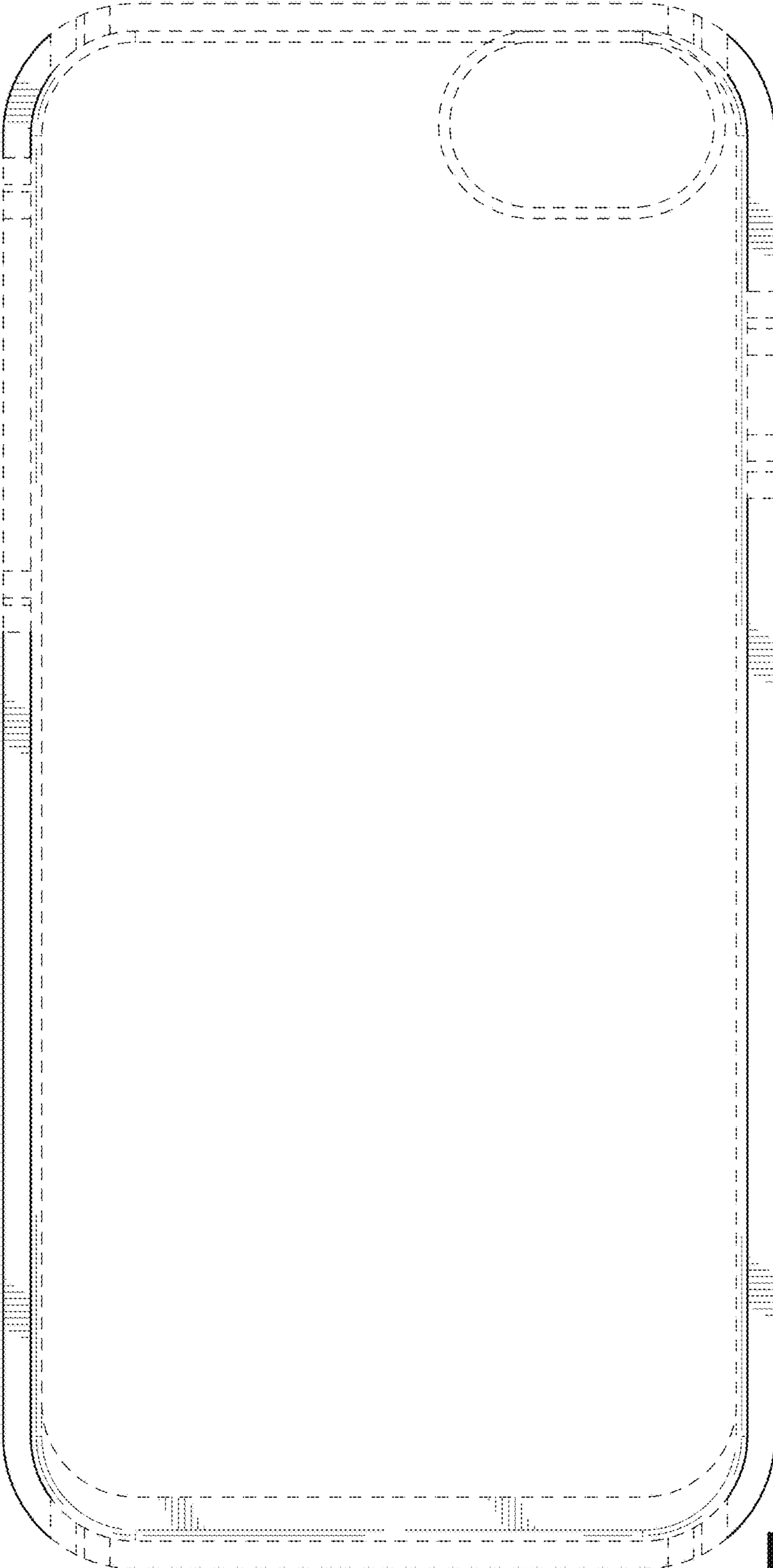

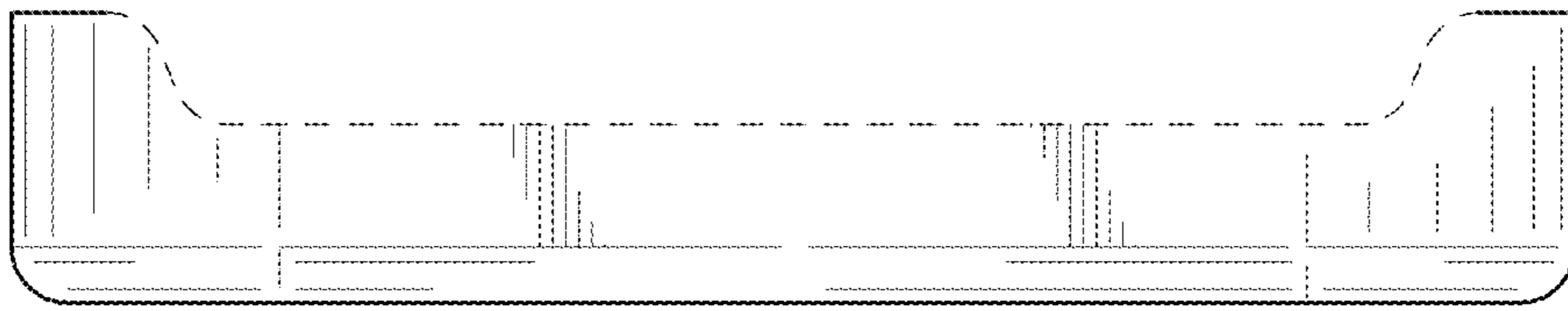

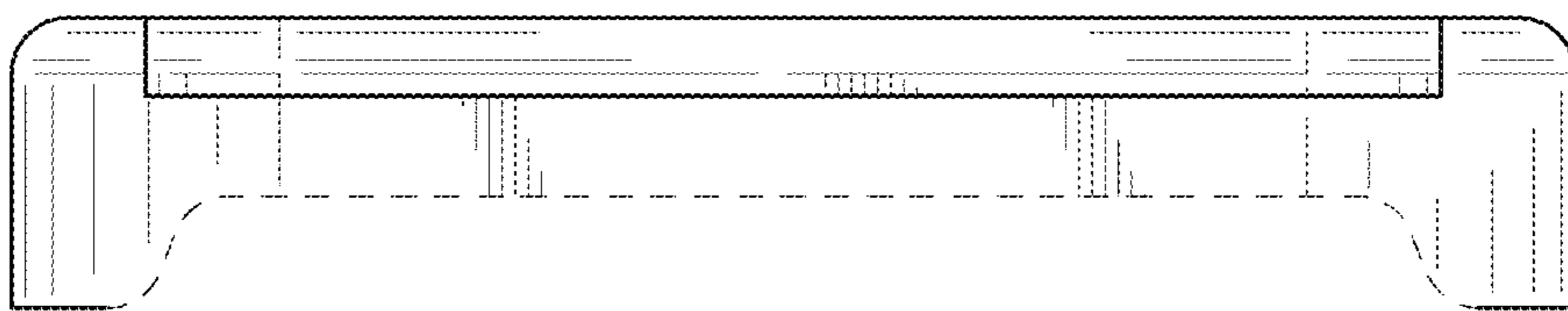
