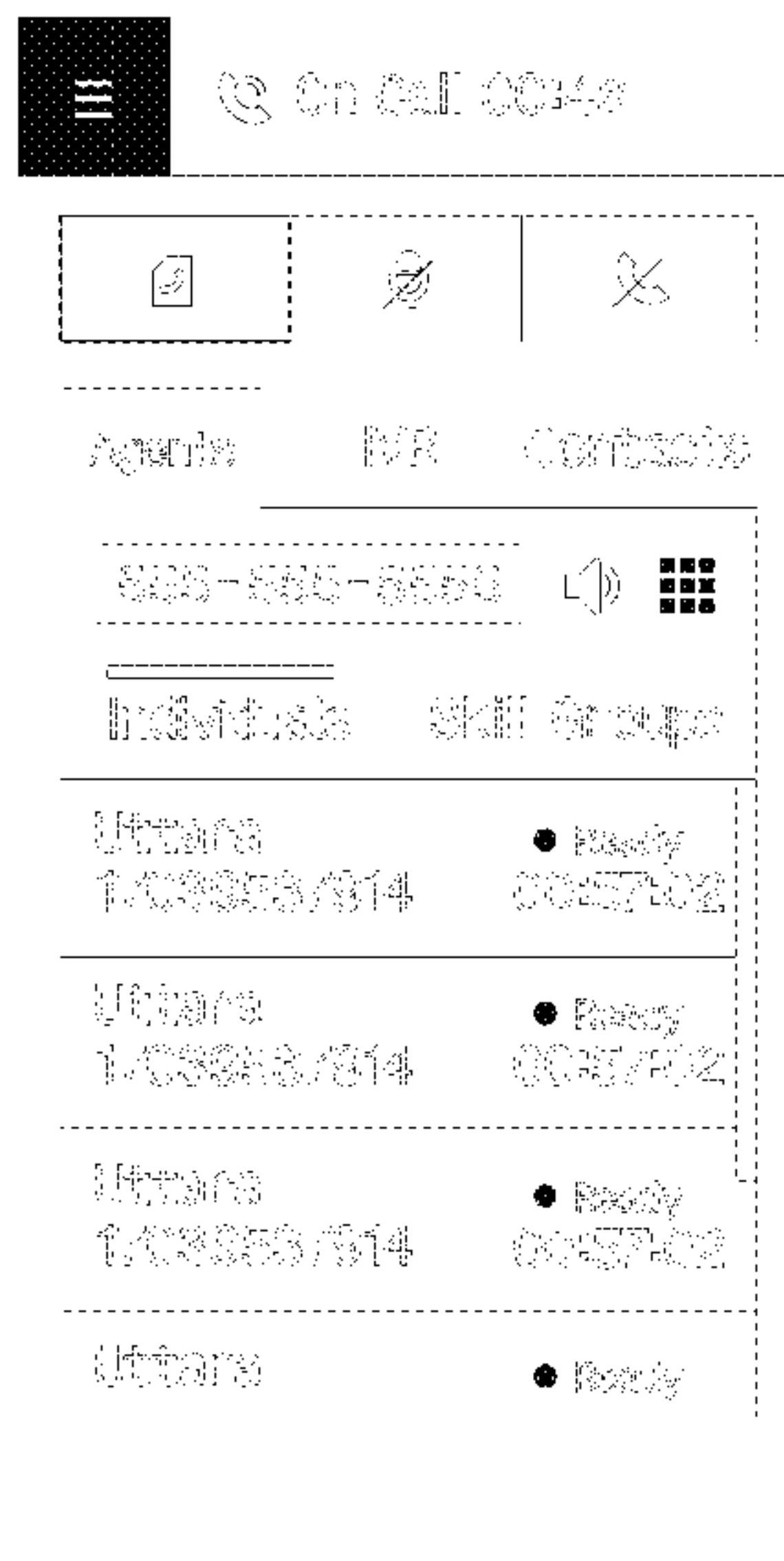
CLAIM
