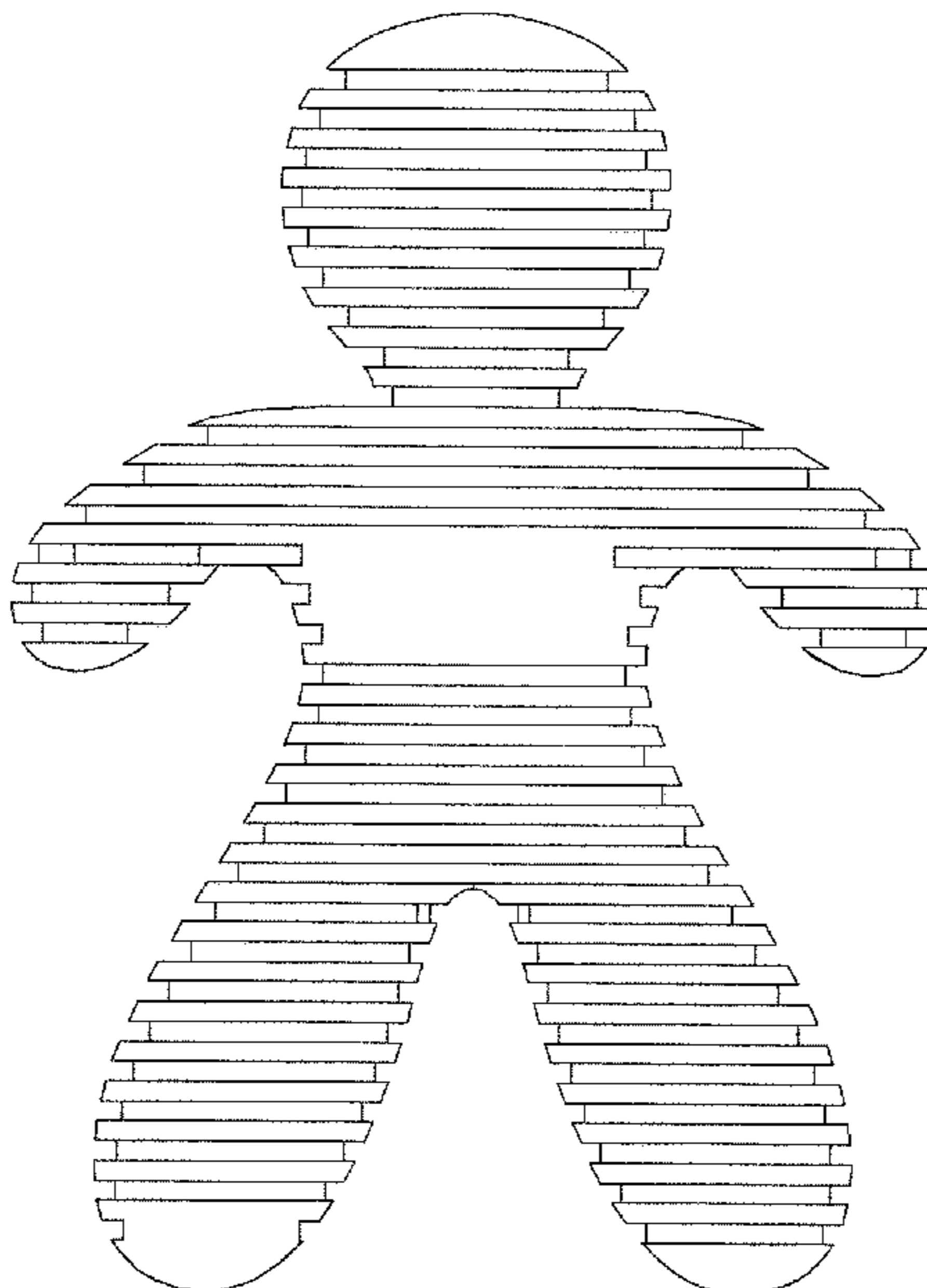

The ornamental design for an air freshener, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an air freshener according to my new design;
FIG. 2 is a rear elevational view of the air freshener of FIG. 1;
FIG. 3 is a right side elevational view of the air freshener of FIG. 1;
FIG. 4 is a left side elevational view of the air freshener of FIG. 1;
FIG. 5 is a bottom plan view of the air freshener of FIG. 1; and,

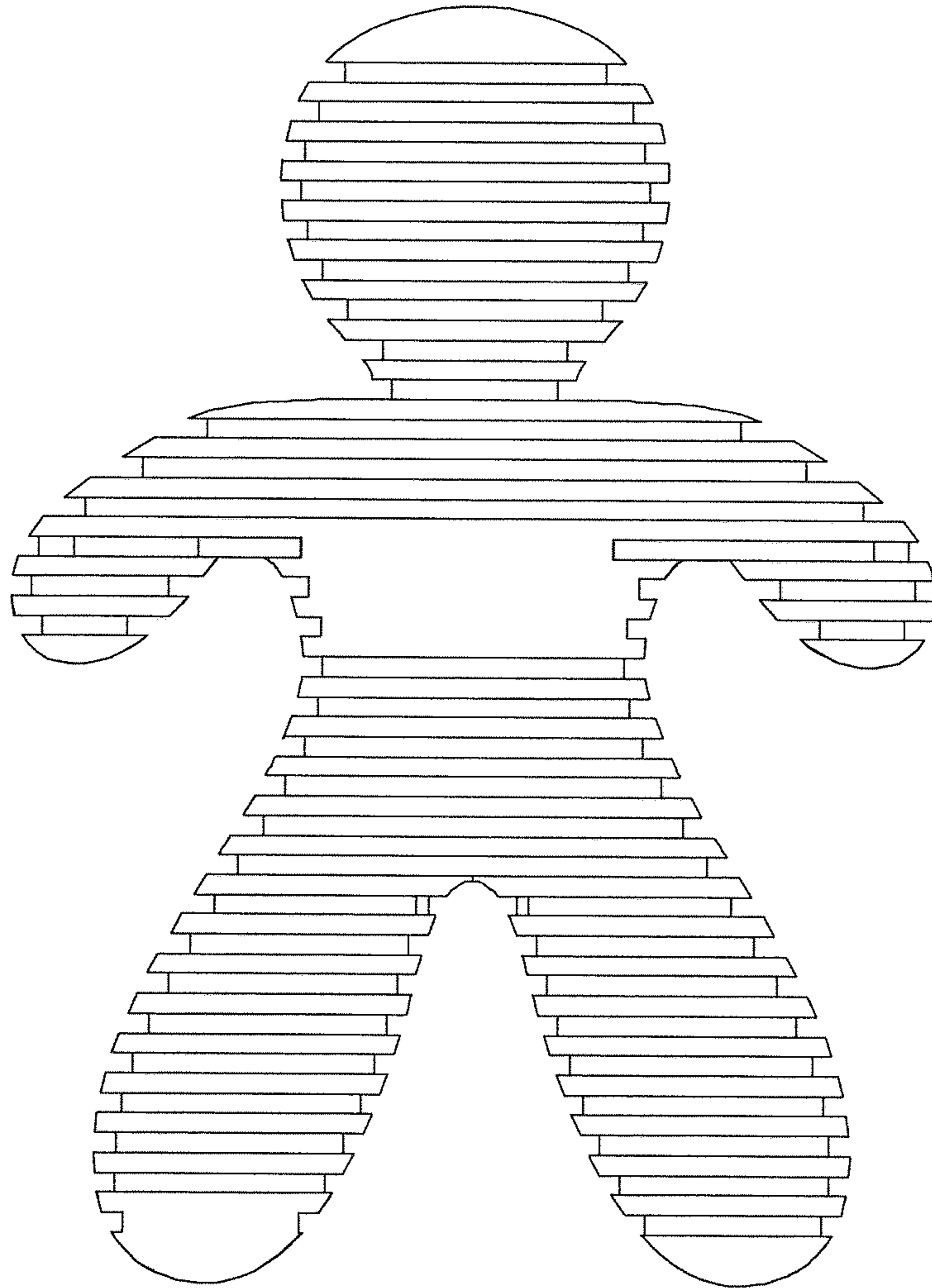

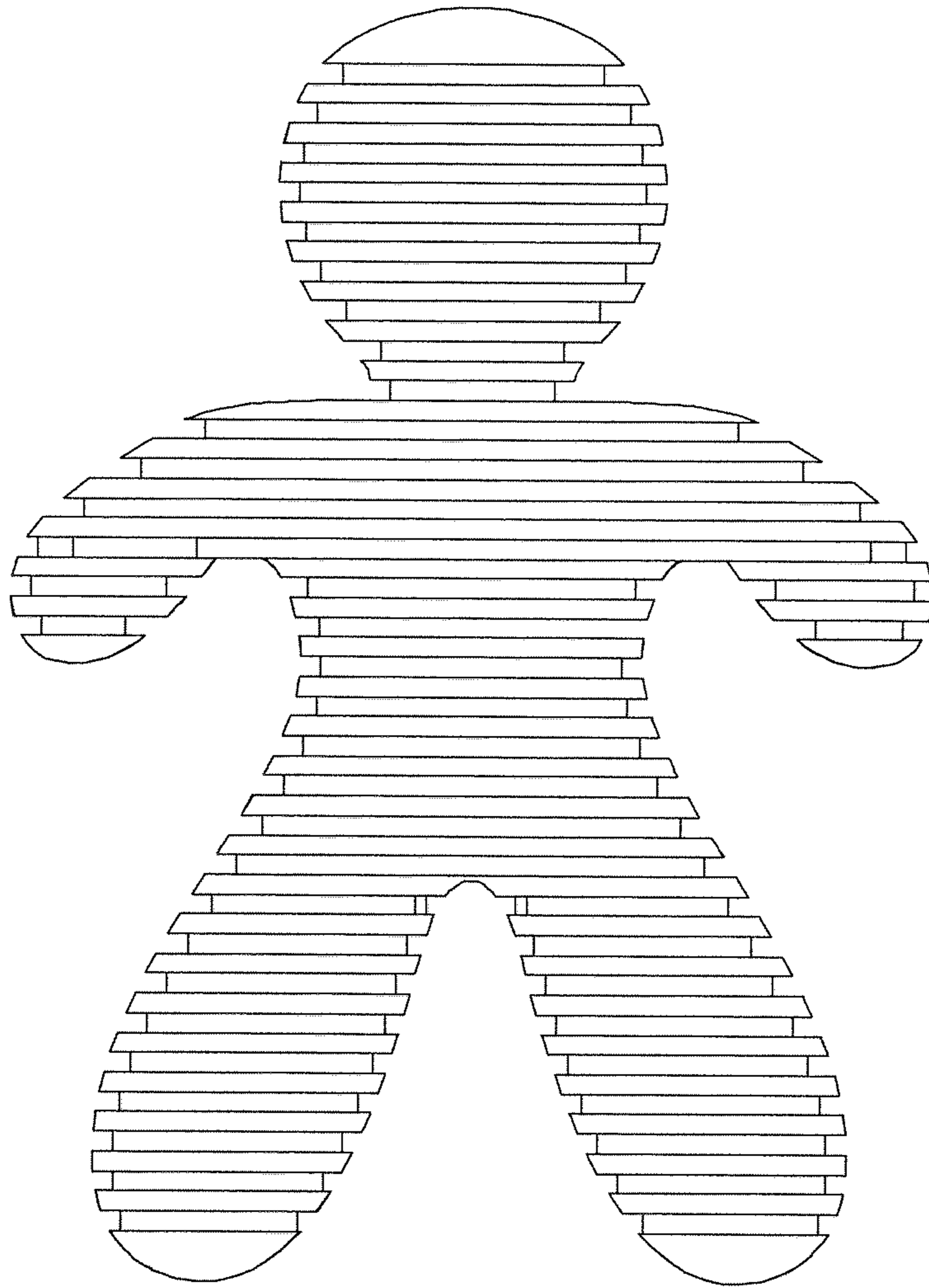

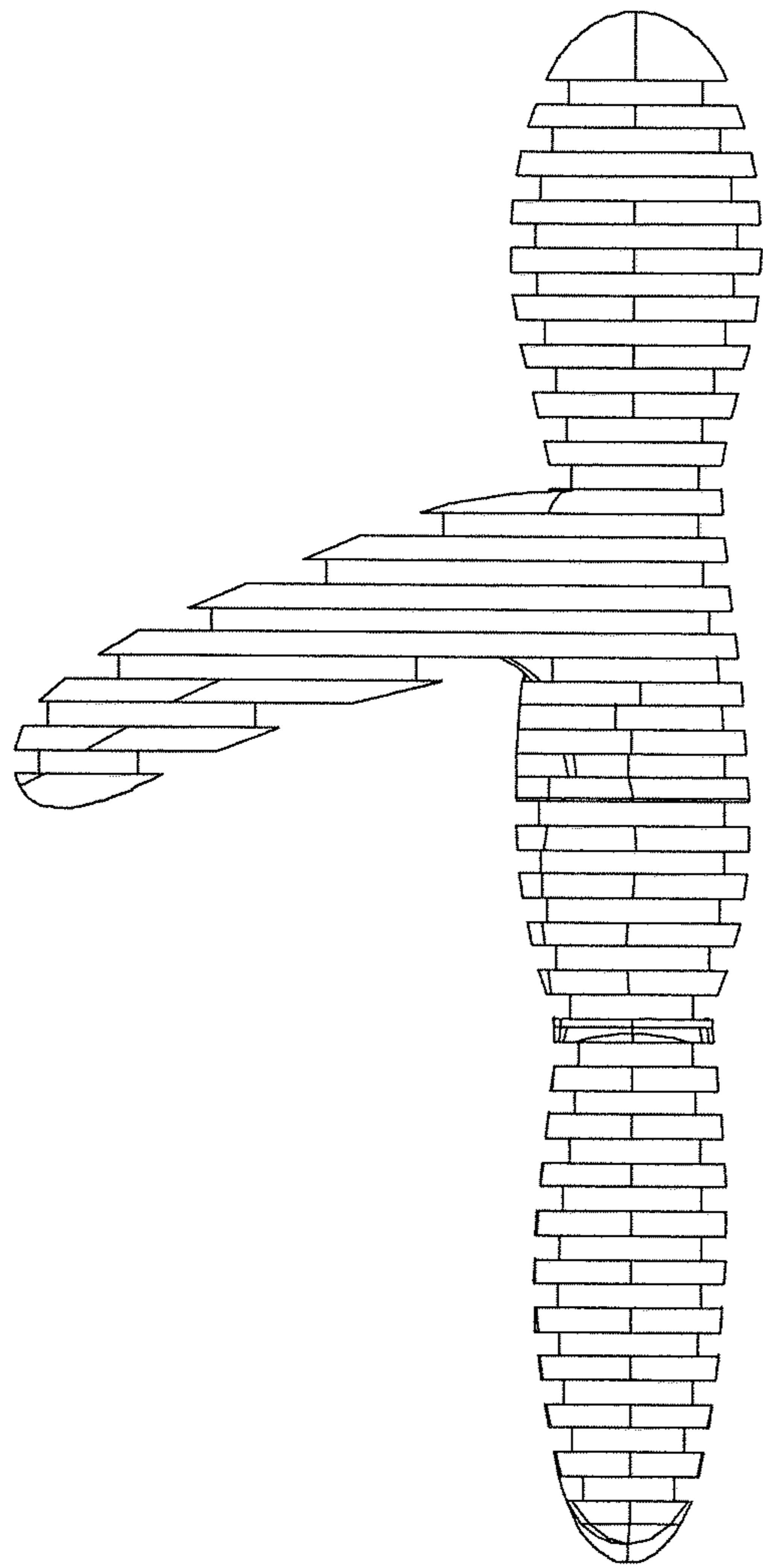

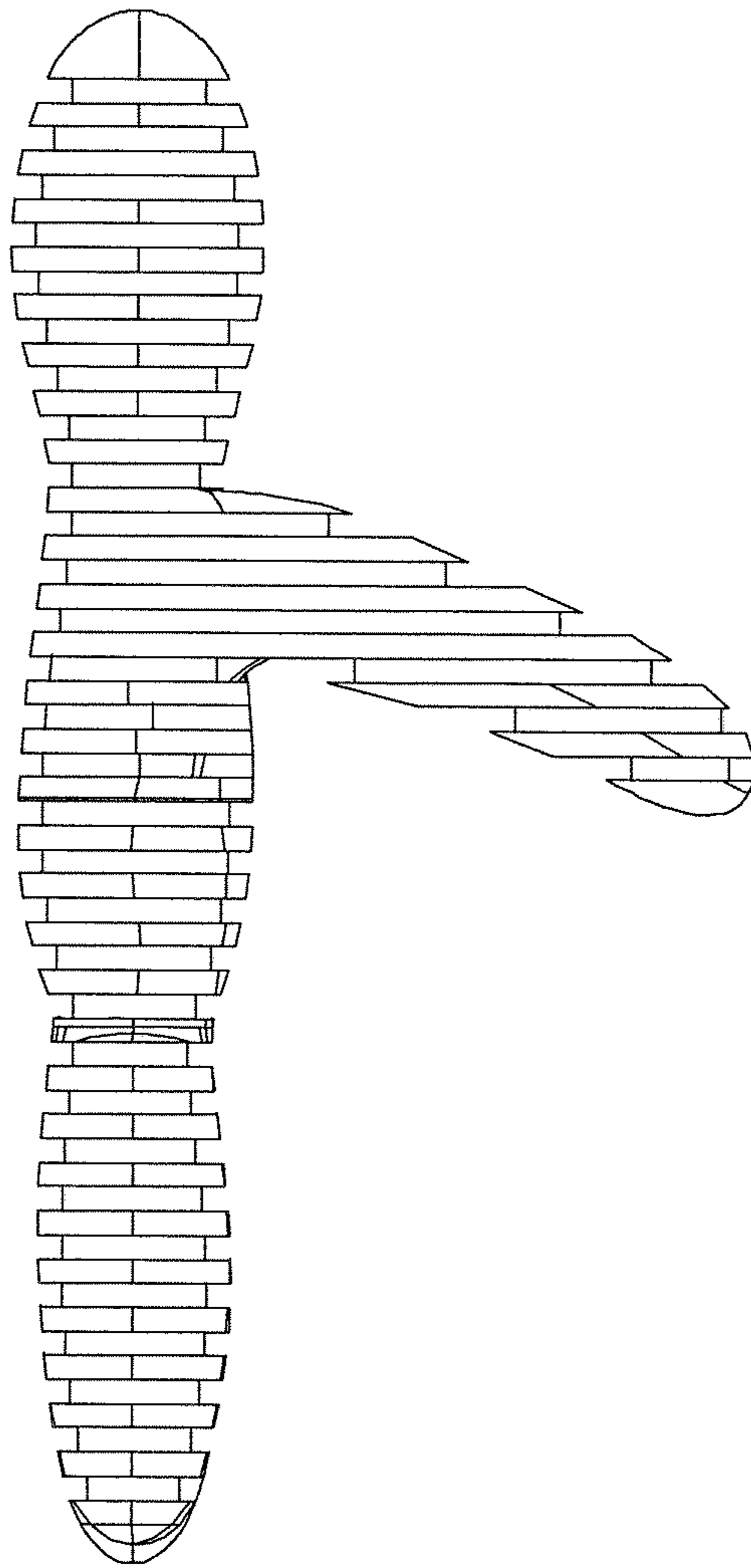

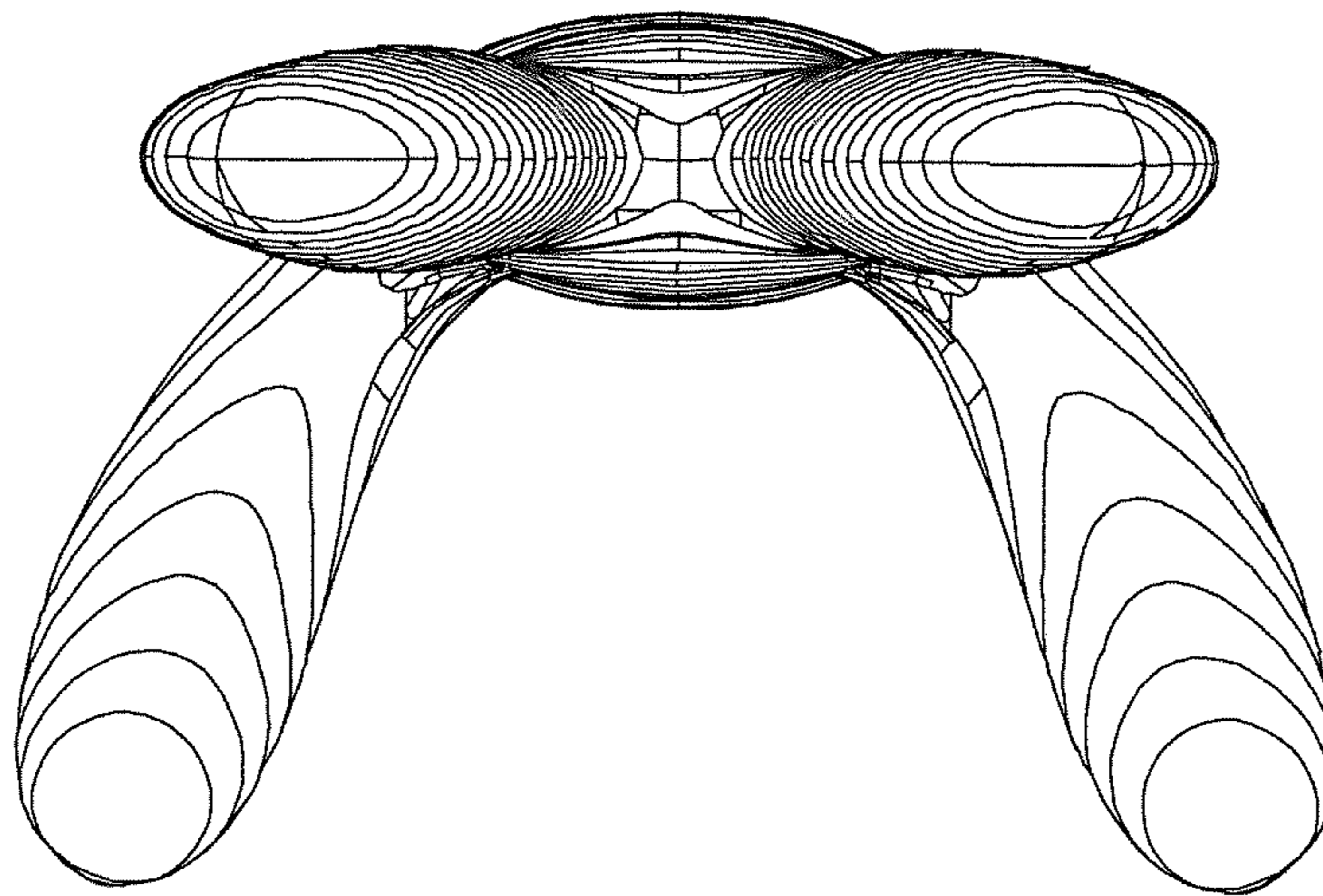

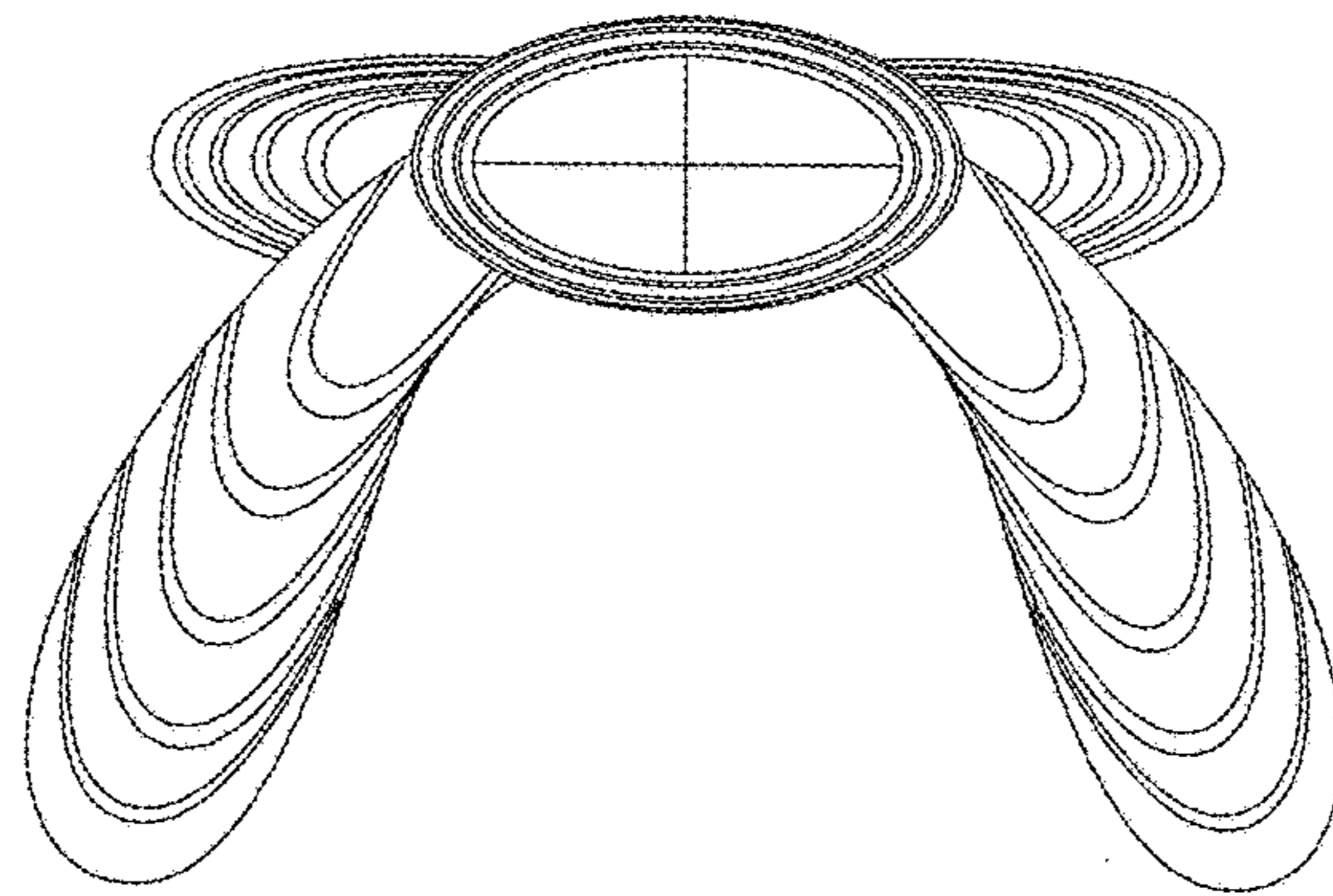
