(57) **CLAIM**

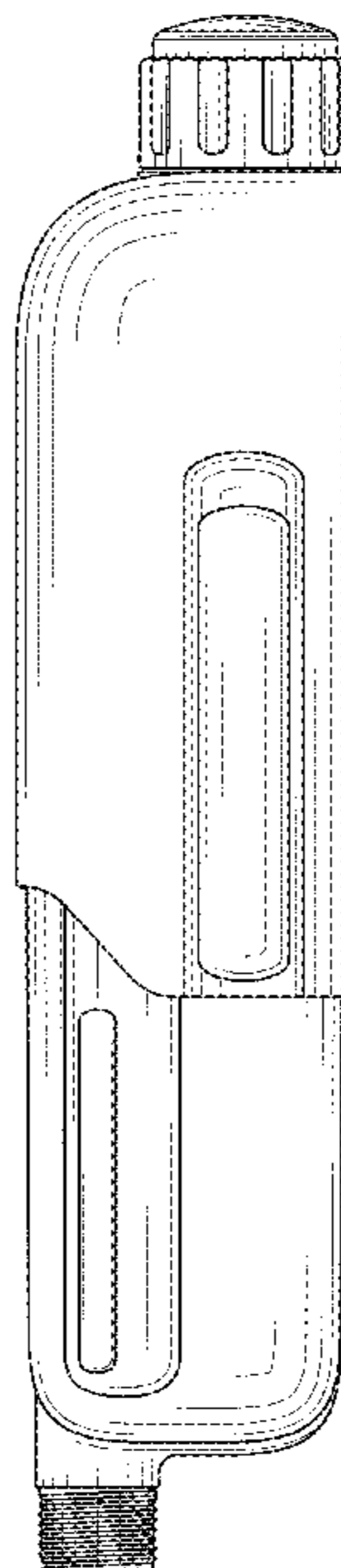
The ornamental injection device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the injection device;  
FIG. 2 is a bottom view of the injection device;  
FIG. 3 is a right side view of the injection device;  
FIG. 4 is a left side view of the injection device;  
FIG. 5 is front end view of the injection device;  
FIG. 6 is a rear end view of the injection device; and,

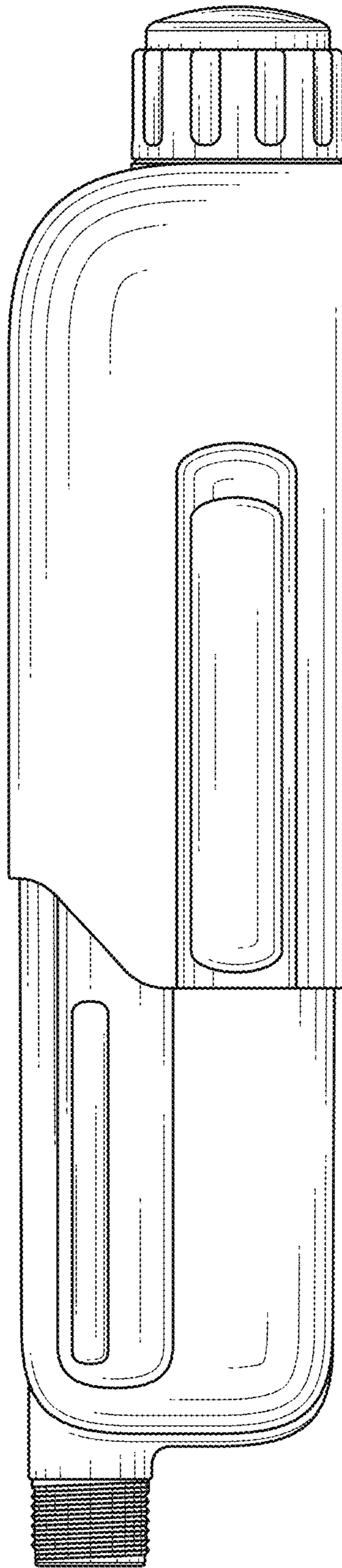

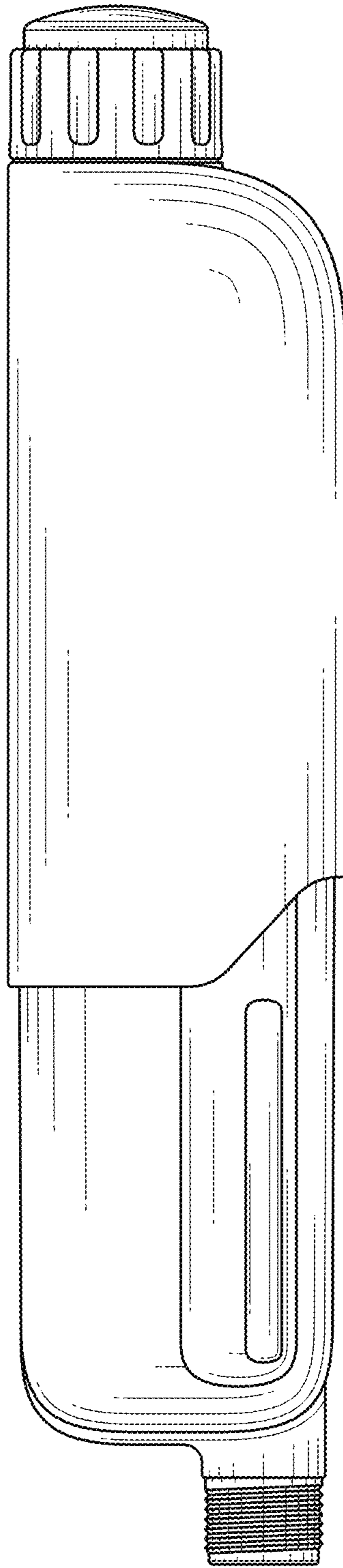

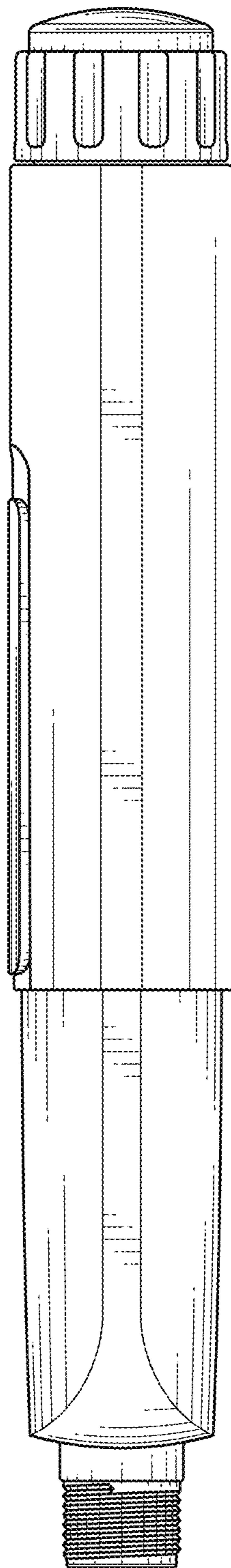

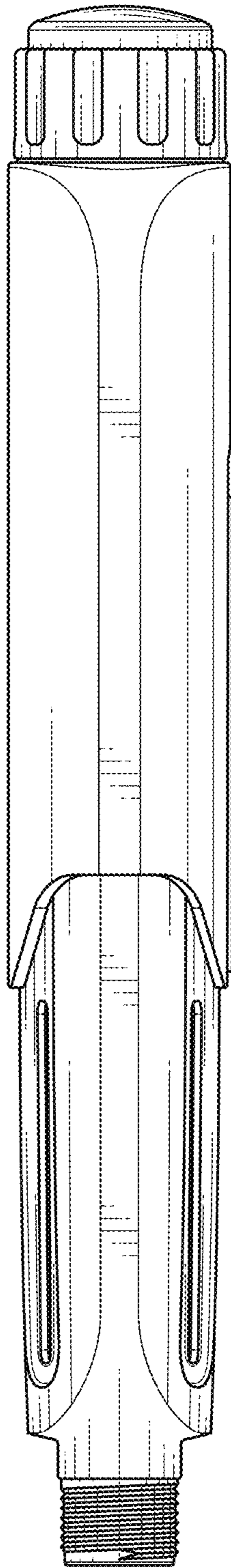

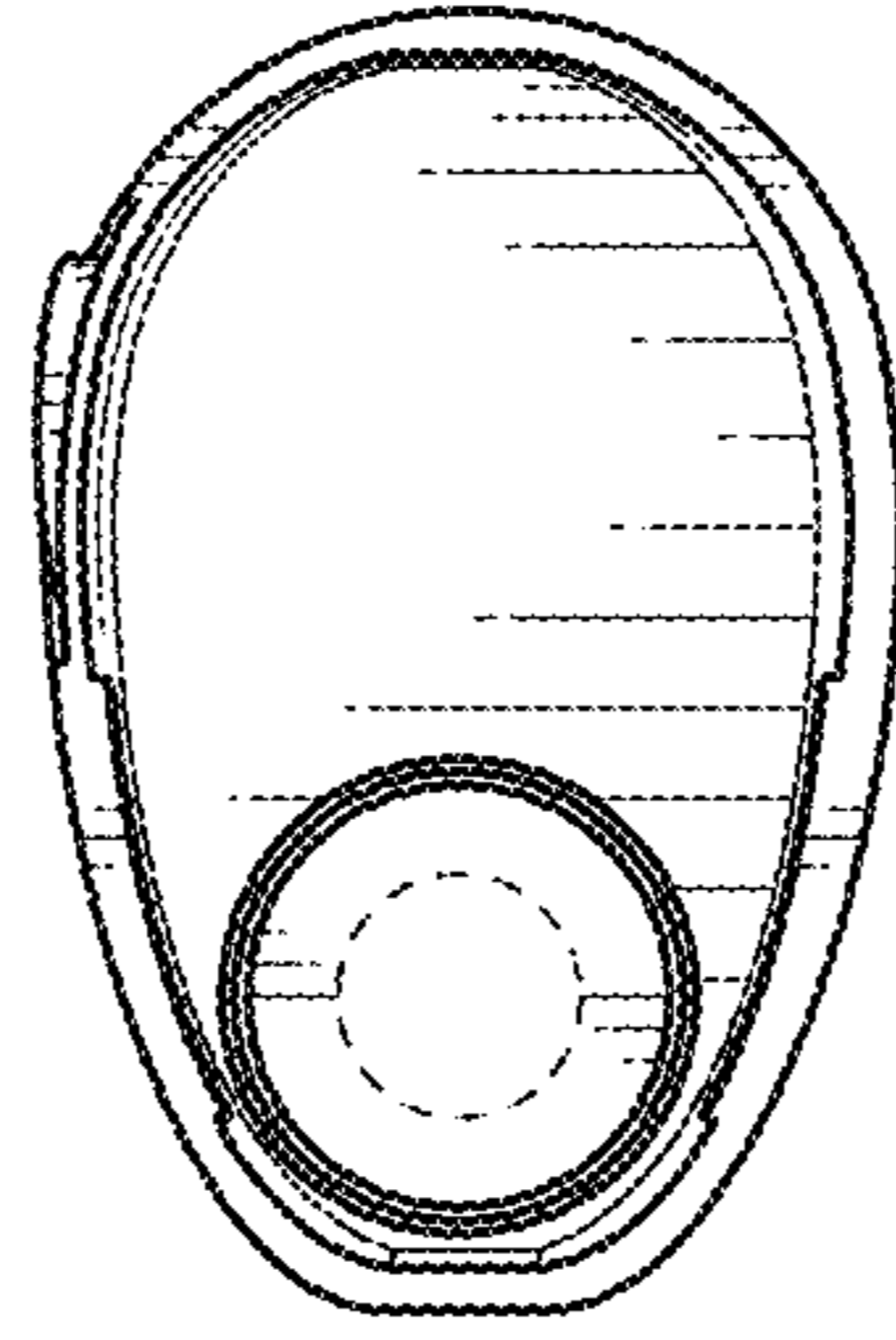

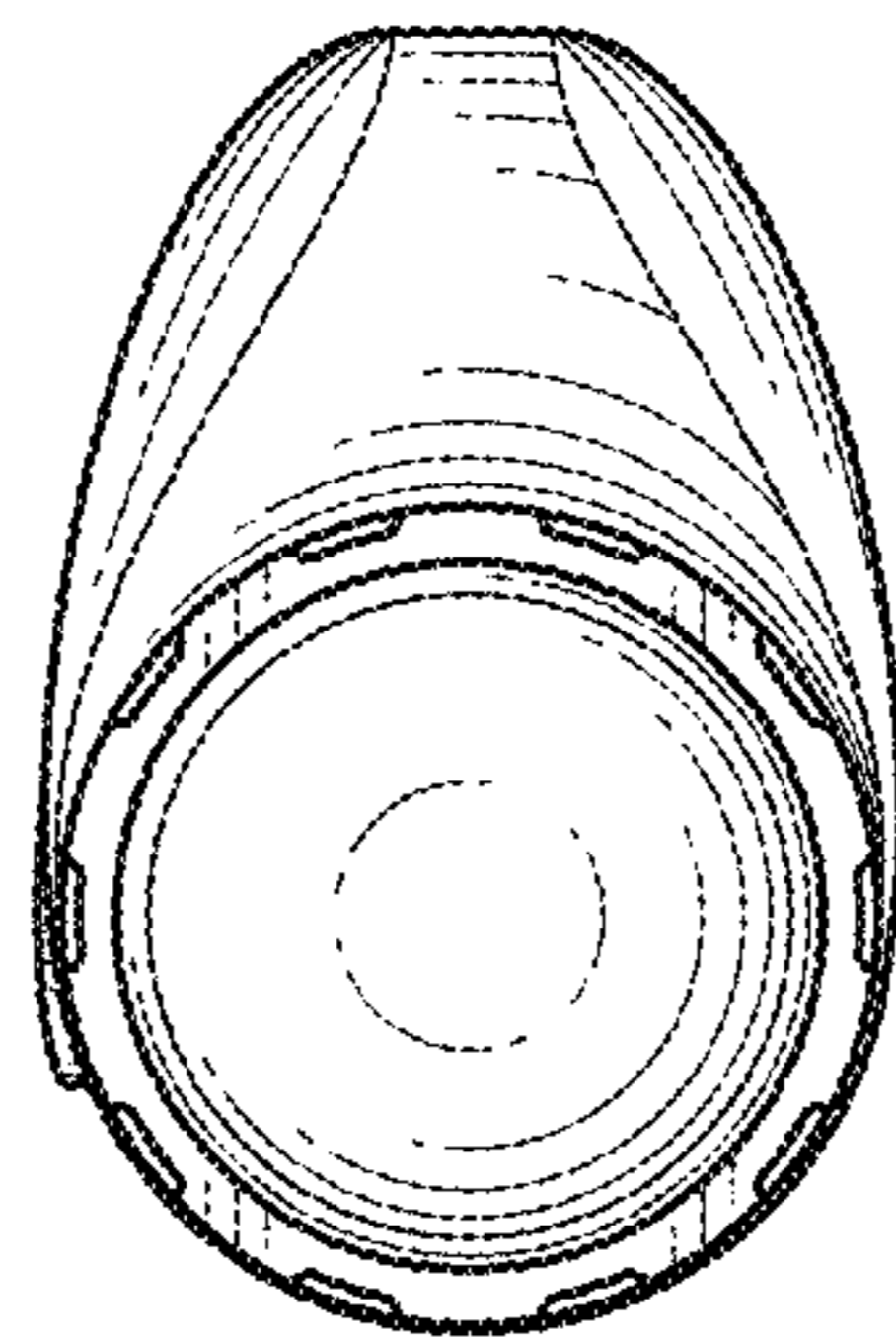

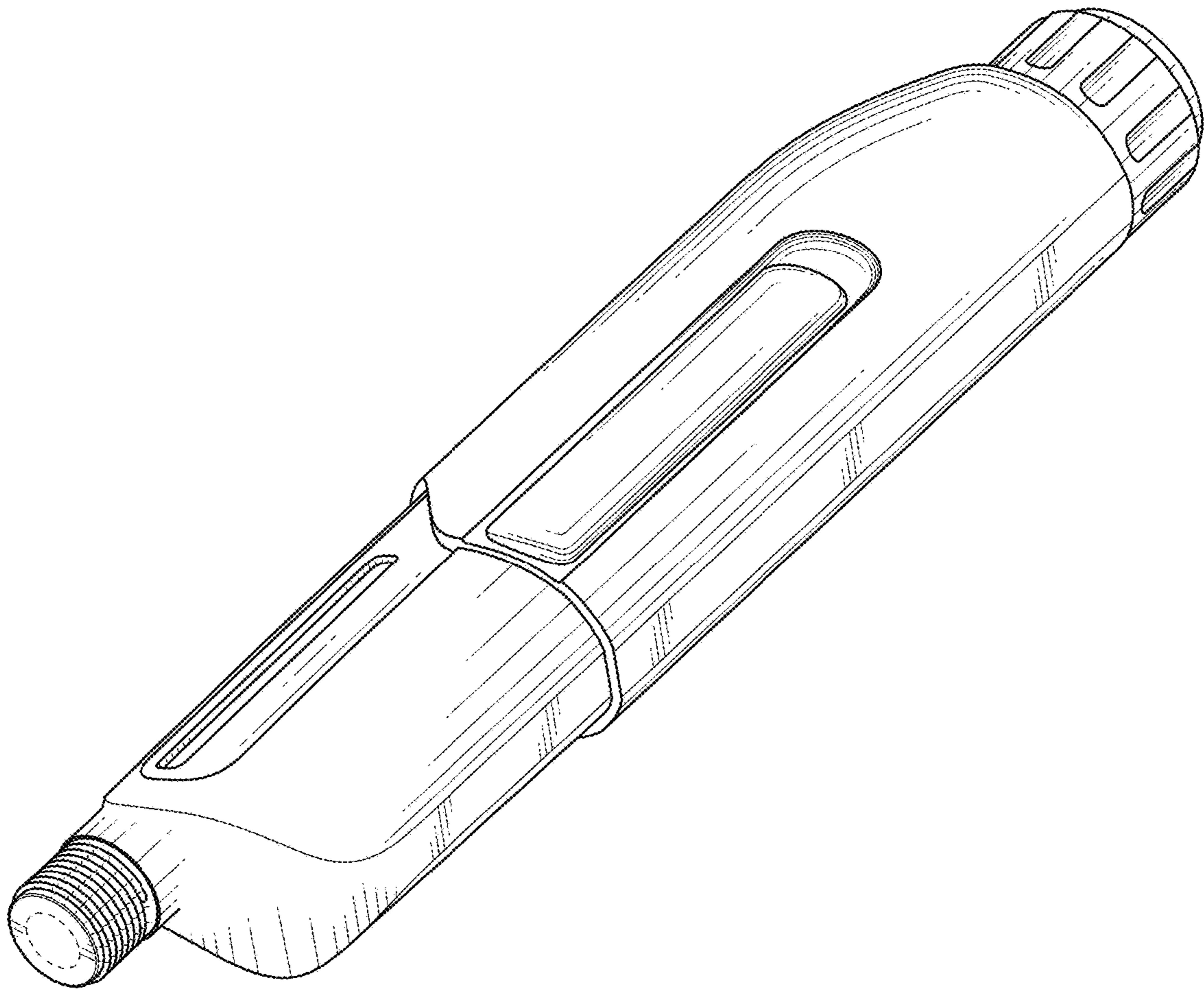
