(57) **CLAIM**

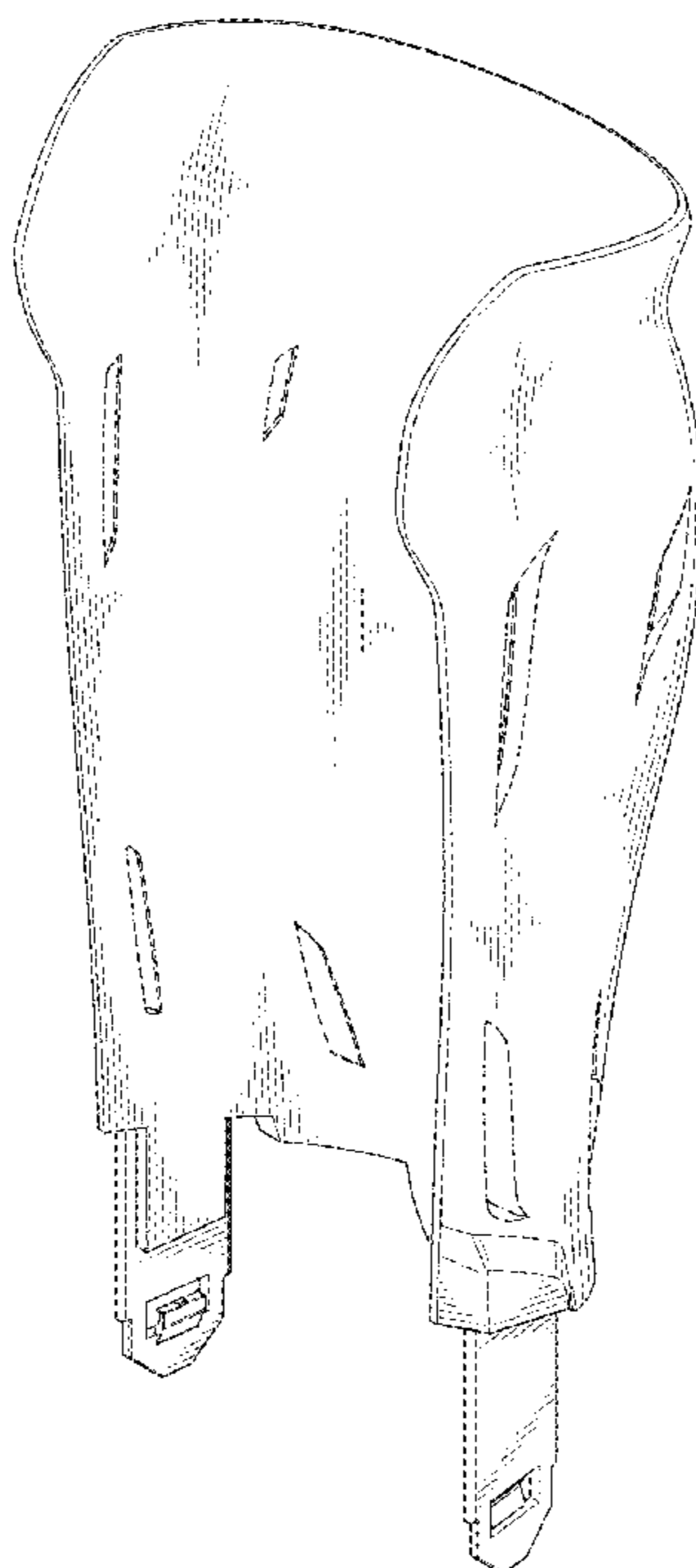
The ornamental design for a leg supporting frame for rehabilitation shoe, as shown.

FIG. 1 is a perspective view of a leg supporting frame for rehabilitation shoe showing my new design;

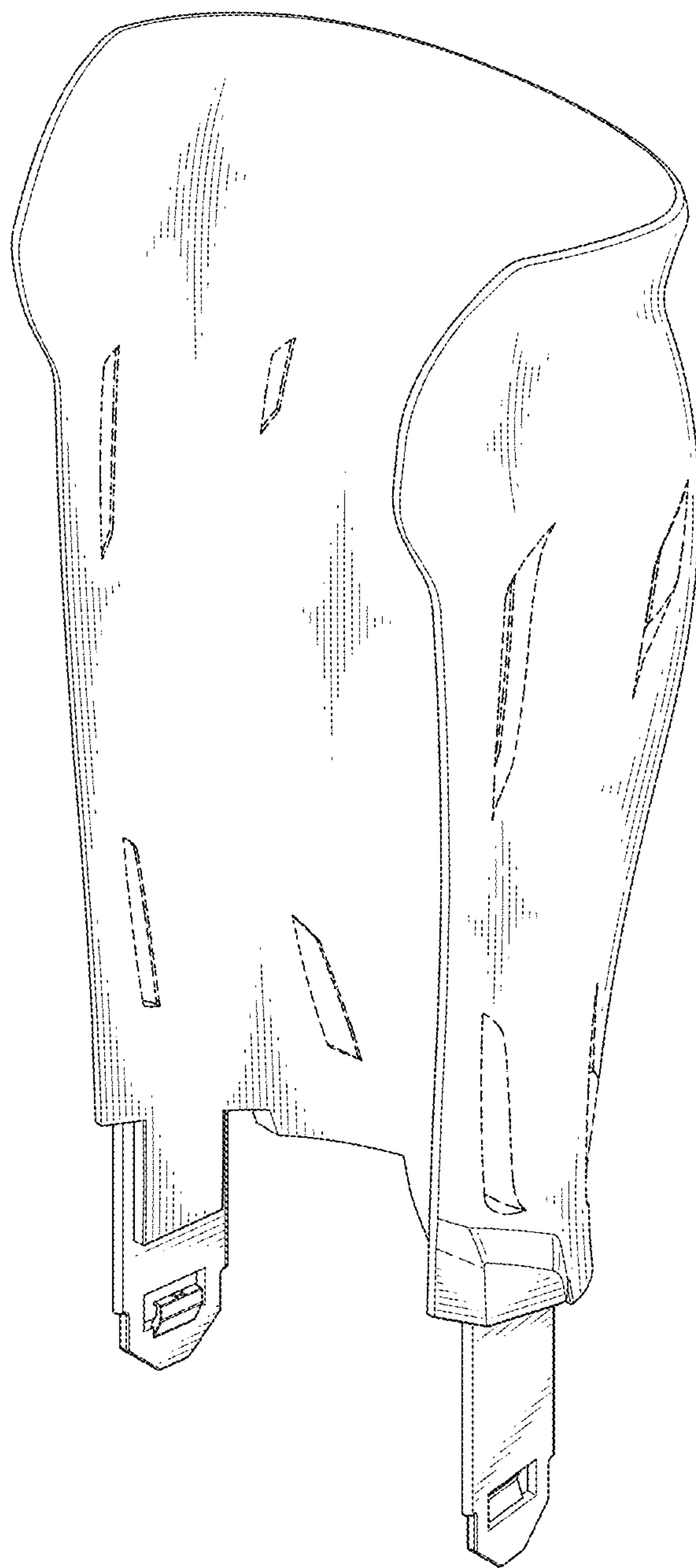

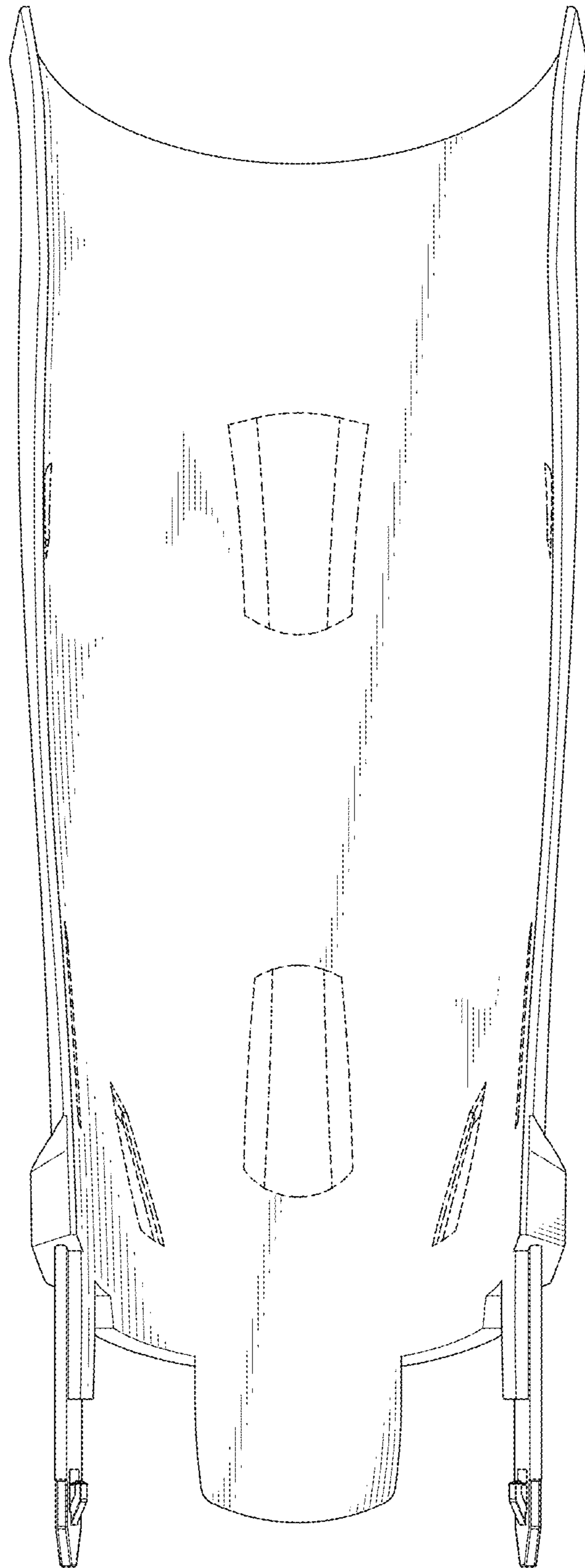

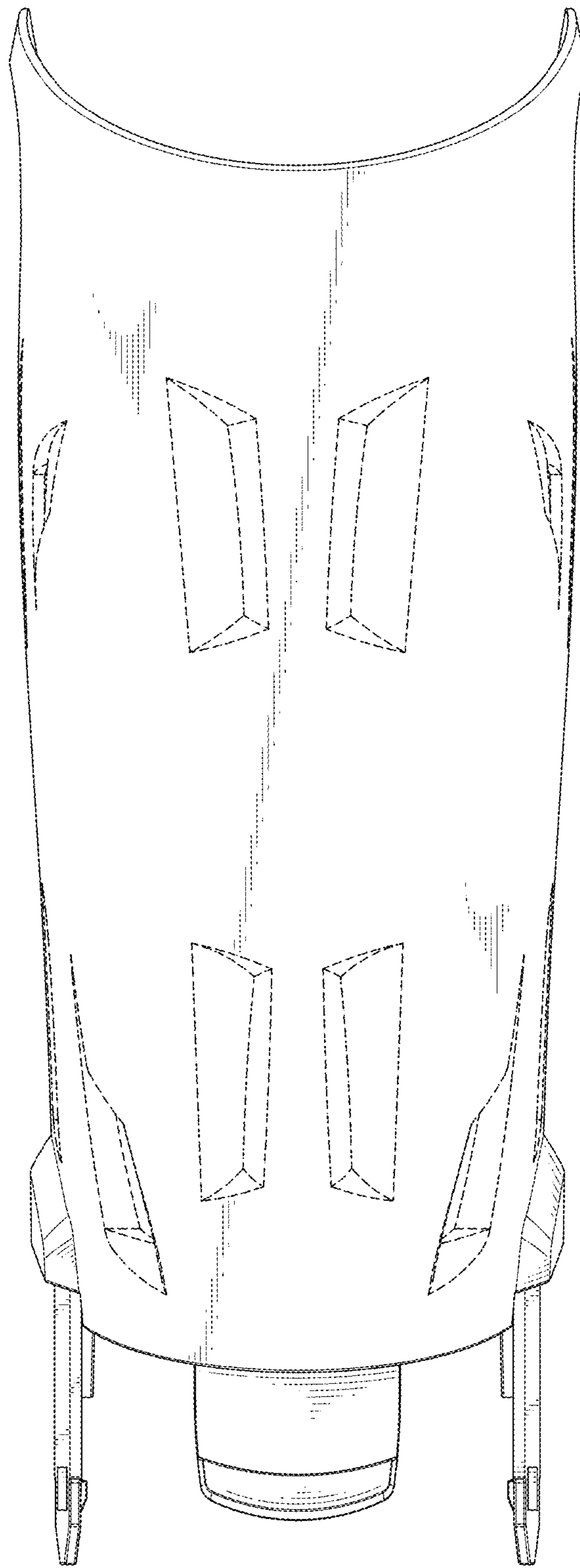

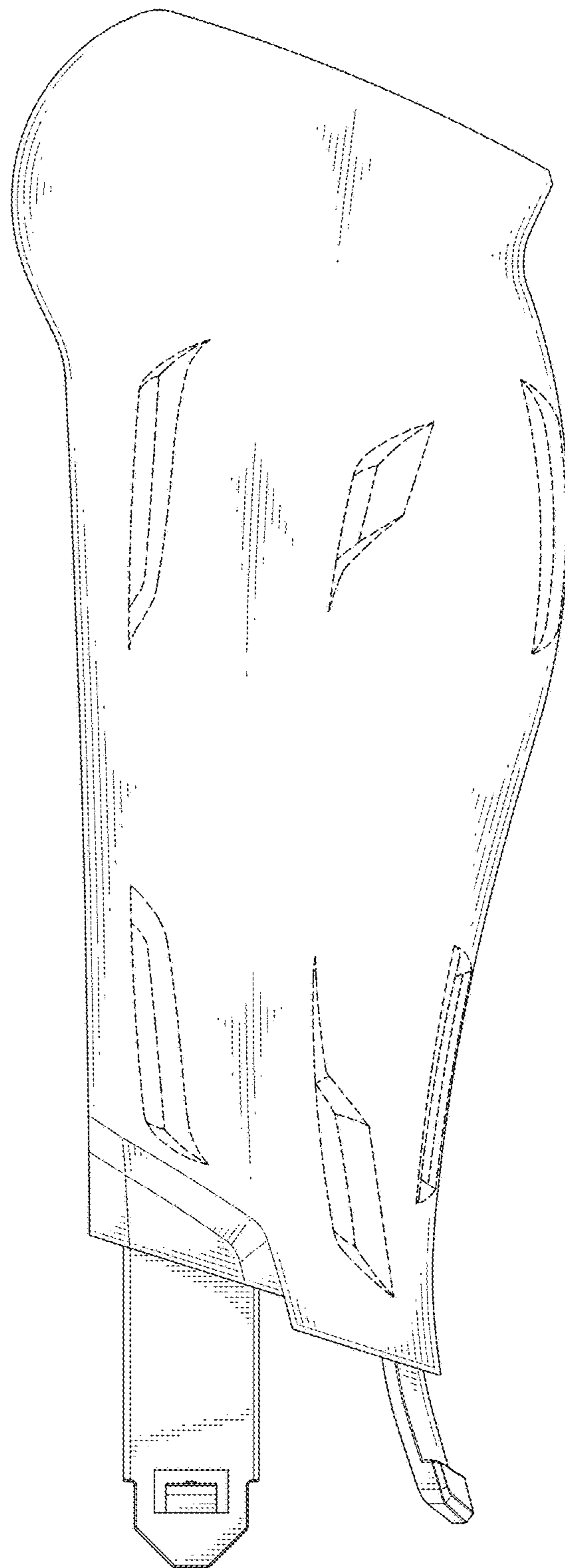

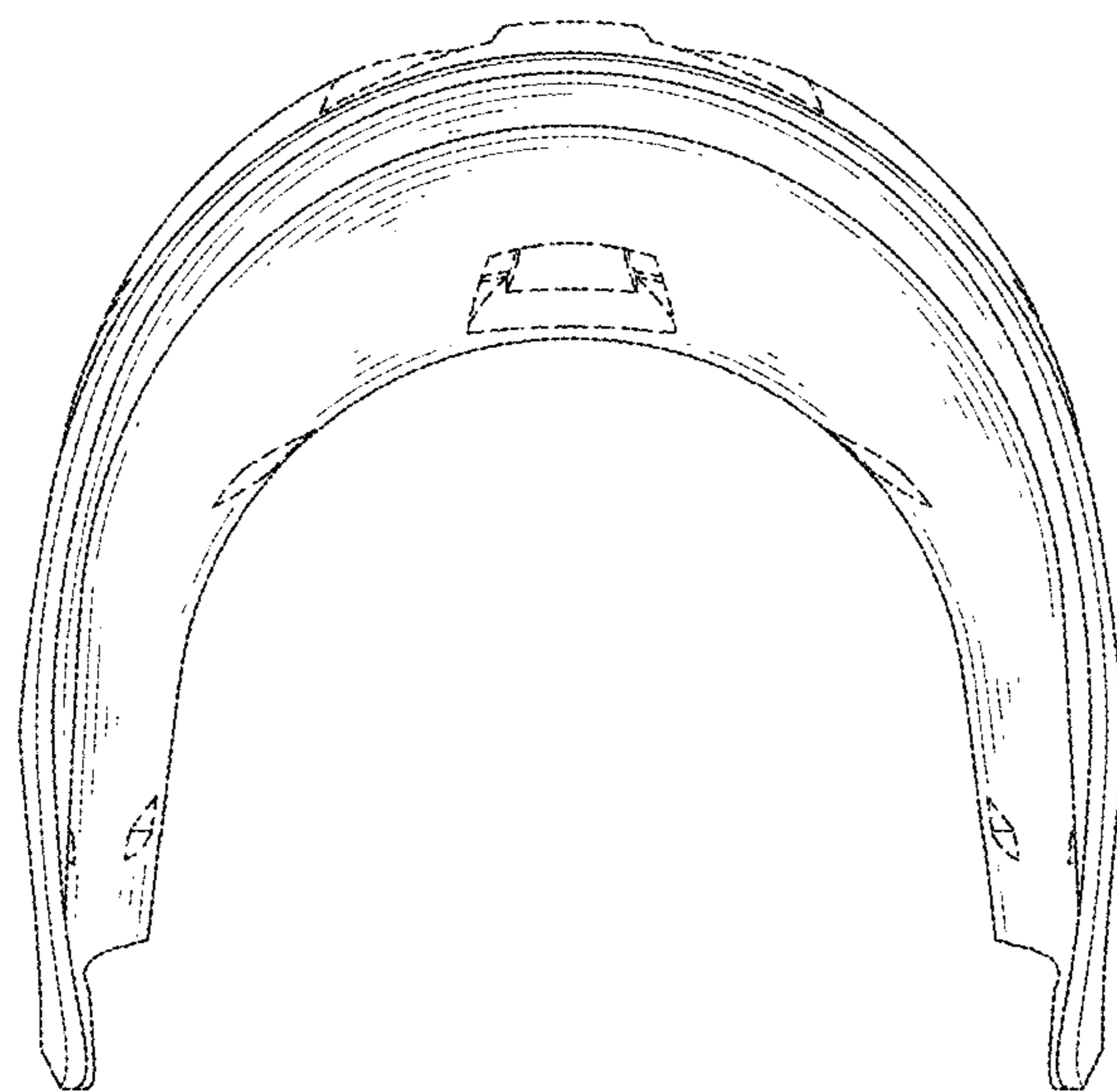

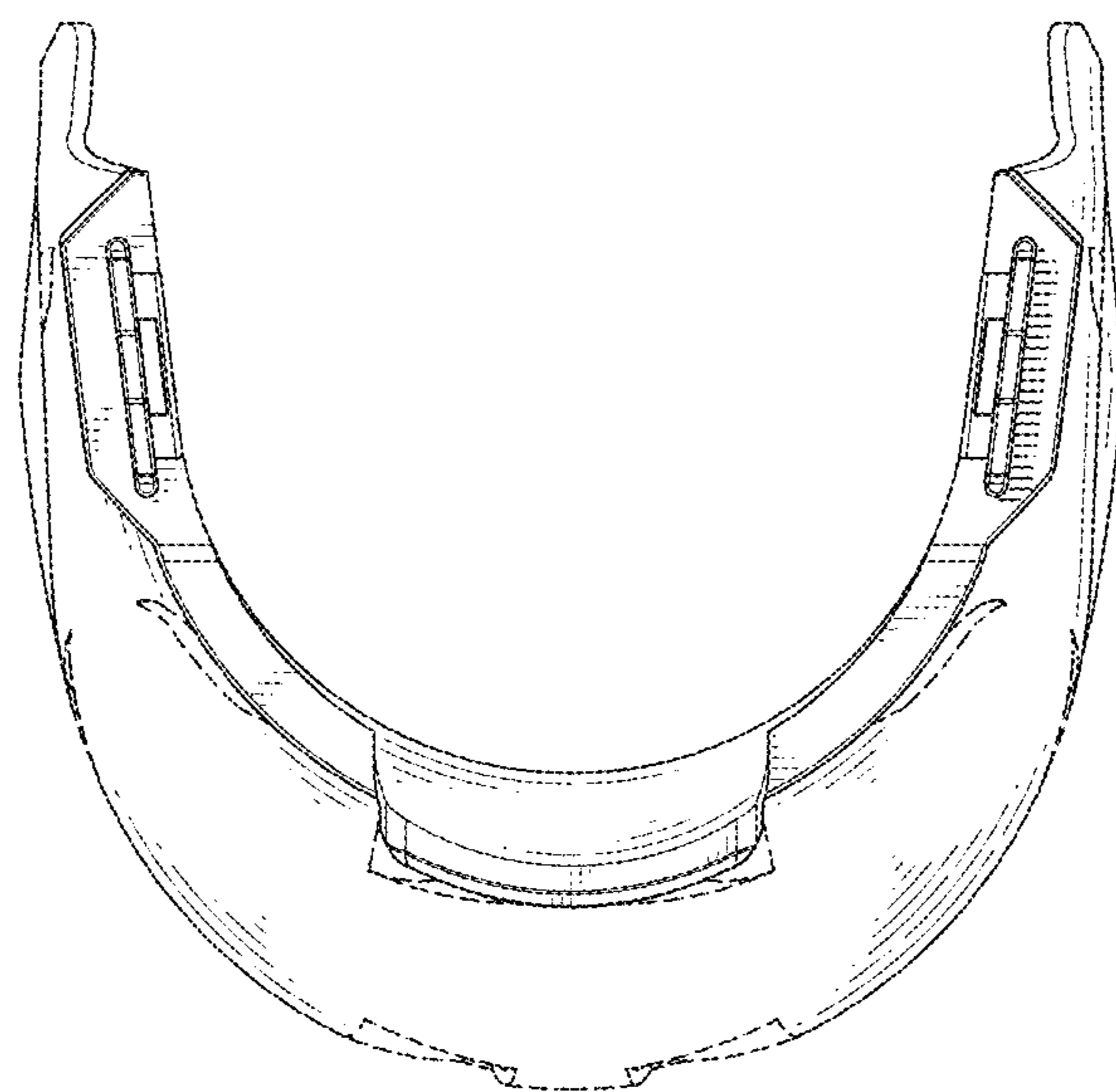

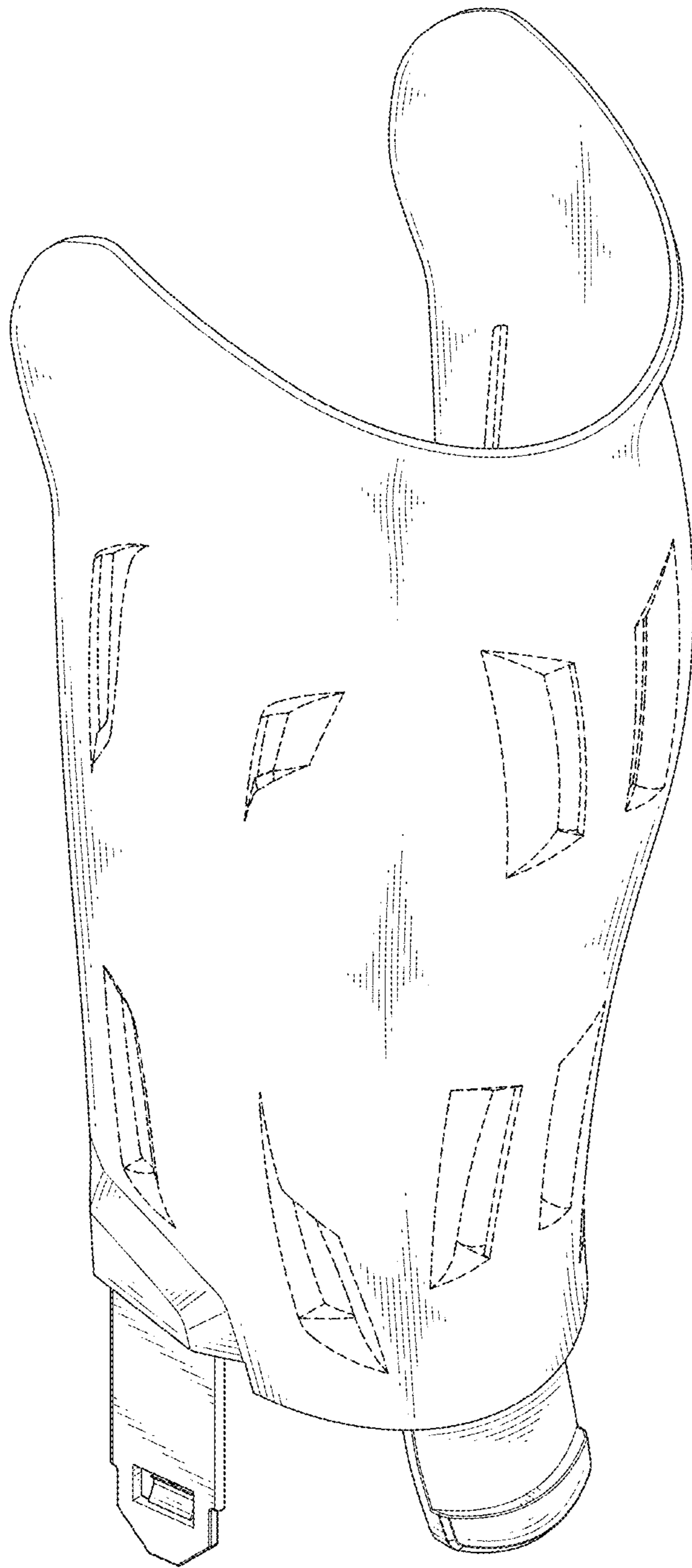

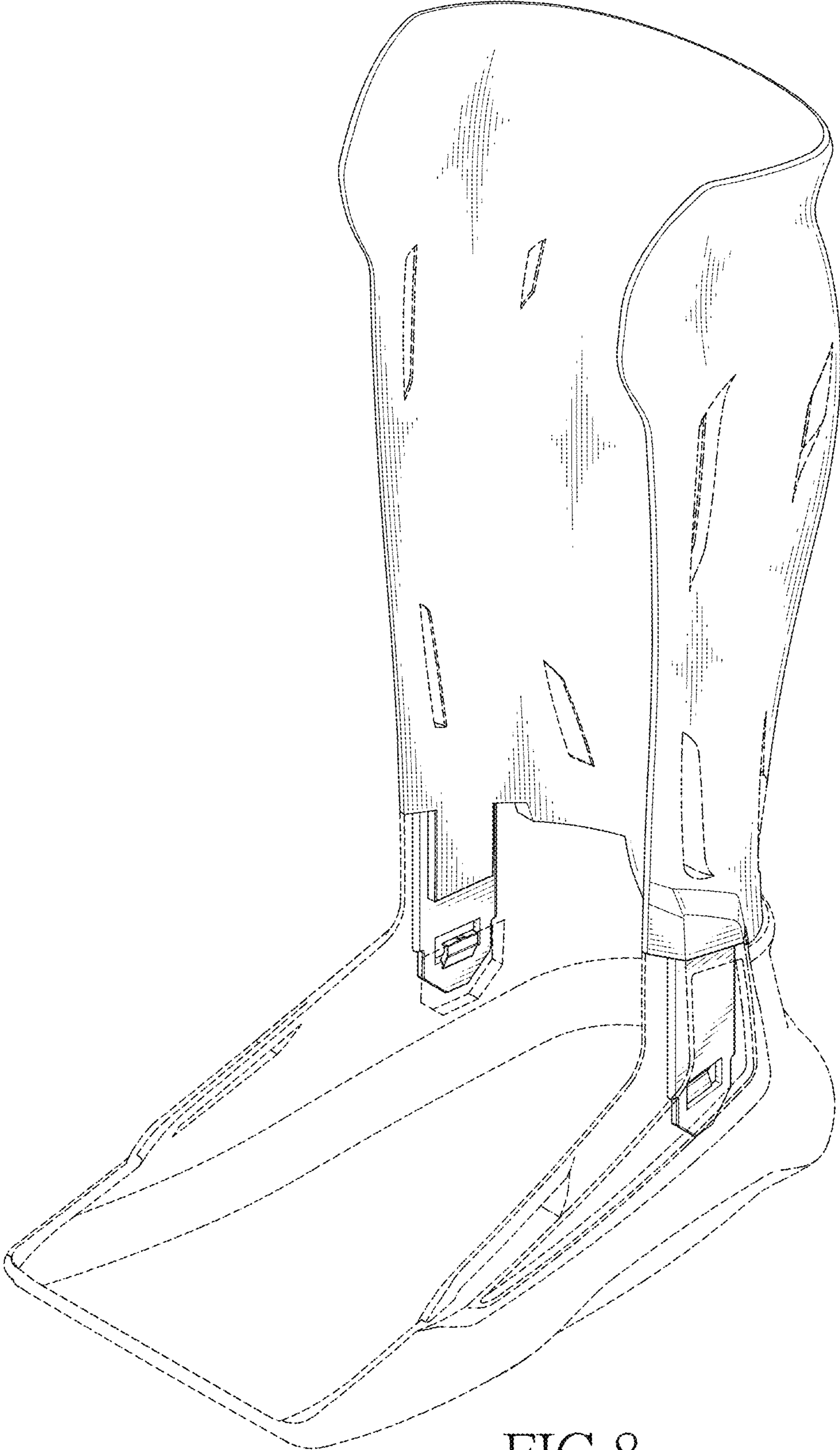
