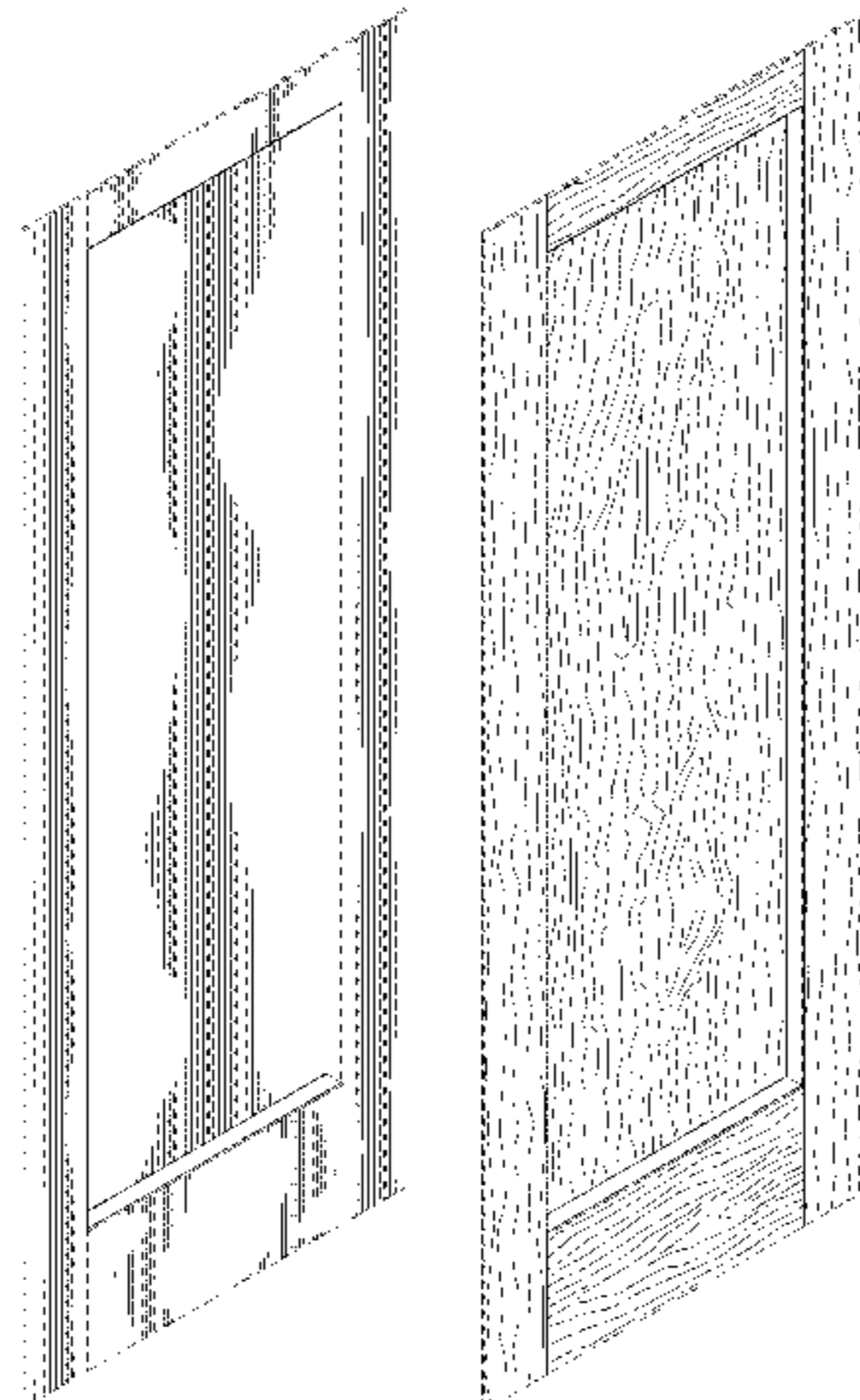
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of our design;

FIG. 9 is a left side elevational view;  
FIG. 10 is a cross-sectional view taken along the line 10-10 of FIG. 2;

FIG. 13 is a rear elevational view;  
FIG. 14 is a top plan view;  
FIG. 15 is a bottom plan elevational view;  
FIG. 16 is a cross-sectional view taken along the line 16-16 of FIG. 12;  
FIG. 17 fragmentary cross-sectional view of a portion of FIG. 16;  
FIG. 18 is a right side elevational view;  
FIG. 19 is a left side elevational view; and,  
FIG. 20 is a cross-sectional view taken along the line 10-10 of FIG. 2.

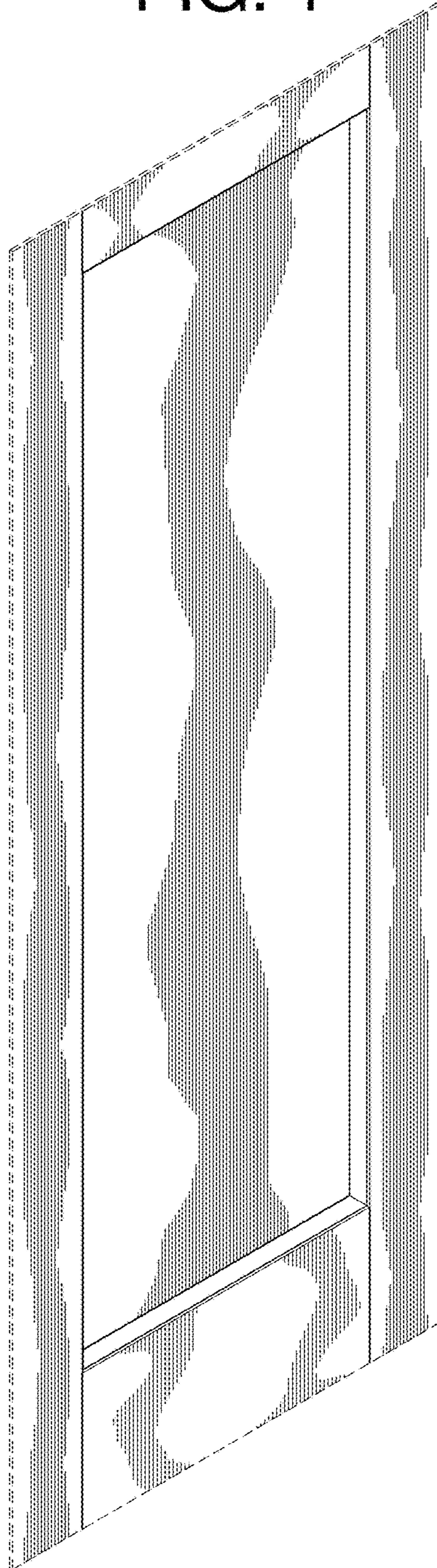

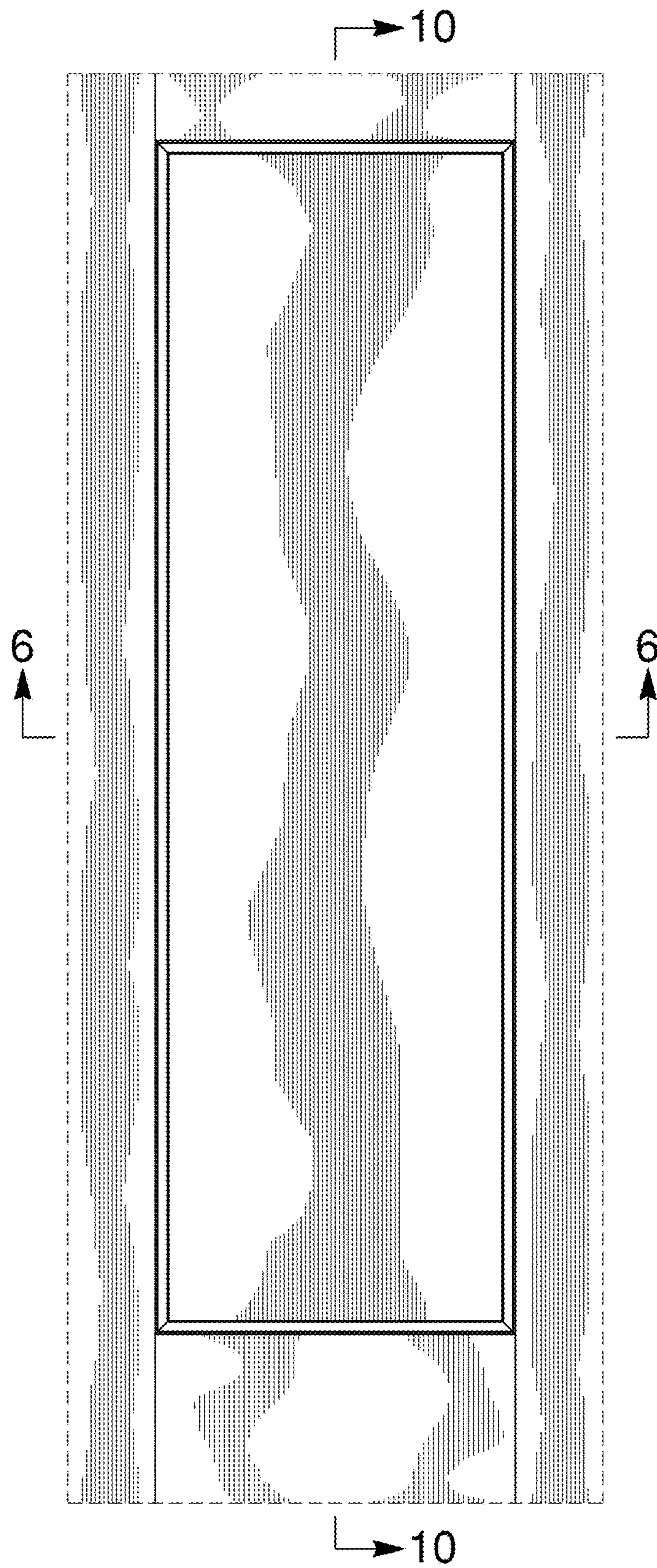

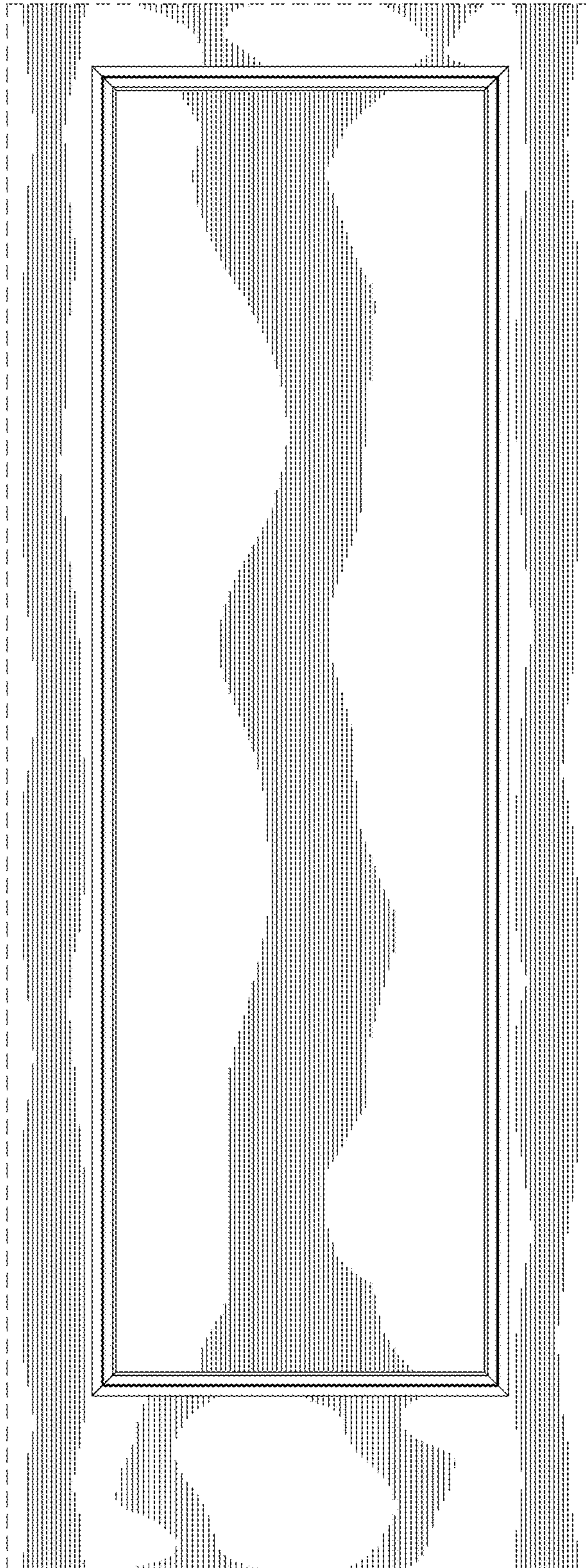

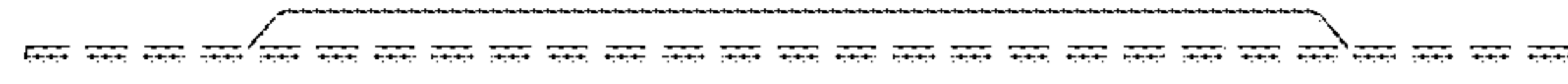

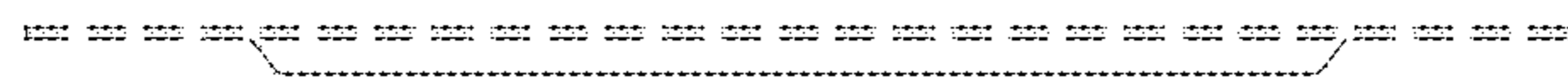

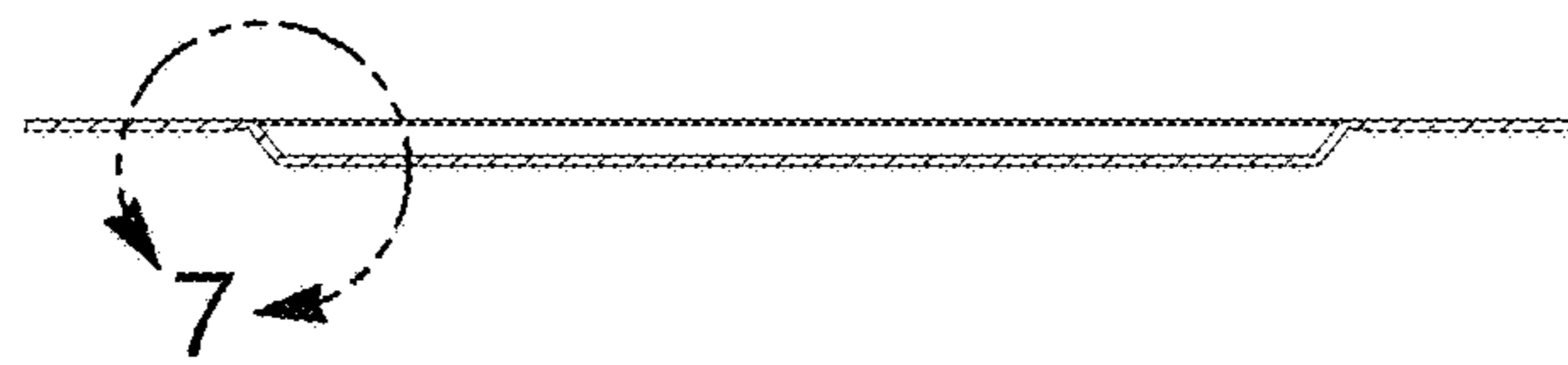

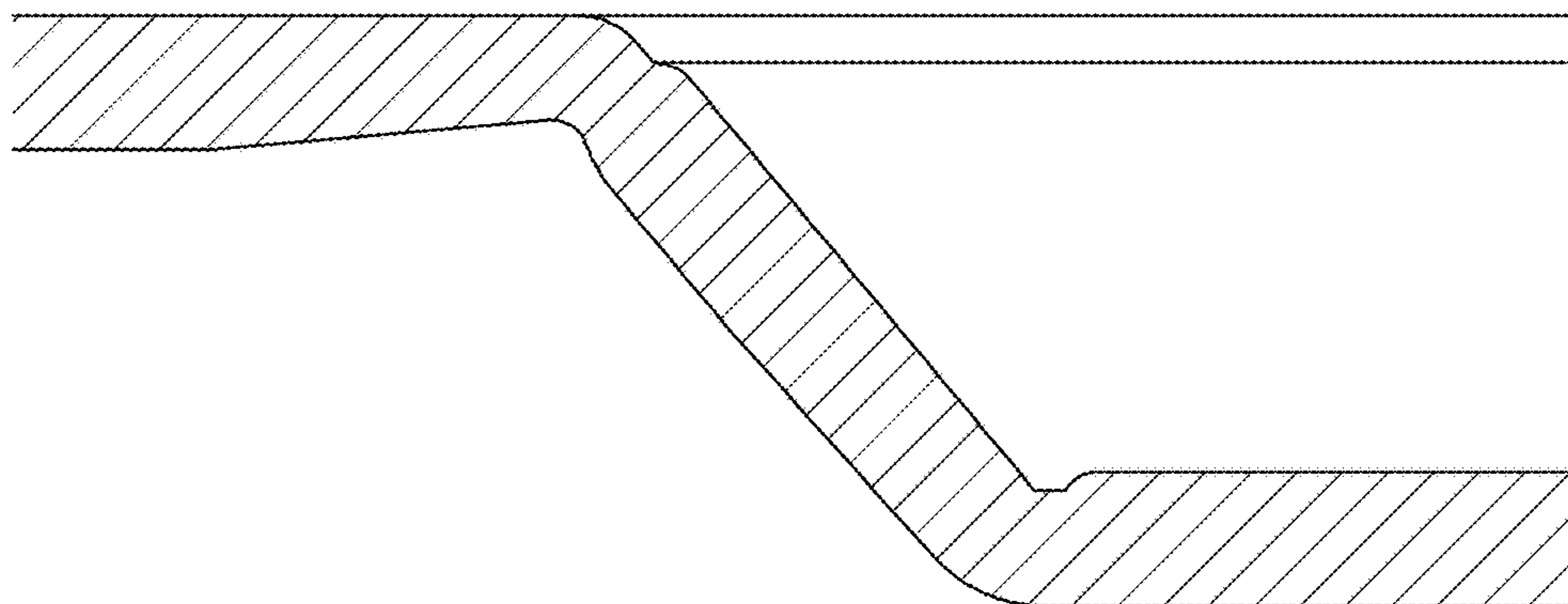

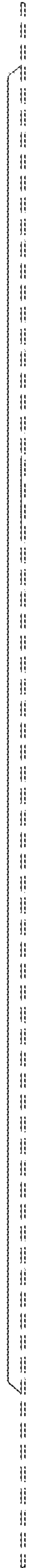

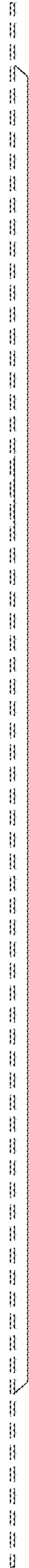

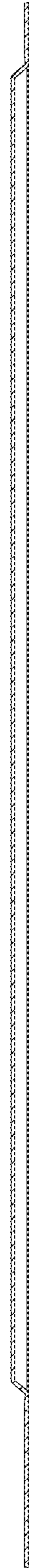

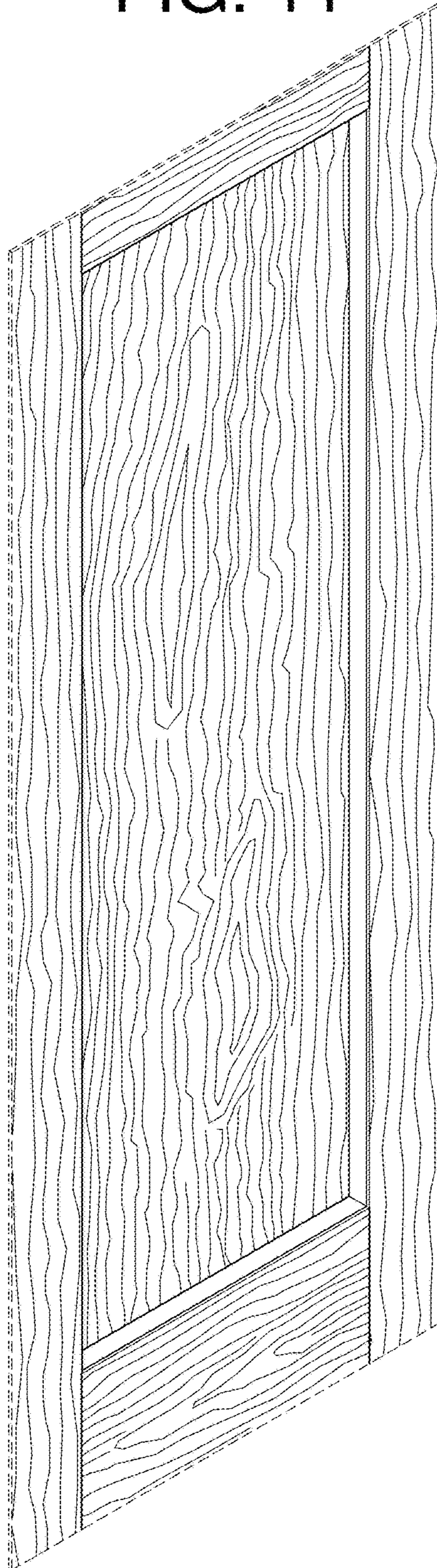

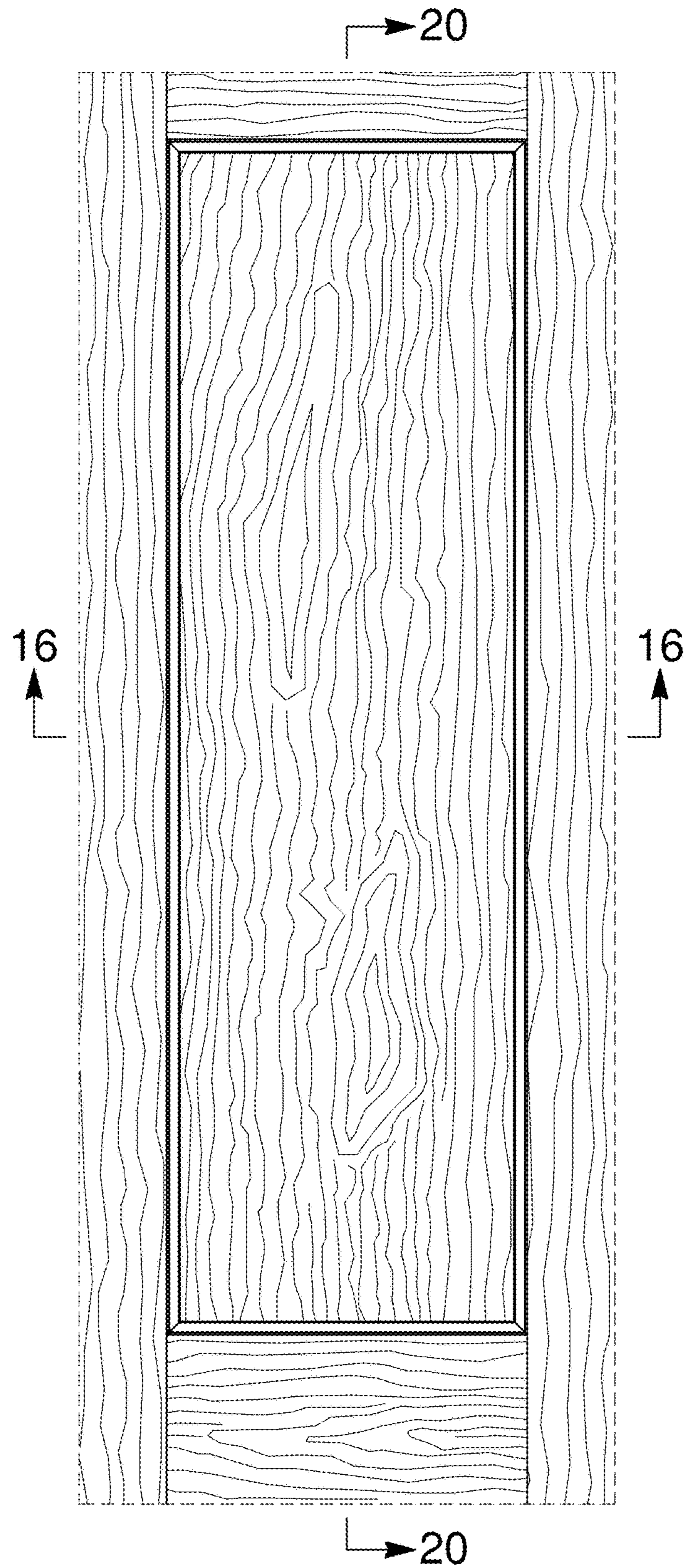

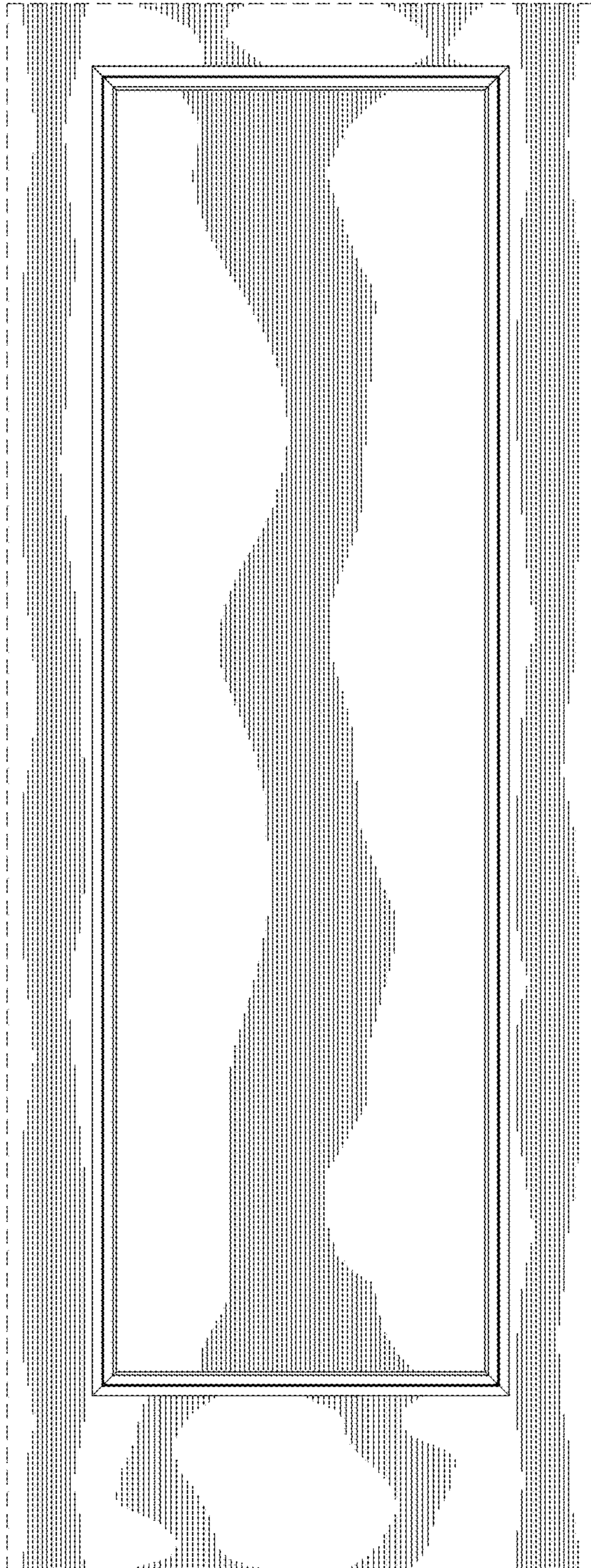

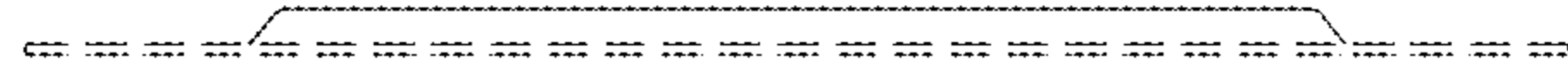

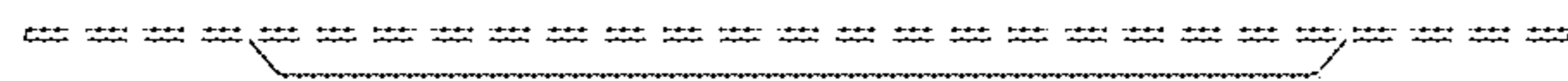

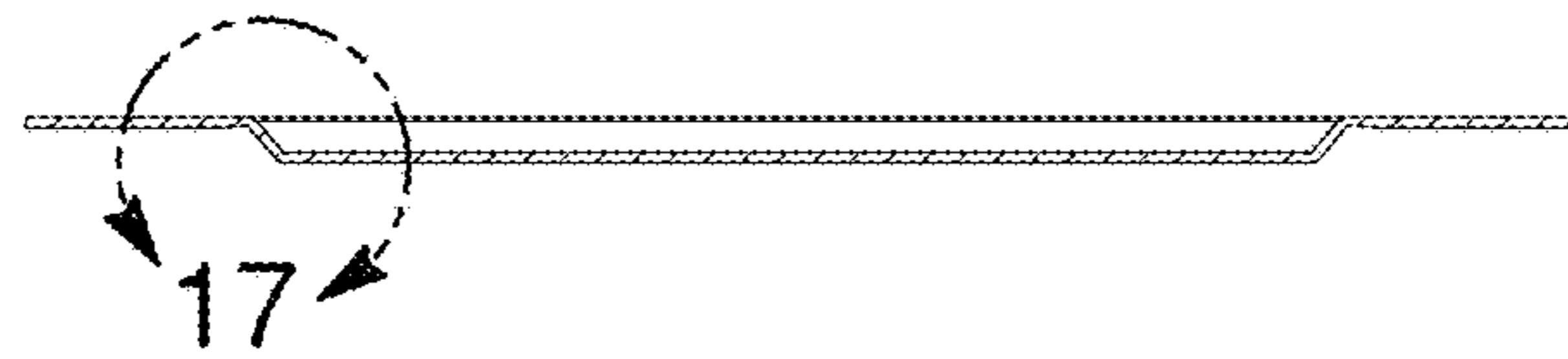

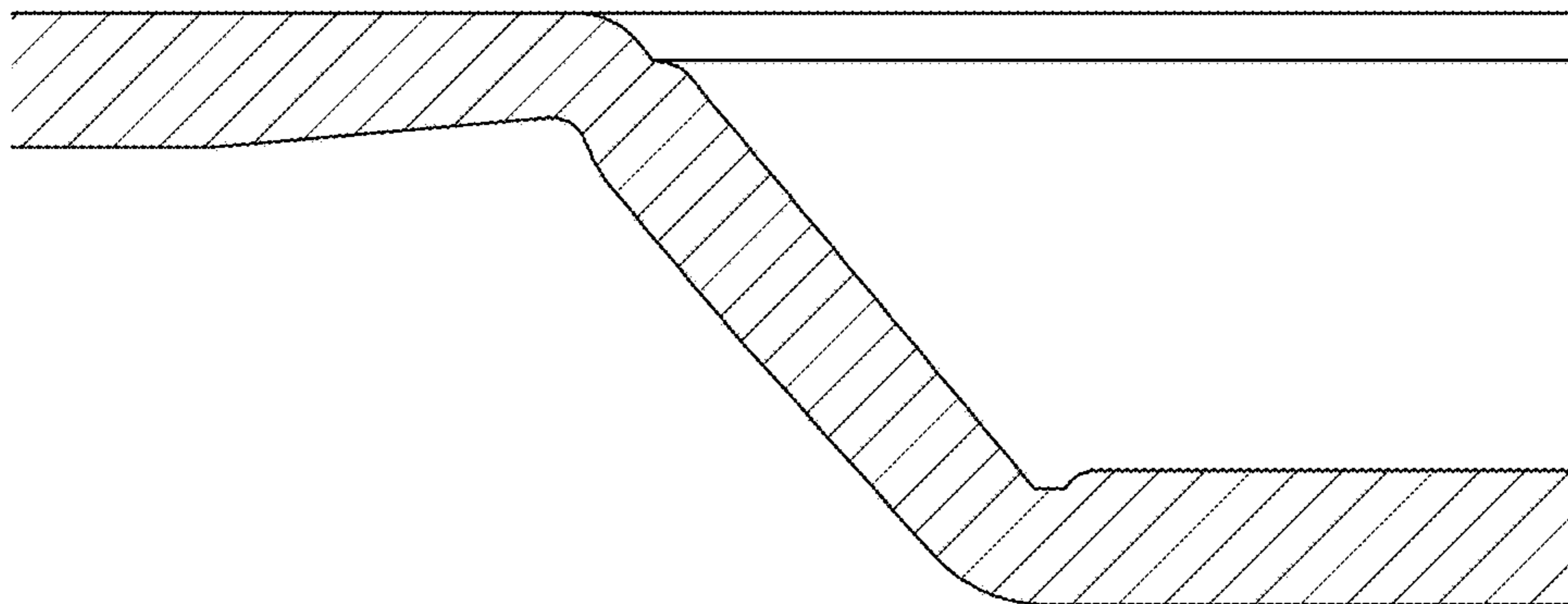

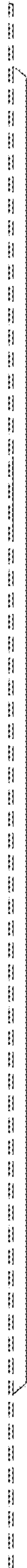
