**DESCRIPTION**

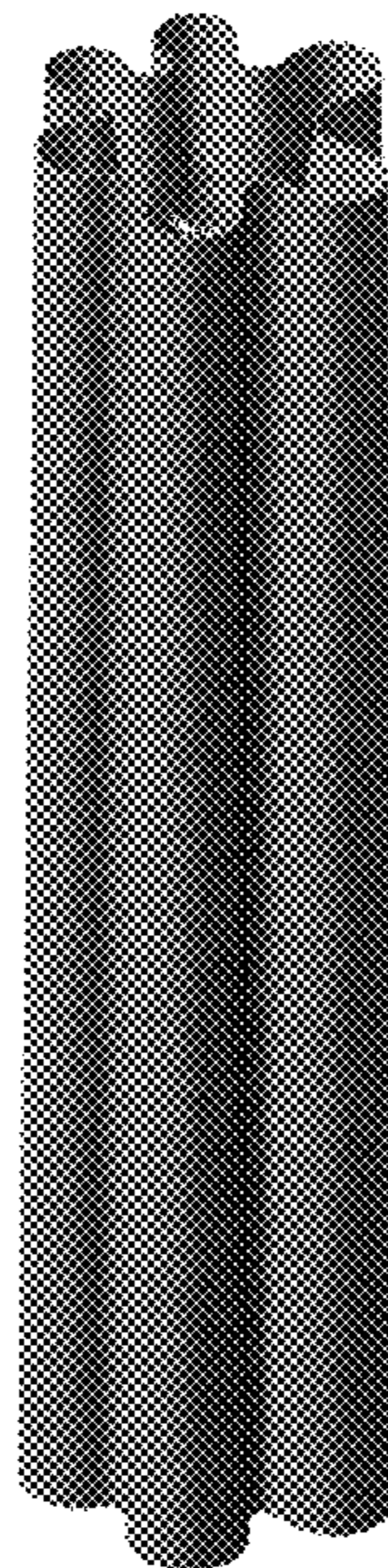
FIG. 1 is a perspective view of a sound absorbing surface showing my new design;

FIG. 2 is another perspective view thereof; and,

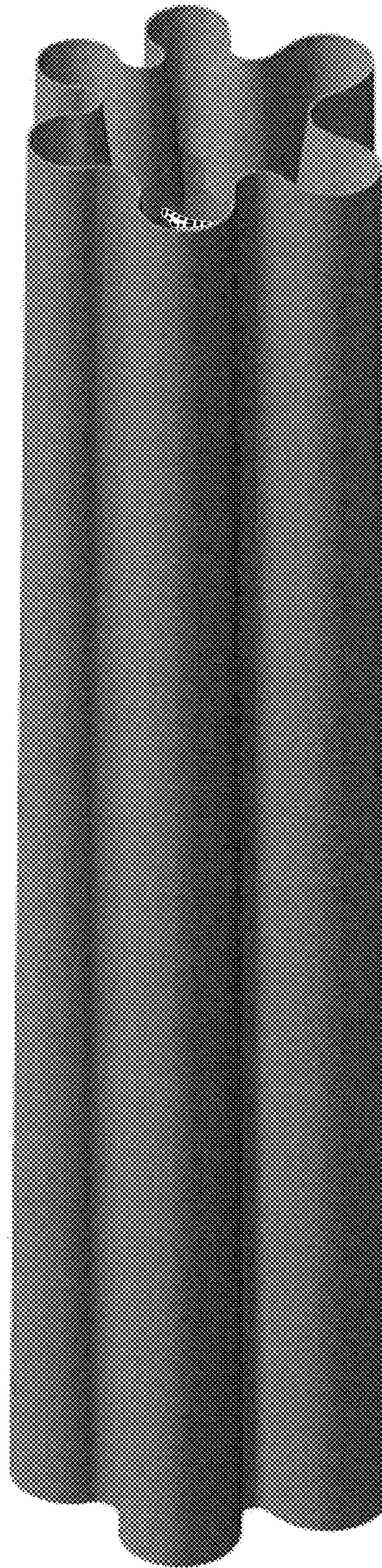
FIG. 3 is a front elevational view thereof.

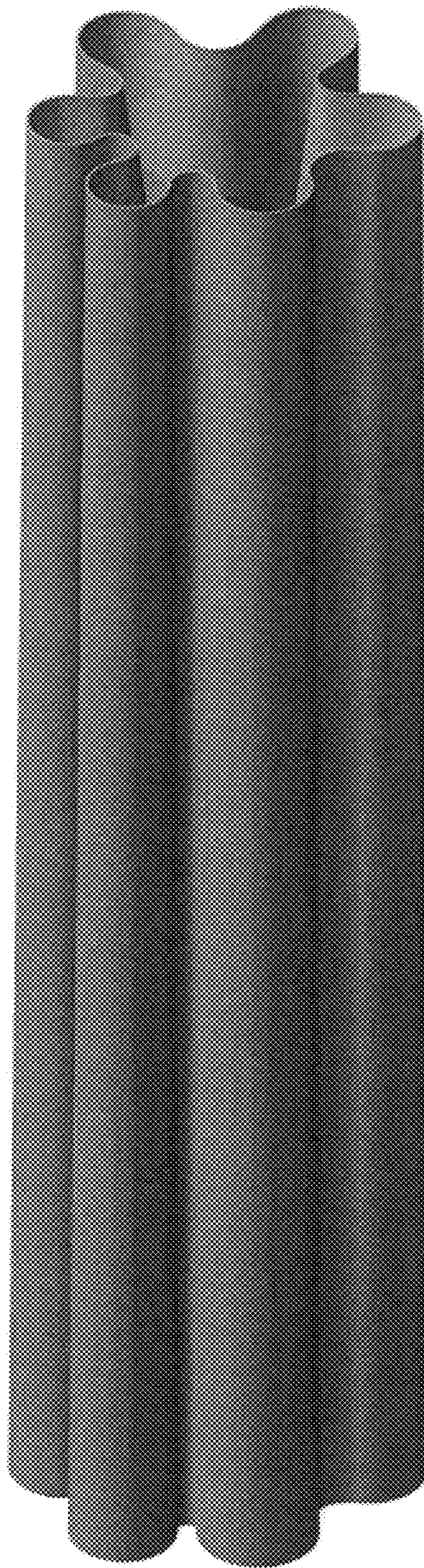
