DESCRIPTION

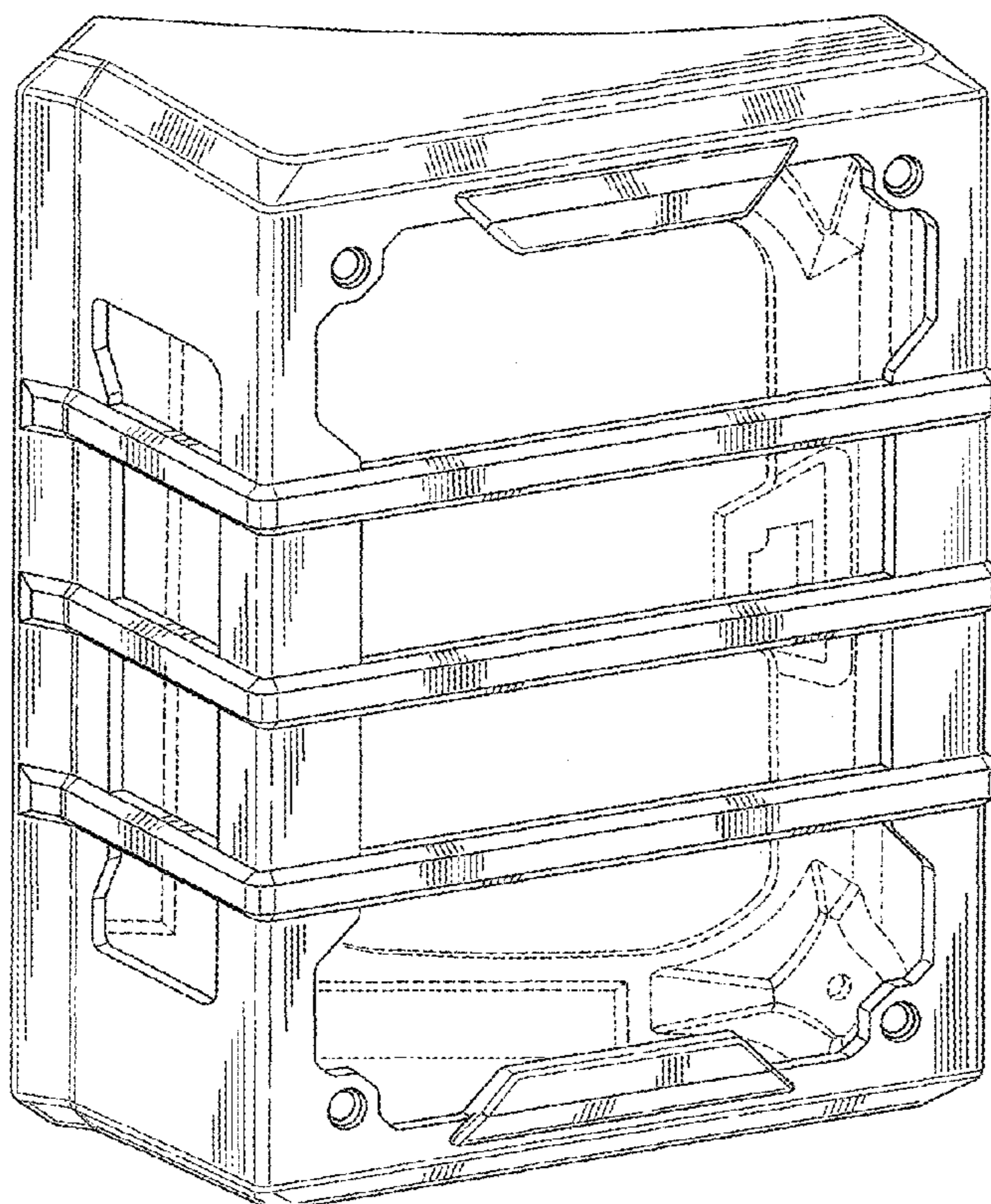

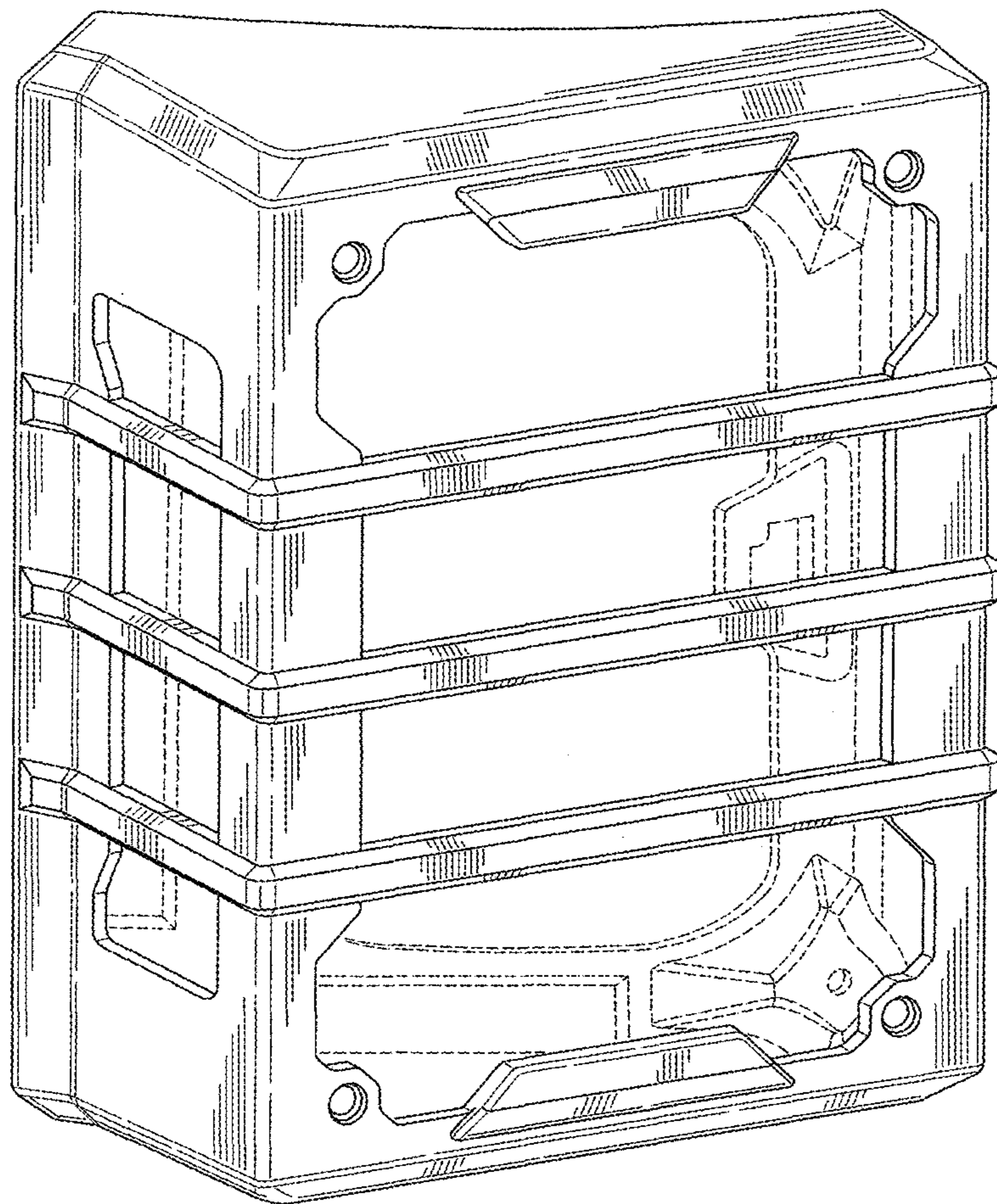

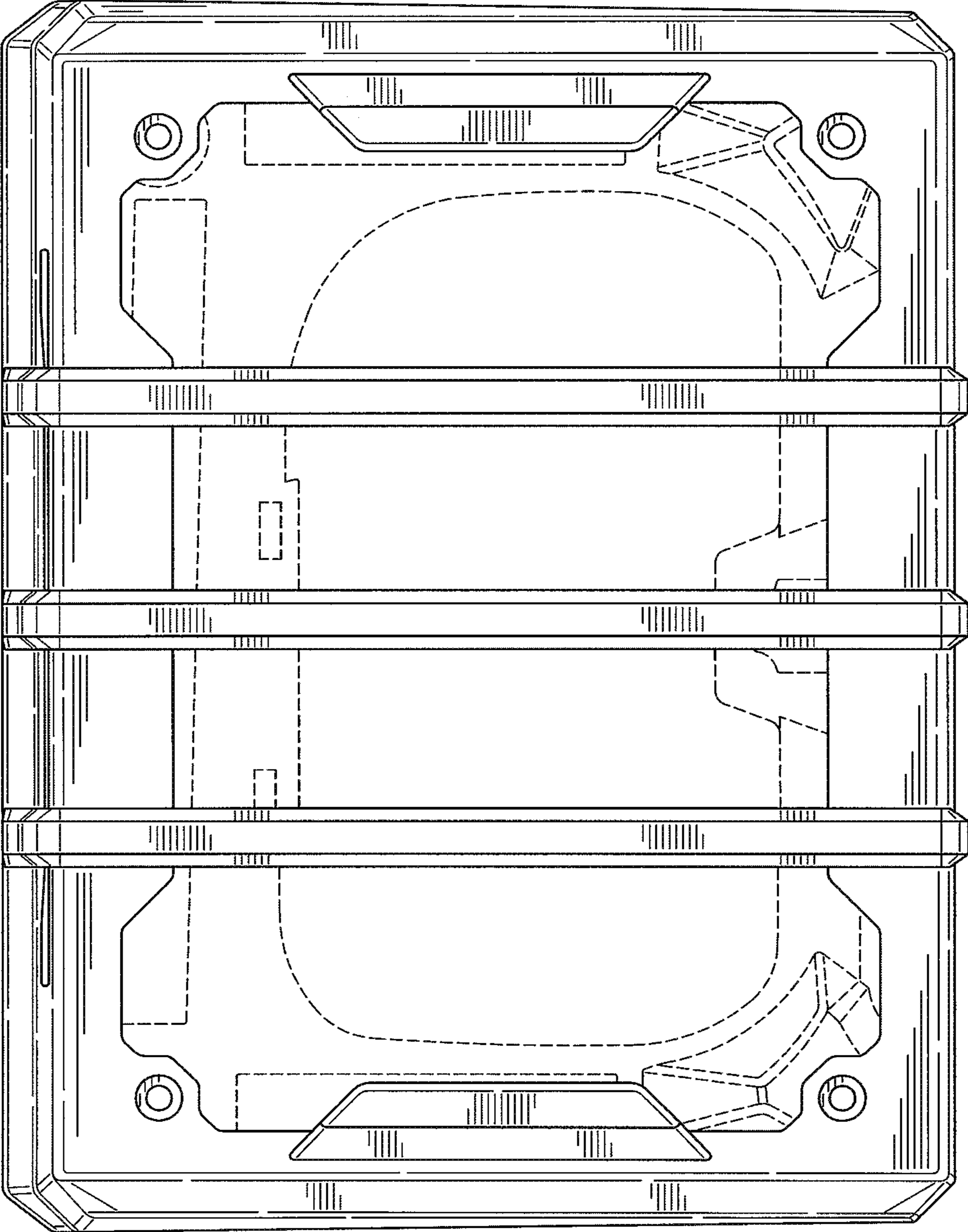

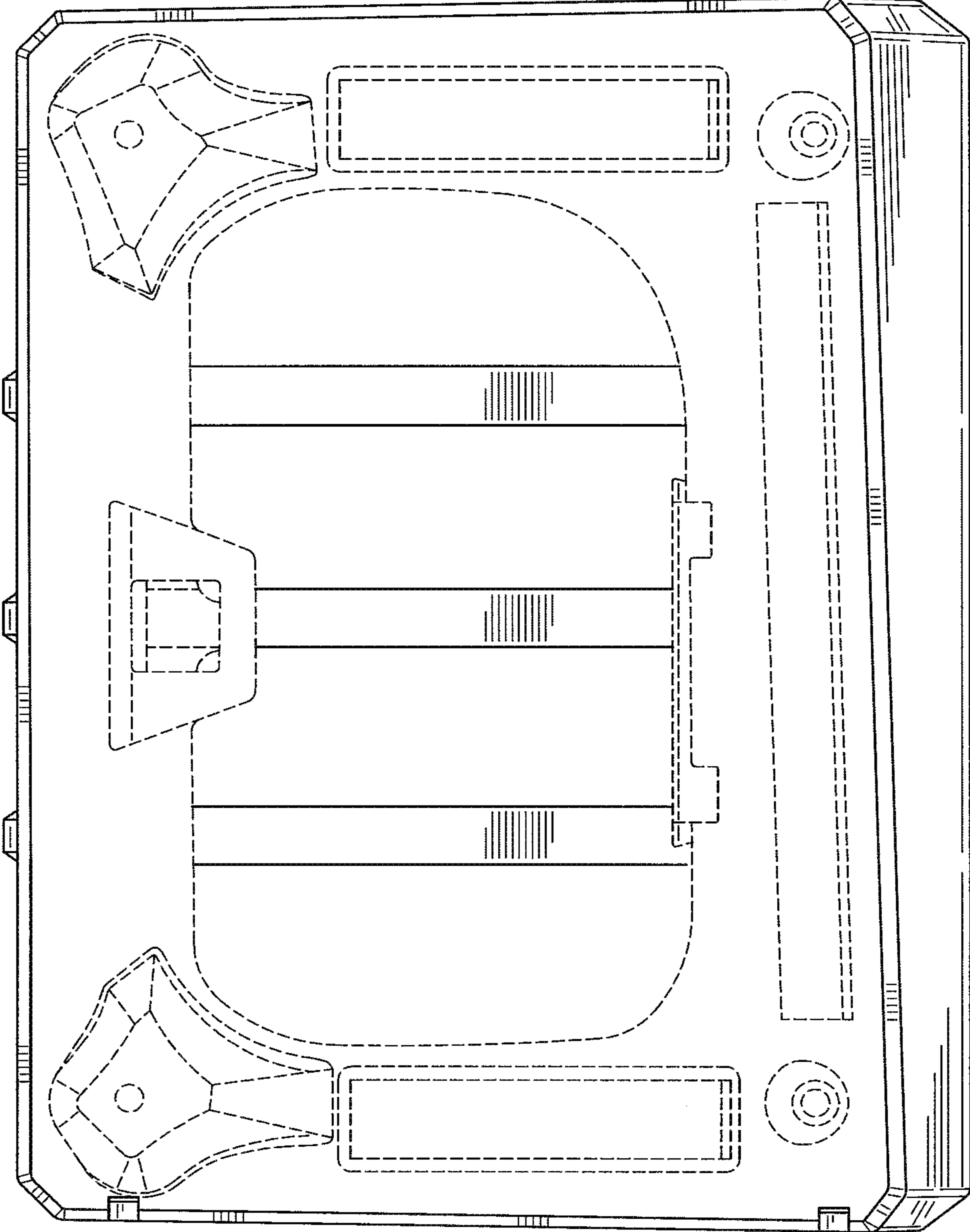

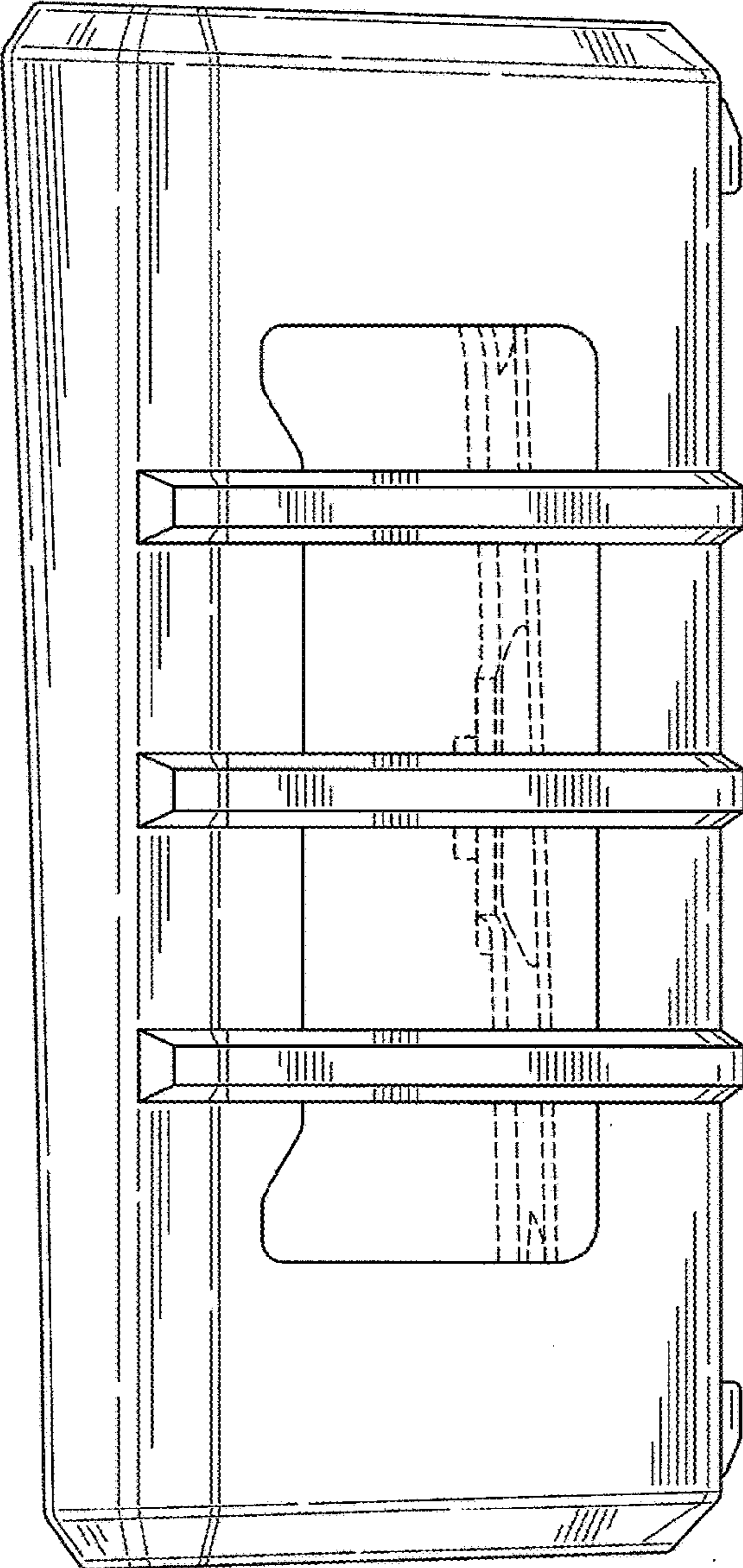
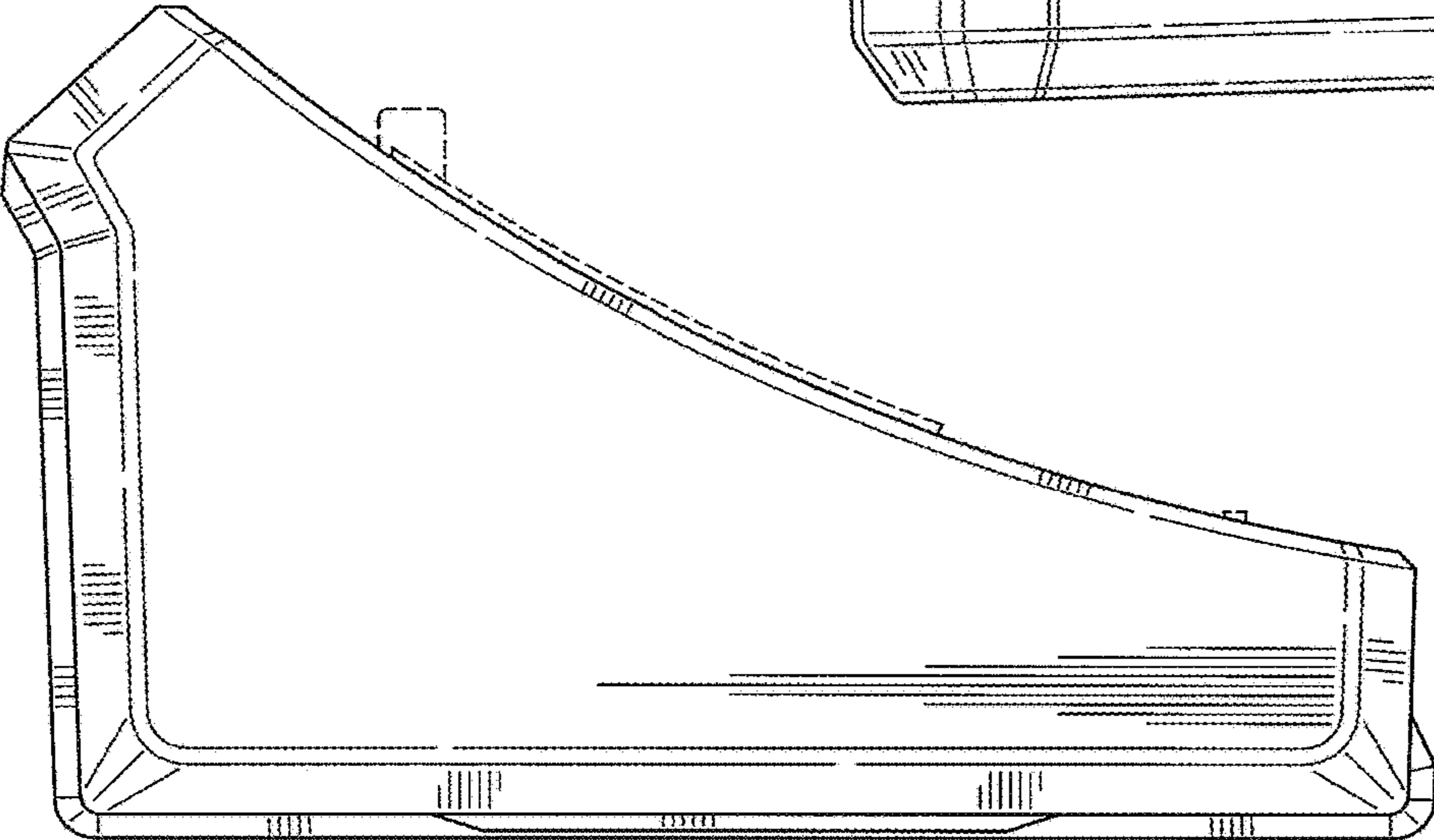

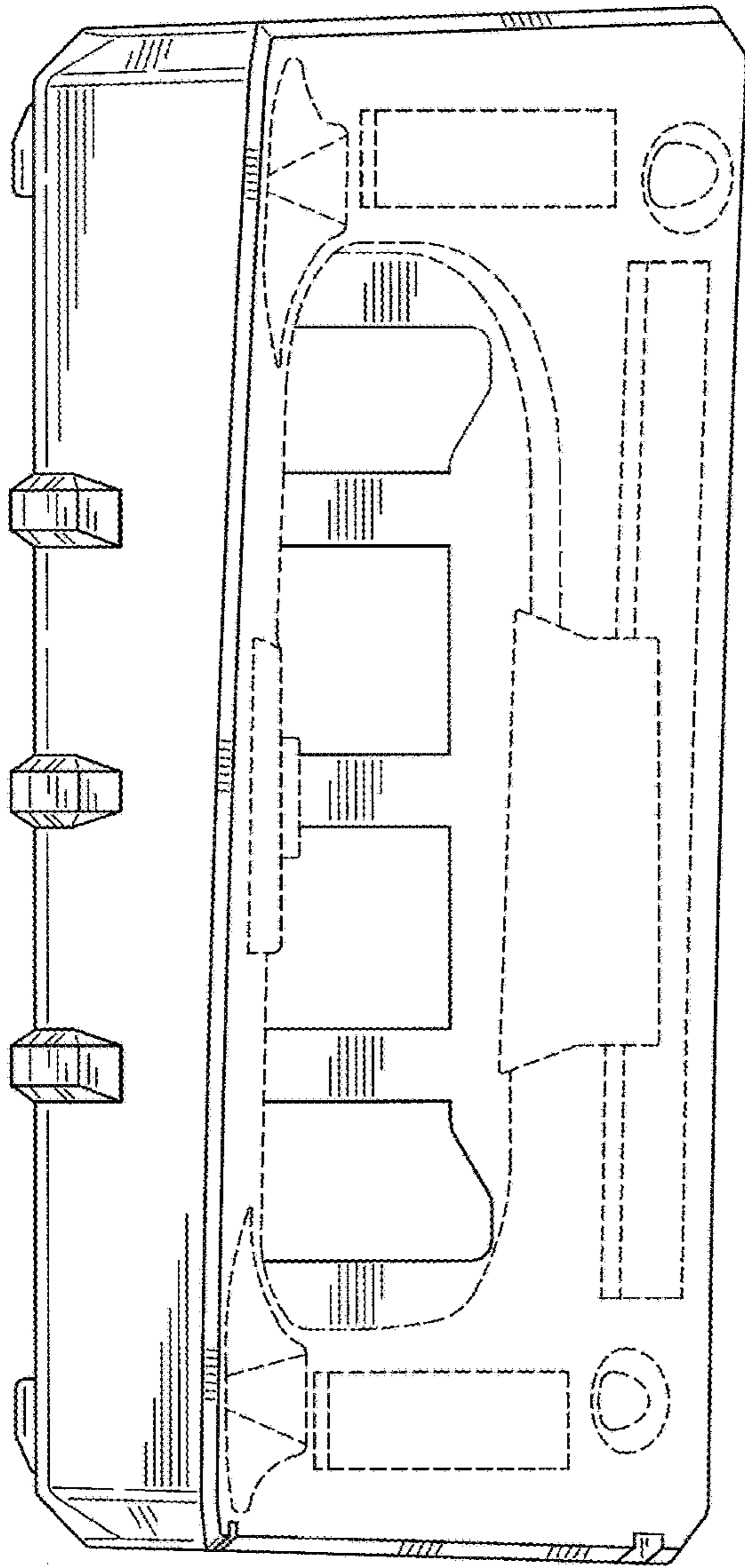
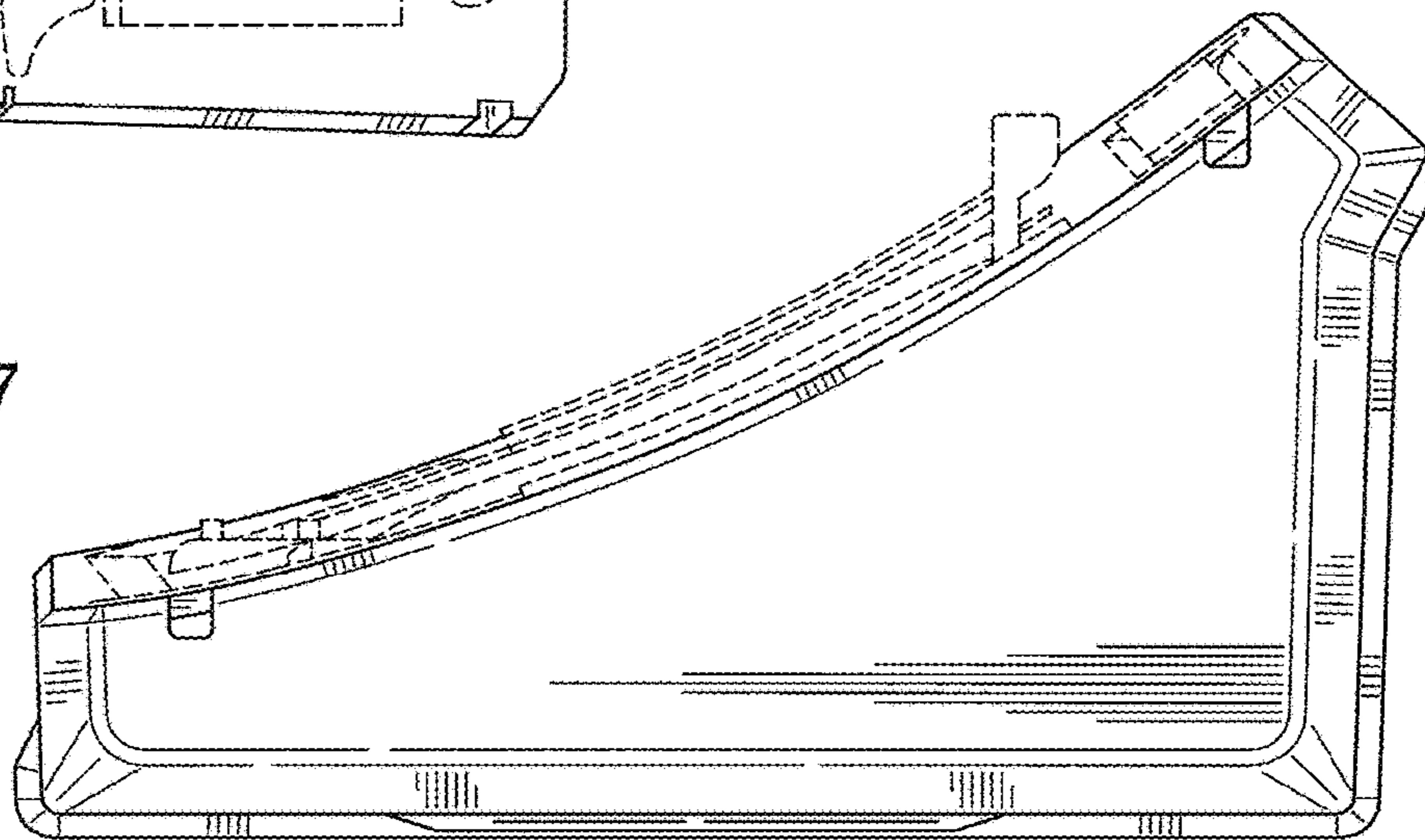

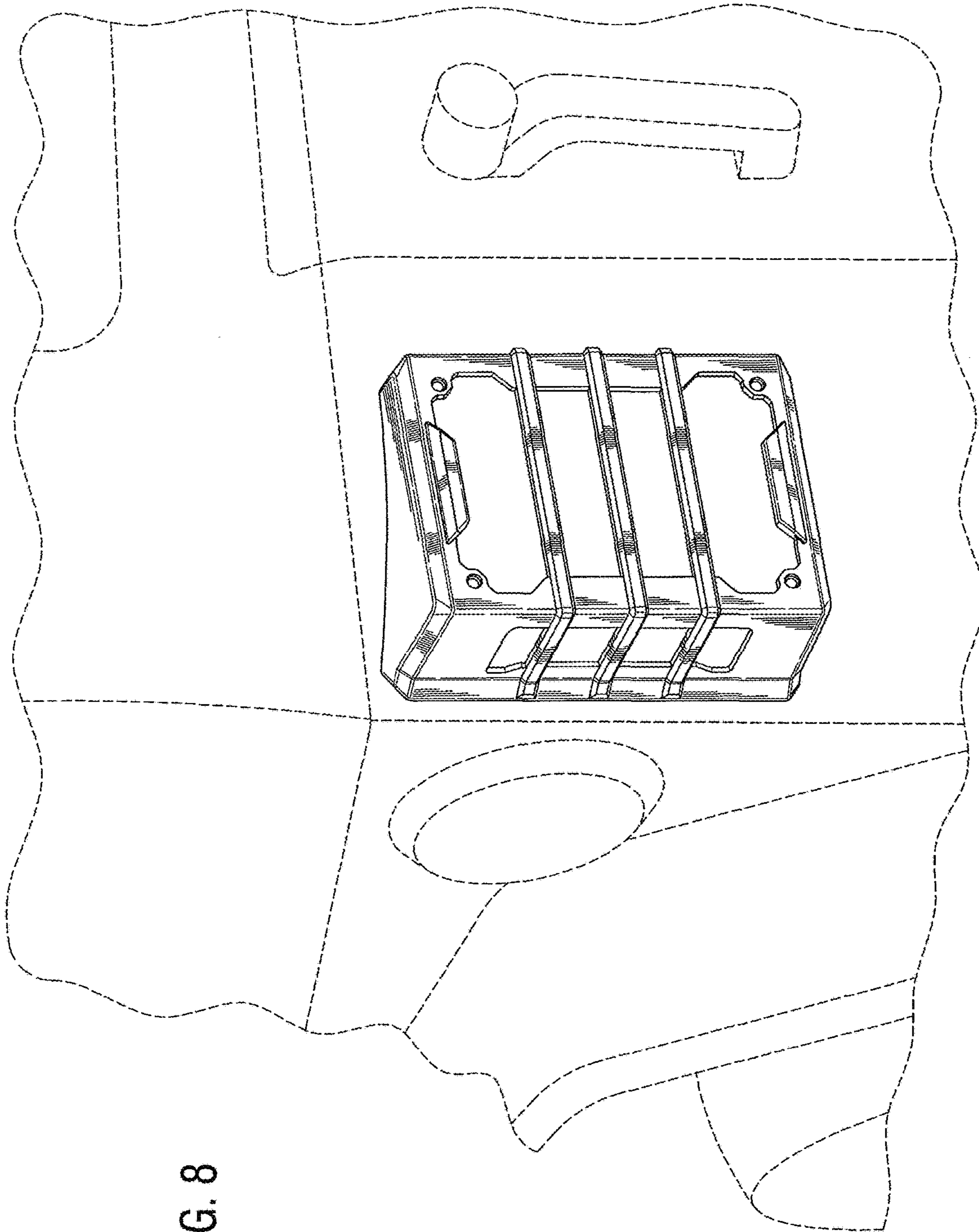
