DESCRIPTION

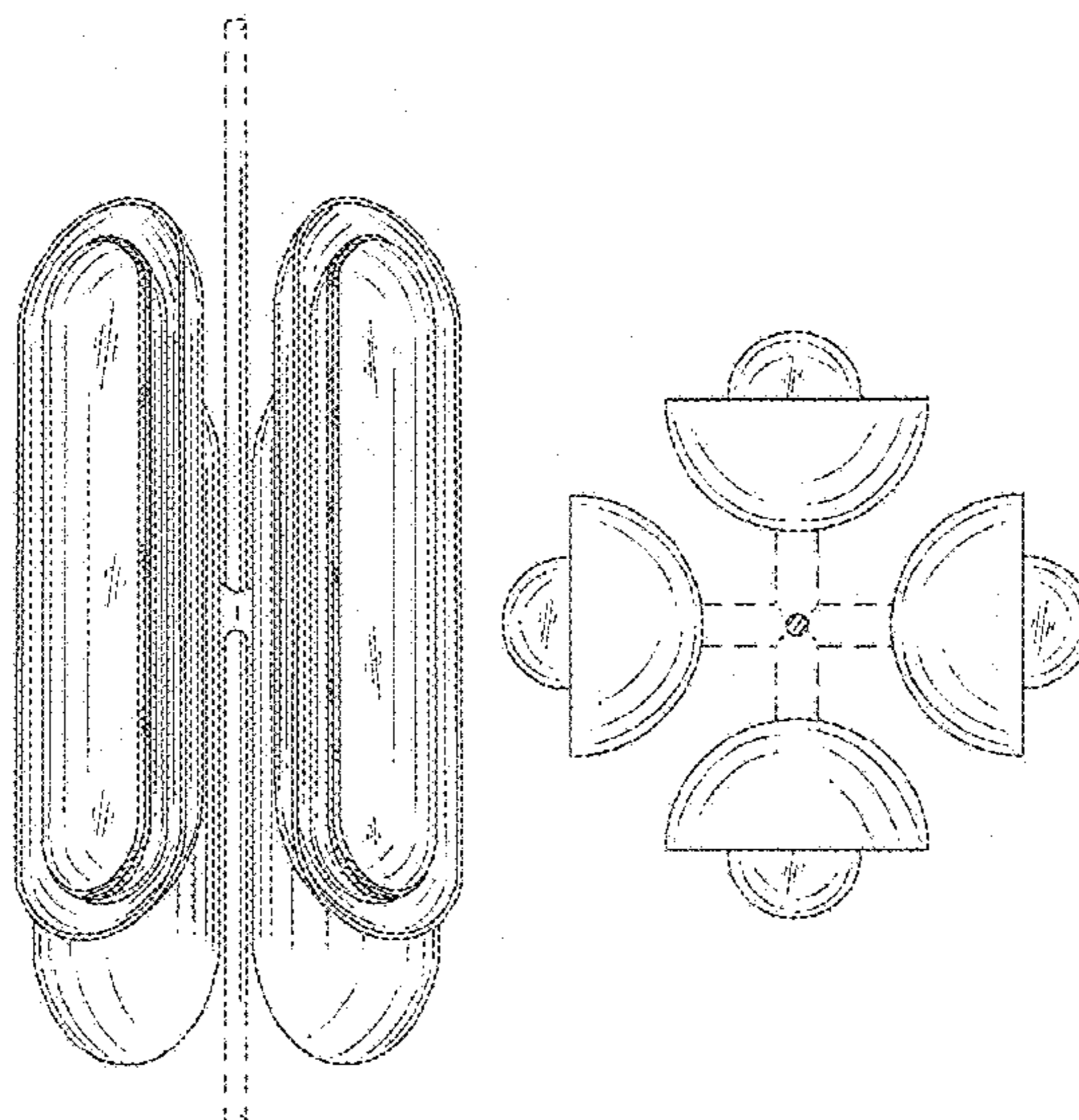
FIG. 1 is a front perspective view of the lighting fixture showing our new design;

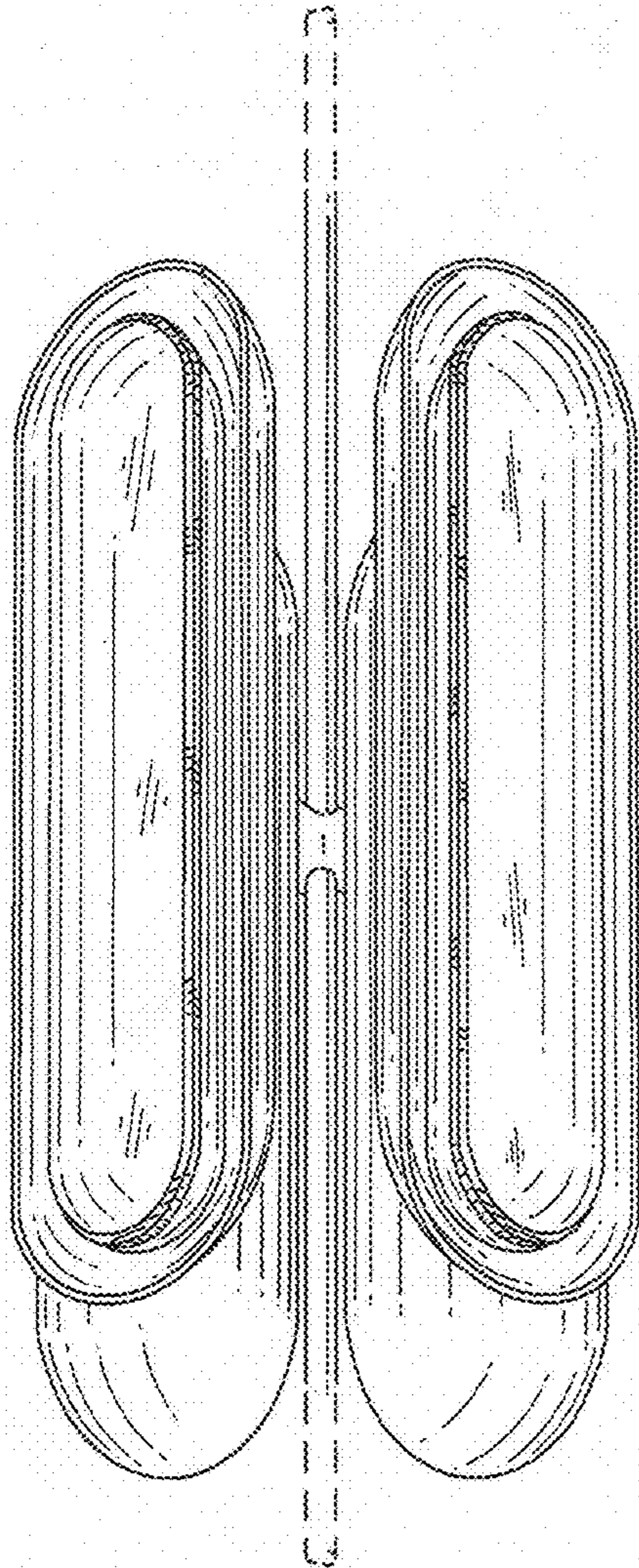

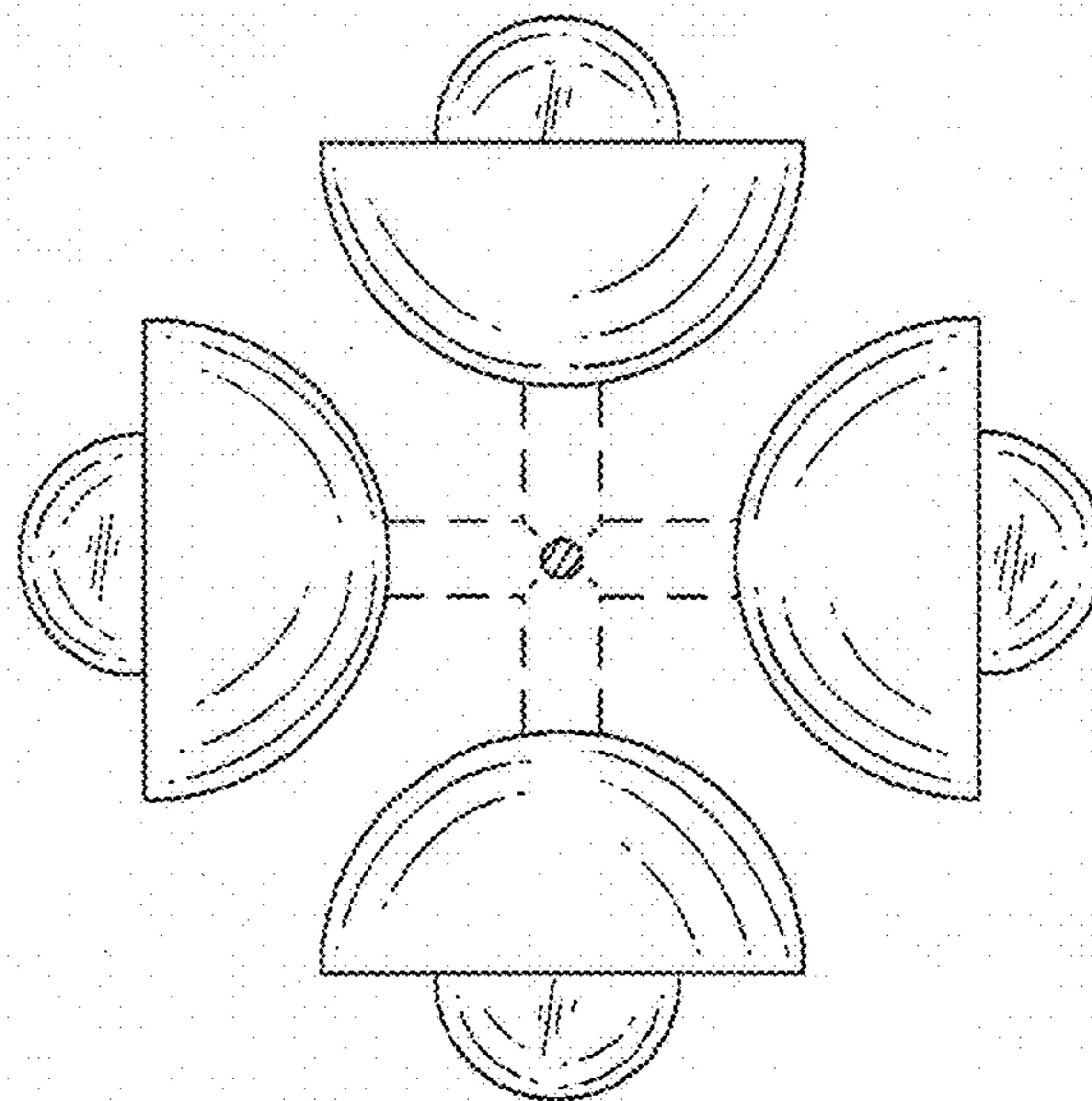

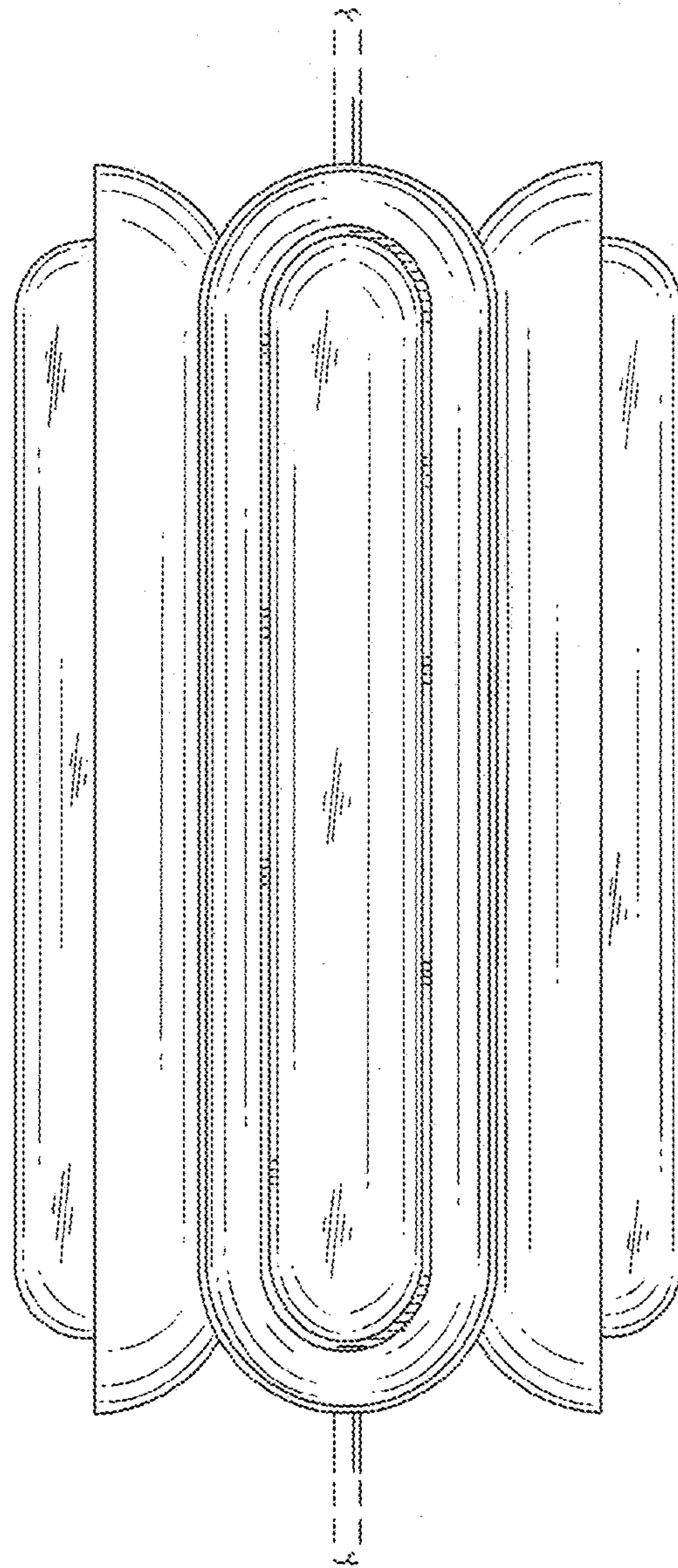
