FIG. 4 is a right side view of the lighted vest;

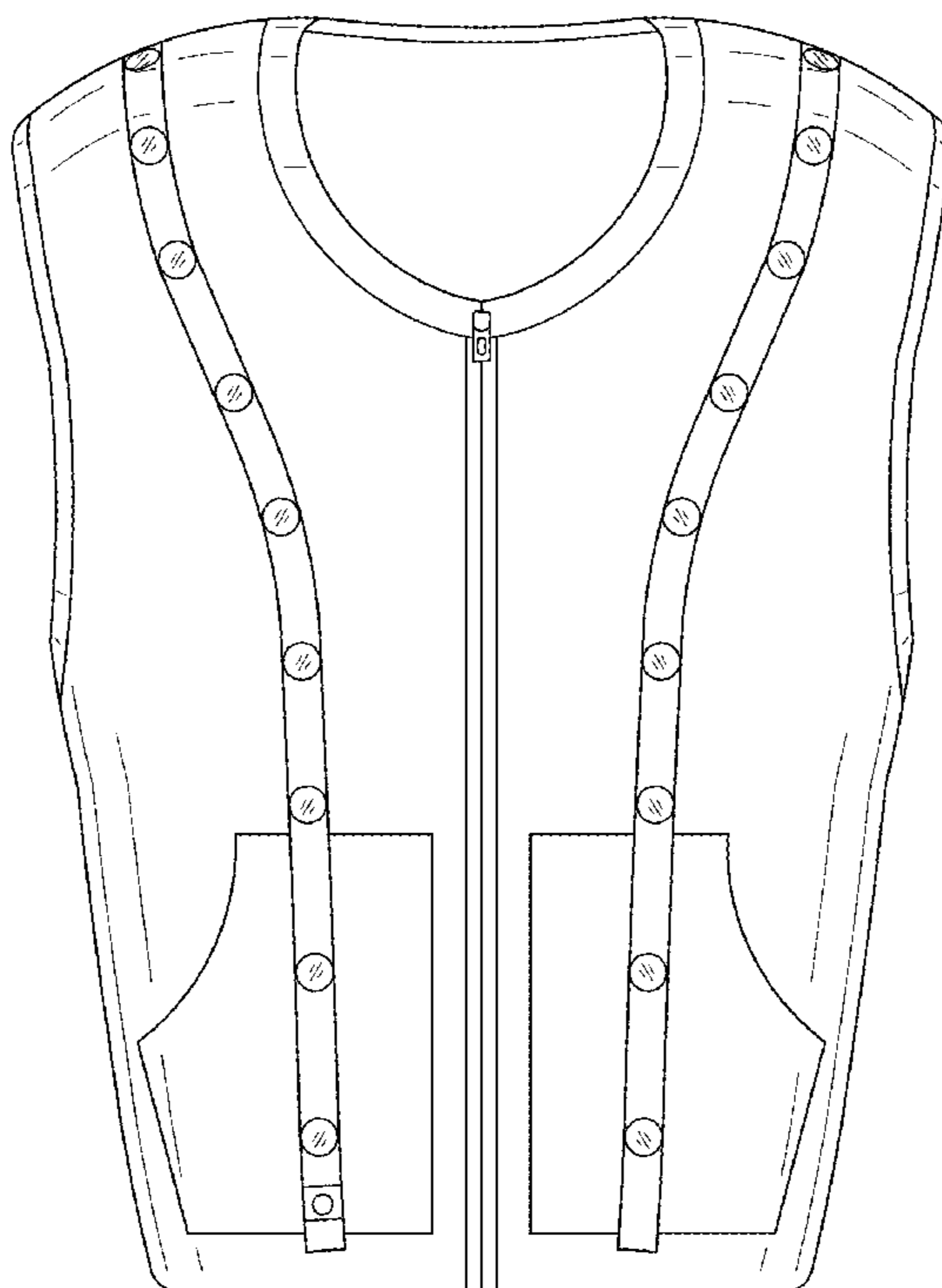
FIG. 5 is a top view of the lighted vest; and,

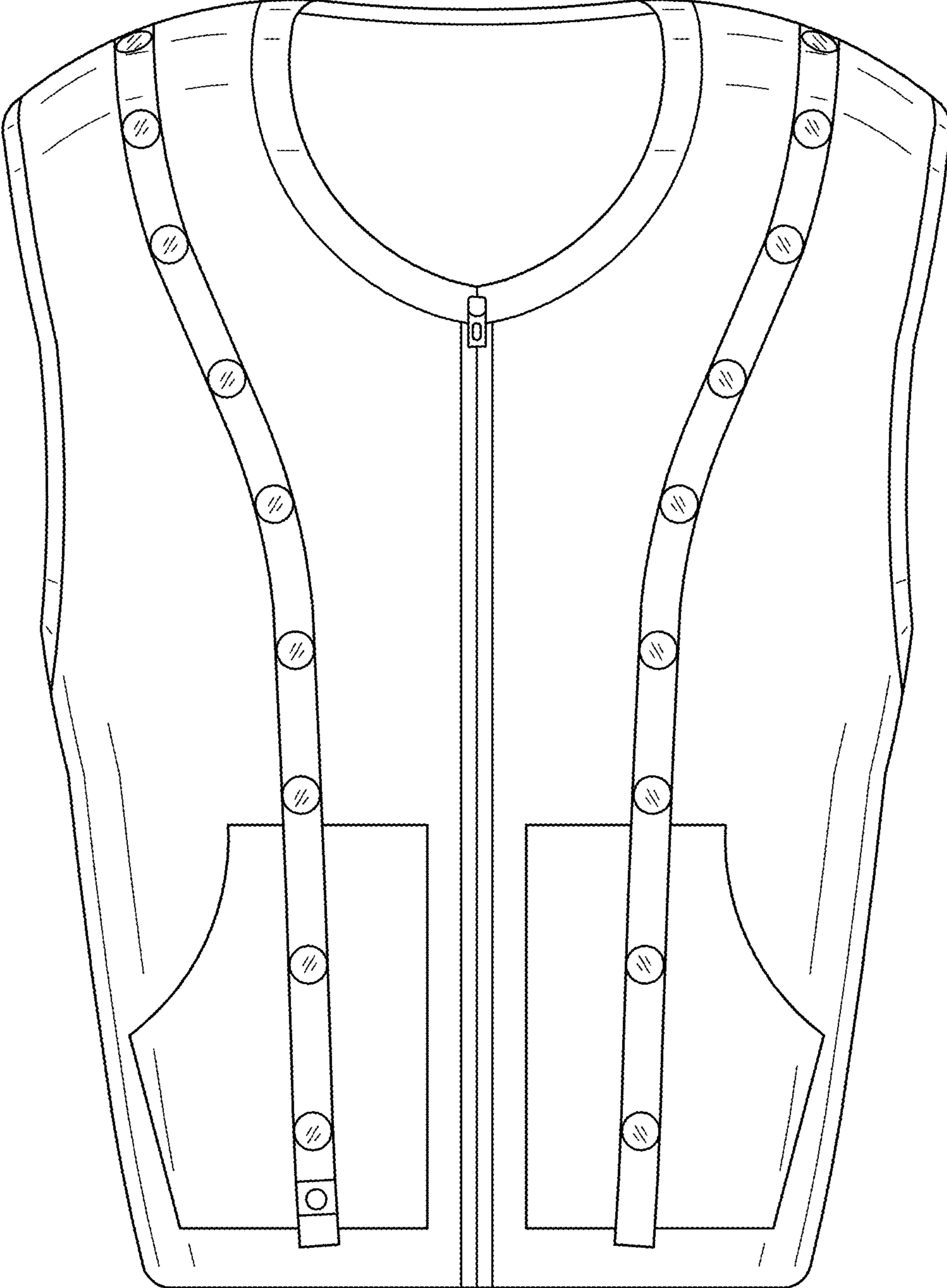

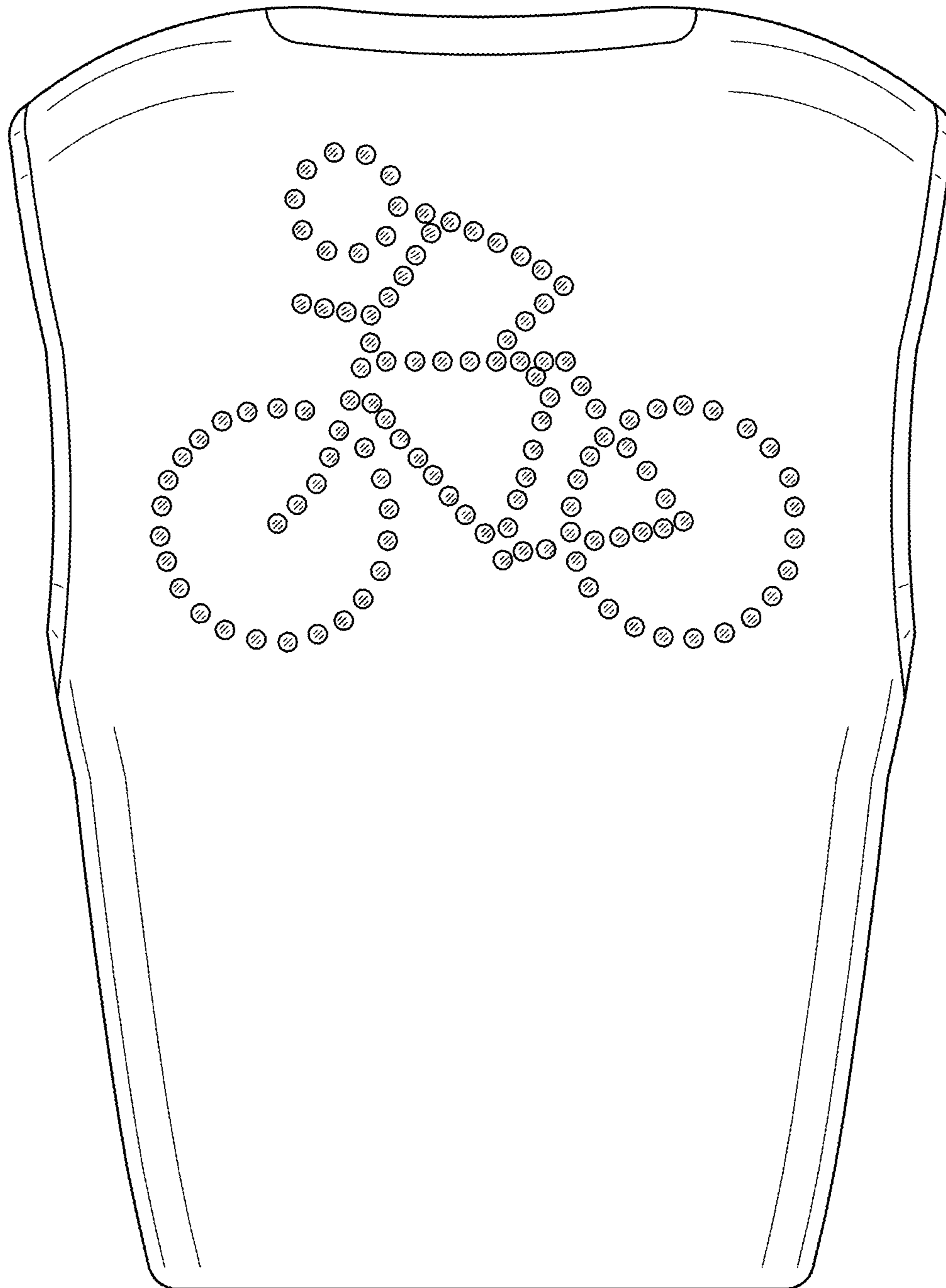

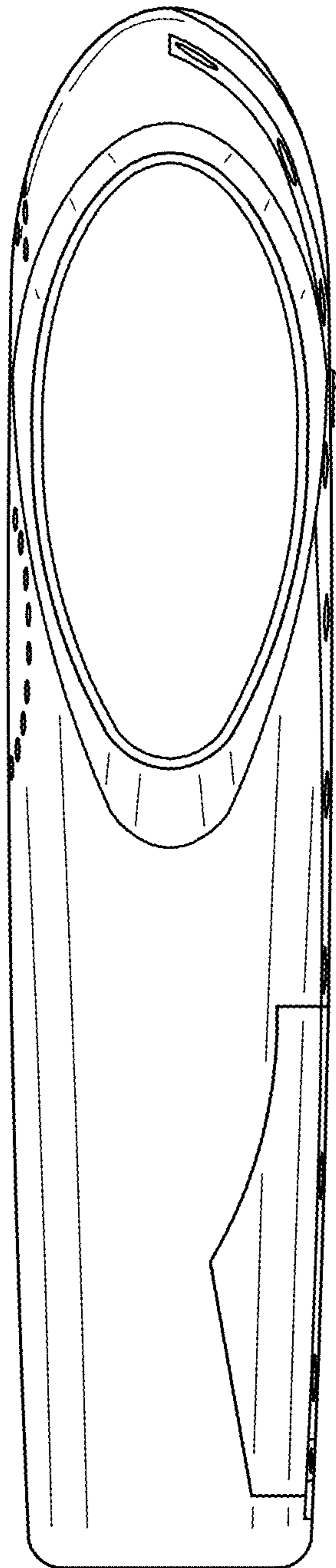

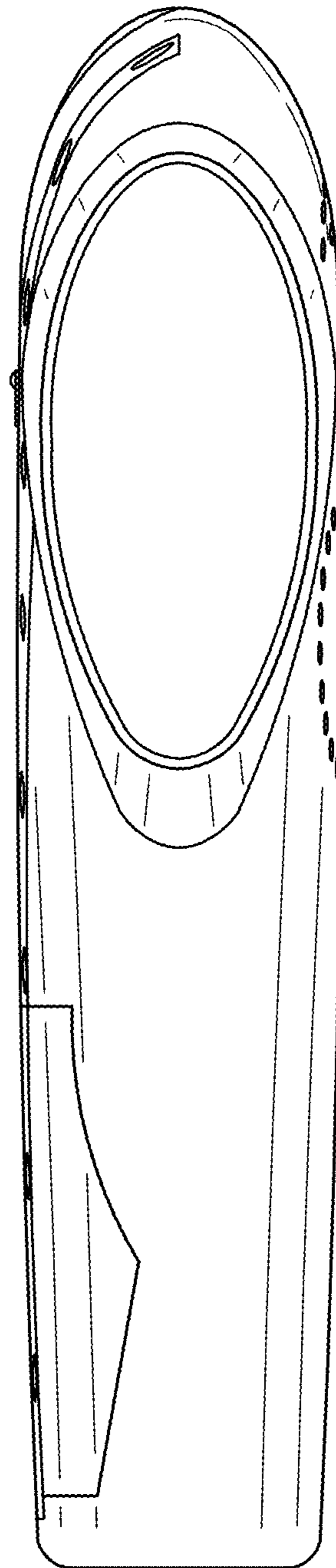

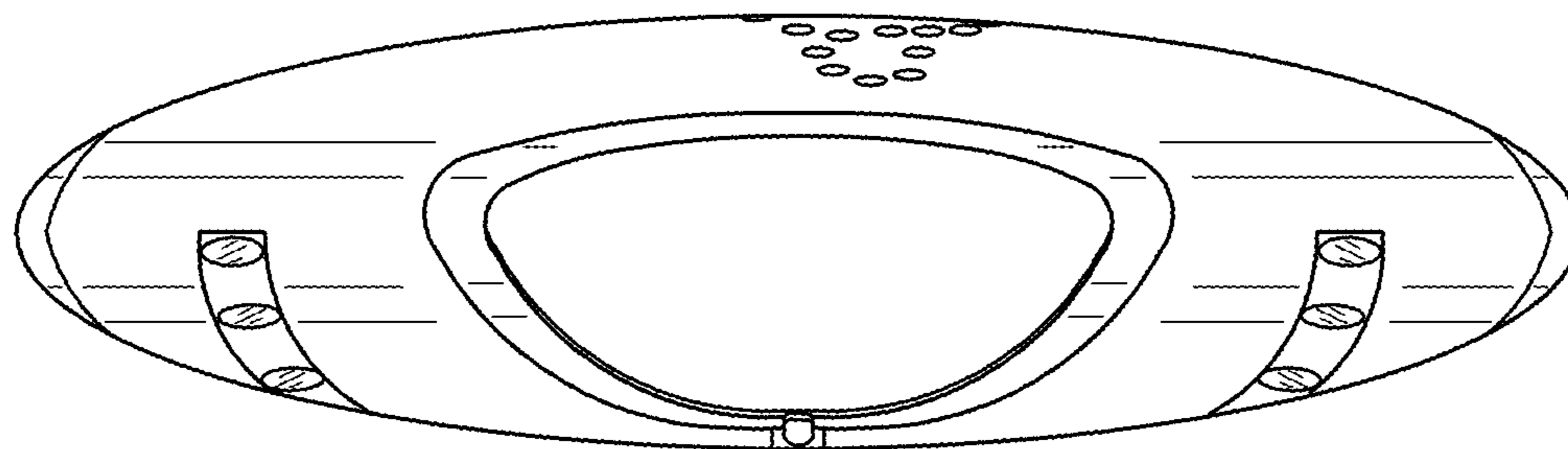

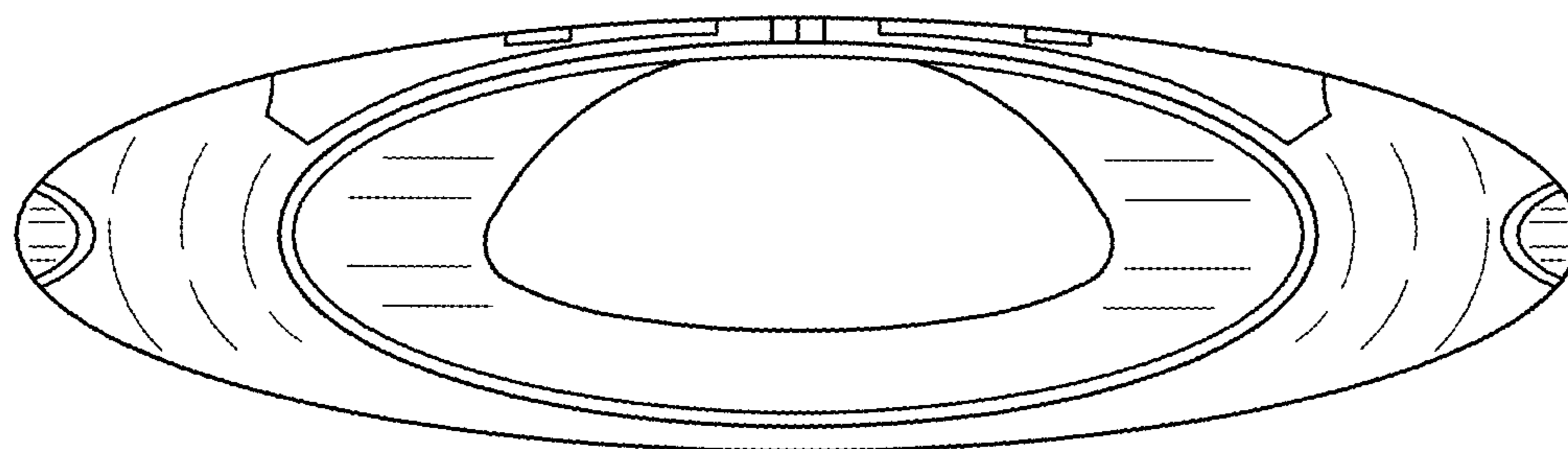
