DESCRIPTION

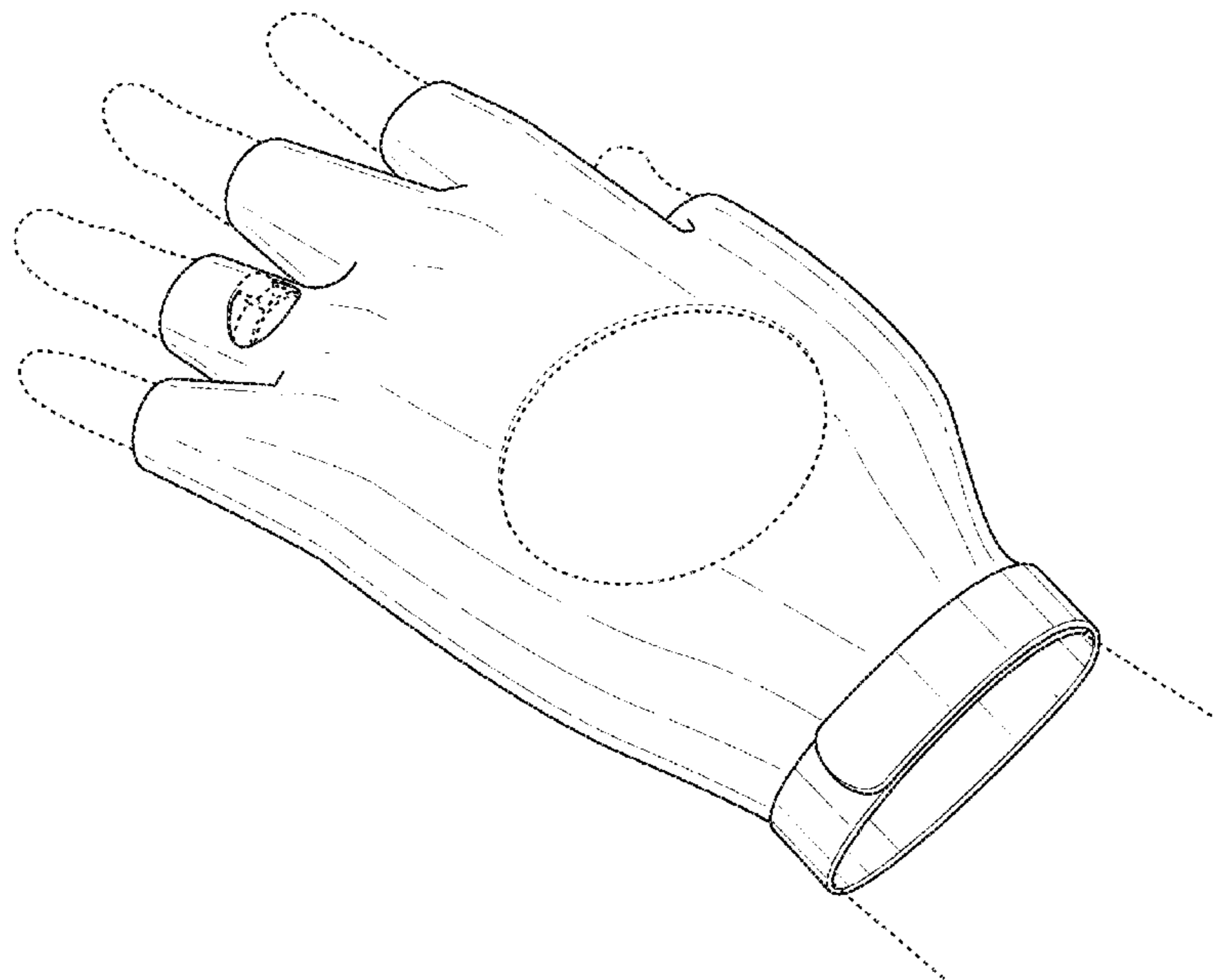
FIG. 1 shows a perspective view of a workout glove showing my new design;

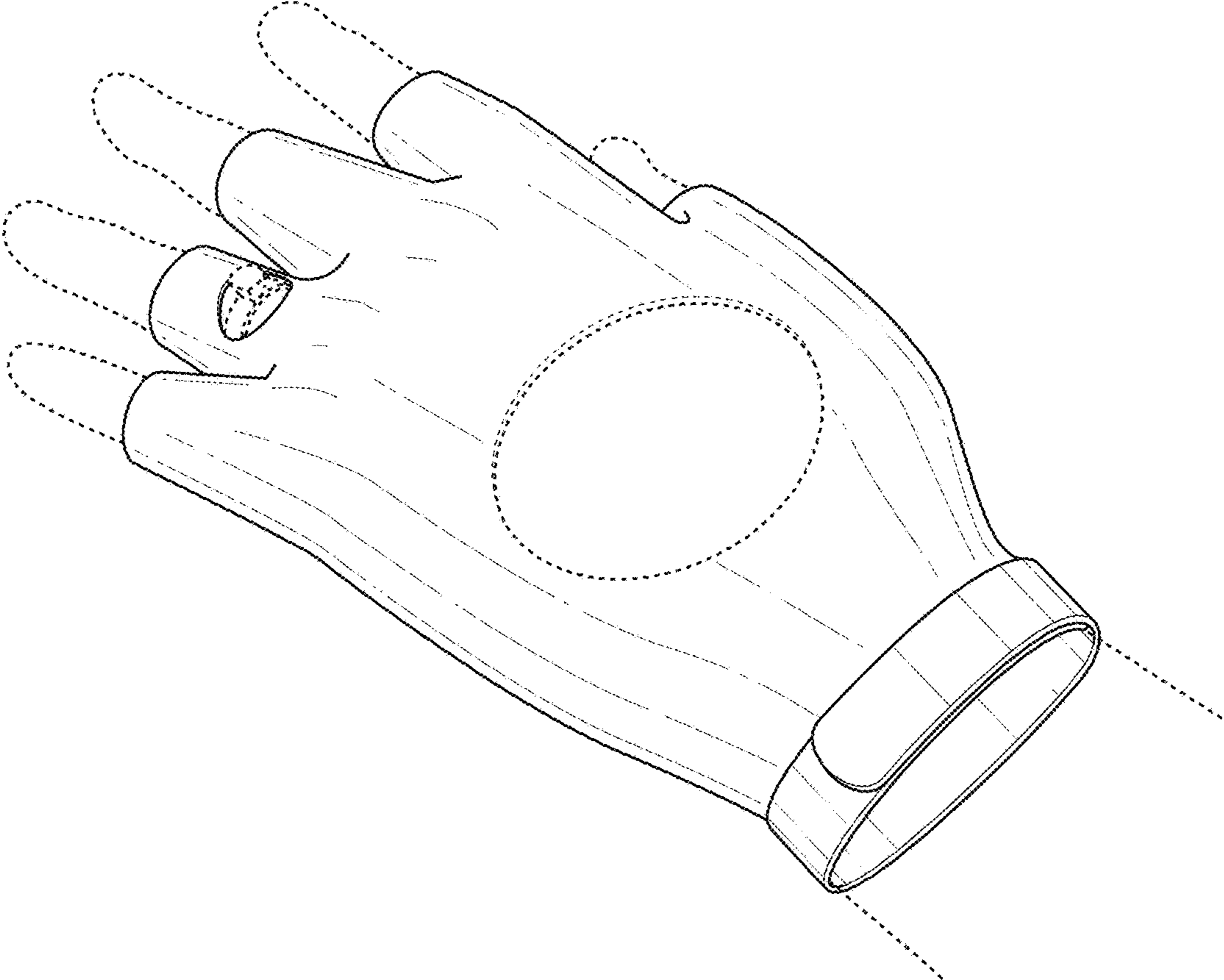

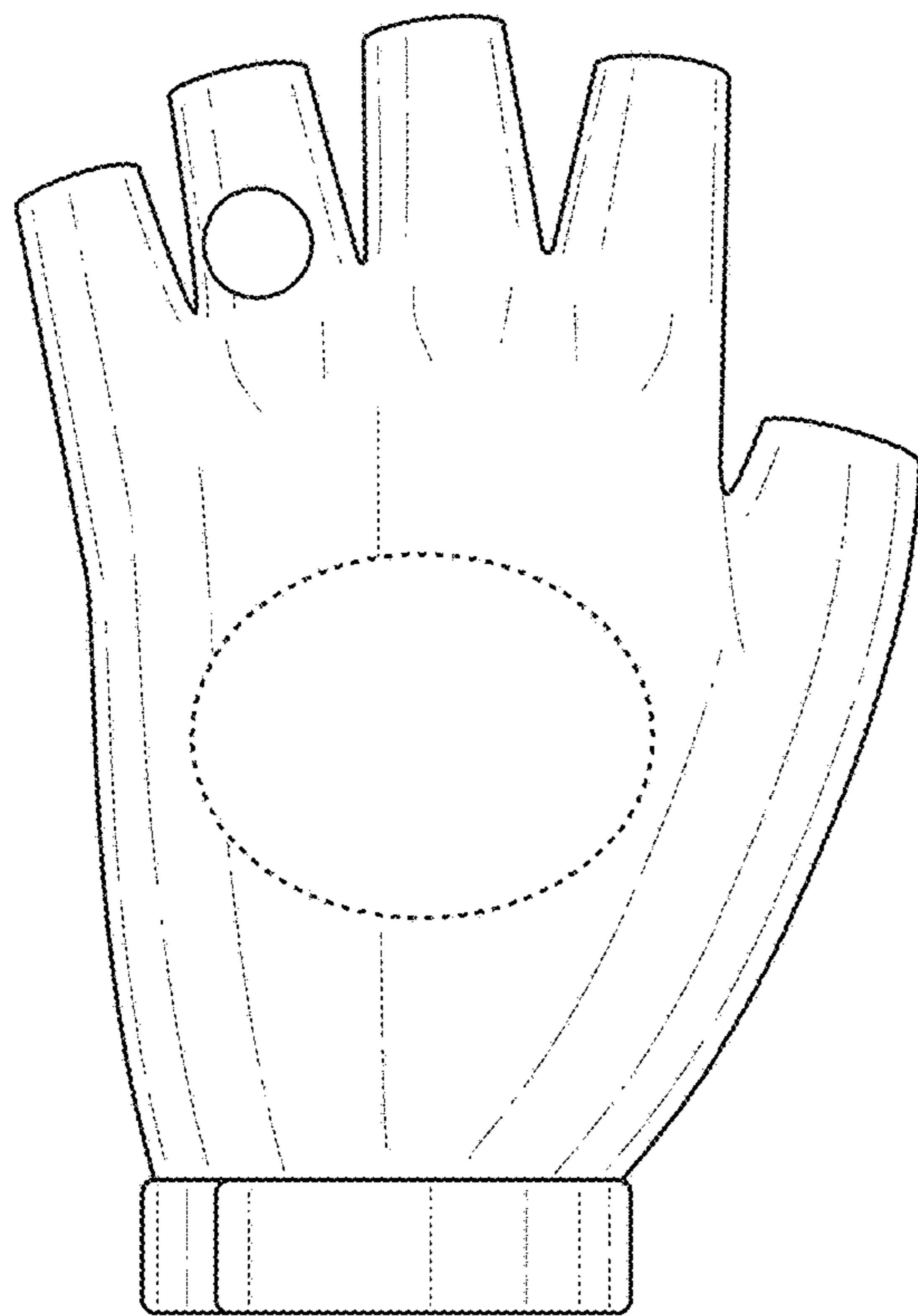

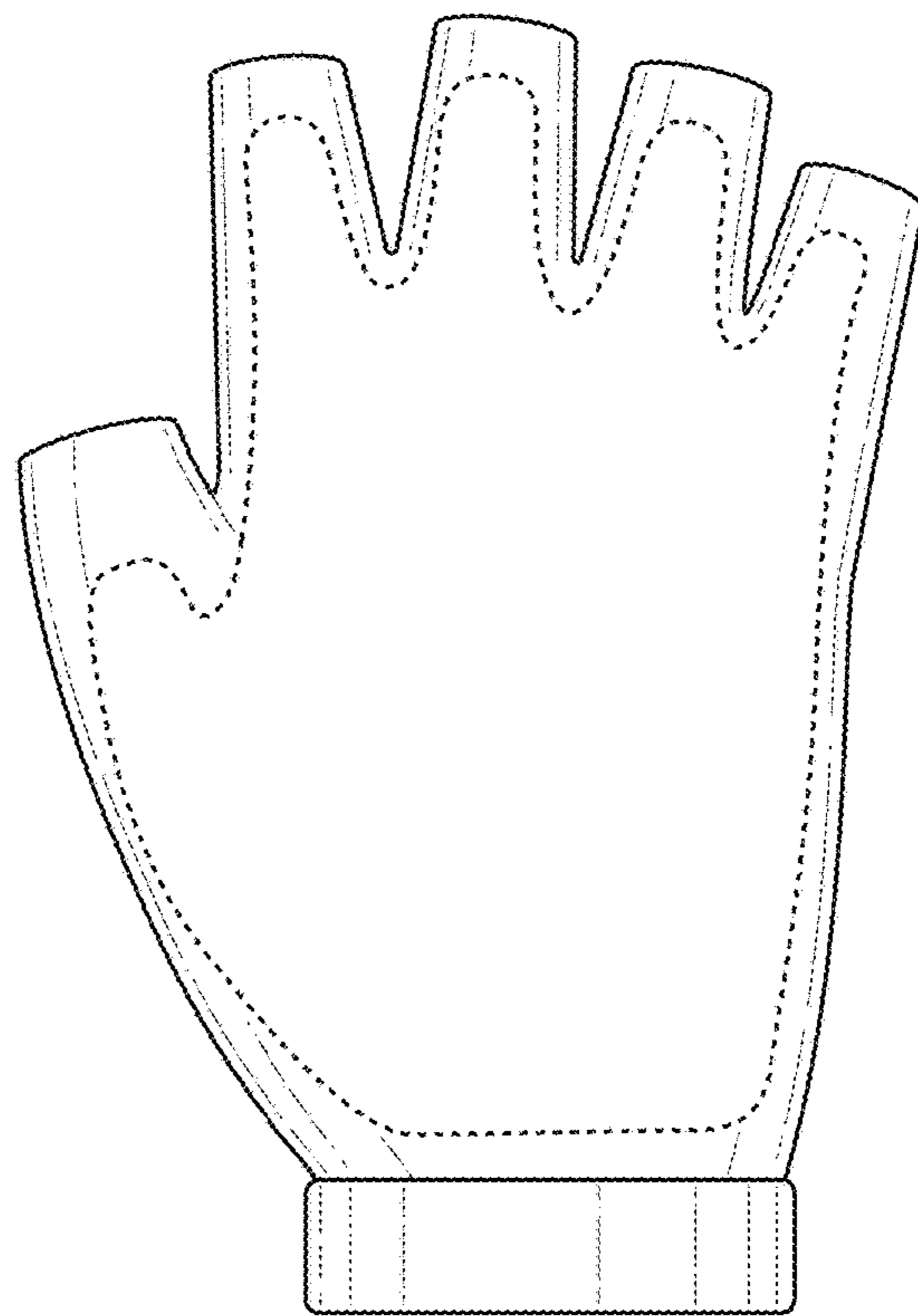

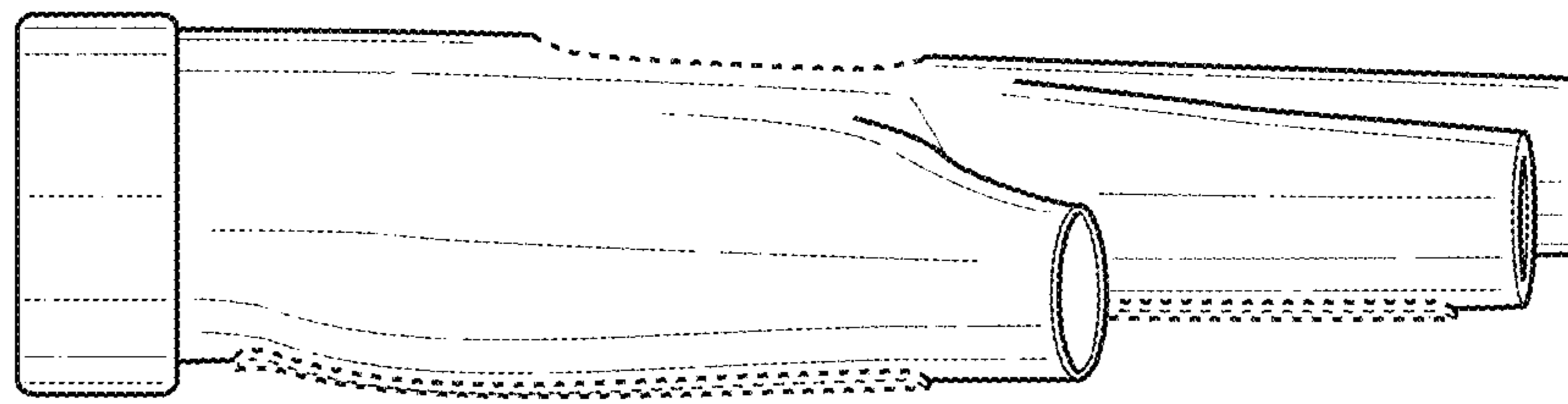

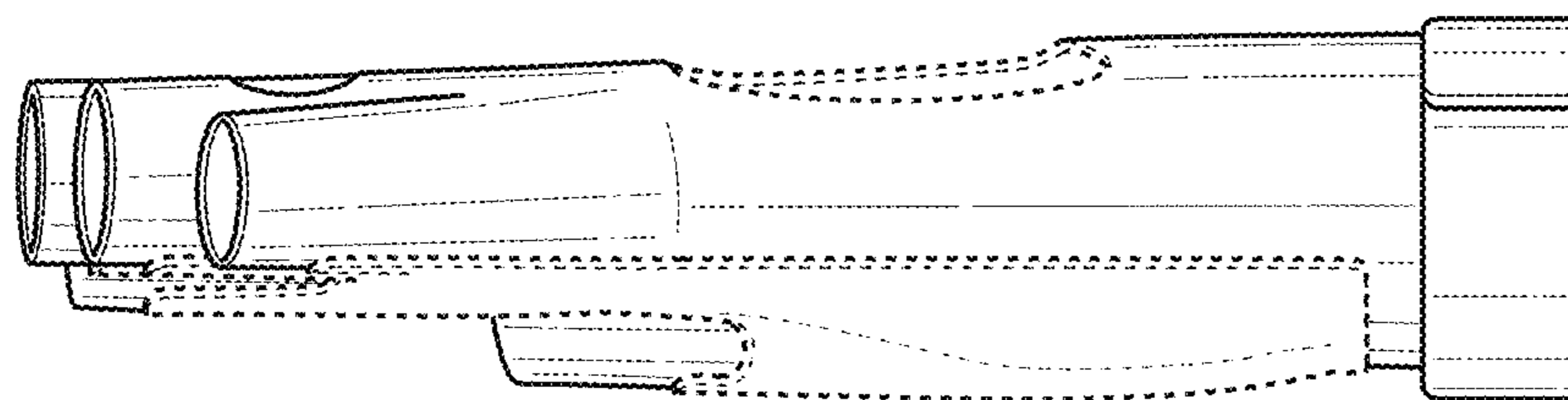

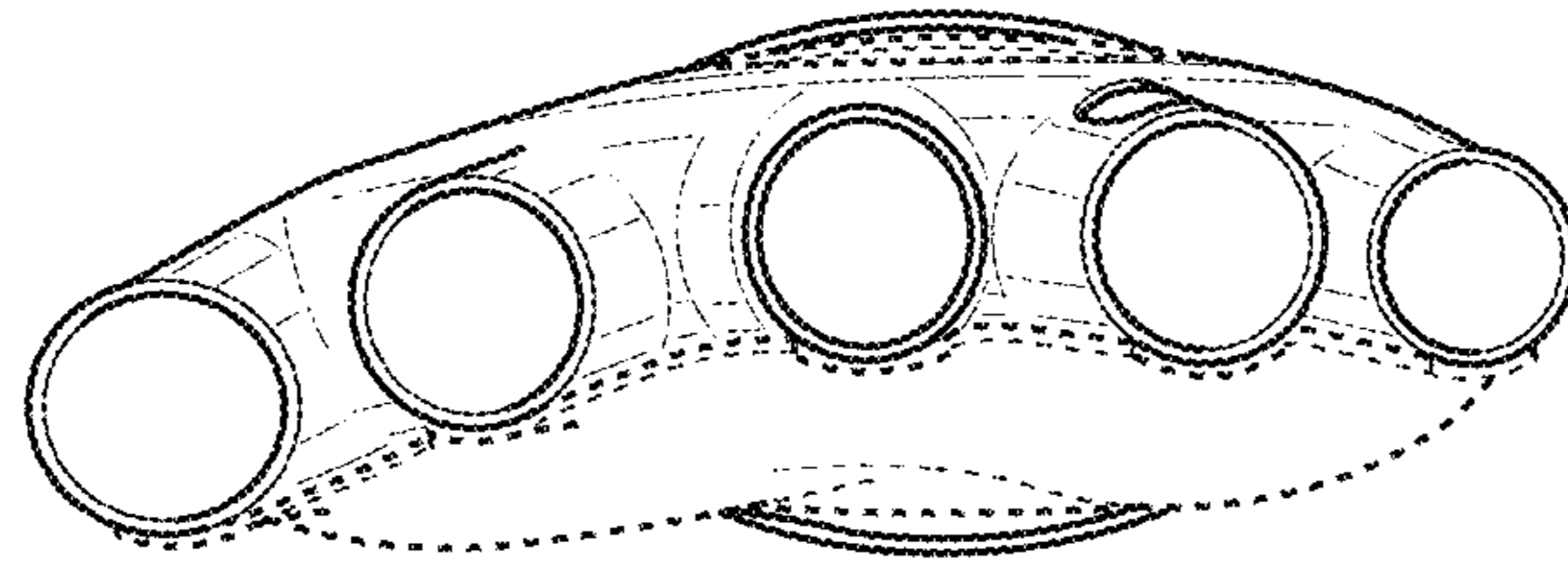

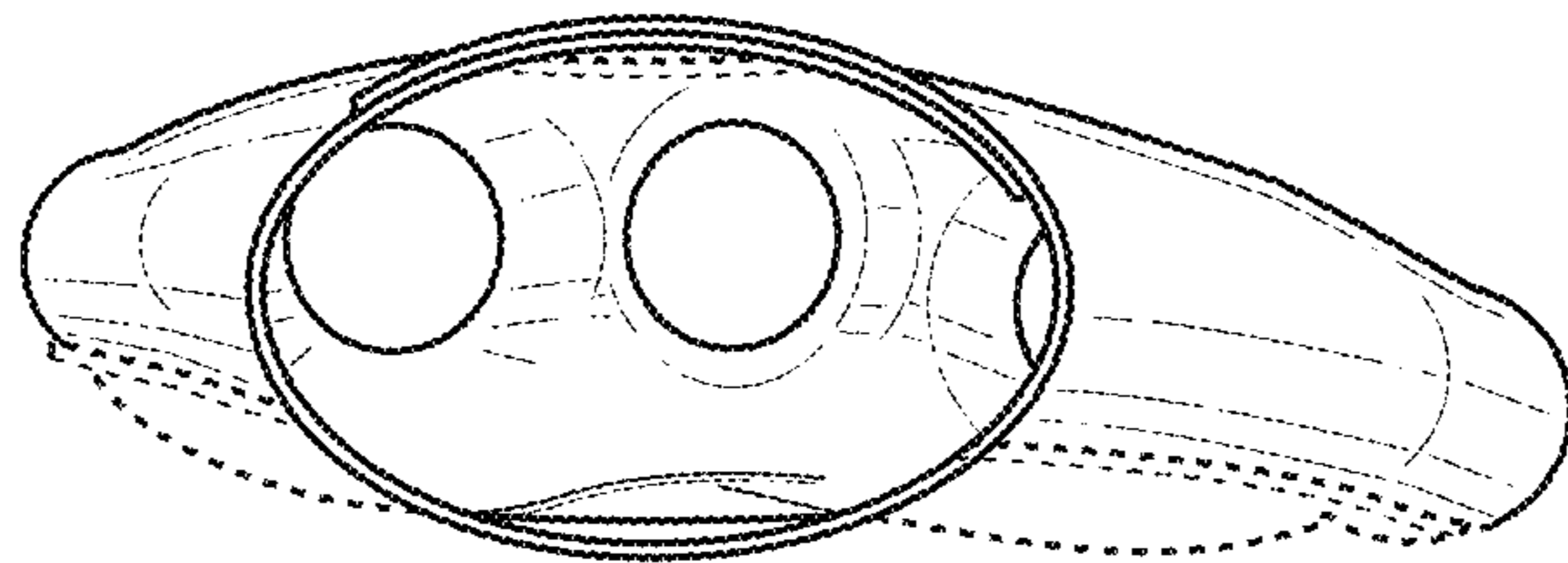
