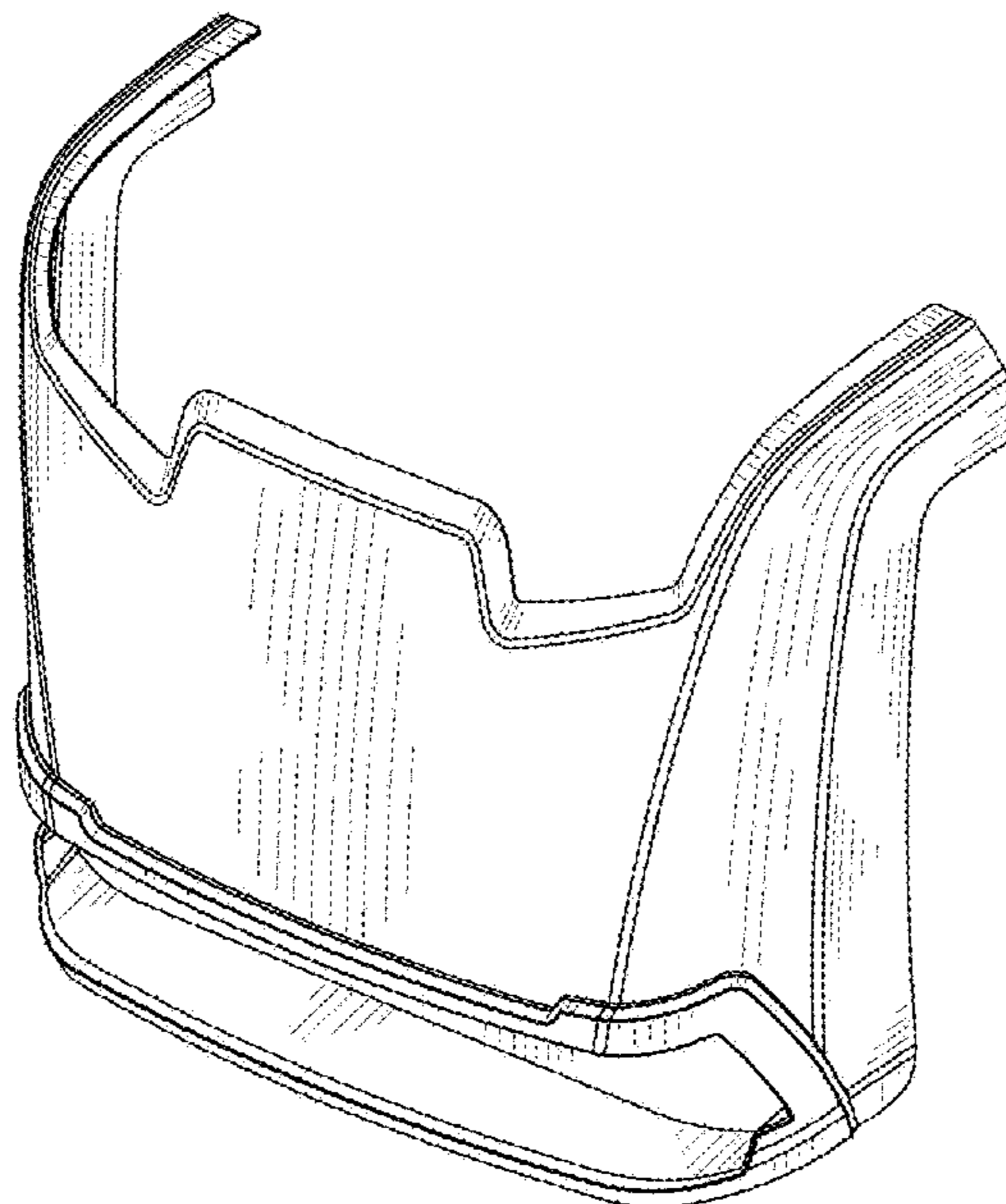
(57) **CLAIM**

The ornamental design for a bonnet for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a bonnet for a vehicle;  
FIG. 2 is a front left perspective view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image;  
FIG. 5 is top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is a front elevational view.

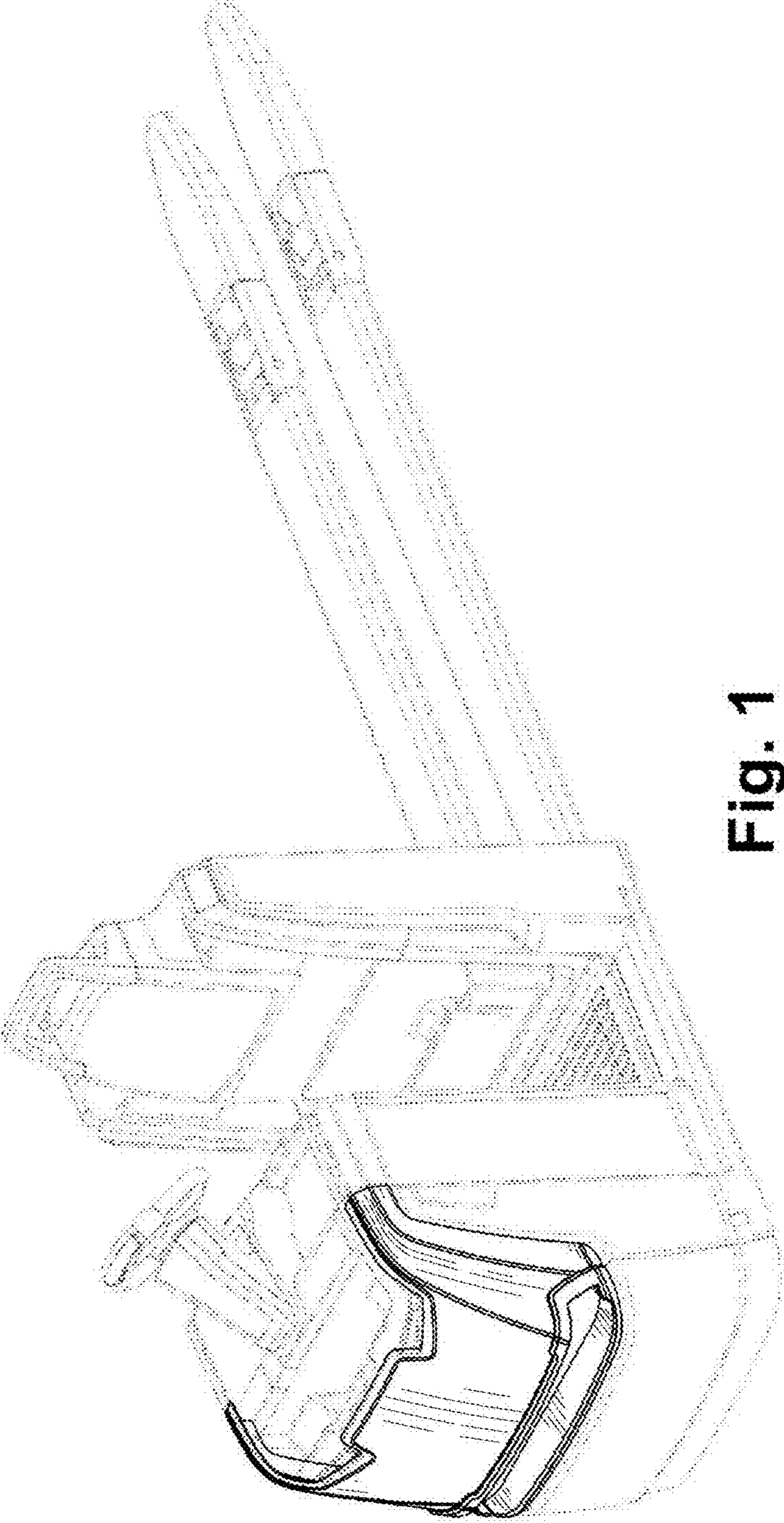

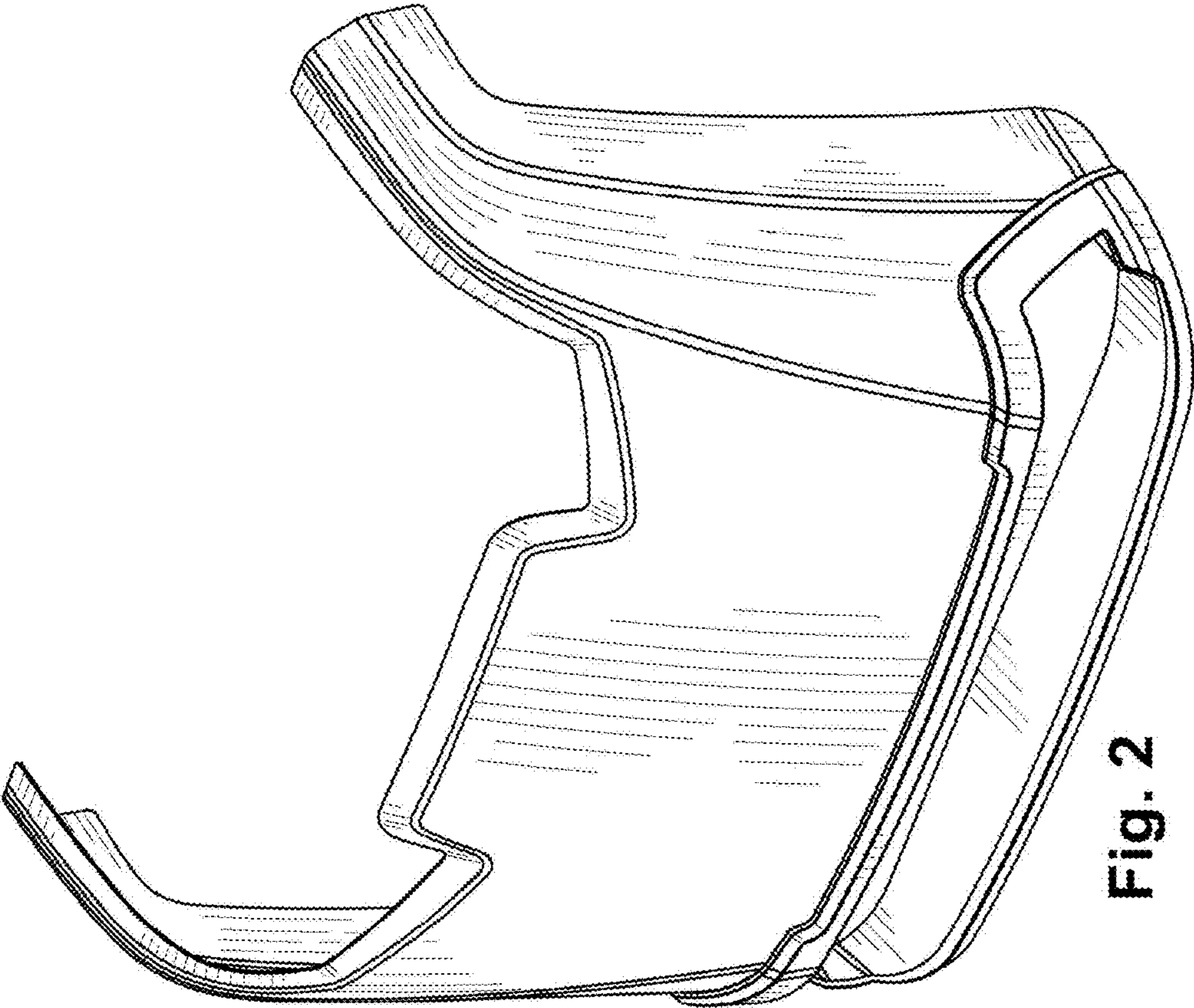

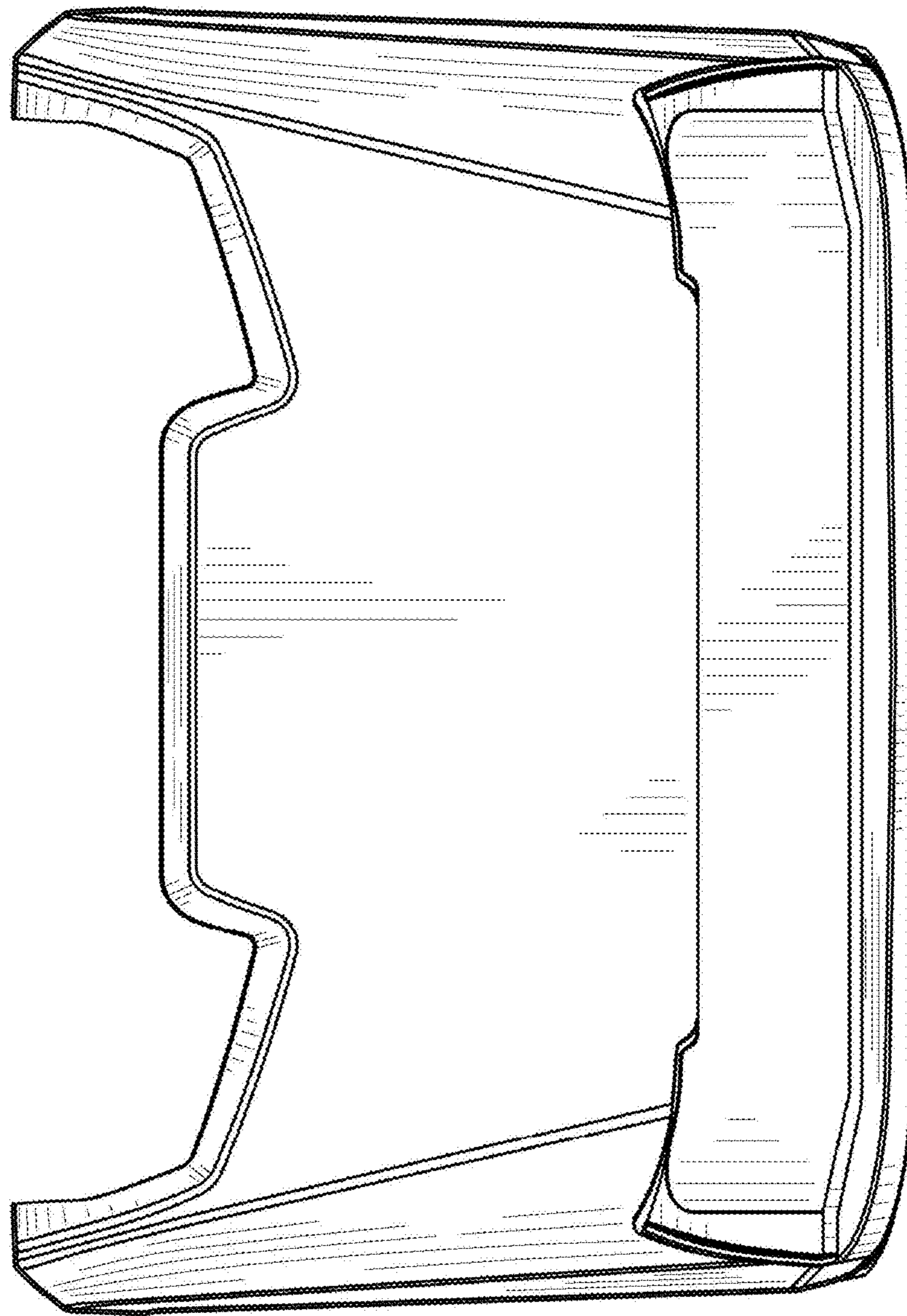

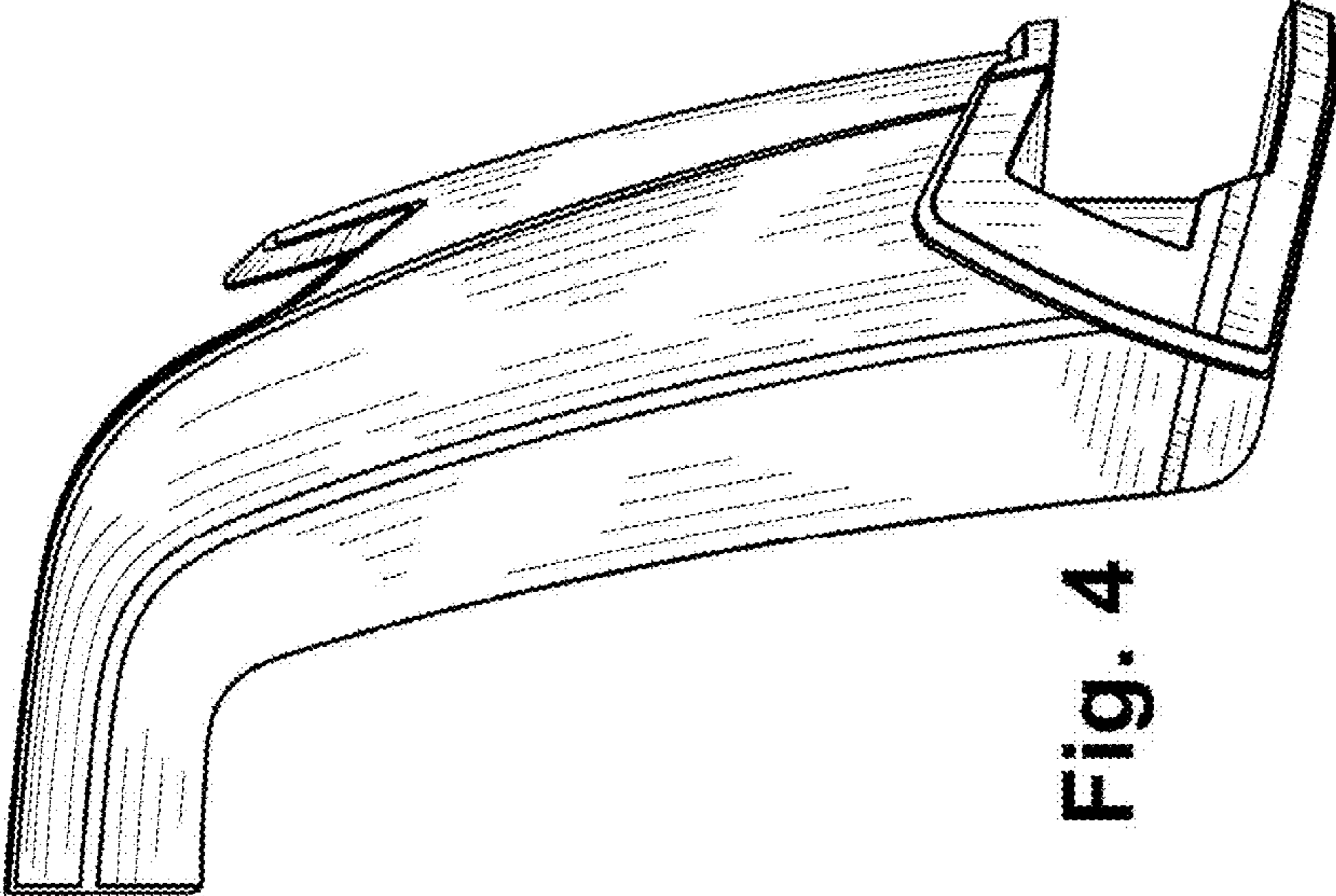

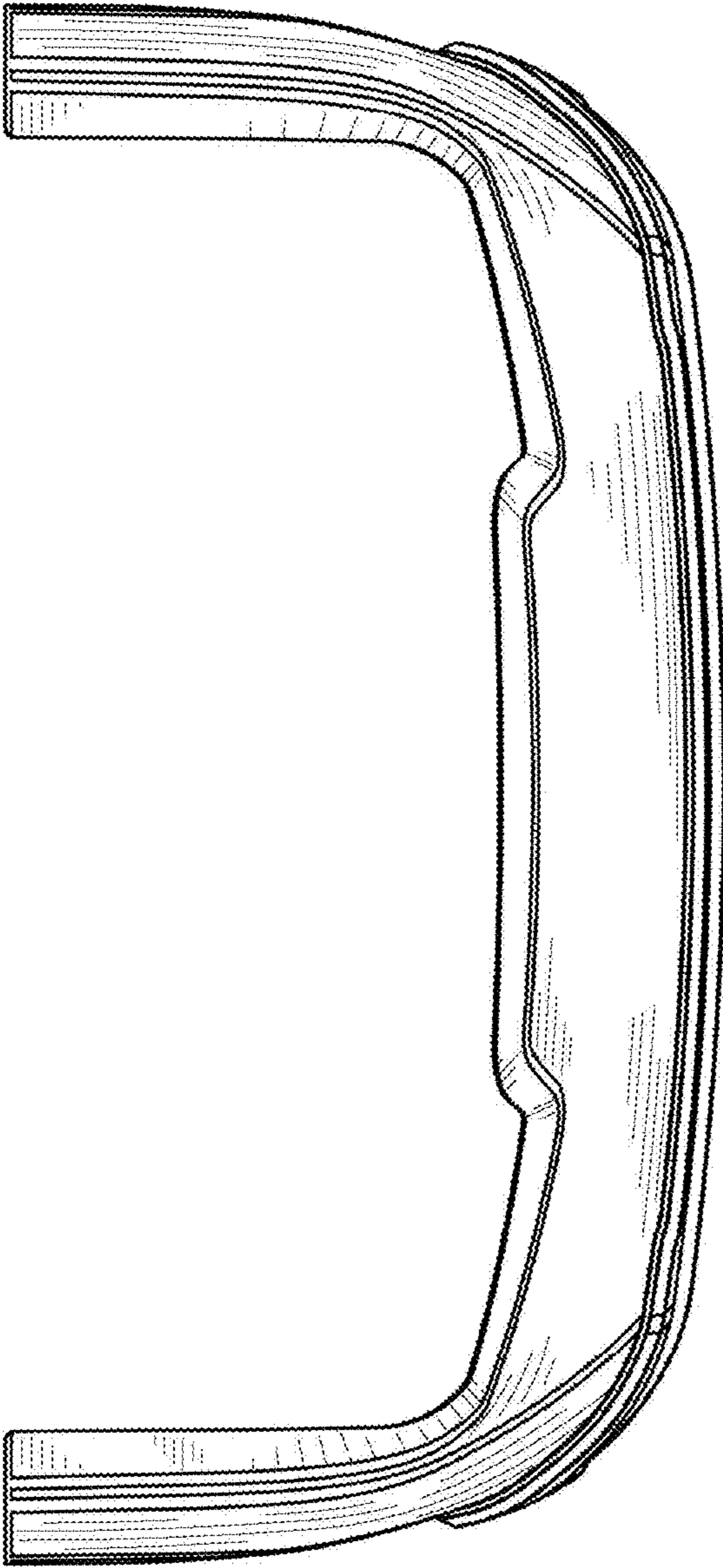

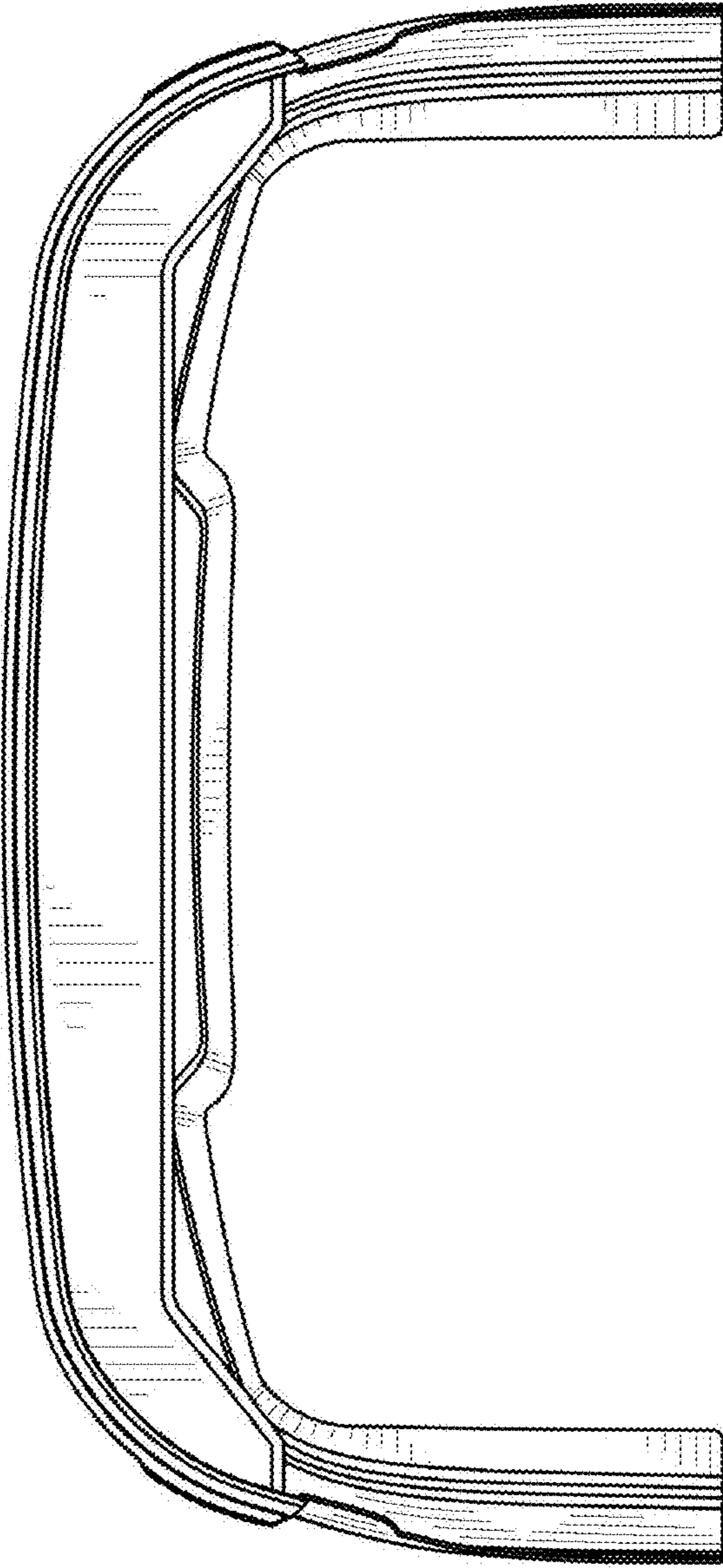

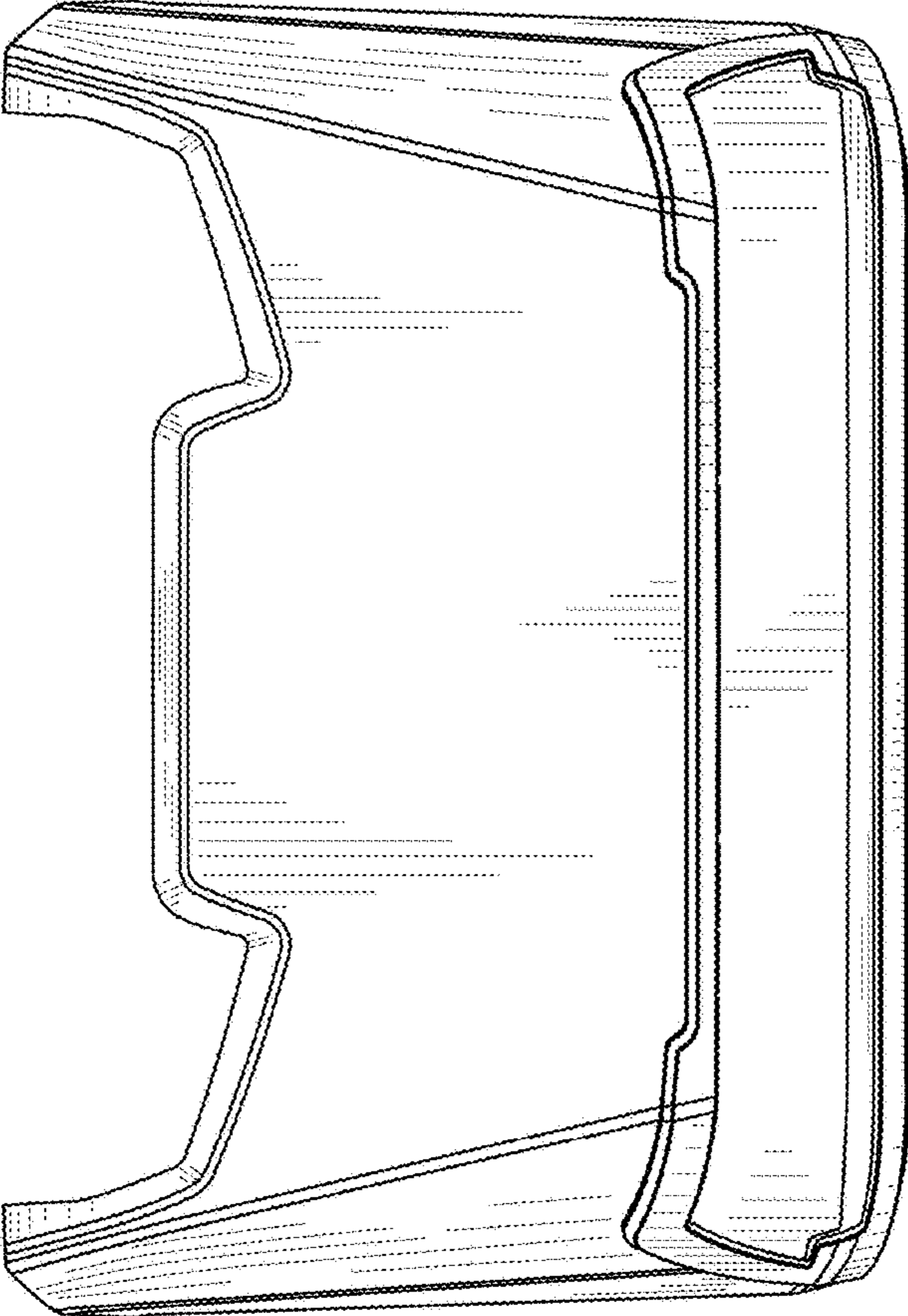
