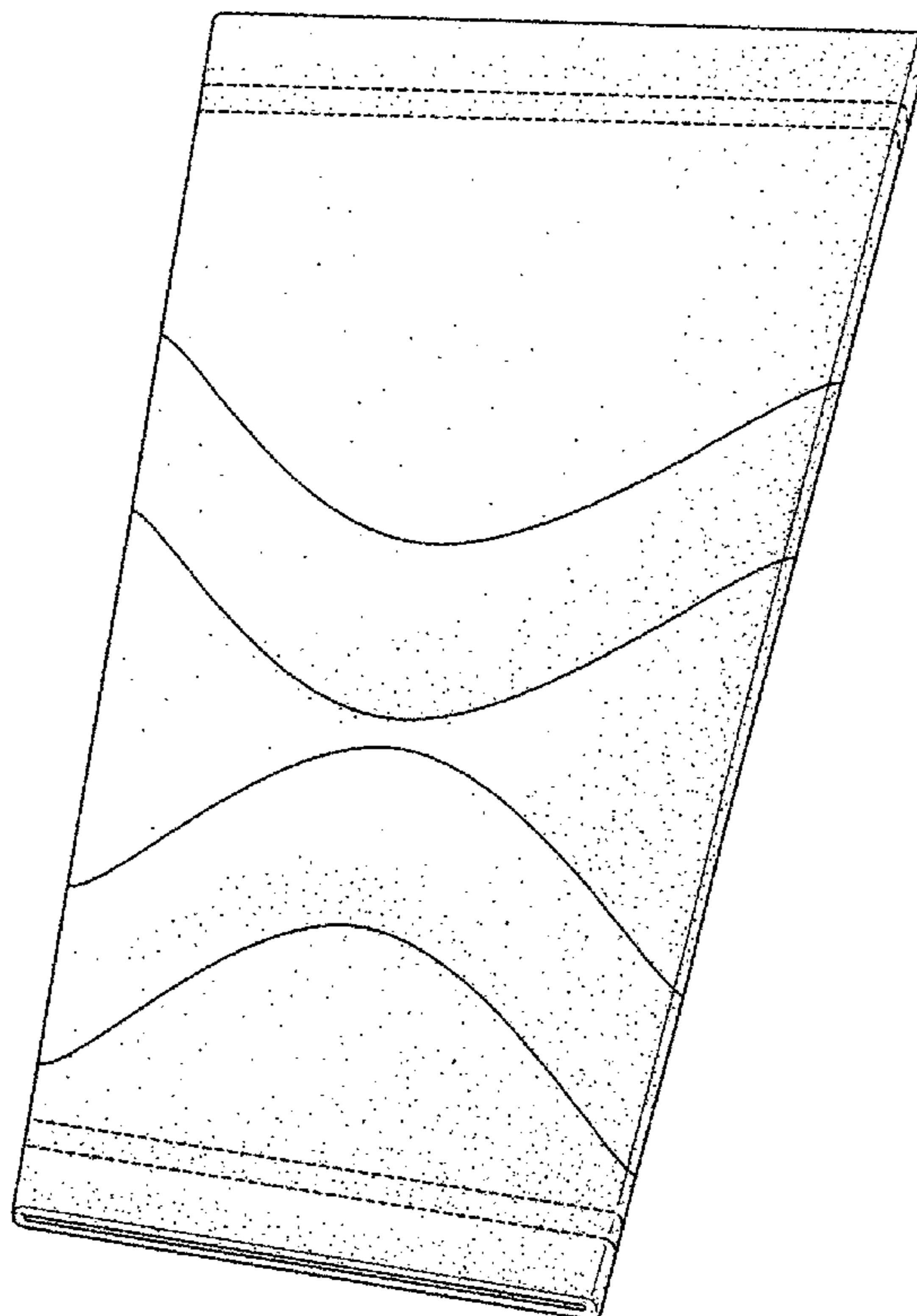
(57) **CLAIM**

The ornamental design for an ankle sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the ankle sleeve of the present invention showing my new design;
FIG. 2 is a front side elevation view thereof;
FIG. 3 is back side elevation view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is another side elevation view thereof
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The short dashed lines on the ankle sleeve illustrate unclaimed stitching.

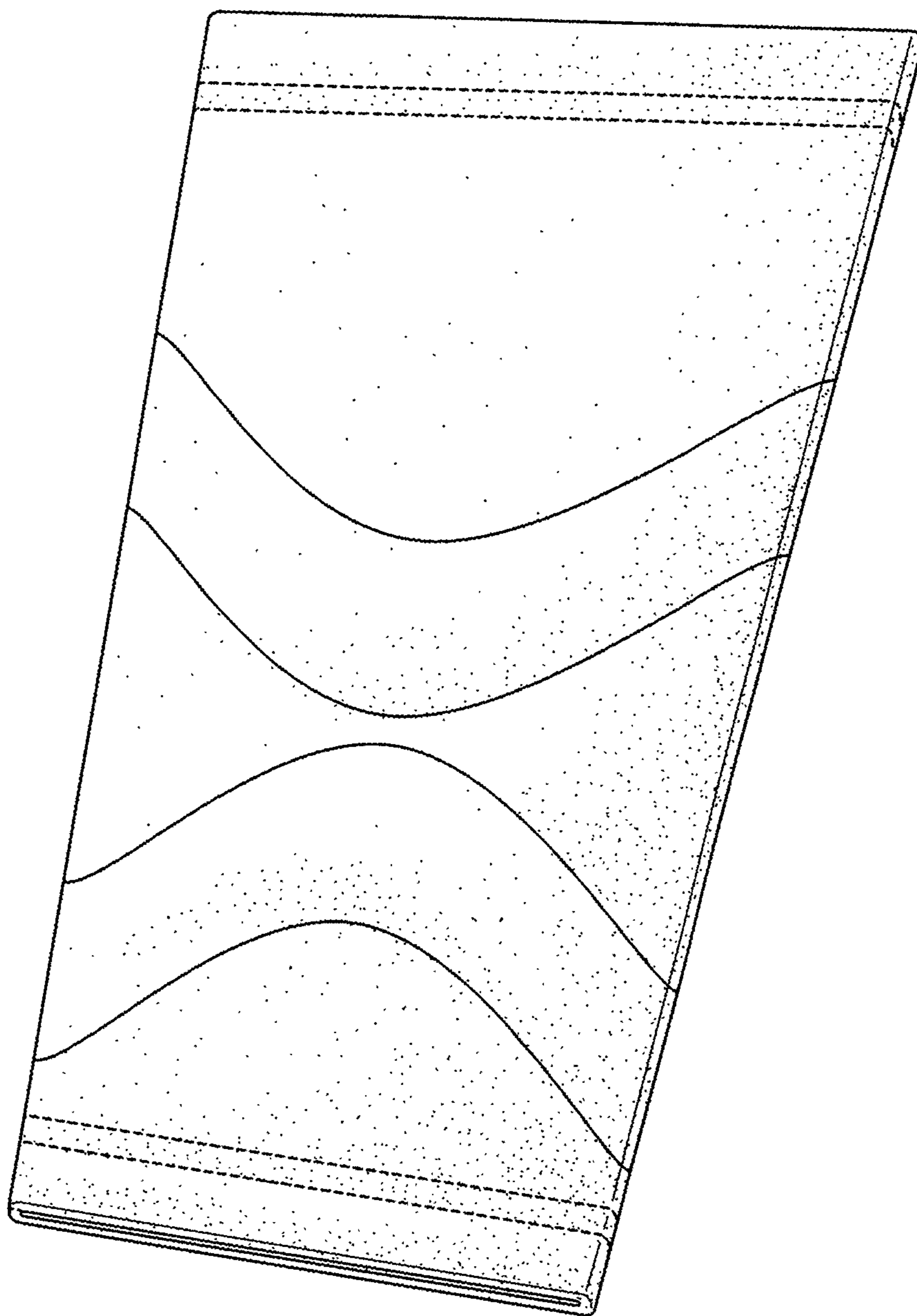

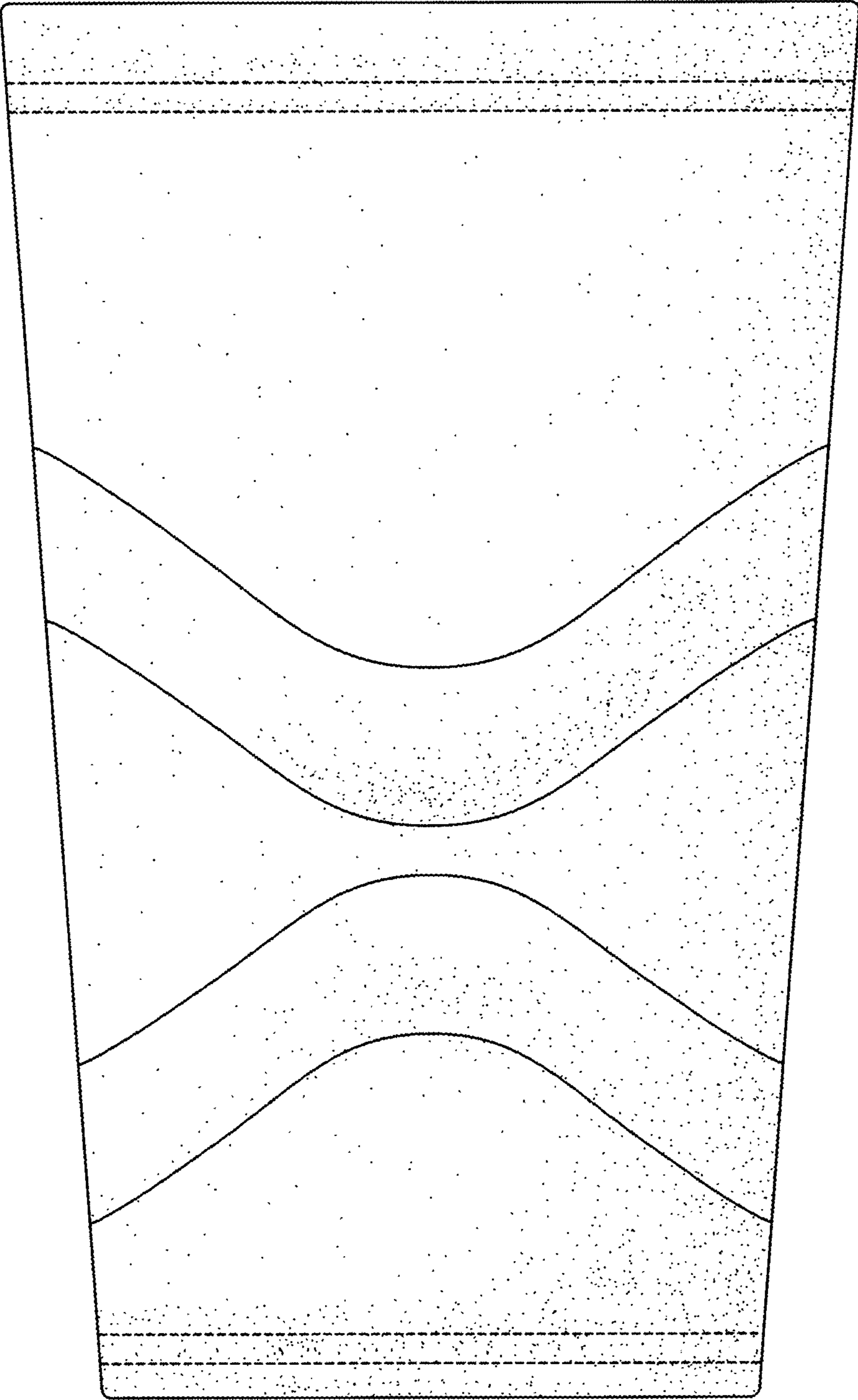

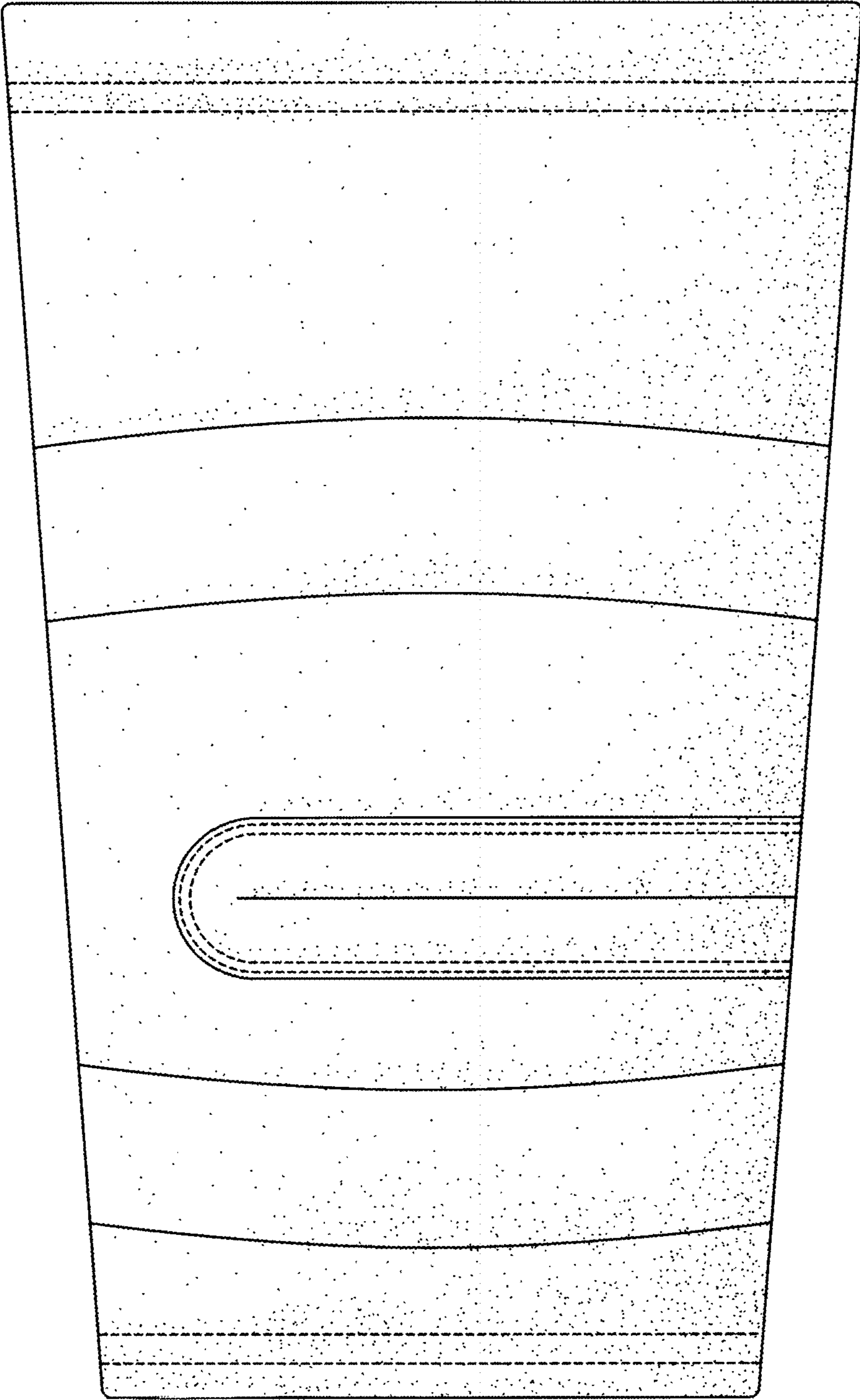

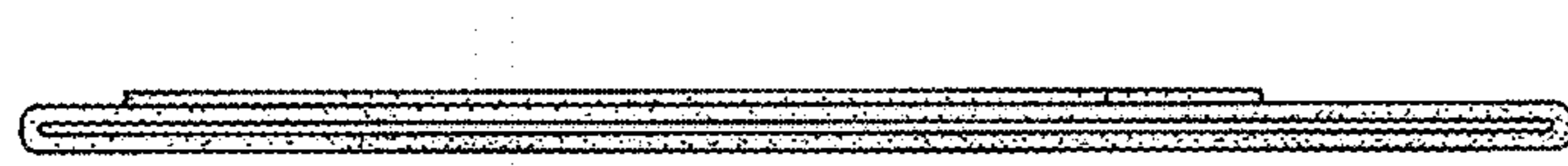

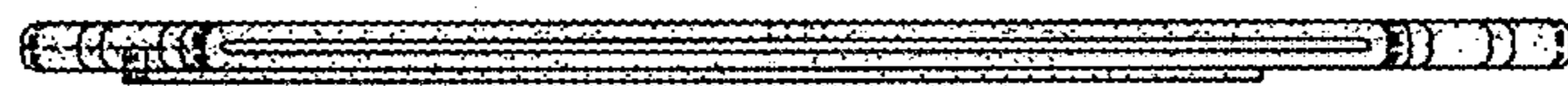
