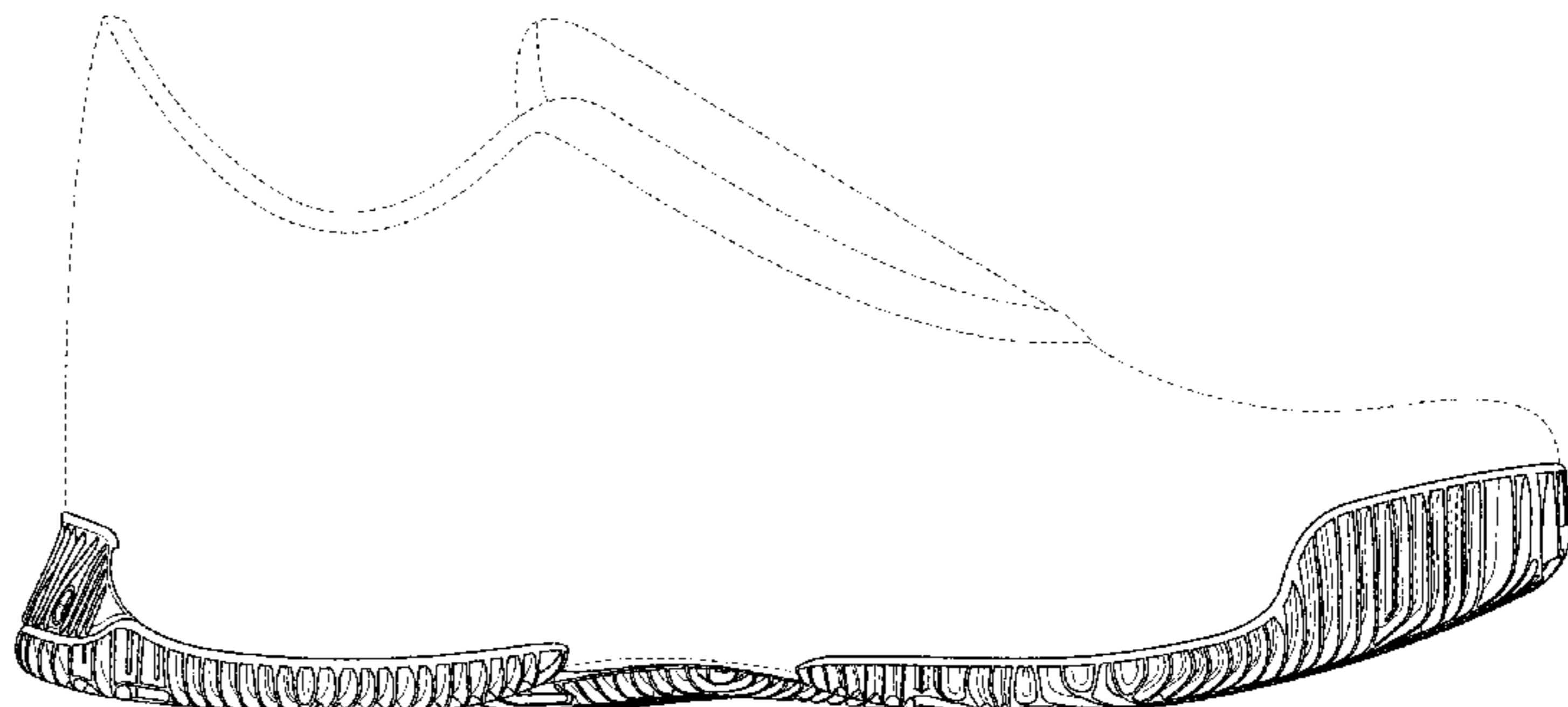
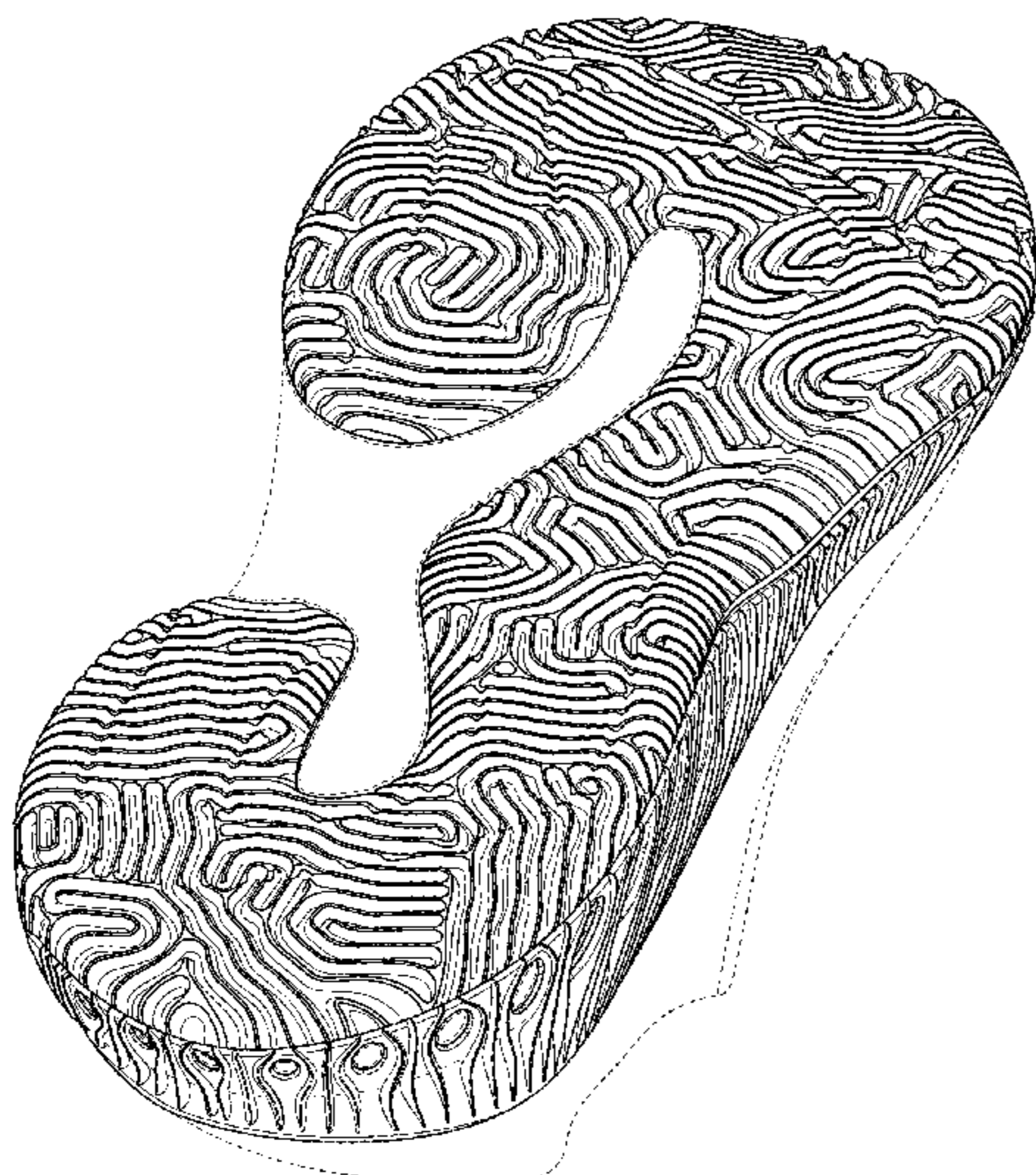
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a shoe showing the claimed design;
FIG. 2 is a front view thereof;

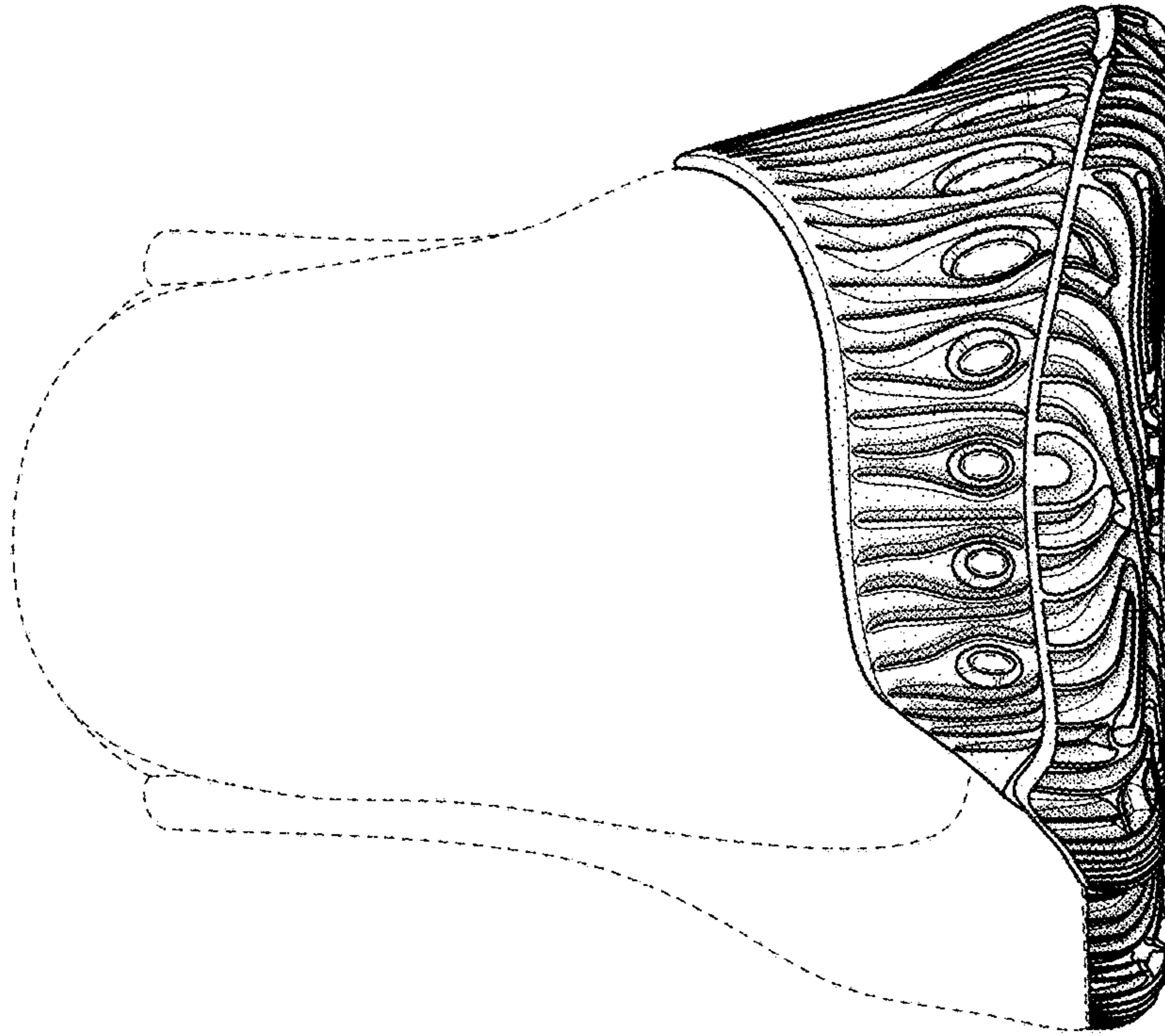

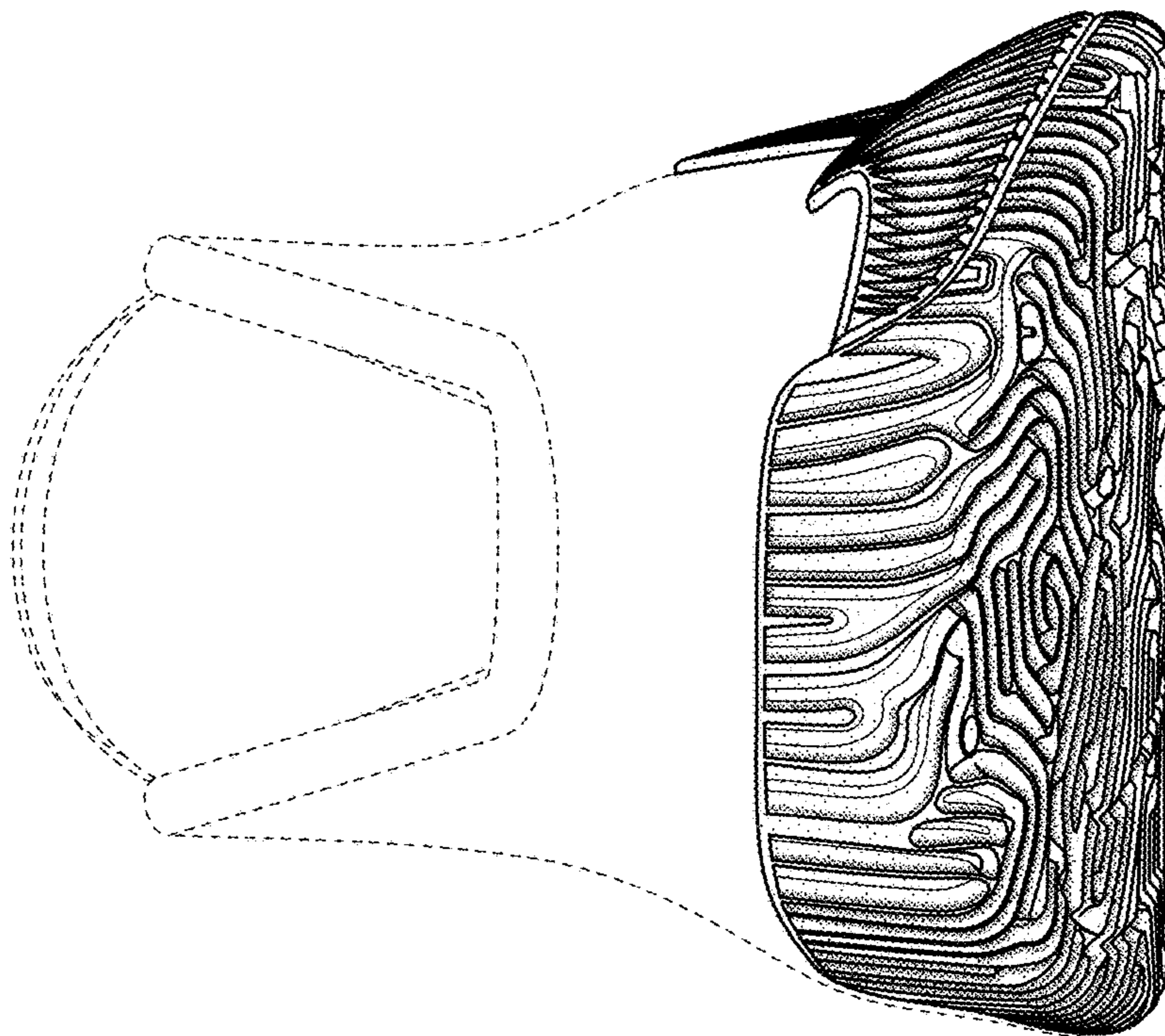

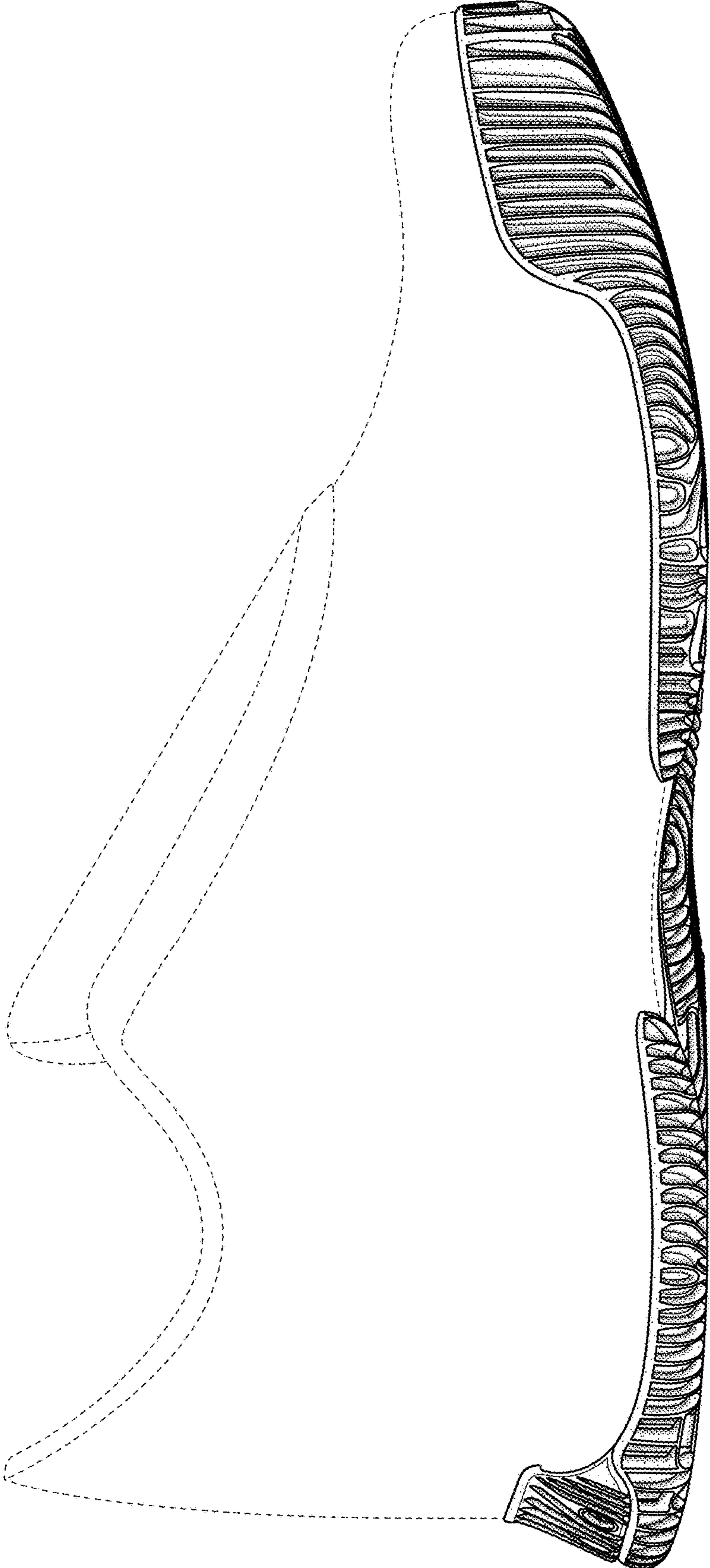

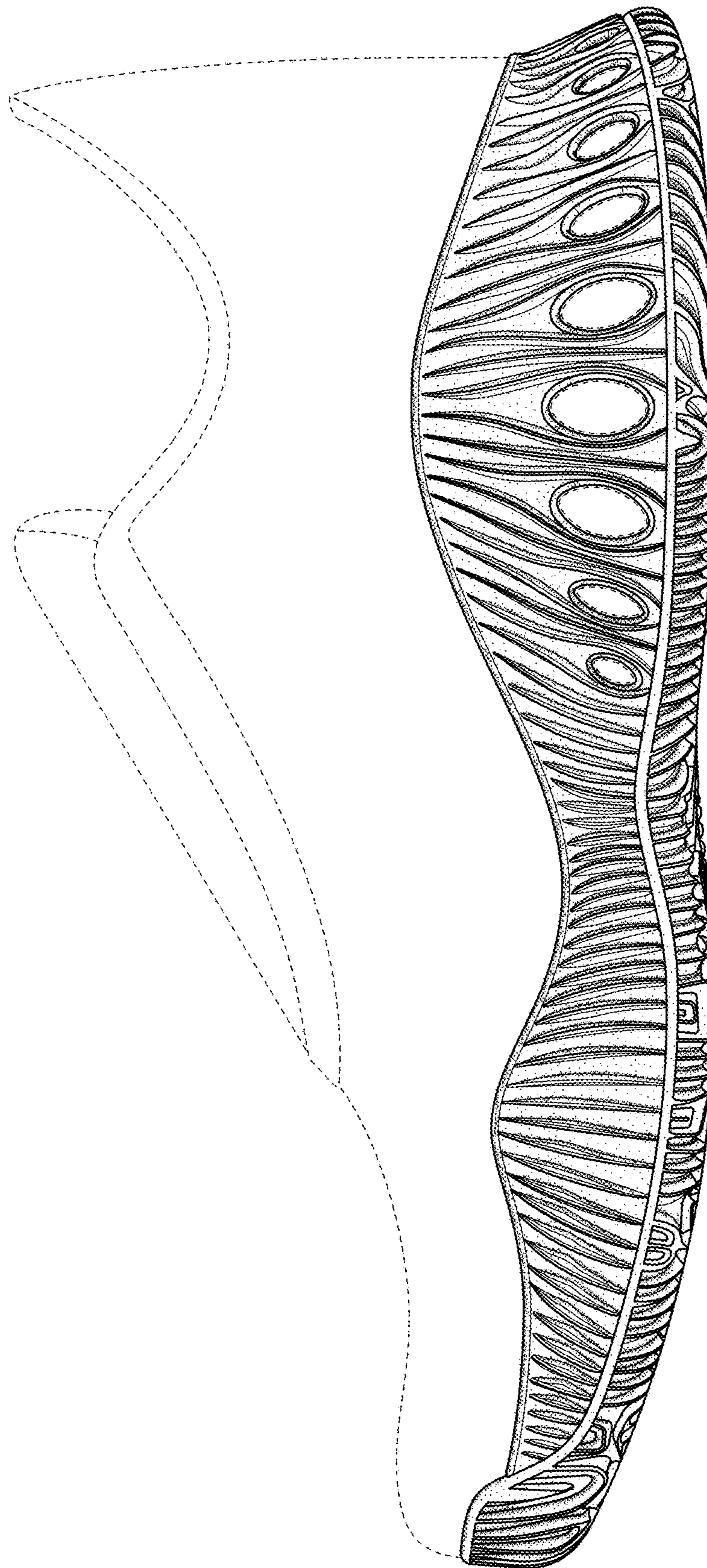

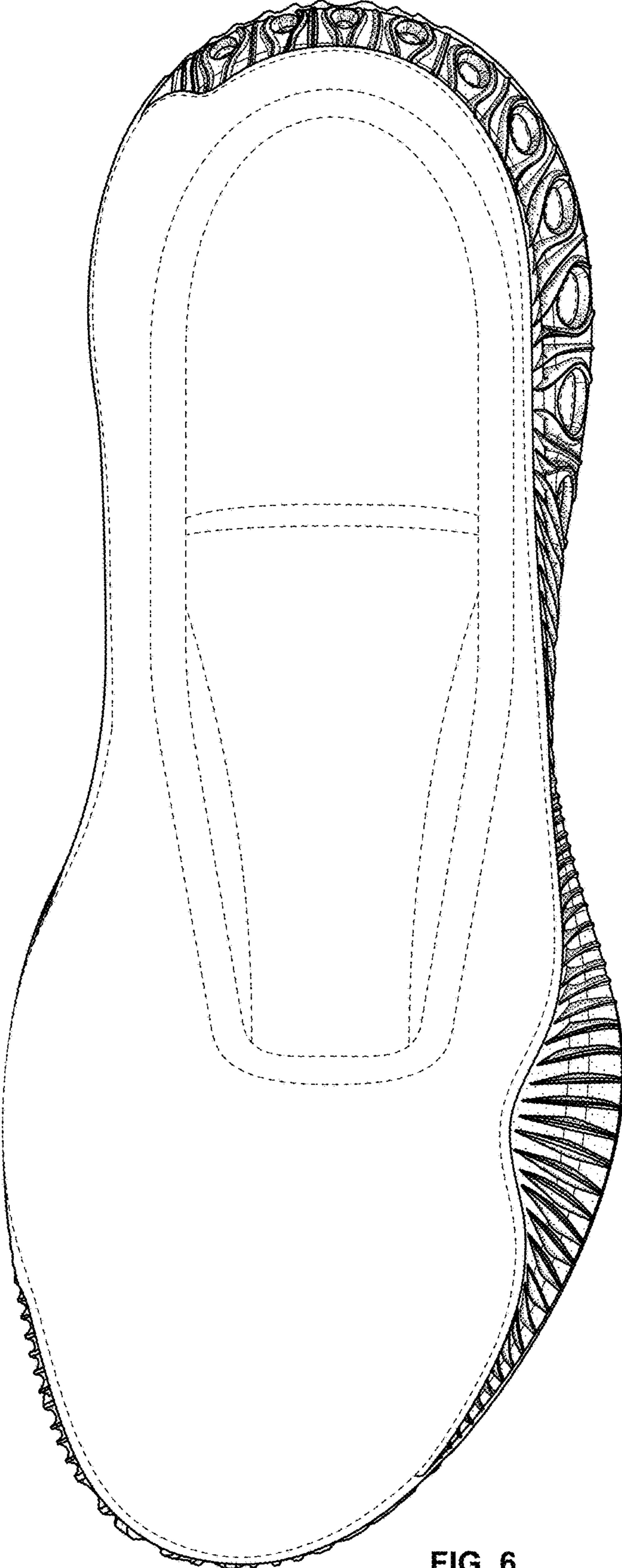

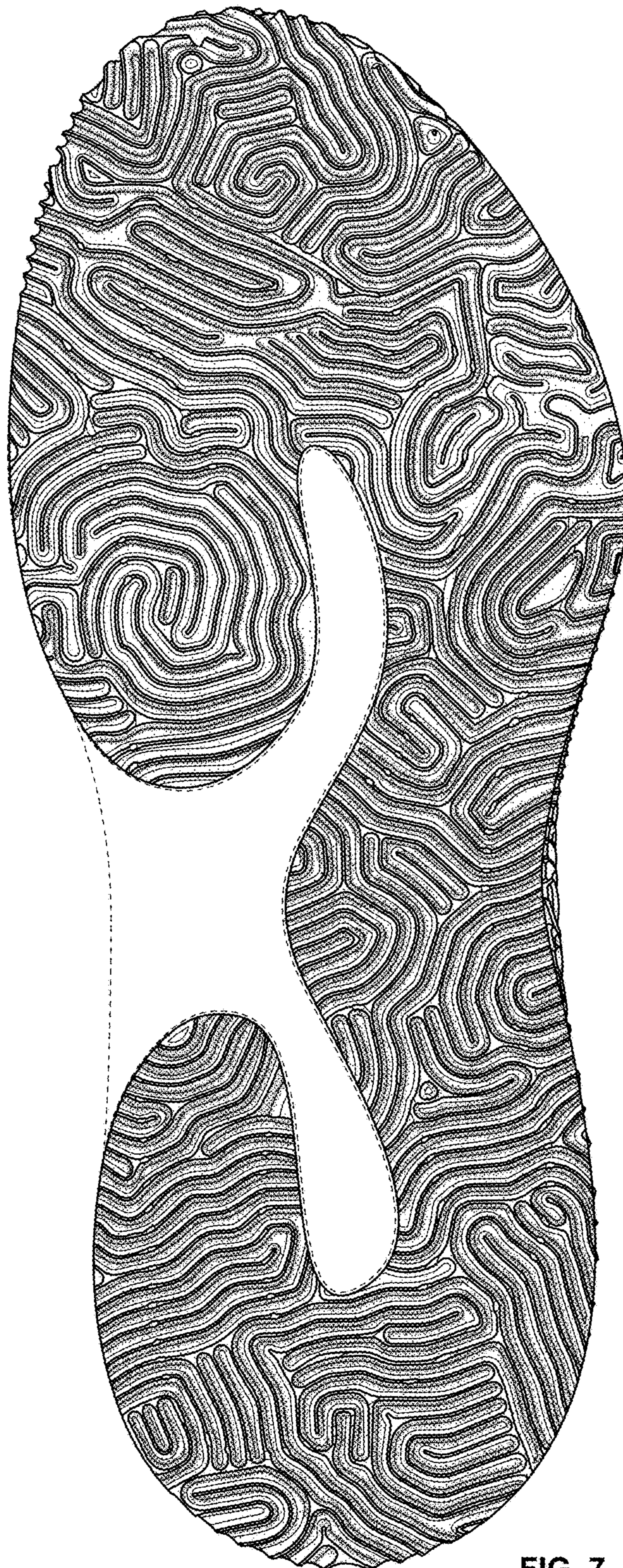

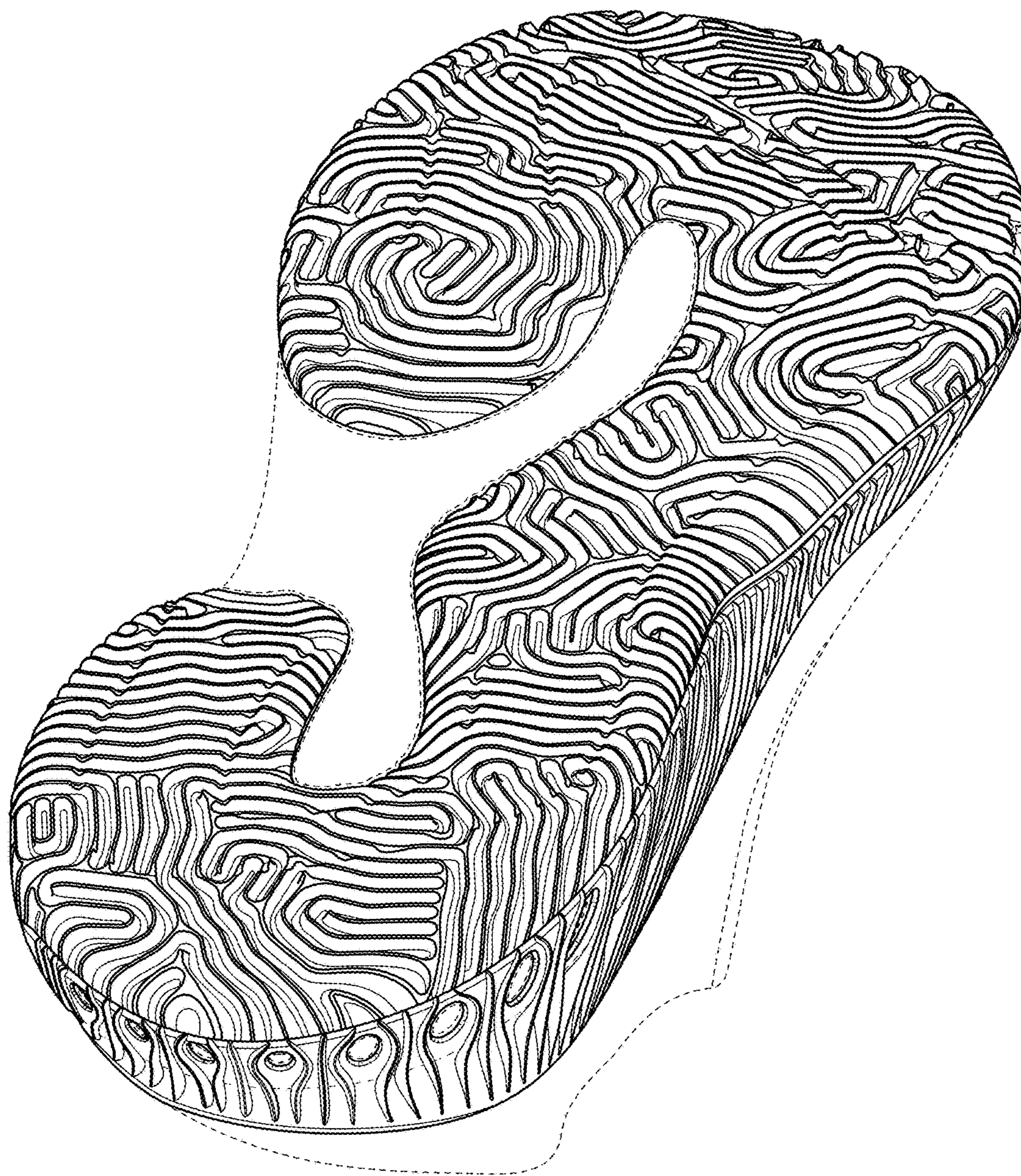

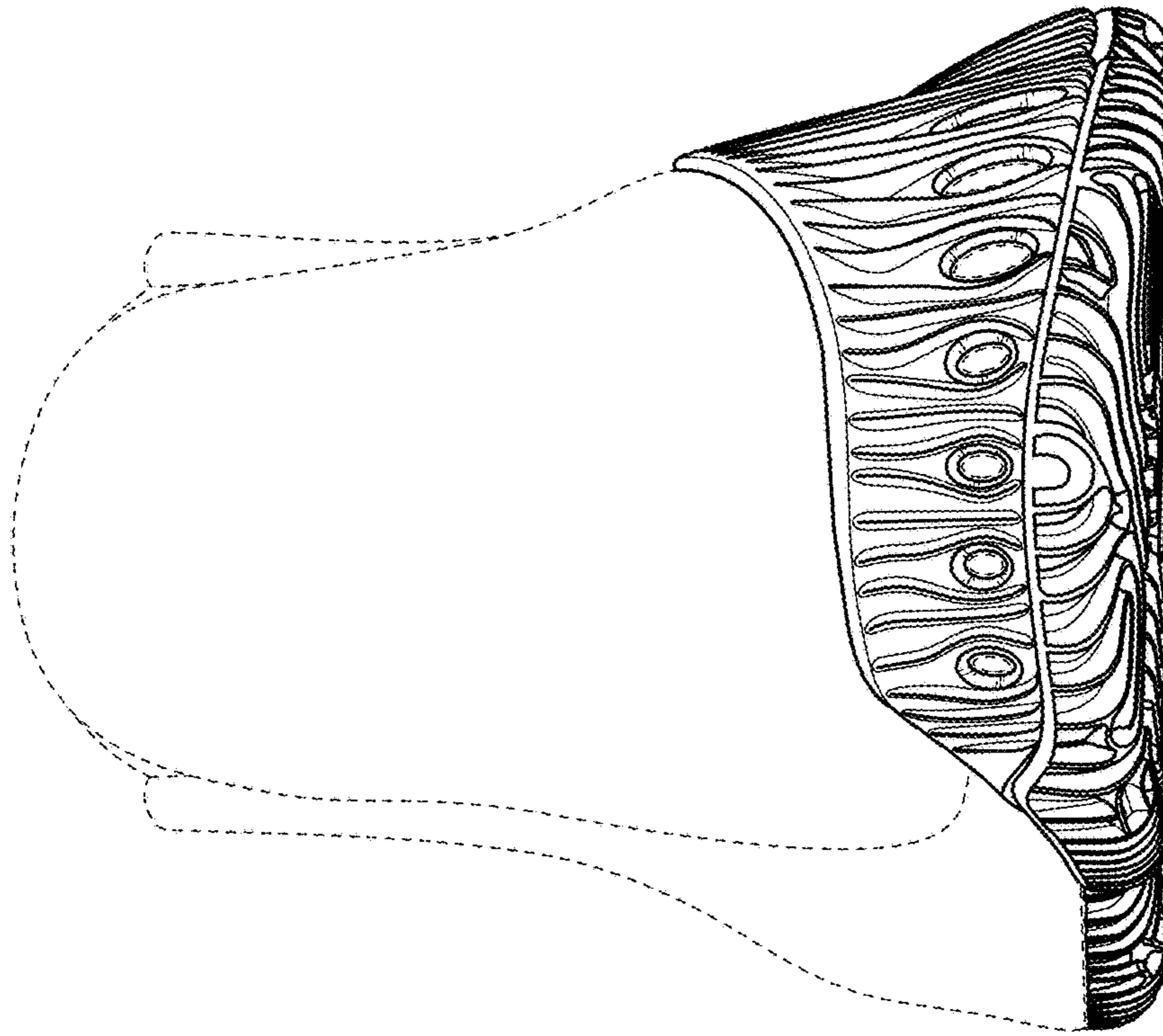

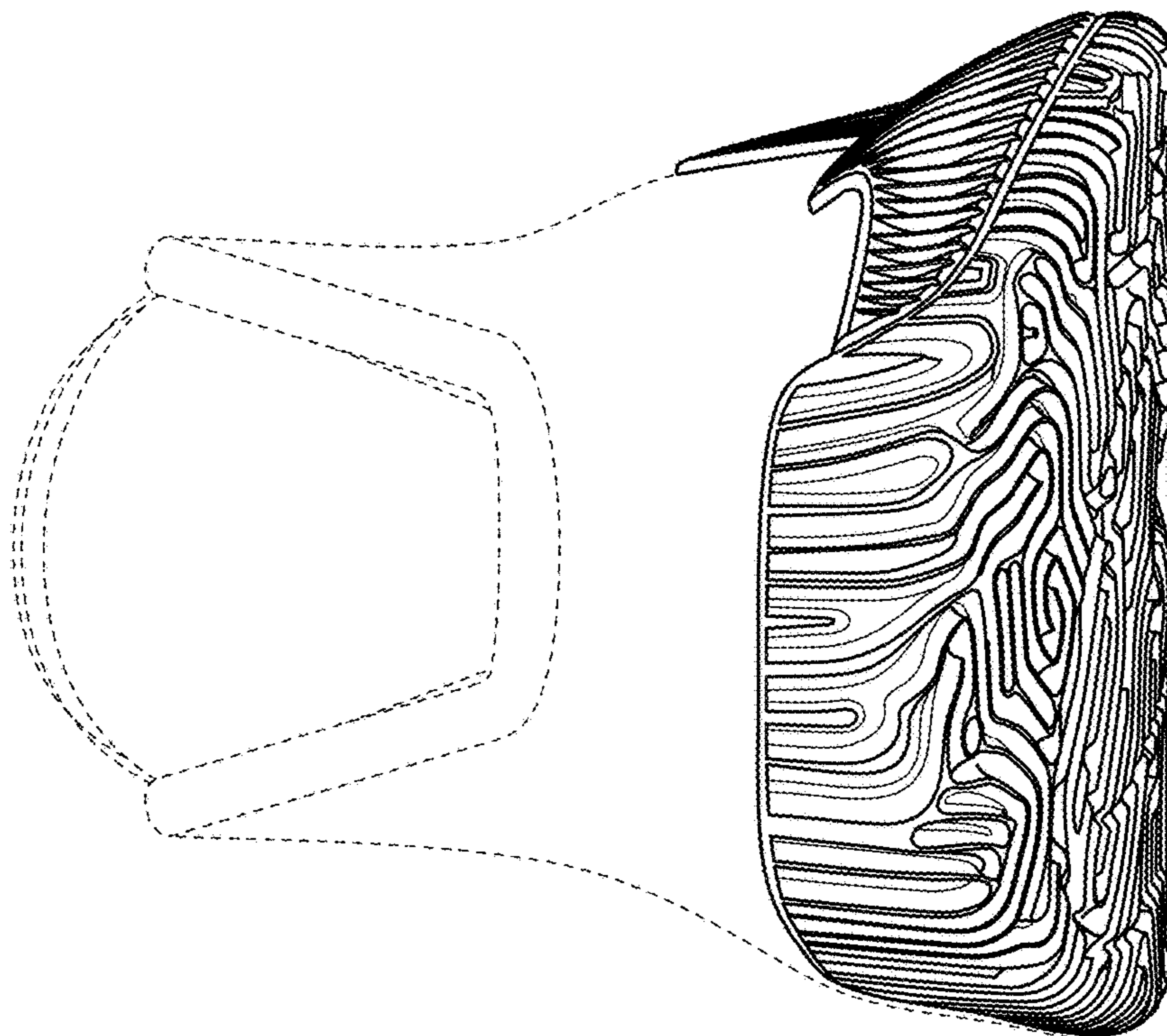

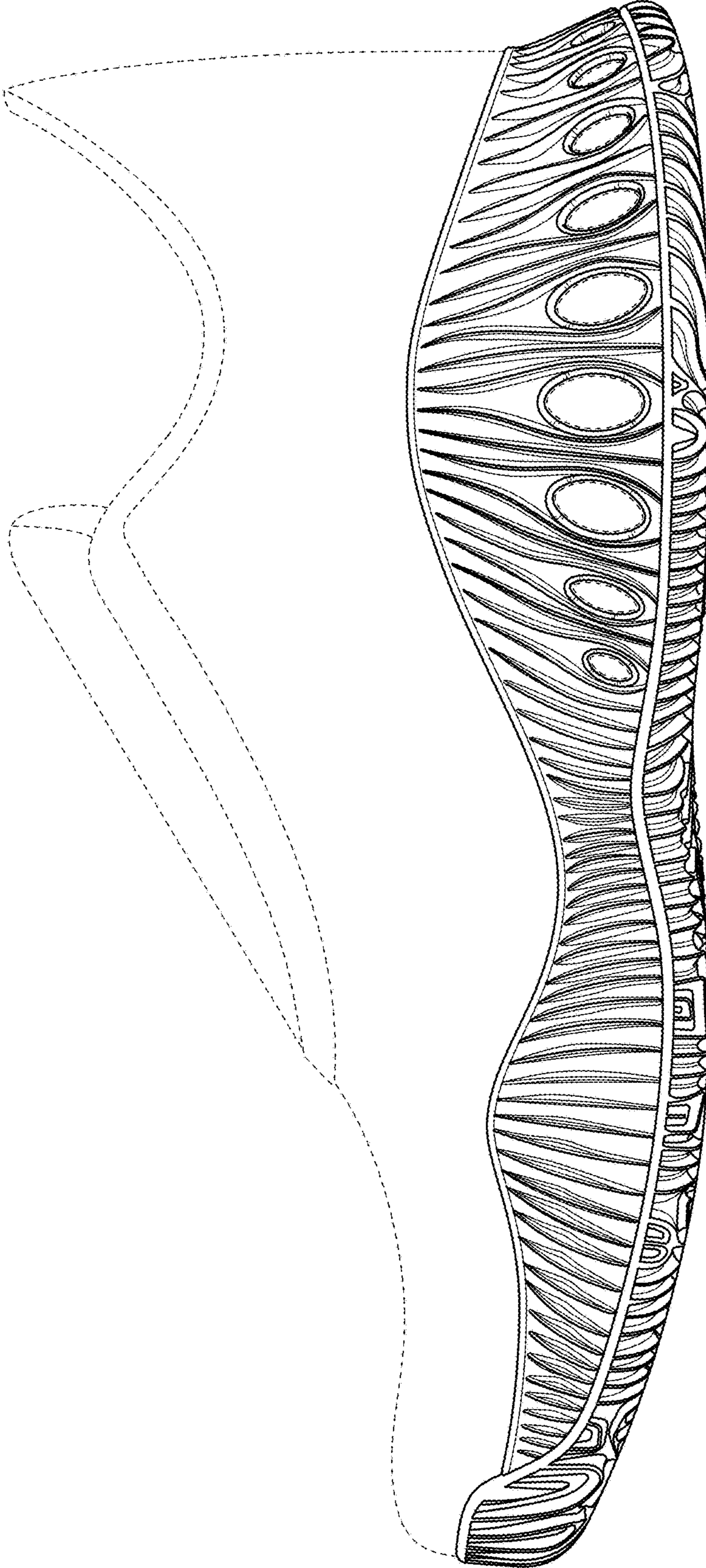

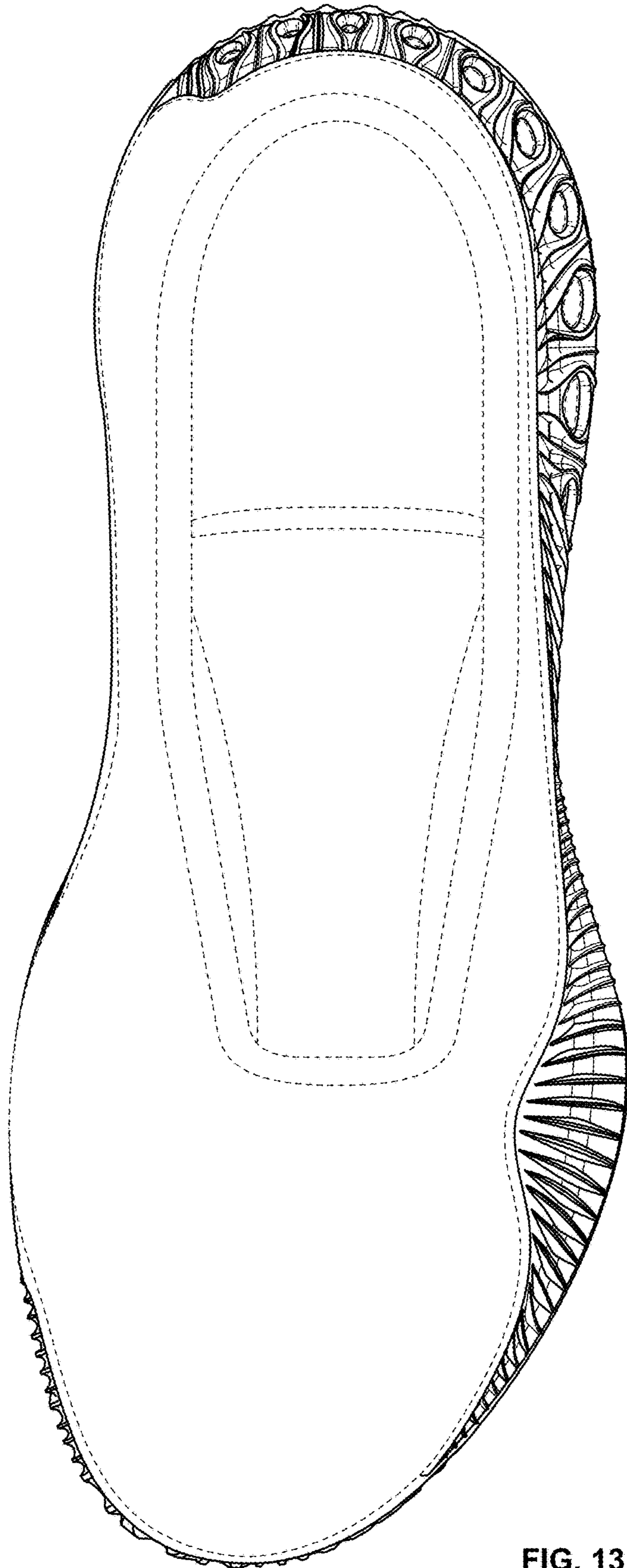

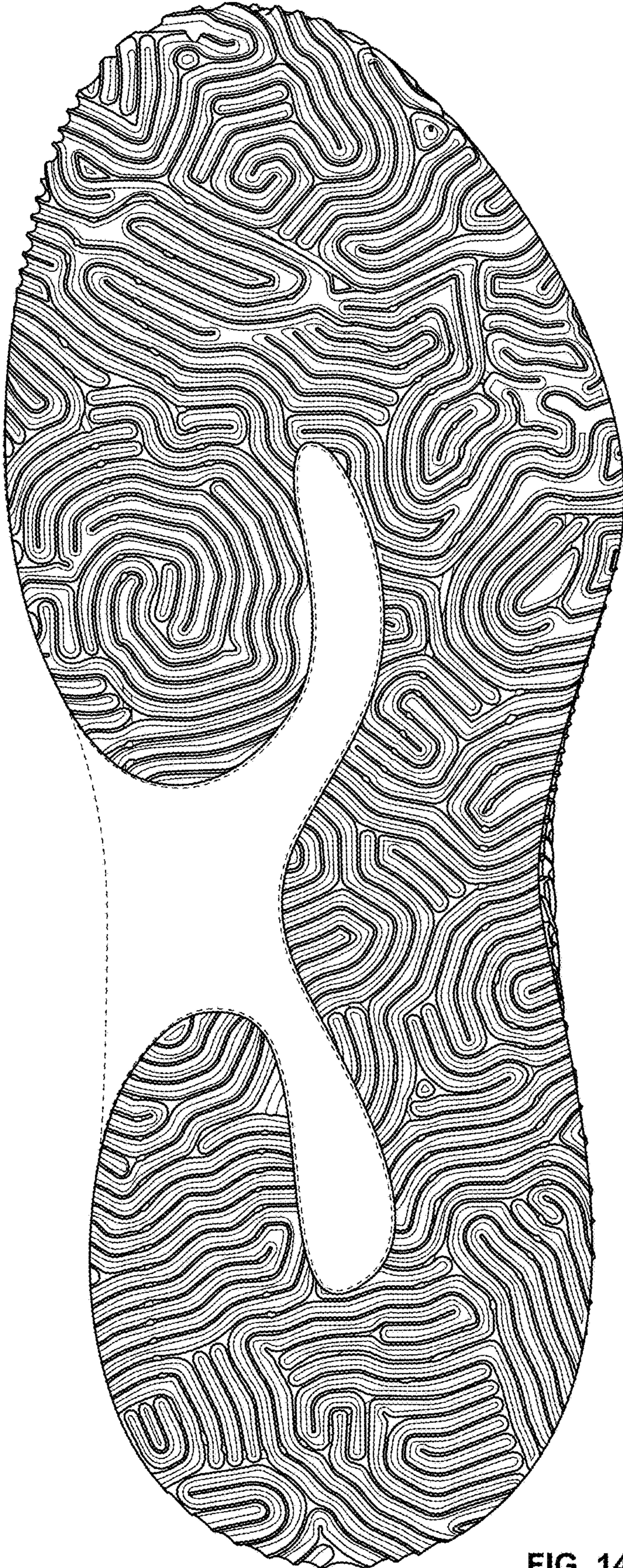
