(57) **CLAIM**

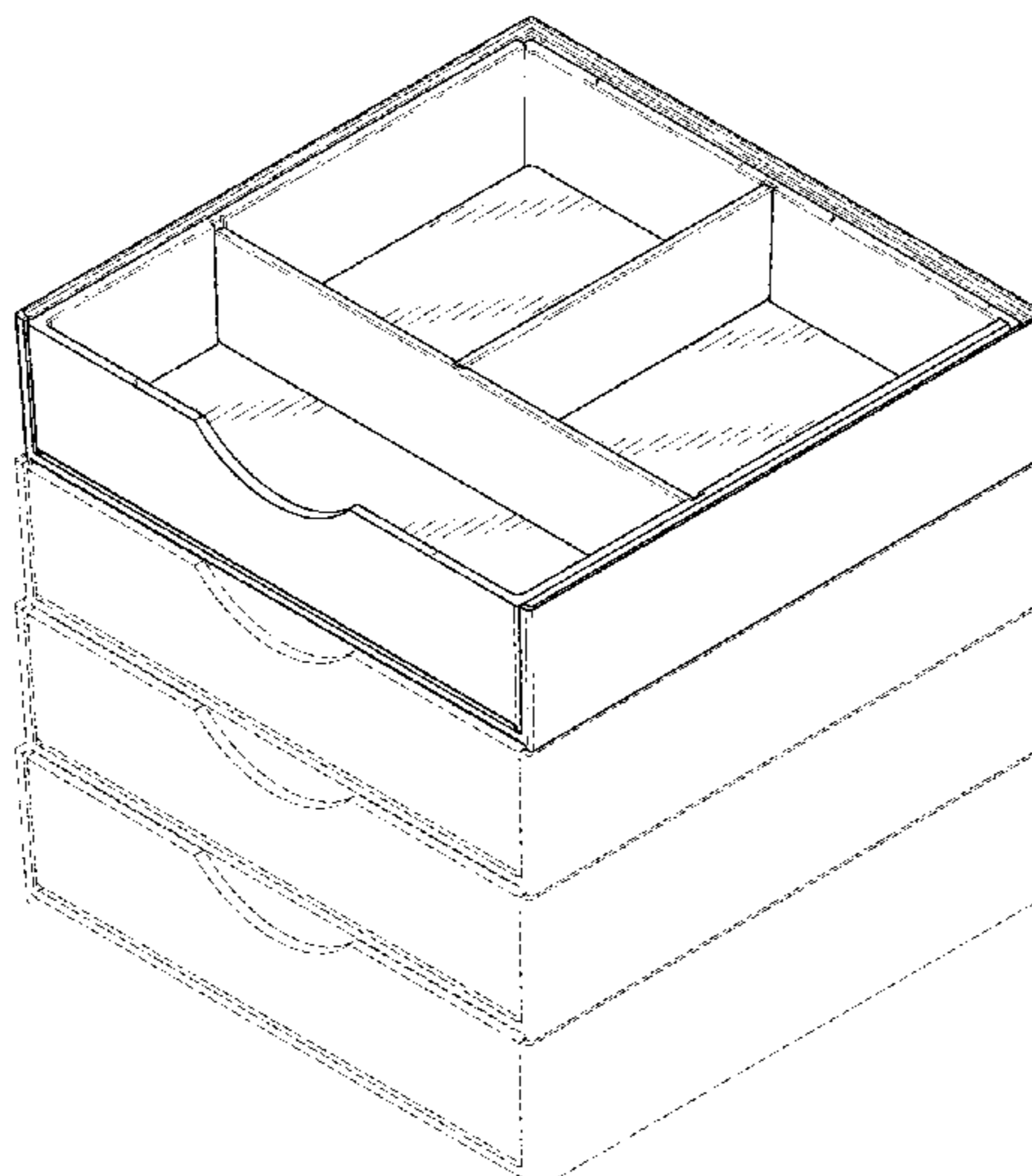
The ornamental design for a stackable box as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and side perspective view of a stackable box embodying my new design.  
FIG. 2 is a bottom, back and side perspective view thereof.

FIG. 5 is a left side view thereof.

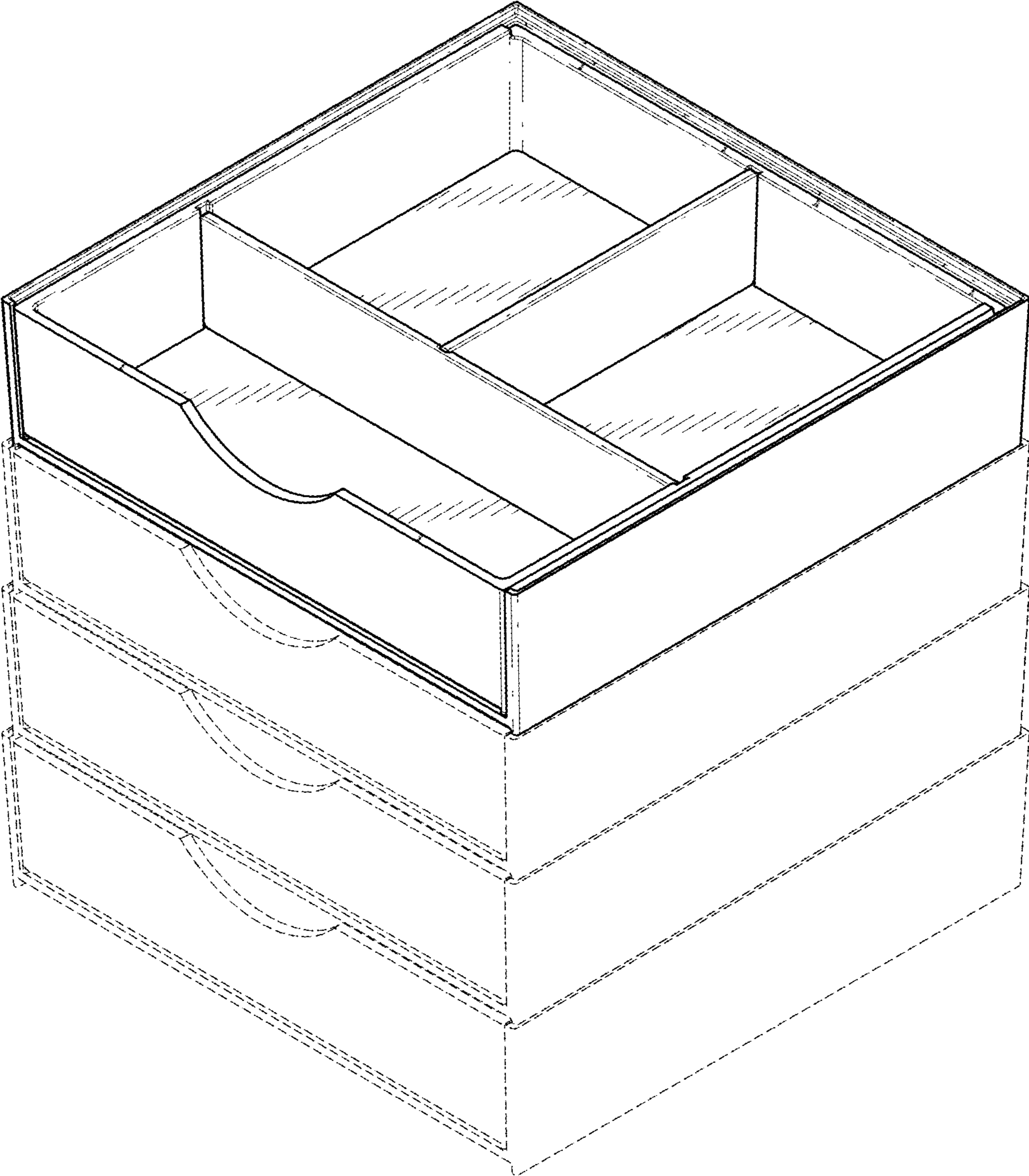

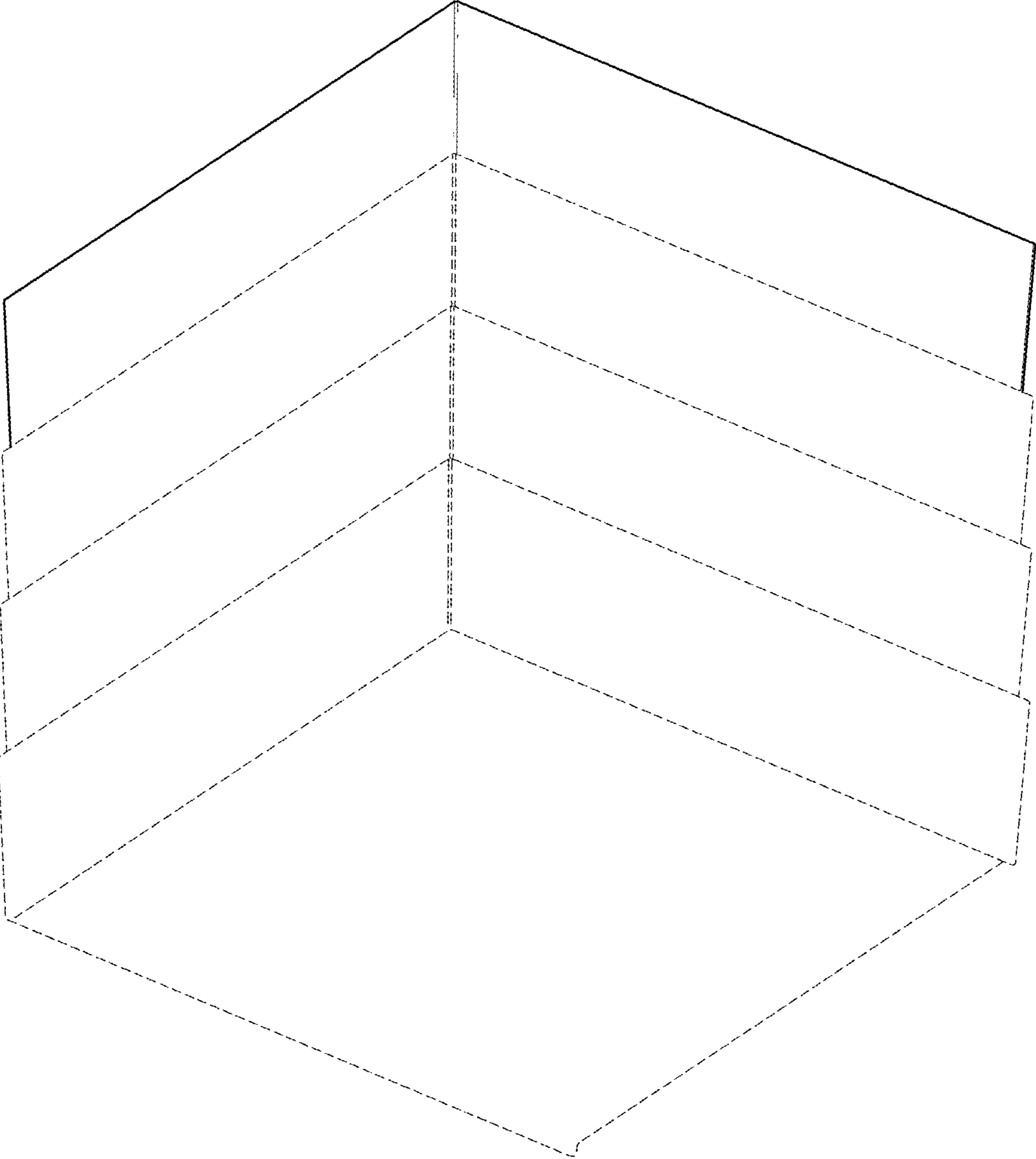
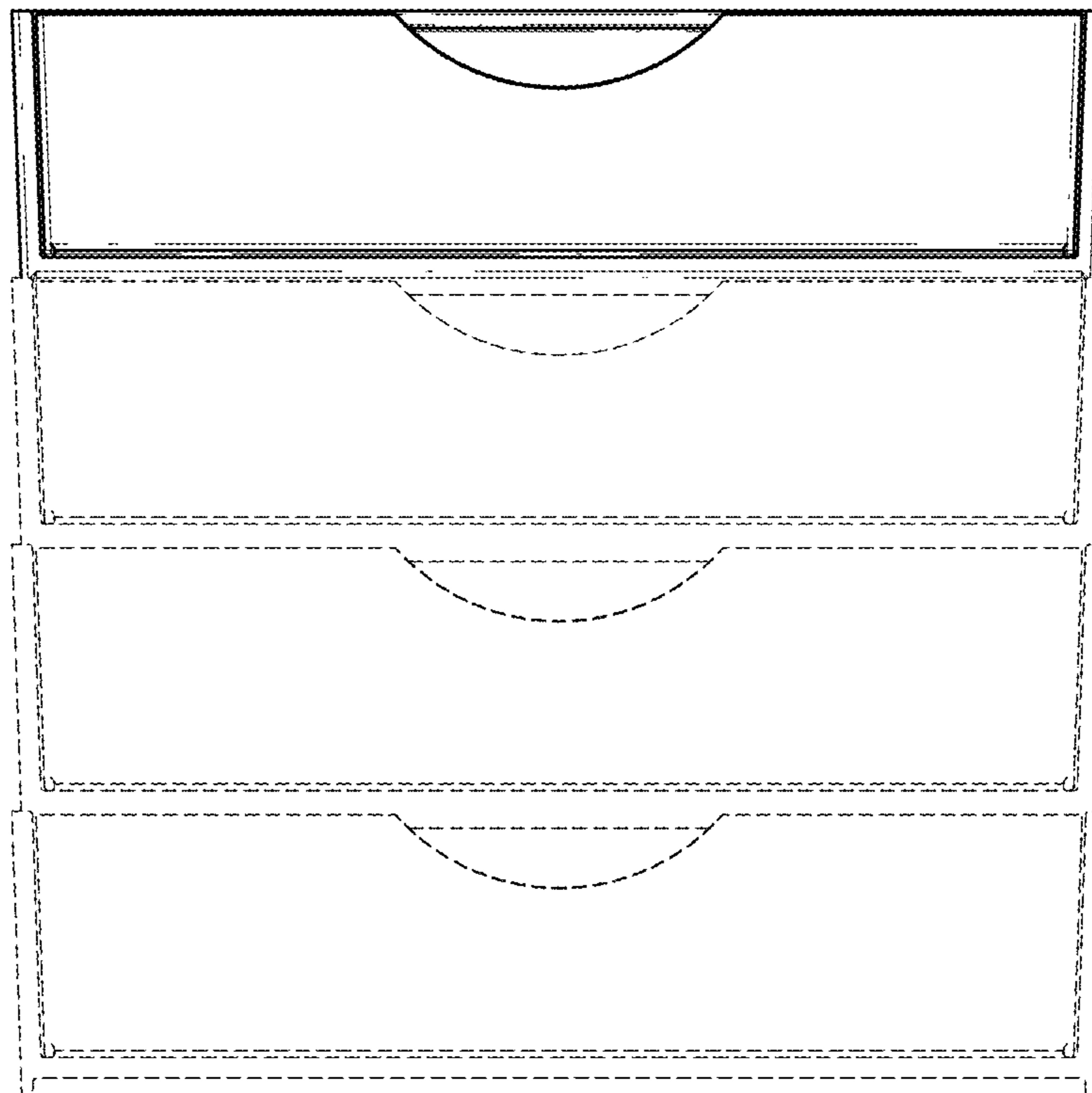
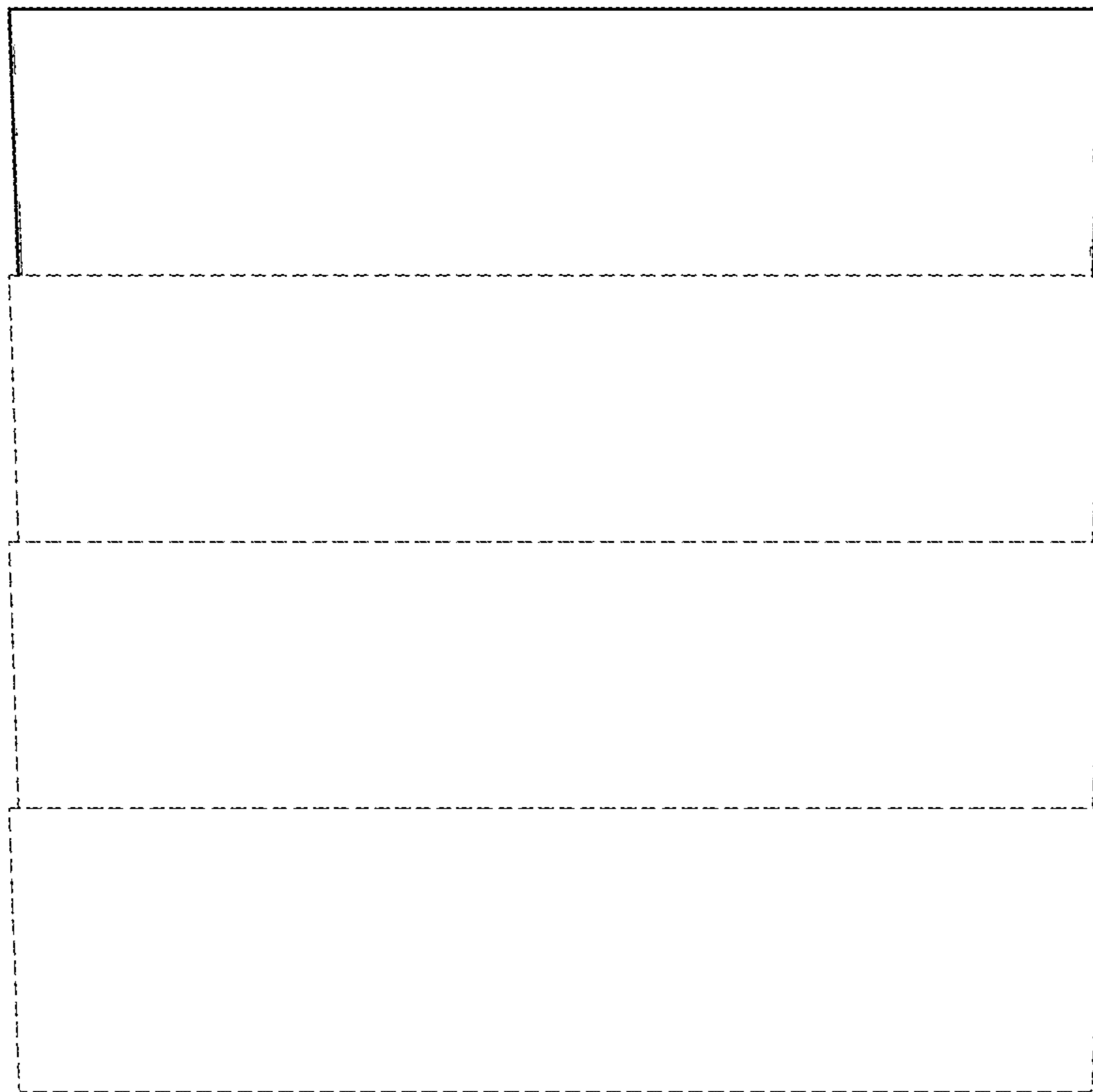


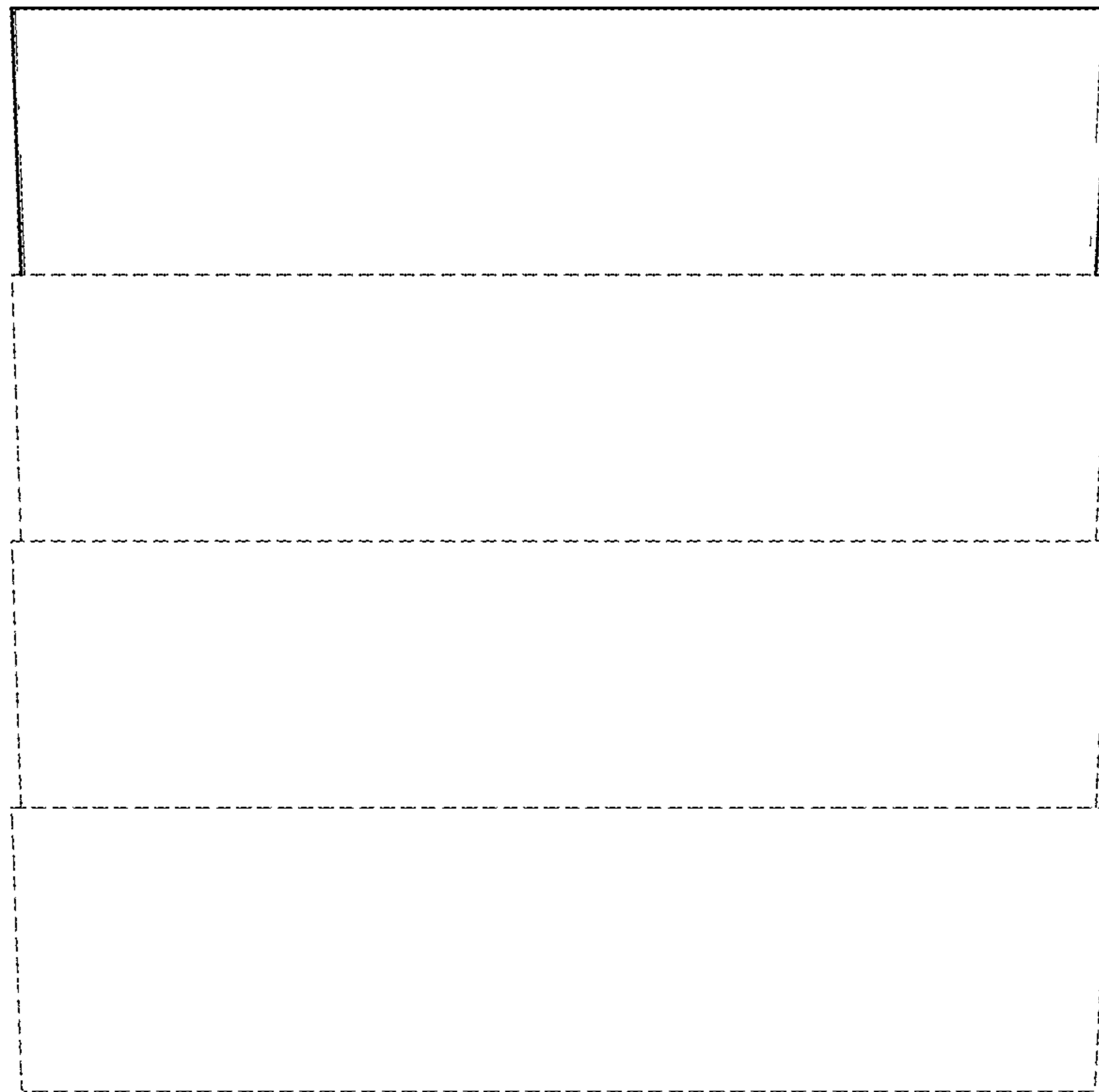

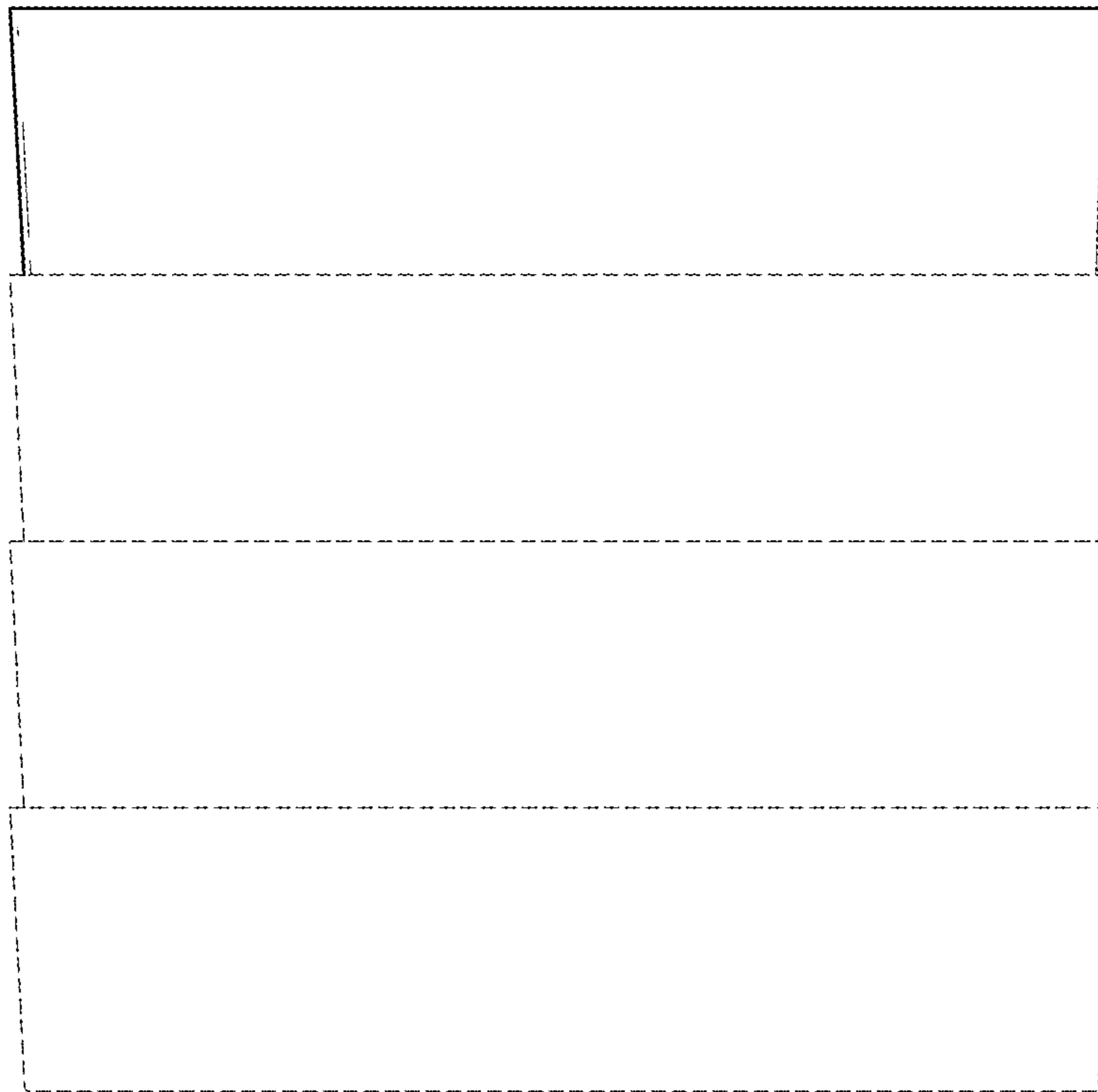

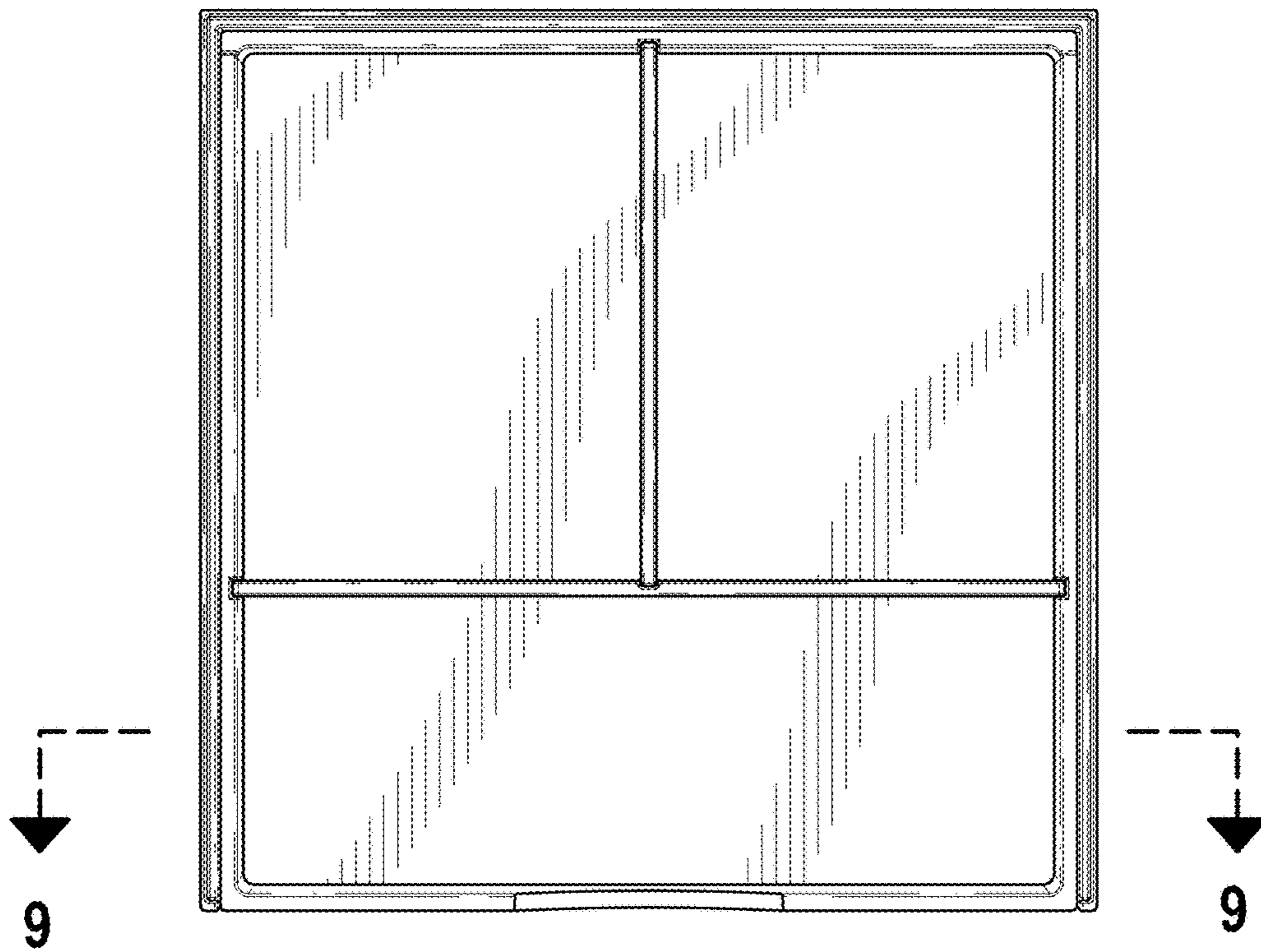

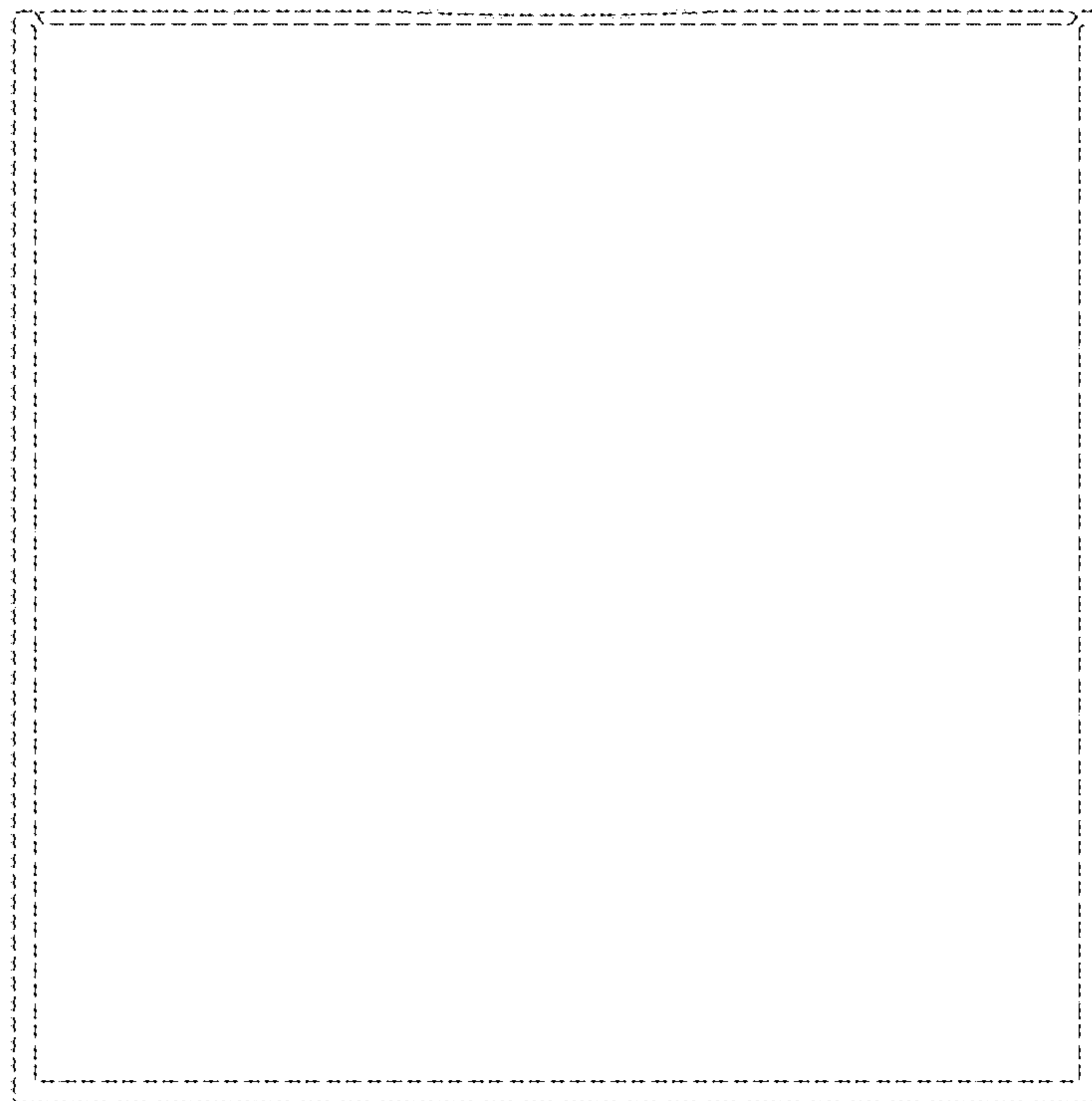

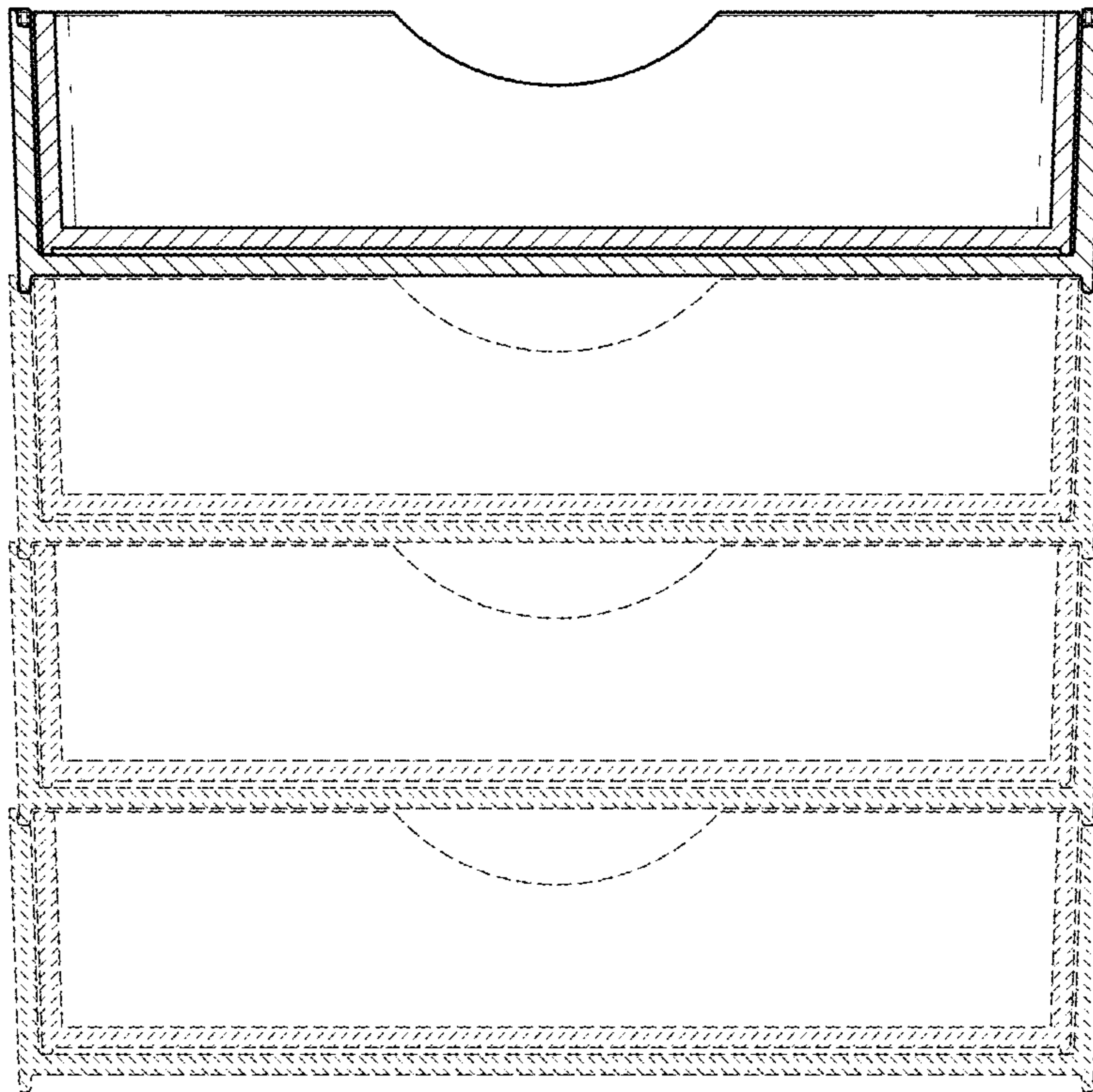
