We claim the ornamental design for a lid for beverage container, as shown and described.

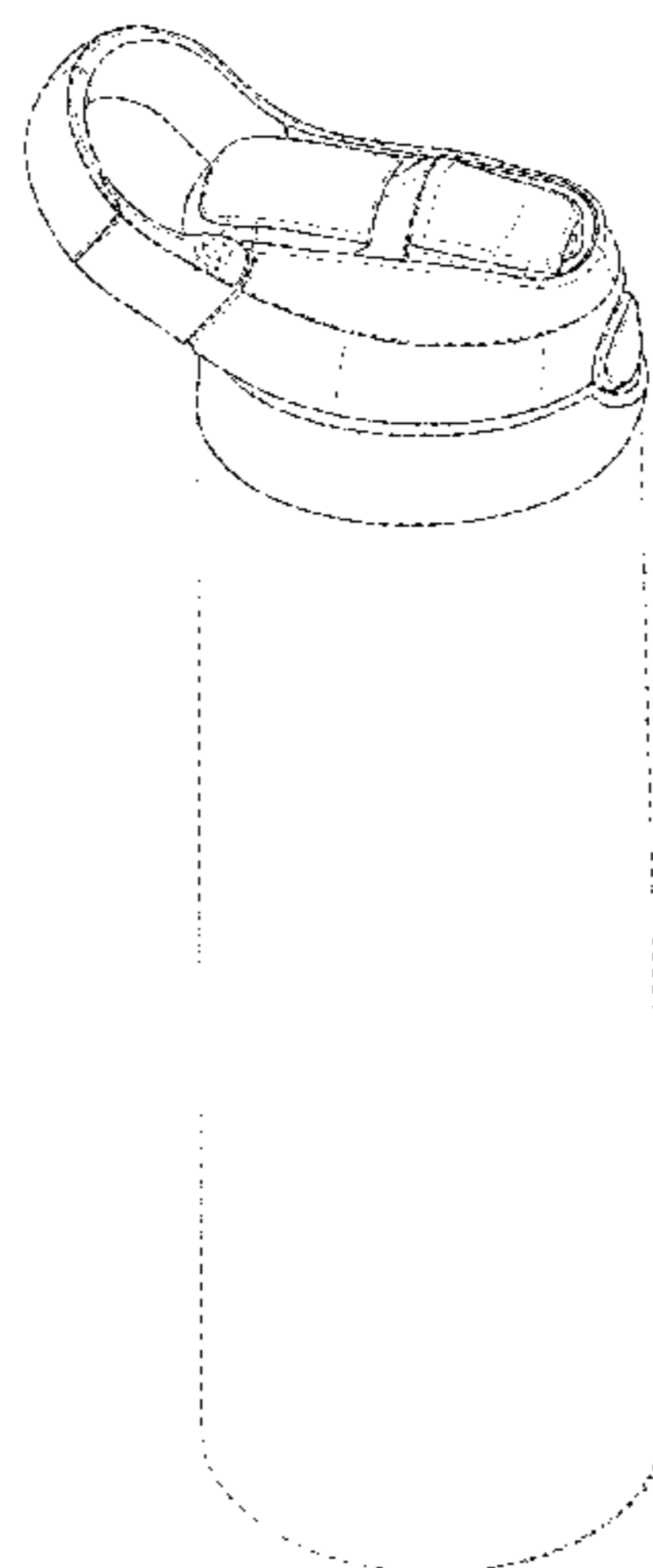
**DESCRIPTION**

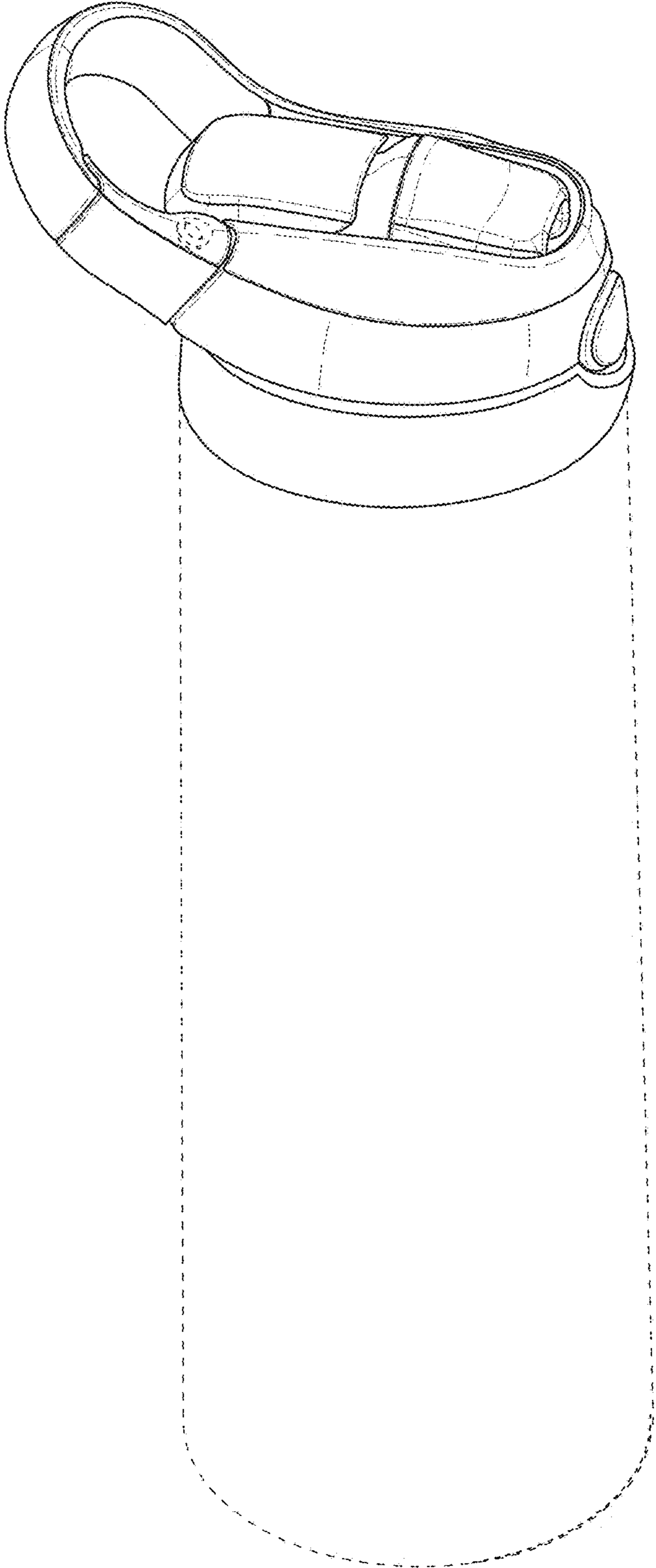

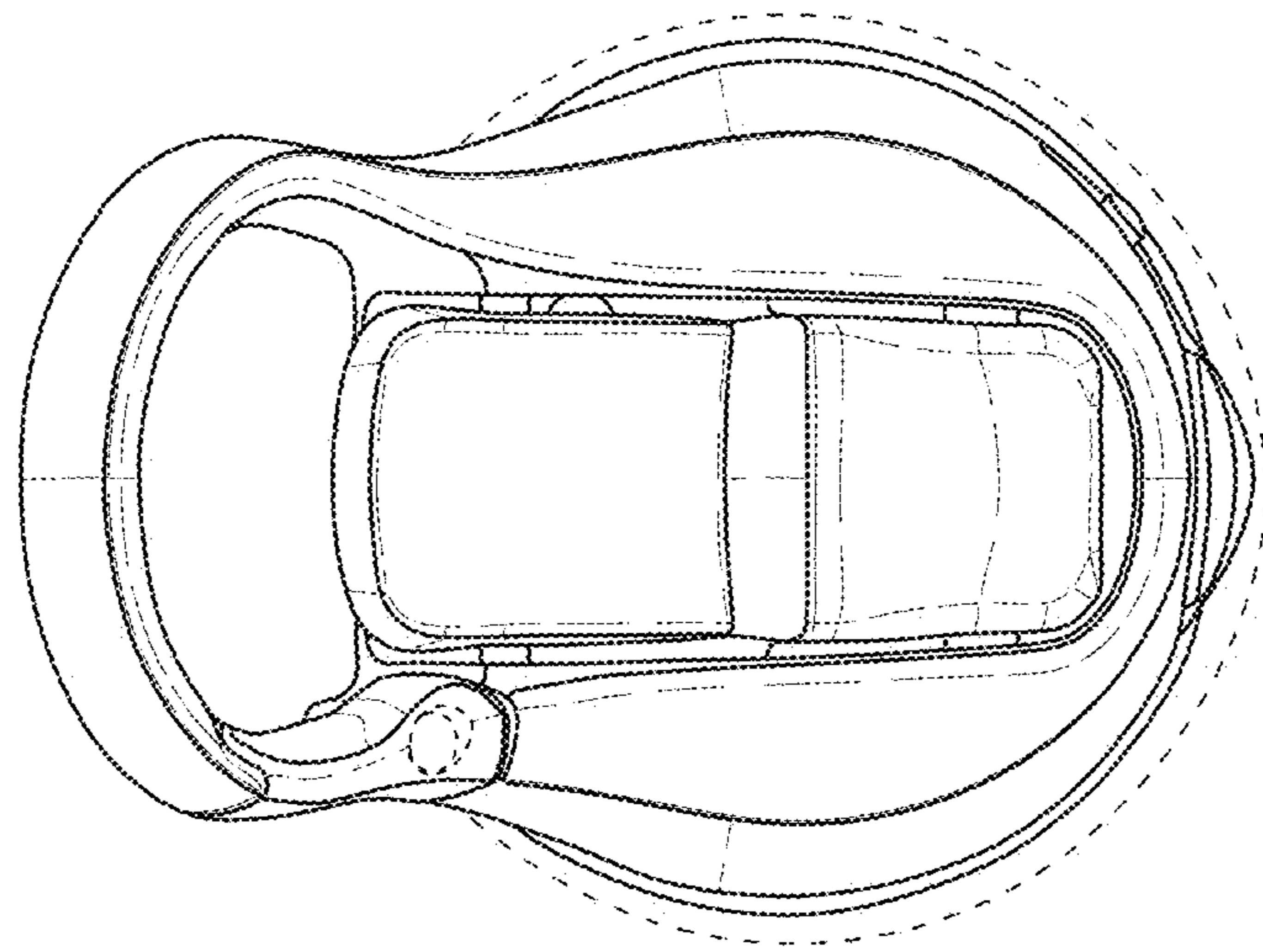

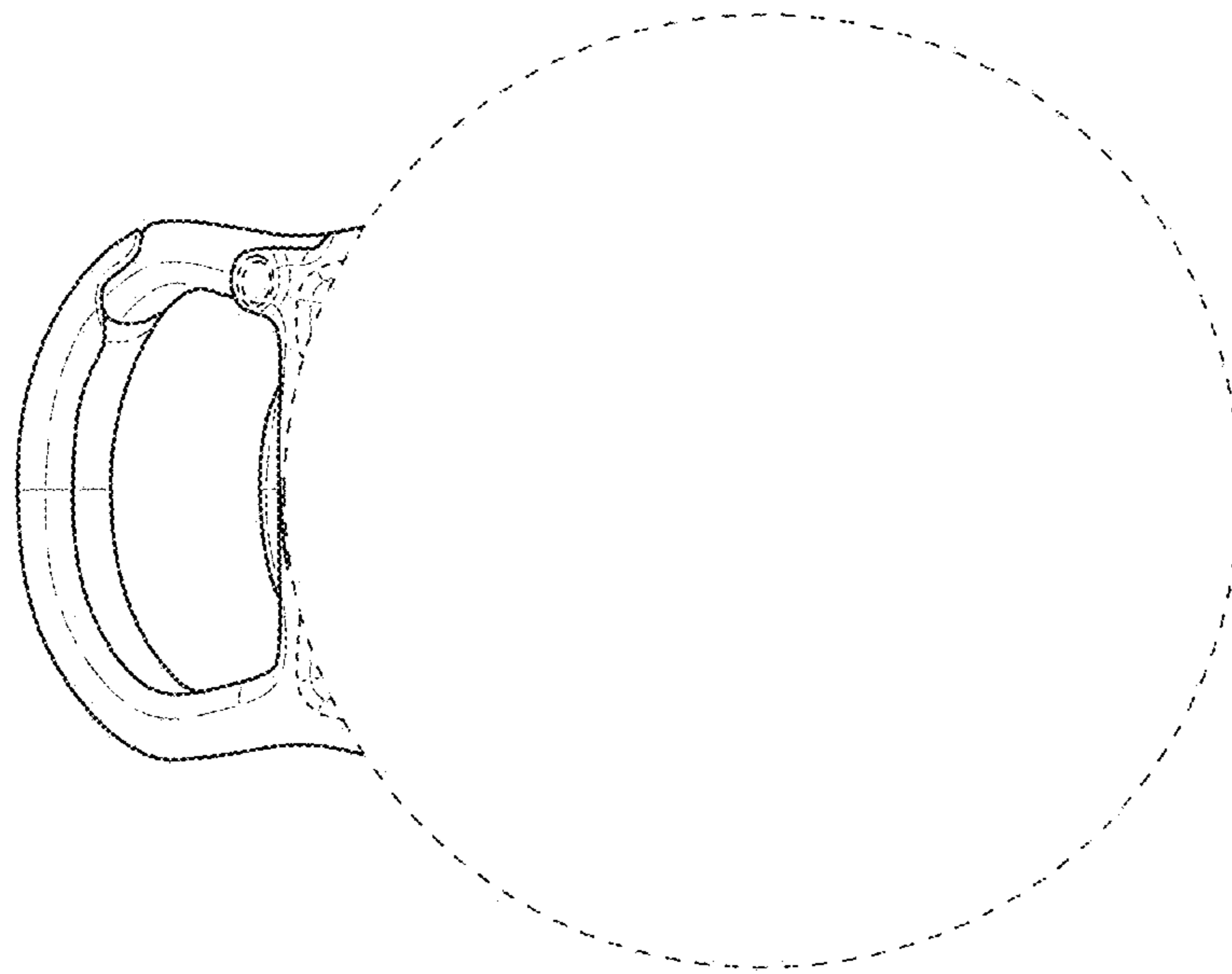

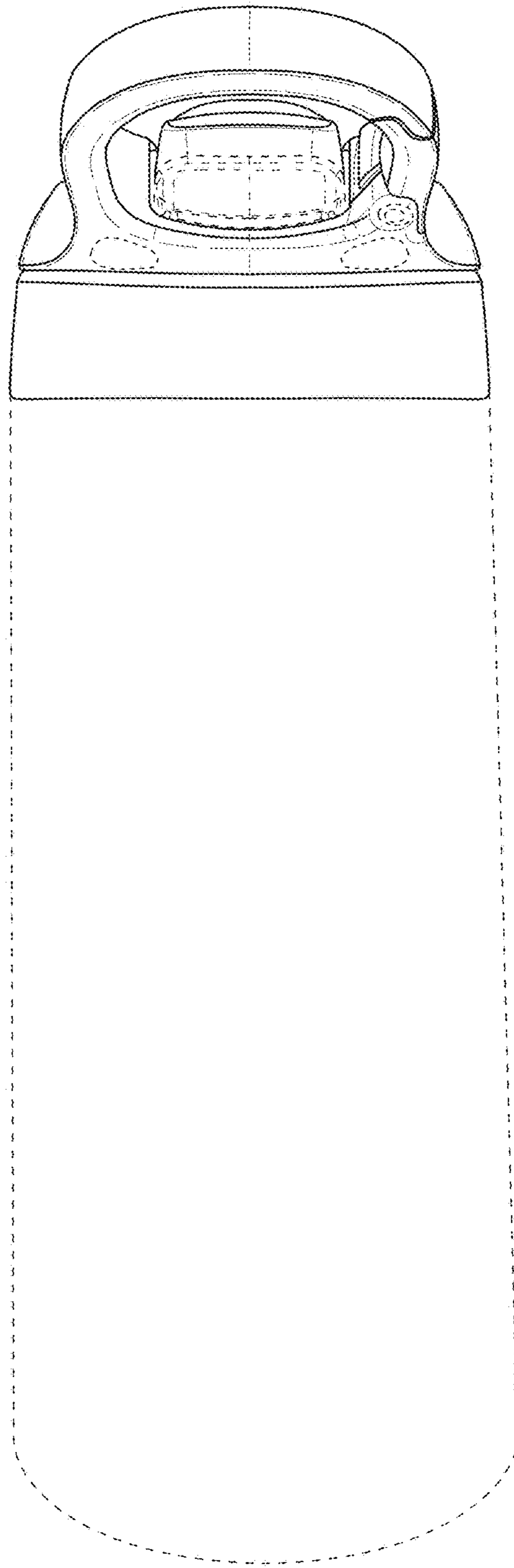

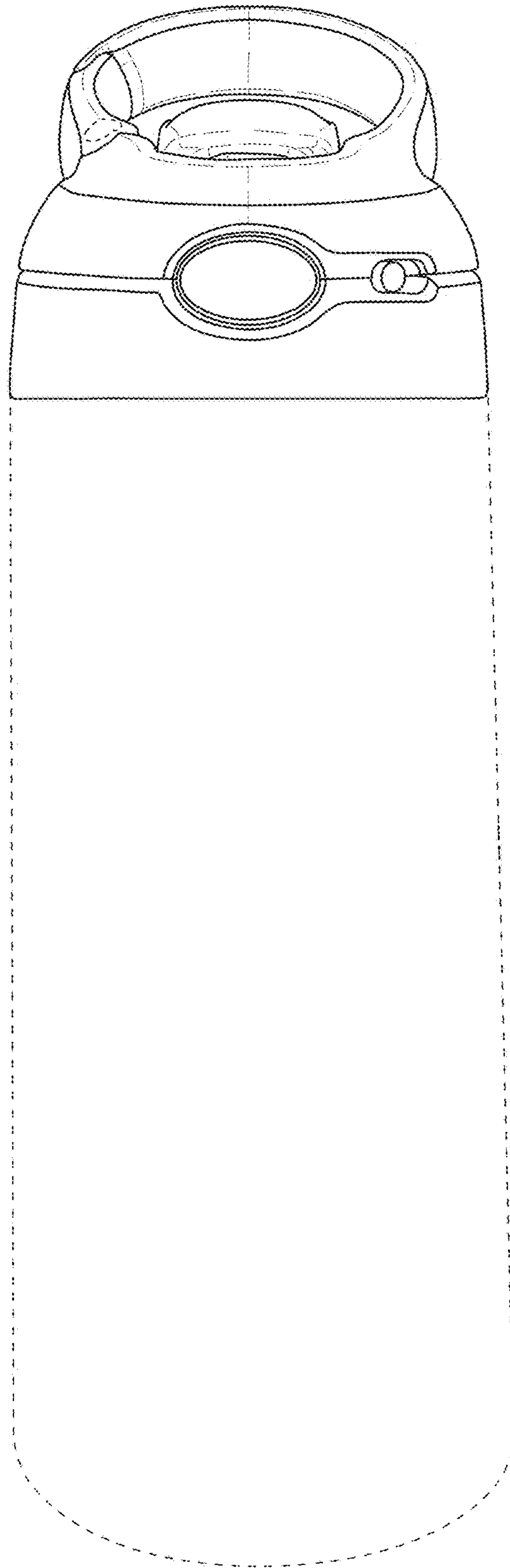
