The ornamental design for a canteen, as shown and described.

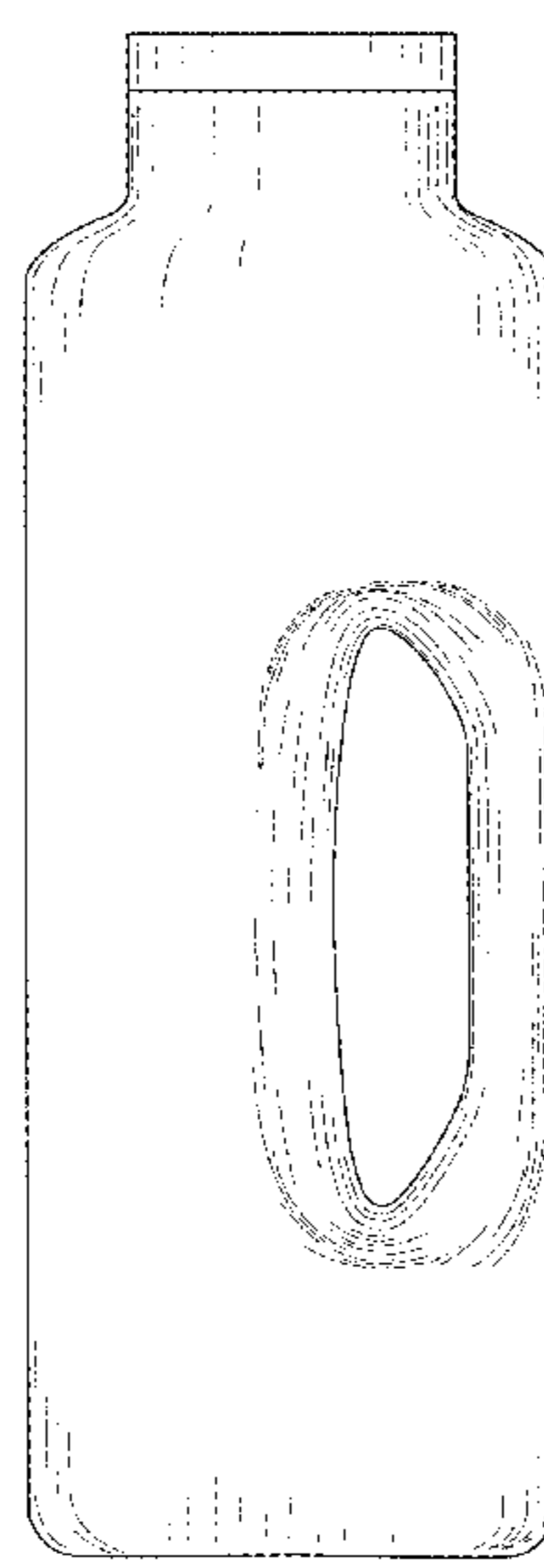
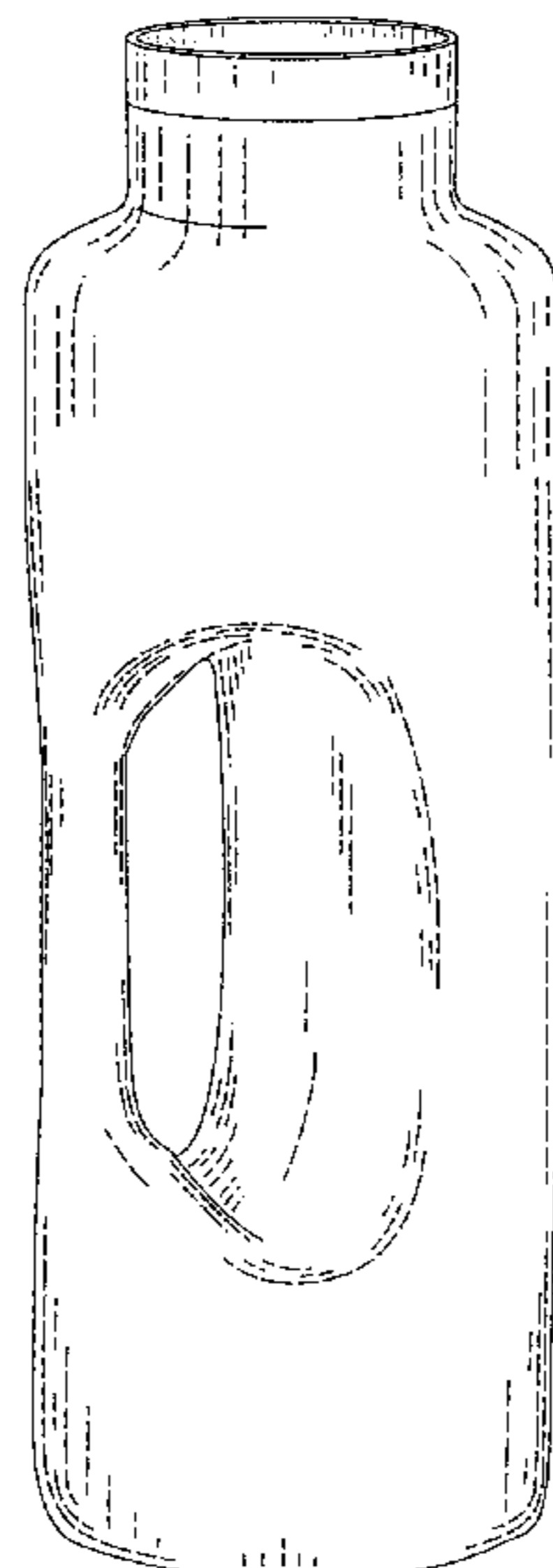
**DESCRIPTION**

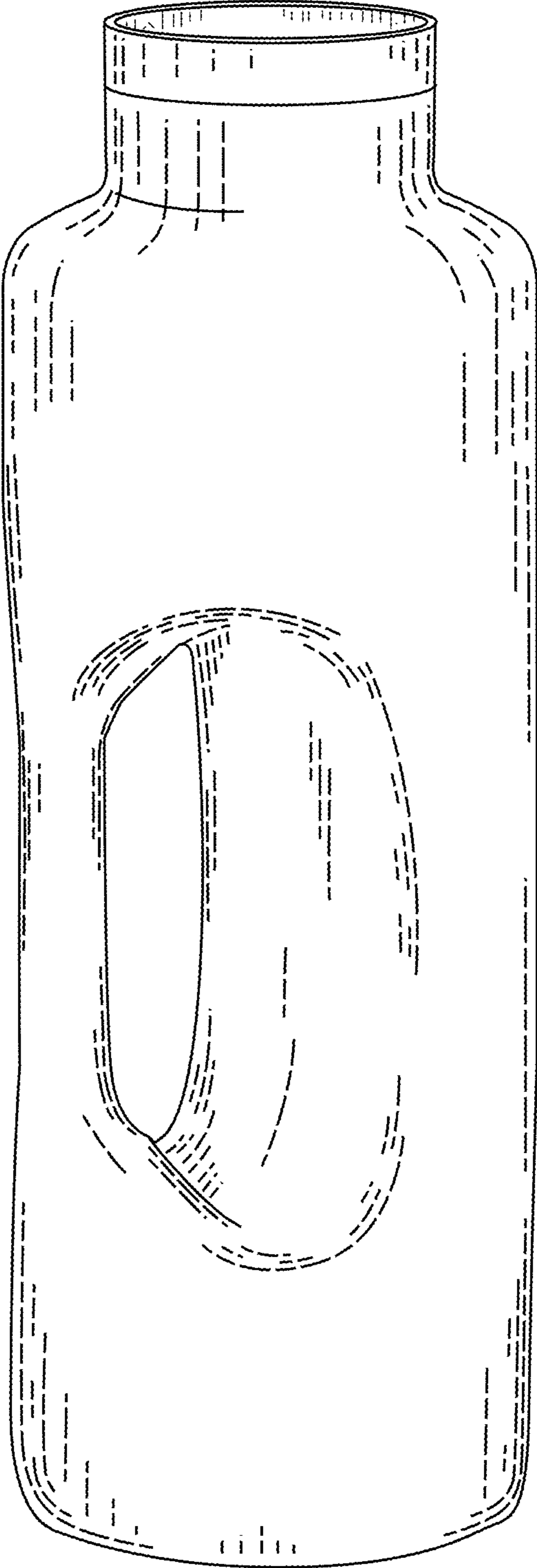

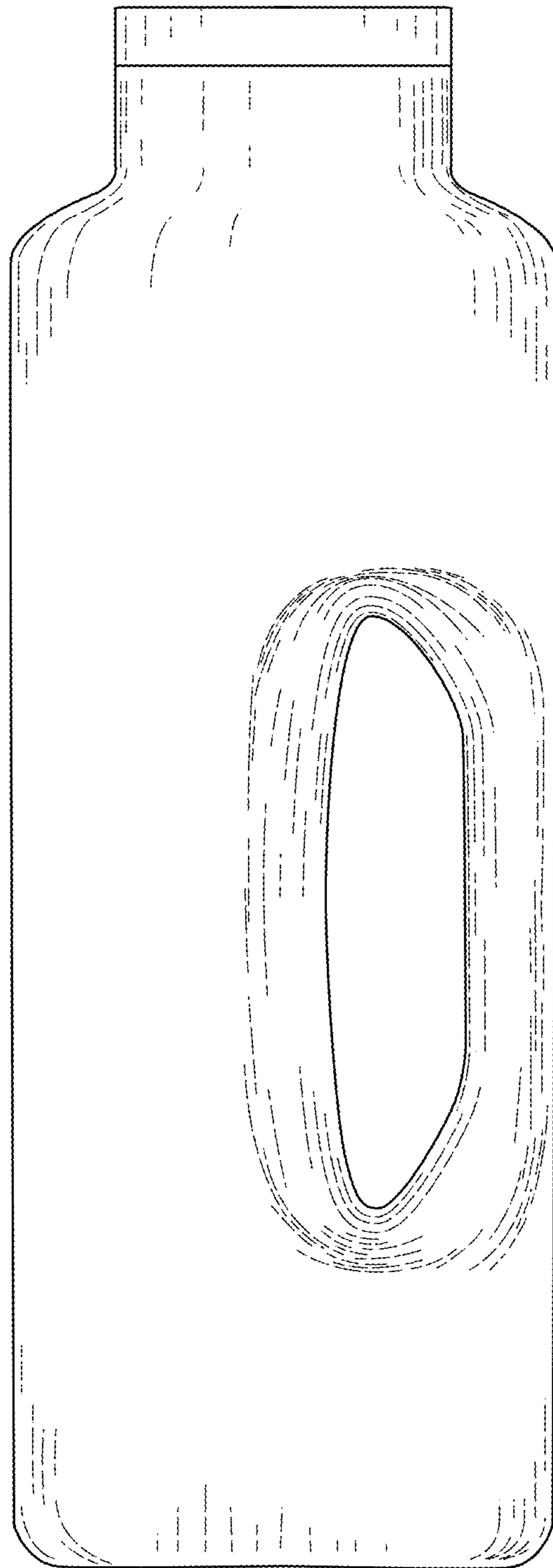

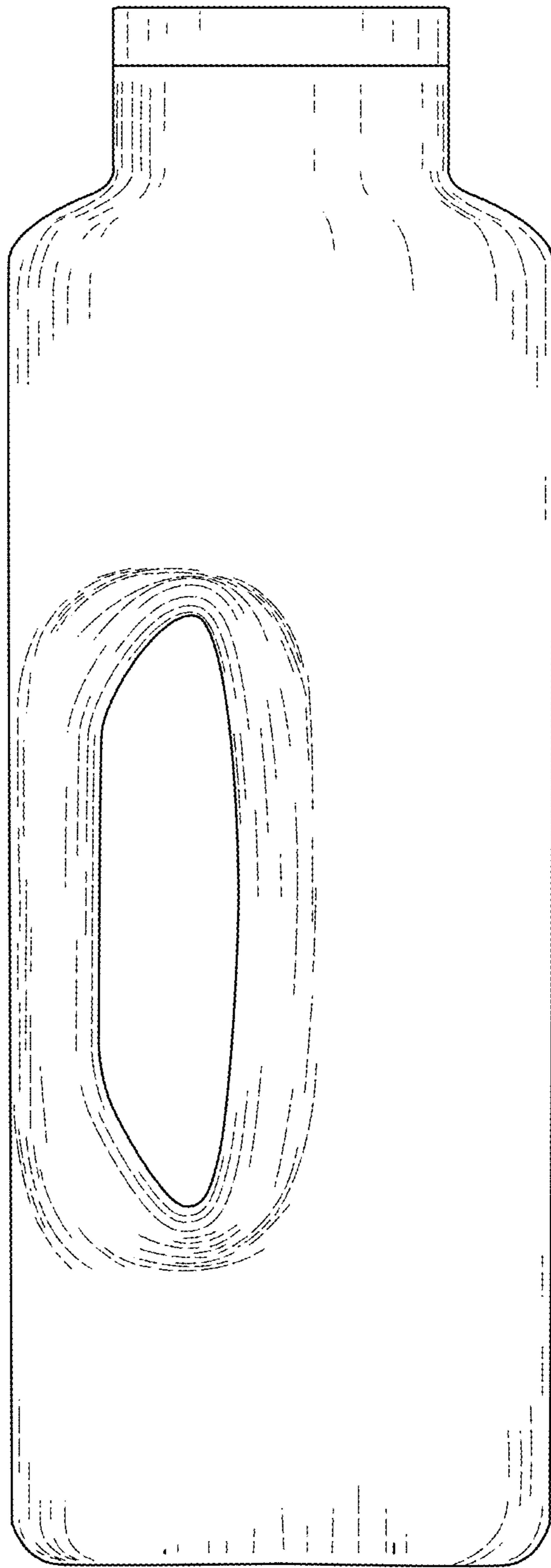

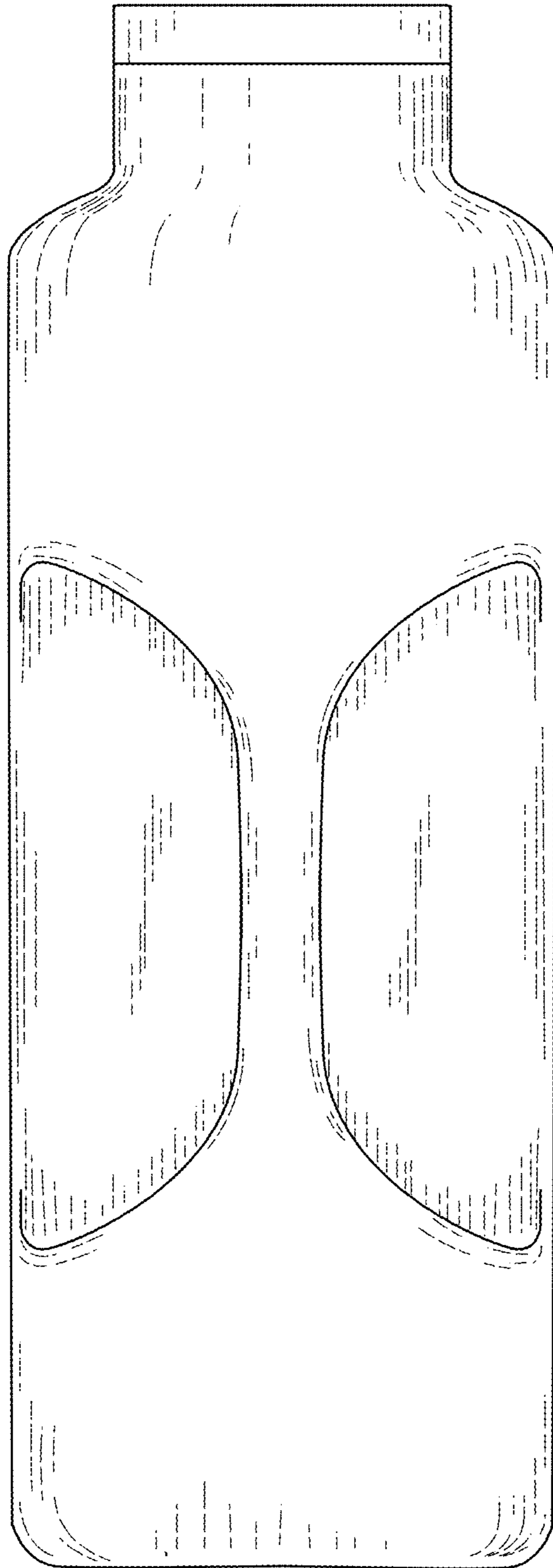

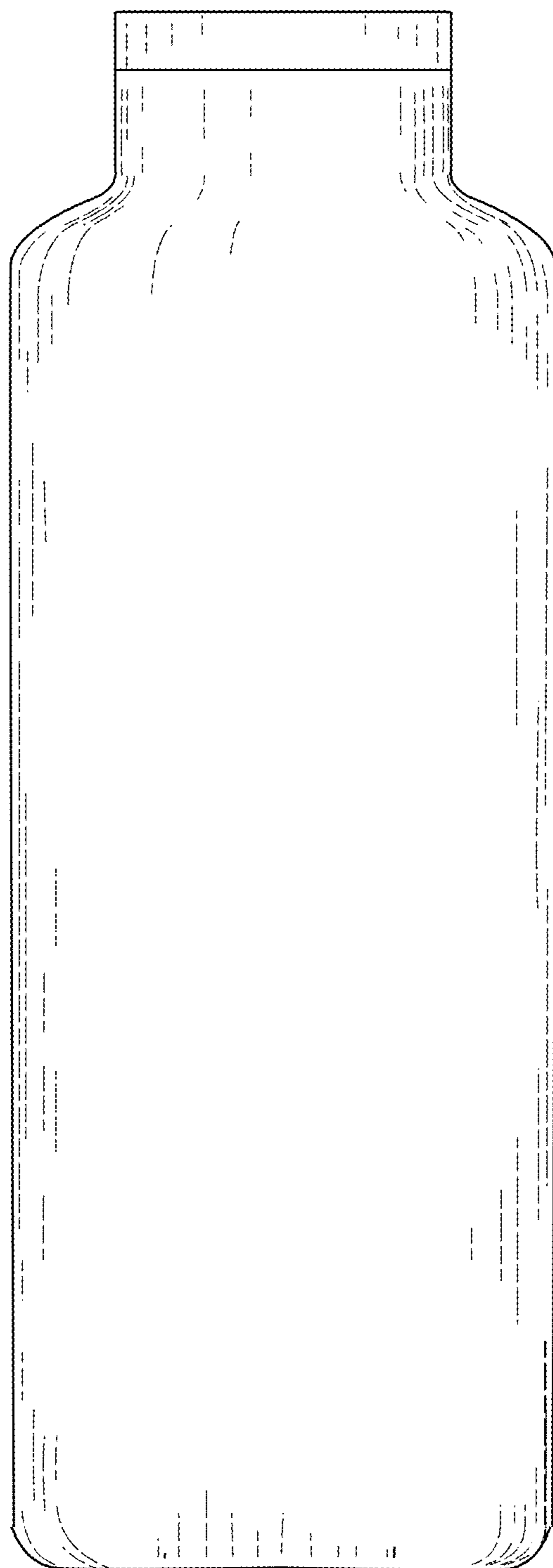

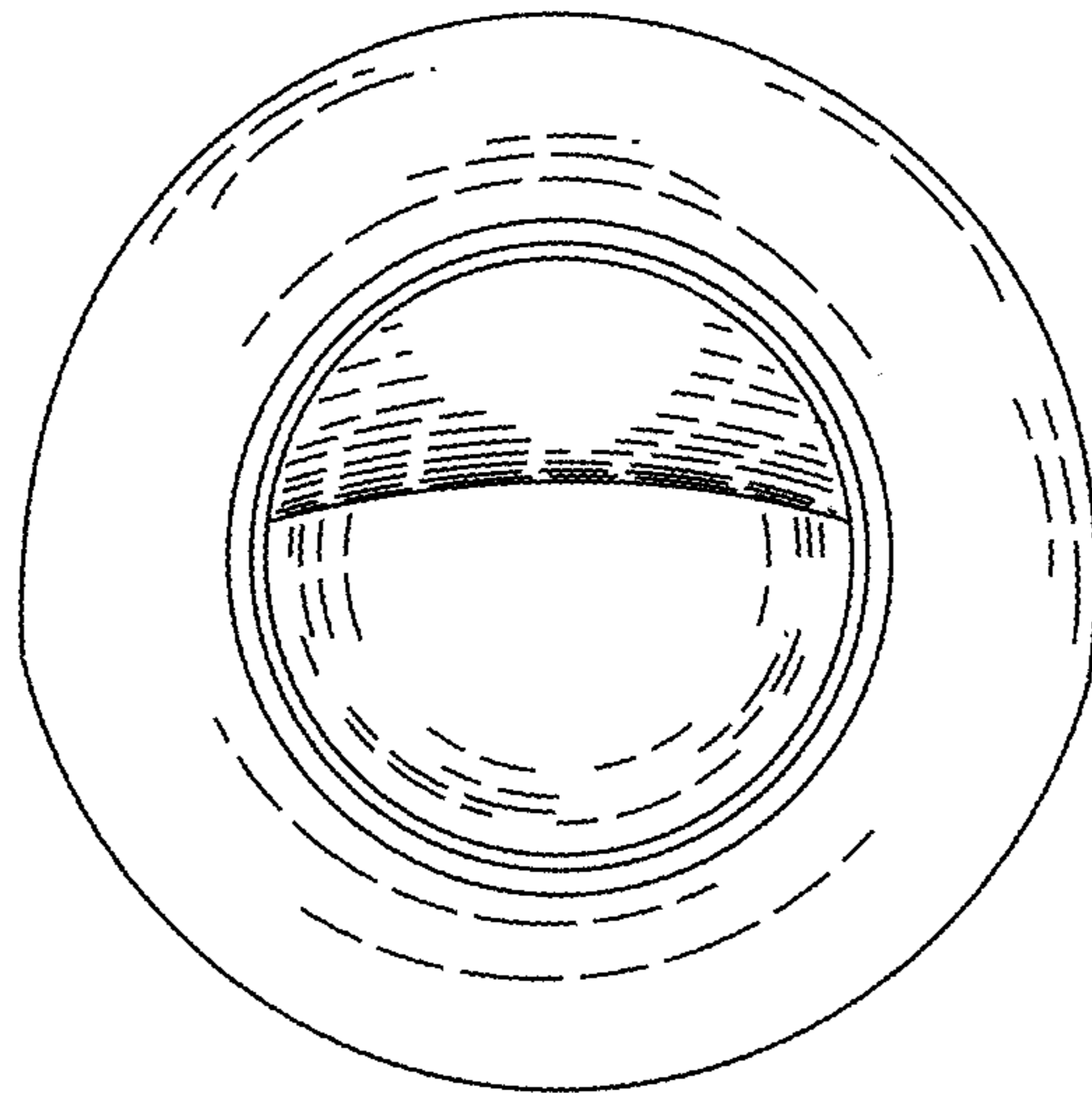

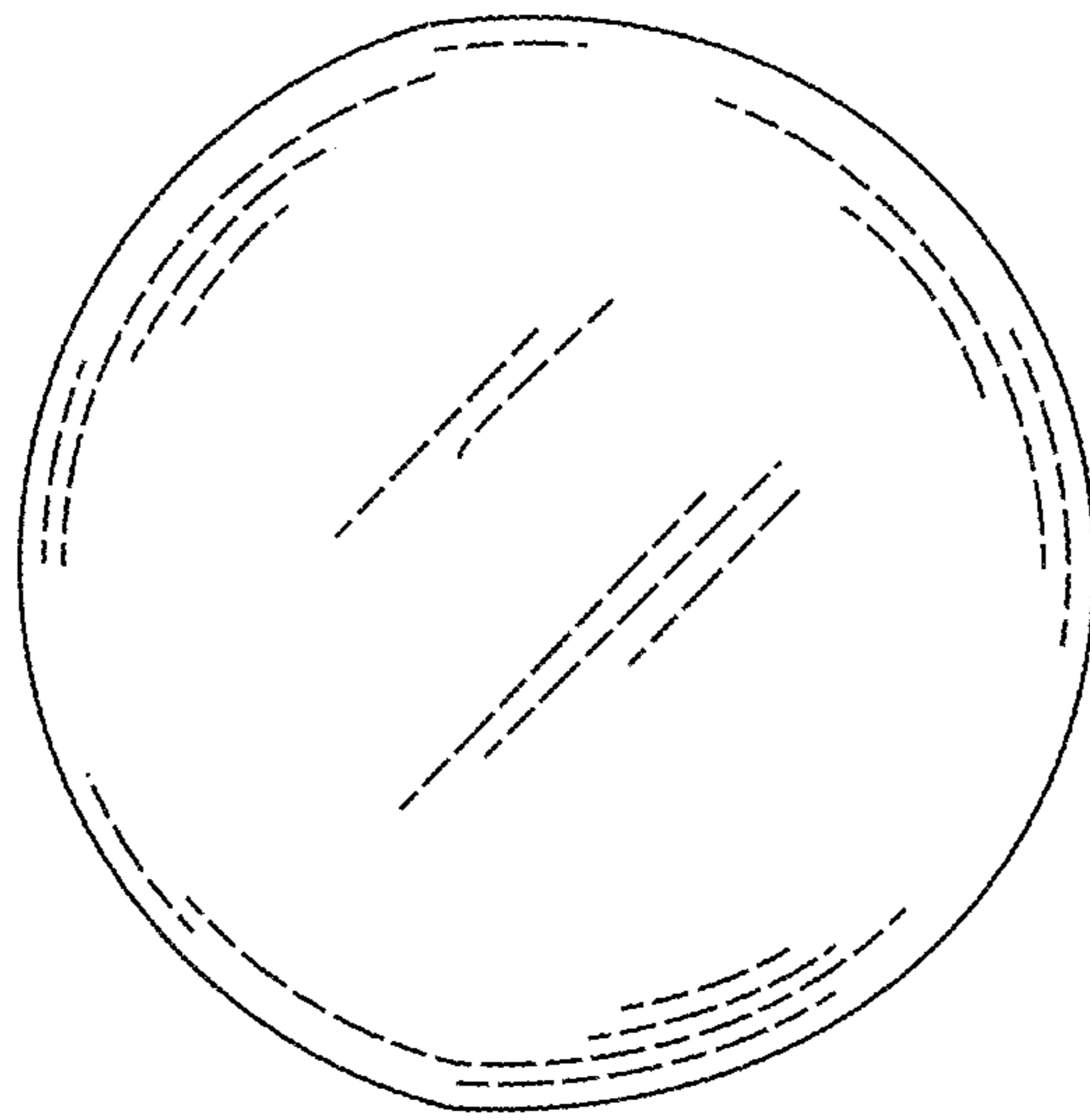

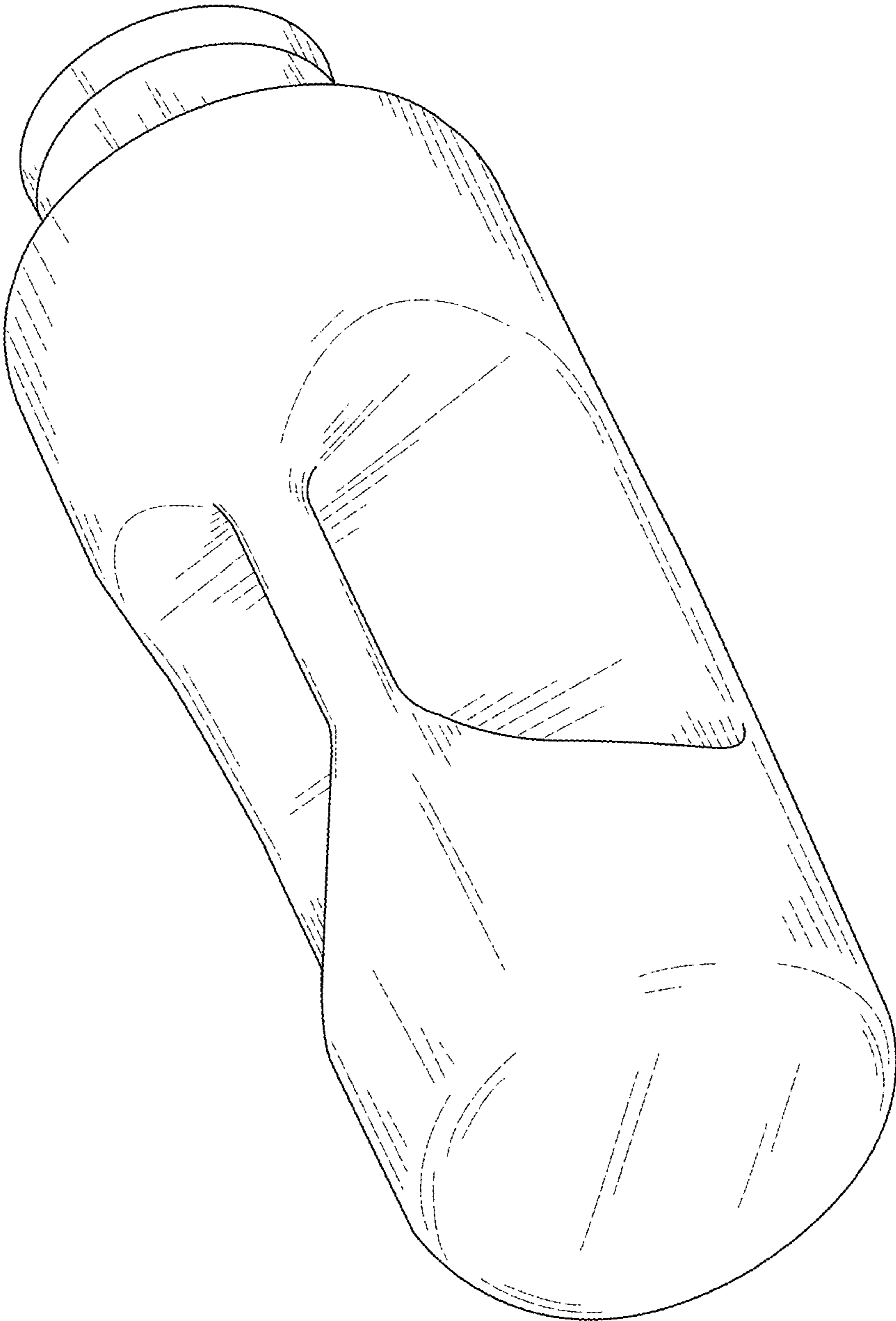
