**DESCRIPTION**

FIG. 1 is a front perspective view of a V-shaped spatula, shown at an enlarged scale.

FIG. 2 is a front perspective view of a V-shaped spatula according to FIG. 1, shown at an enlarged scale.

FIG. 3 is a left side perspective view of a V-shaped spatula according to FIG. 1.

FIG. 4 is a bottom perspective view of a V-shaped spatula according to FIG. 1.

FIG. 5 is a top perspective view of a V-shaped spatula according to FIG. 1.

FIG. 6 is a front perspective view of a V-shaped spatula according to FIG. 1; and,

FIG. 7 is a back perspective view of a V-shaped spatula according to FIG. 1.

Various curvatures for the spatula are shown in broken lines for illustrative purposes only and form no part of the claimed design. The broken lines are intended to illustrate the thickness of the spatula as well as the curvature of the undulation of the inner part of the spatula.

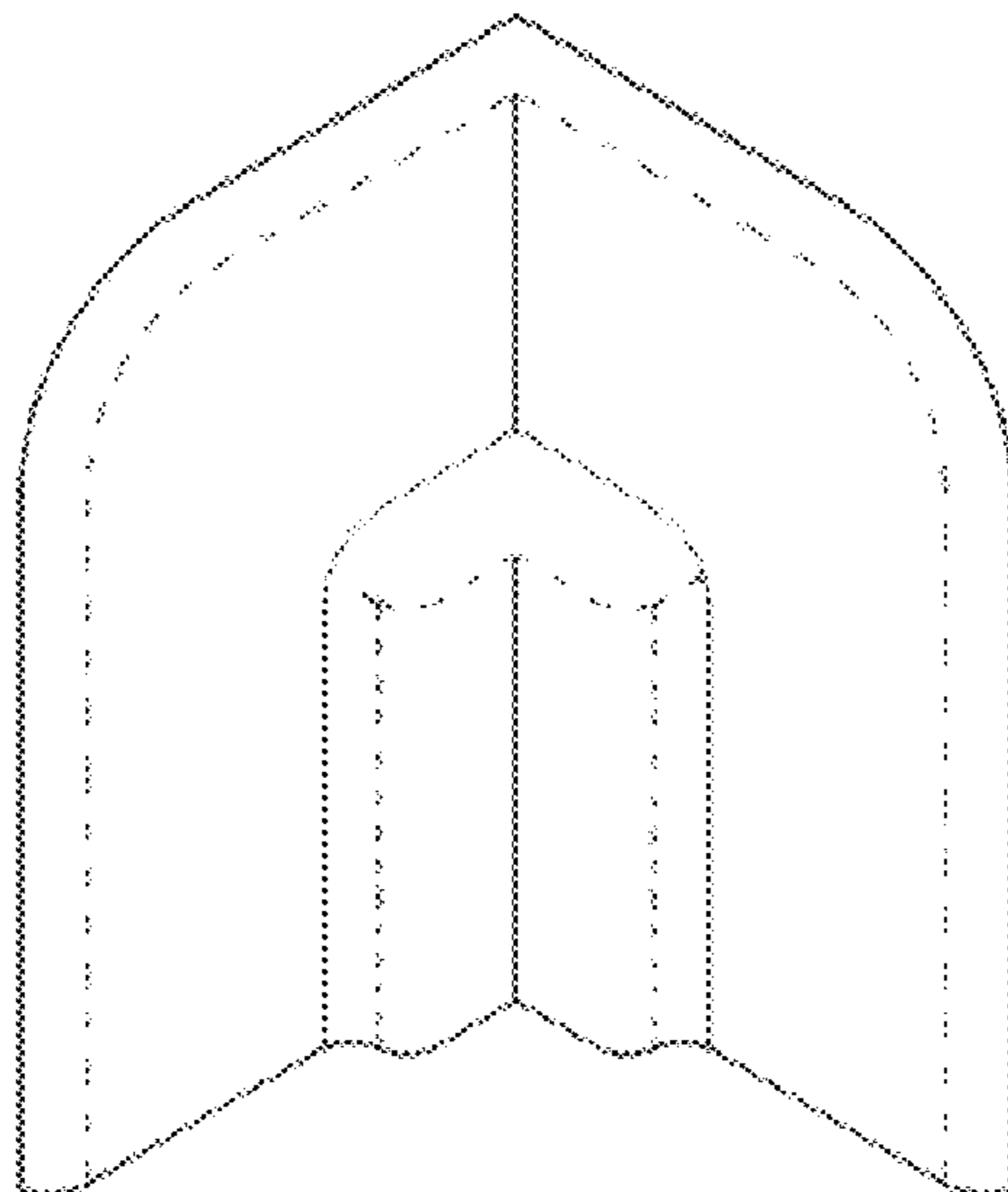

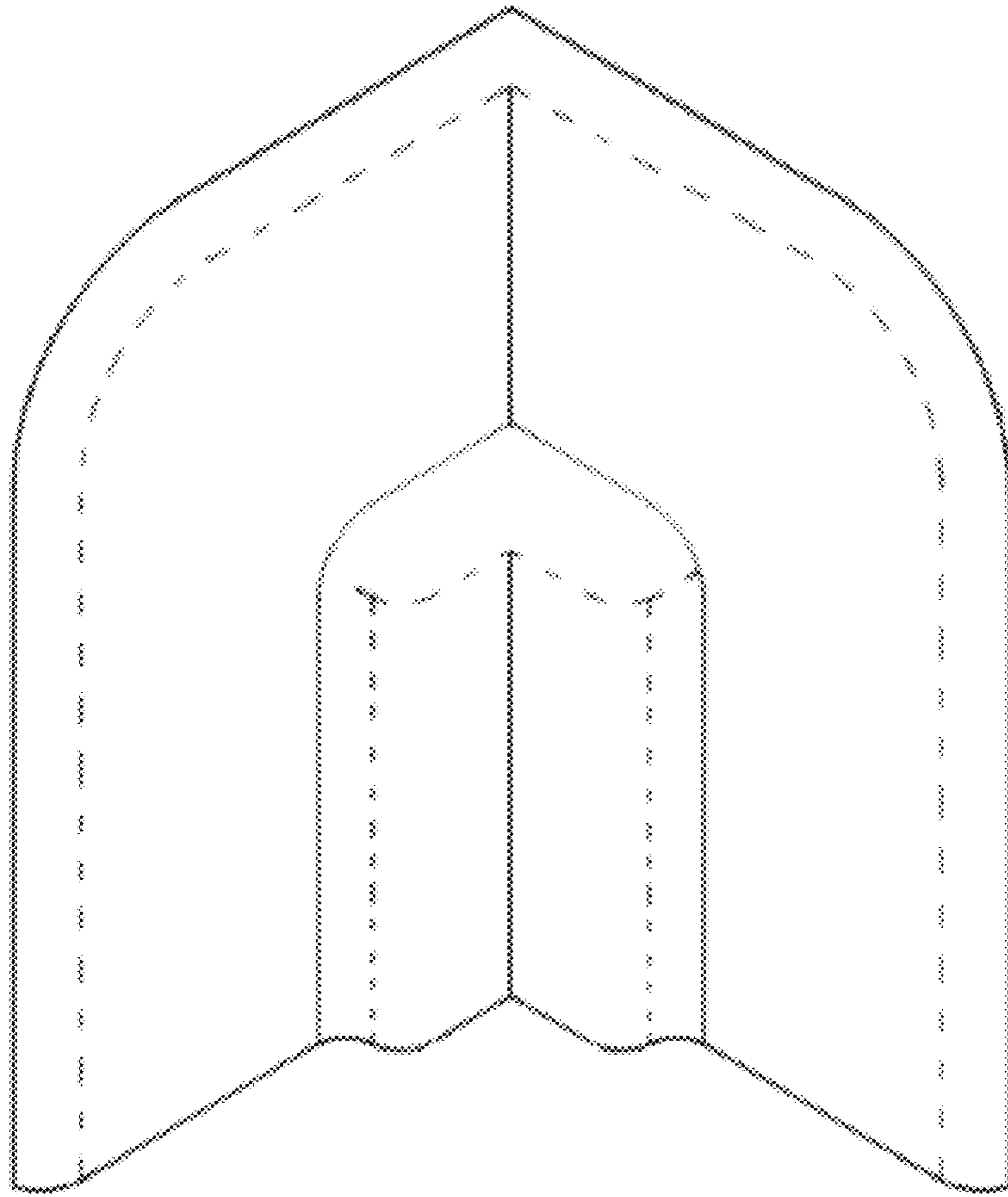

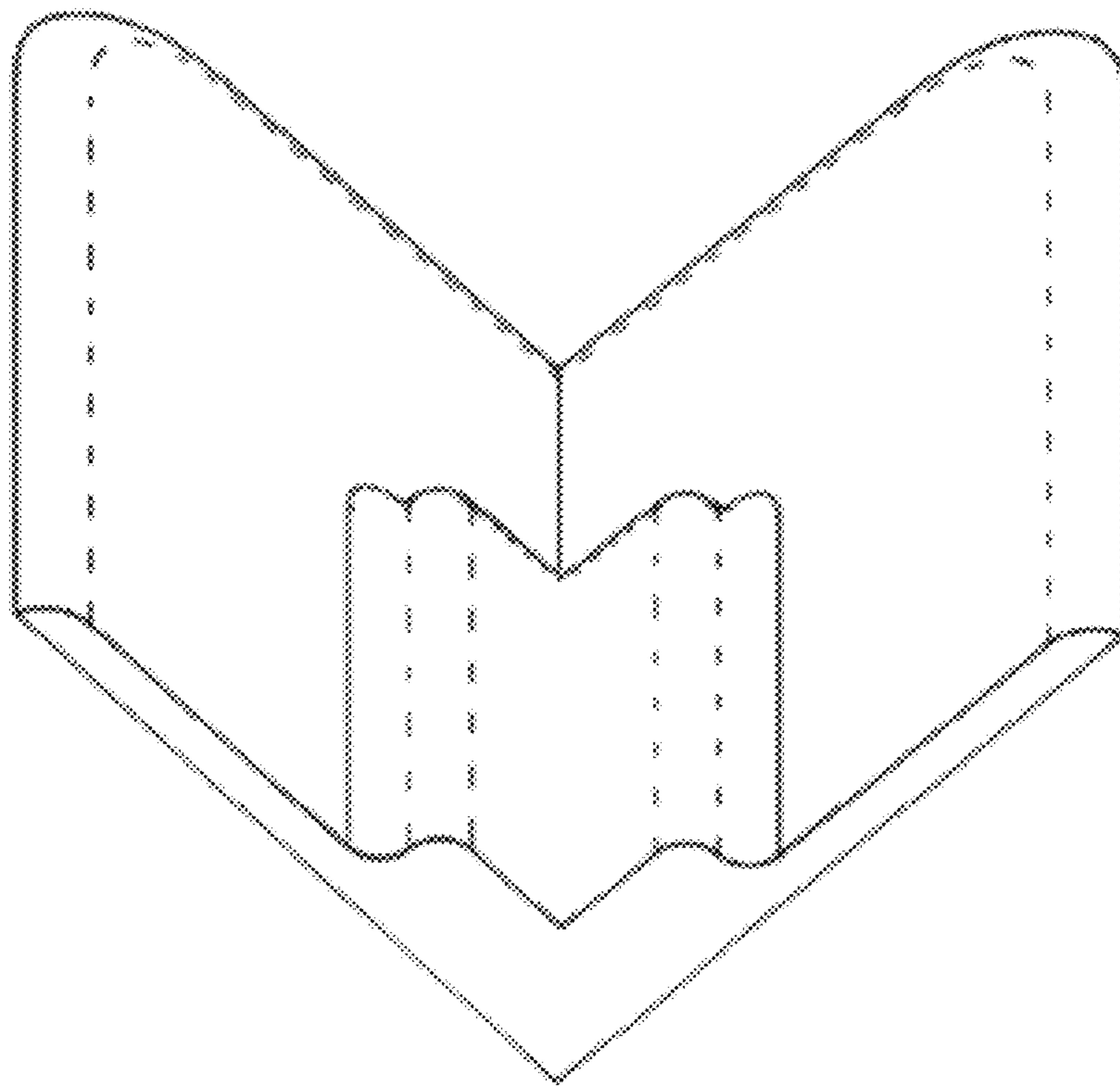

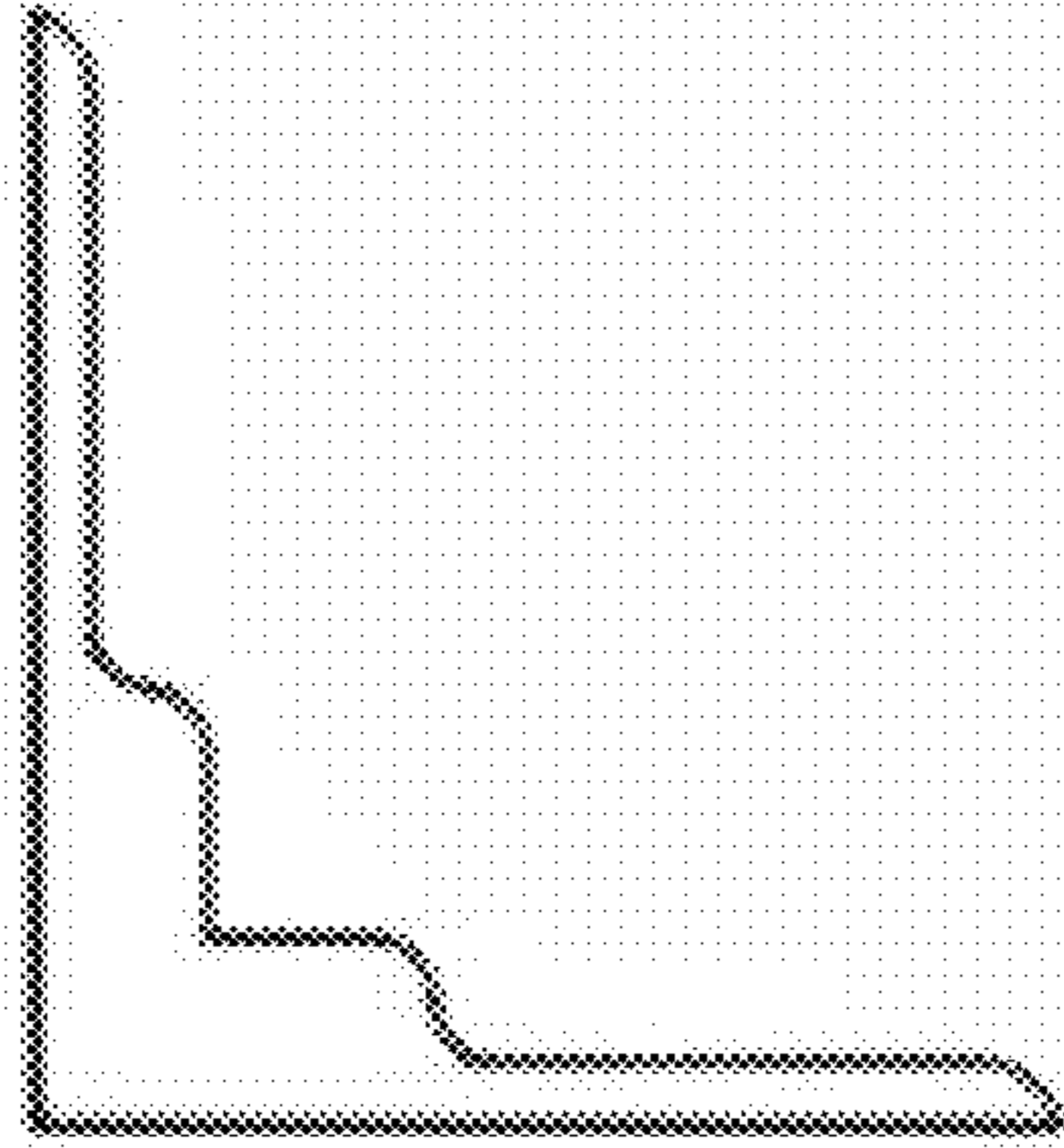




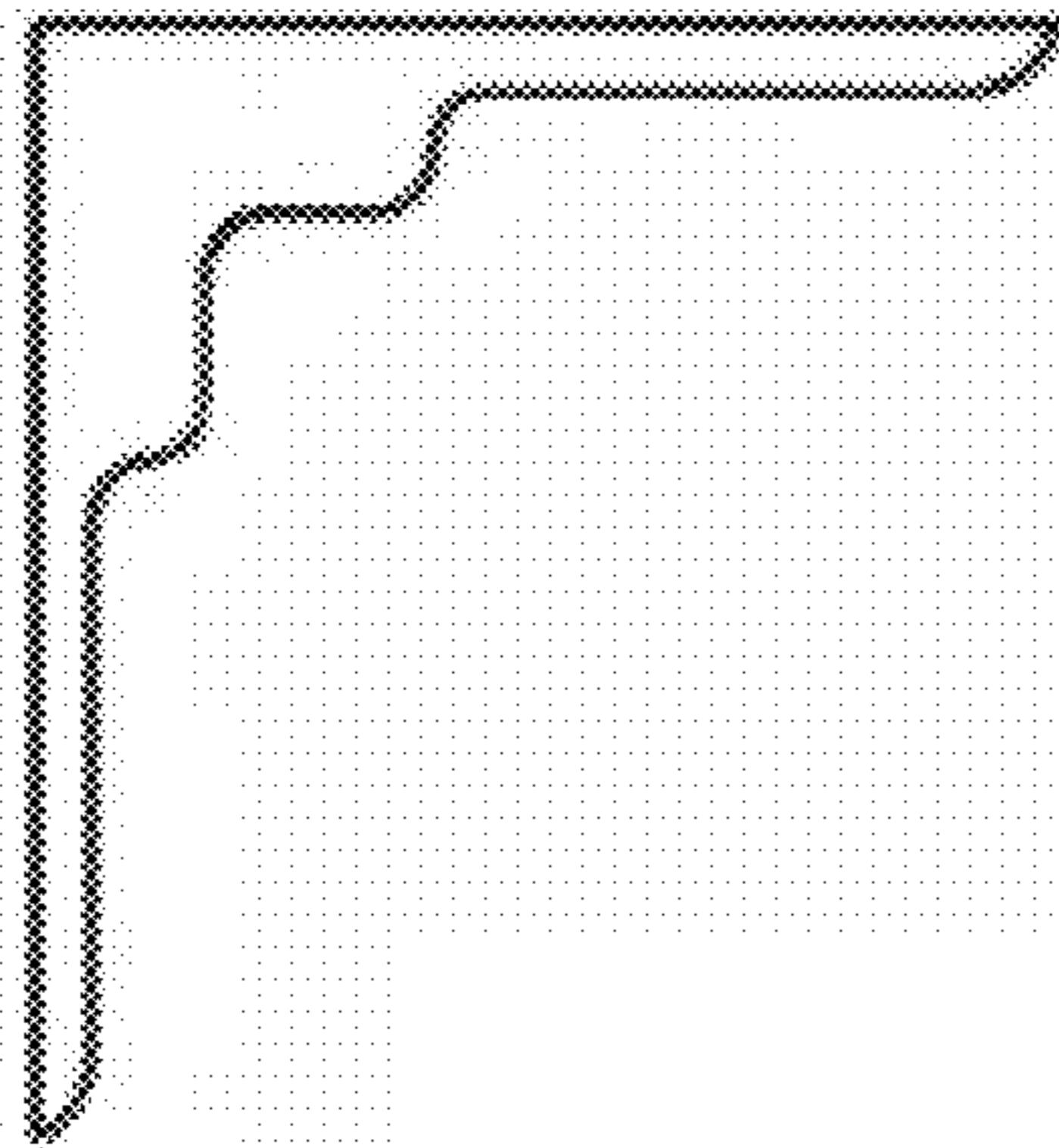

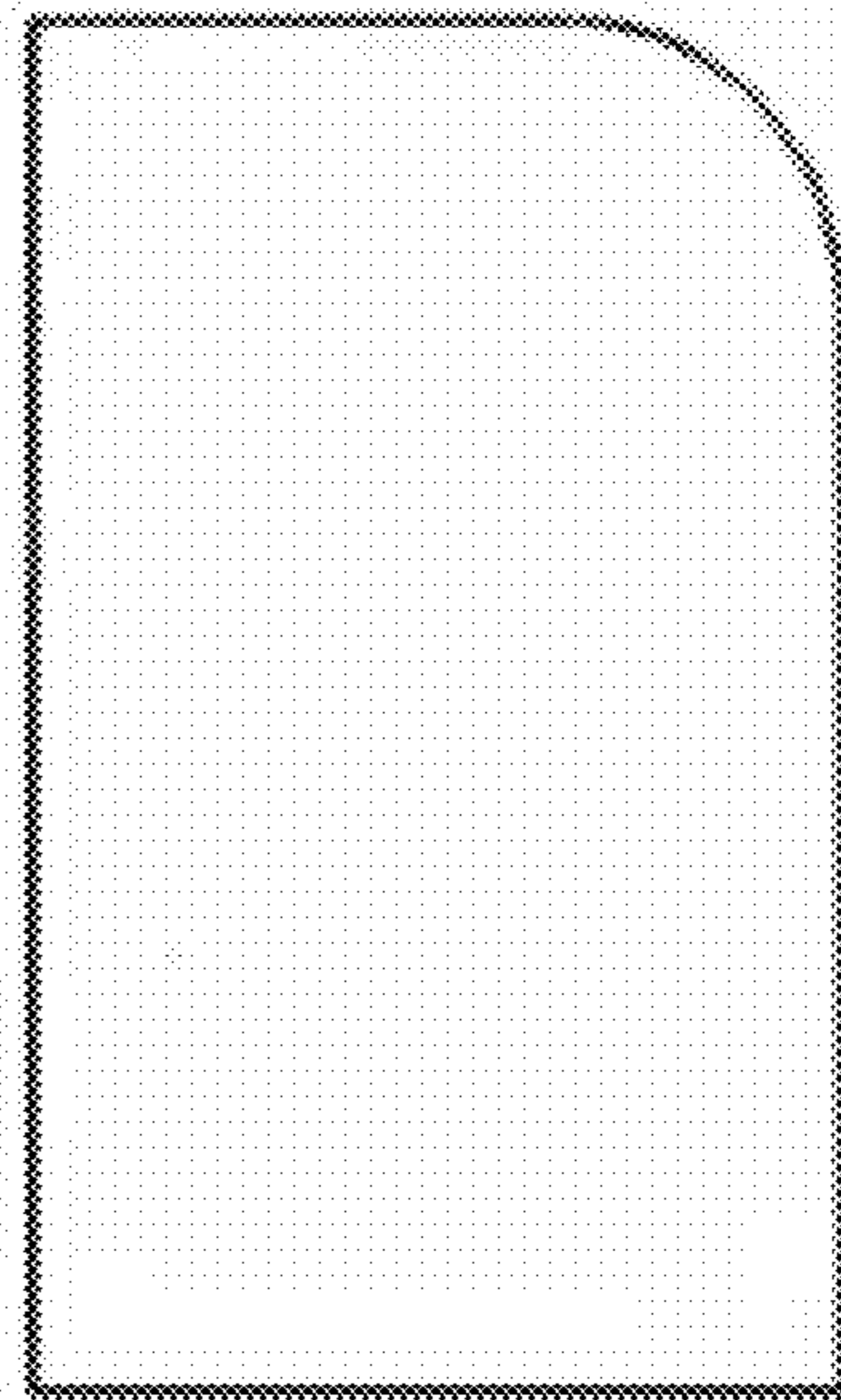

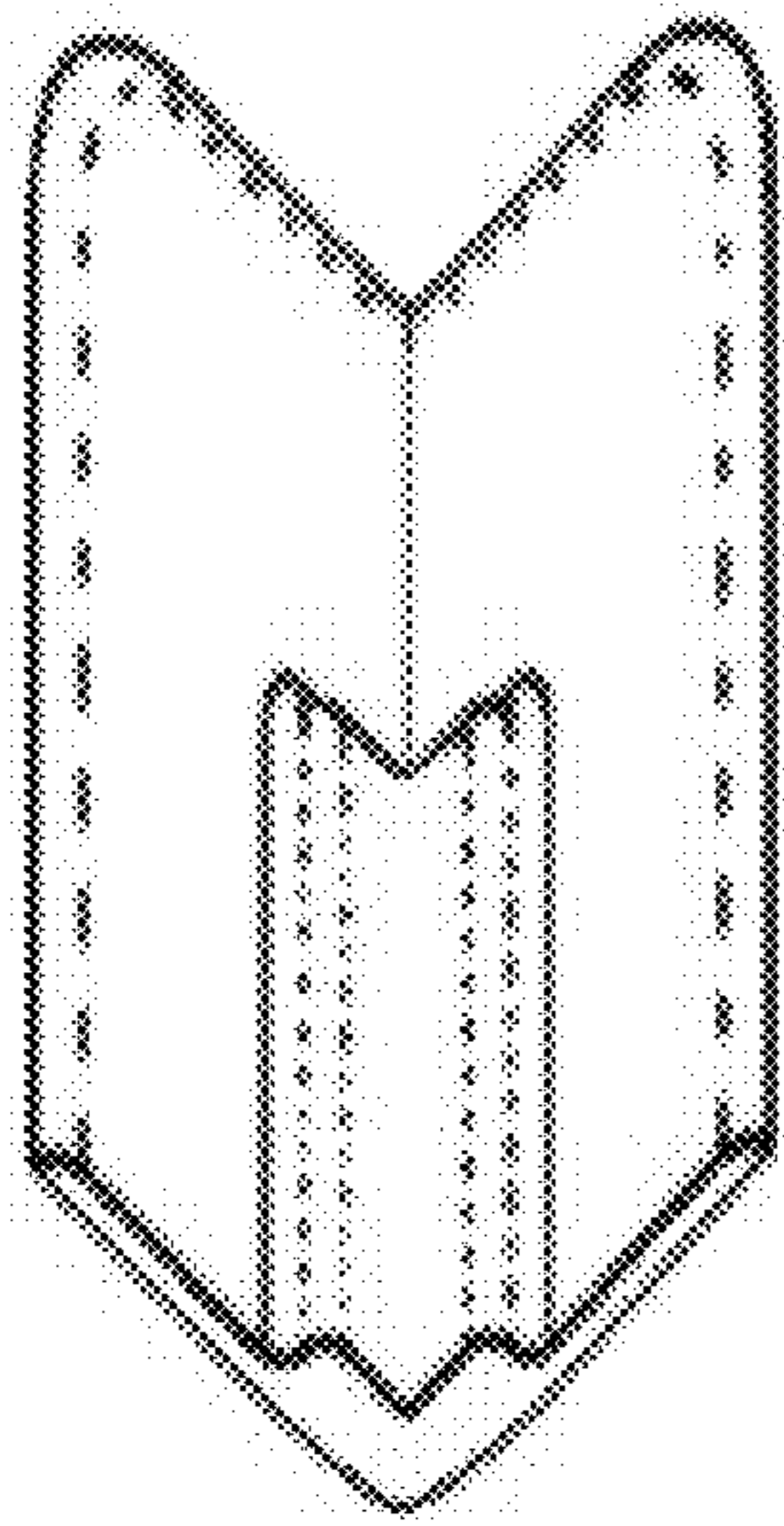

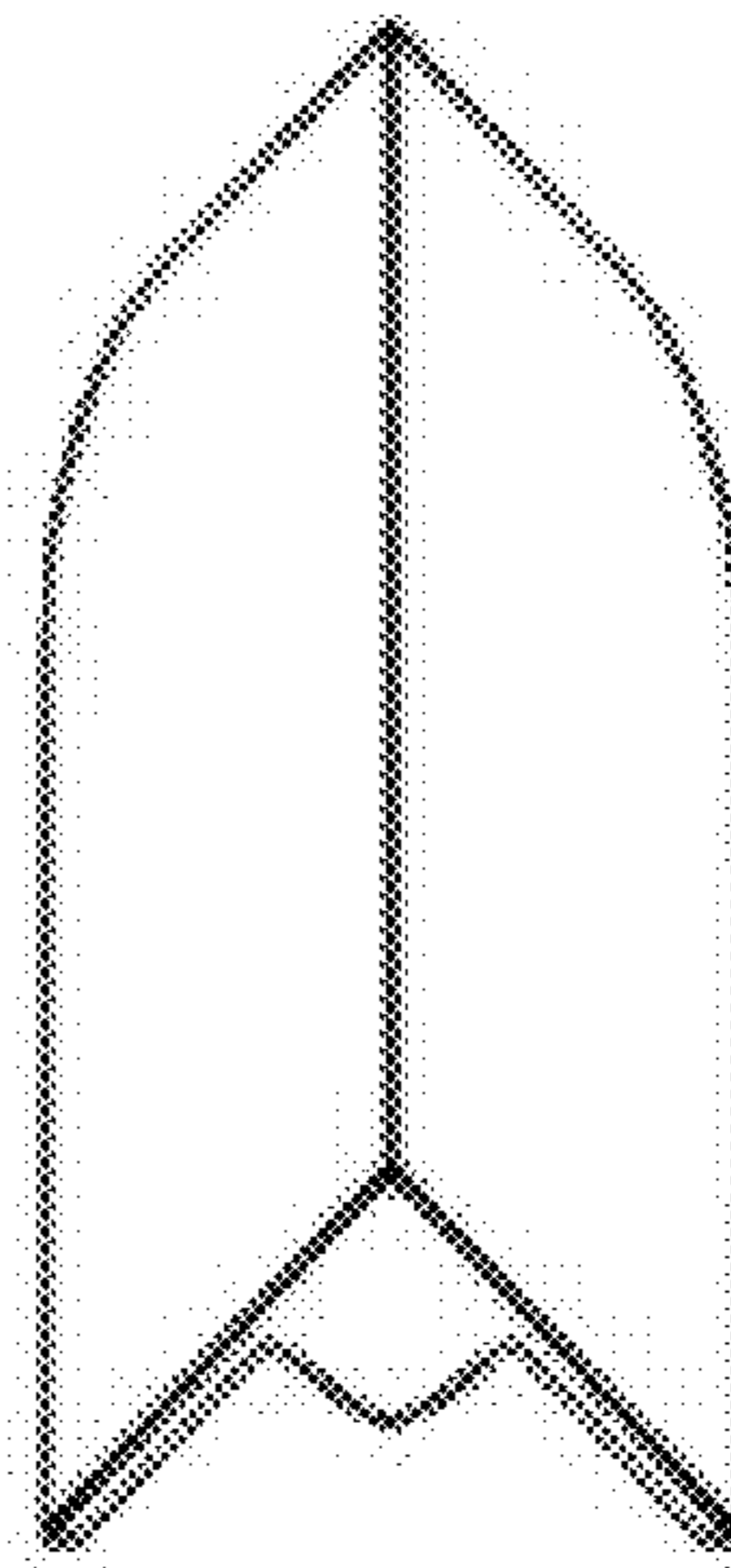
