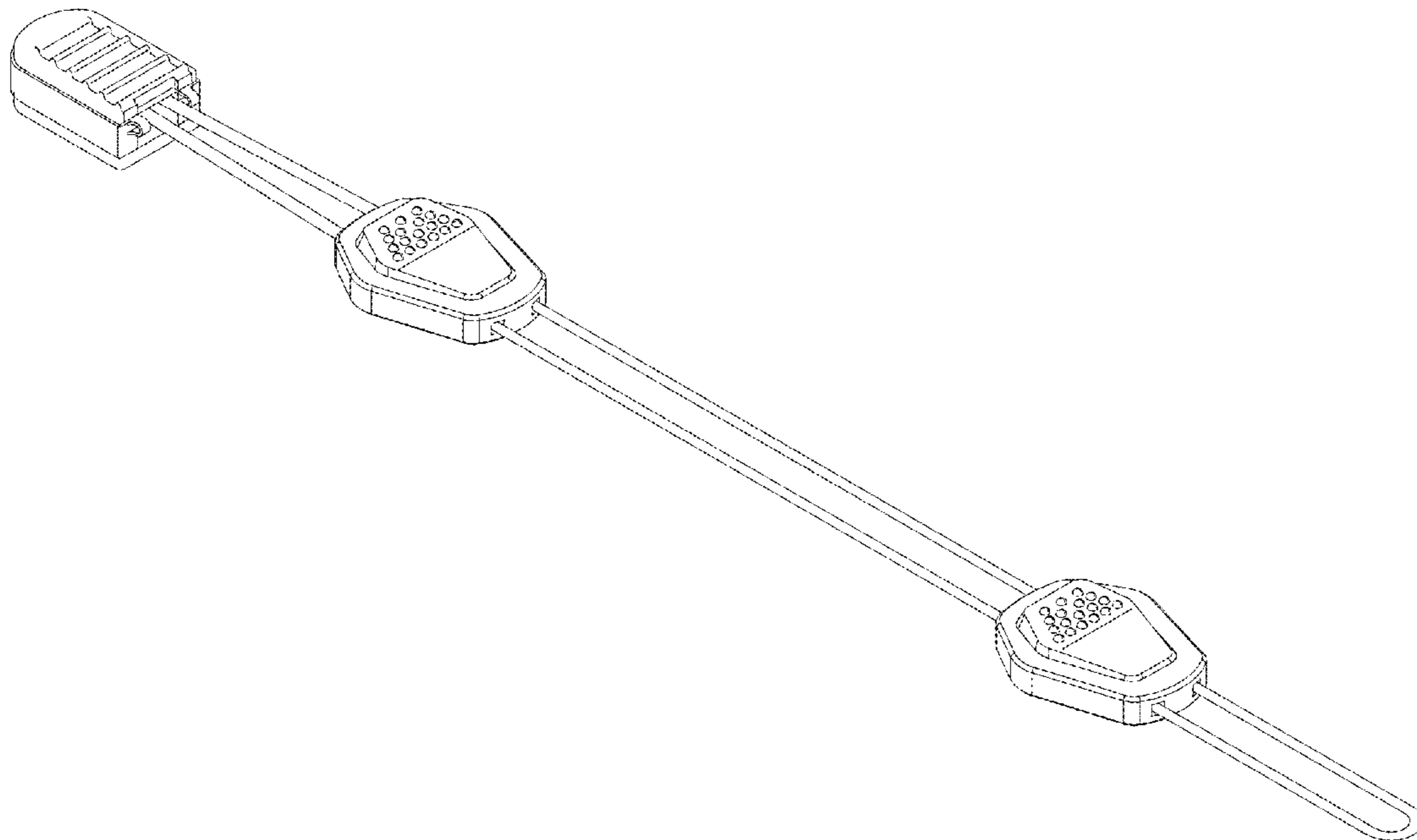
(57) **CLAIM**

The ornamental design for a portable, adjustable, light-weight cabinet lock, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of a portable, adjustable, lightweight cabinet lock showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top front perspective view of a second embodiment of a portable, adjustable, lightweight cabinet lock; and, FIG. 7 is a top plan view of FIG. 6.

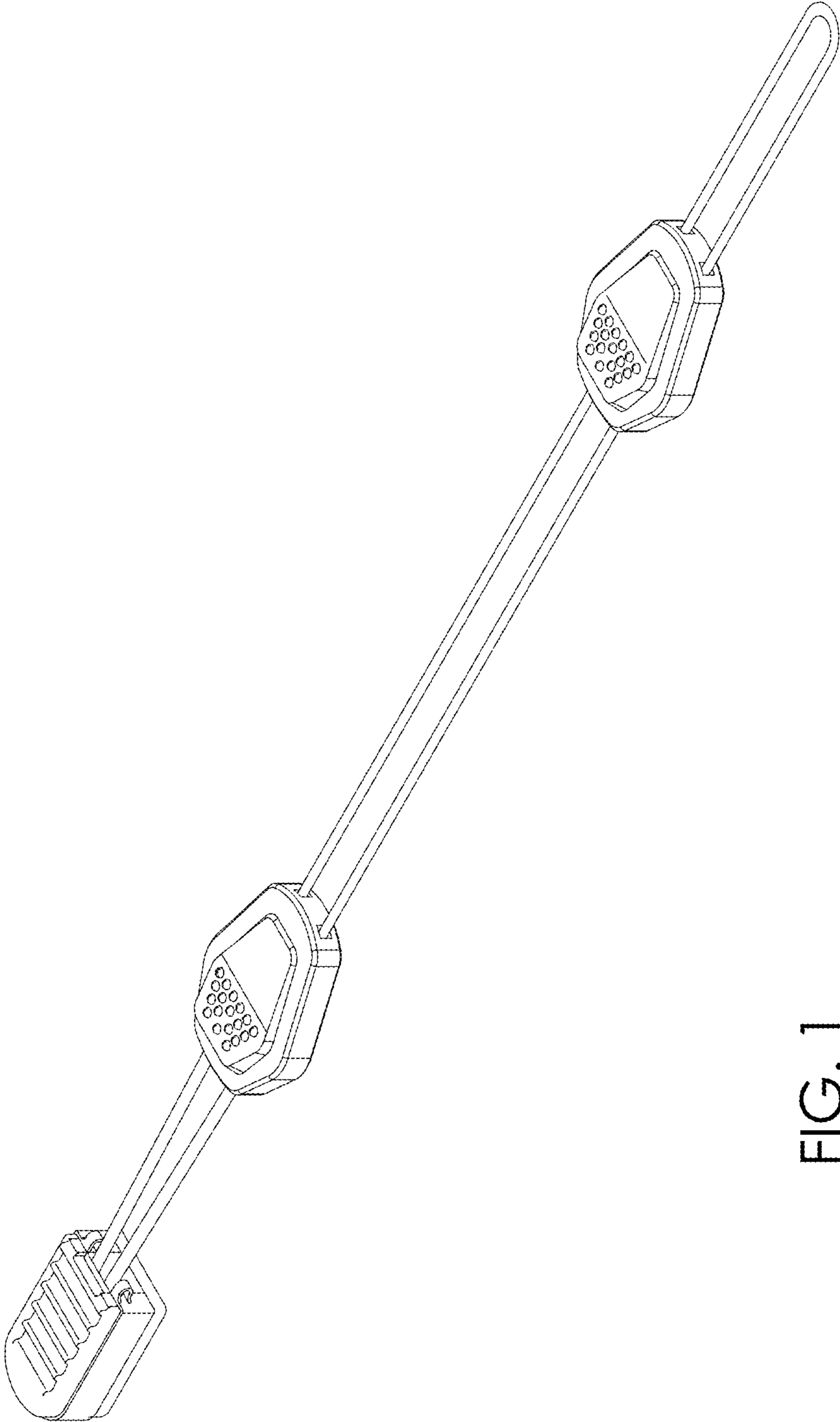

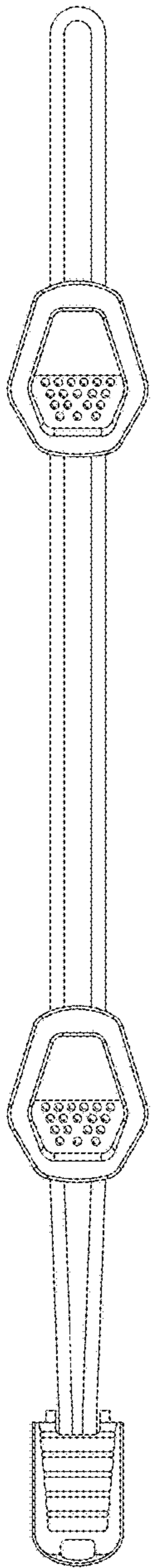

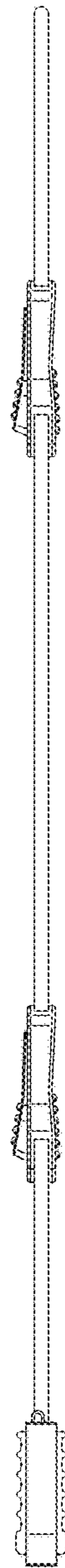

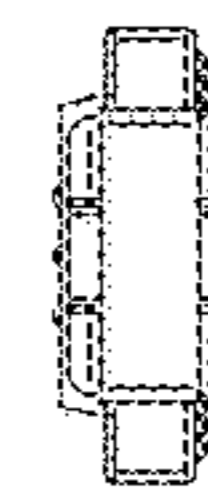

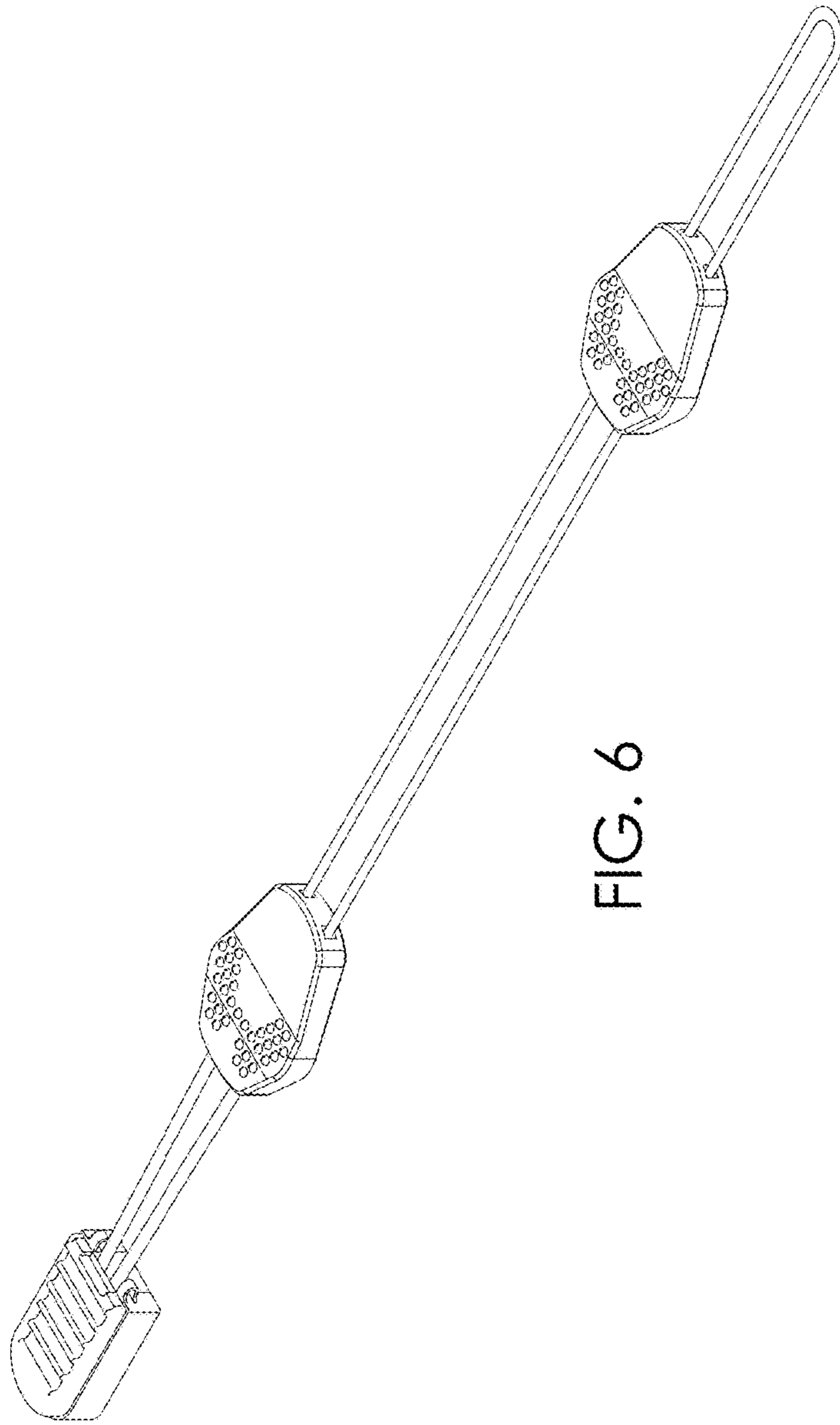

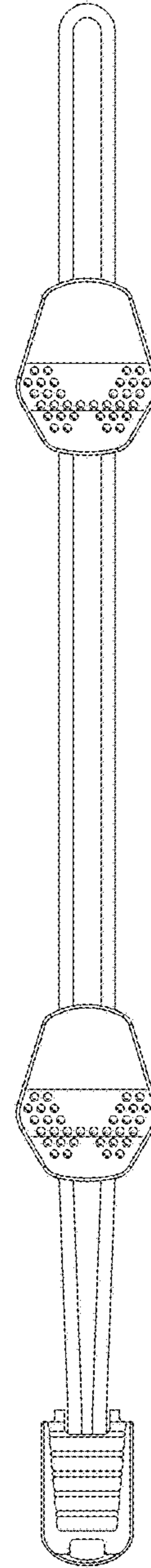
