DESCRIPTION

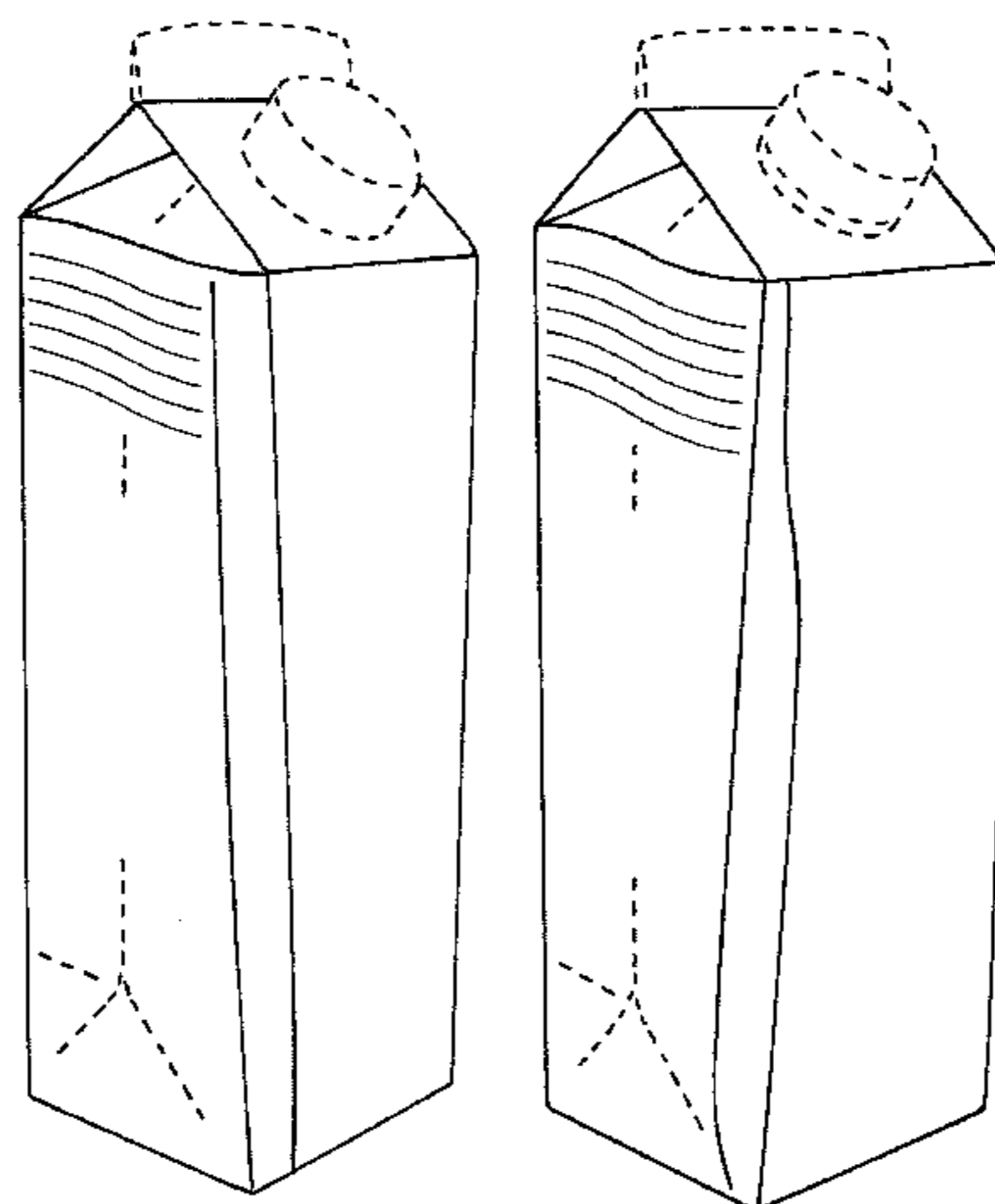


FIG. 20 is a front perspective view of the carton thereof in a fully assembled configuration of use;

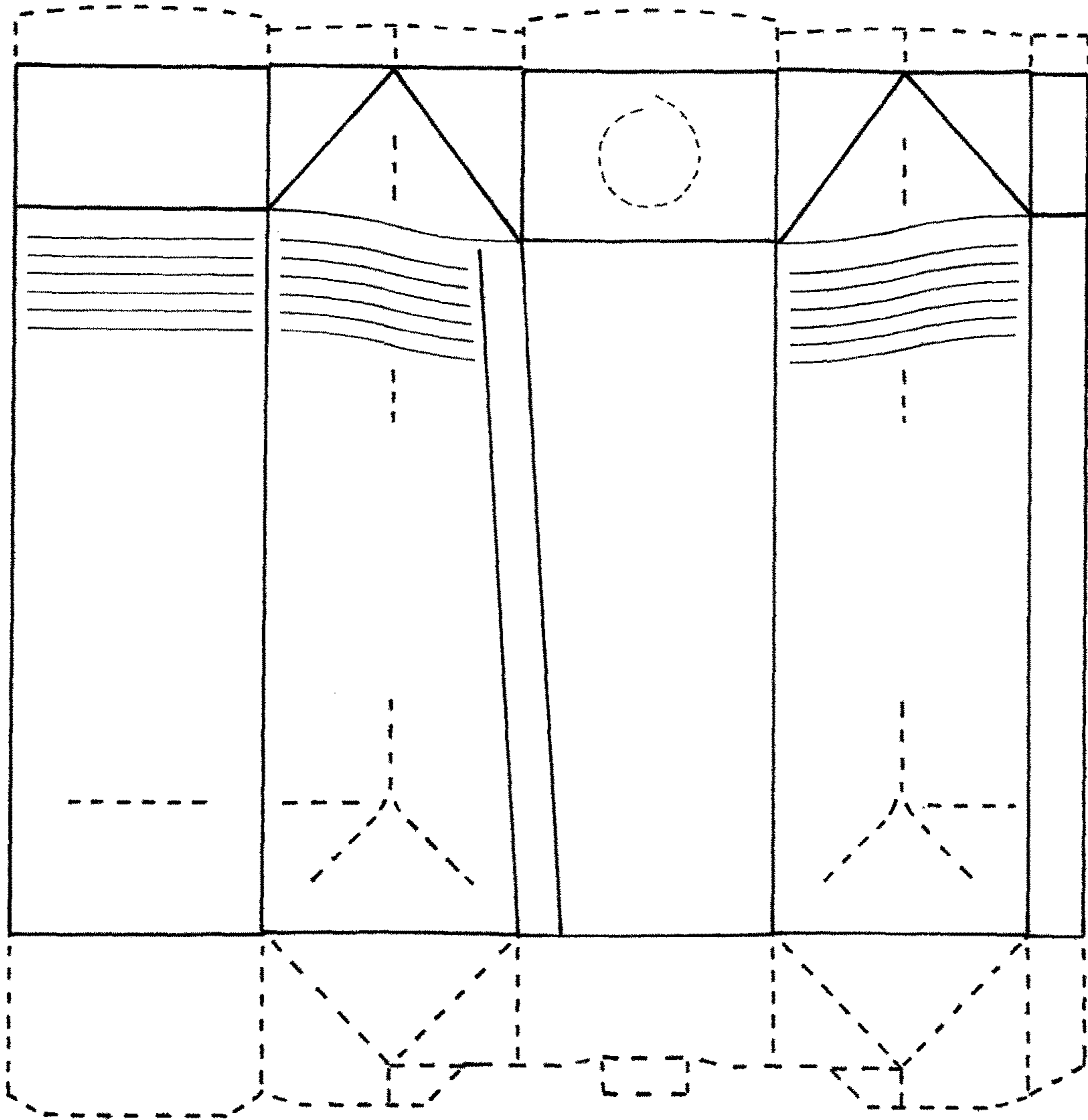

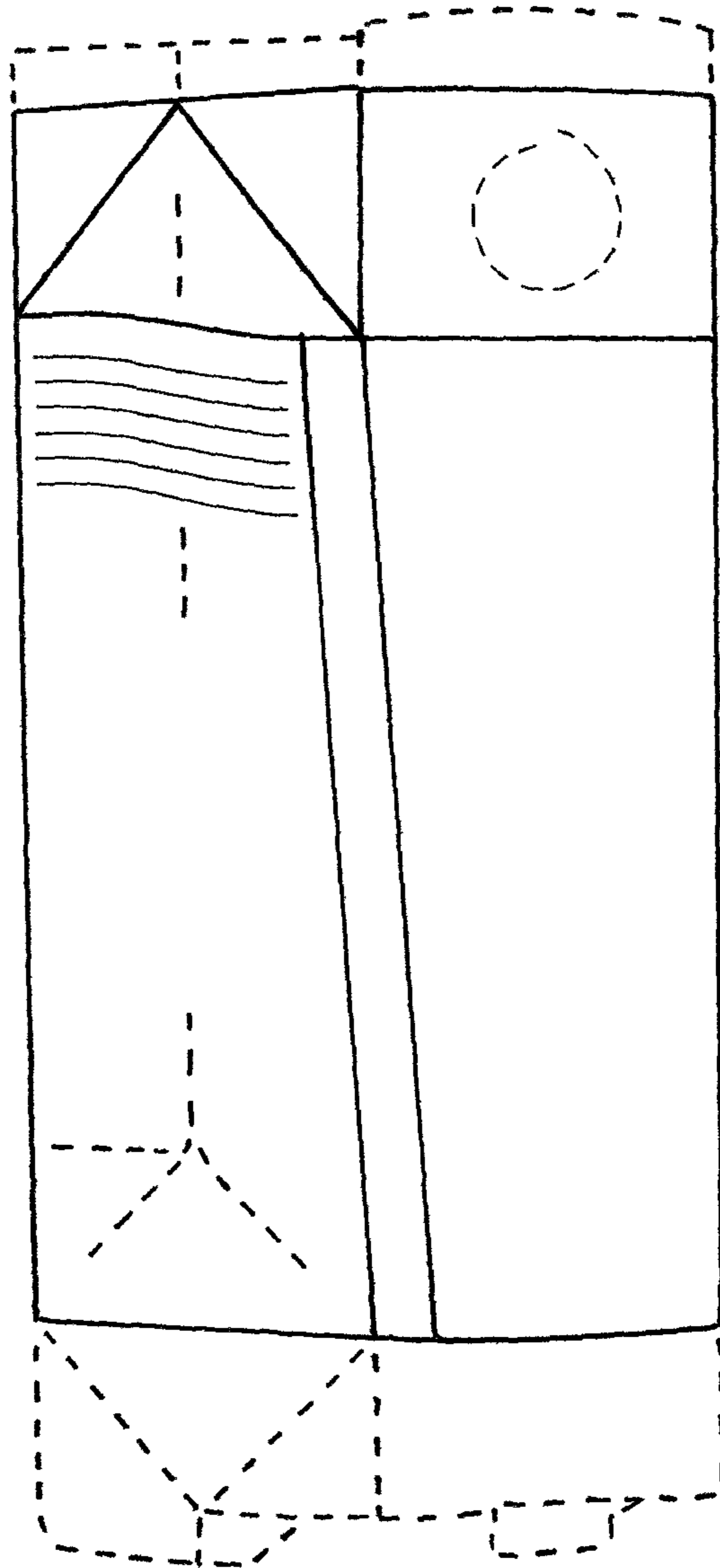

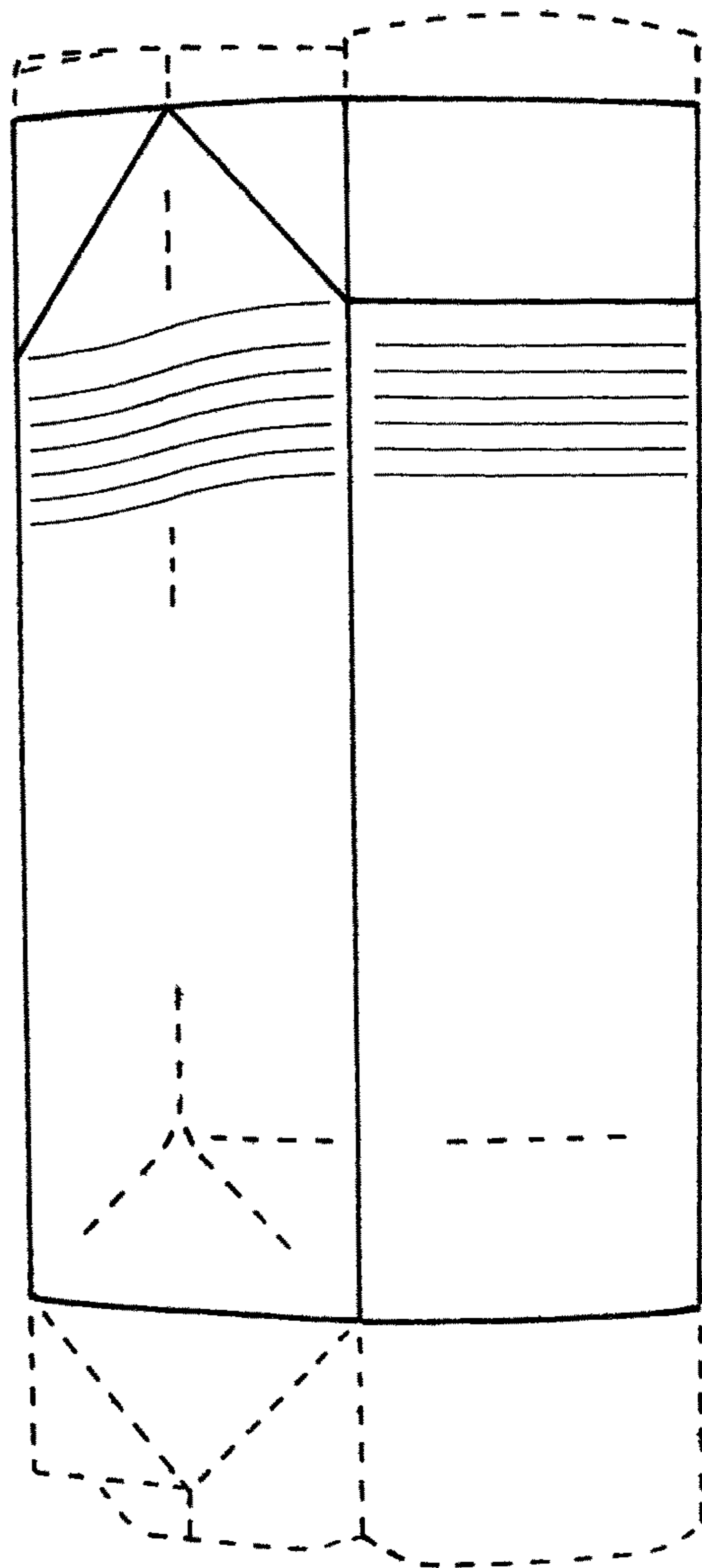

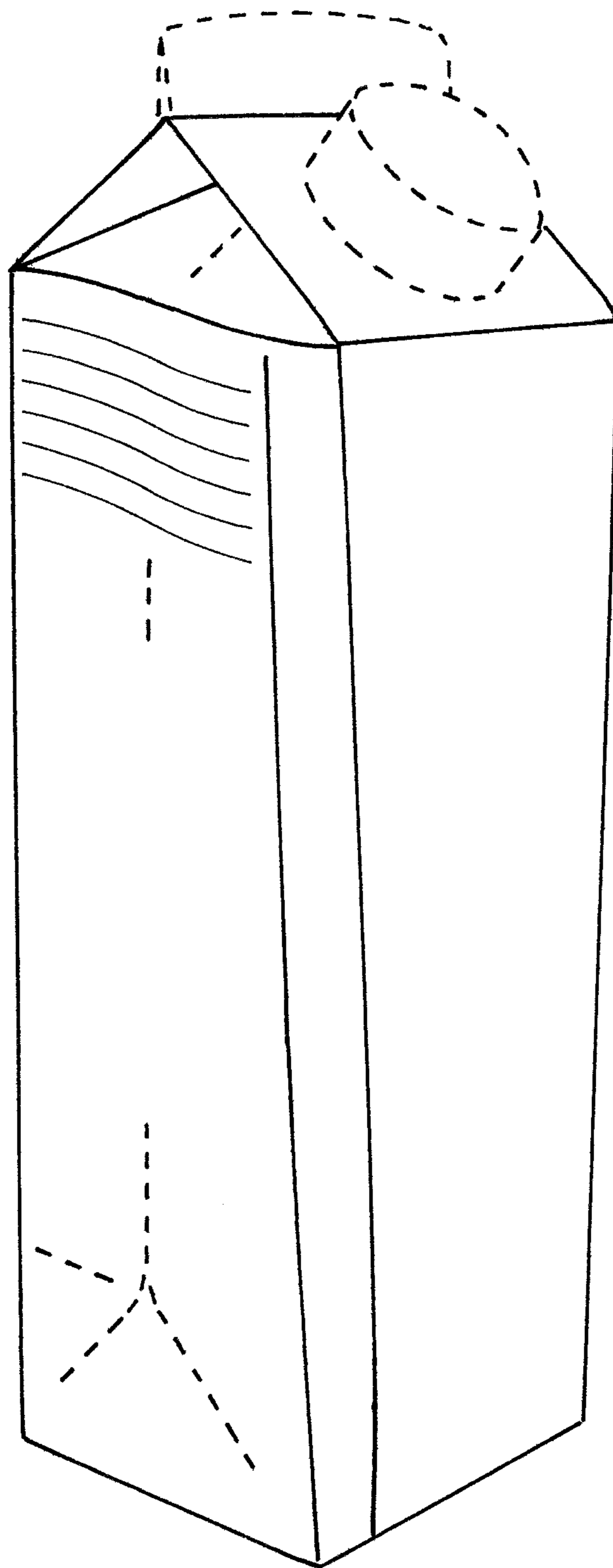

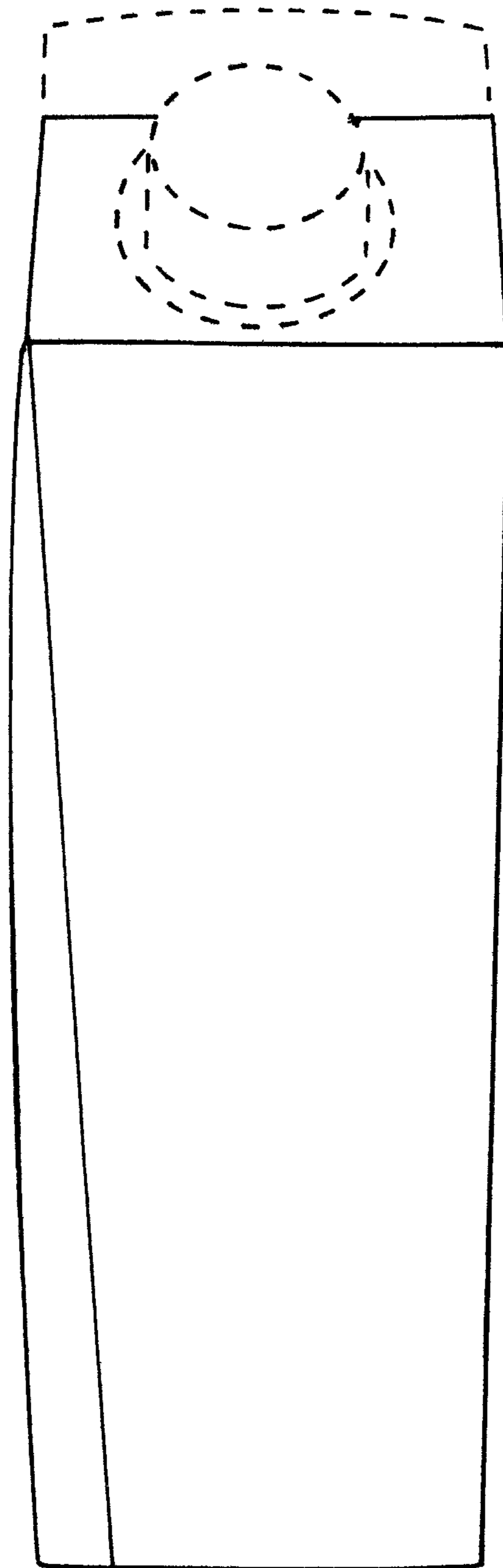

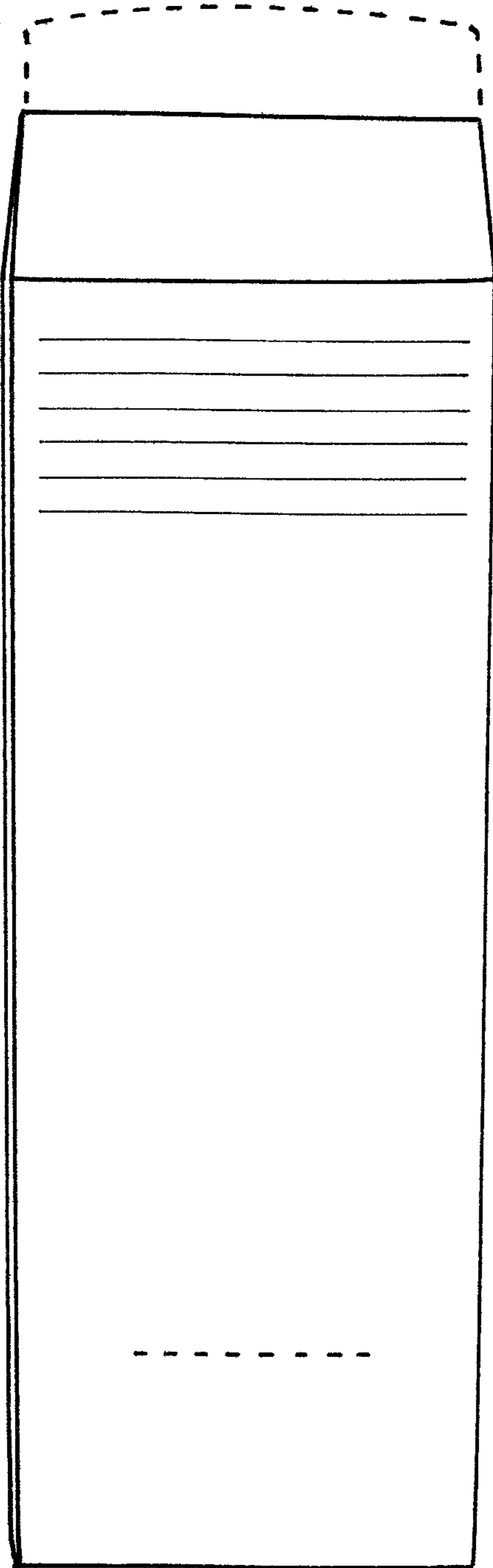

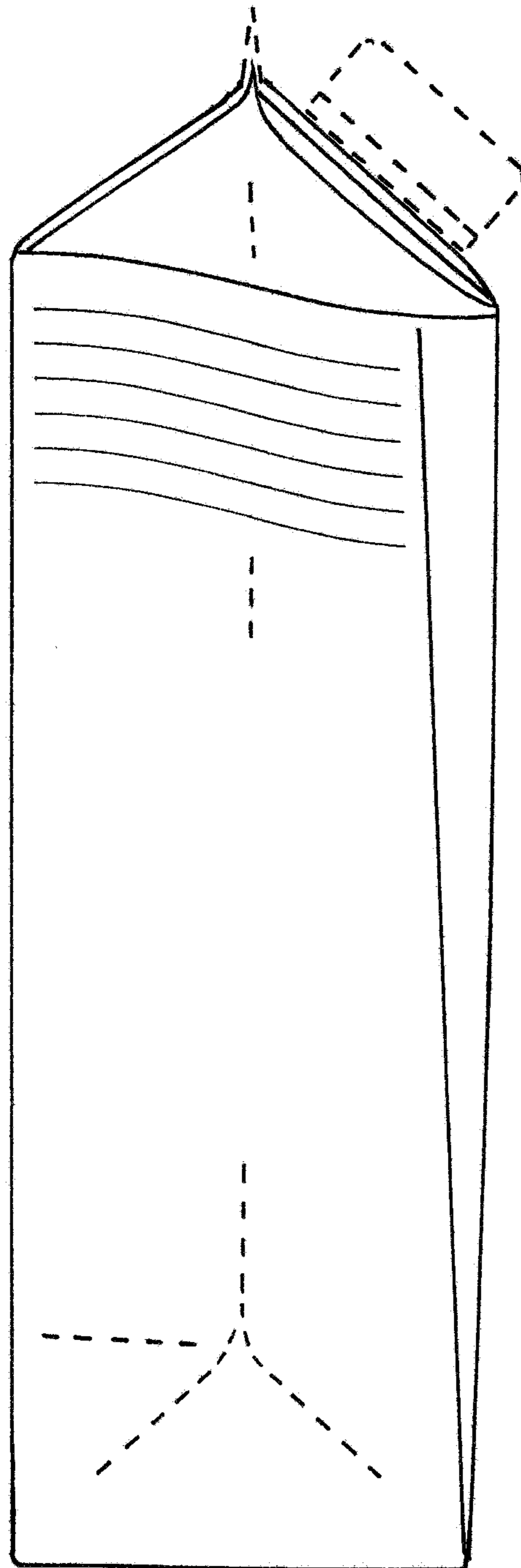

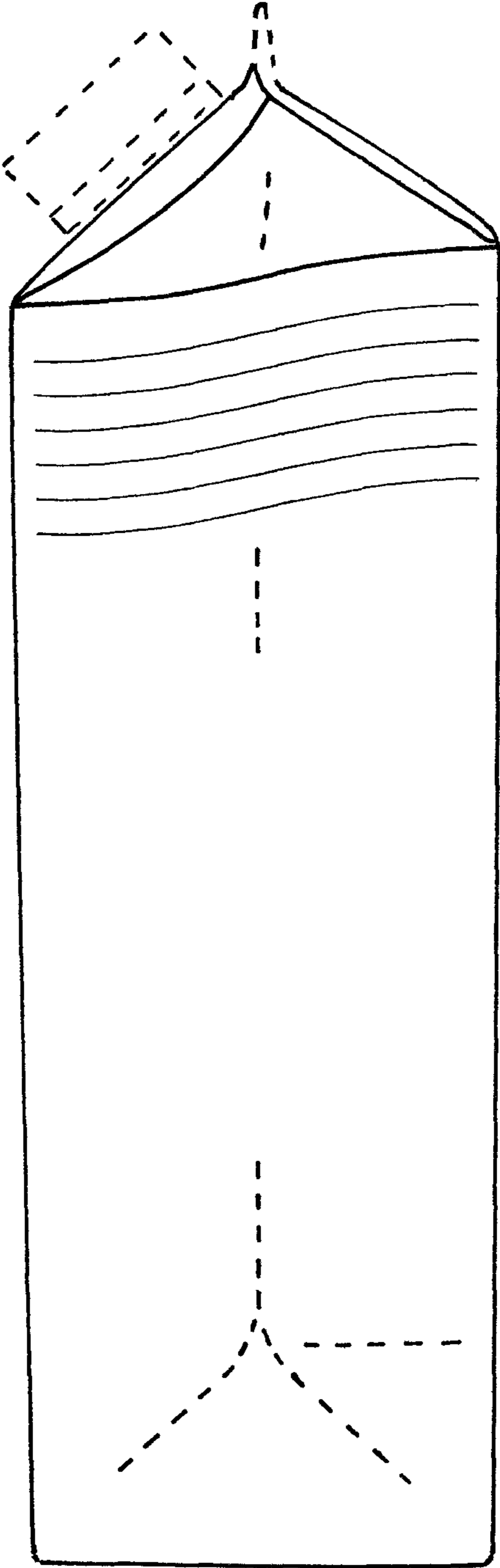

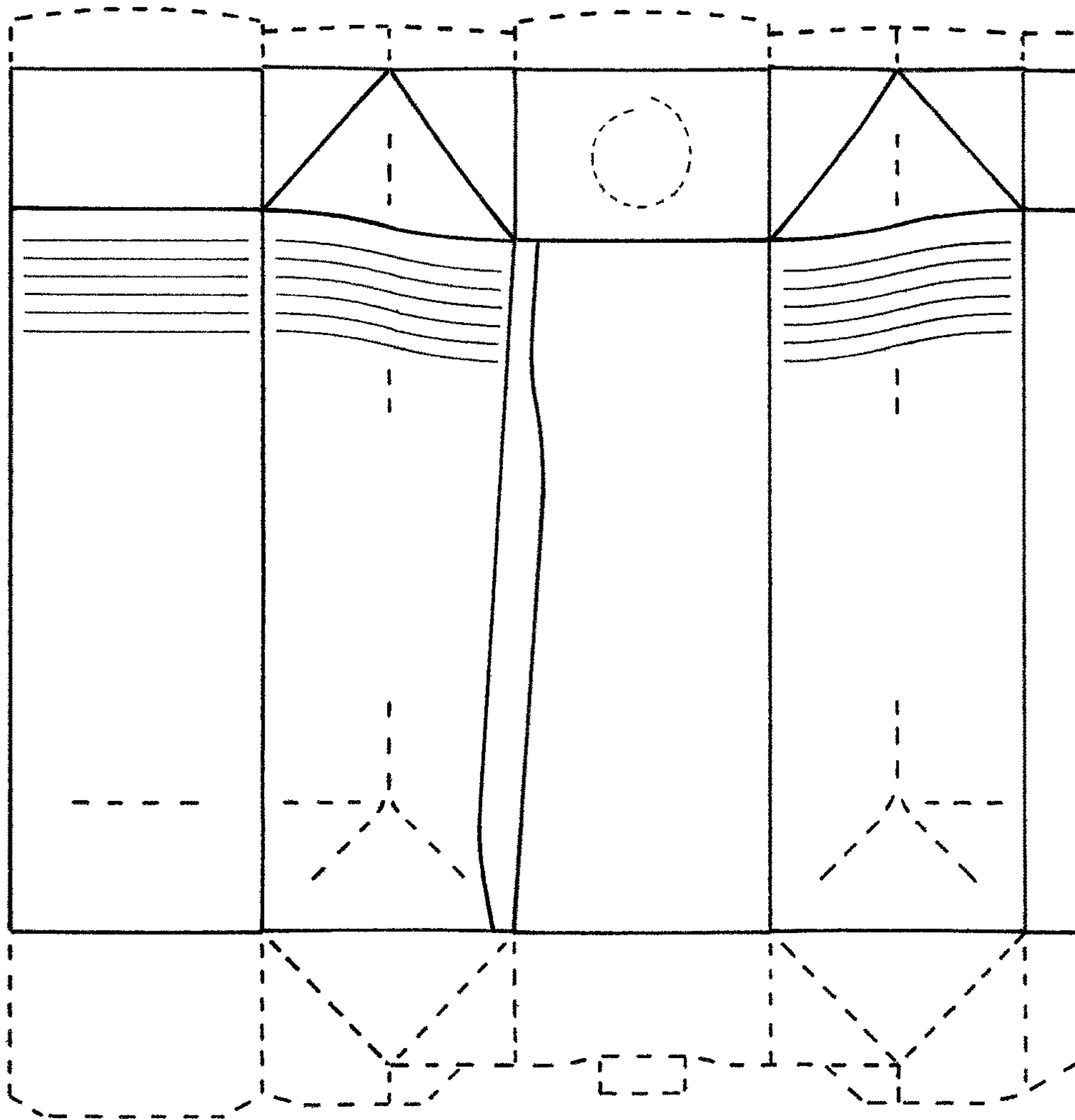

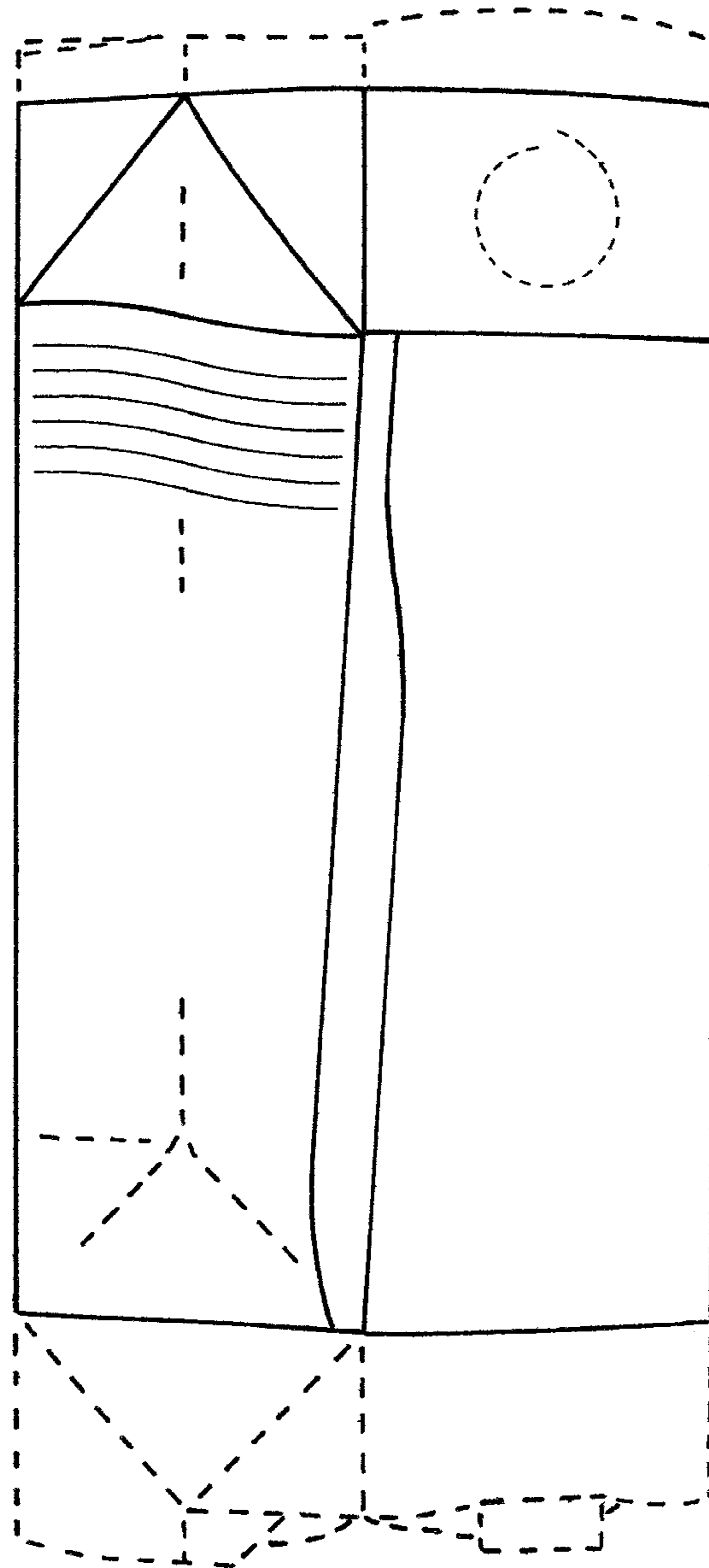

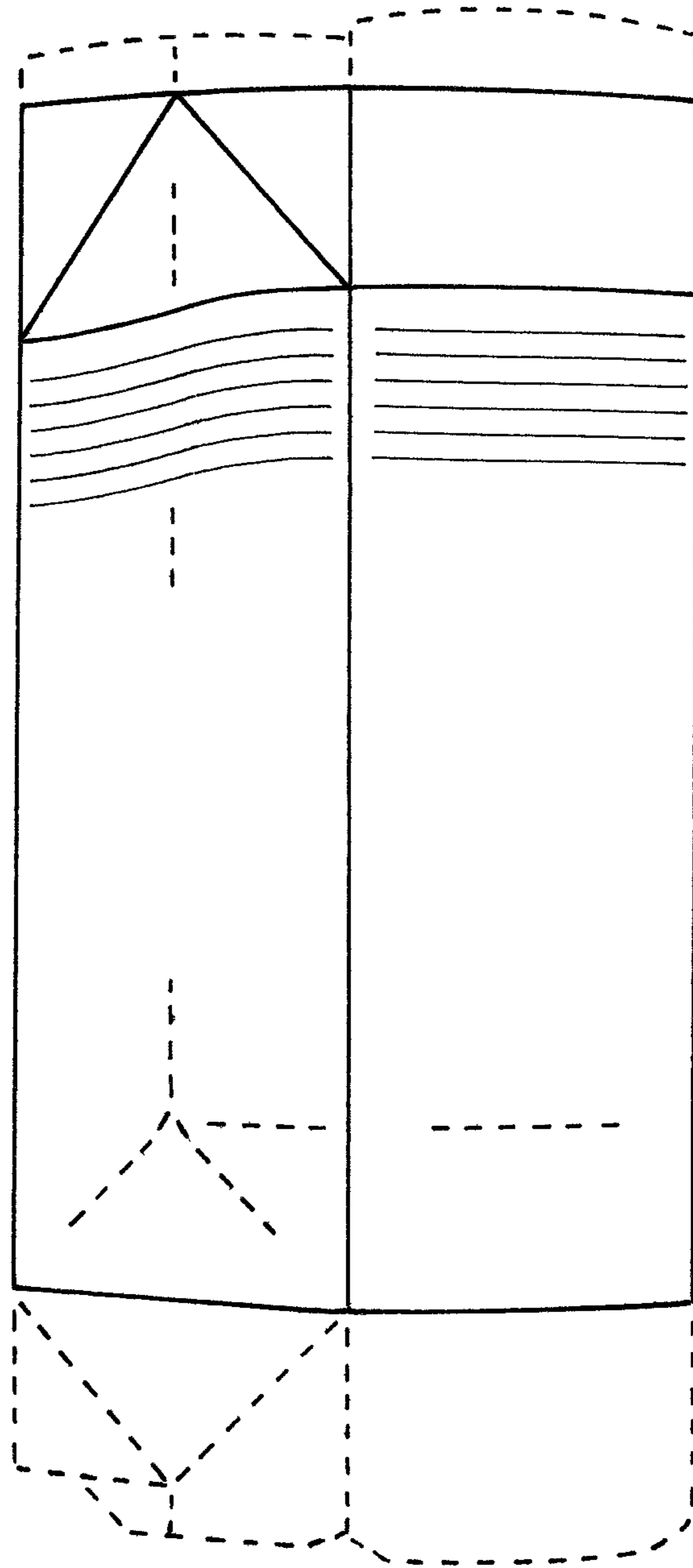

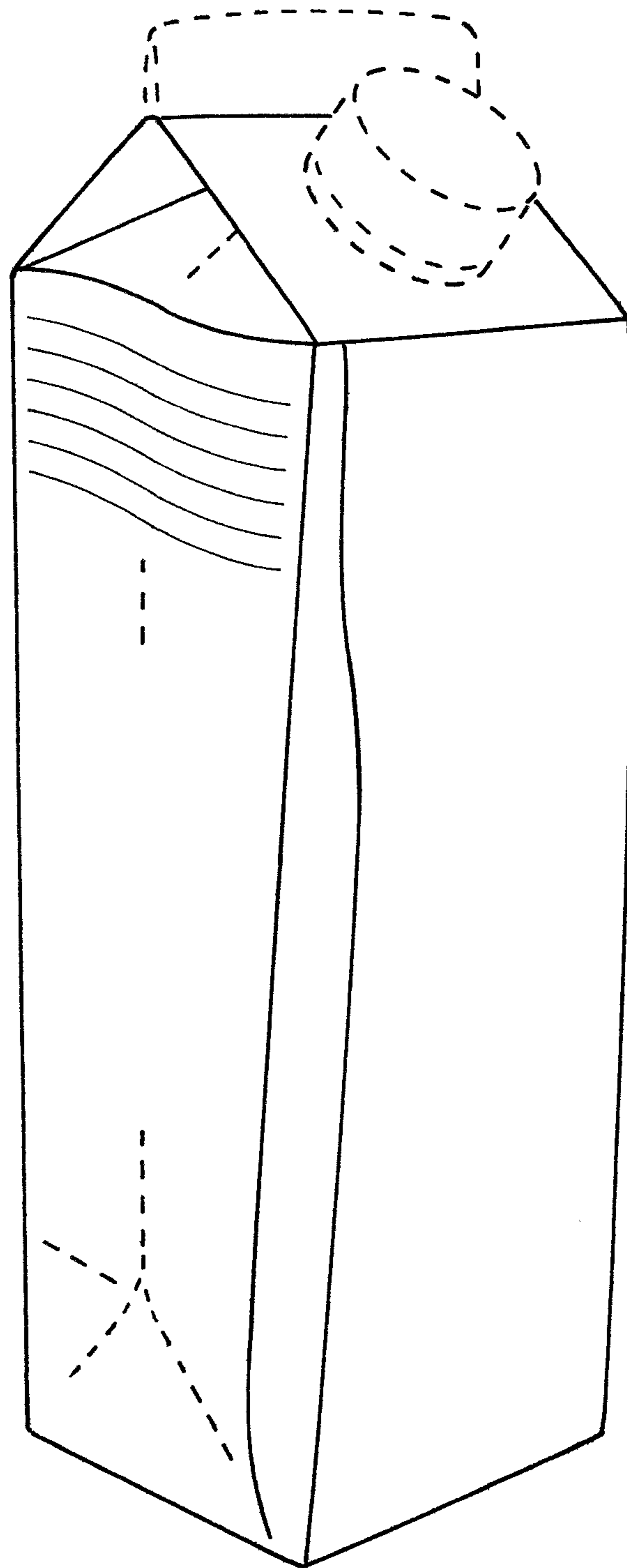

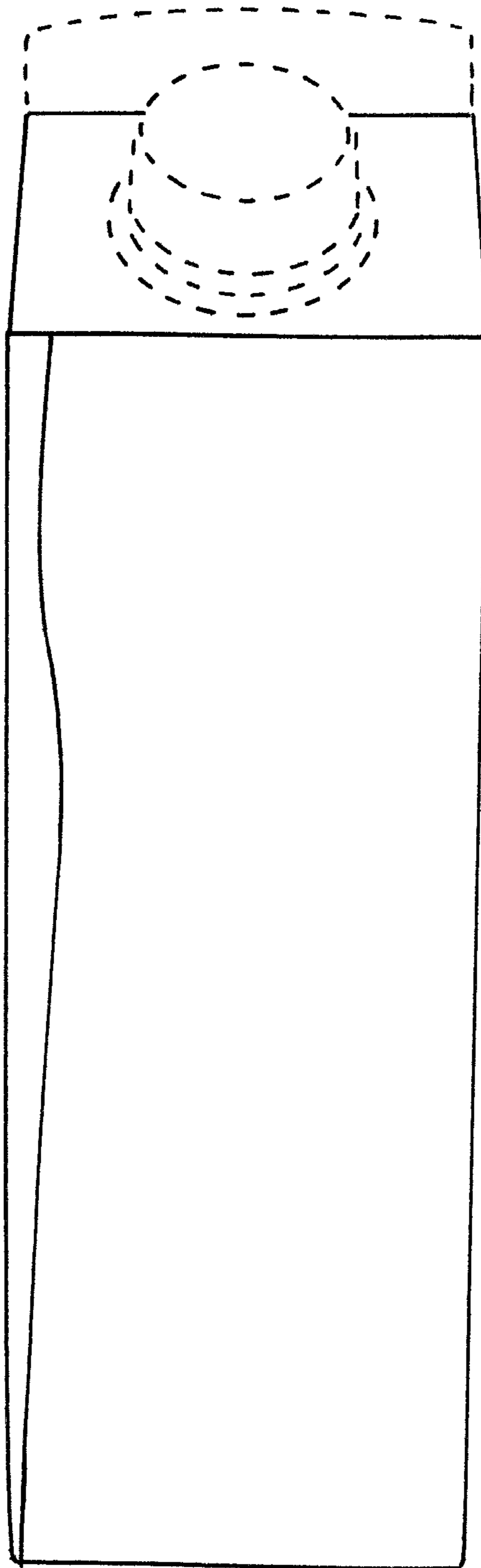

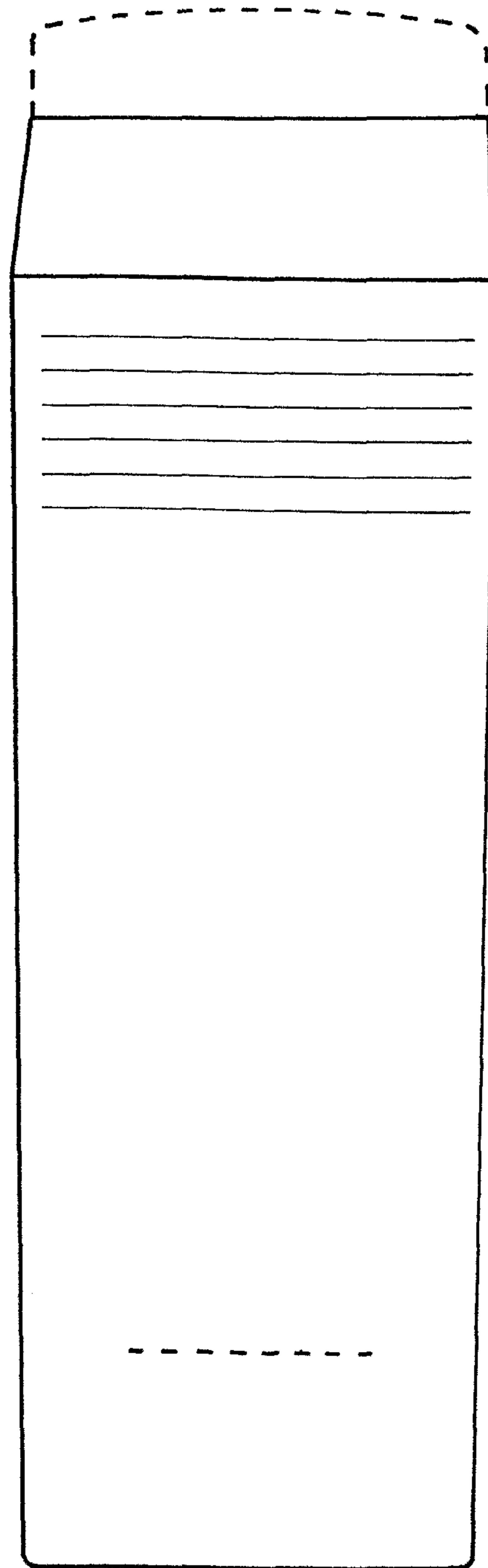

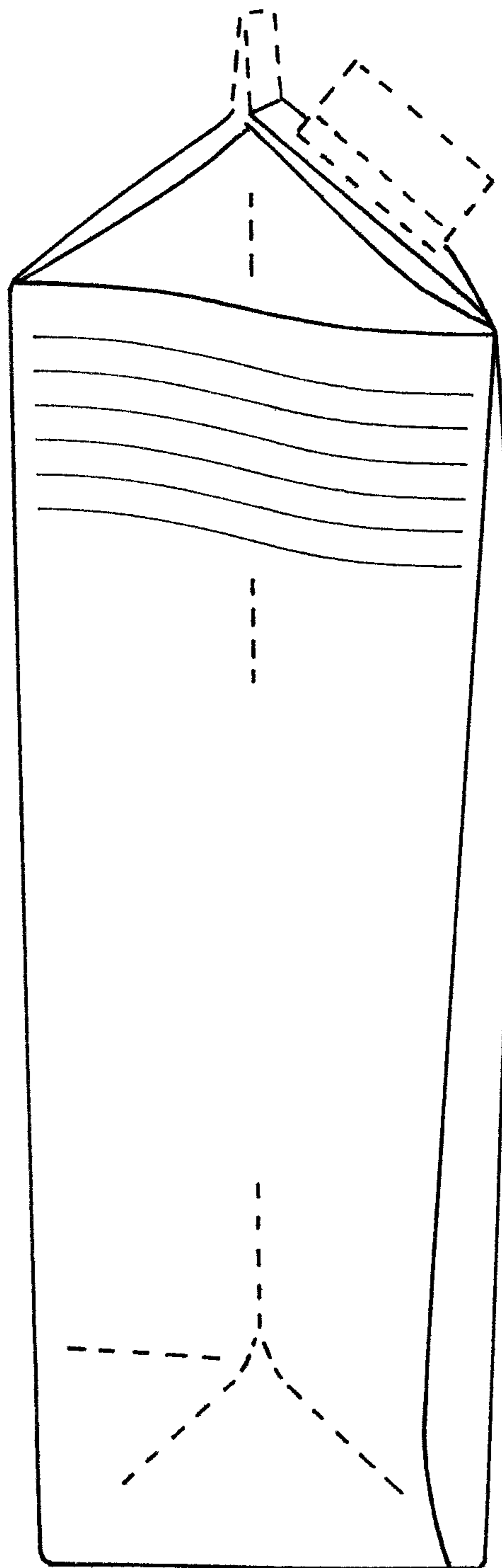

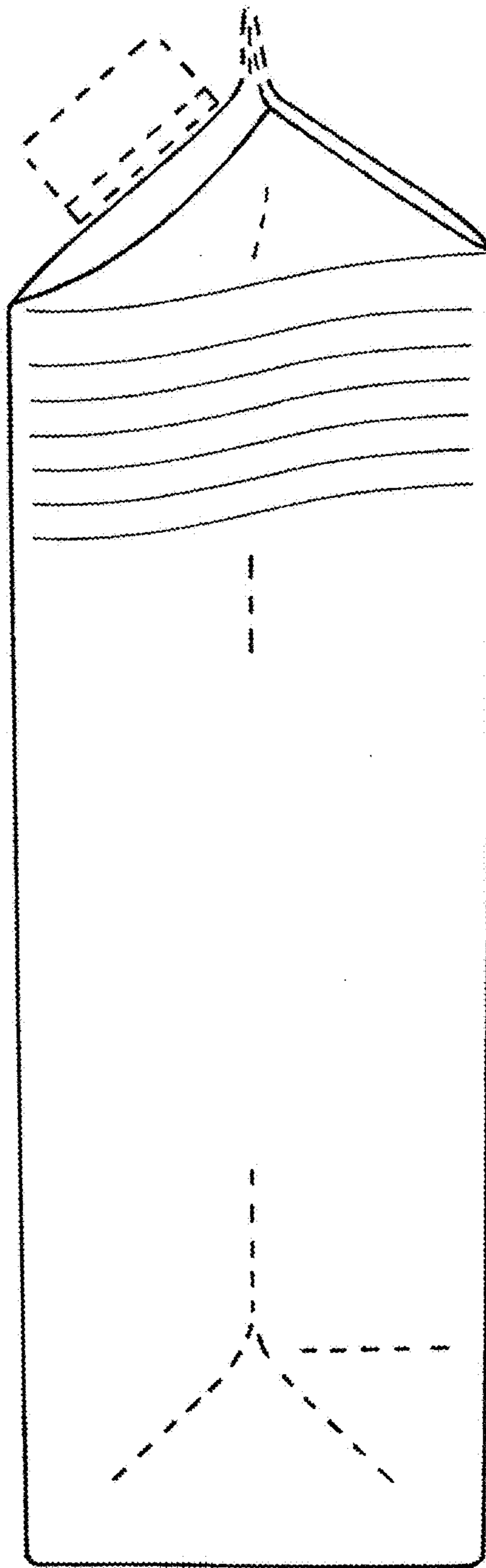

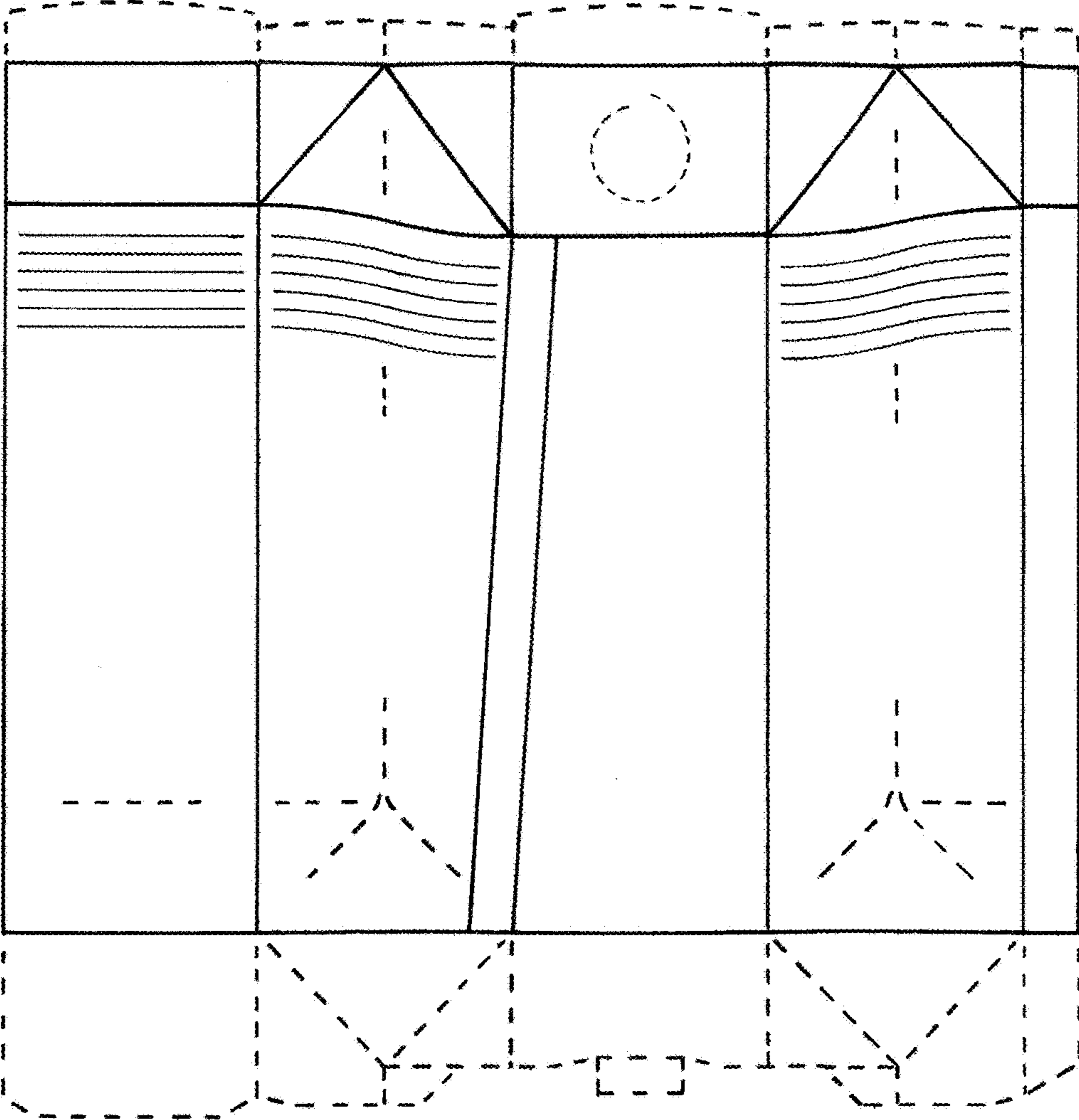

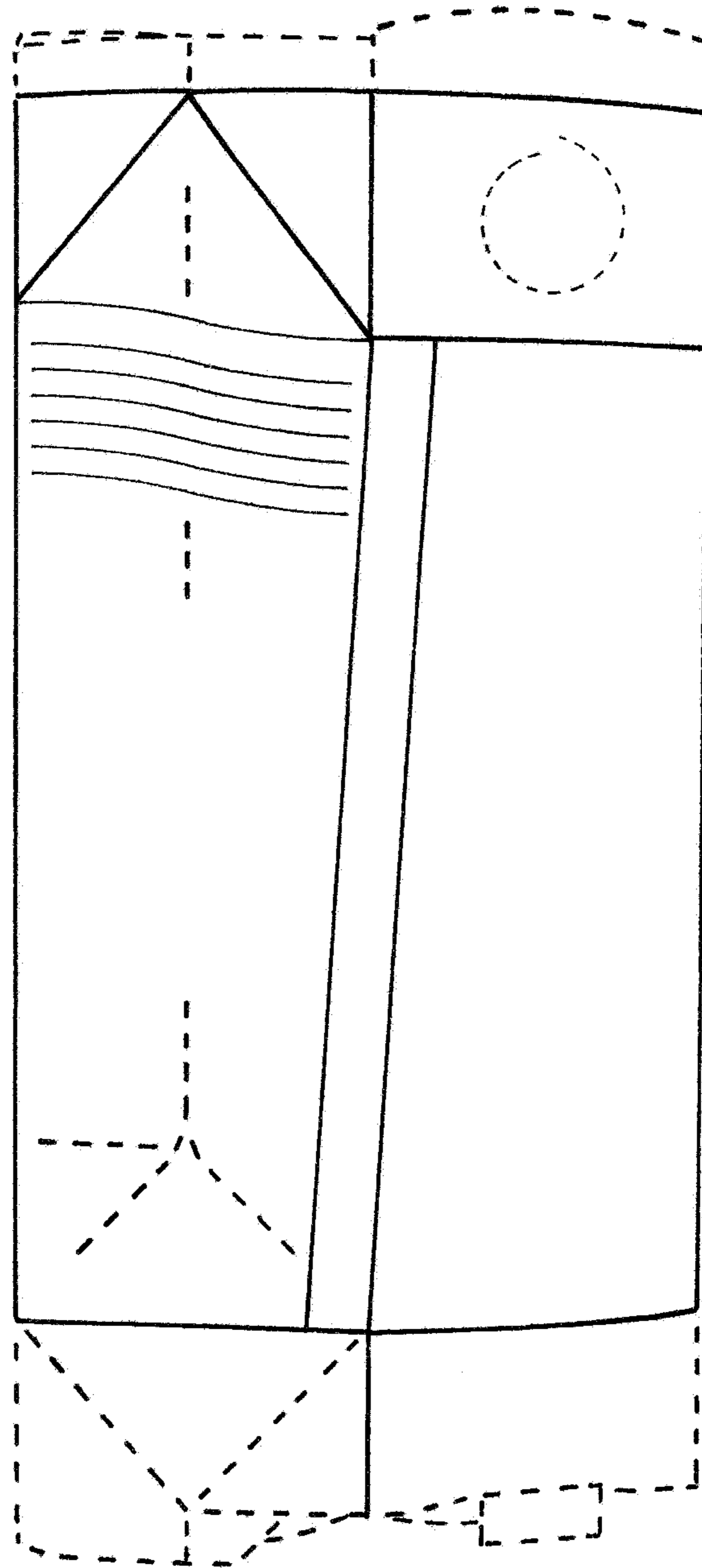

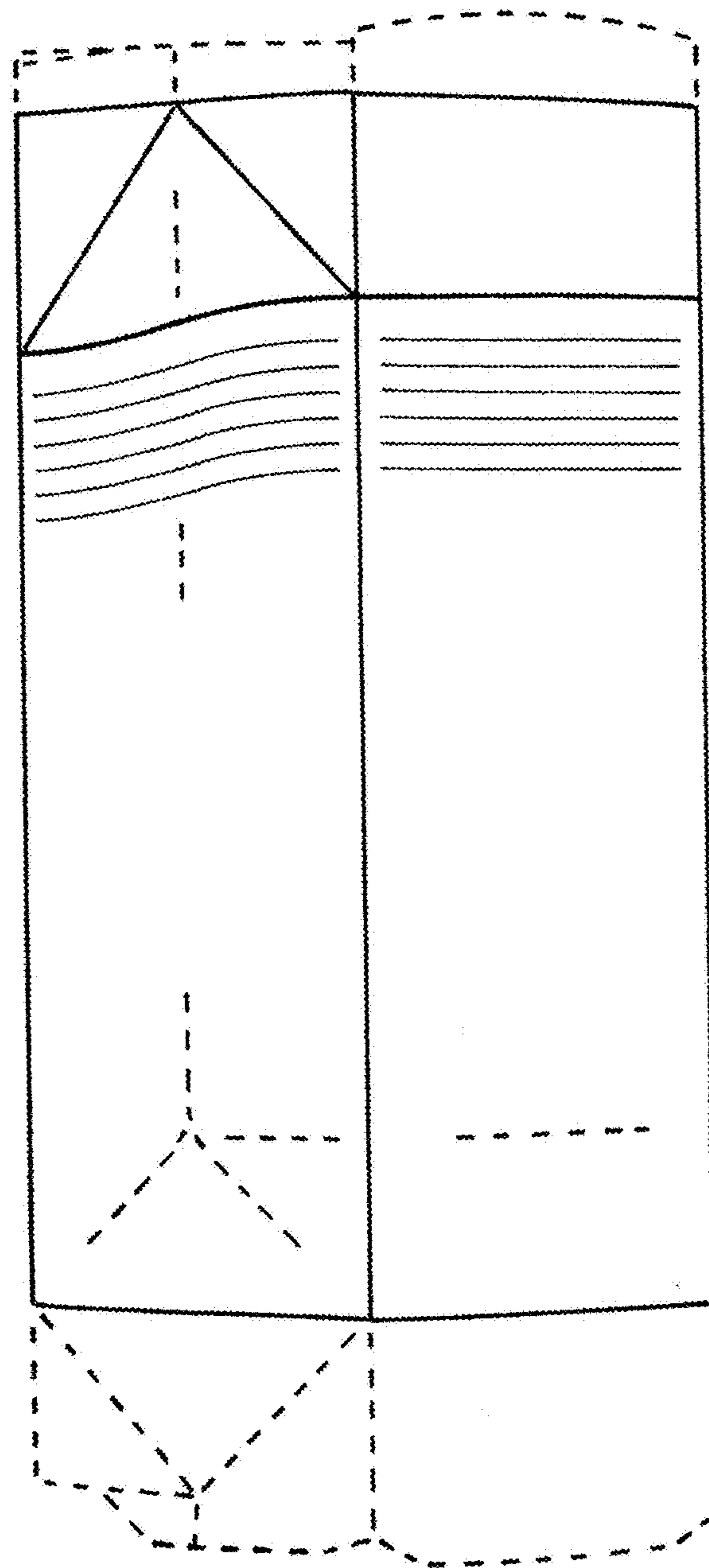

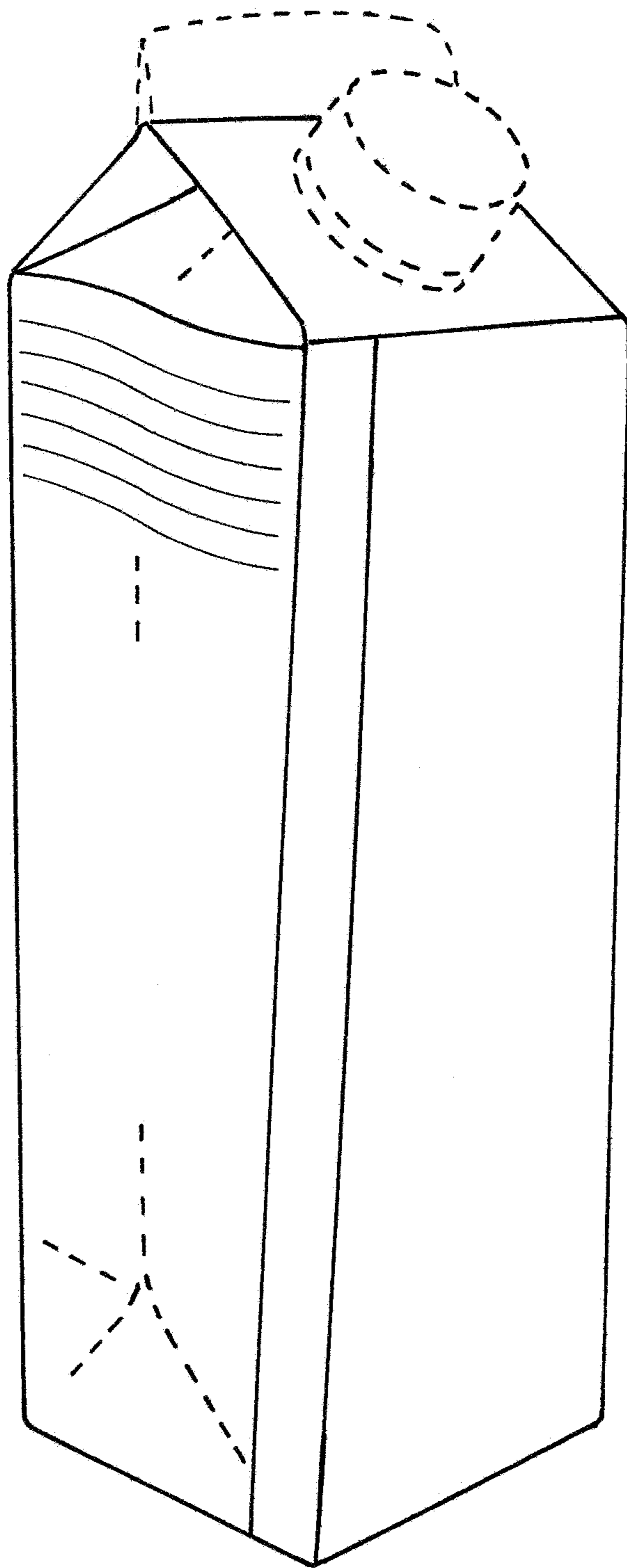

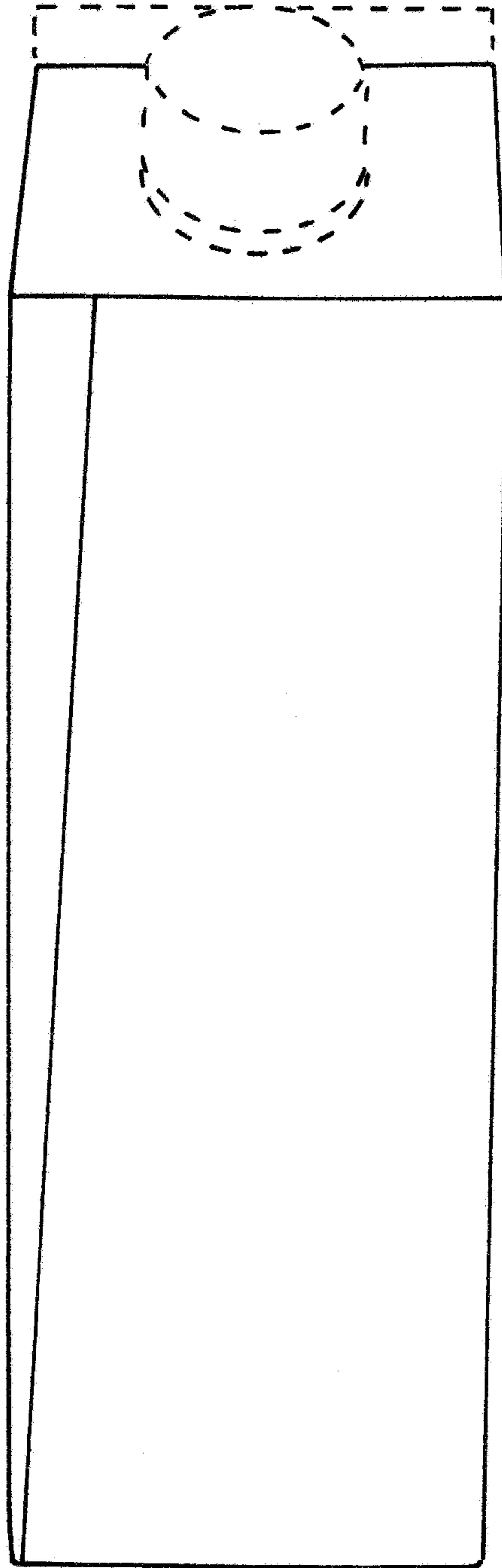

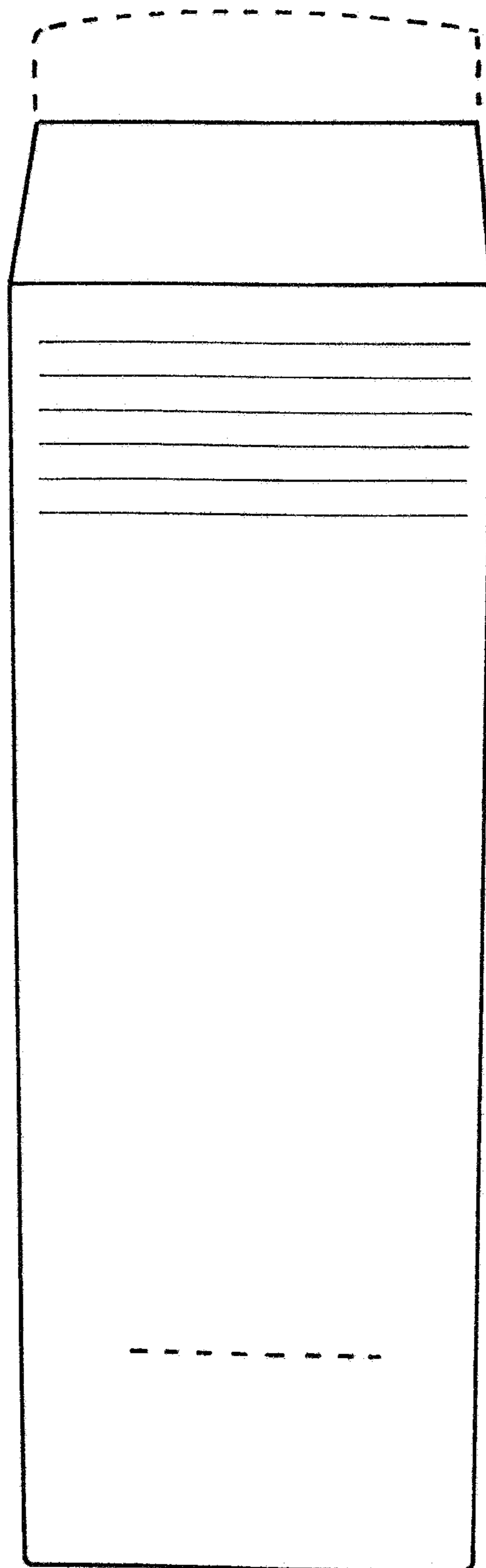

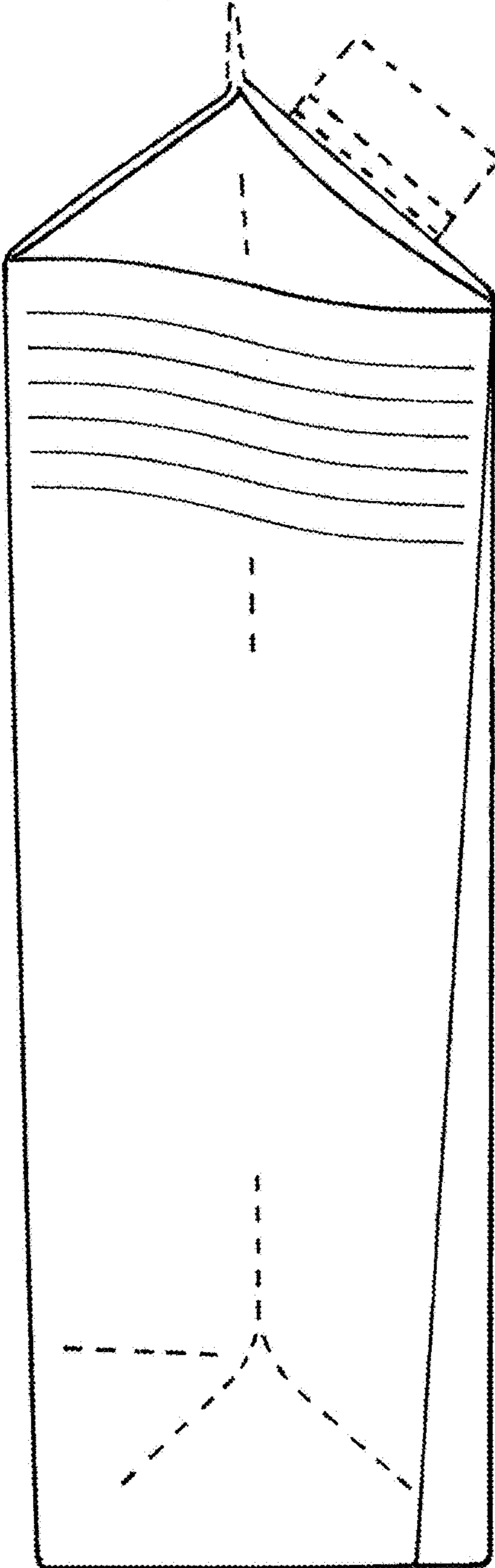

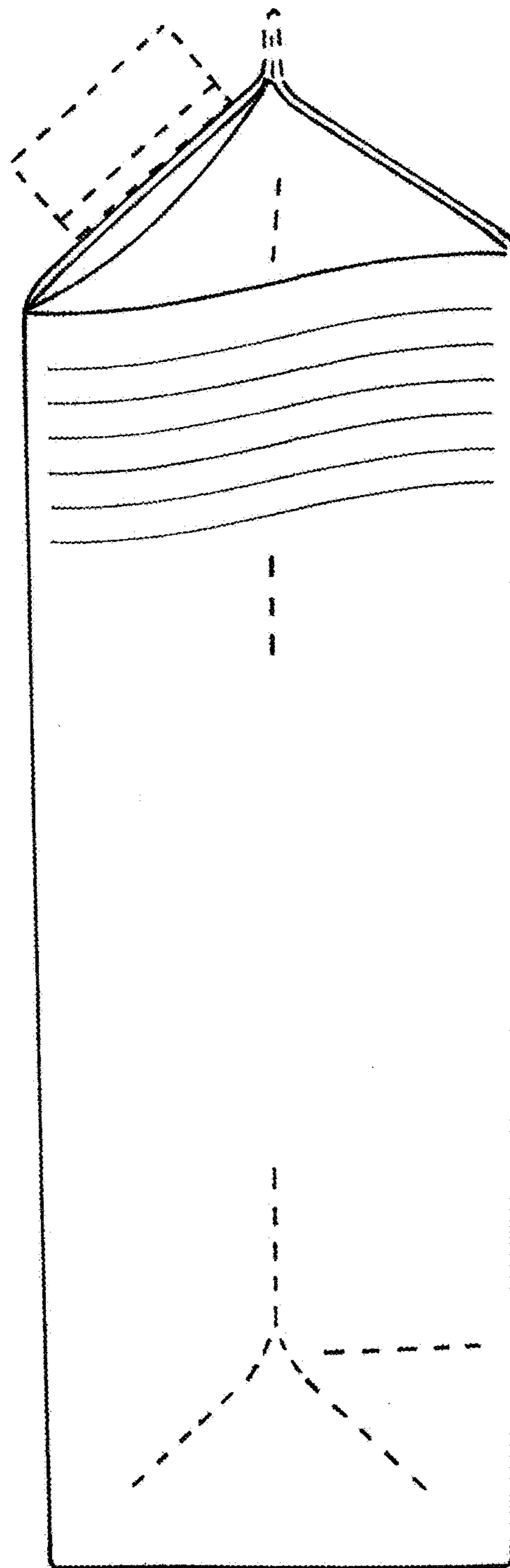
