The ornamental design for a pessary seal, as shown and described.

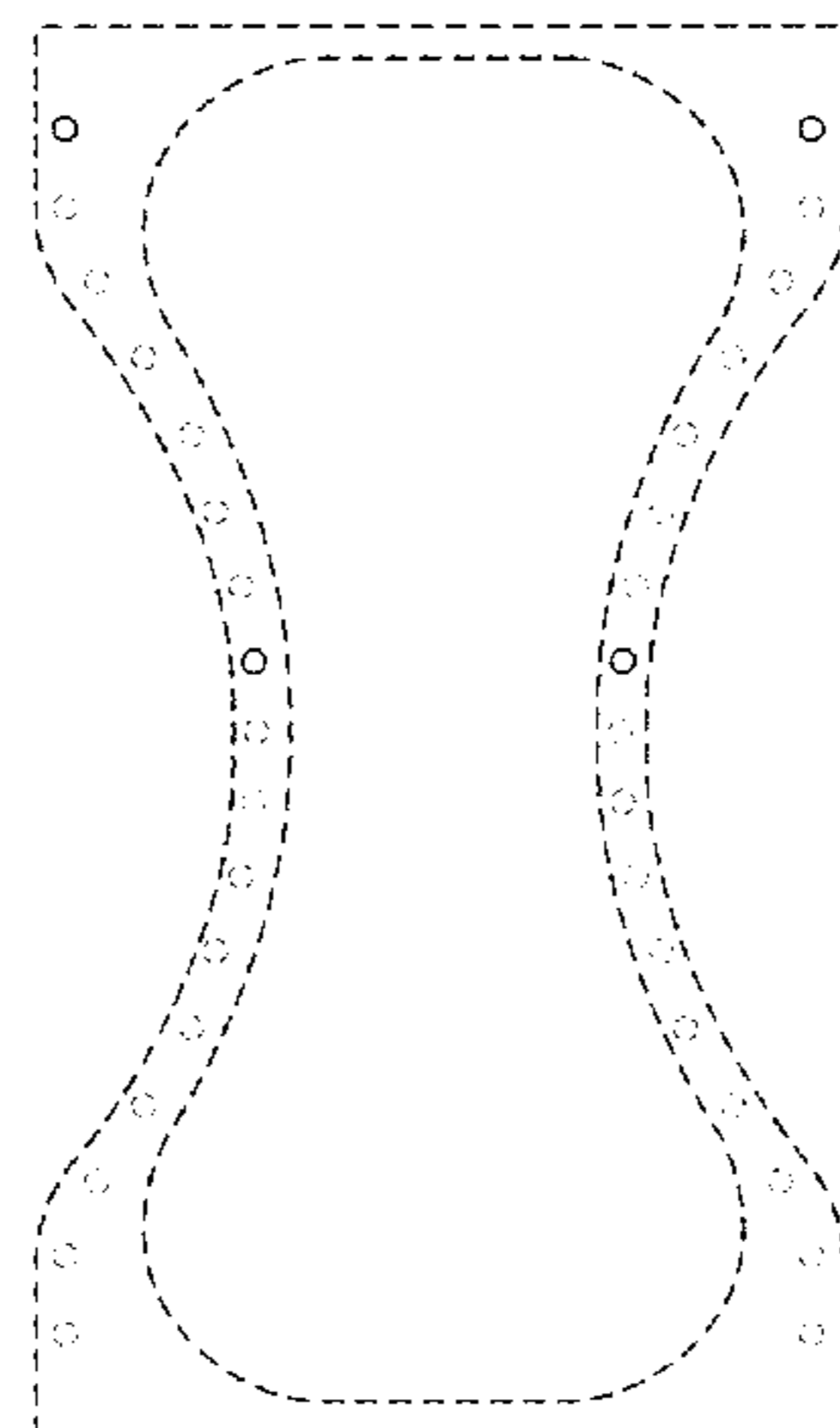
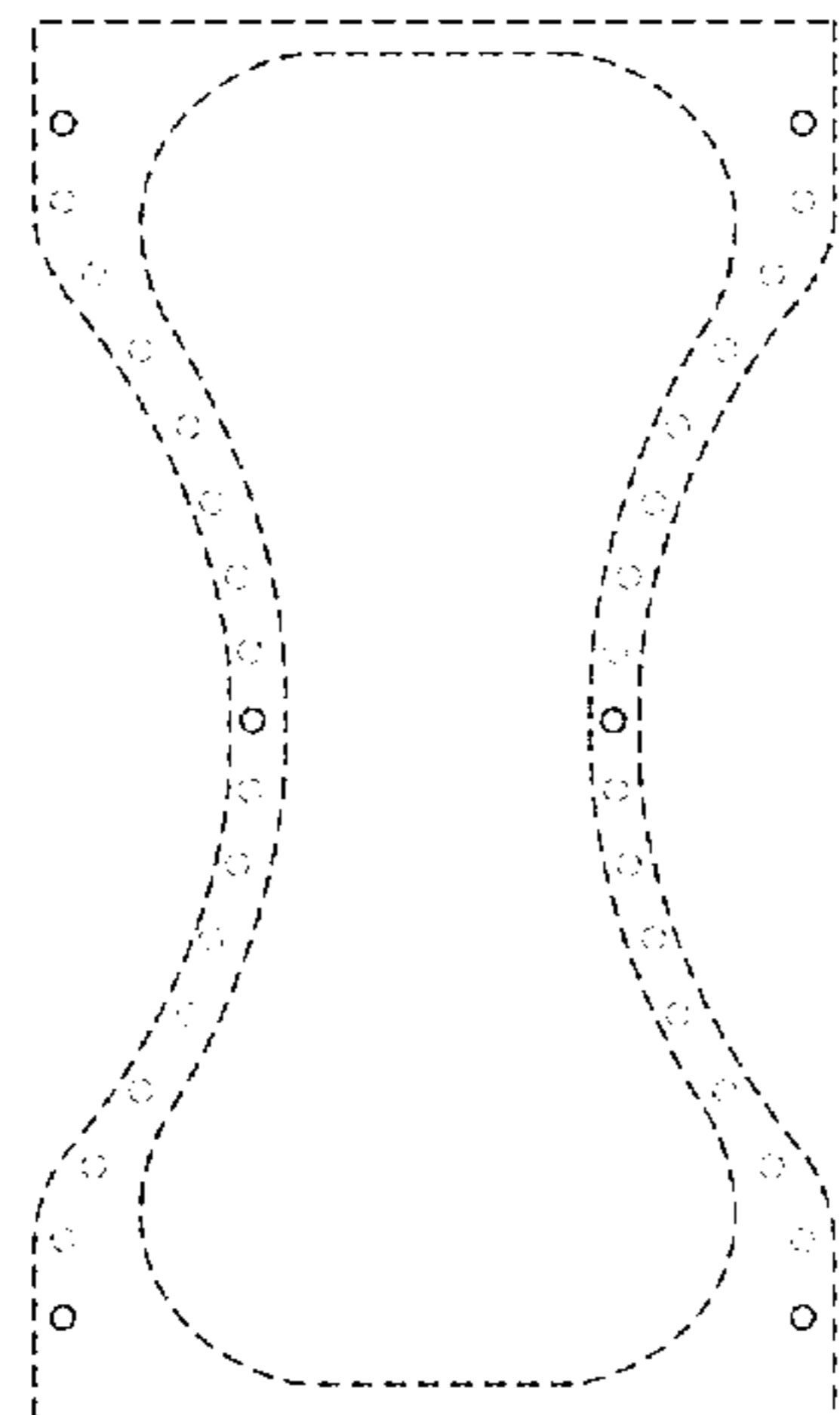
DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a pessary seal showing our new design;

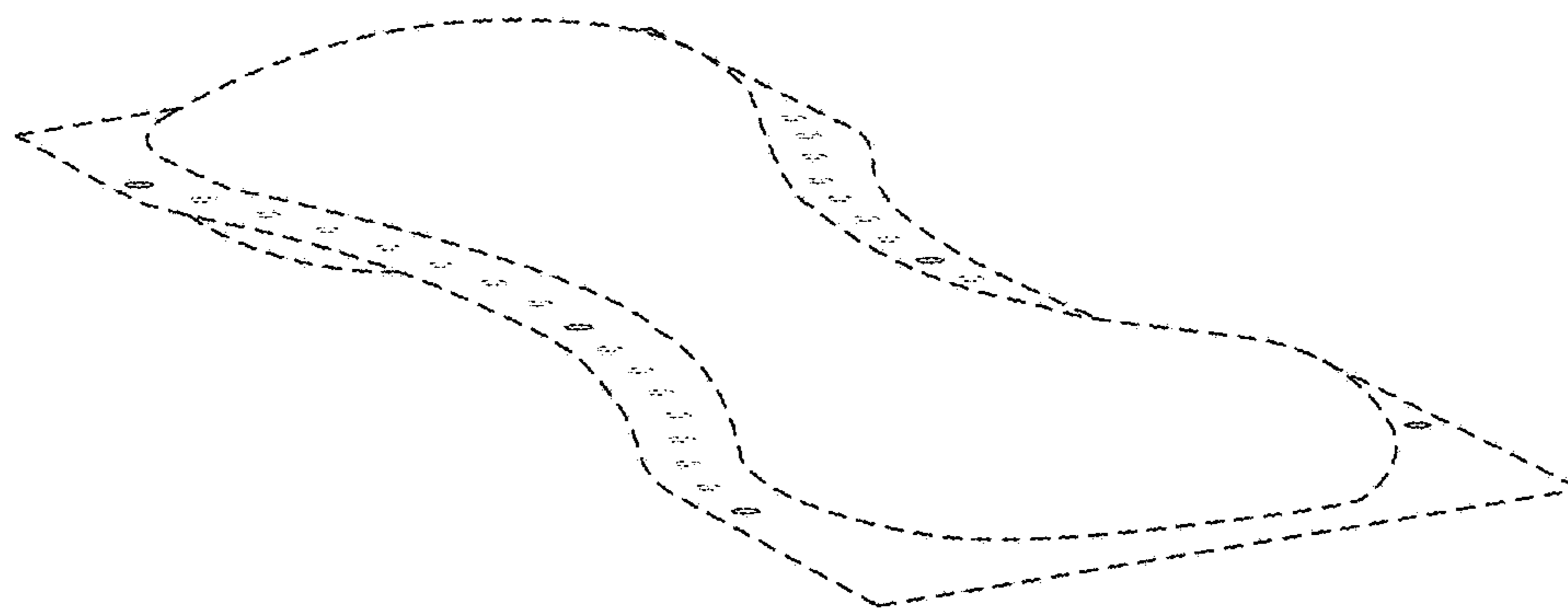

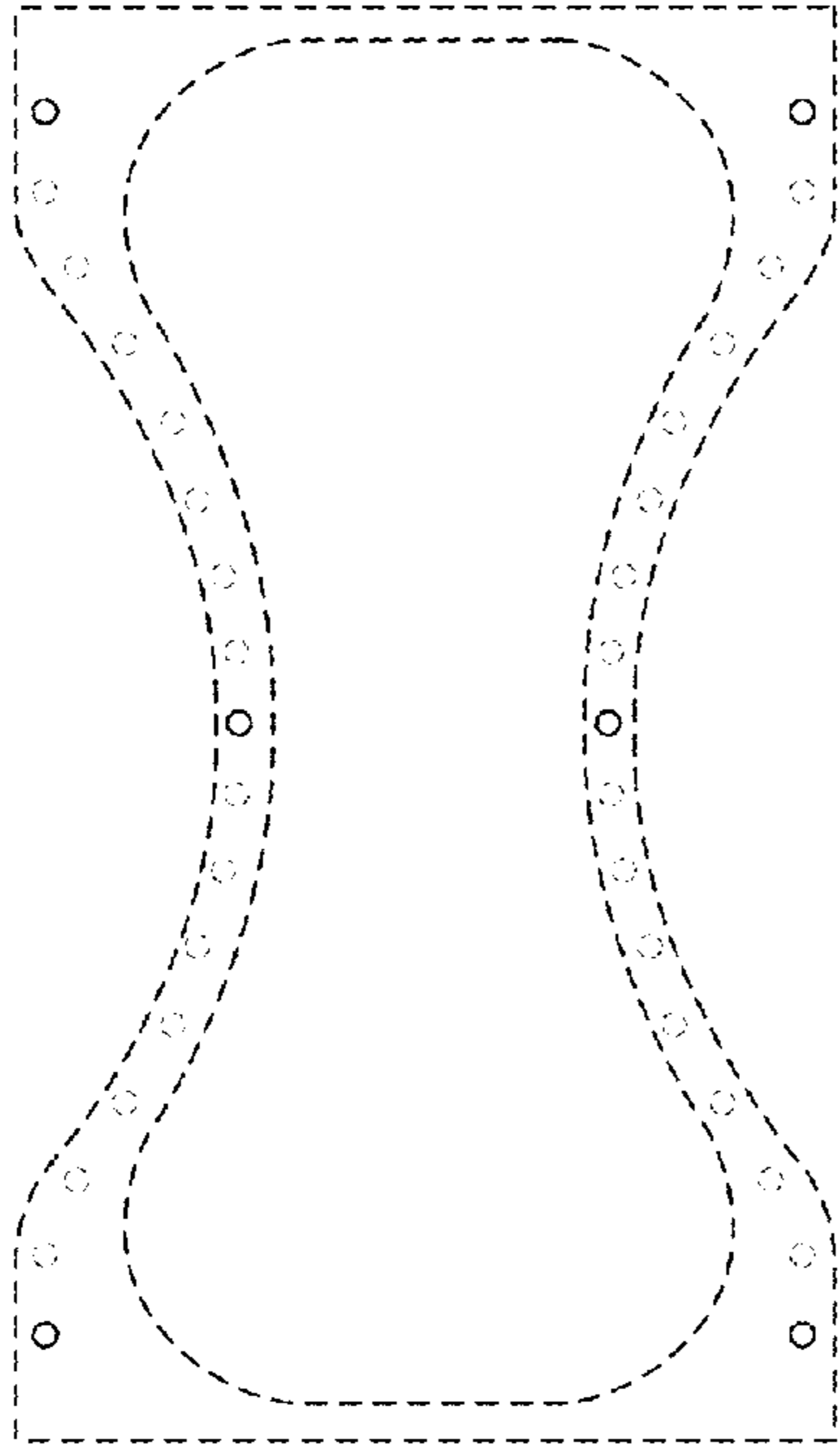

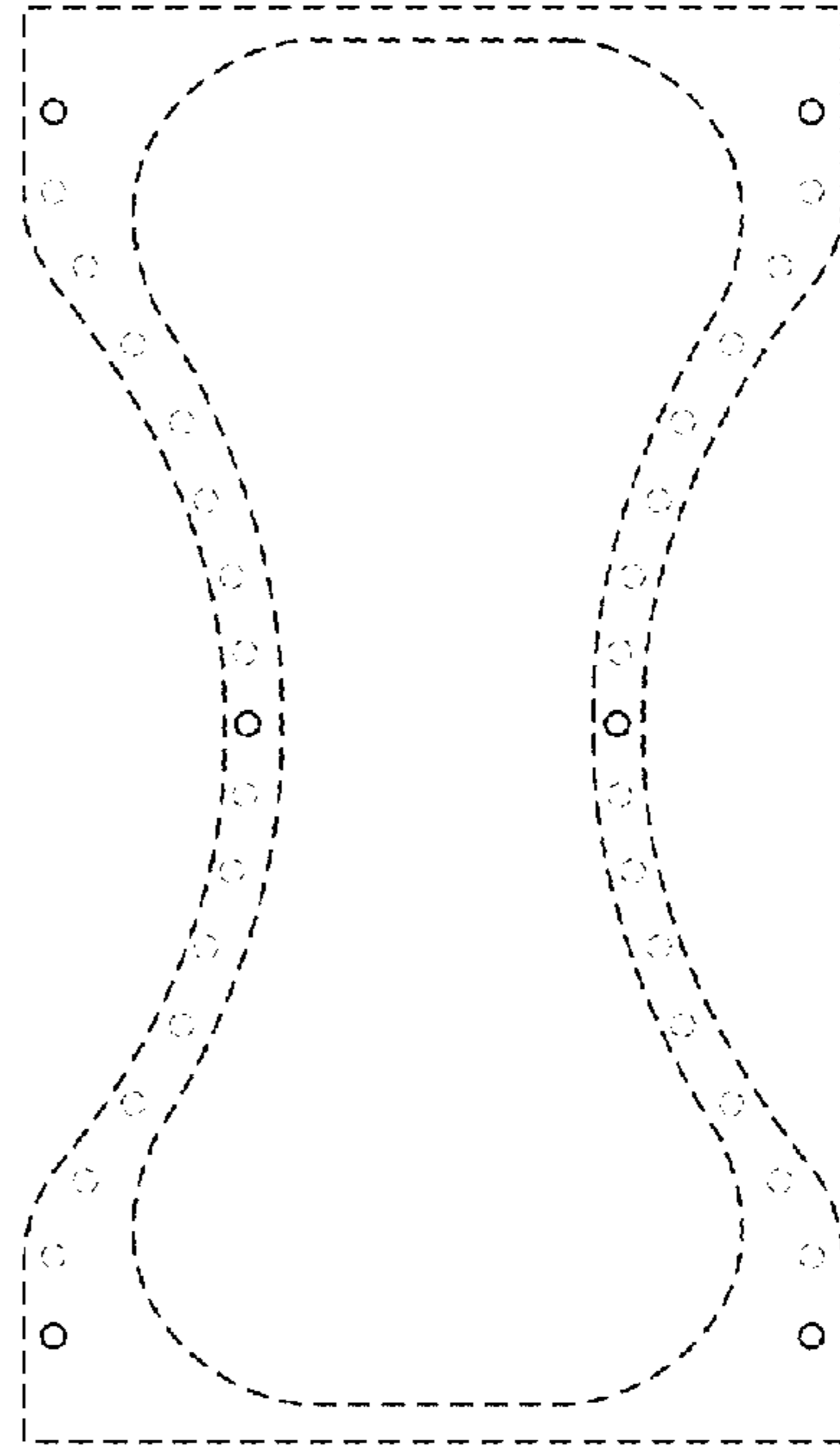

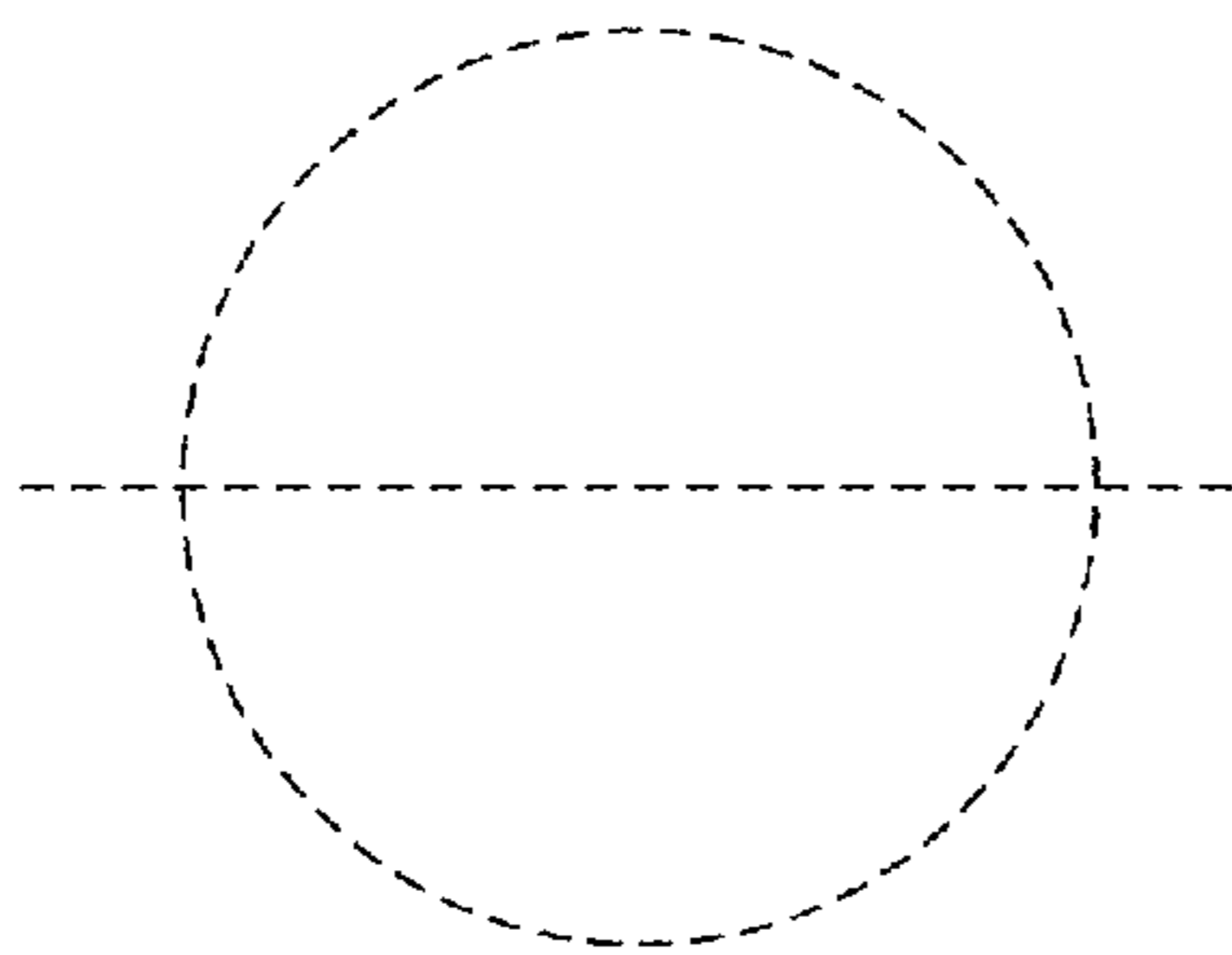

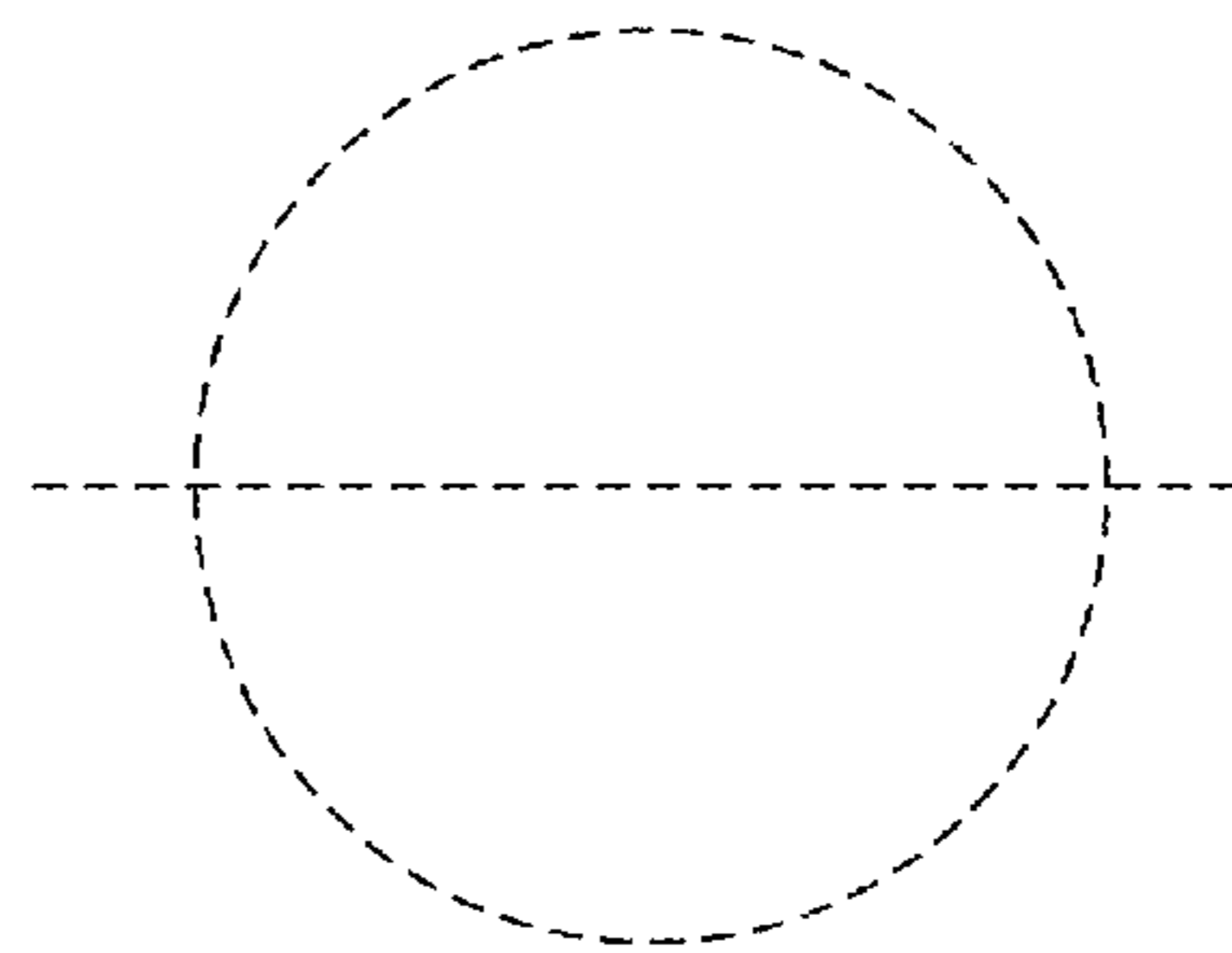

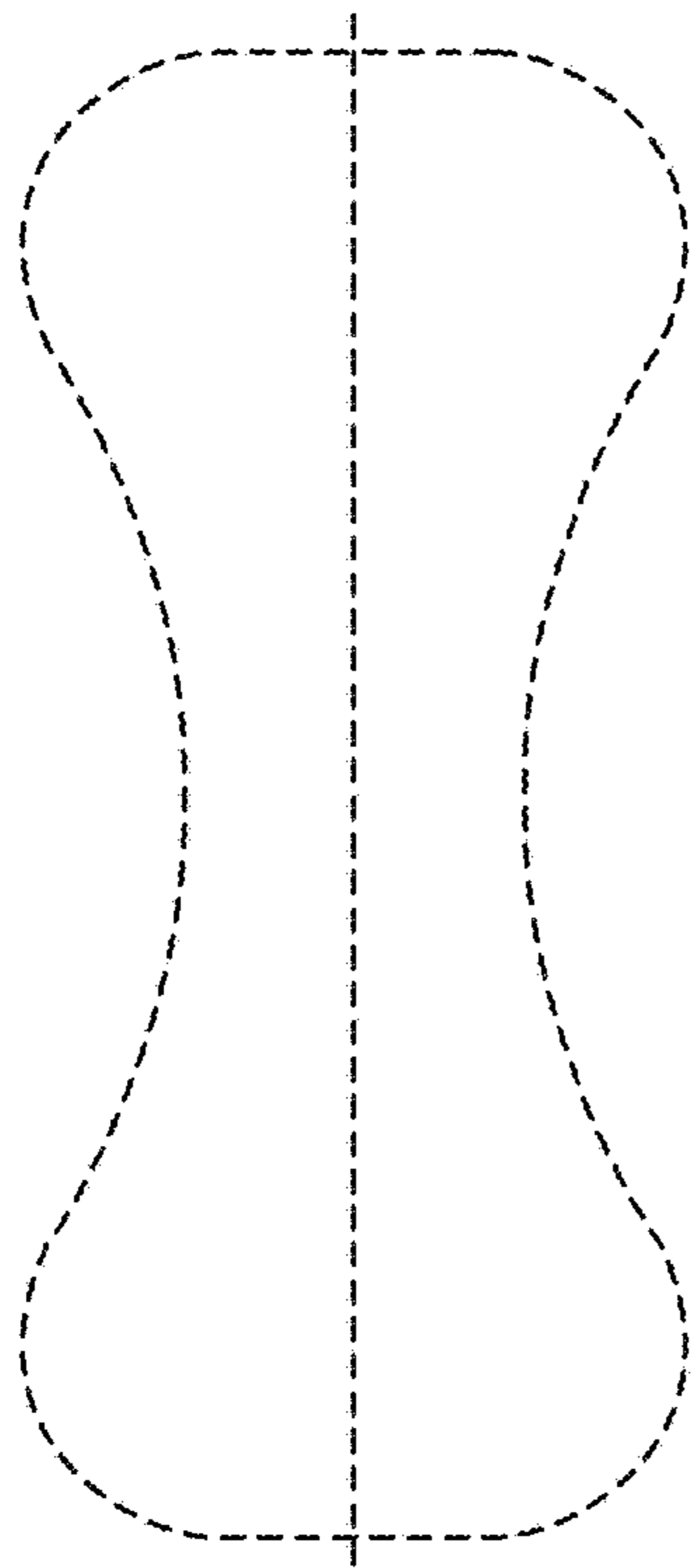

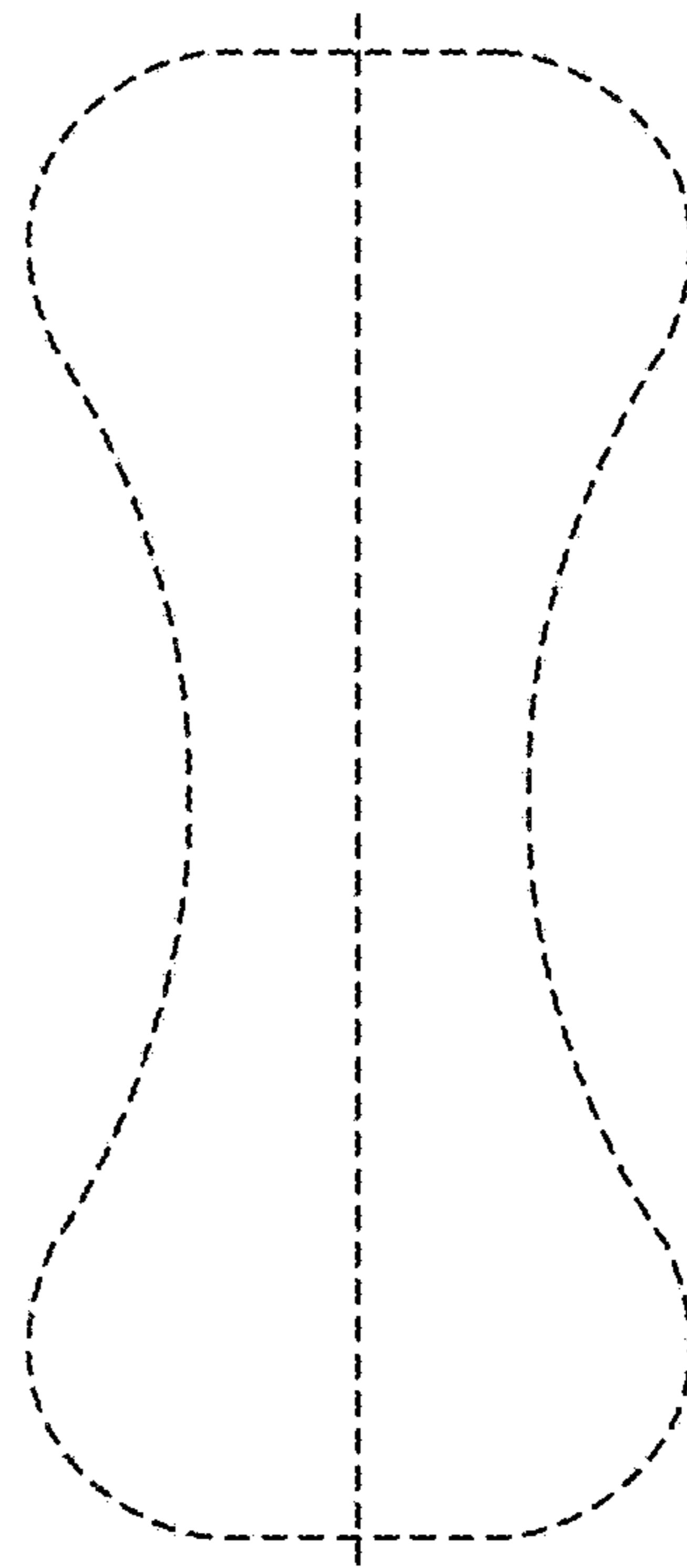

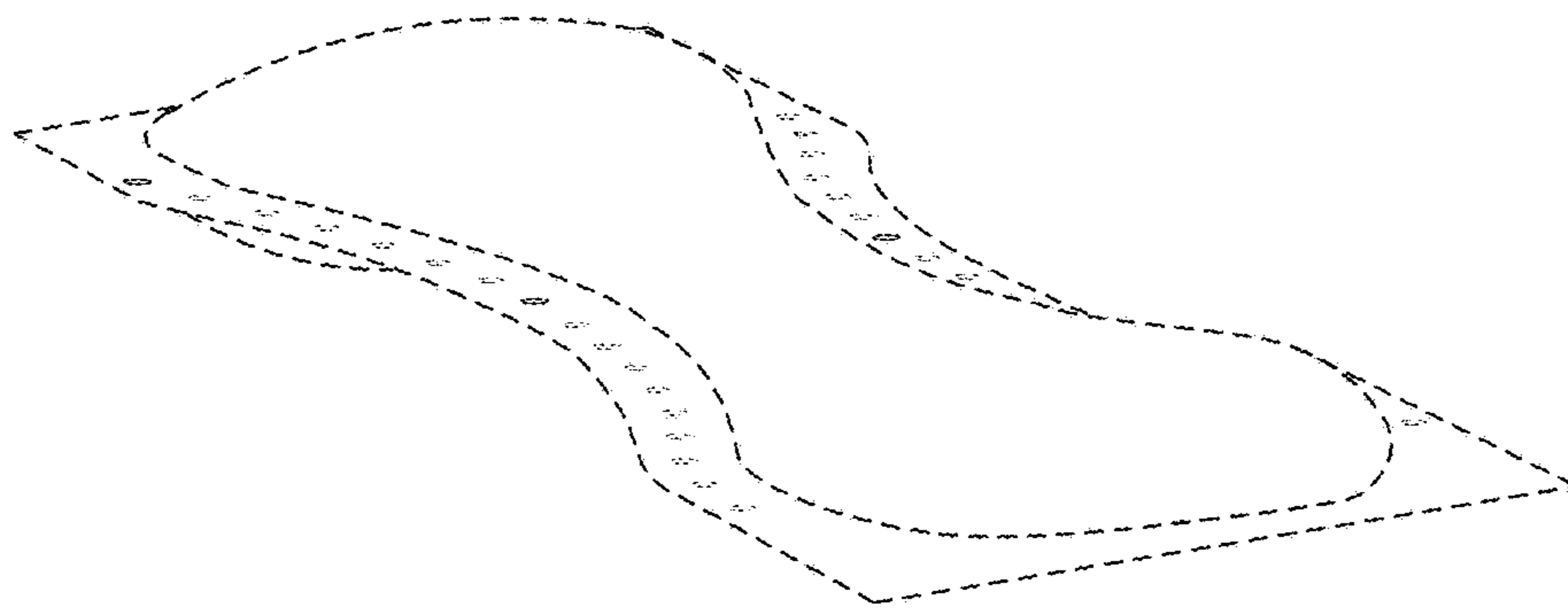

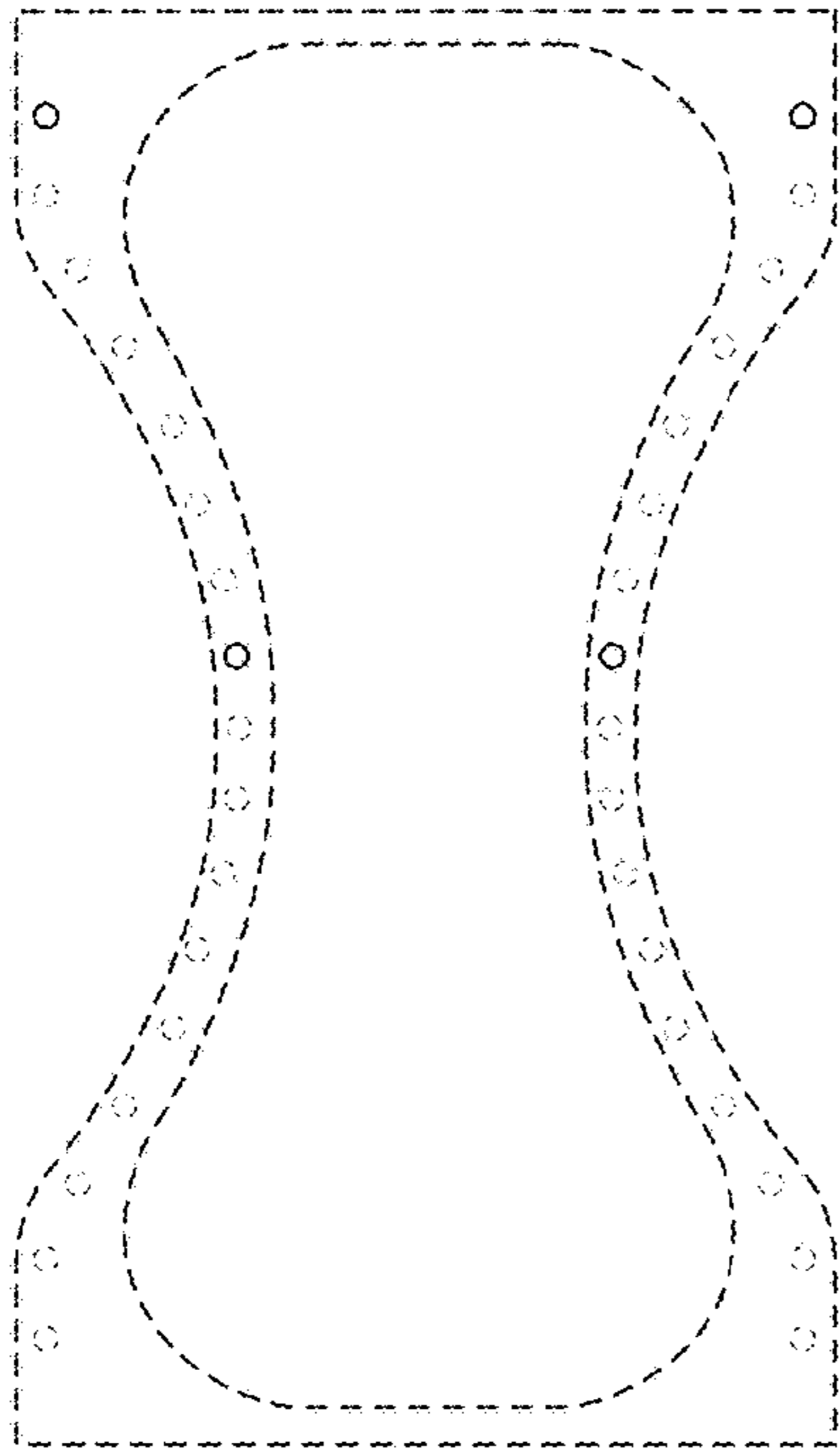

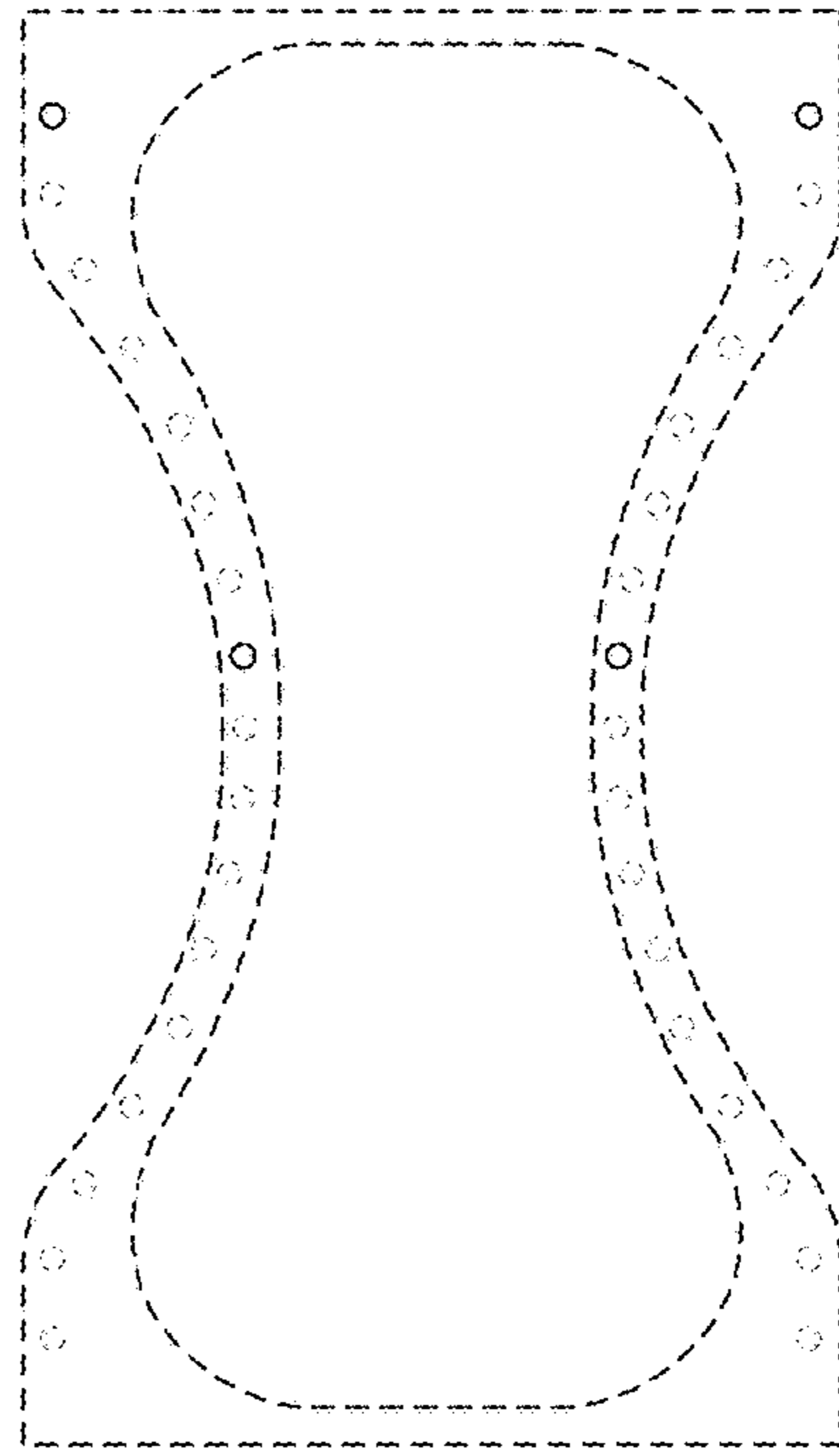

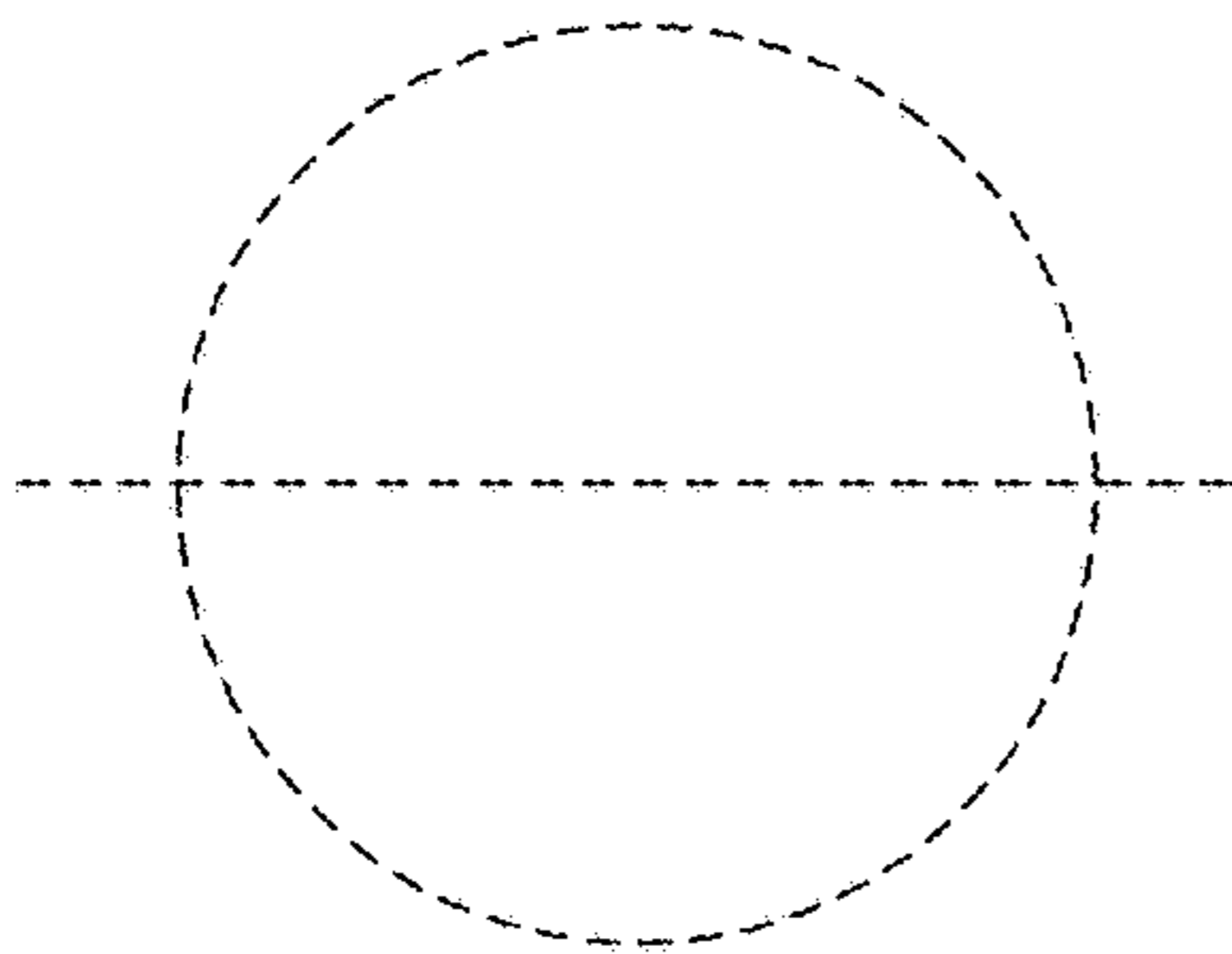

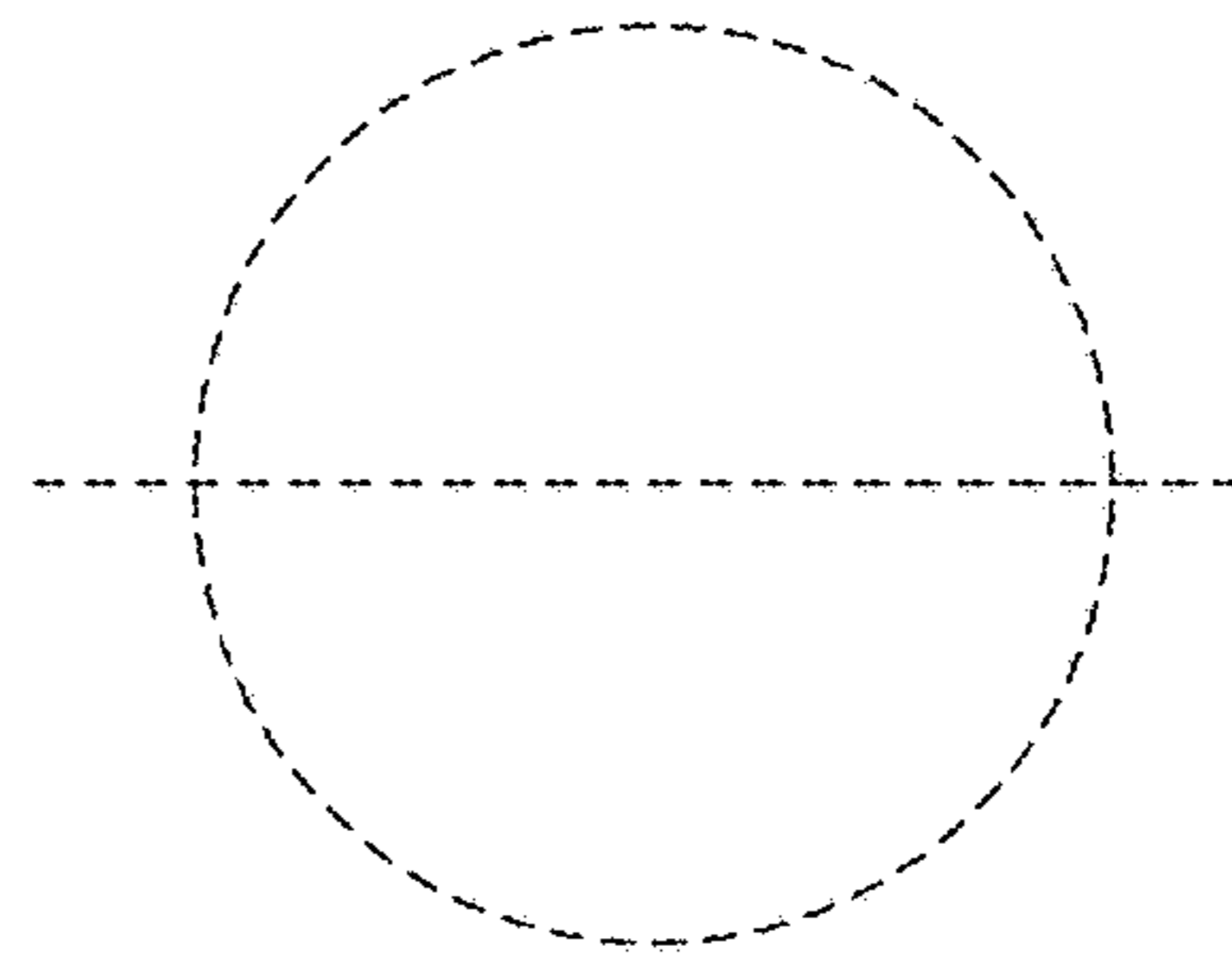

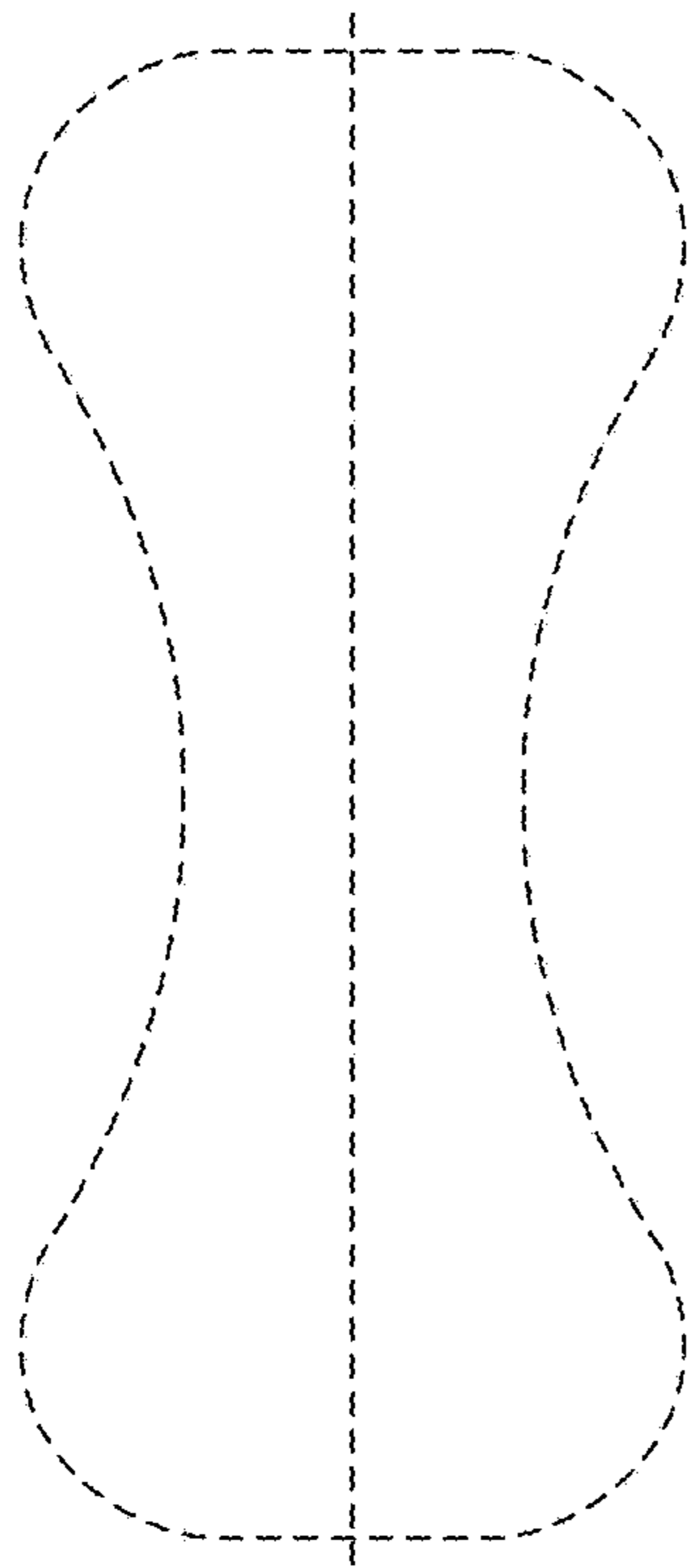

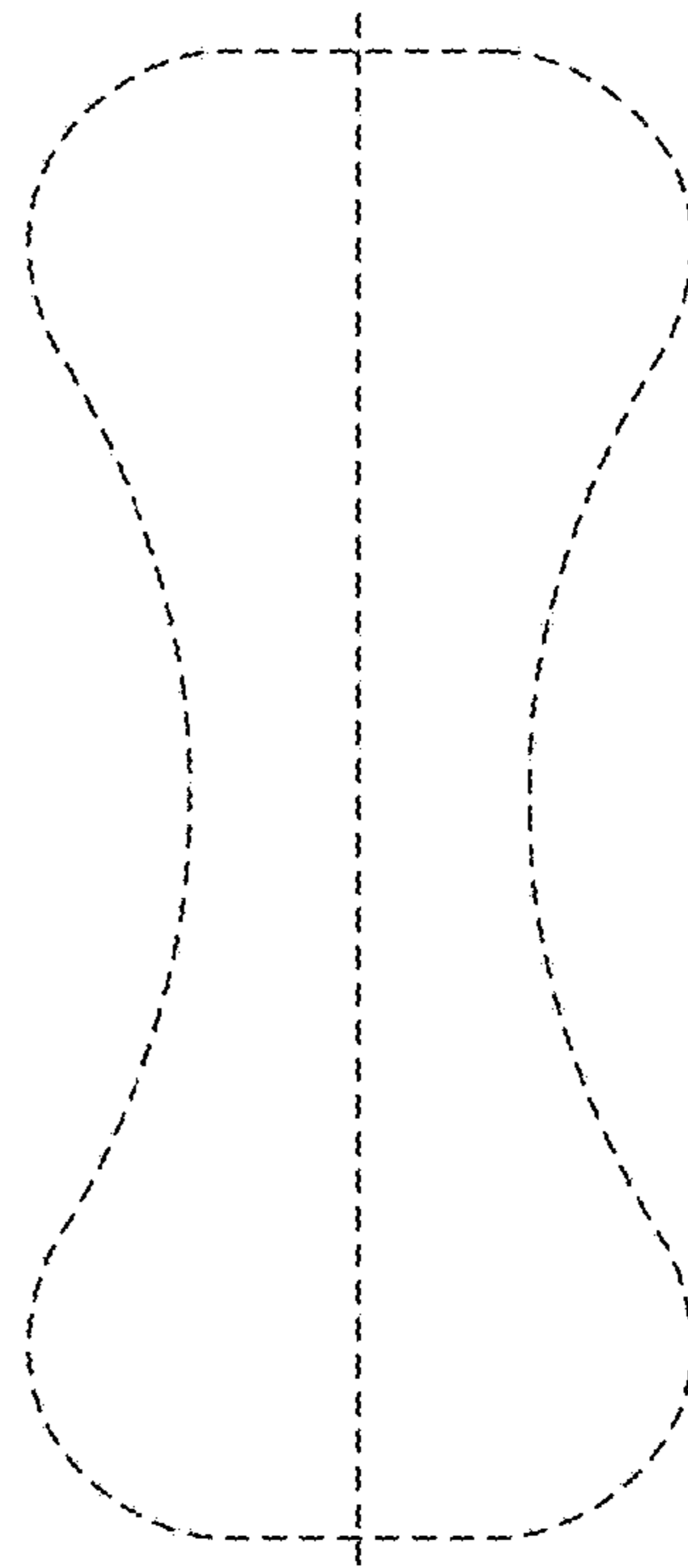

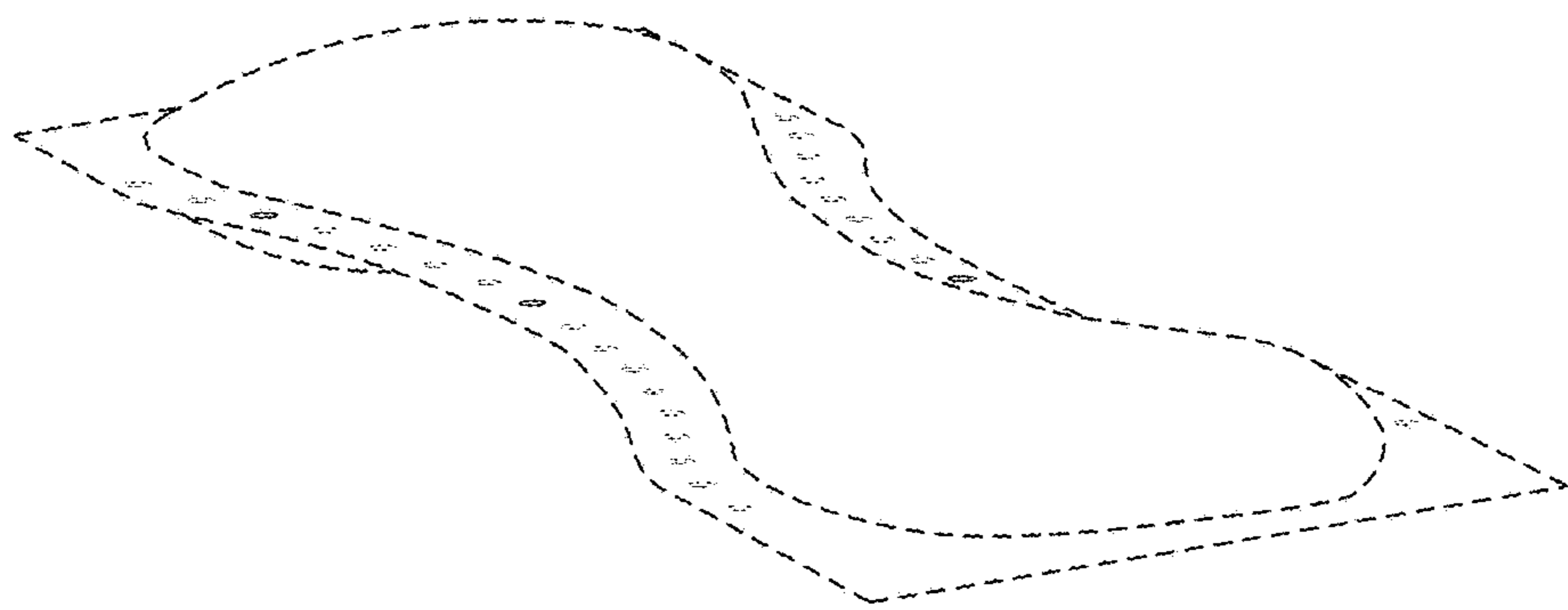

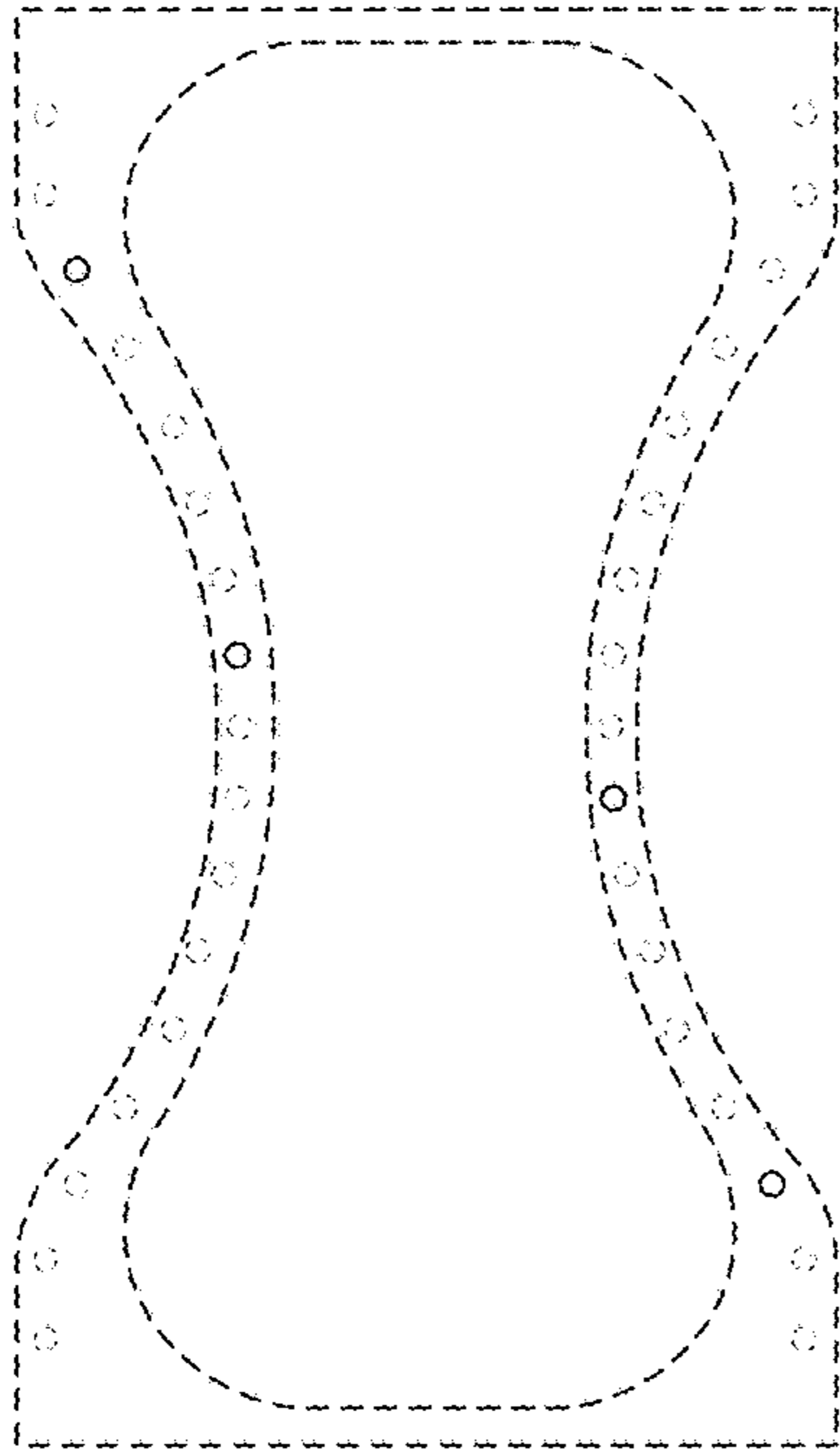

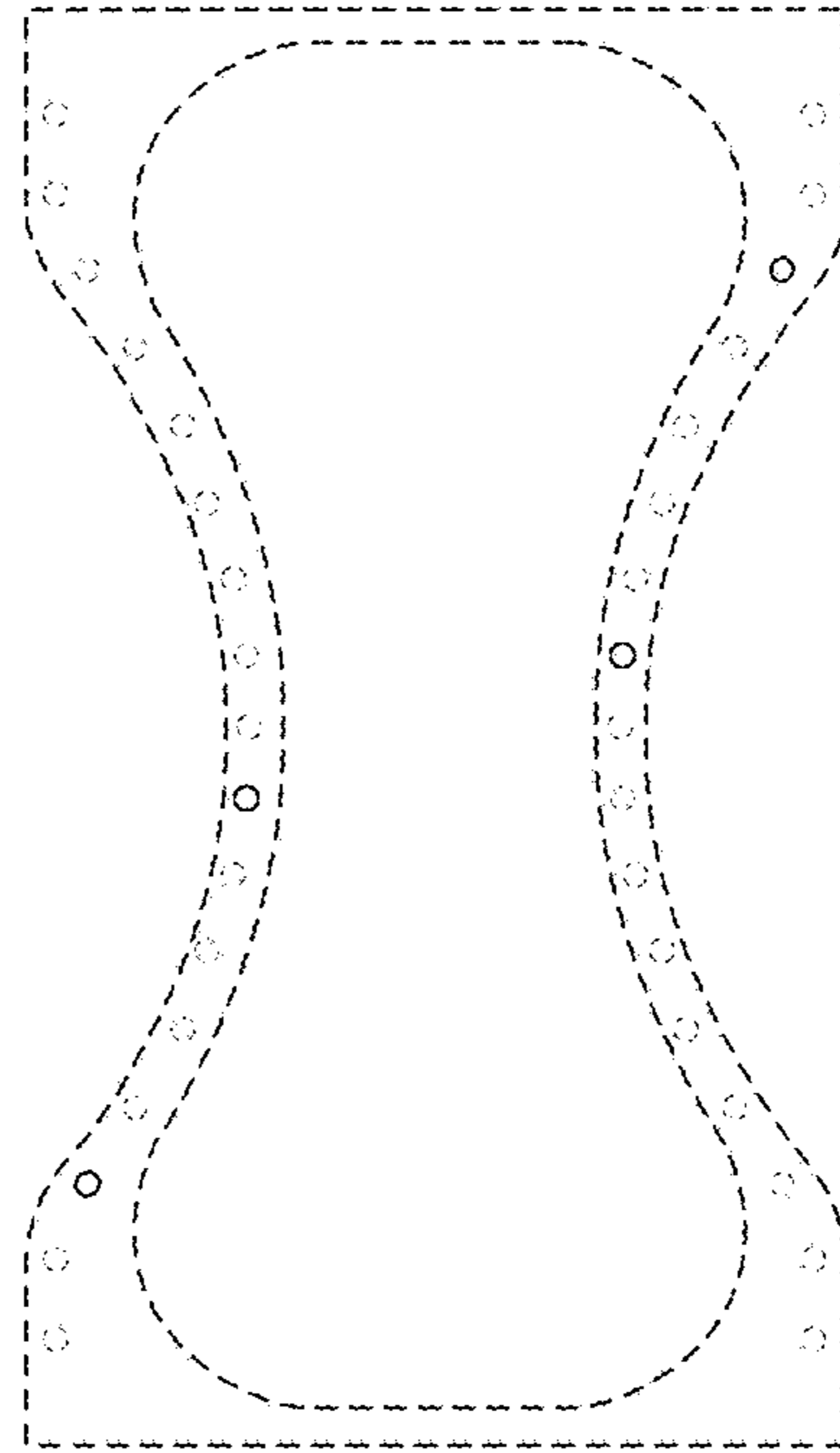

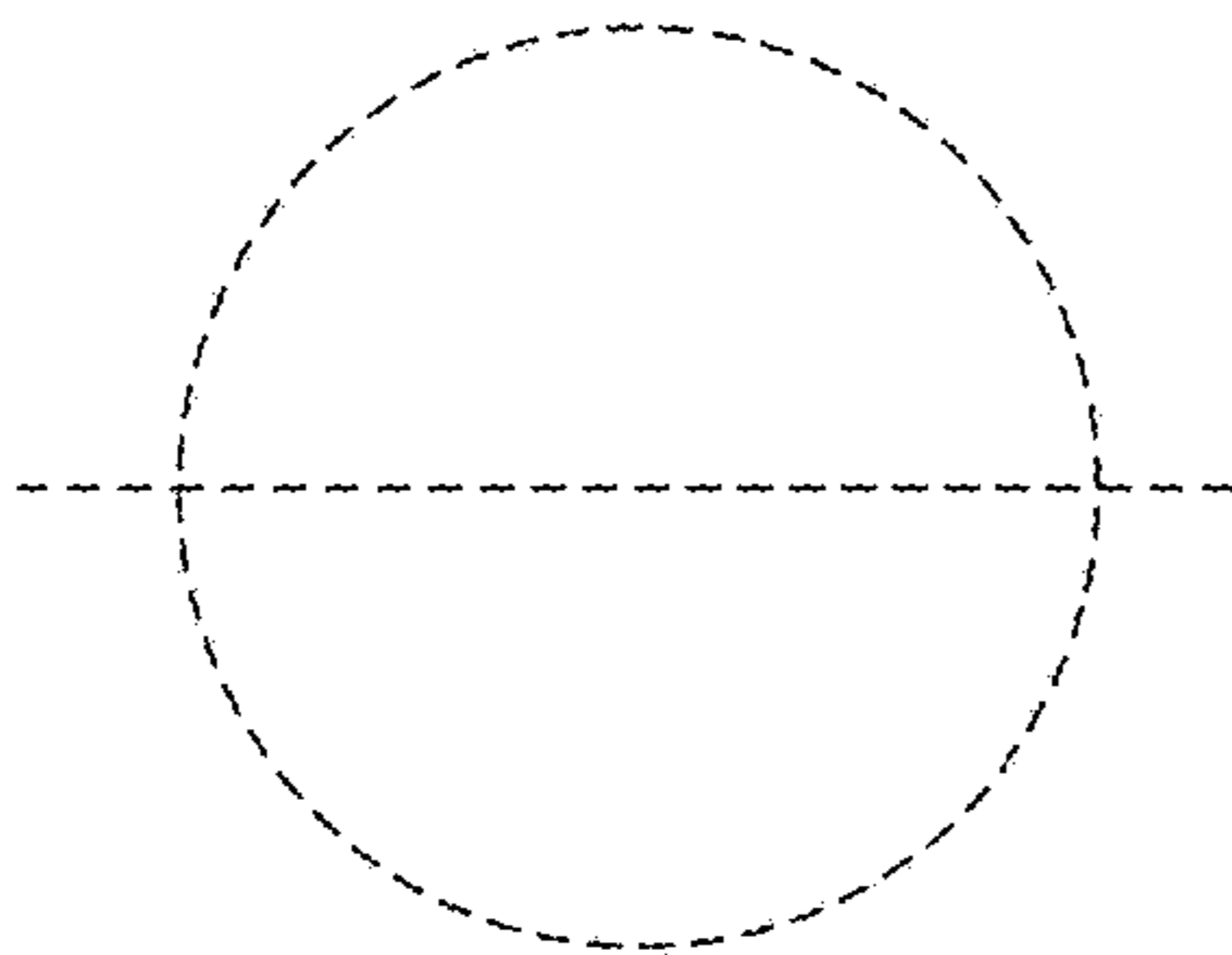

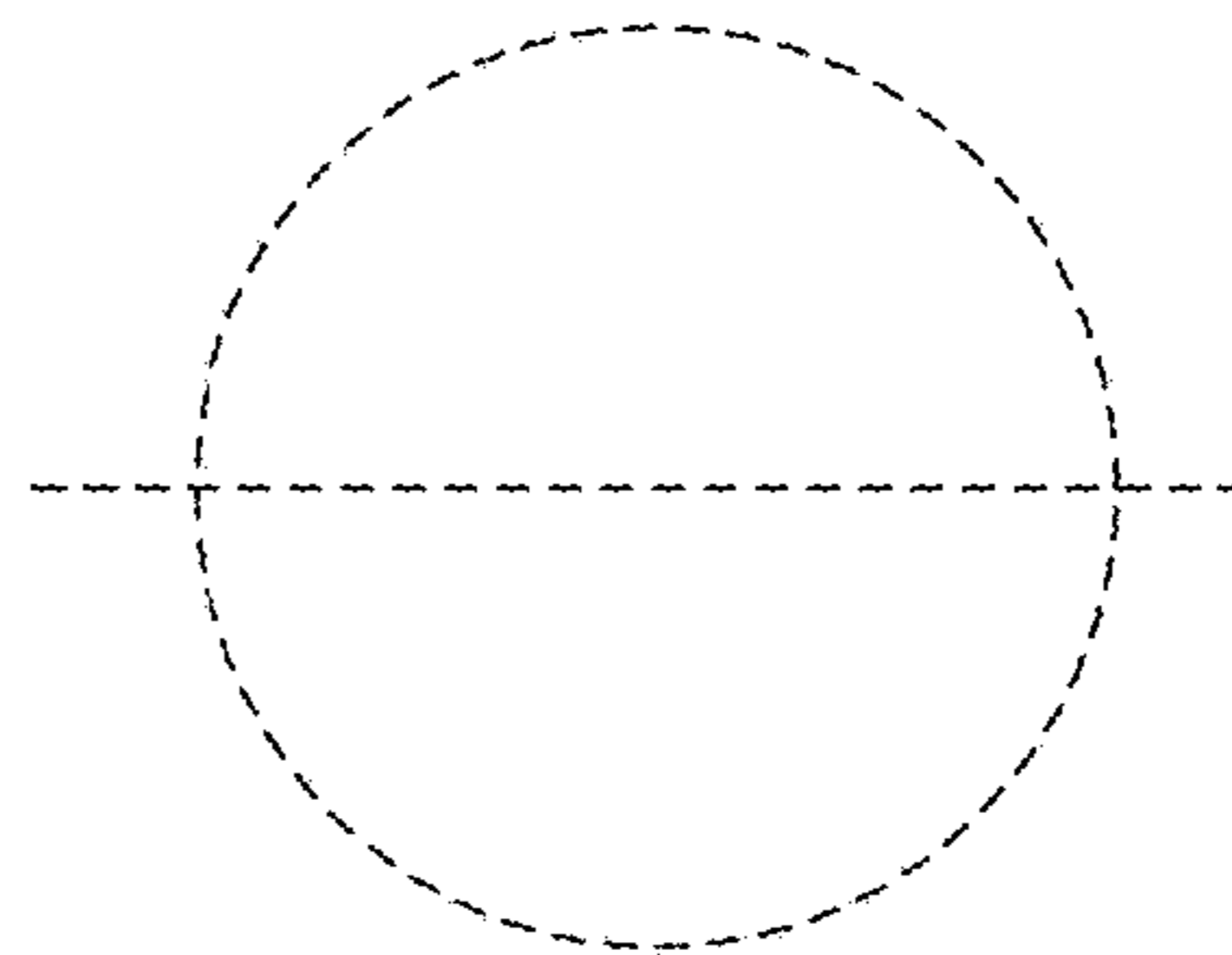

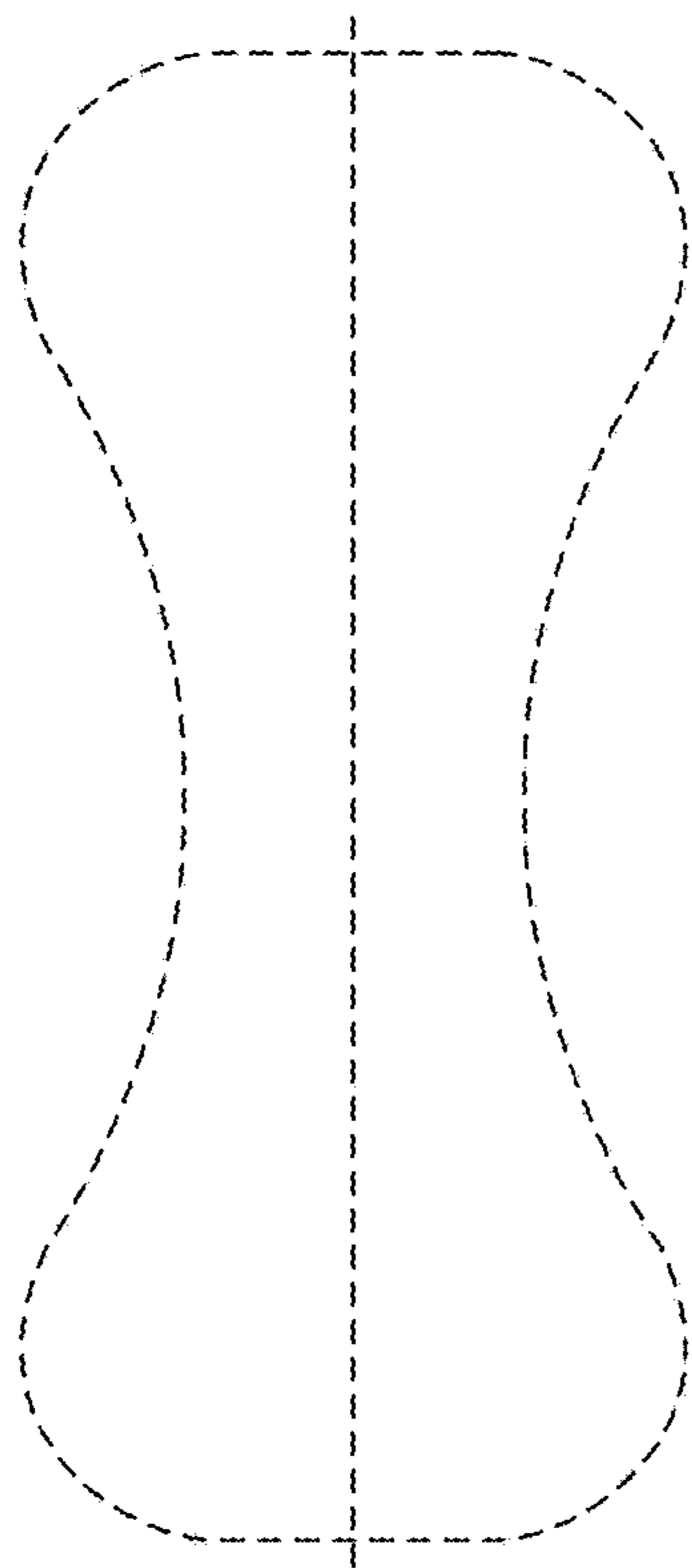

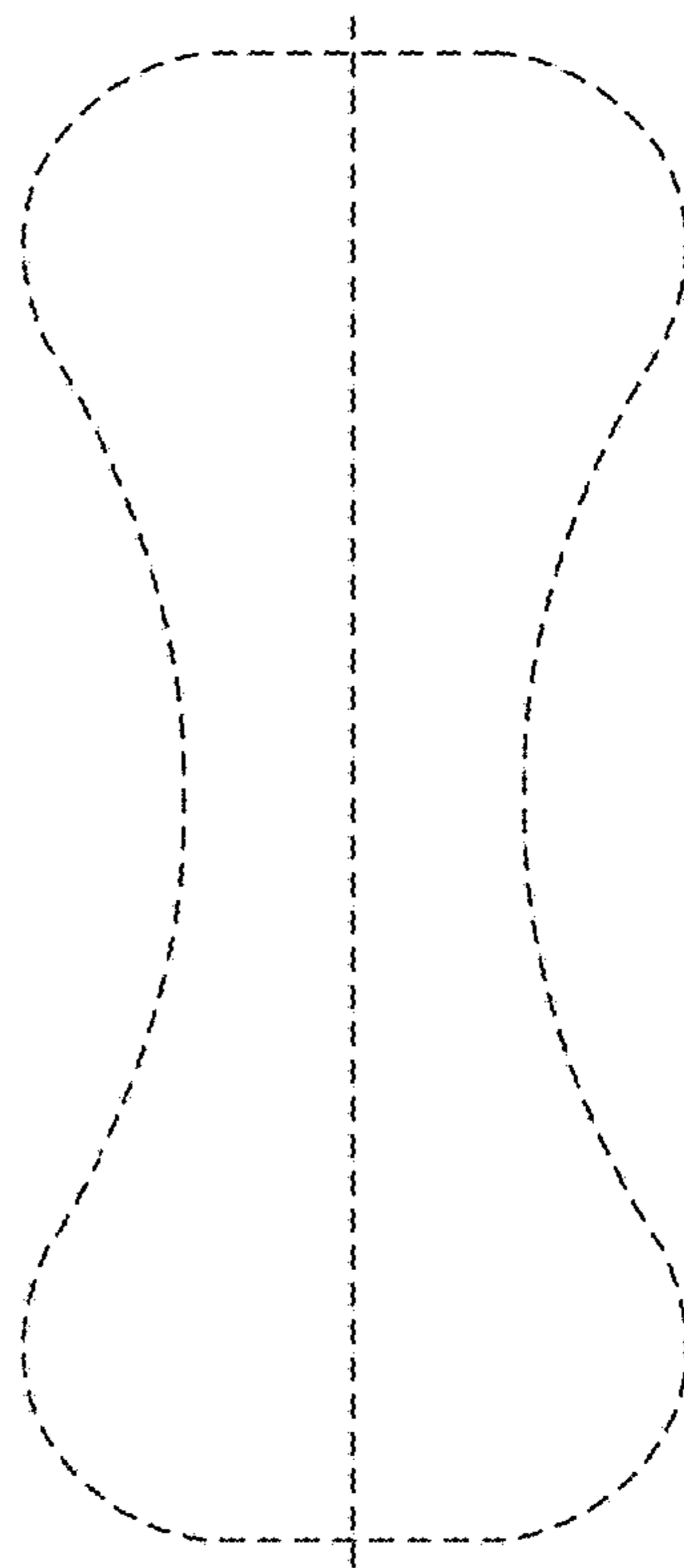
