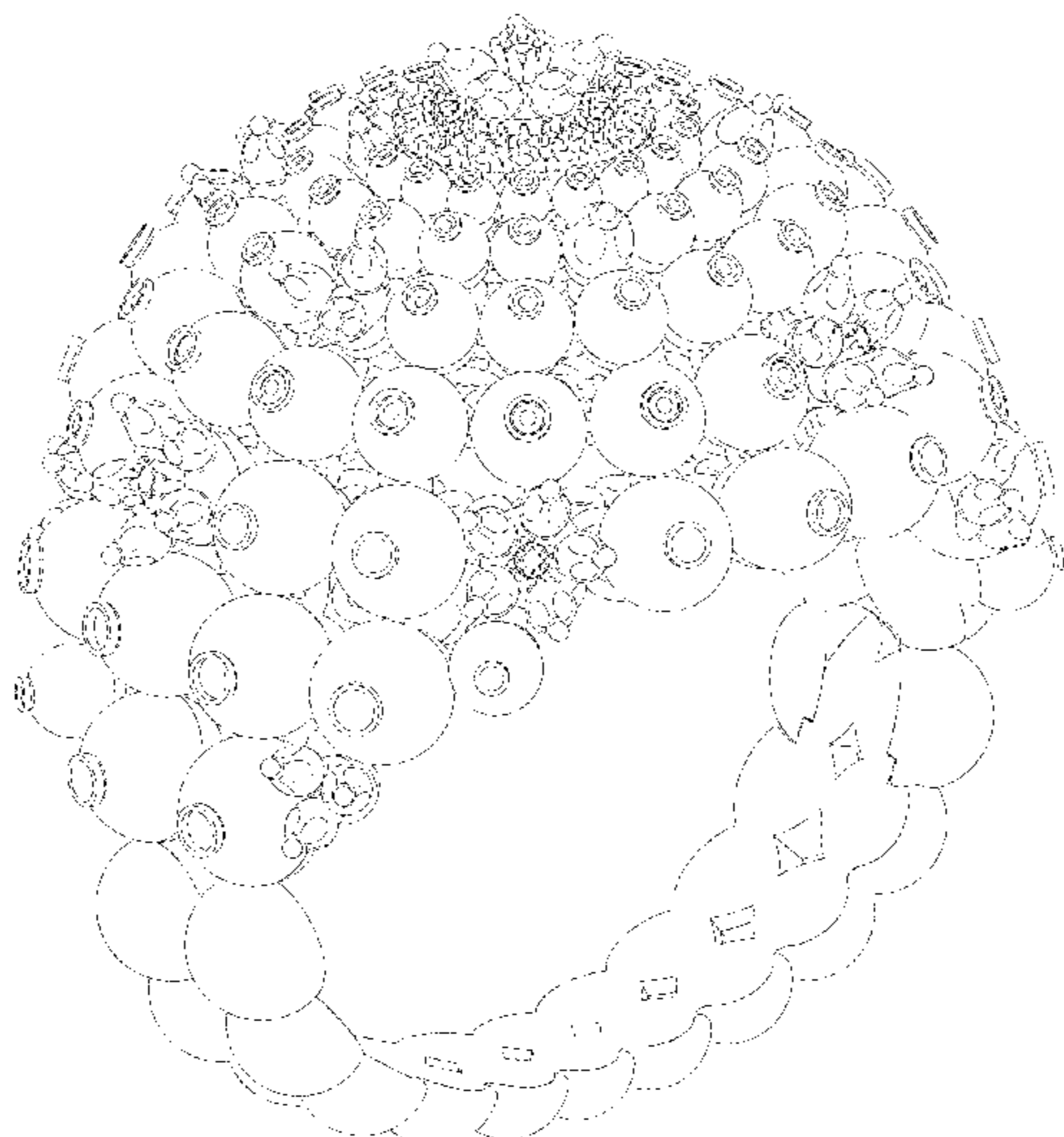
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front side view of a bracelet of the present invention.
FIG. 2 is a back side view of the bracelet of FIG. 1.
FIG. 3 is a right side view of the bracelet of FIG. 1.
FIG. 4 is a left side view of the bracelet of FIG. 1.
FIG. 5 is a top side view of the bracelet of FIG. 1.
FIG. 6 is a bottom side view of the bracelet of FIG. 1.
FIG. 7 is a front, left side perspective view of the bracelet of FIG. 1; and,
FIG. 8 is a front, right side perspective view of the bracelet of FIG. 1.

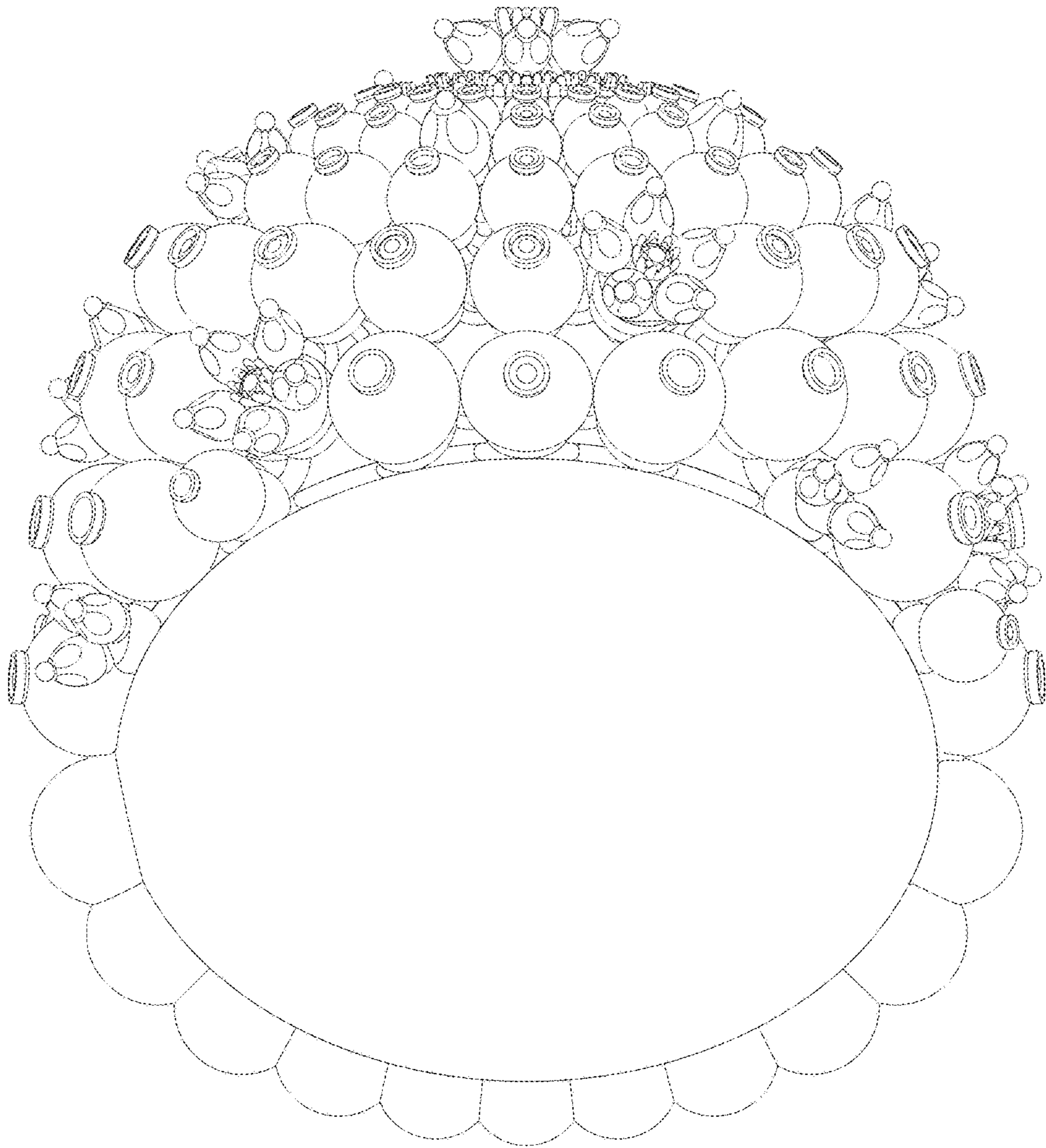

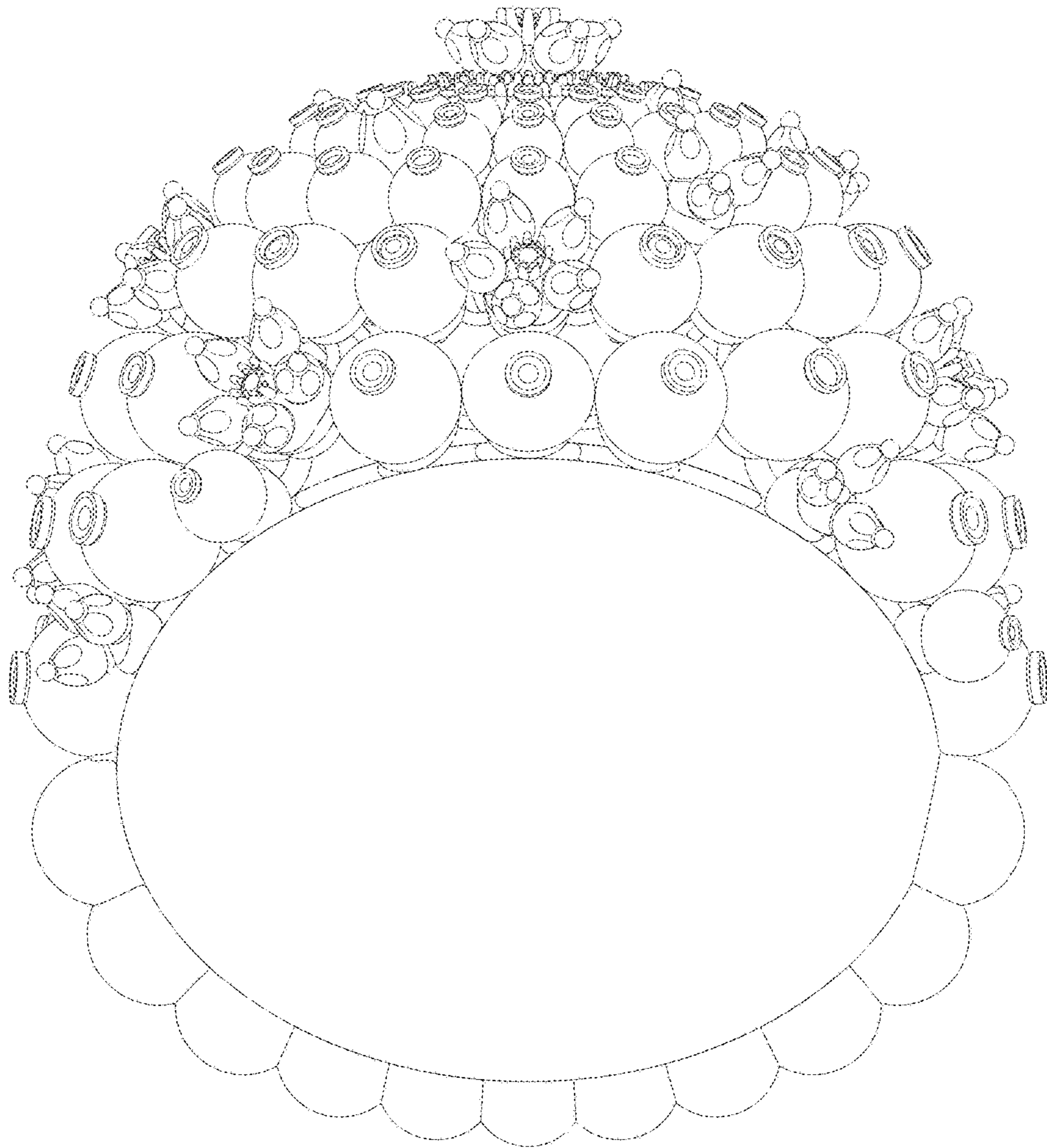

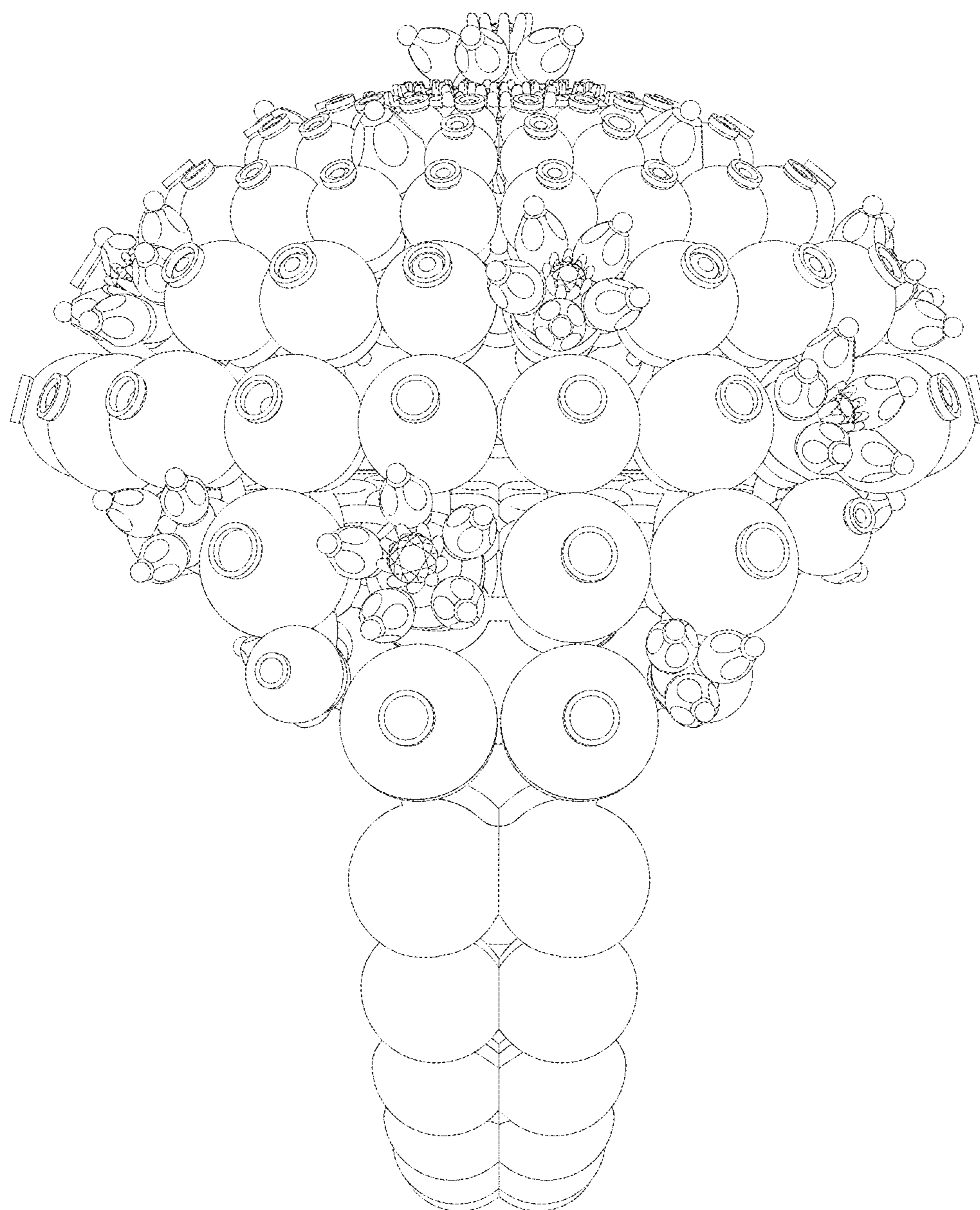

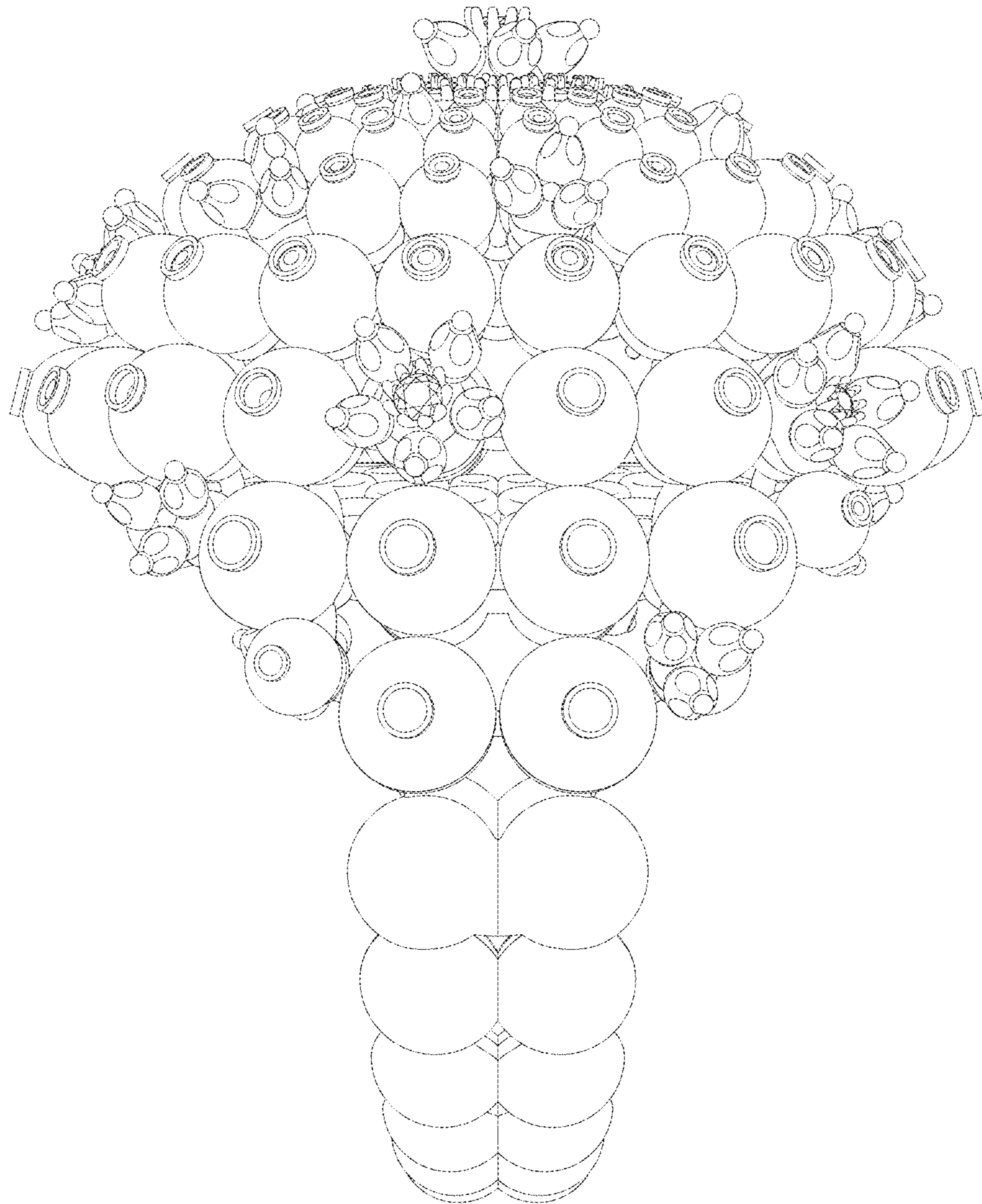

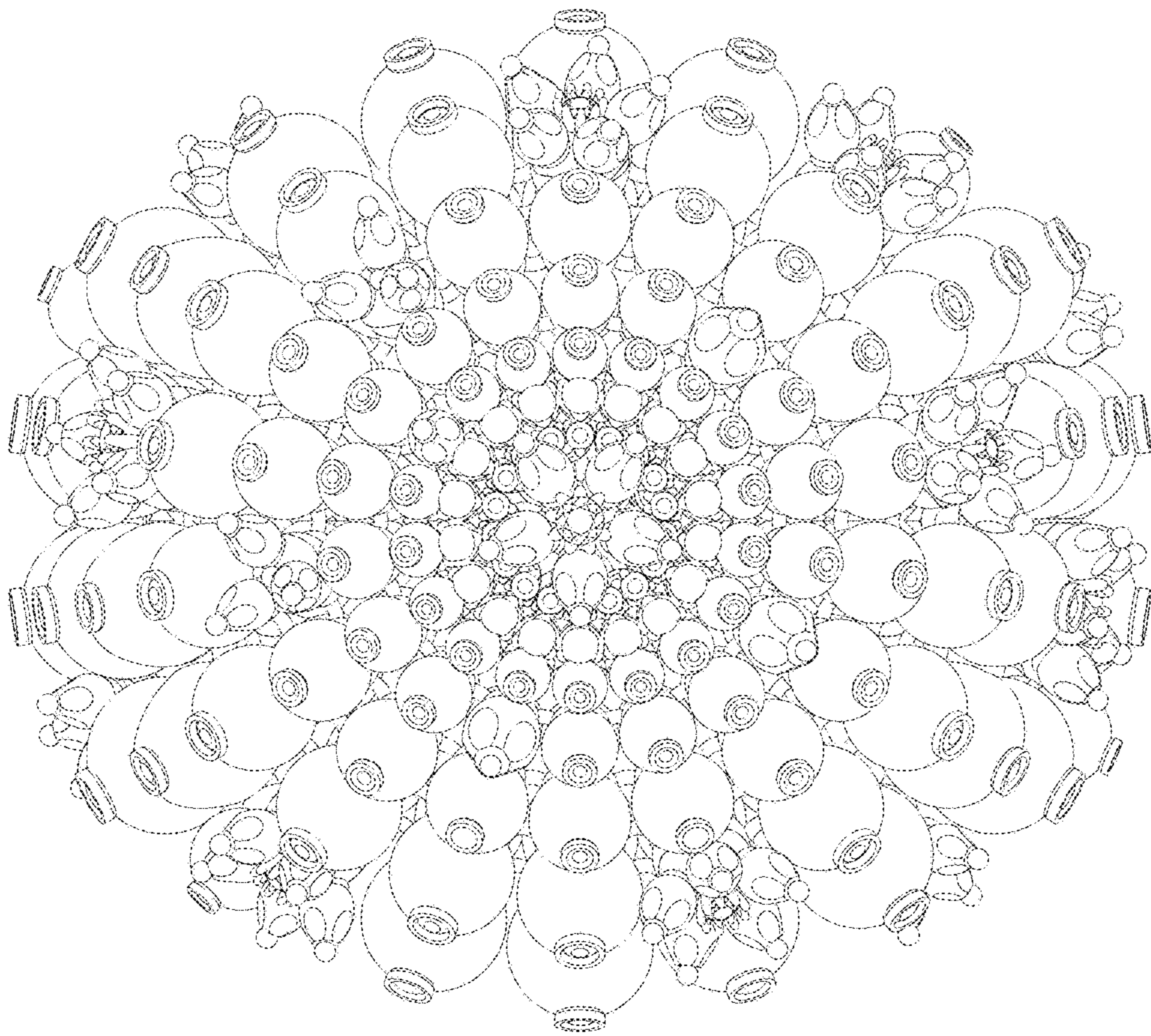

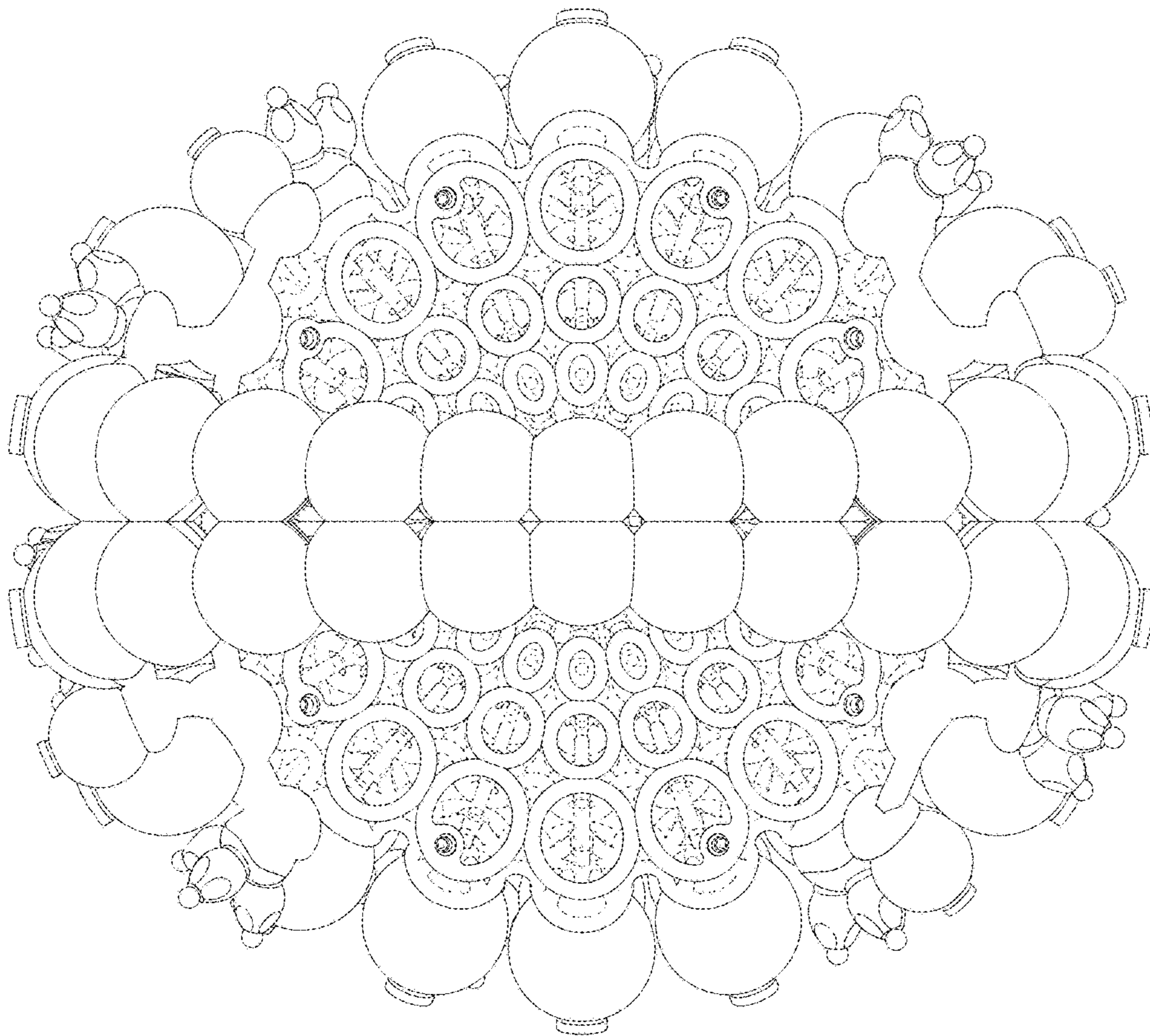

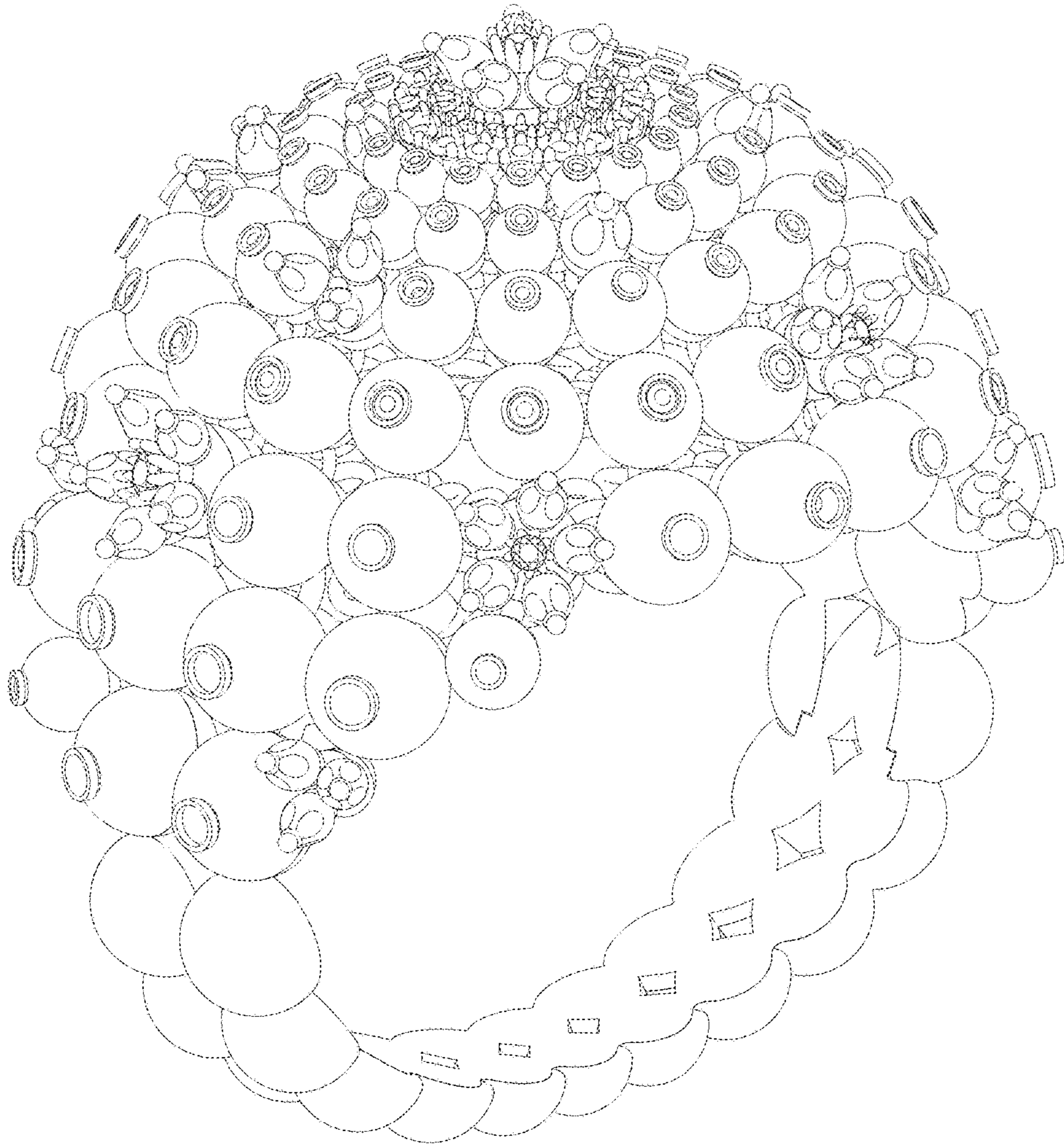

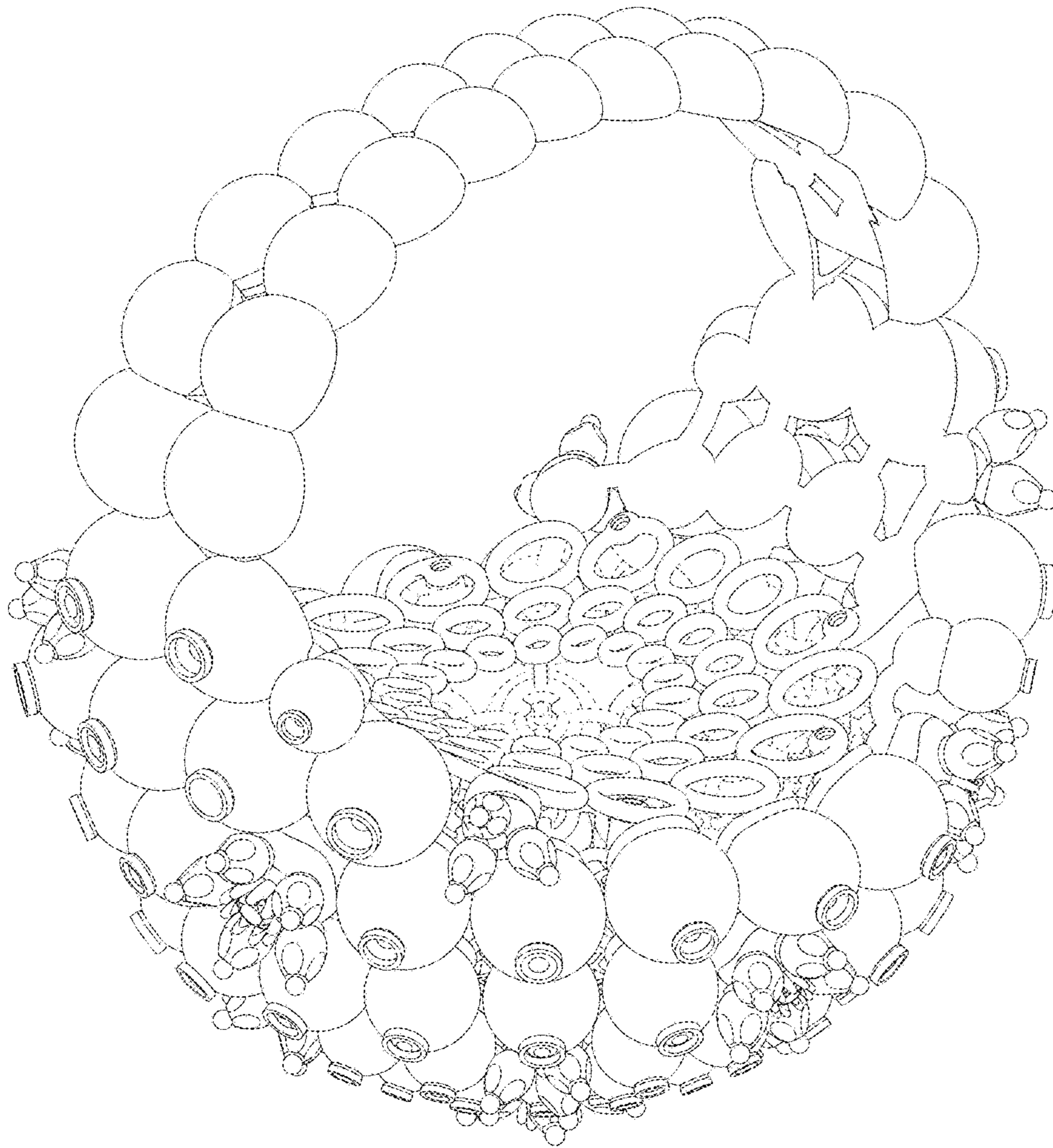
