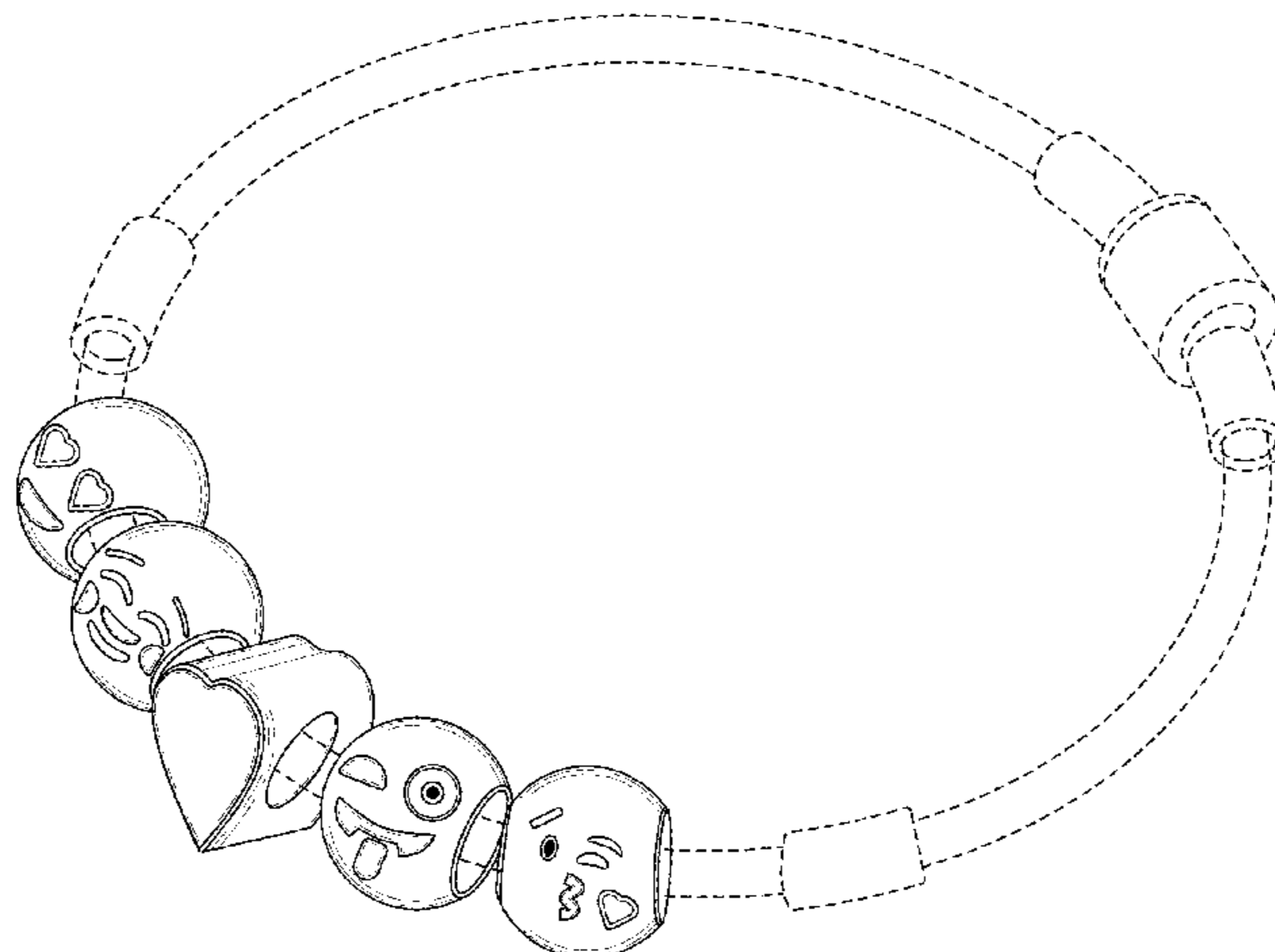
(57) **CLAIM**

The ornamental design for set of charms for a bracelet, as shown and described.

DESCRIPTION

FIG. 1 is a front-right top perspective view of a set of charms for a bracelet, showing my new design; FIG. 2 is a front elevational view of FIG. 1 thereof; FIG. 3 is a rear elevational view of FIG. 1 thereof; FIG. 4 is a left elevational view of FIG. 1 thereof; FIG. 5 is a right elevational view of FIG. 1 thereof; FIG. 6 is a top plan view of FIG. 1 thereof; and, FIG. 7 is a bottom plan view of FIG. 1 thereof. The broken lines showing the bracelet is for purpose of illustrating the environment in which the charms embodying the design may be used. The broken lines form no part of the claimed design.

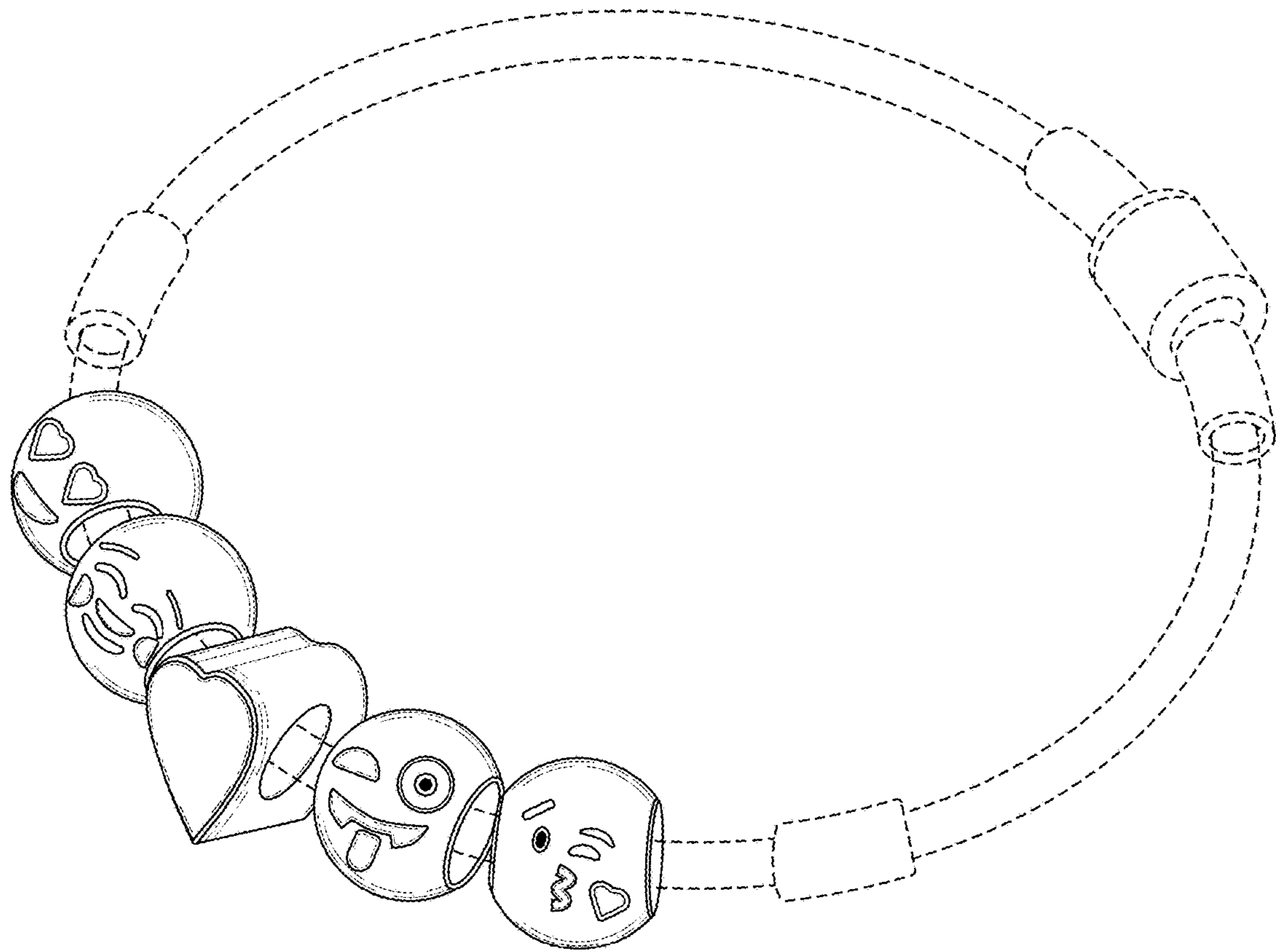

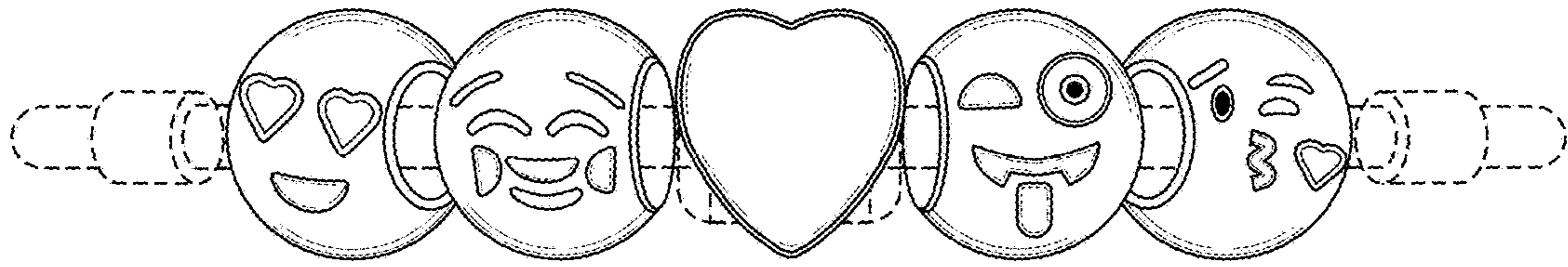

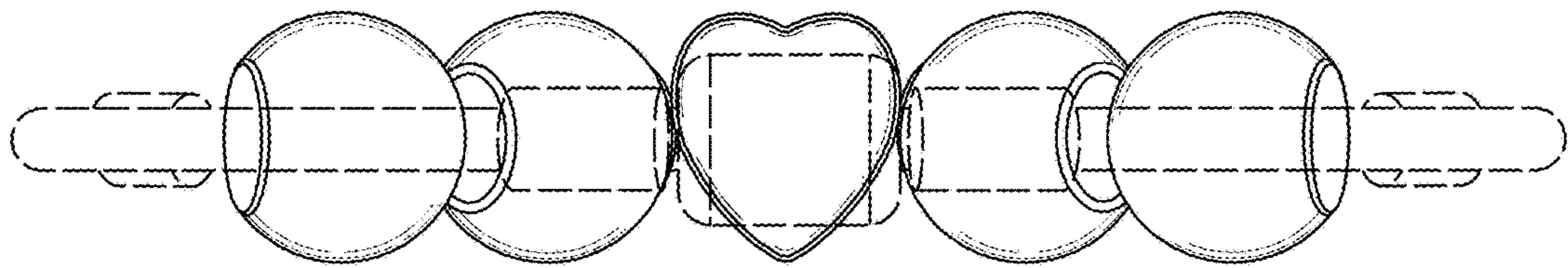

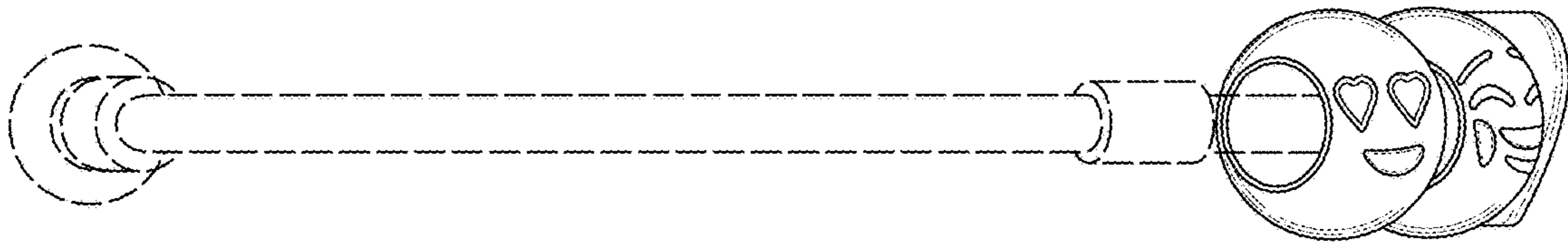

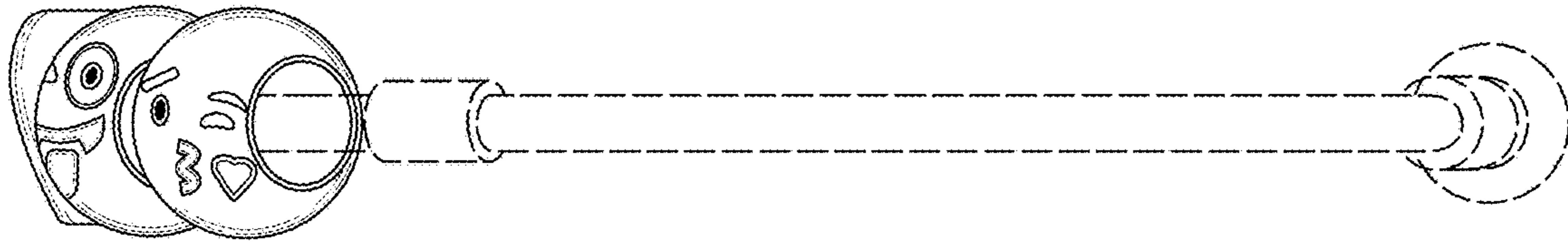

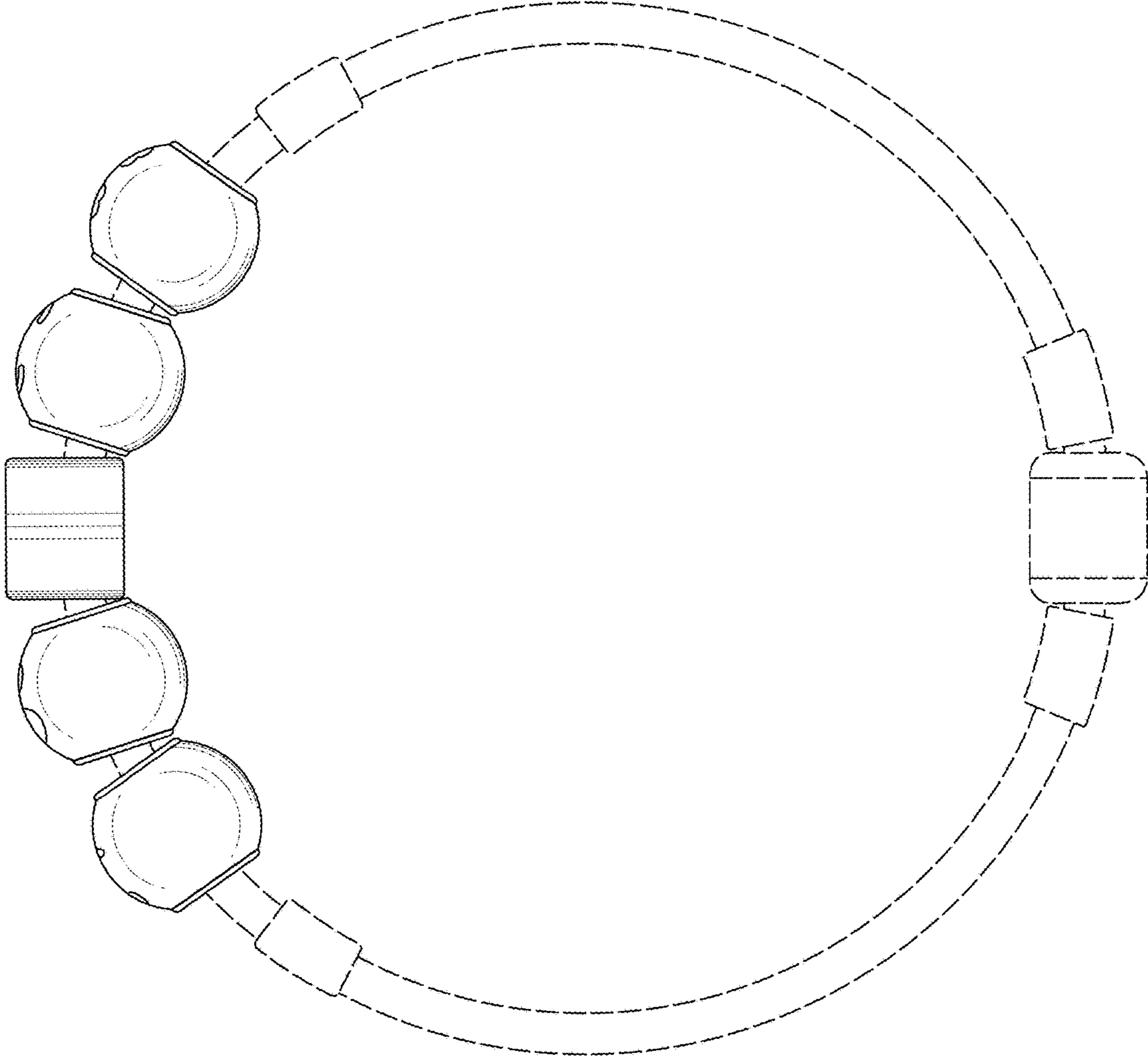

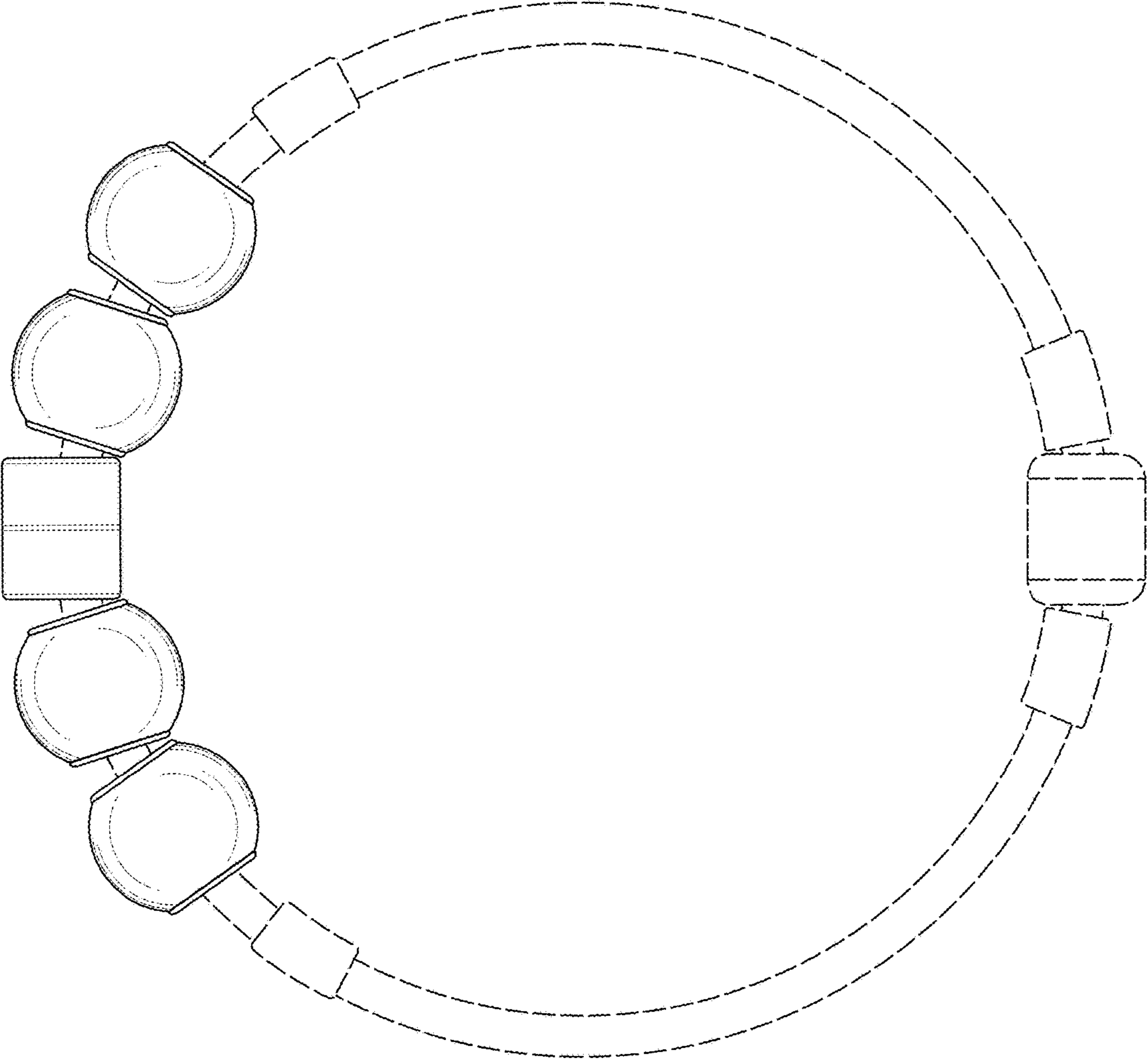
