**DESCRIPTION**

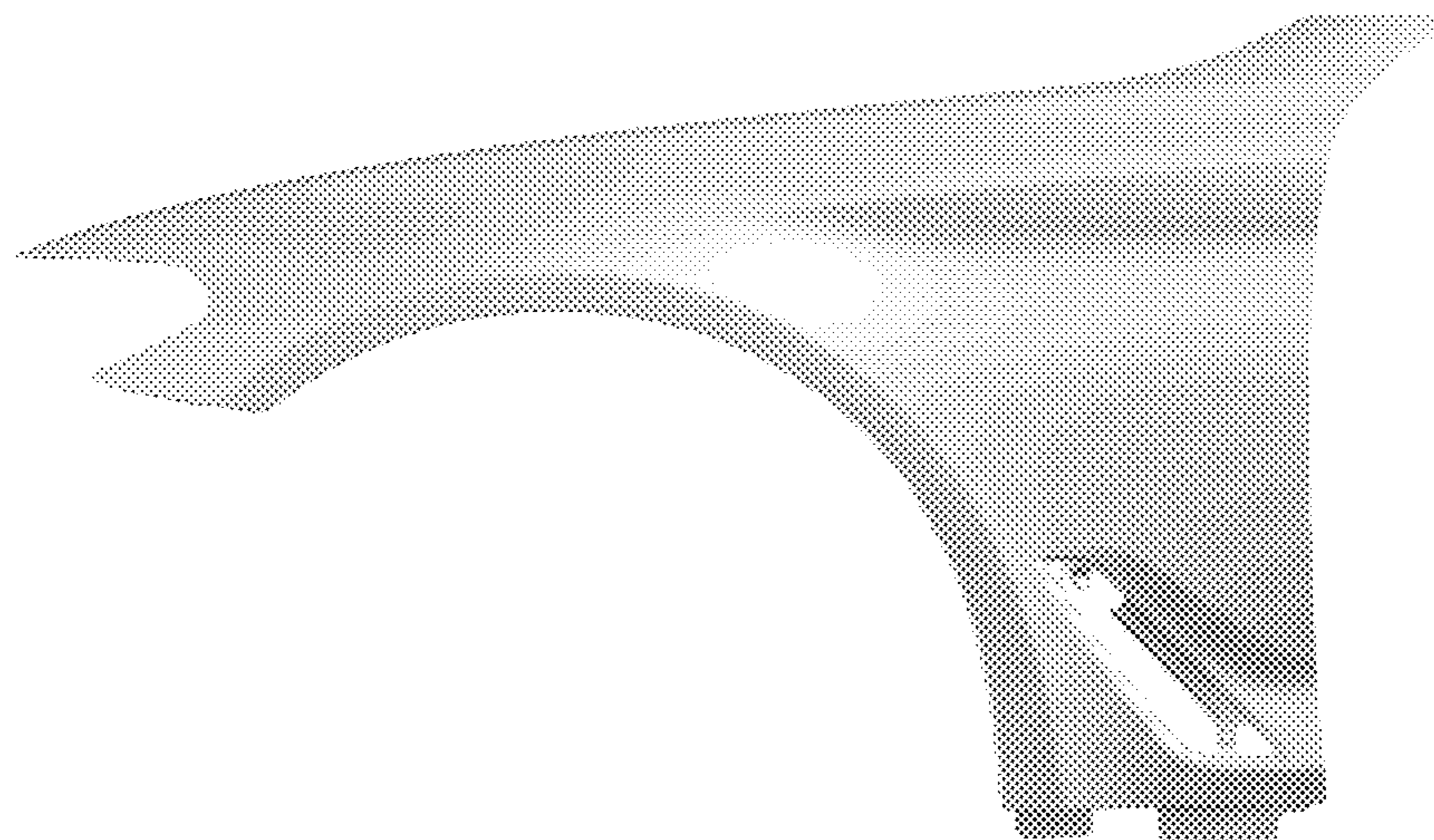

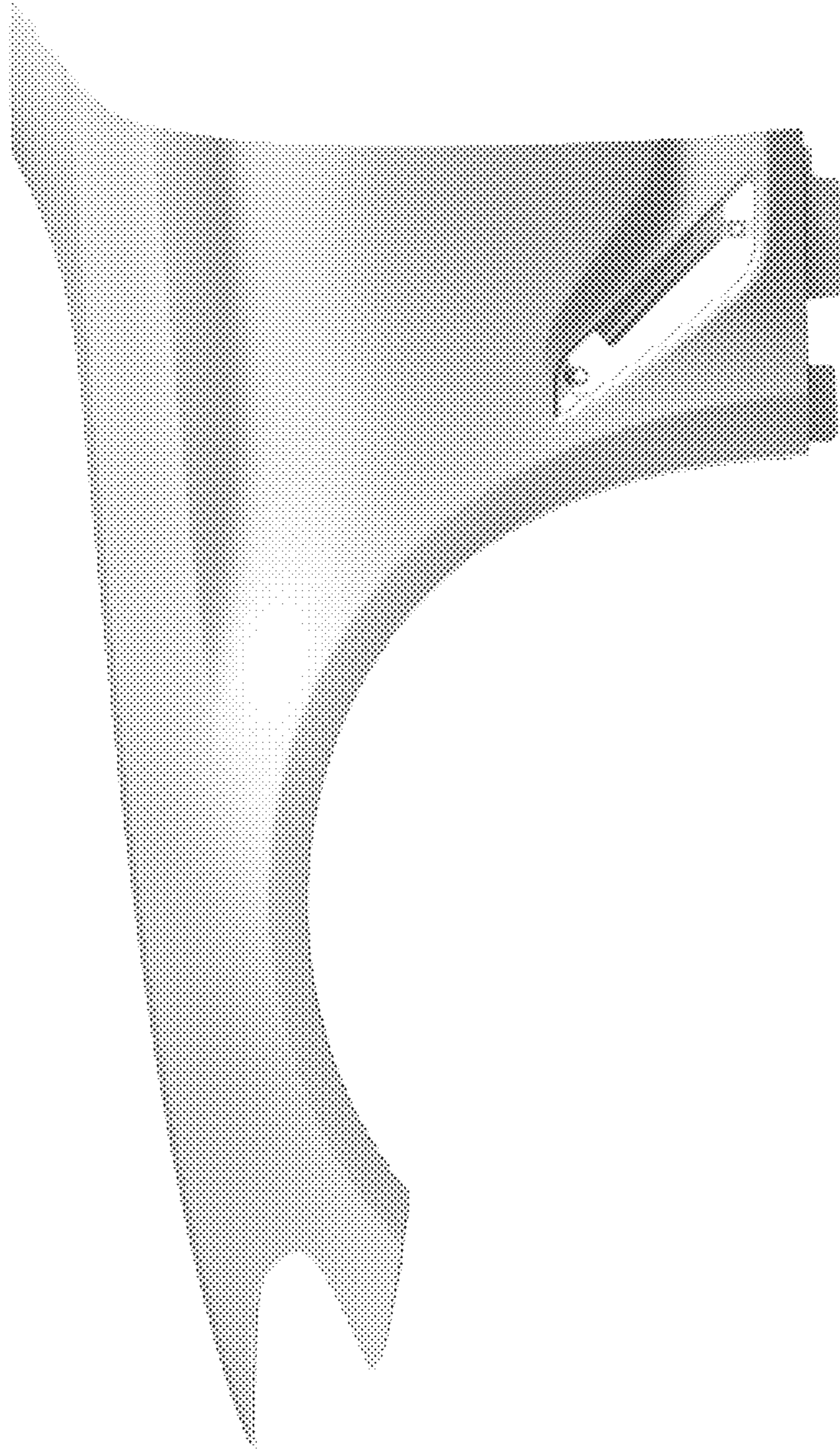

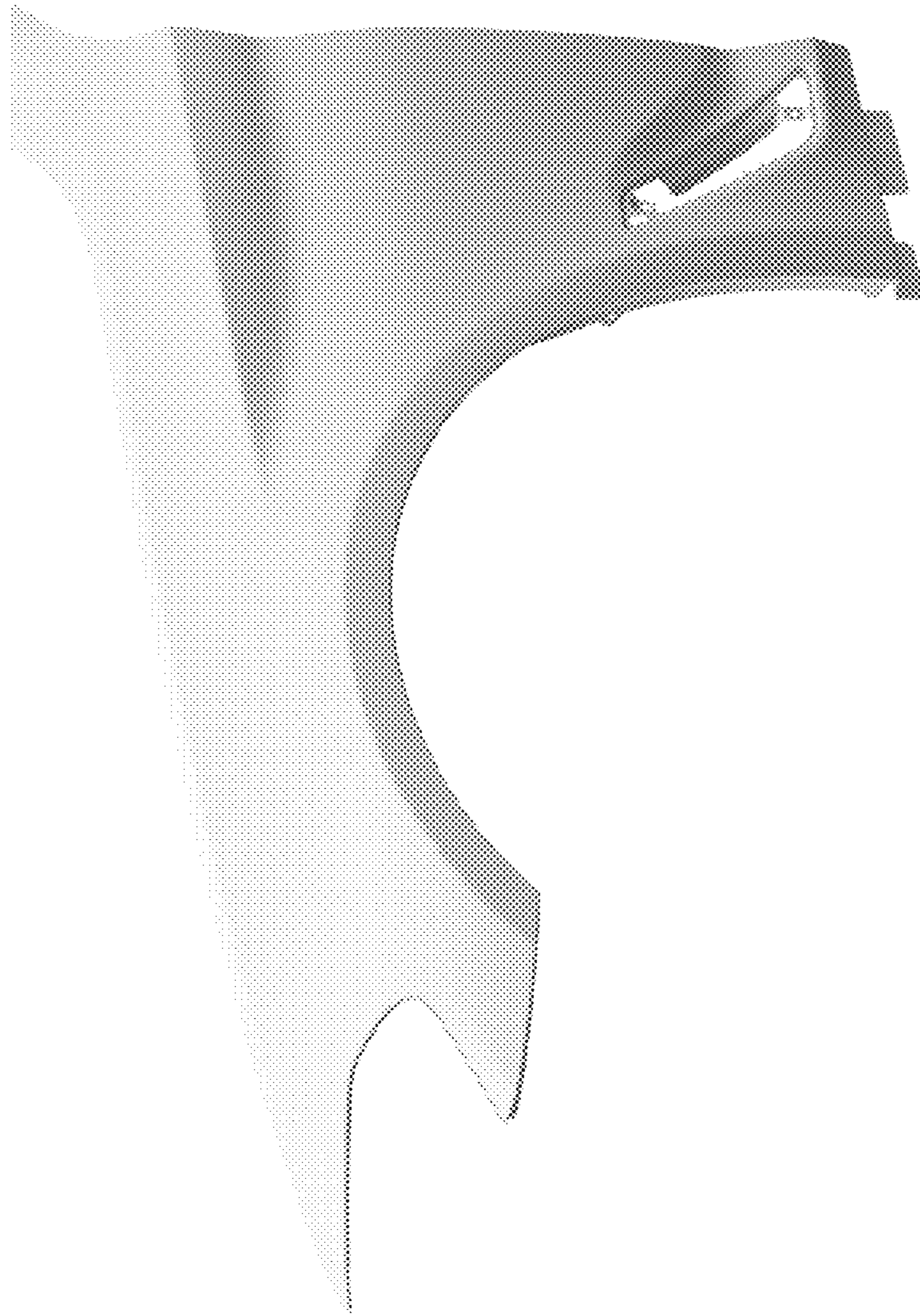

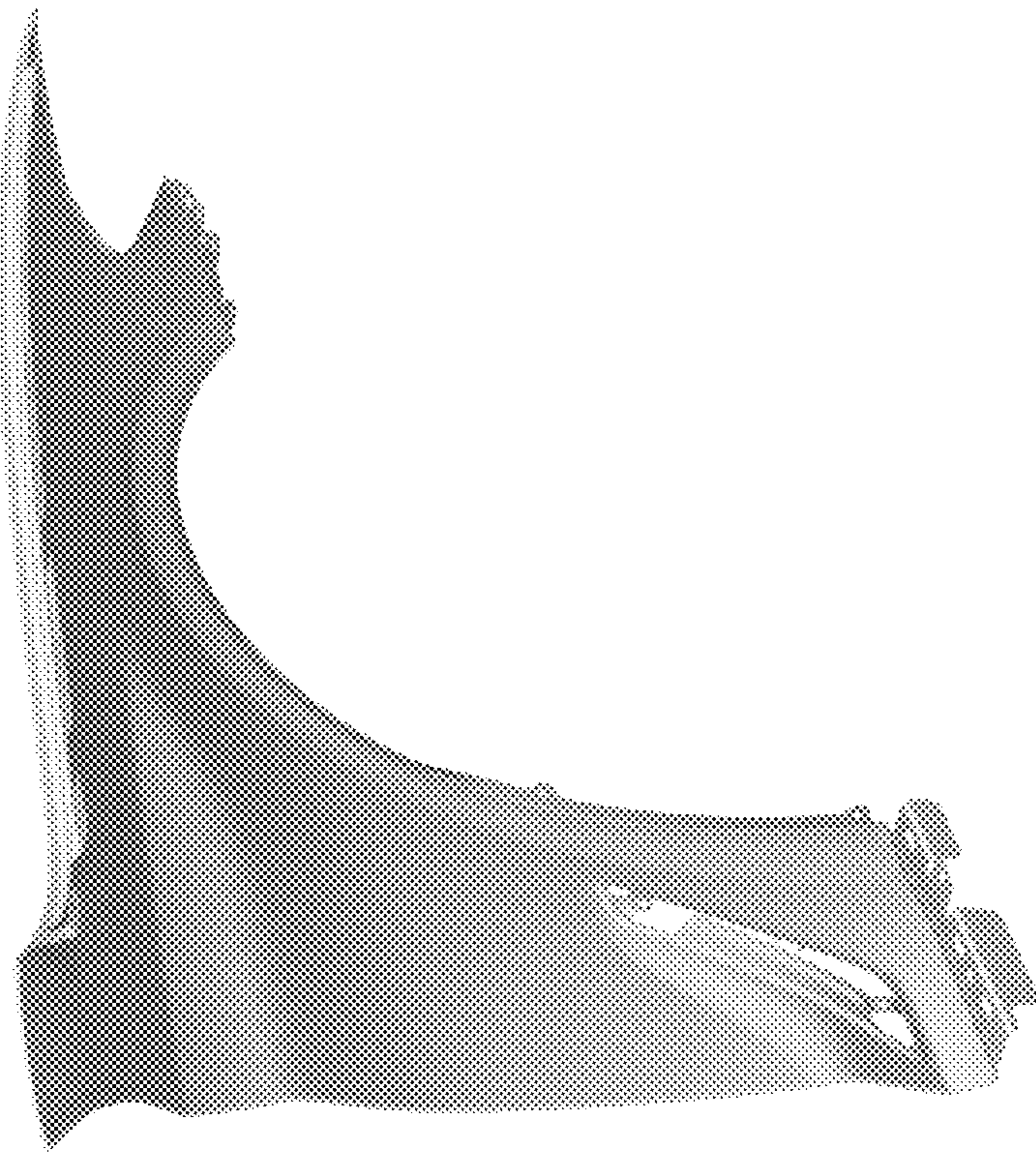

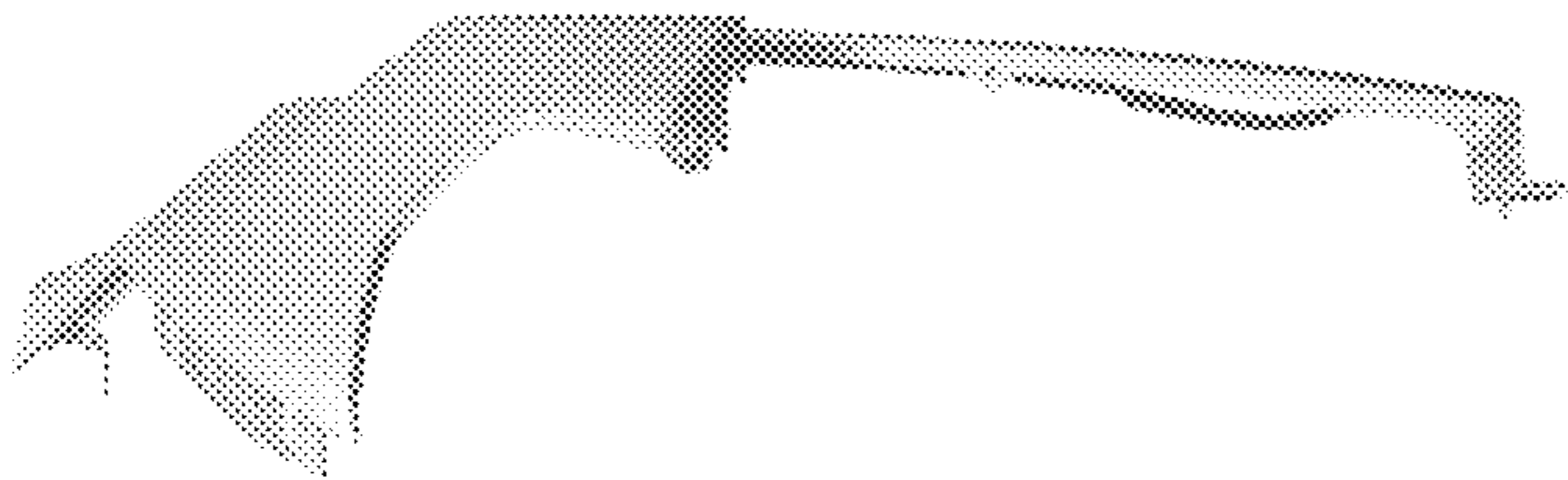

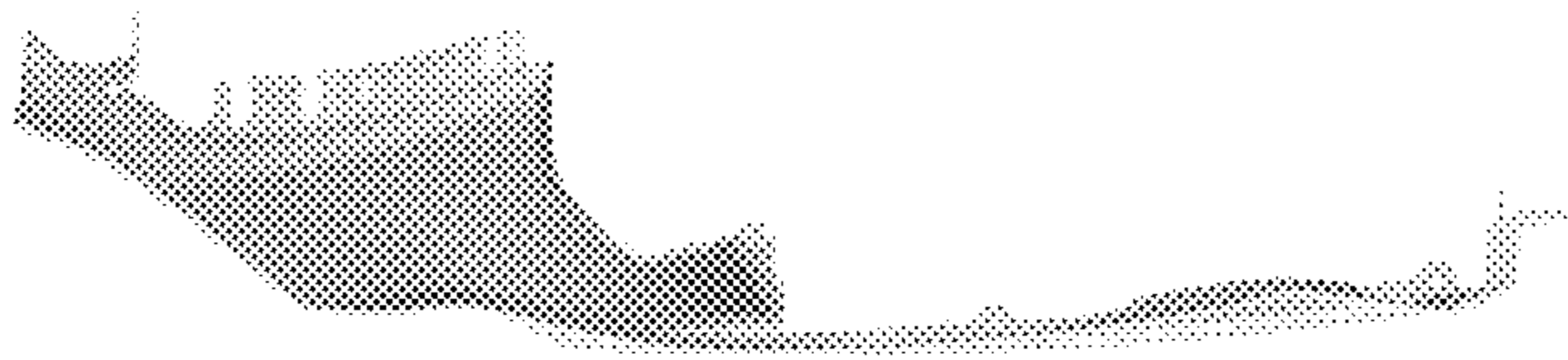

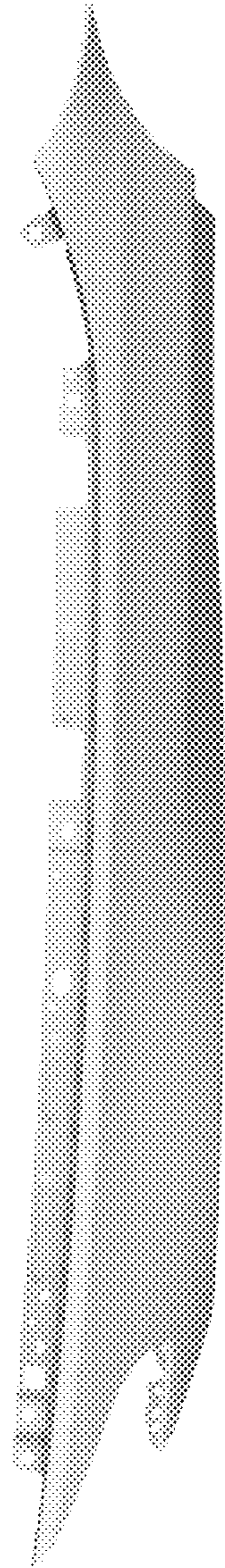

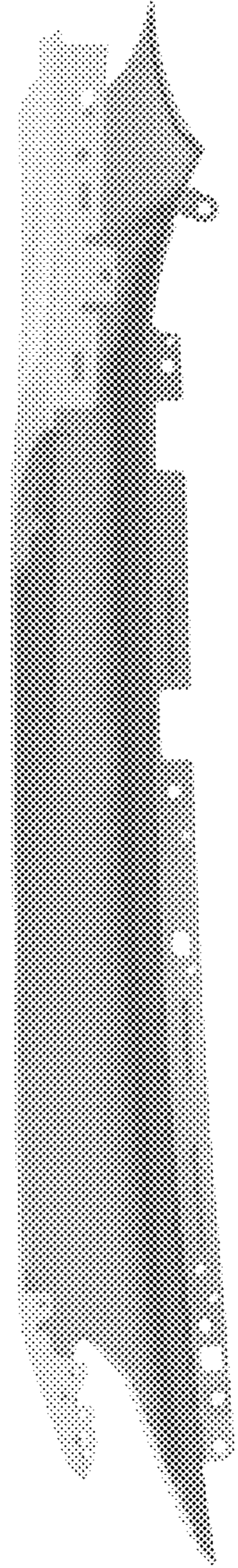

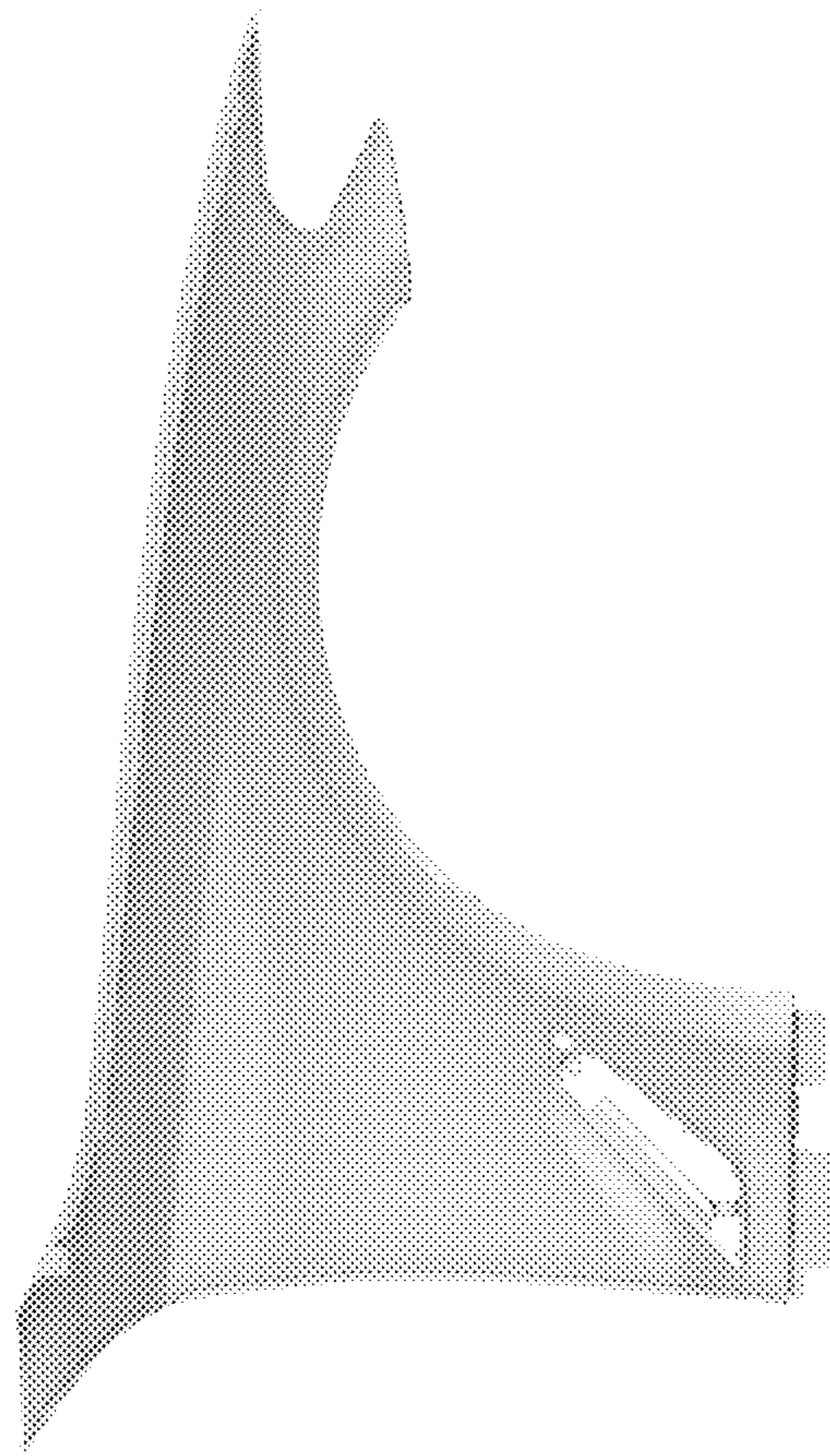
