The ornamental design for a display screen or a portion thereof with animated graphical user interface, as shown and described.

FIG. 13 is a third image of a display screen or a portion thereof with animated graphical user interface;

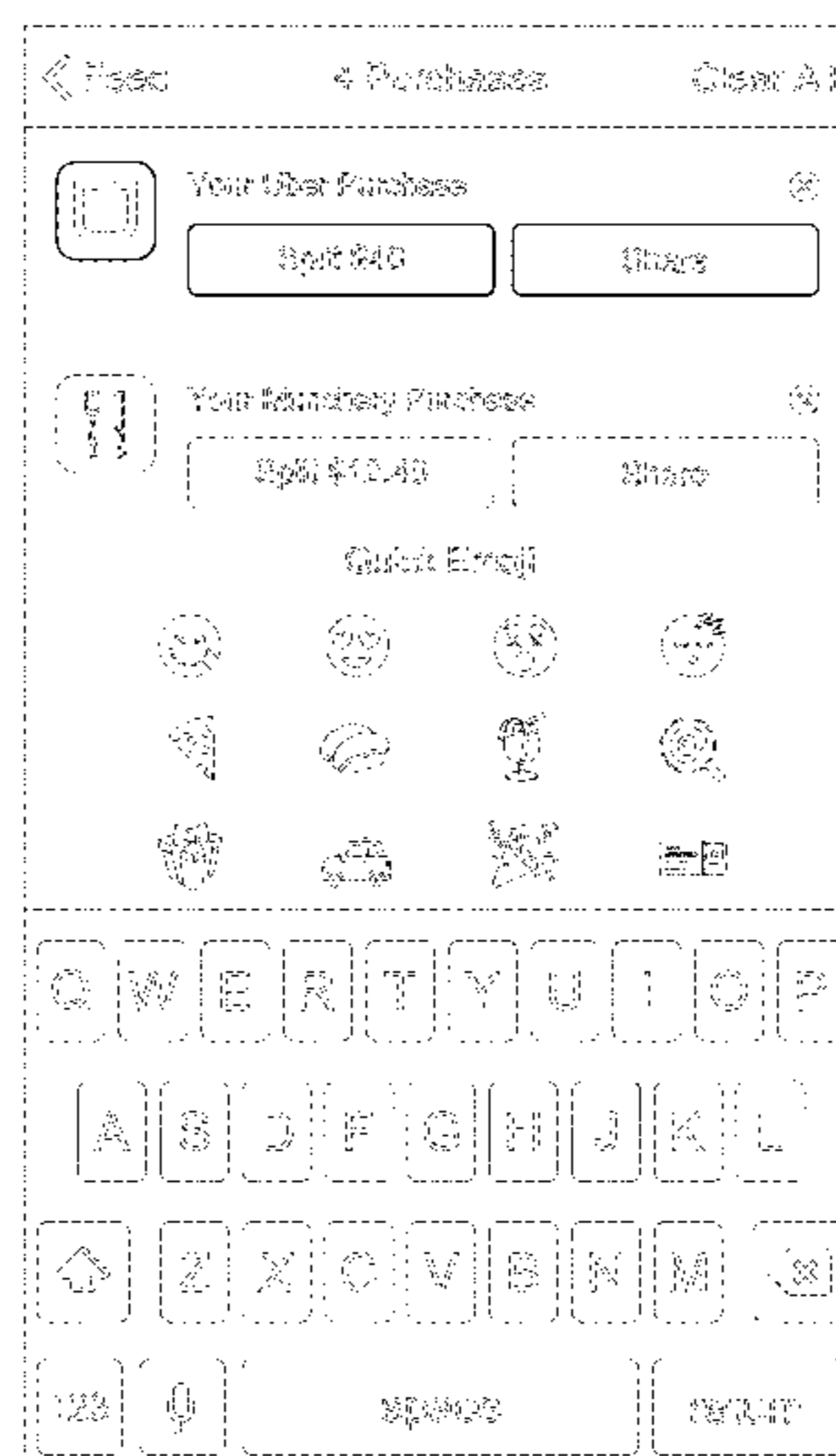
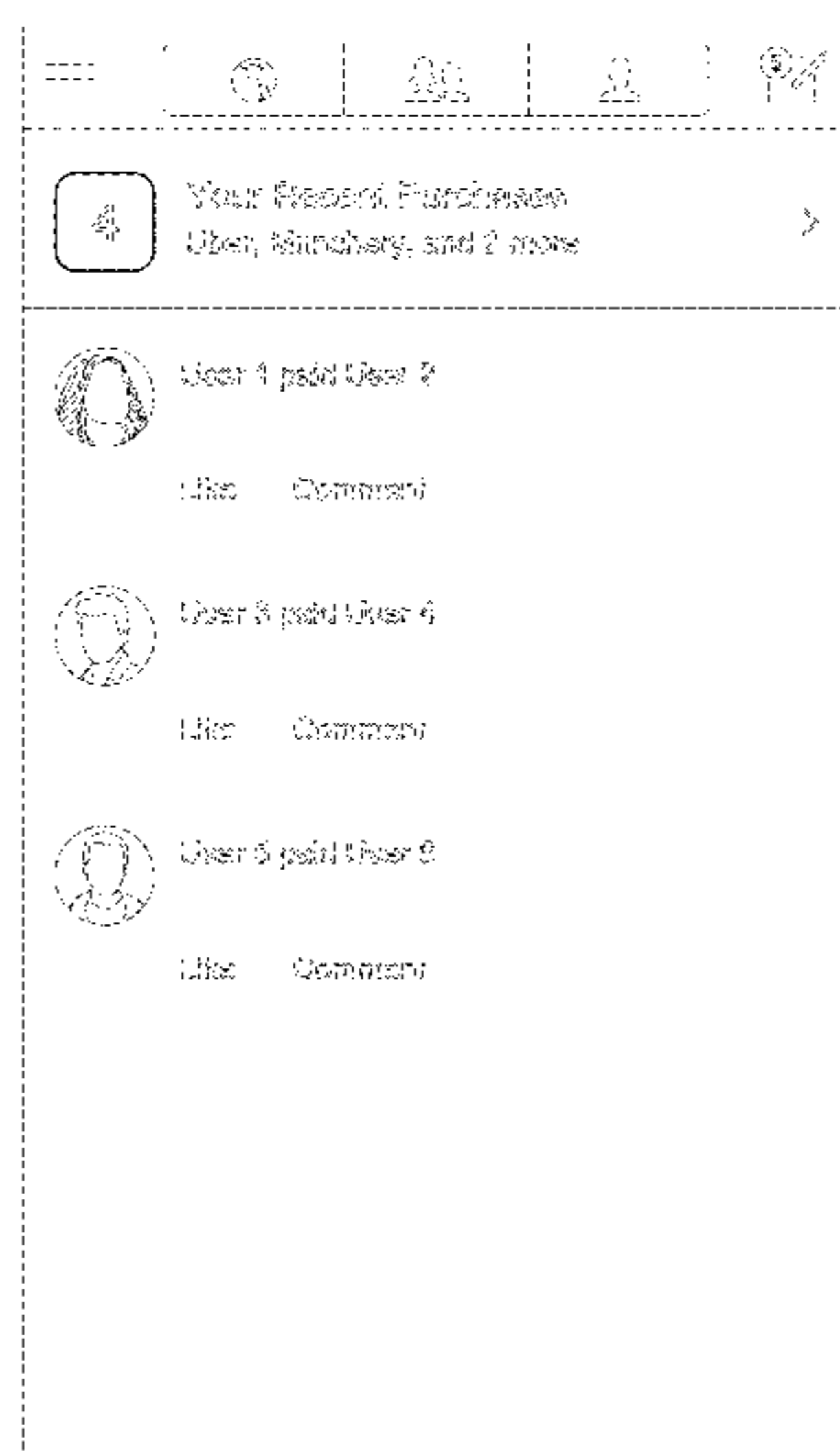
FIG. 14 is a fourth image of a display screen or a portion thereof with animated graphical user interface; and,

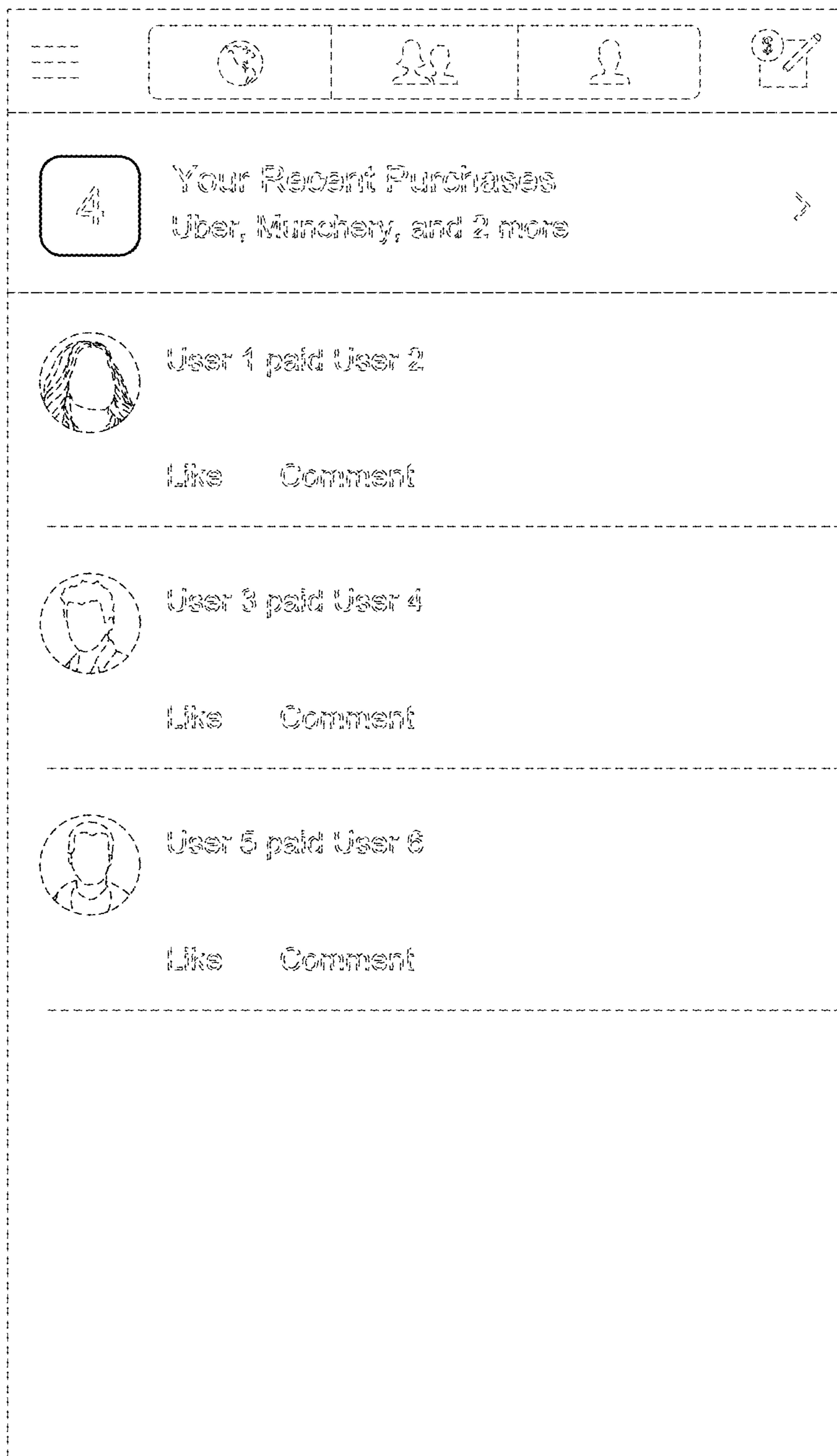

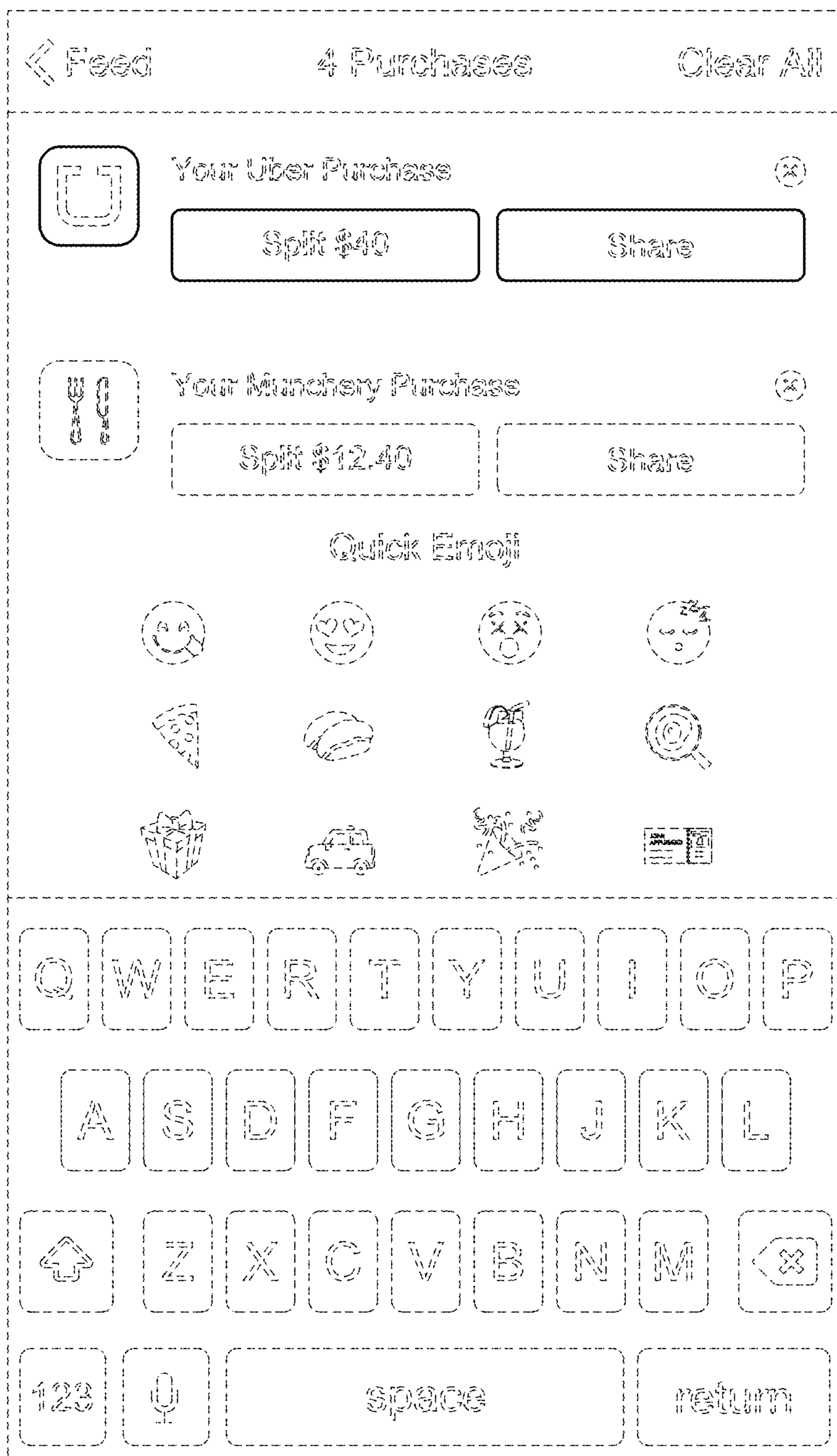

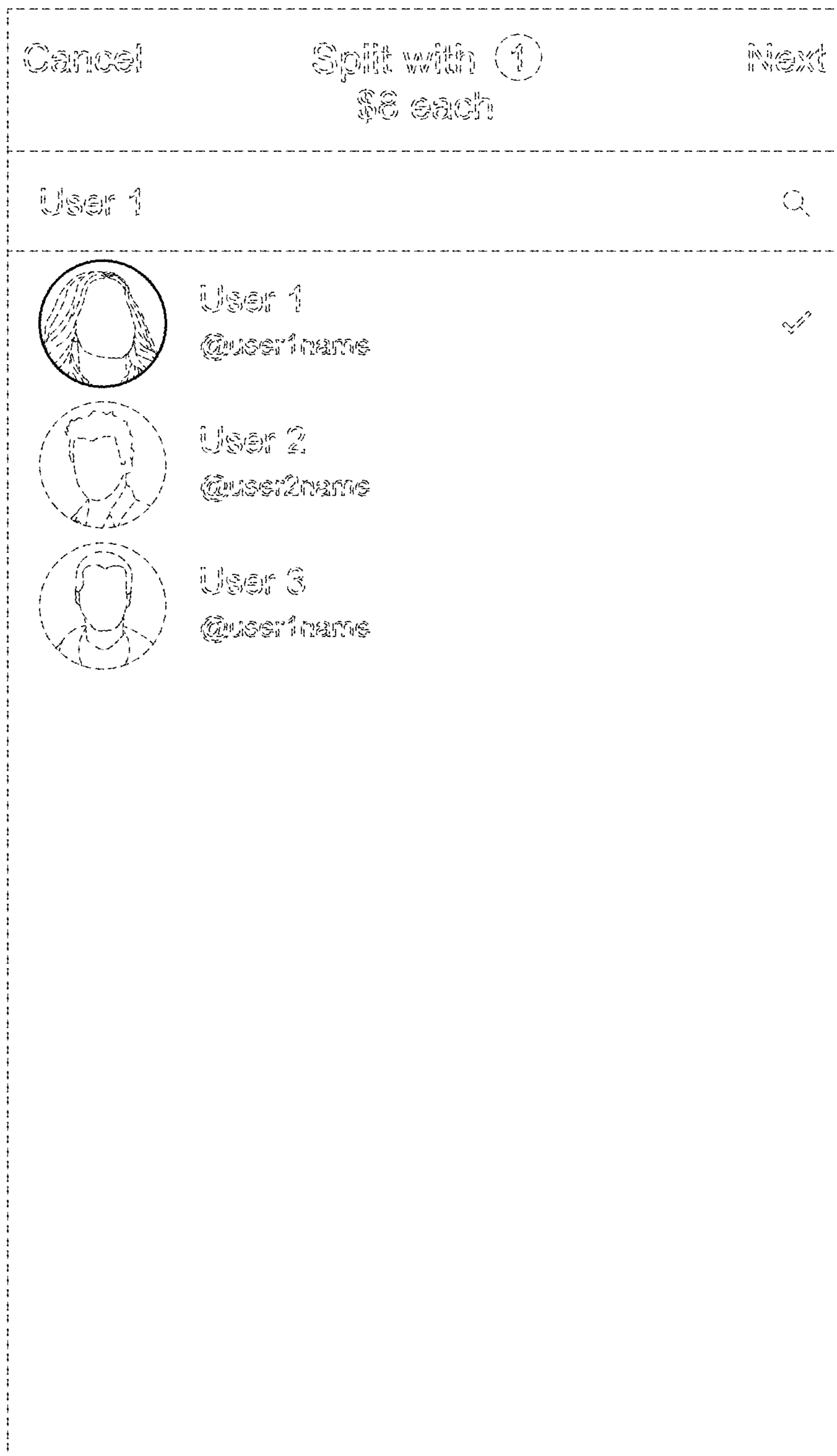

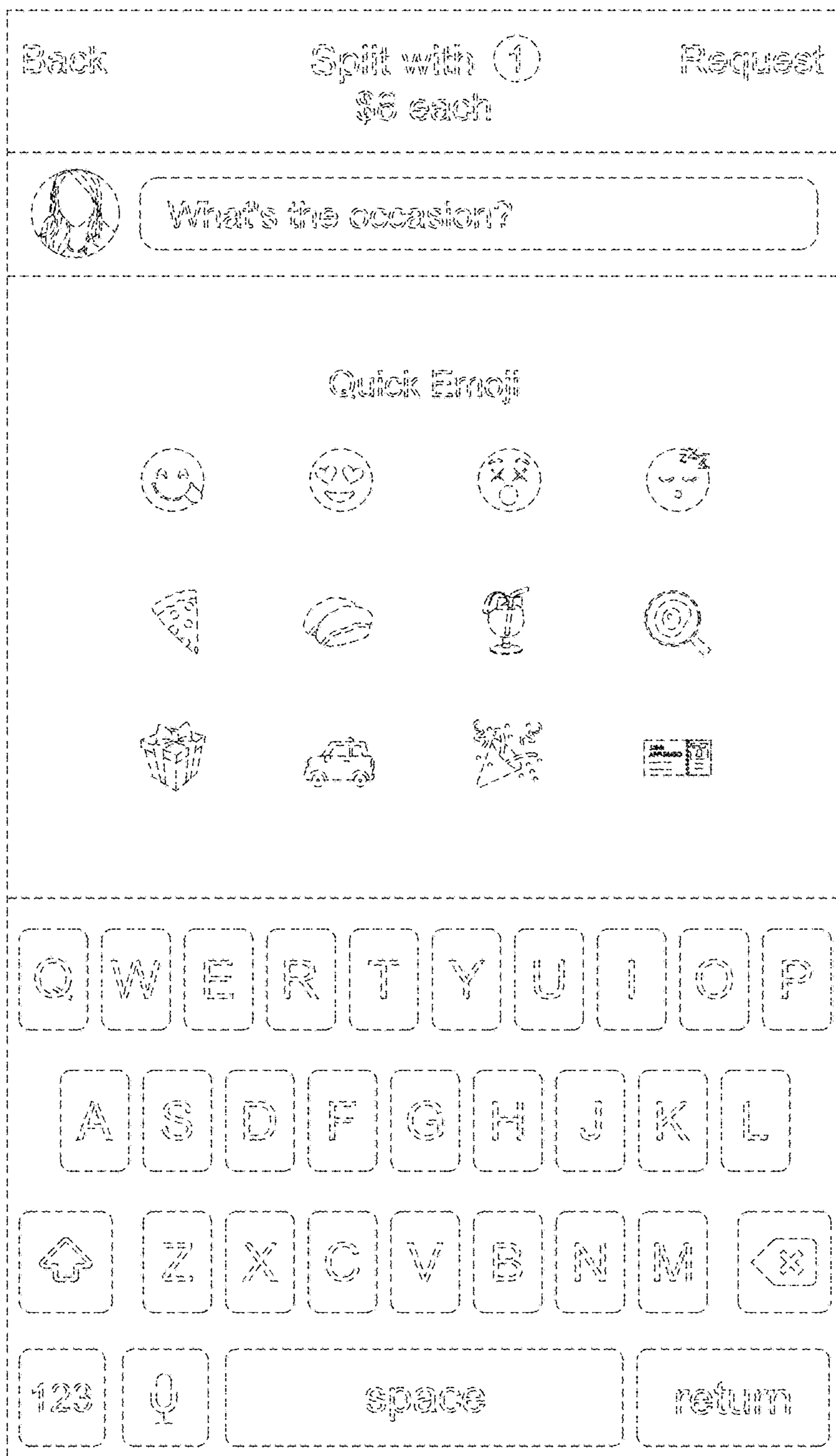

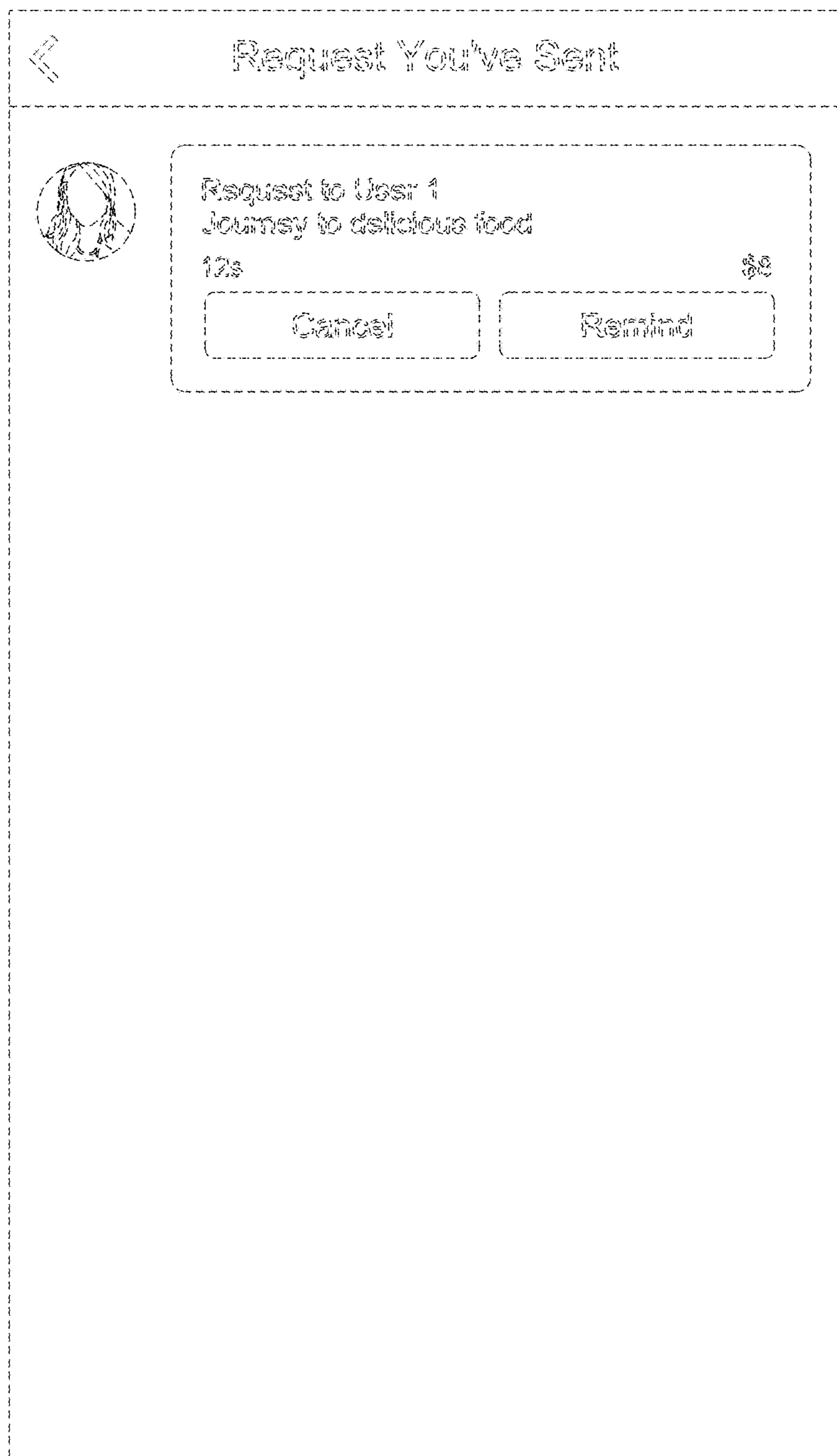

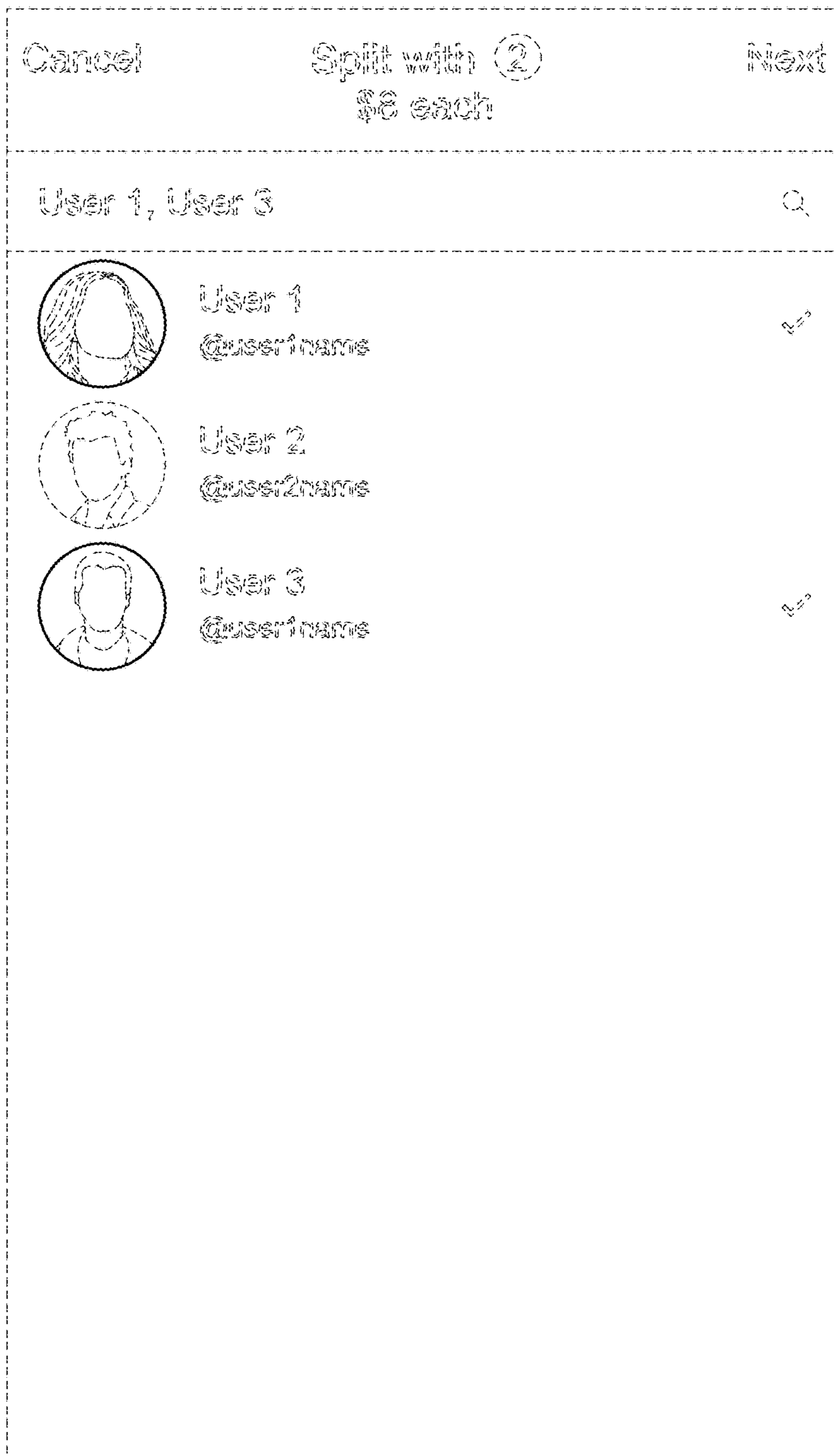

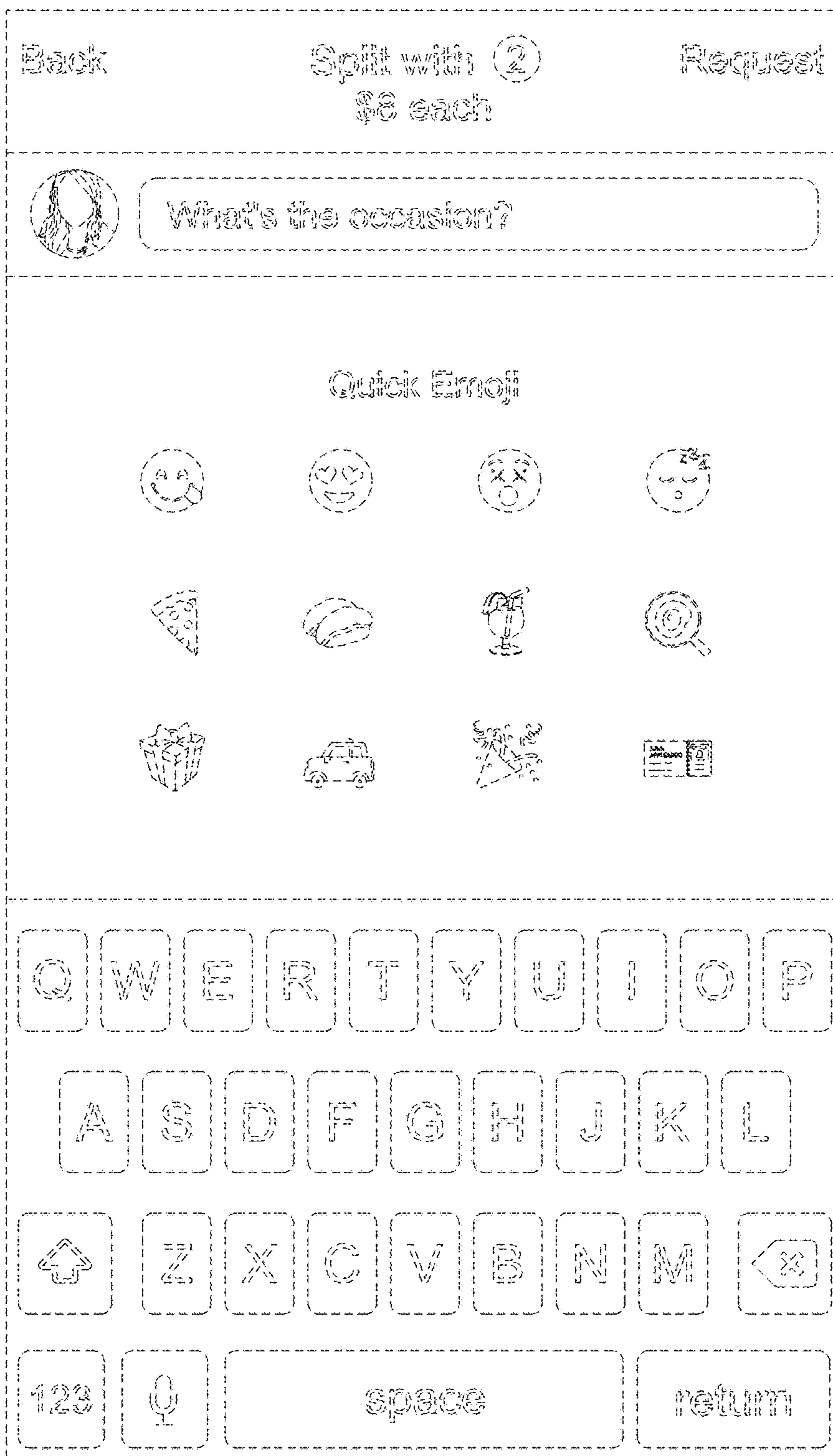

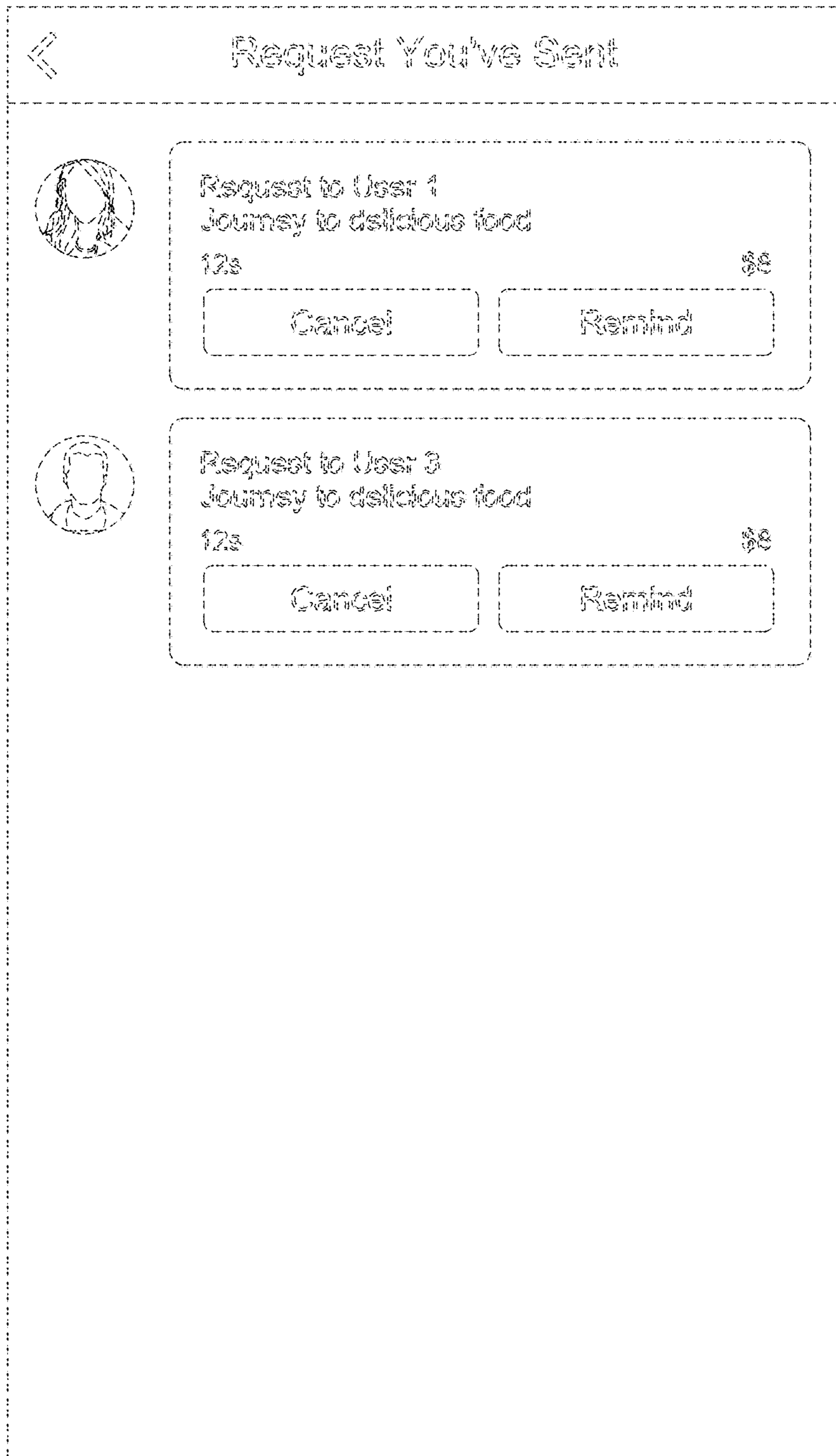

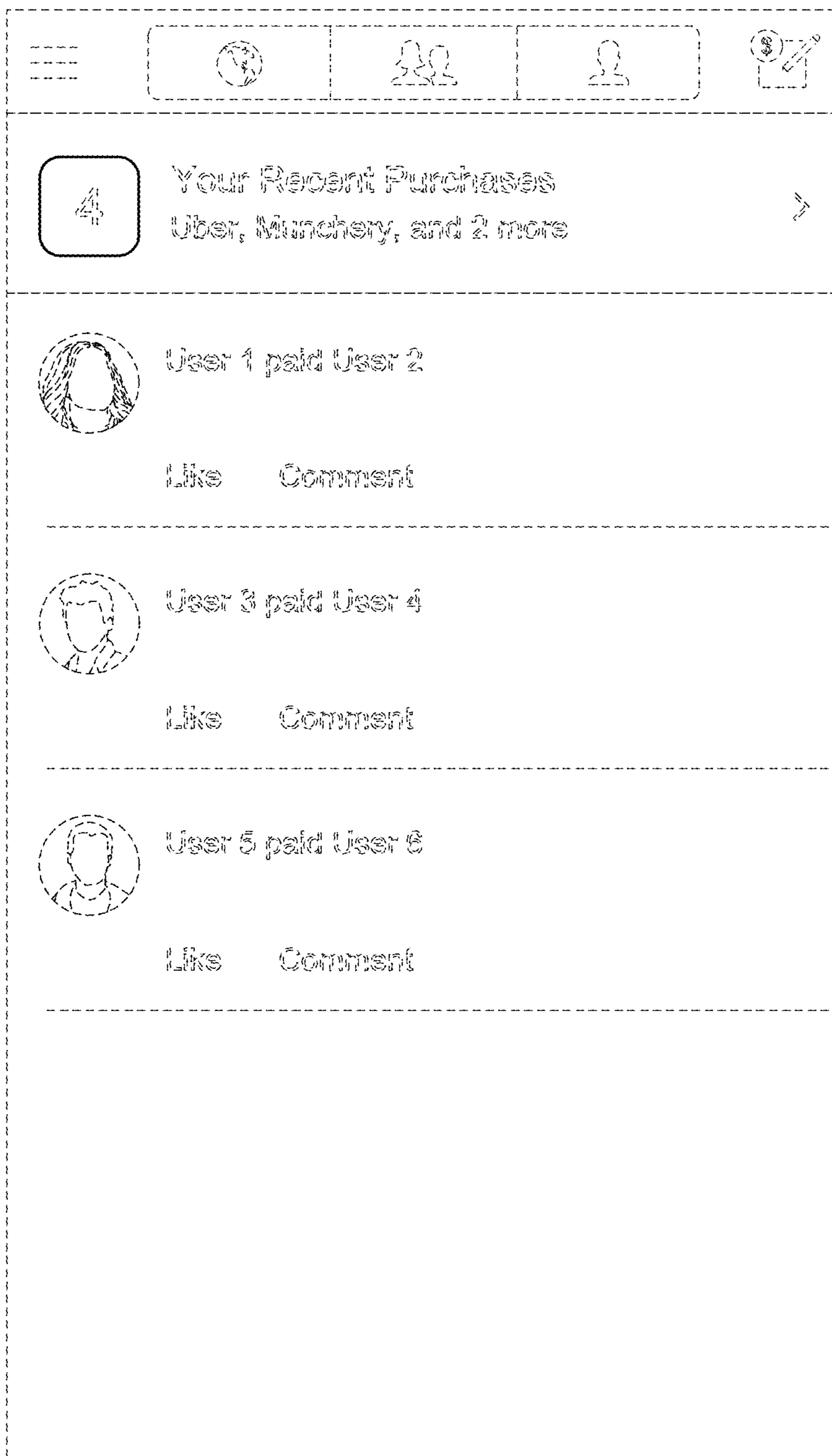

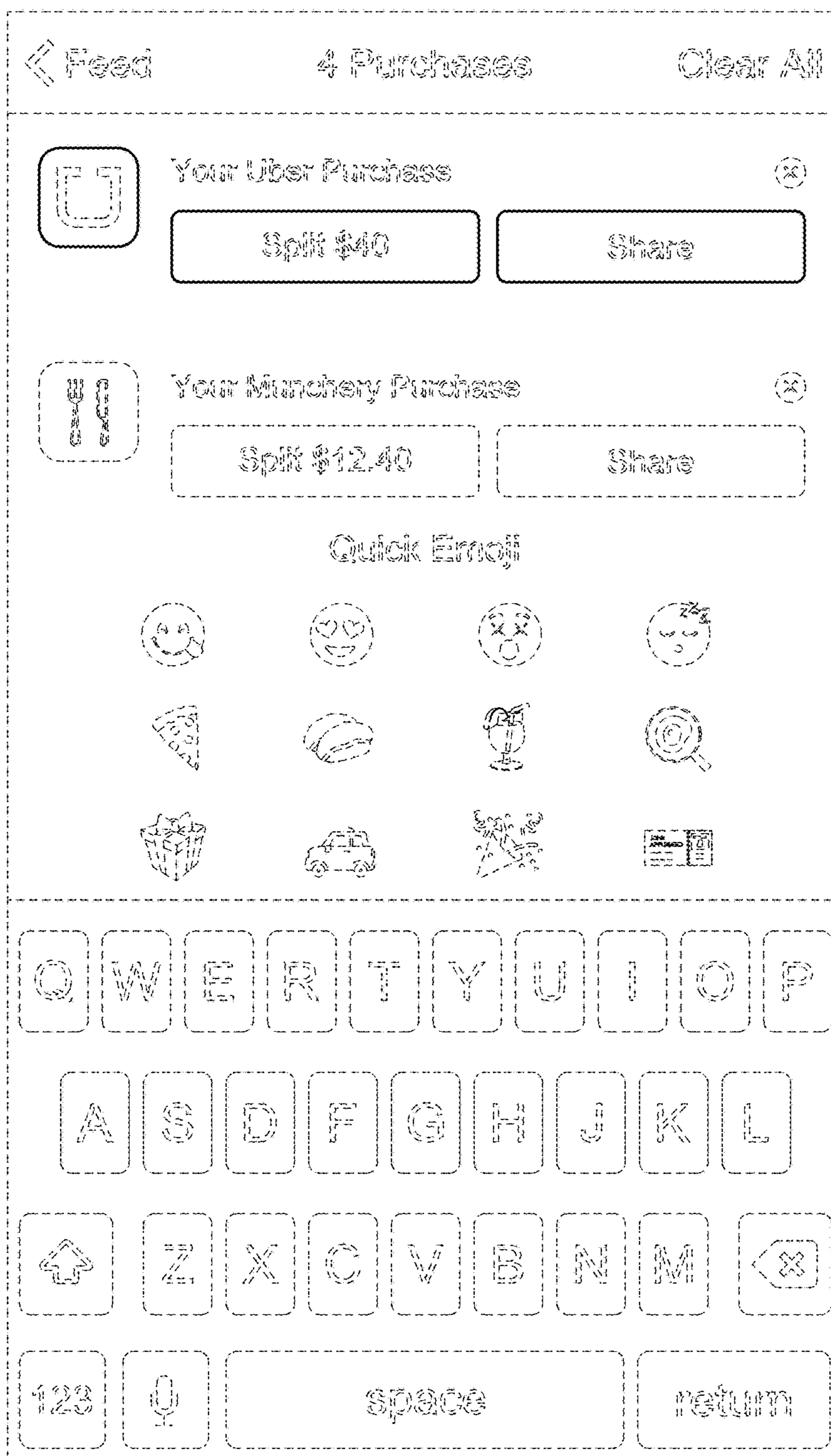

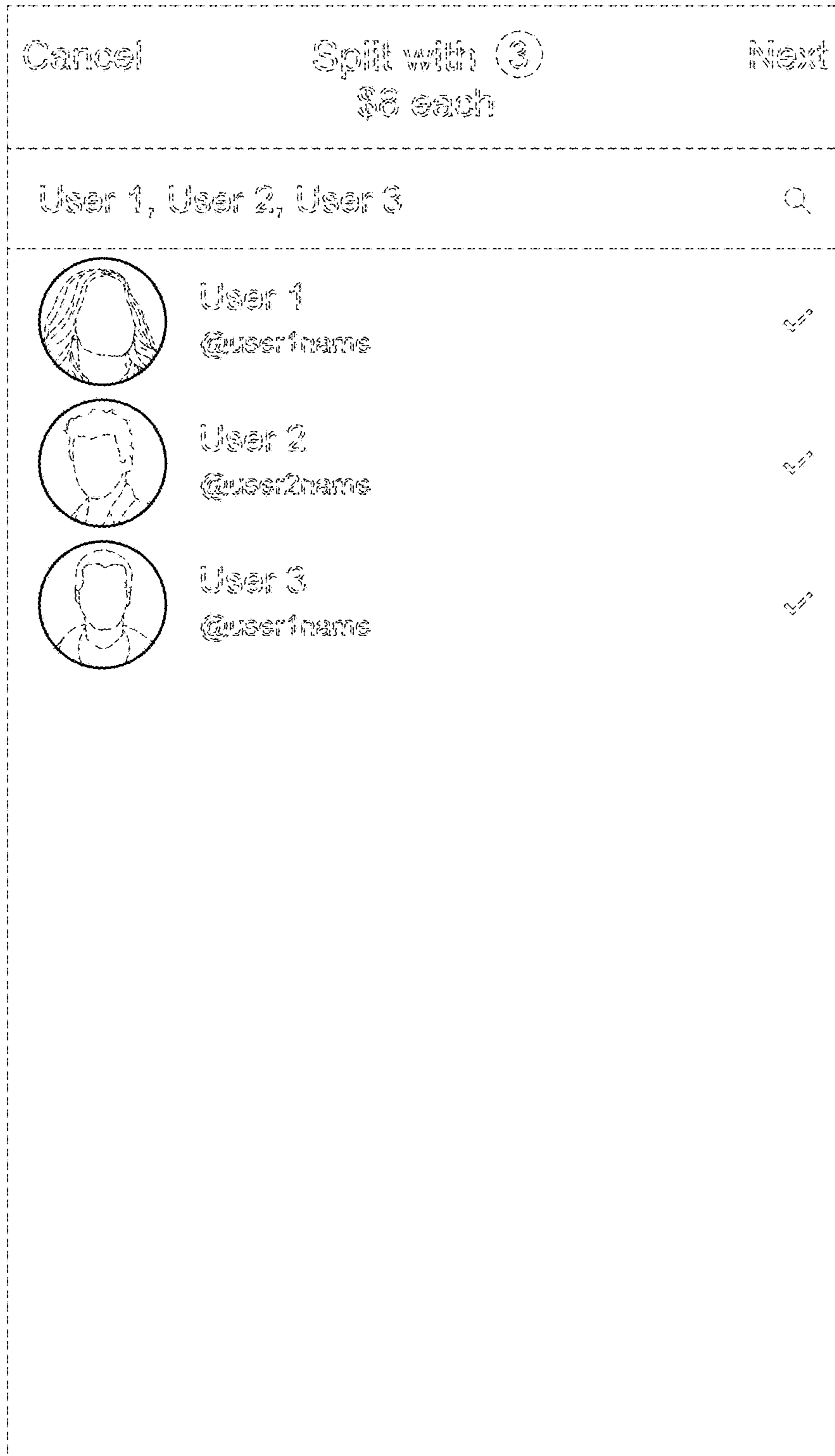

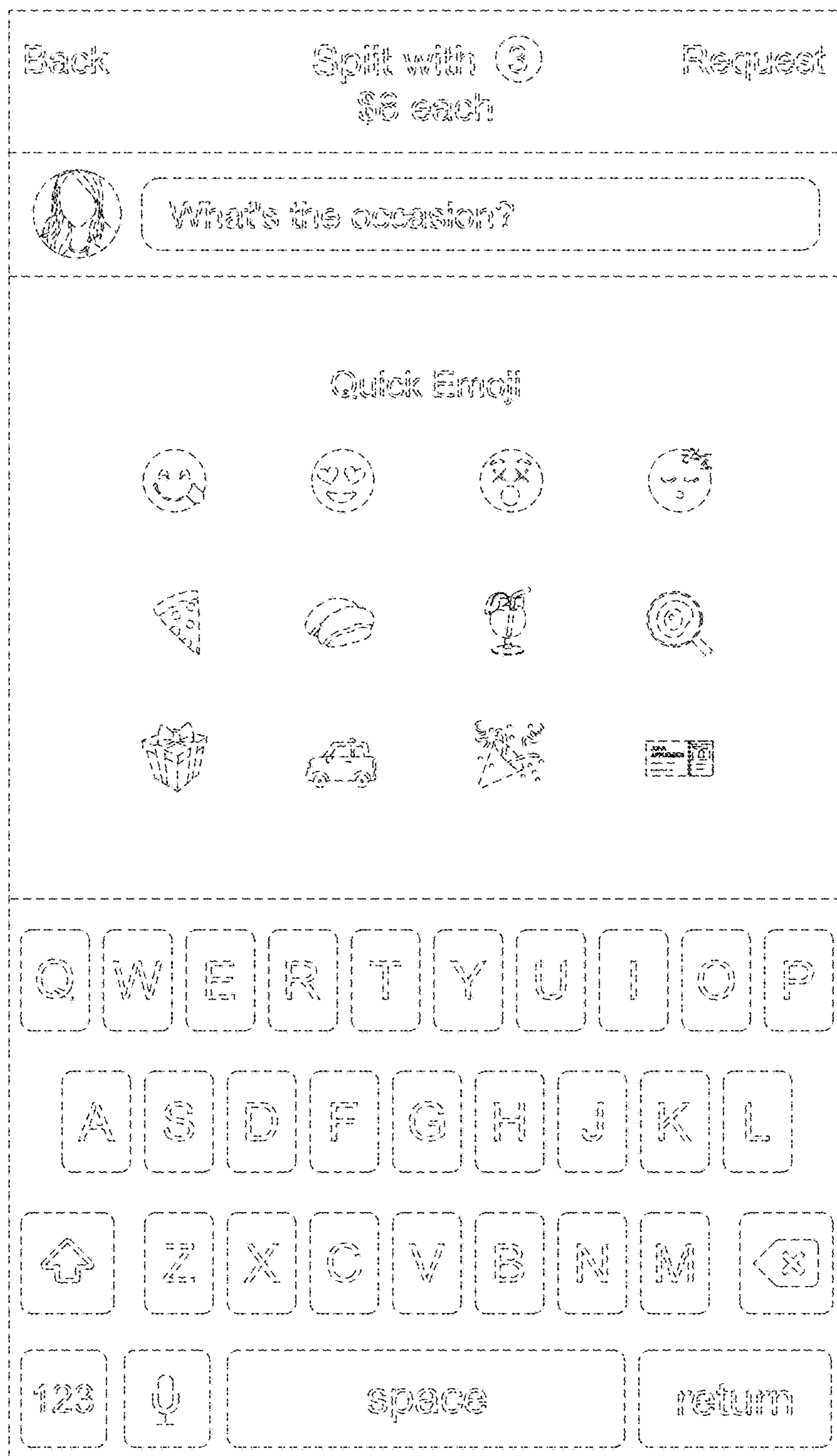

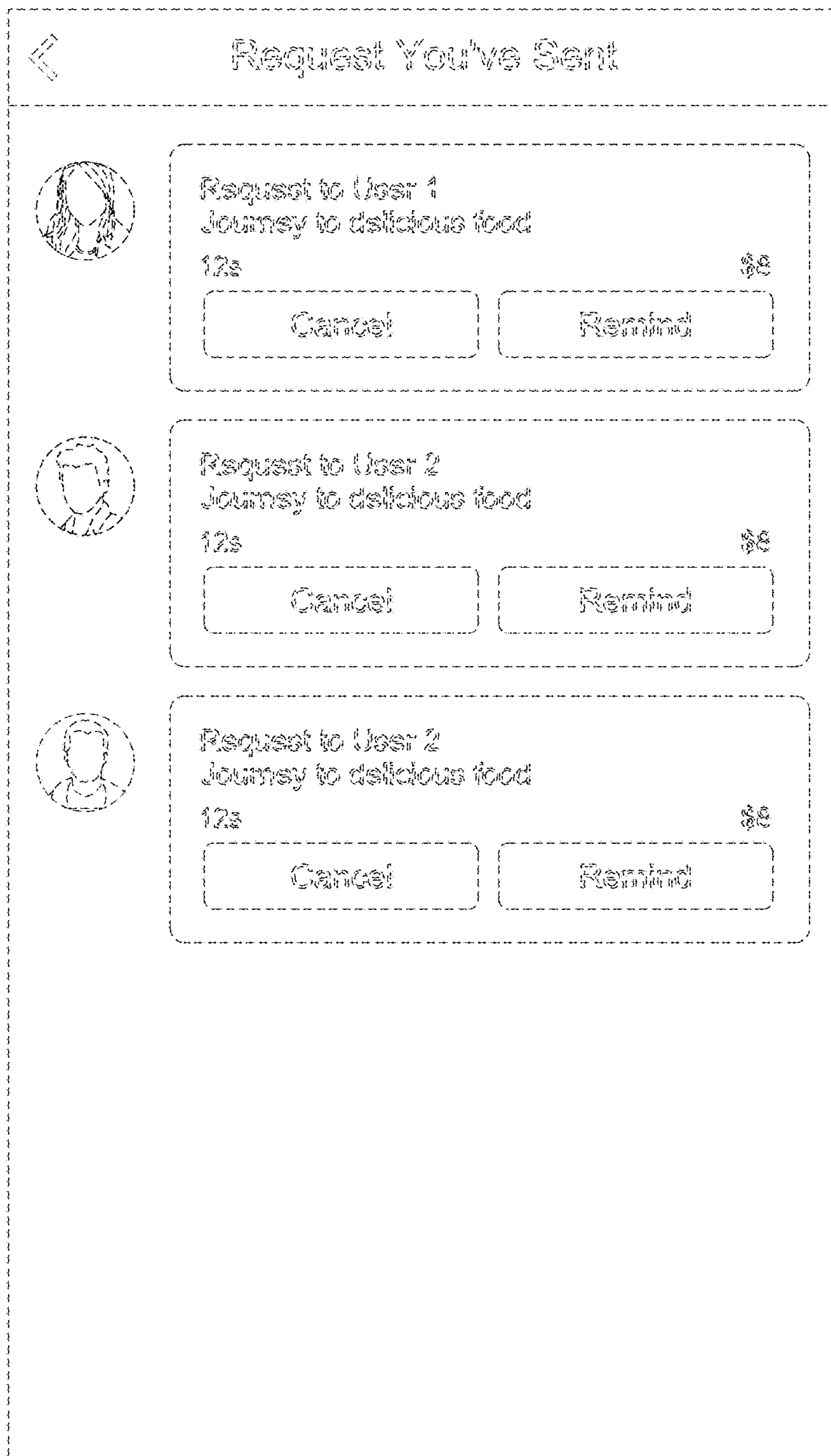
