The ornamental design for a display screen or a portion thereof with animated graphical user interface, as shown and described.

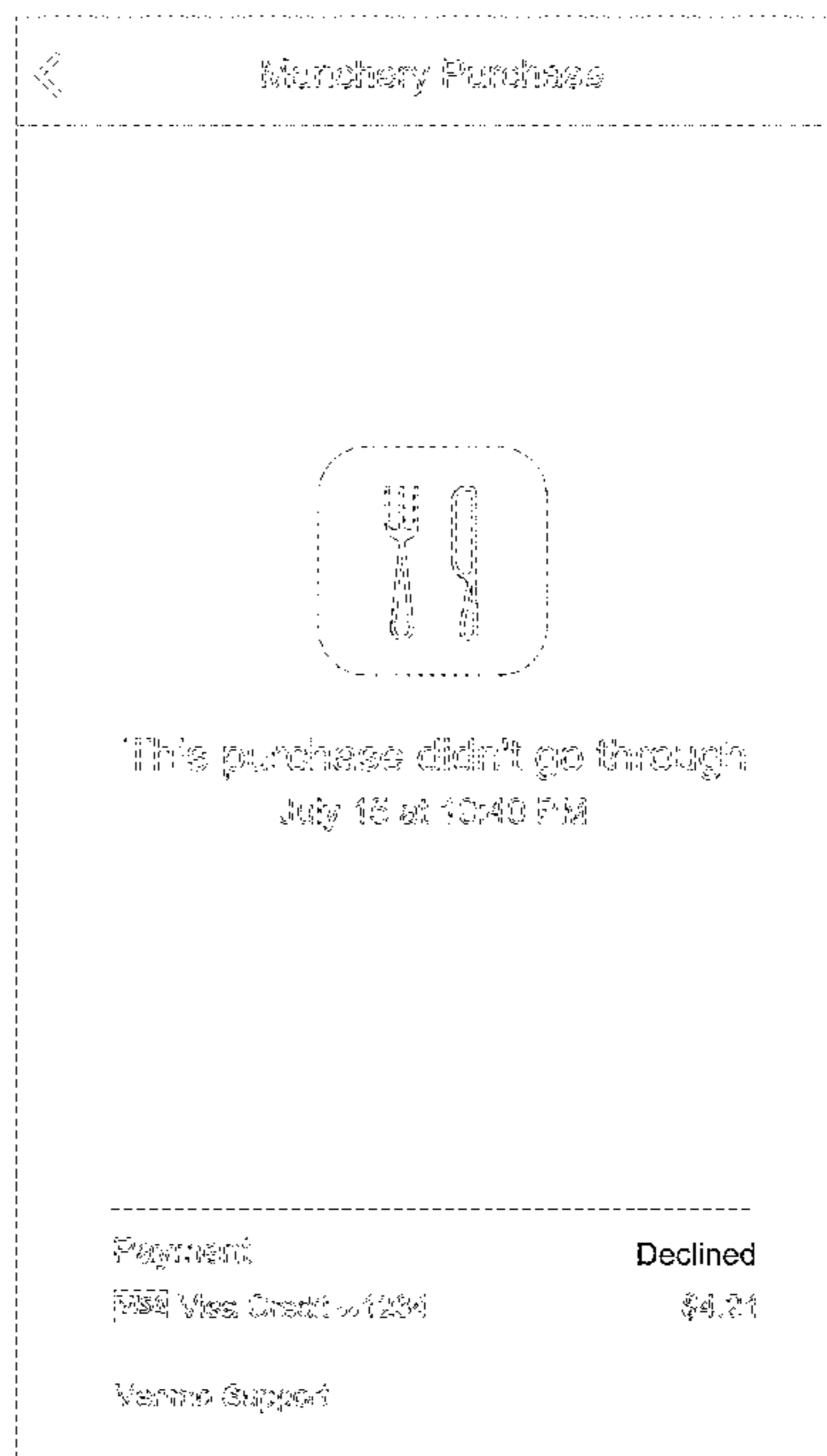
**DESCRIPTION**

FIG. 1 is a first image of a display screen or a portion thereof with animated graphical user interface; FIG. 2 is a second image of a display screen or a portion thereof with animated graphical user interface; FIG. 3 is a third image of a display screen or a portion thereof with animated graphical user interface; and, FIG. 4 is a fourth image of a display screen or a portion thereof with animated graphical user interface.

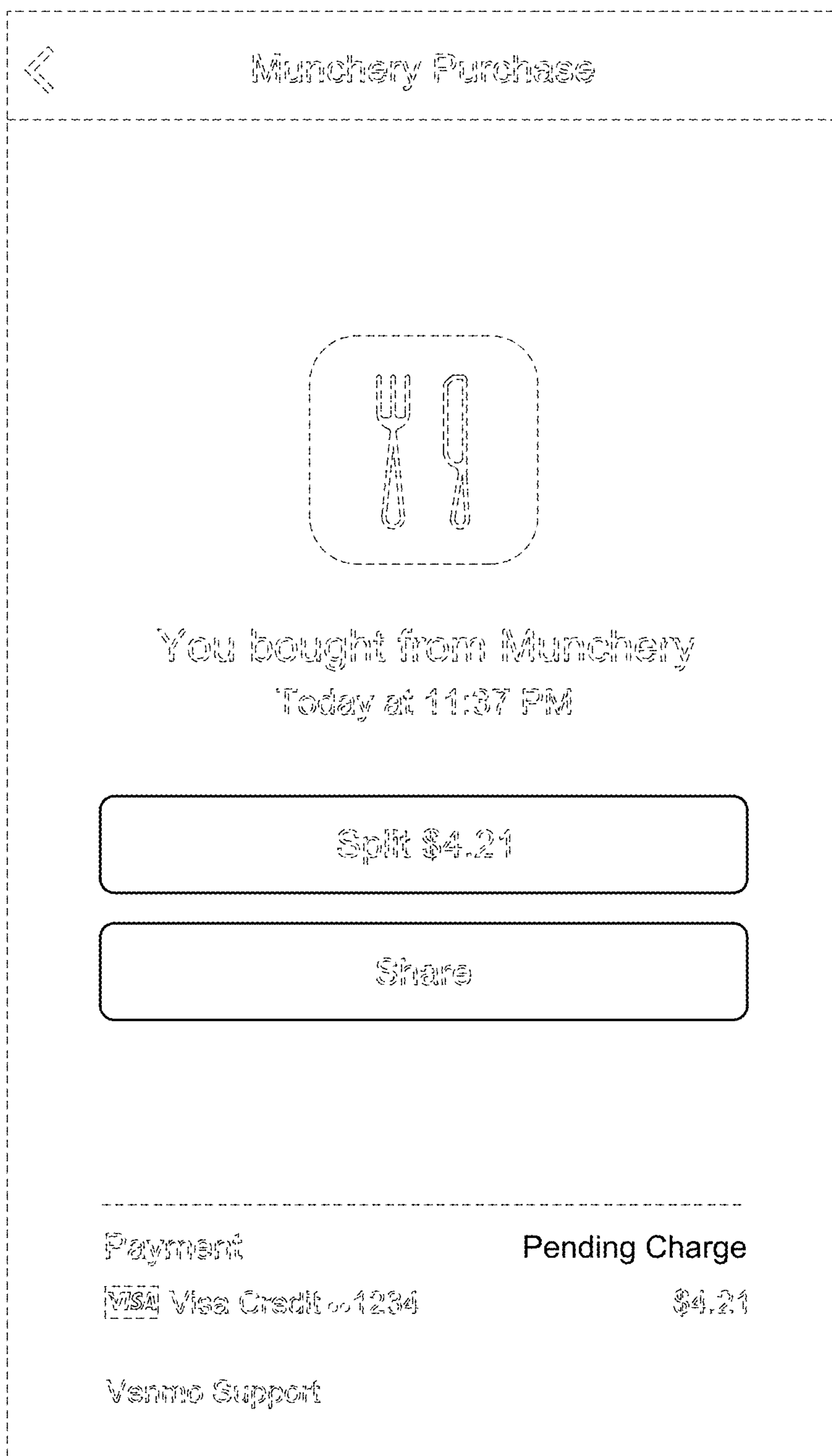

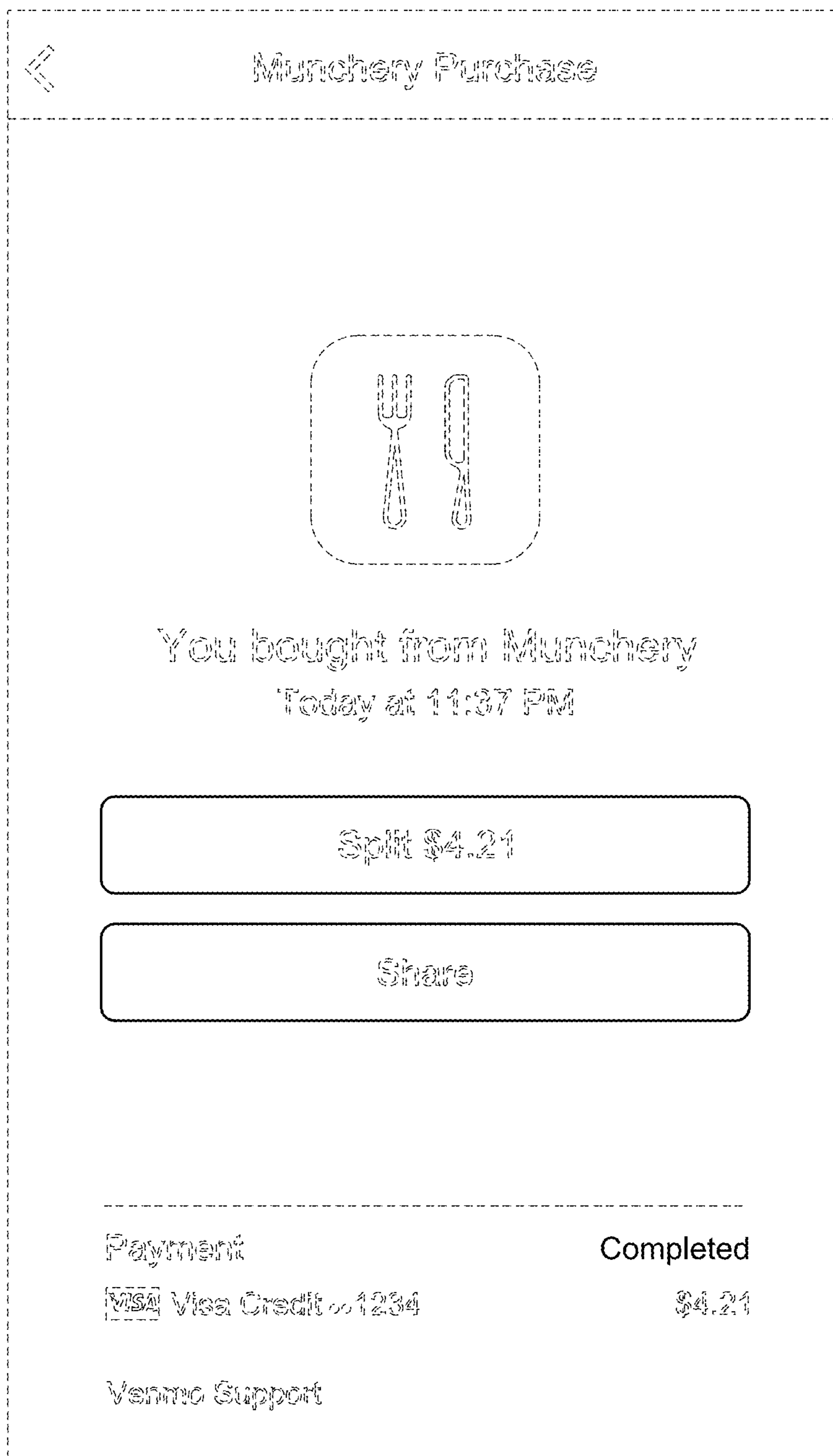

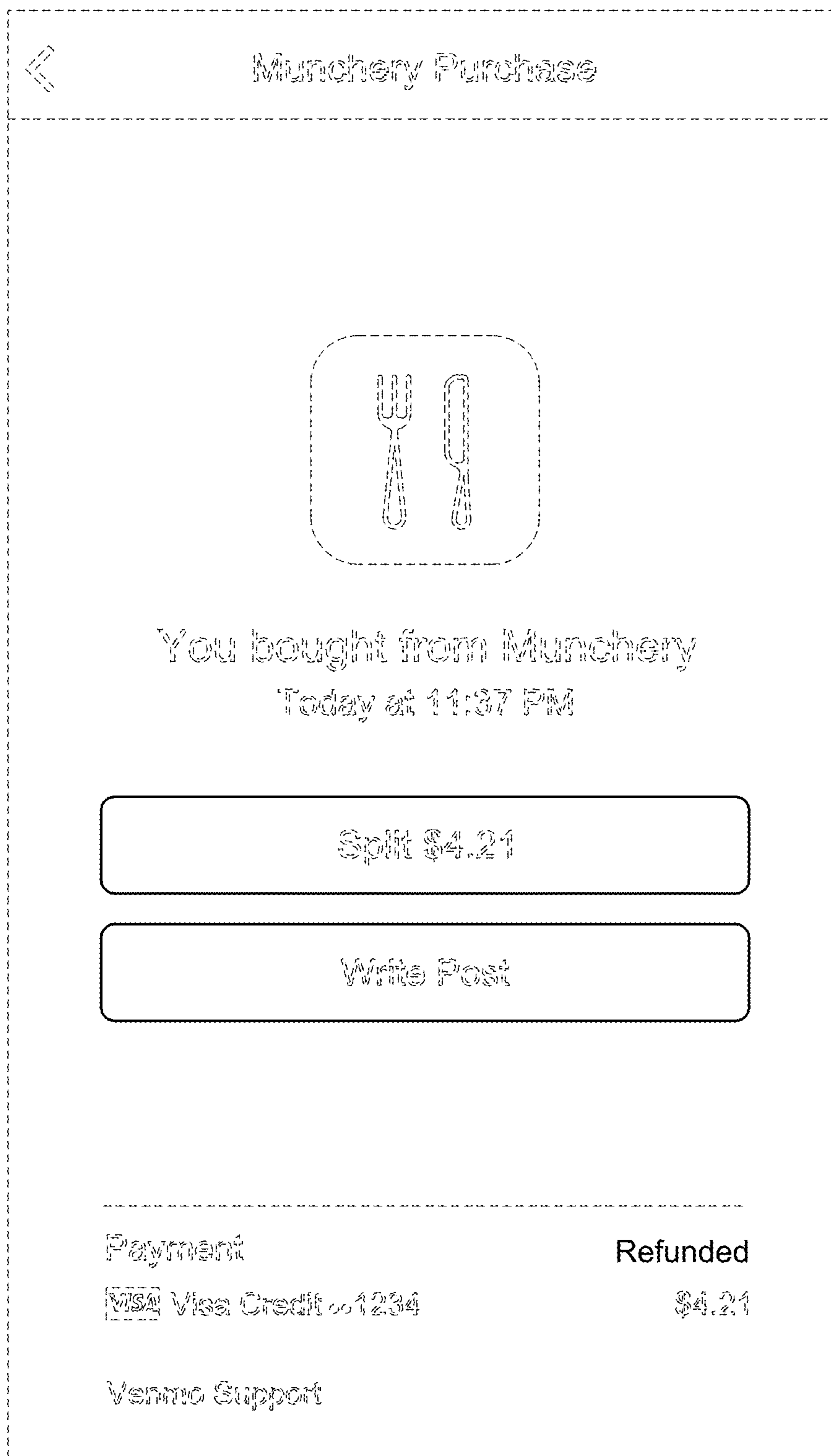
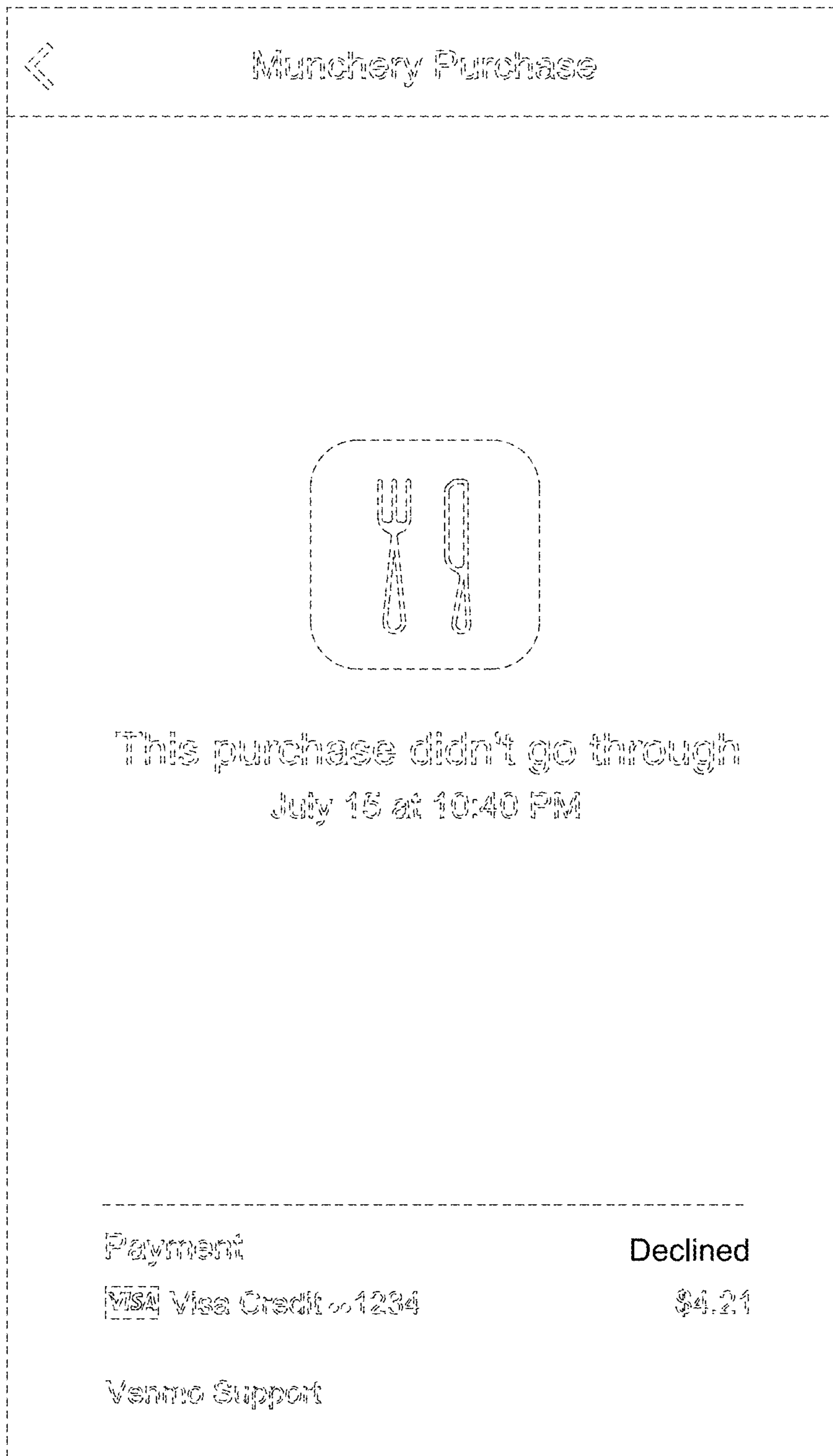
