DESCRIPTION

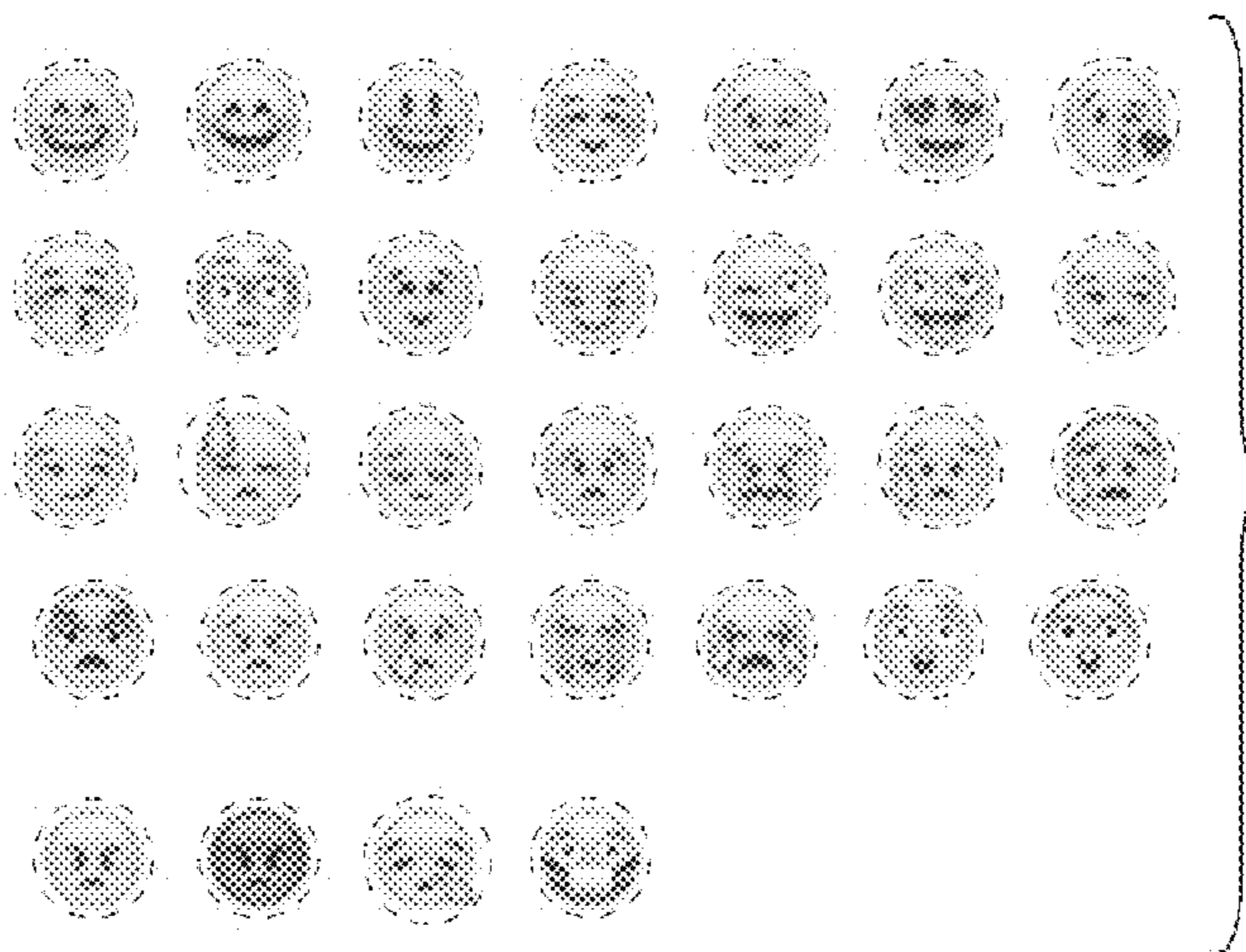
