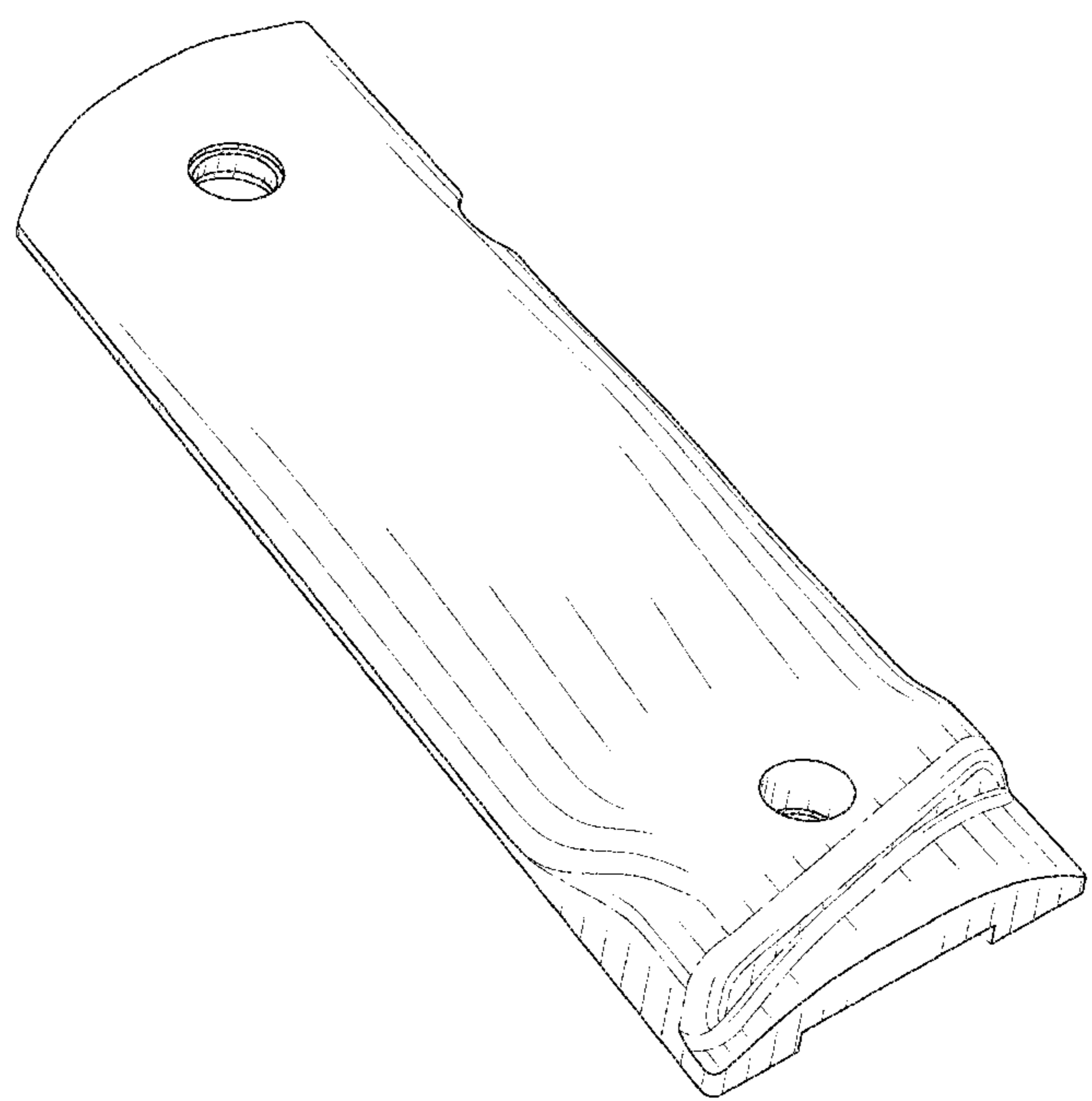

(57) **CLAIM**  
The ornamental design for a pair of pistol grips, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left side, and bottom perspective view of a right side grip panel of a pair of pistol grips showing the new design;

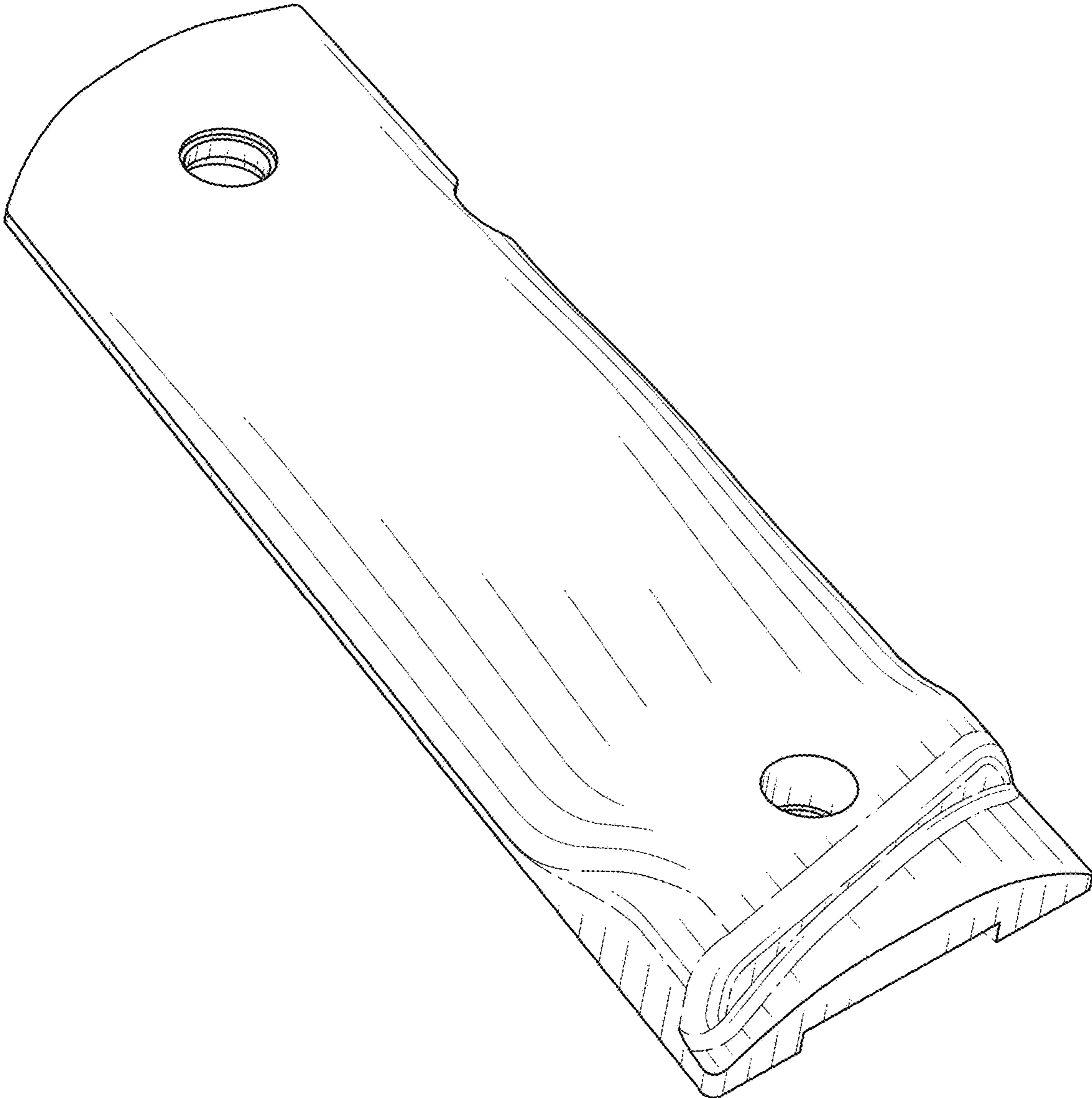

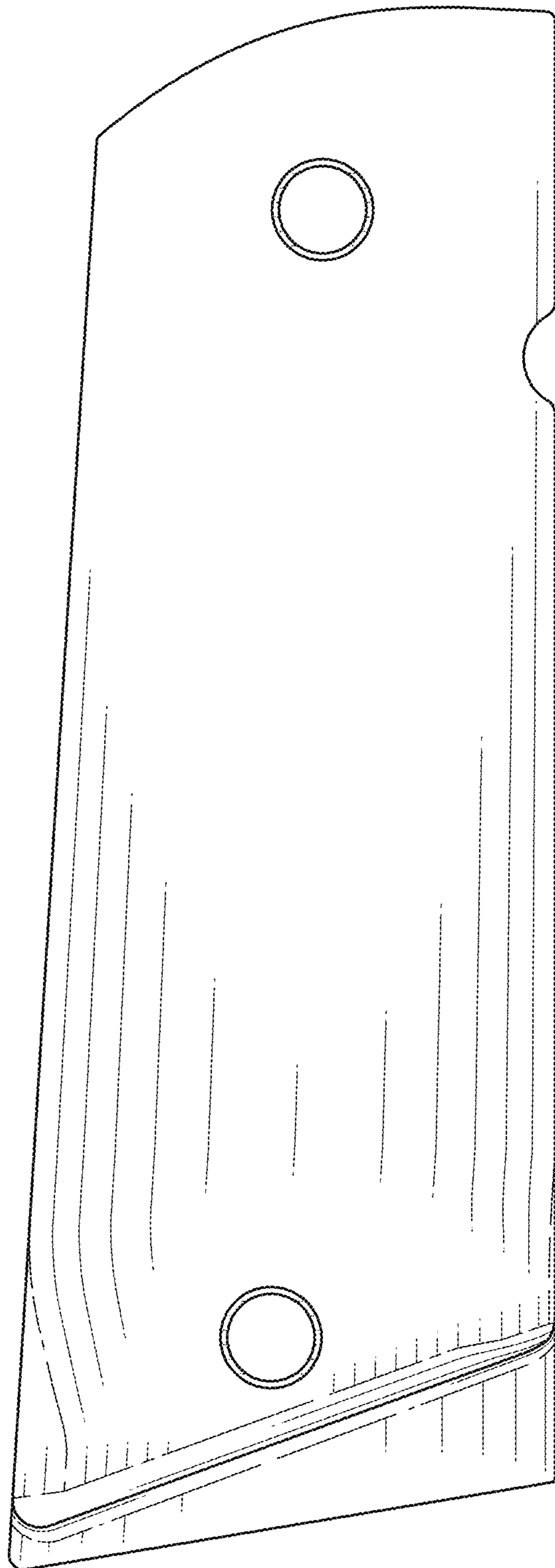

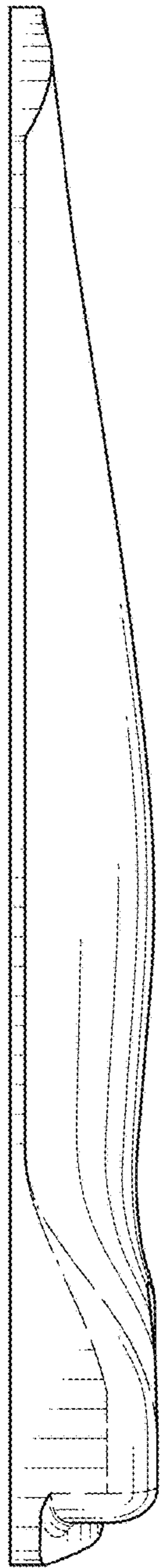

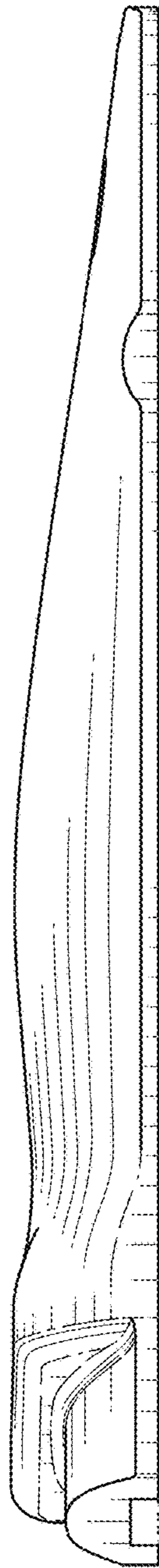

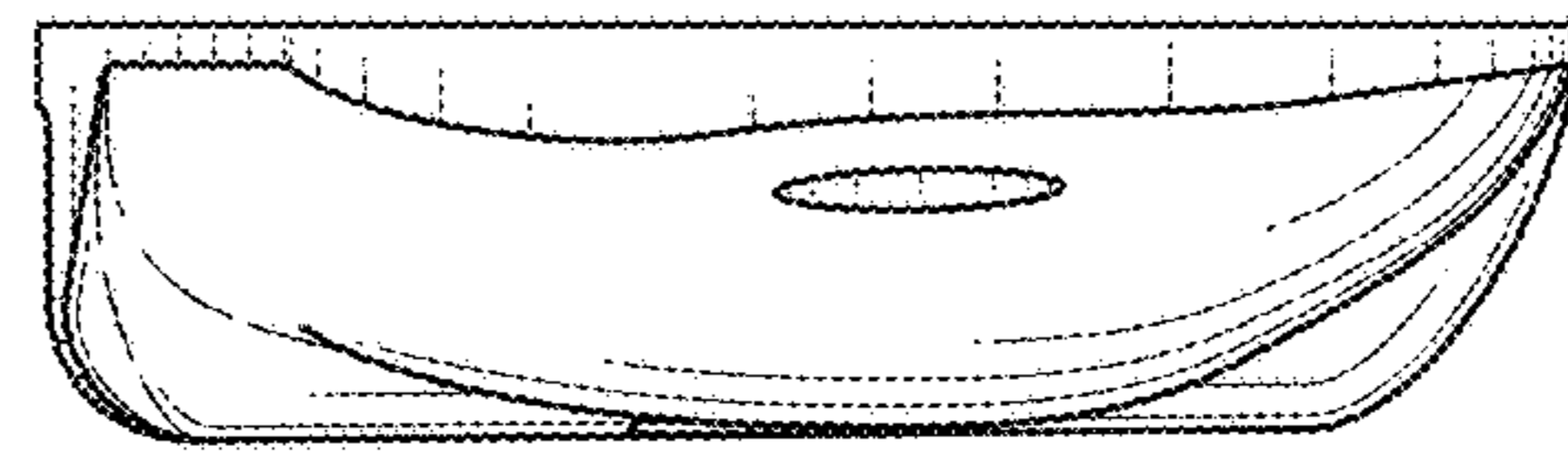

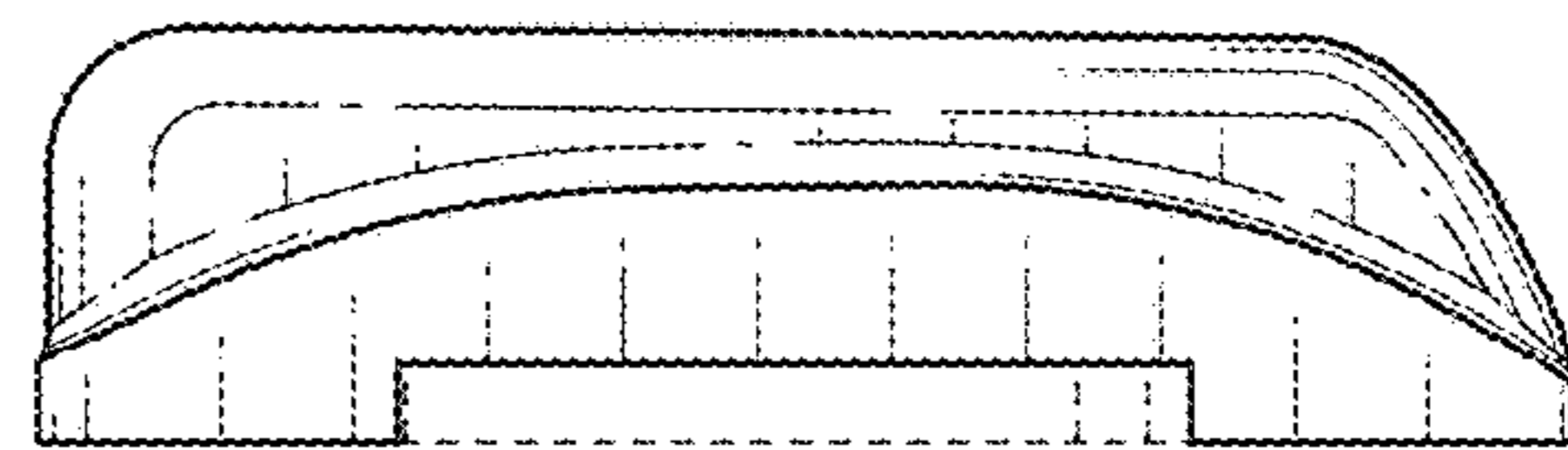

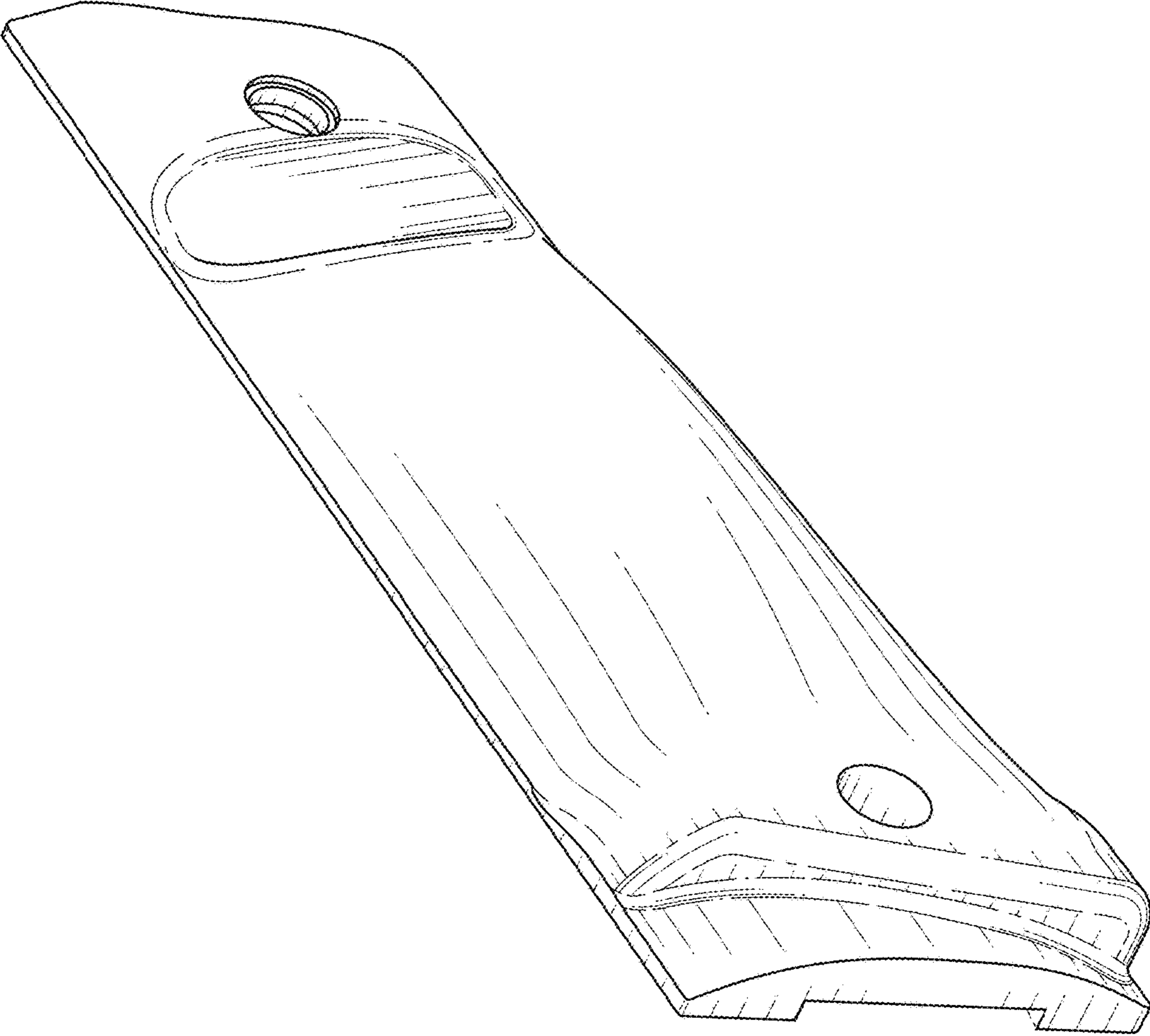

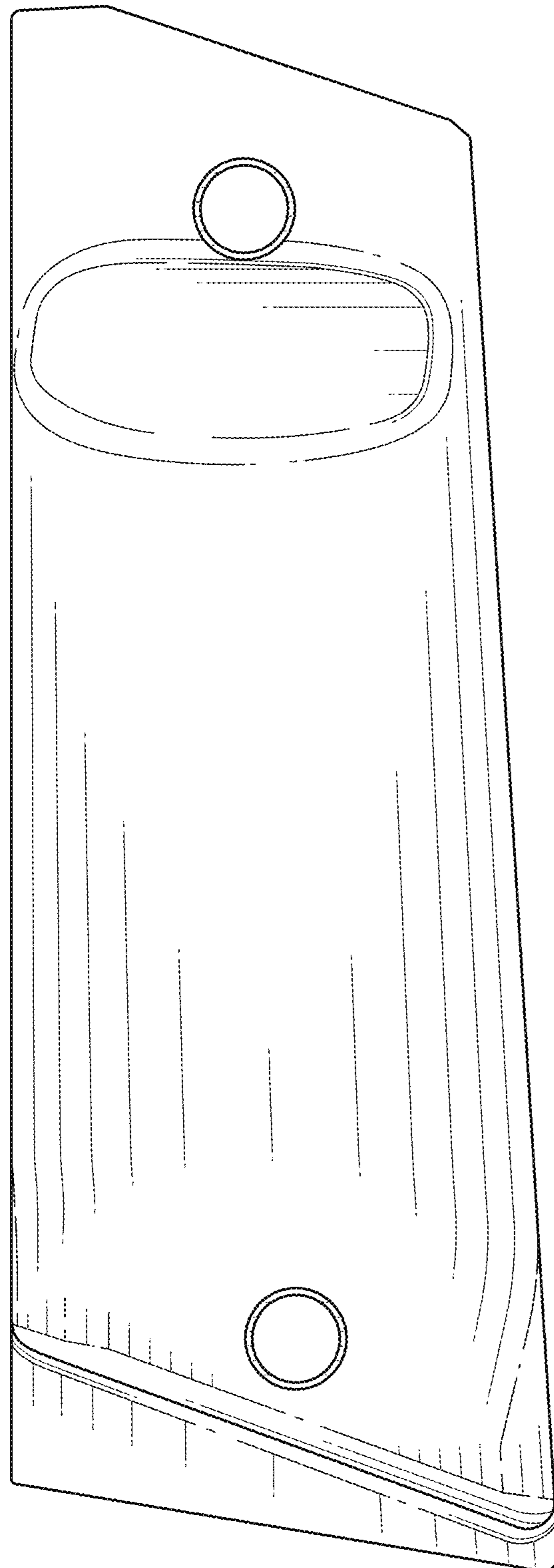

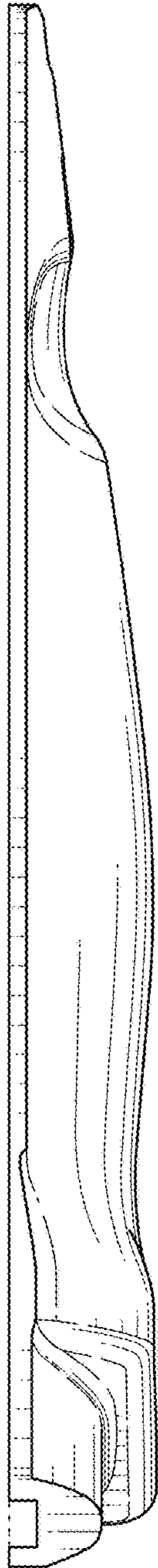

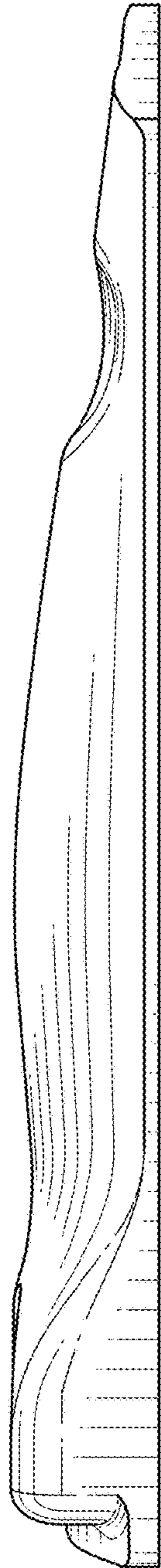

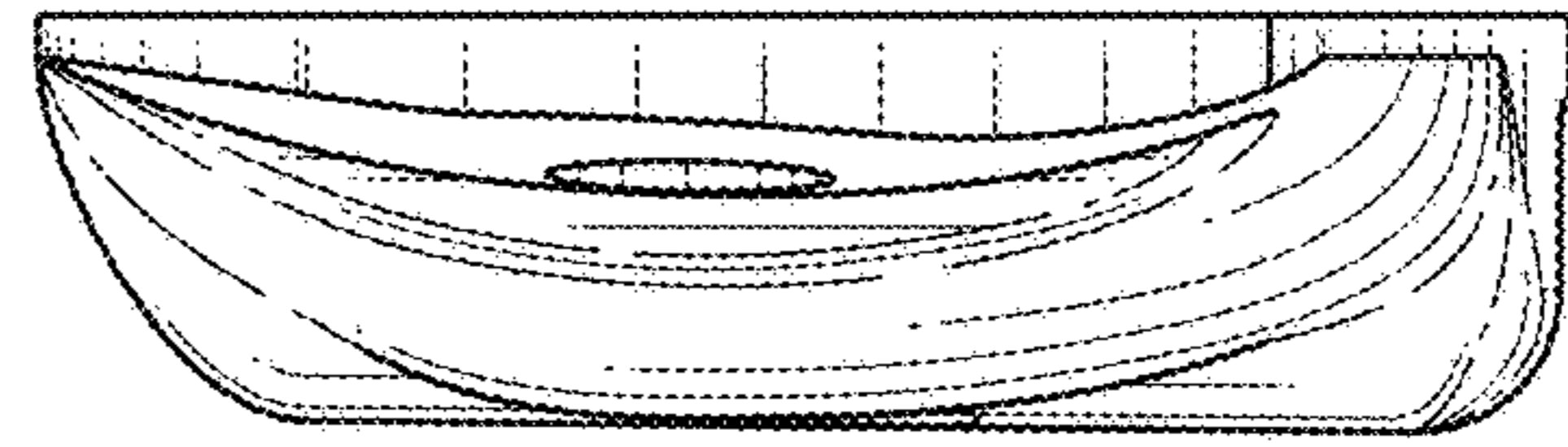

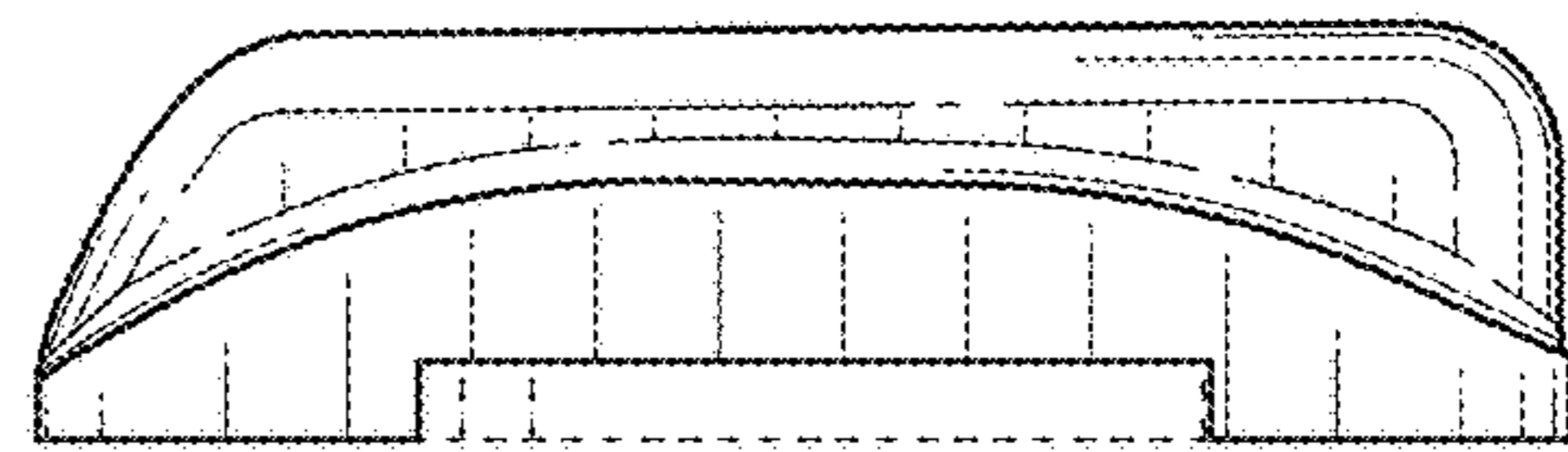
