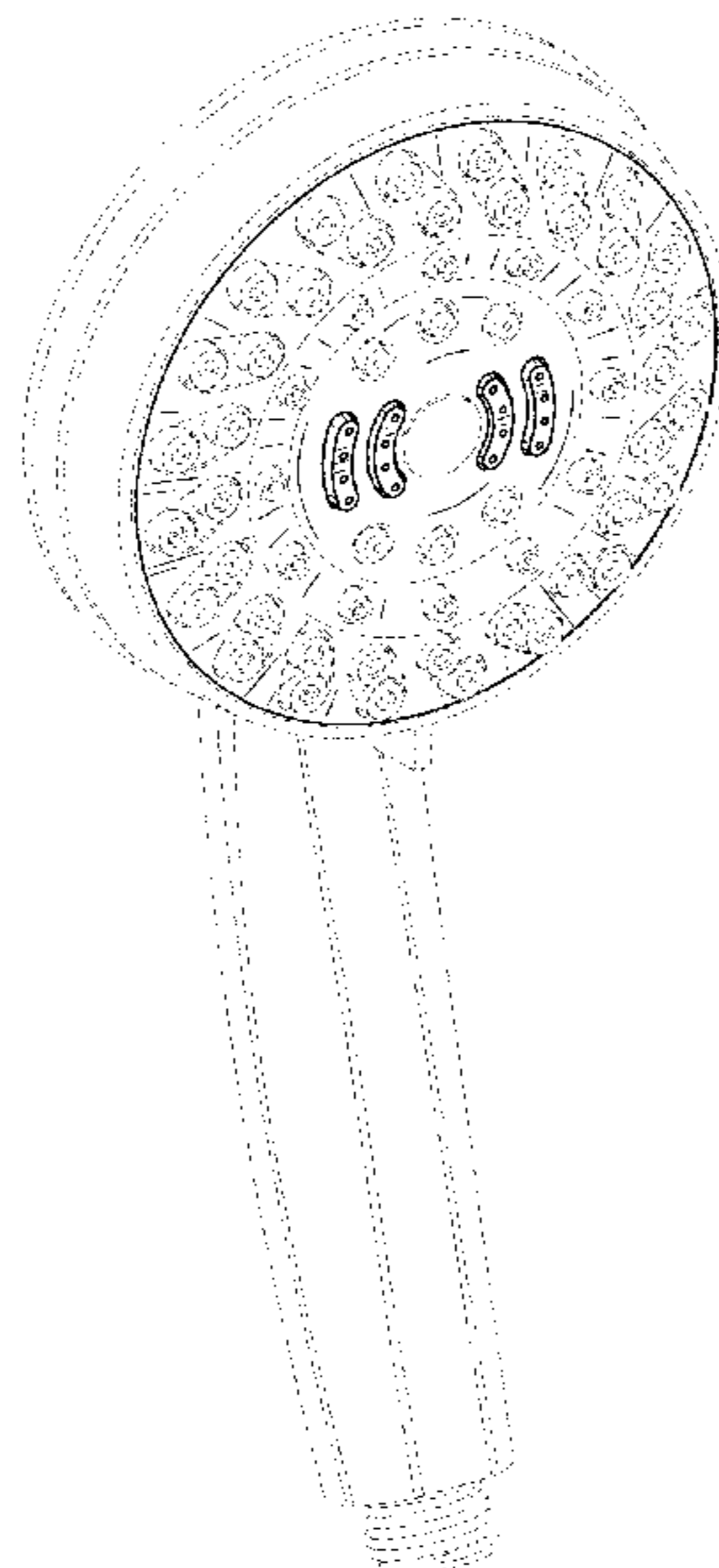
FIG. 1 is a front isometric view of a nozzle arrangement of a showerhead.

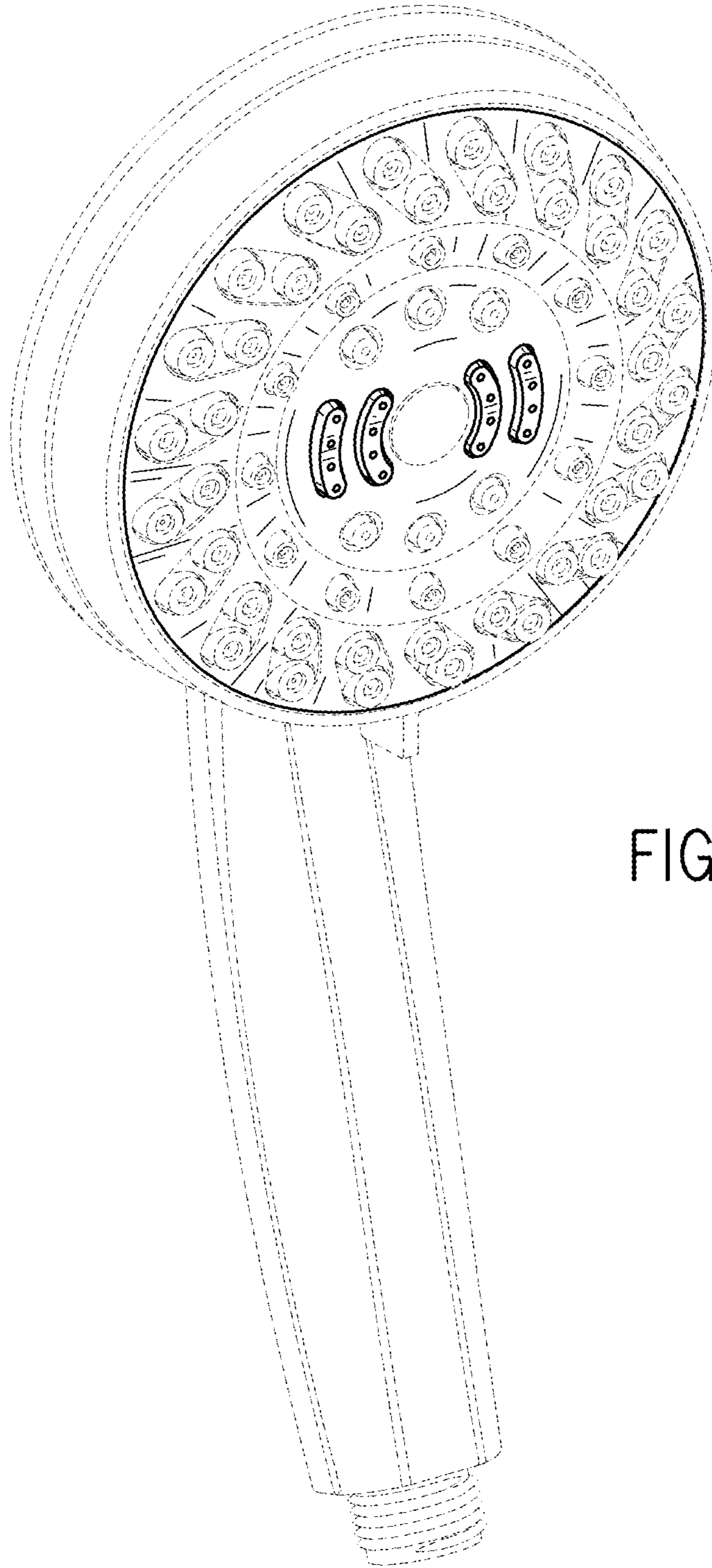

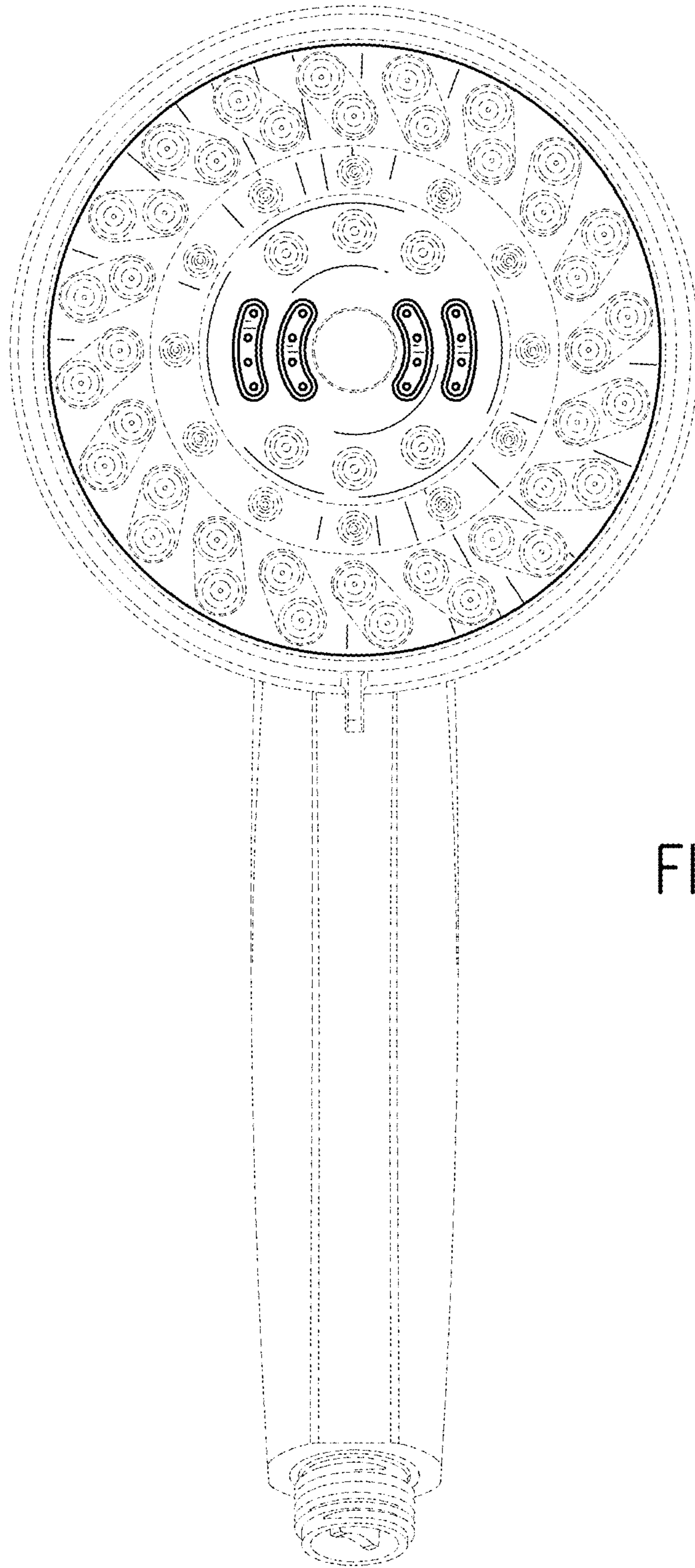

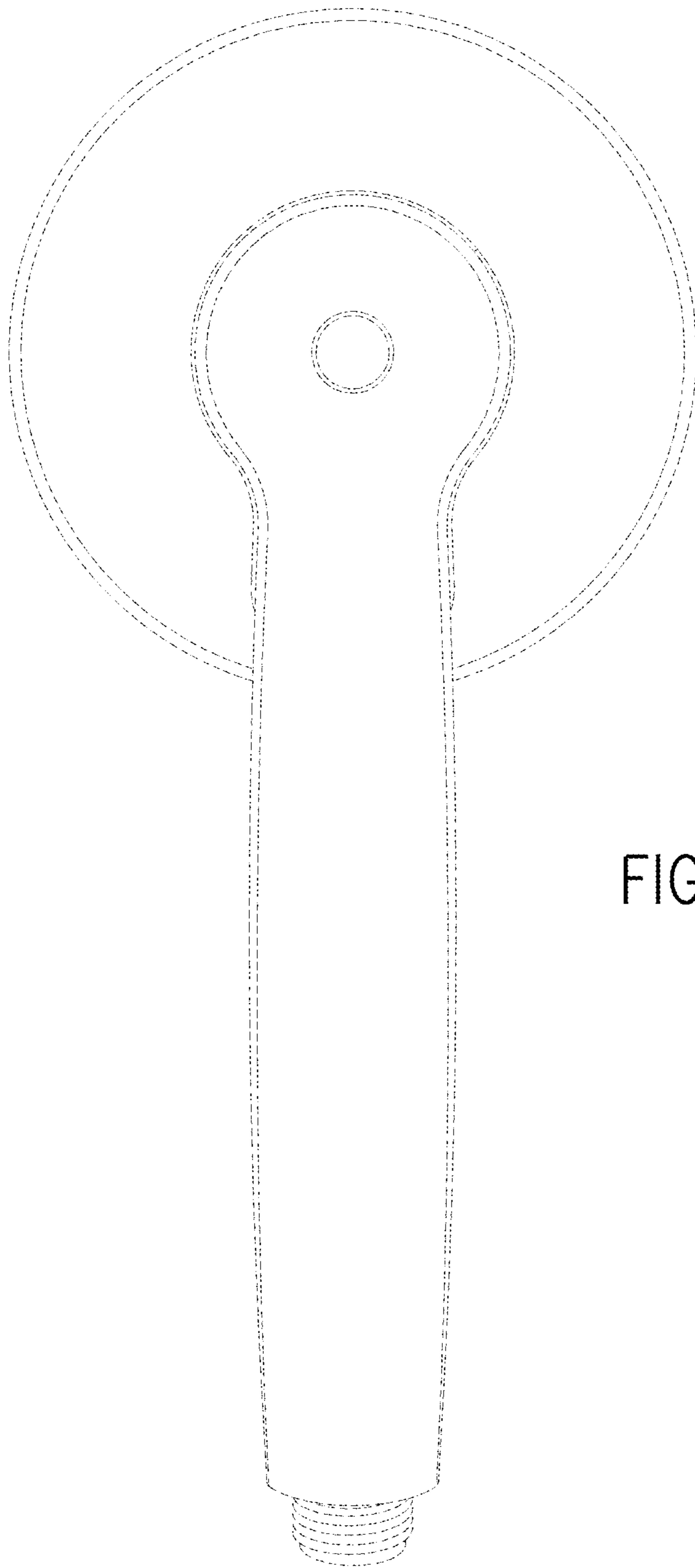

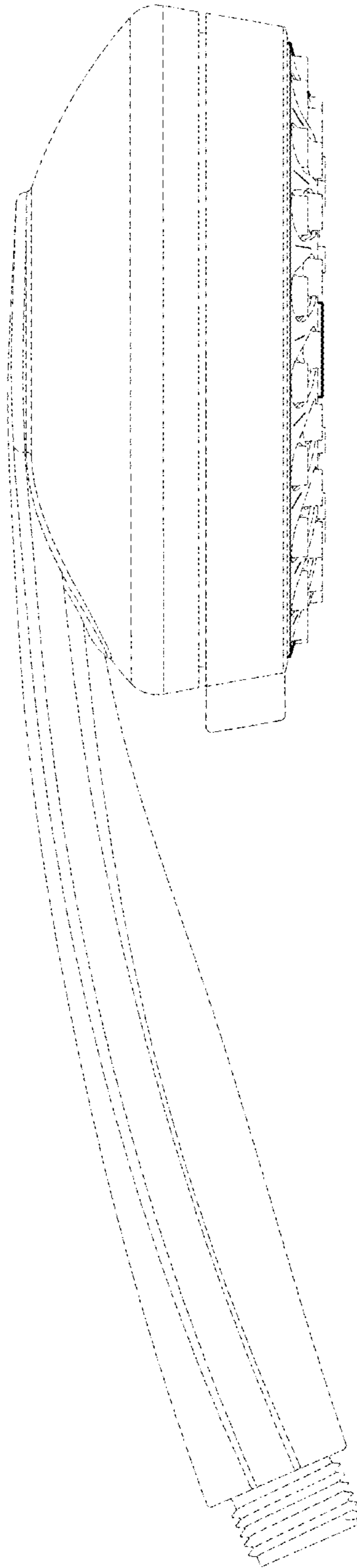

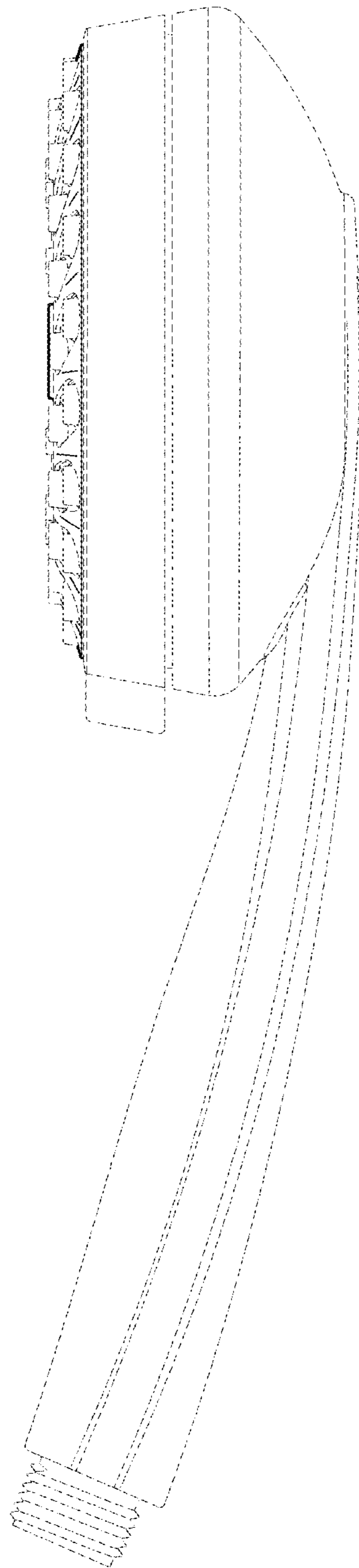

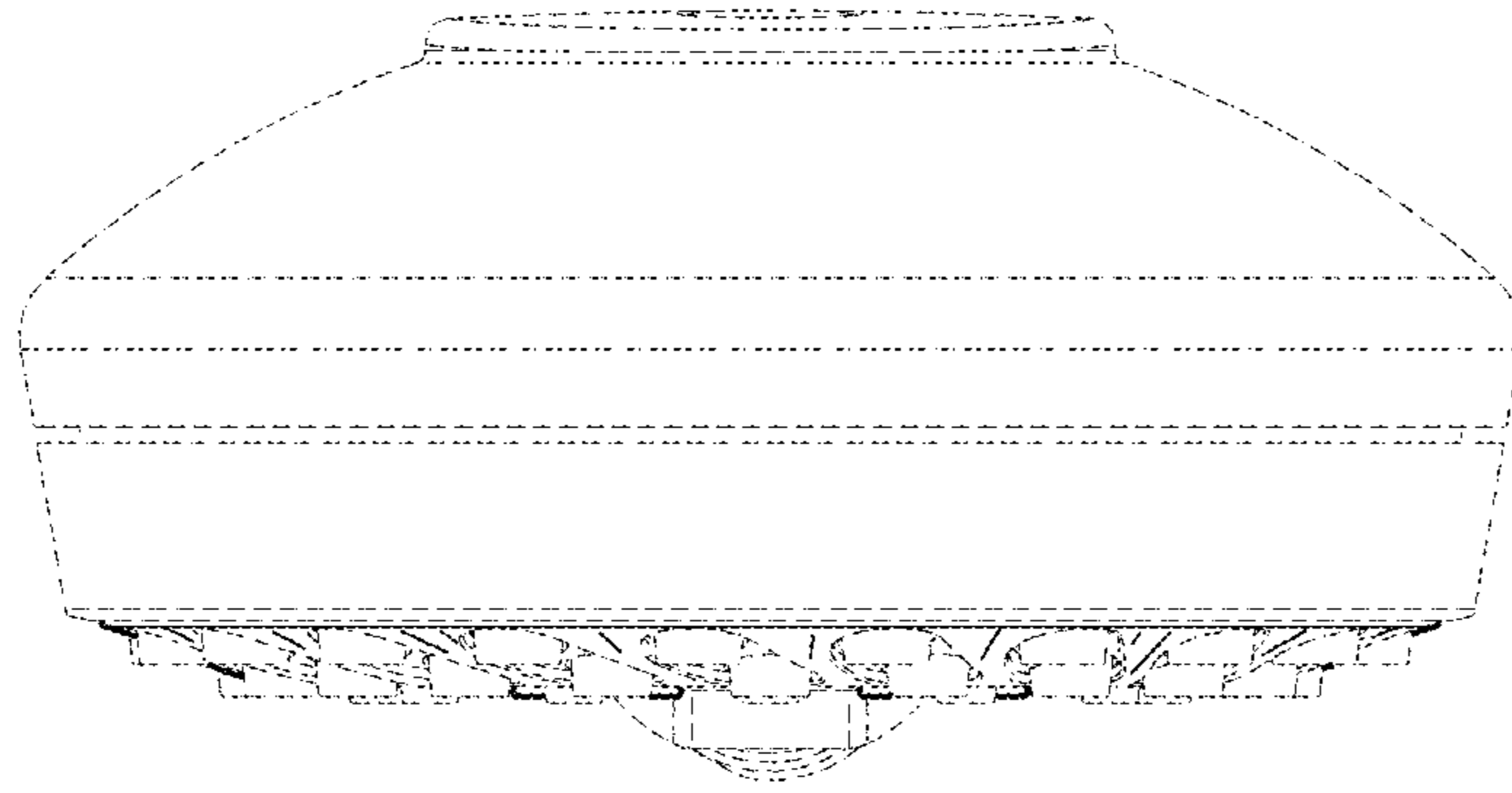

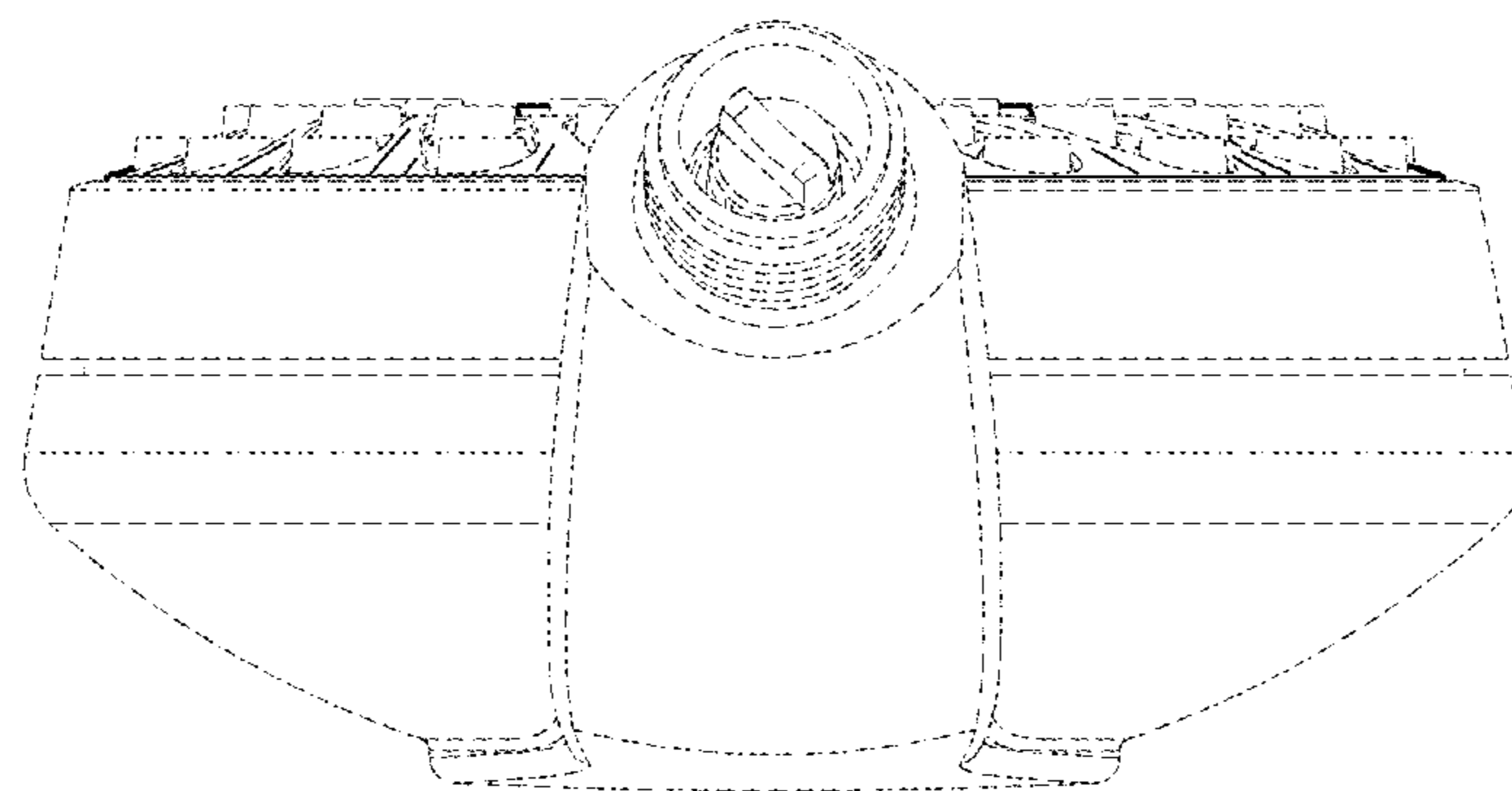
