I claim the ornamental design for a faucet, as shown and described.

**DESCRIPTION**

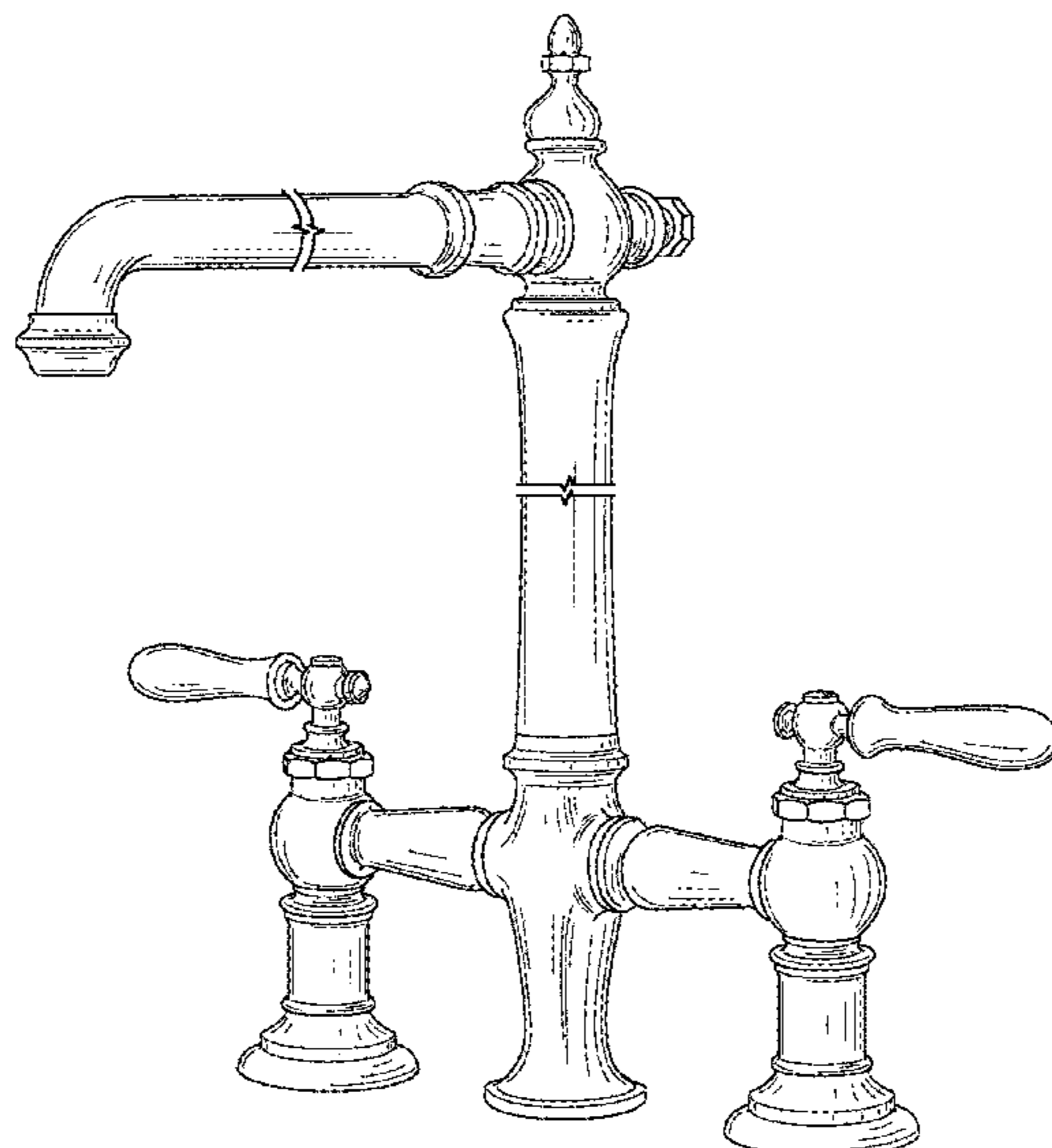
FIG. 1 is a top, front, left perspective view of an embodiment of the claimed design;

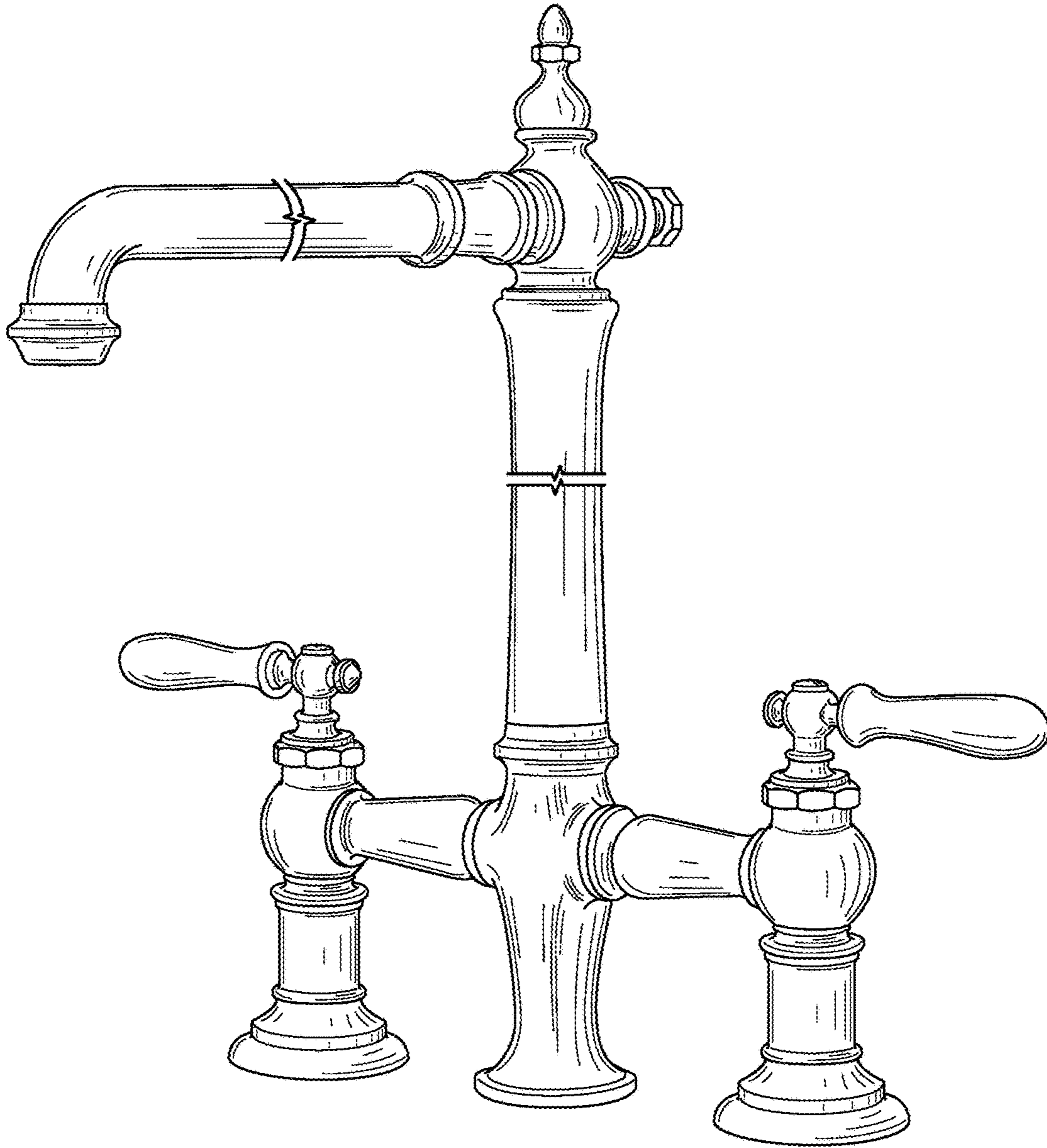

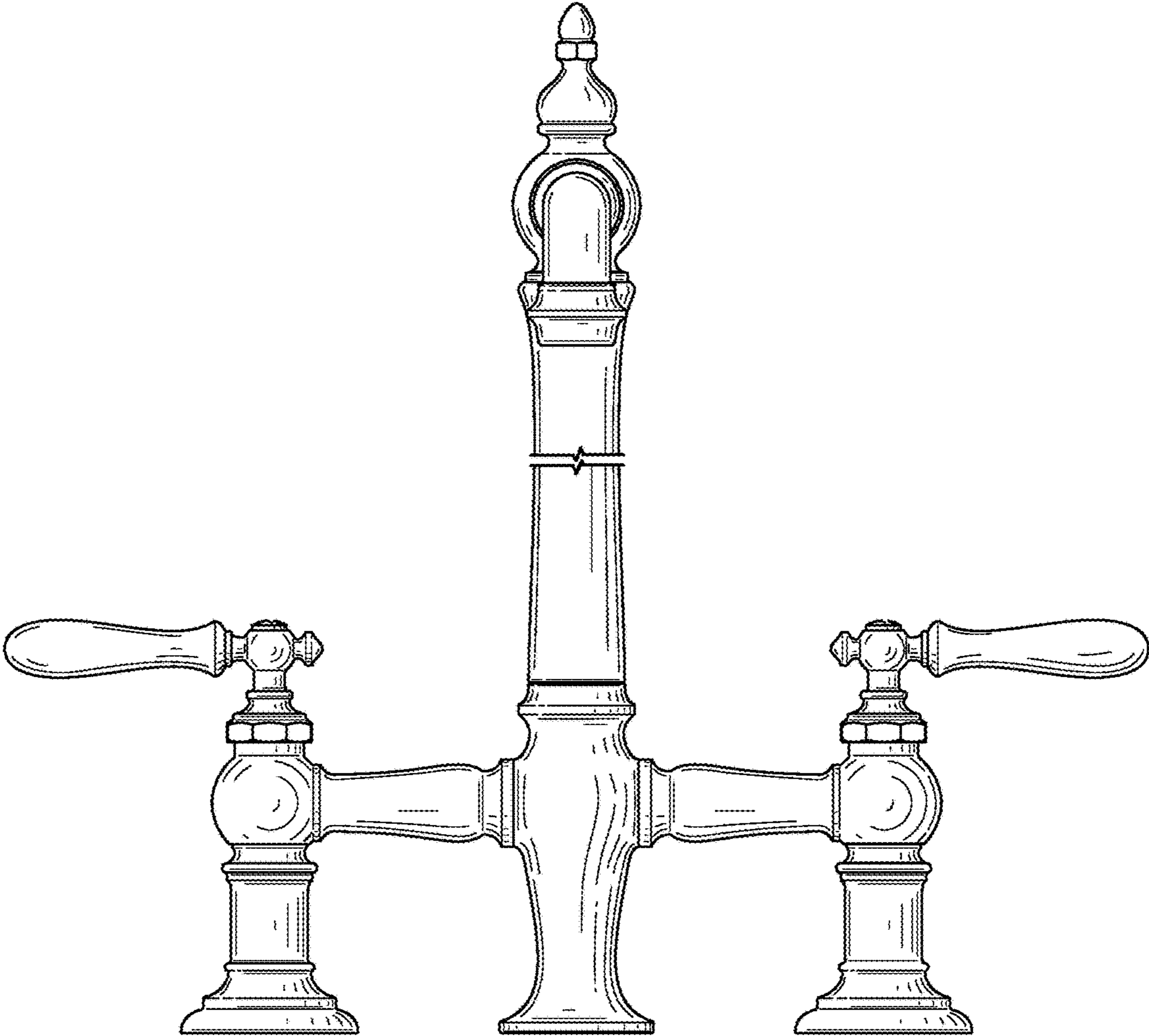

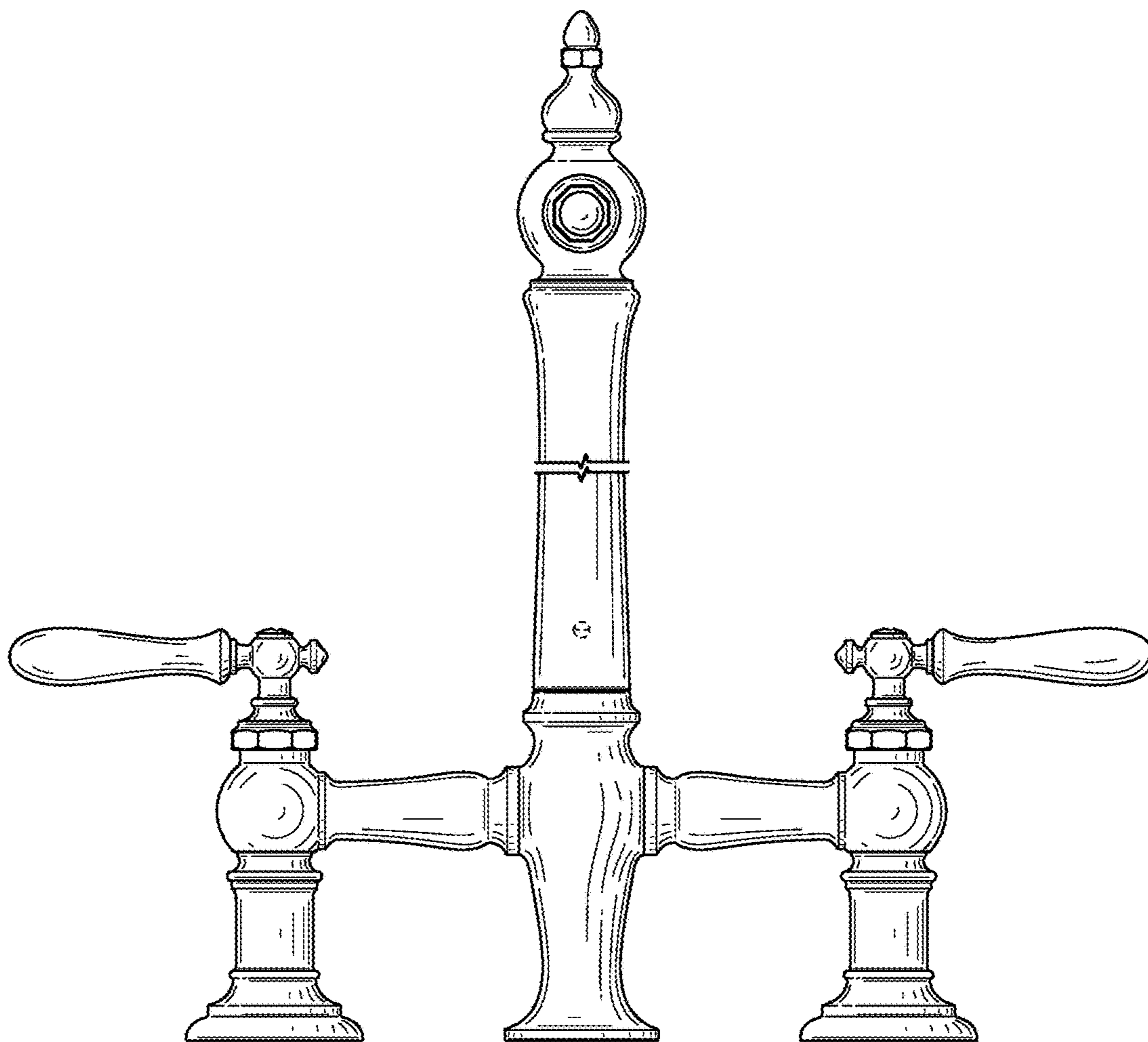

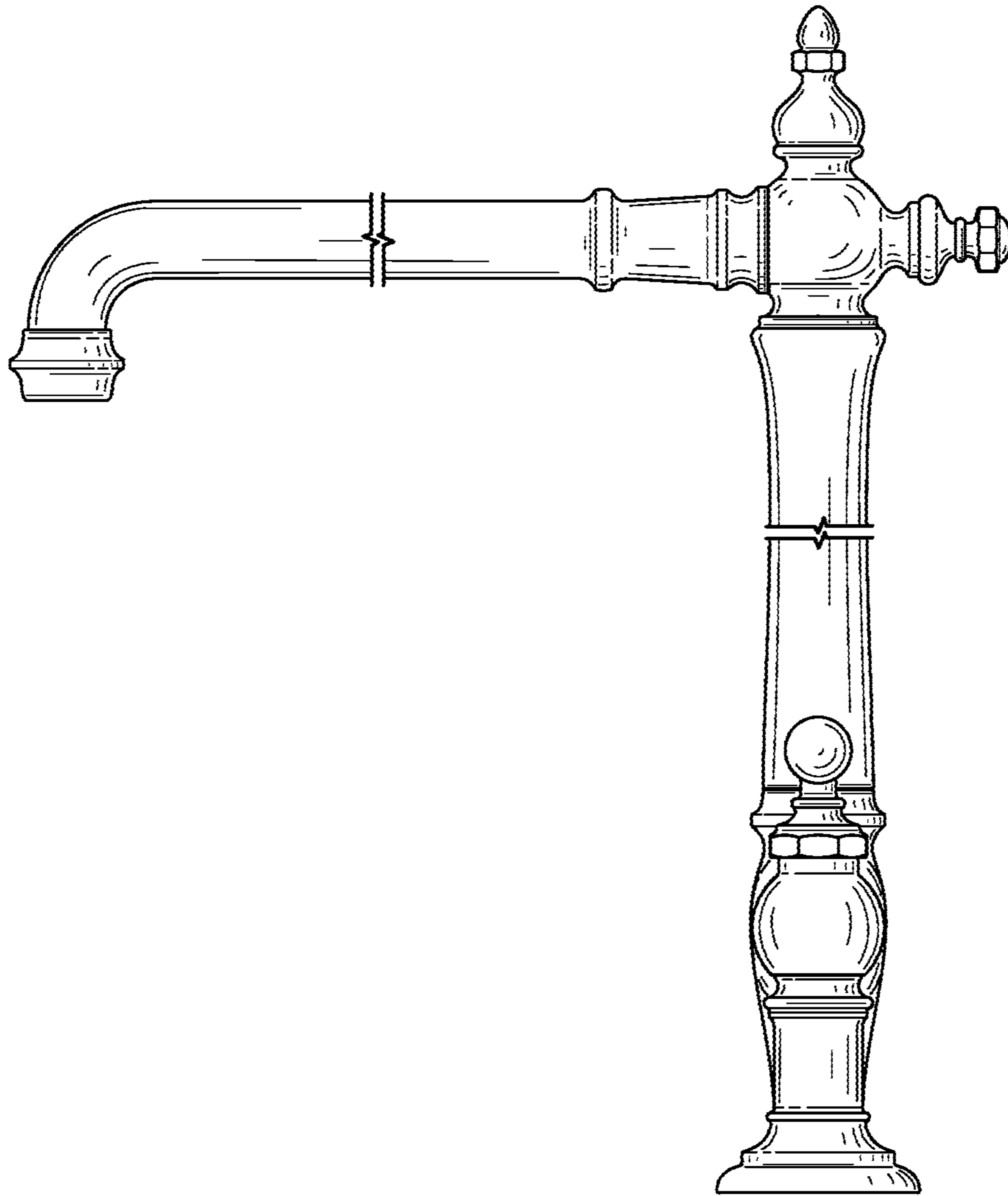

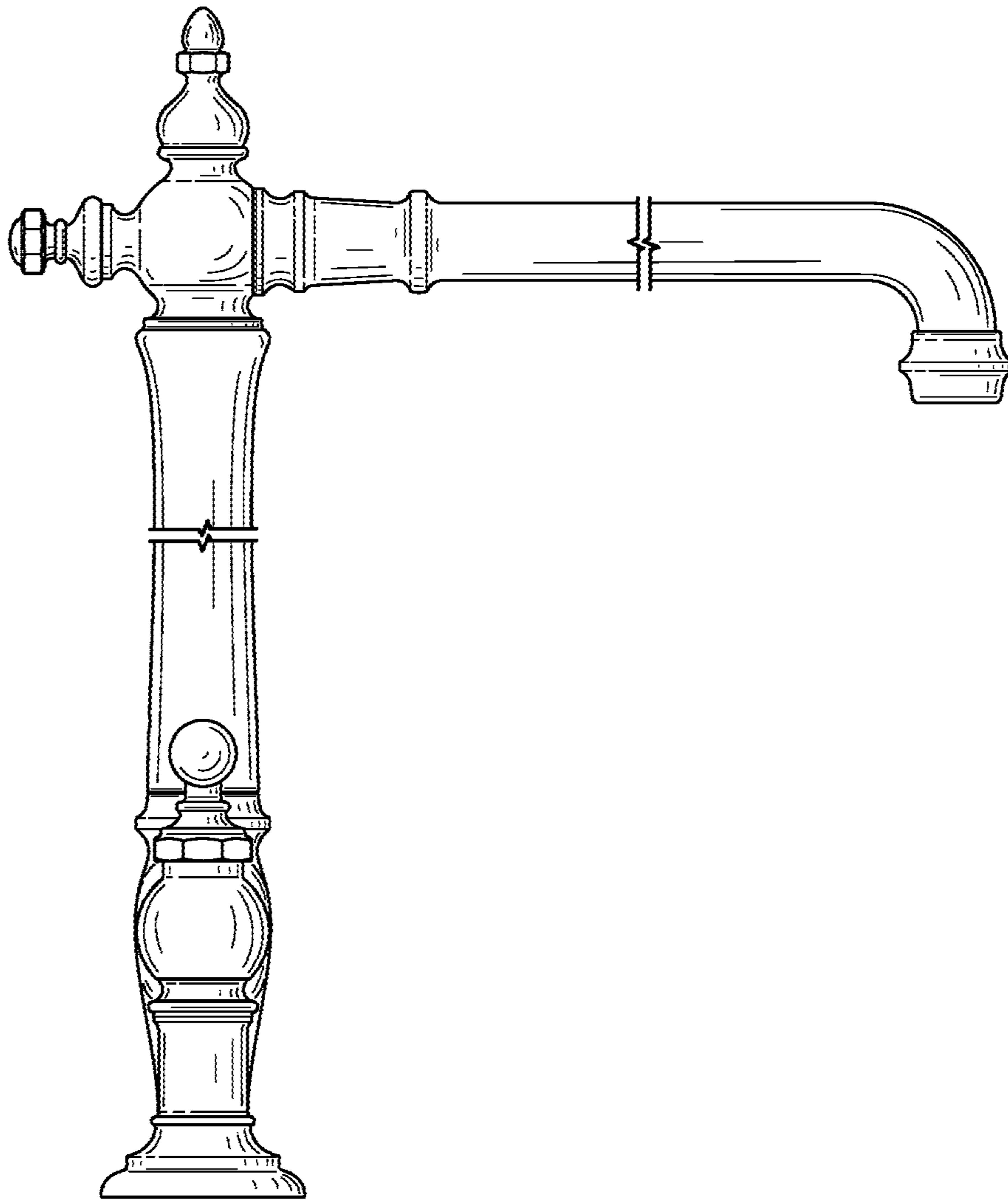

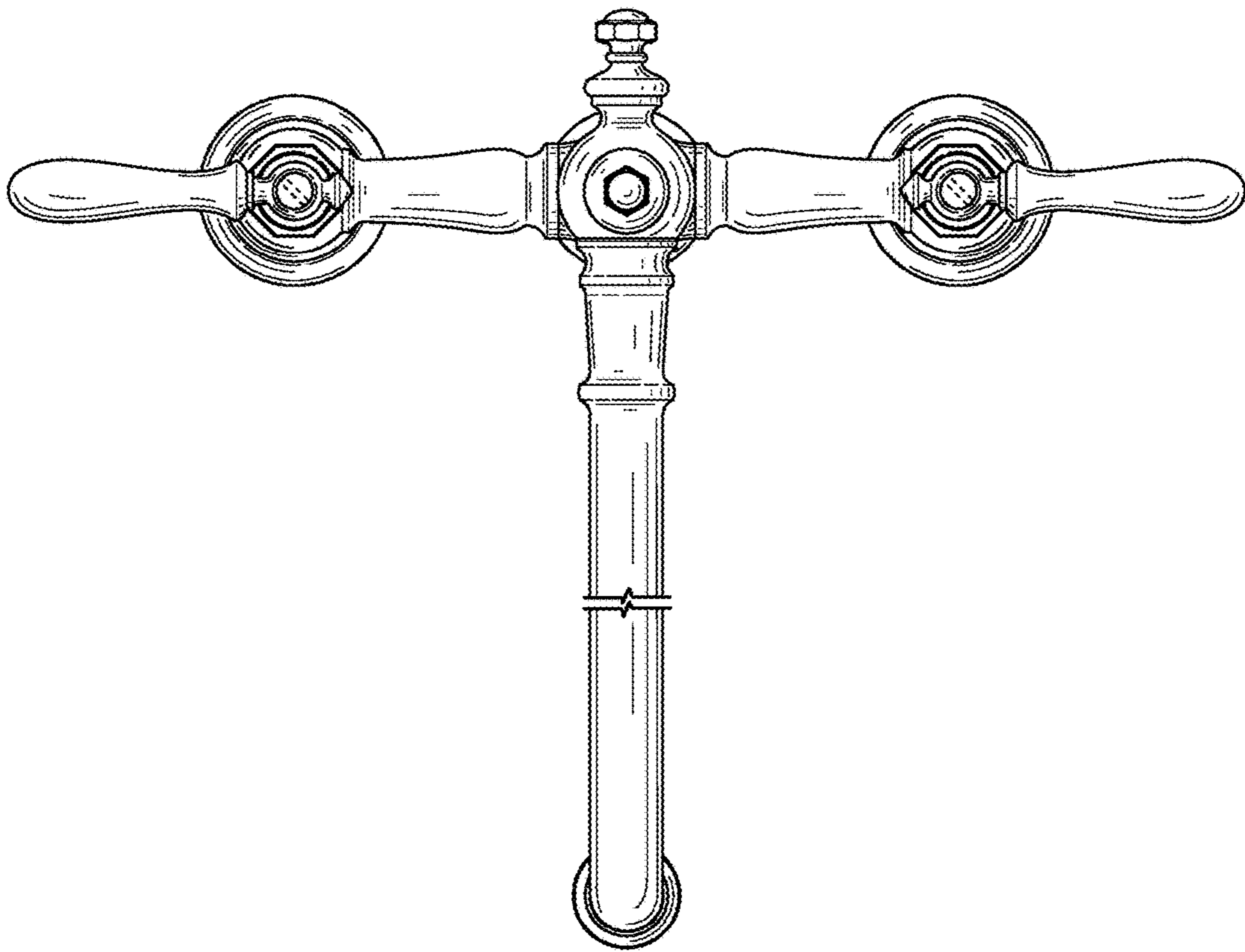

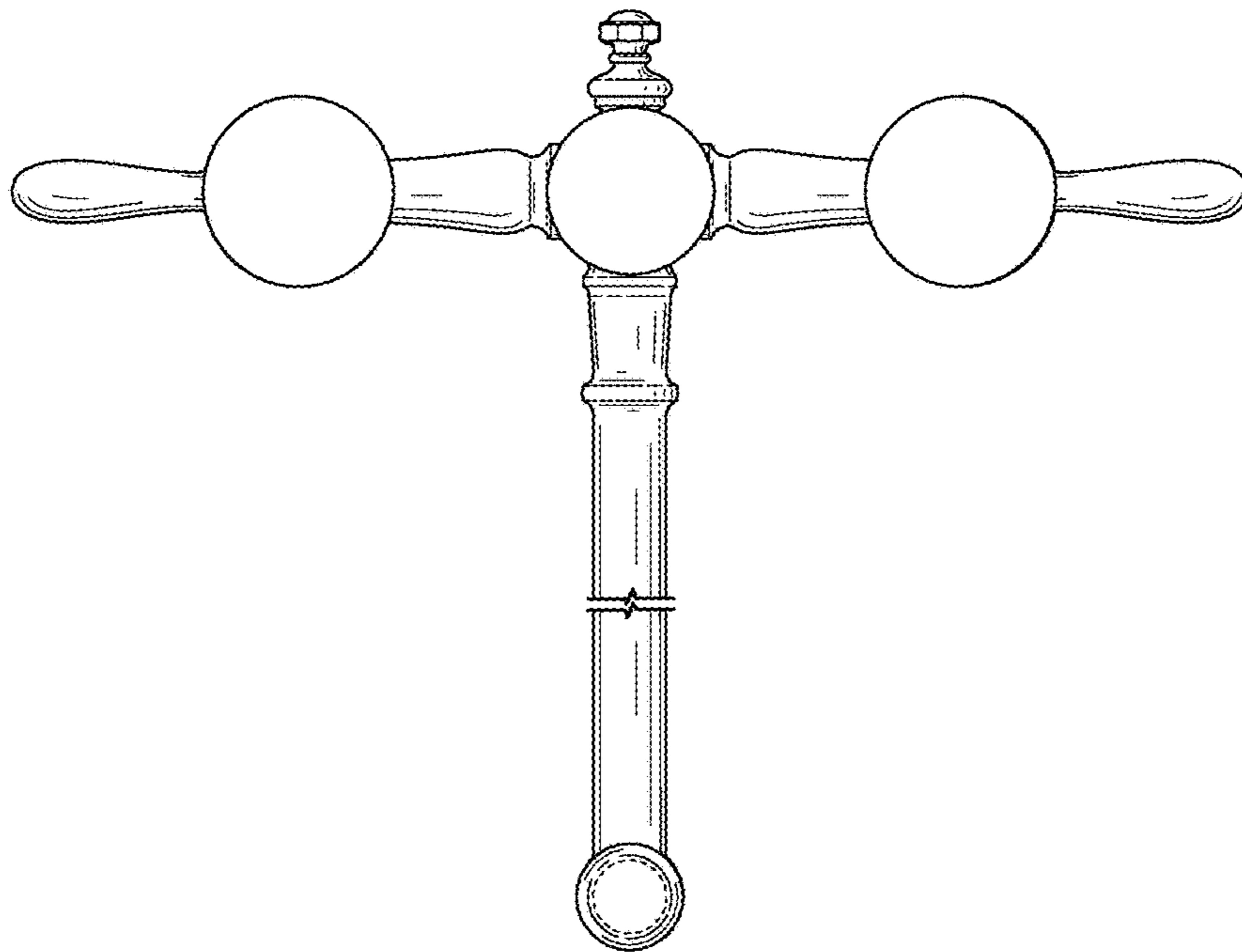
