(57) **CLAIM**

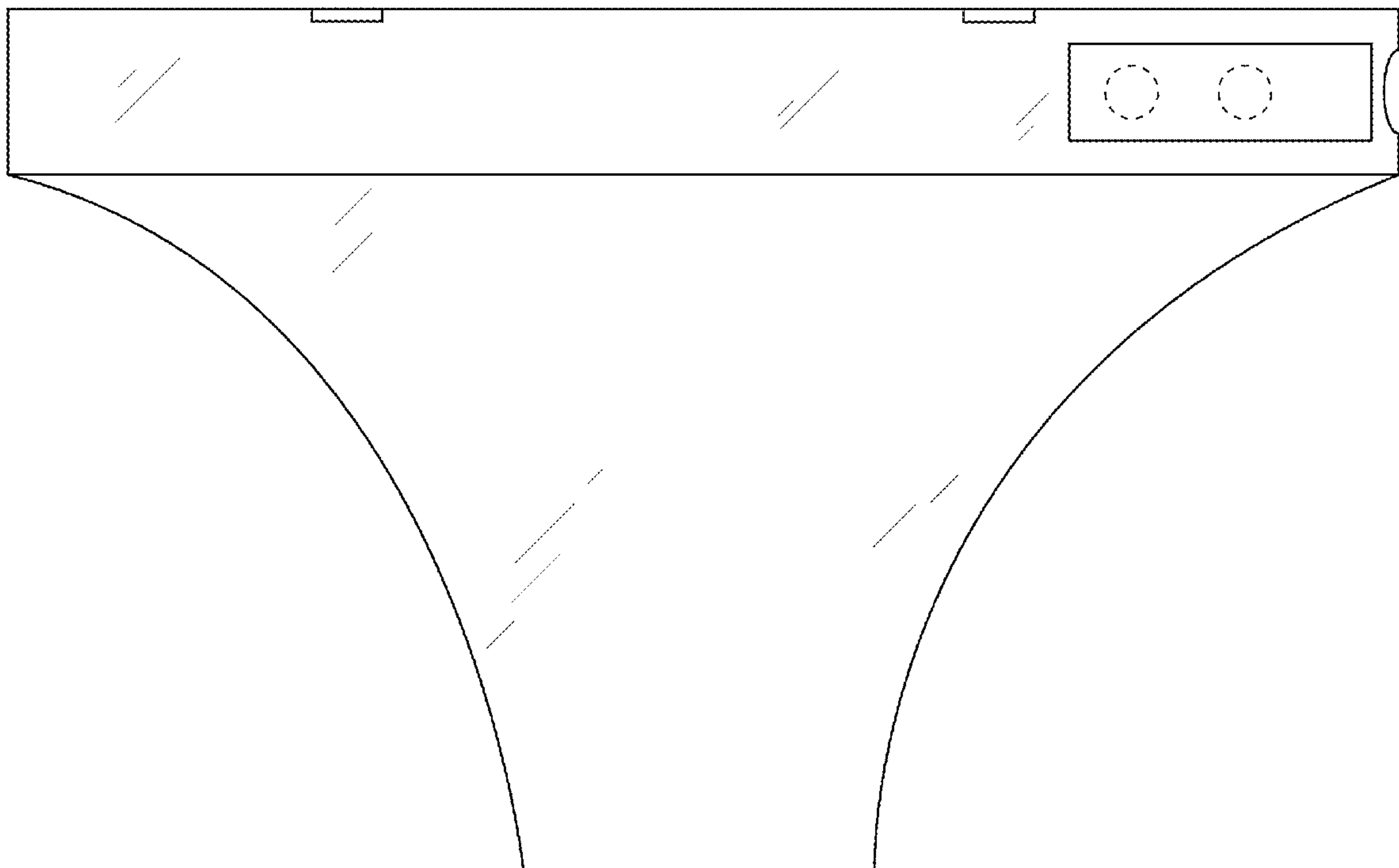
The ornamental design for a female pelvic heating pad, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a female pelvic heating pad showing my new design;

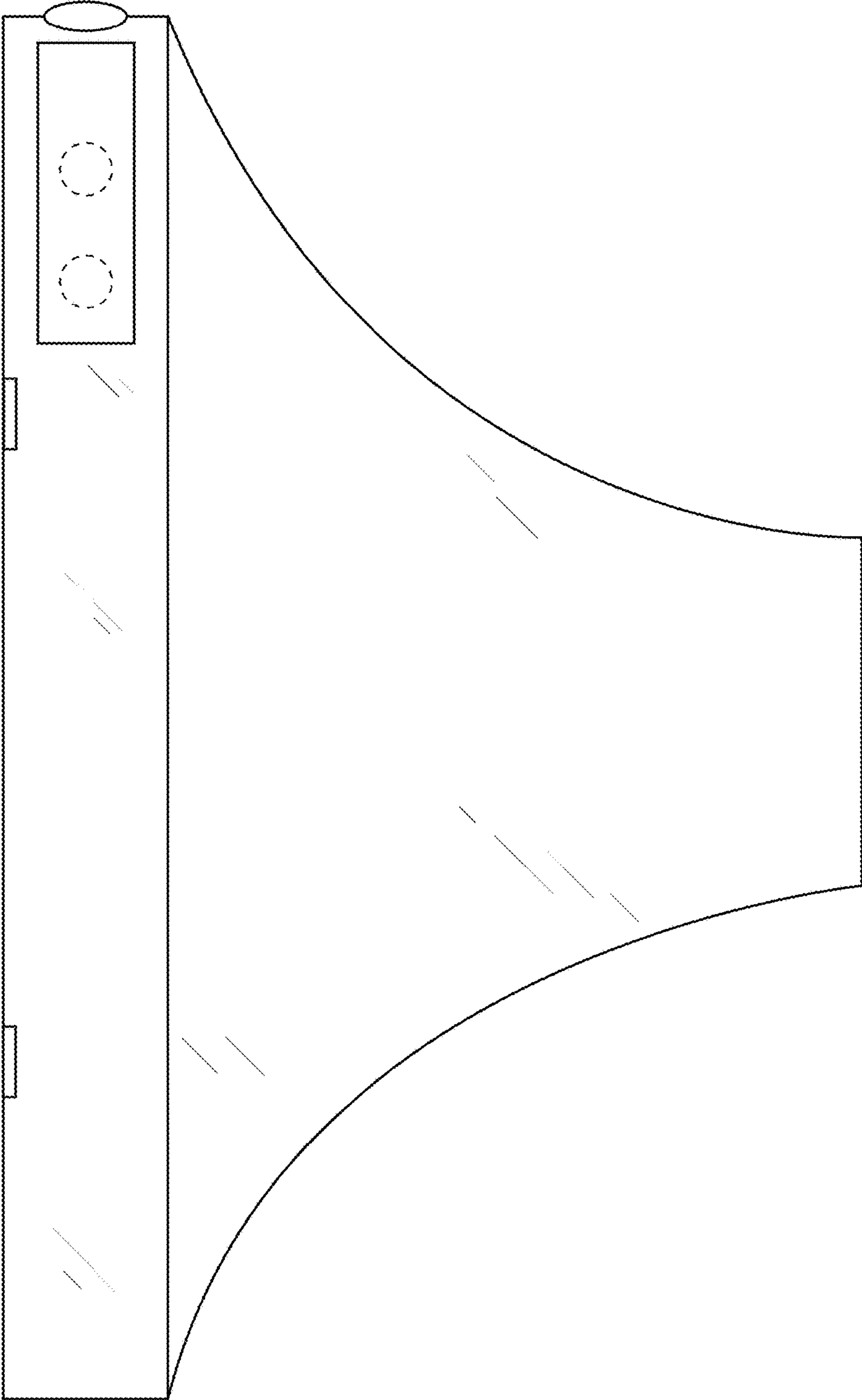

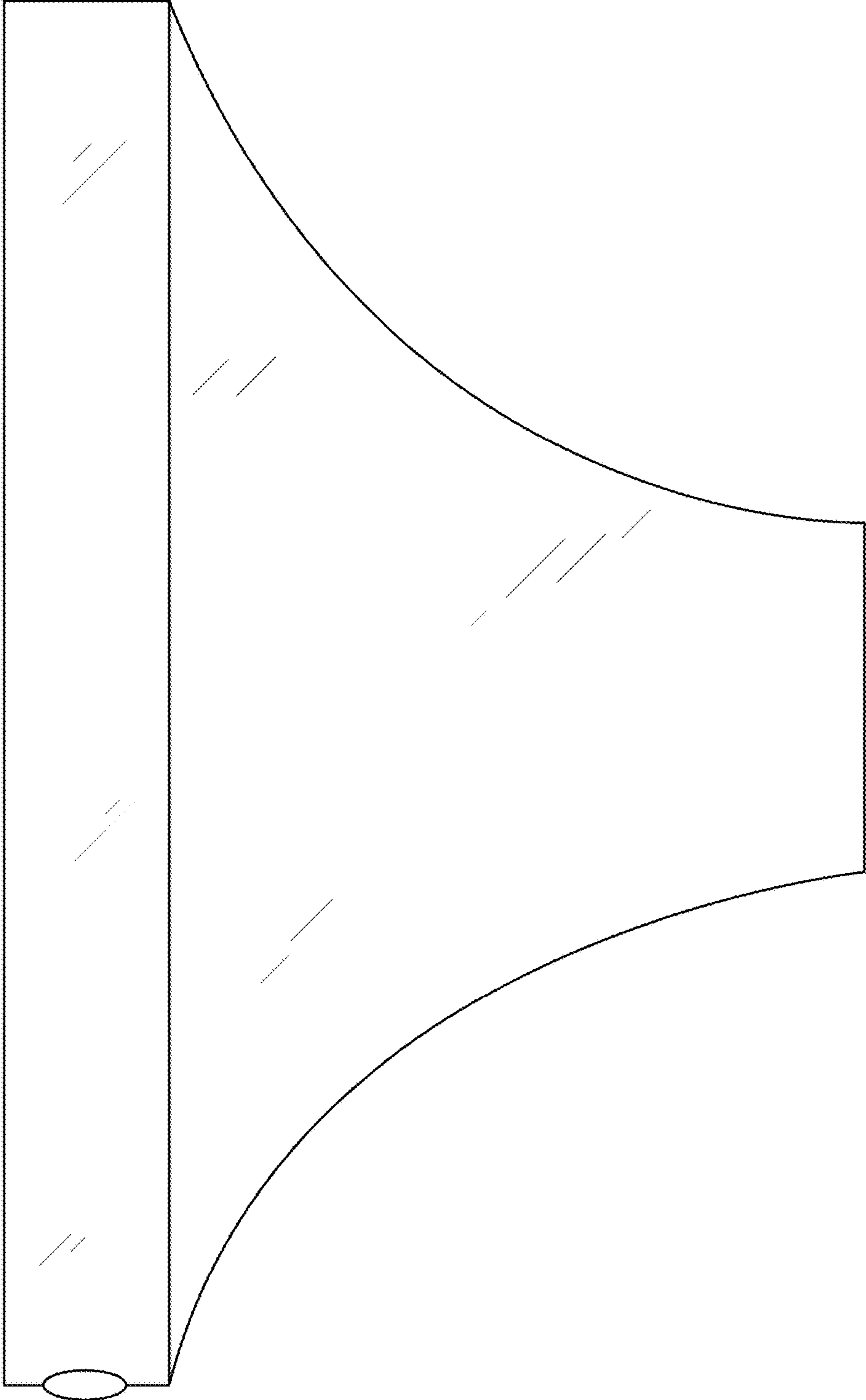

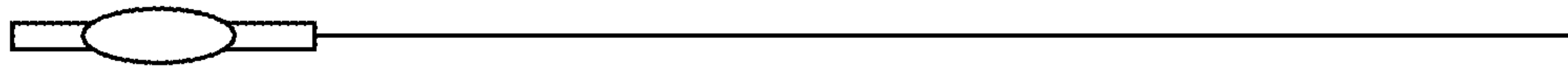

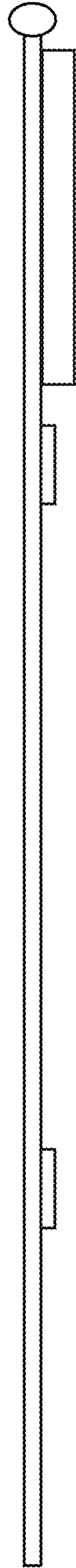

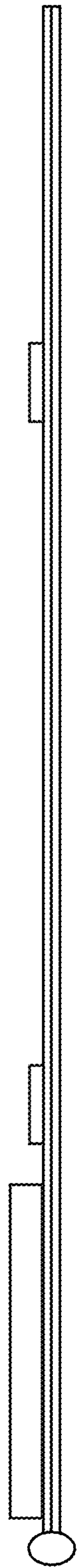
