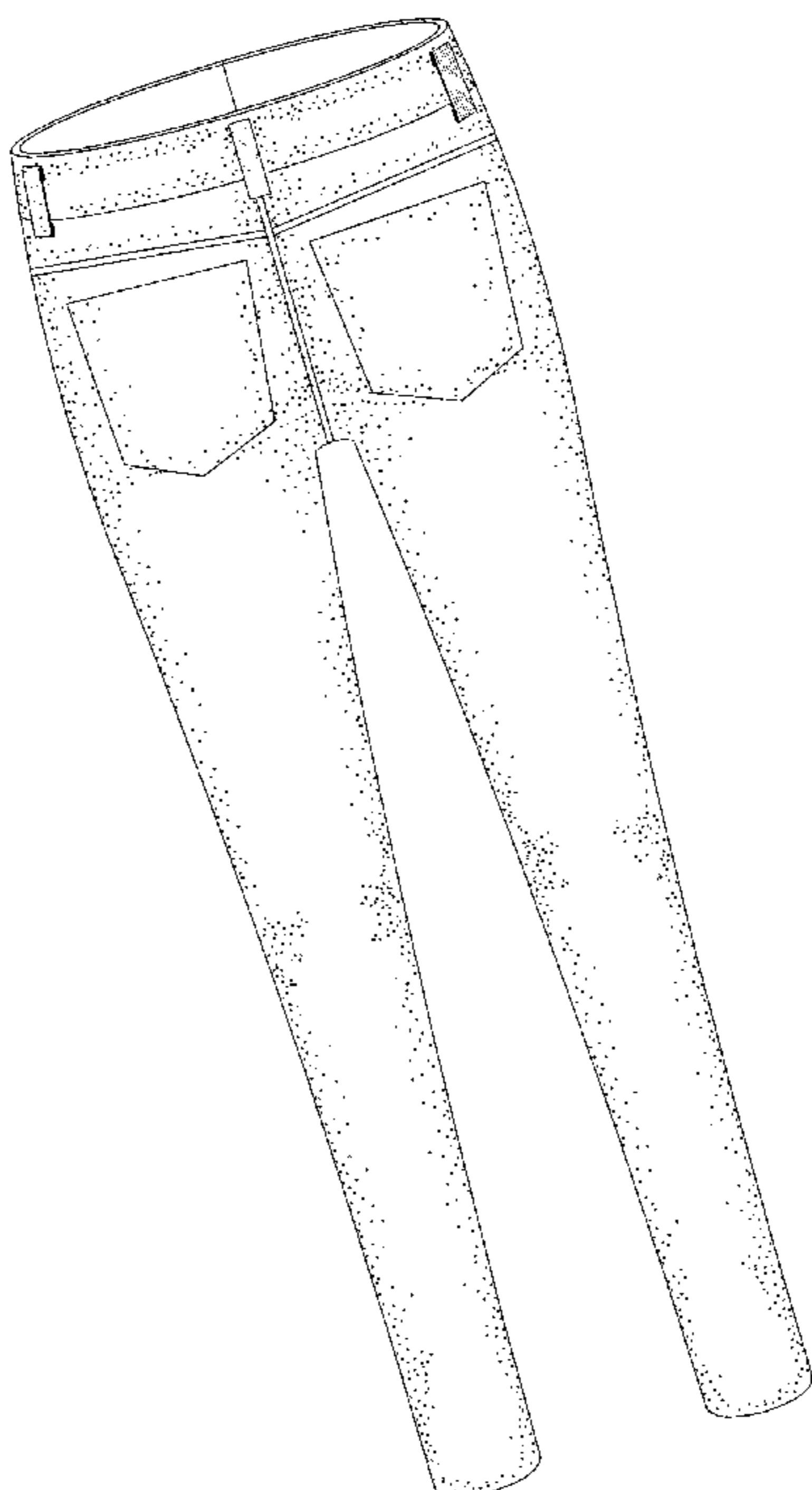
(57) **CLAIM**

The ornamental design for denim pants having one belt loop, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of denim pants showing my new design, having a leather belt loop;

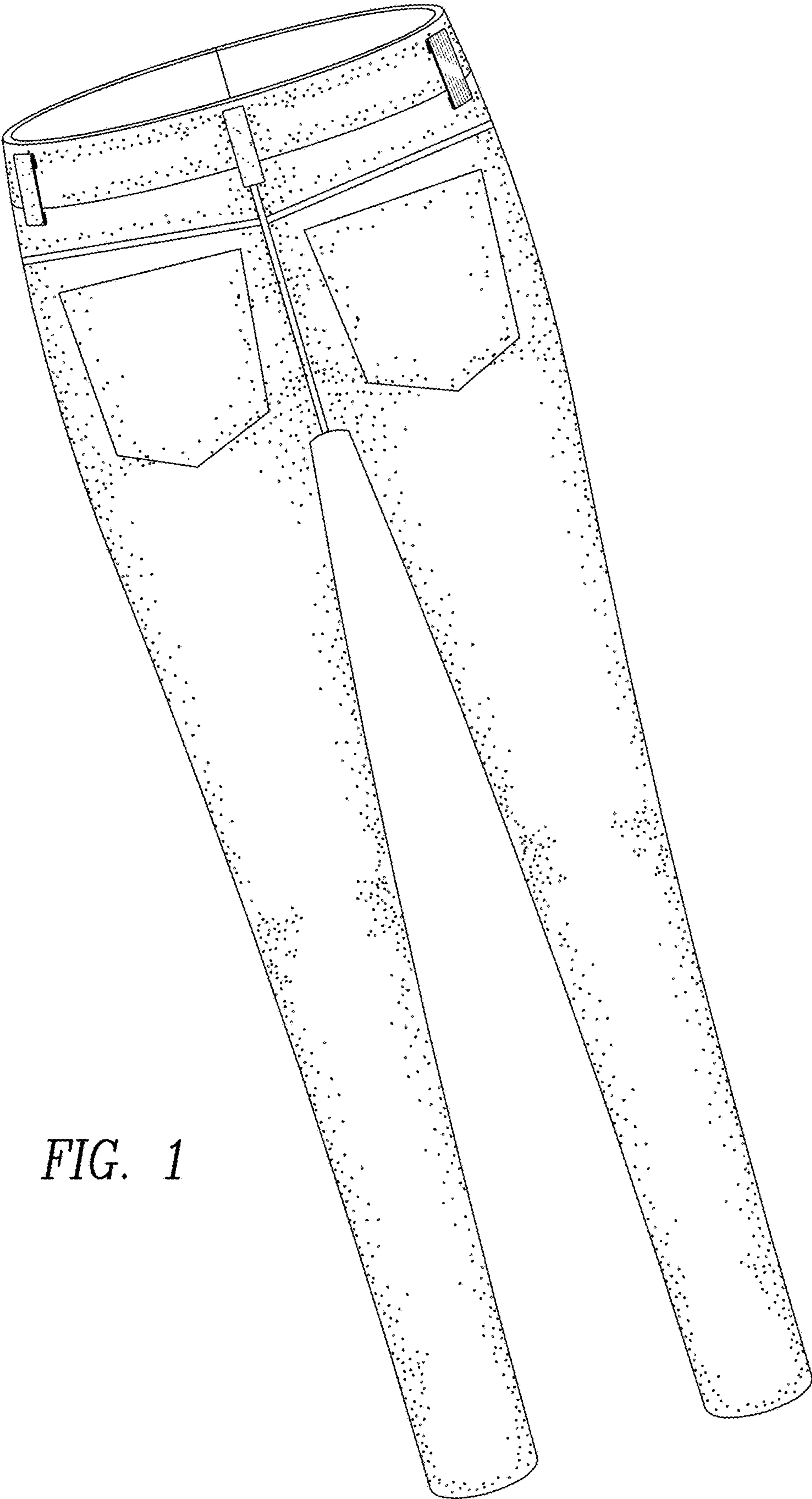

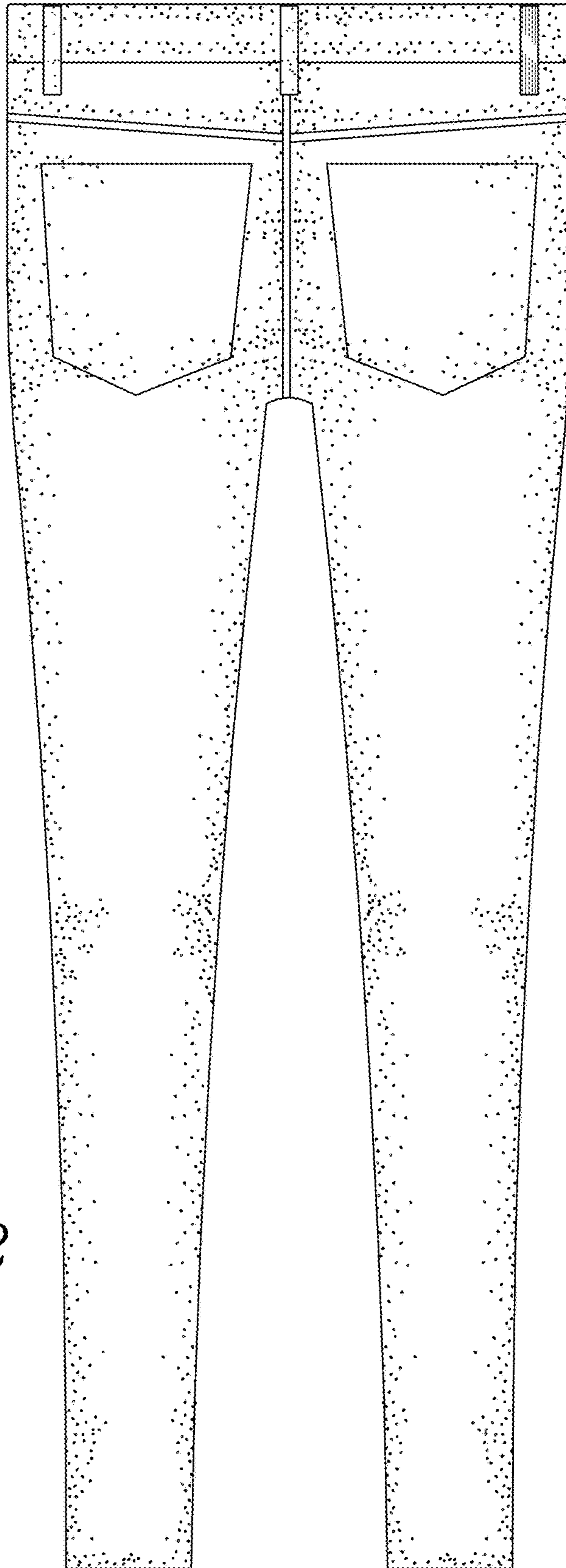

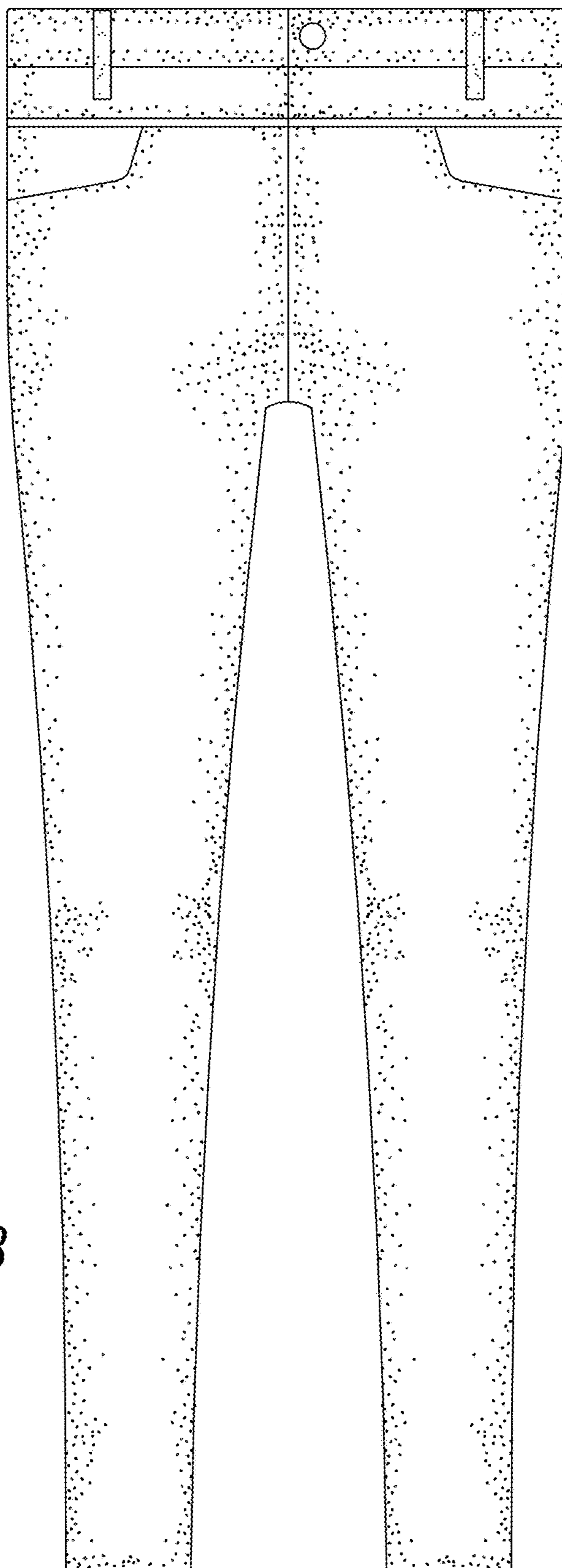

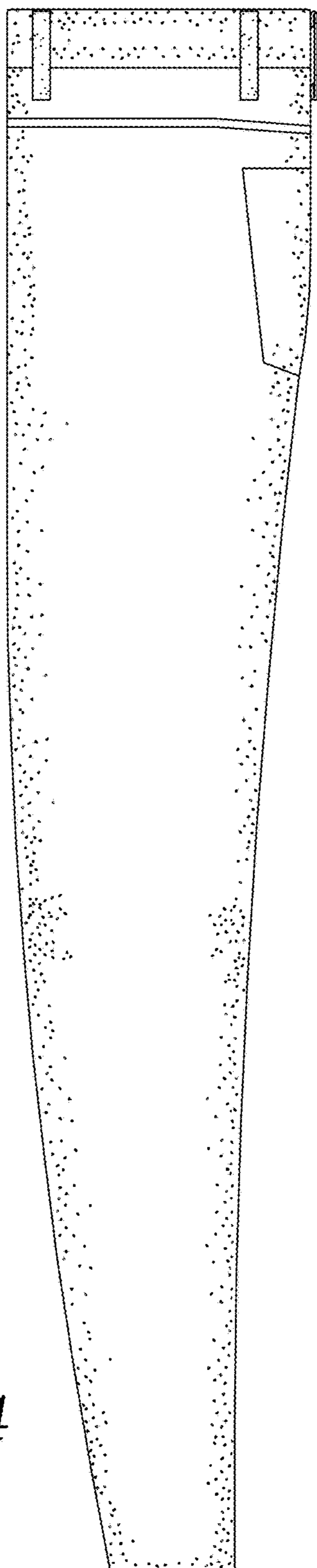

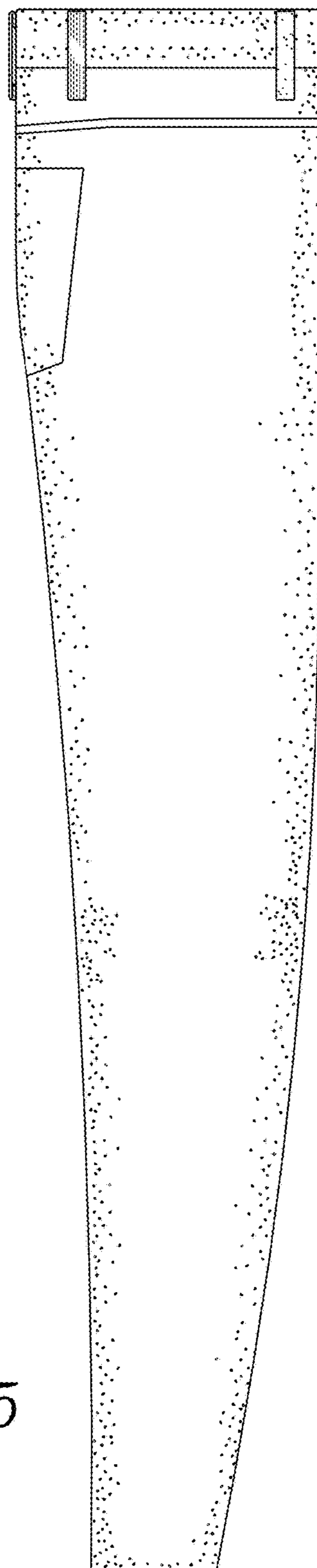

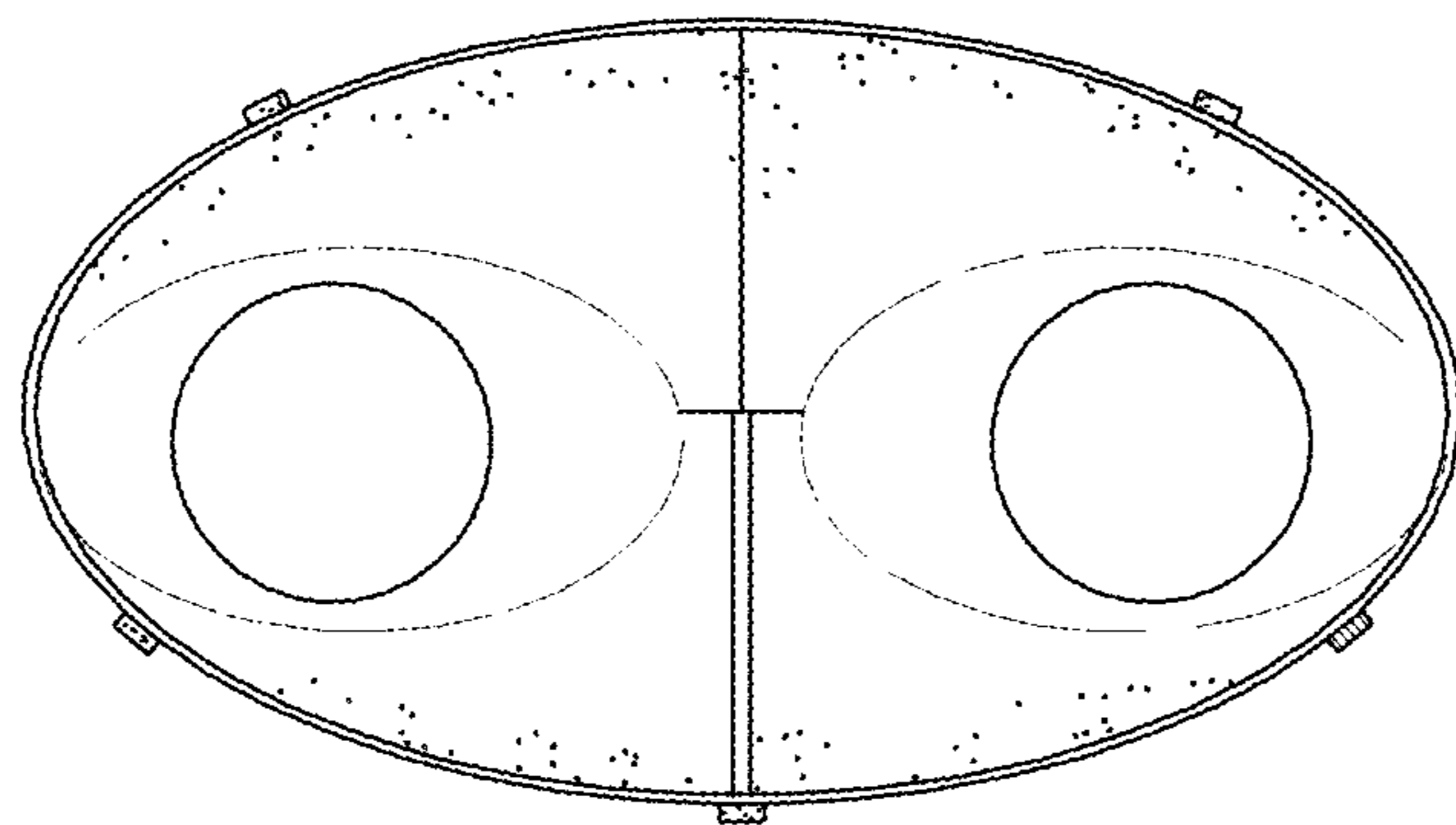

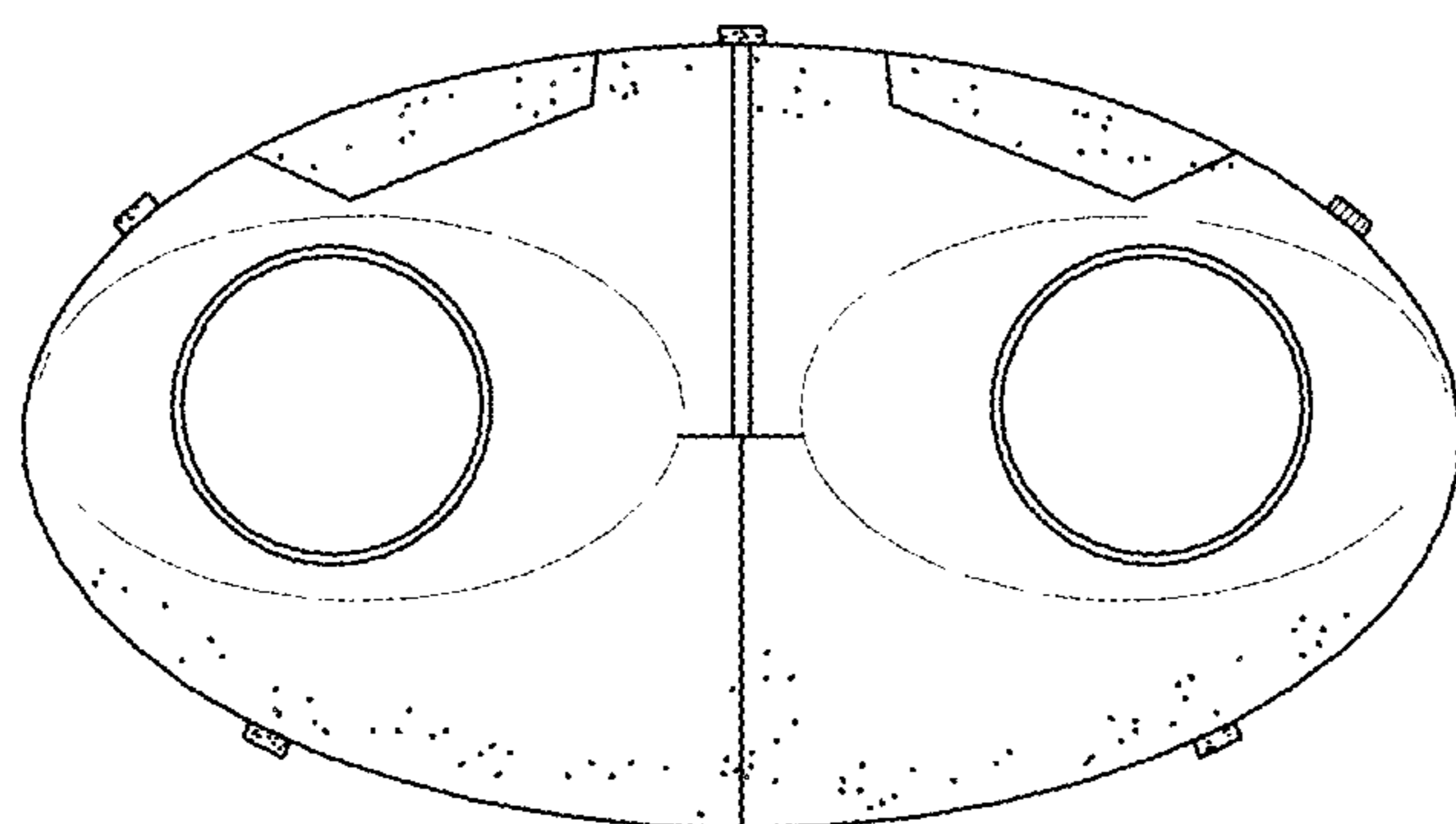
