(57) **CLAIM**

The ornamental design for a footwear tread, as shown and described.

**DESCRIPTION**

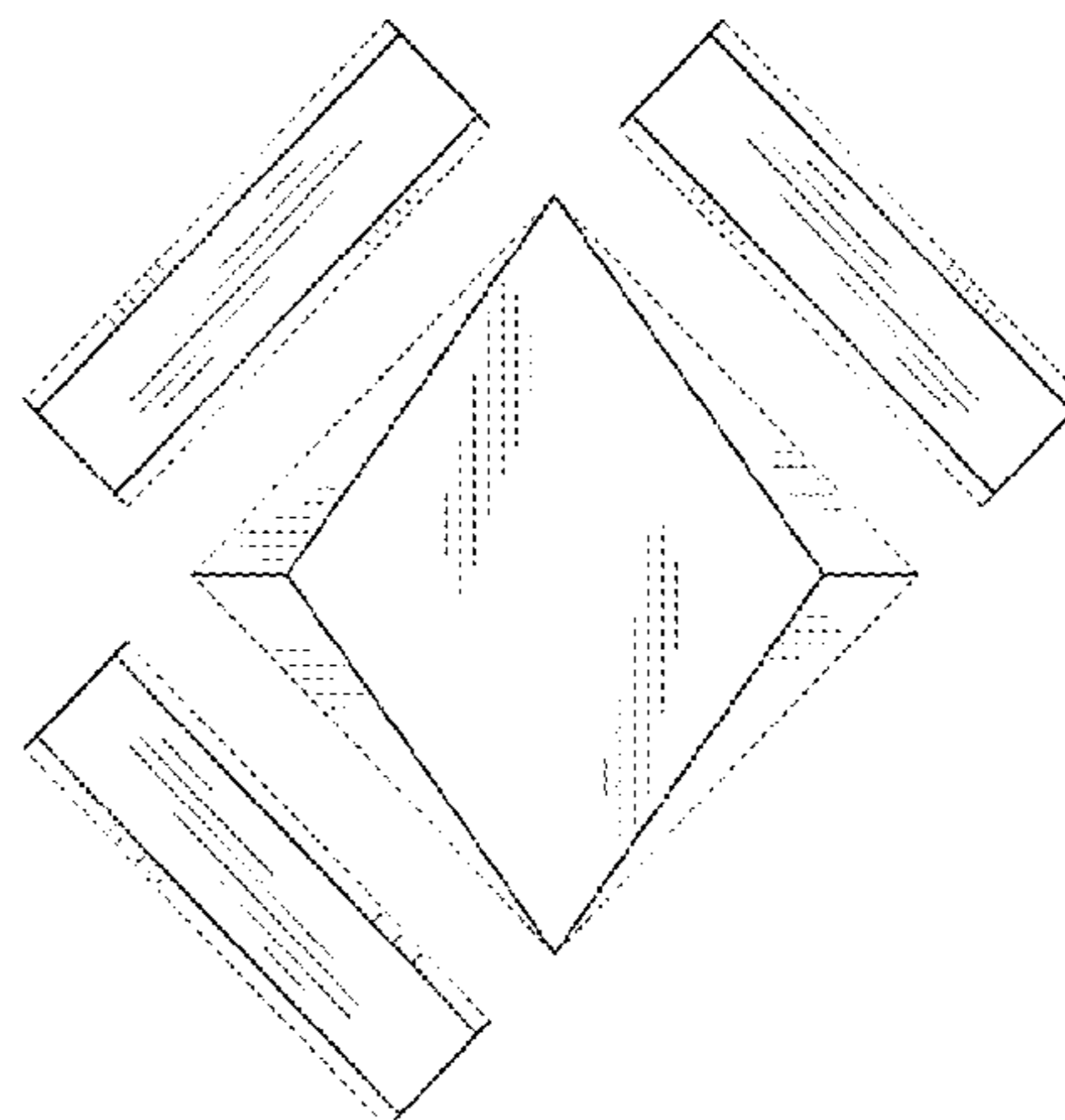
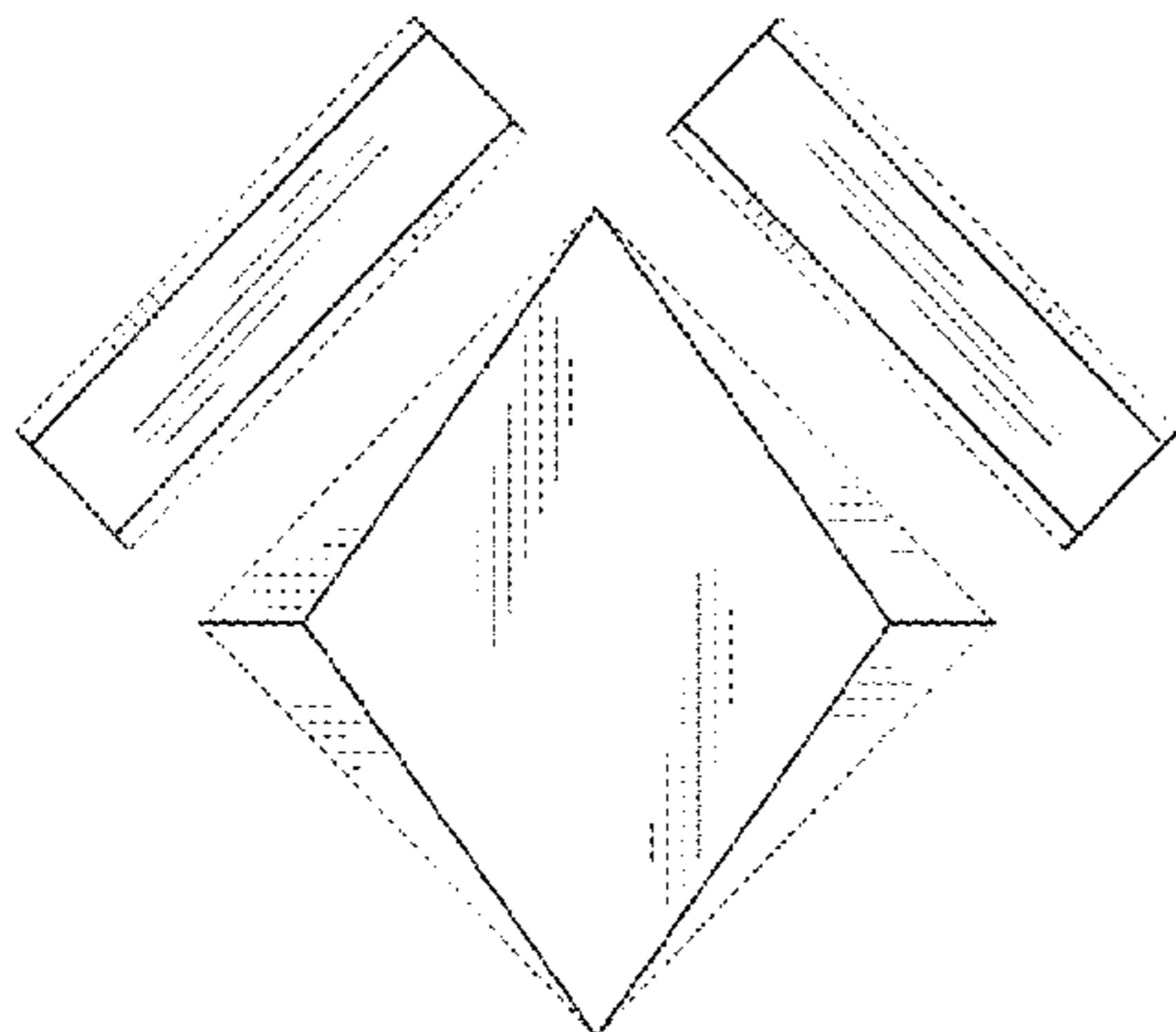


FIG. 22 is a right side elevational view of the footwear tread of the fourth embodiment;

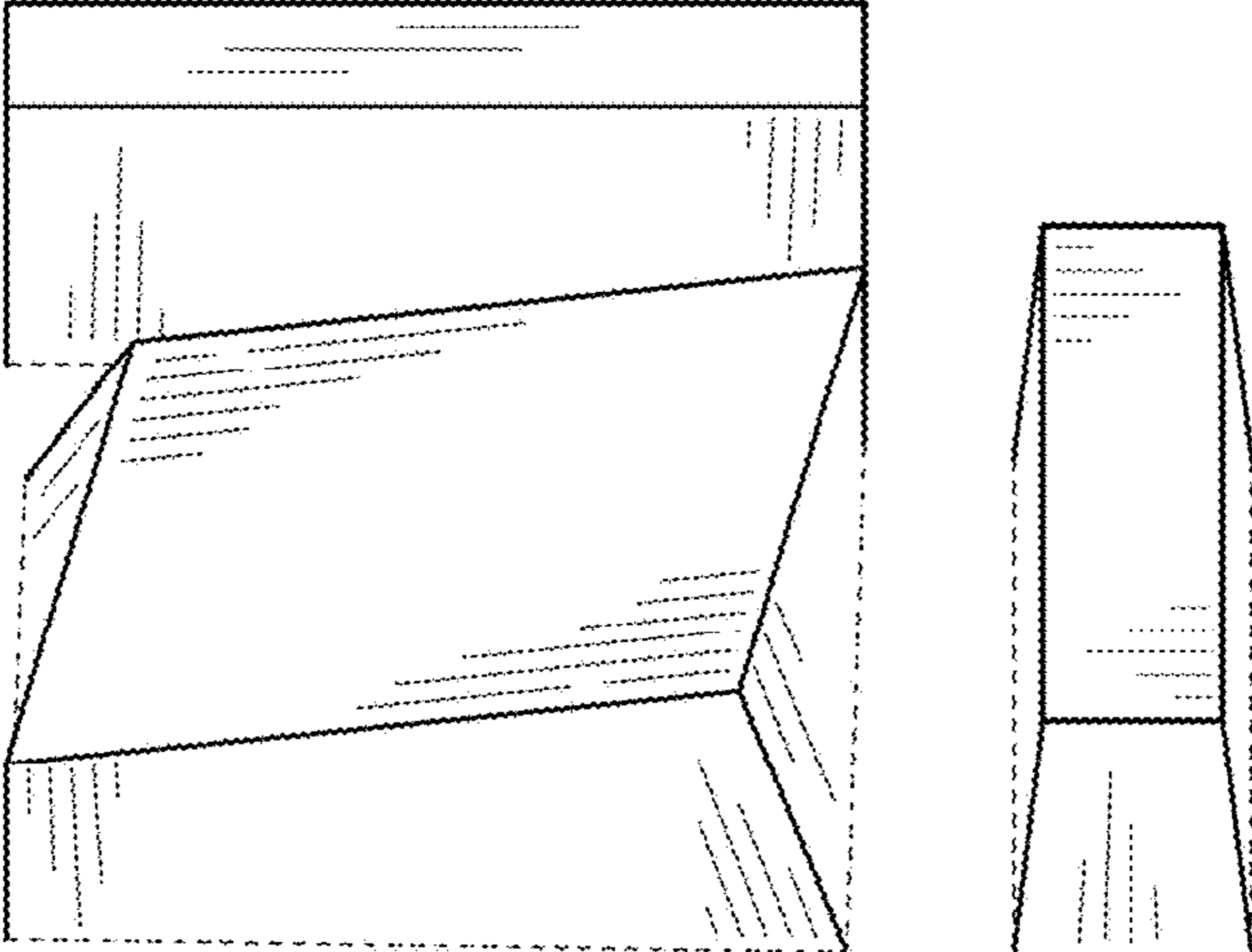

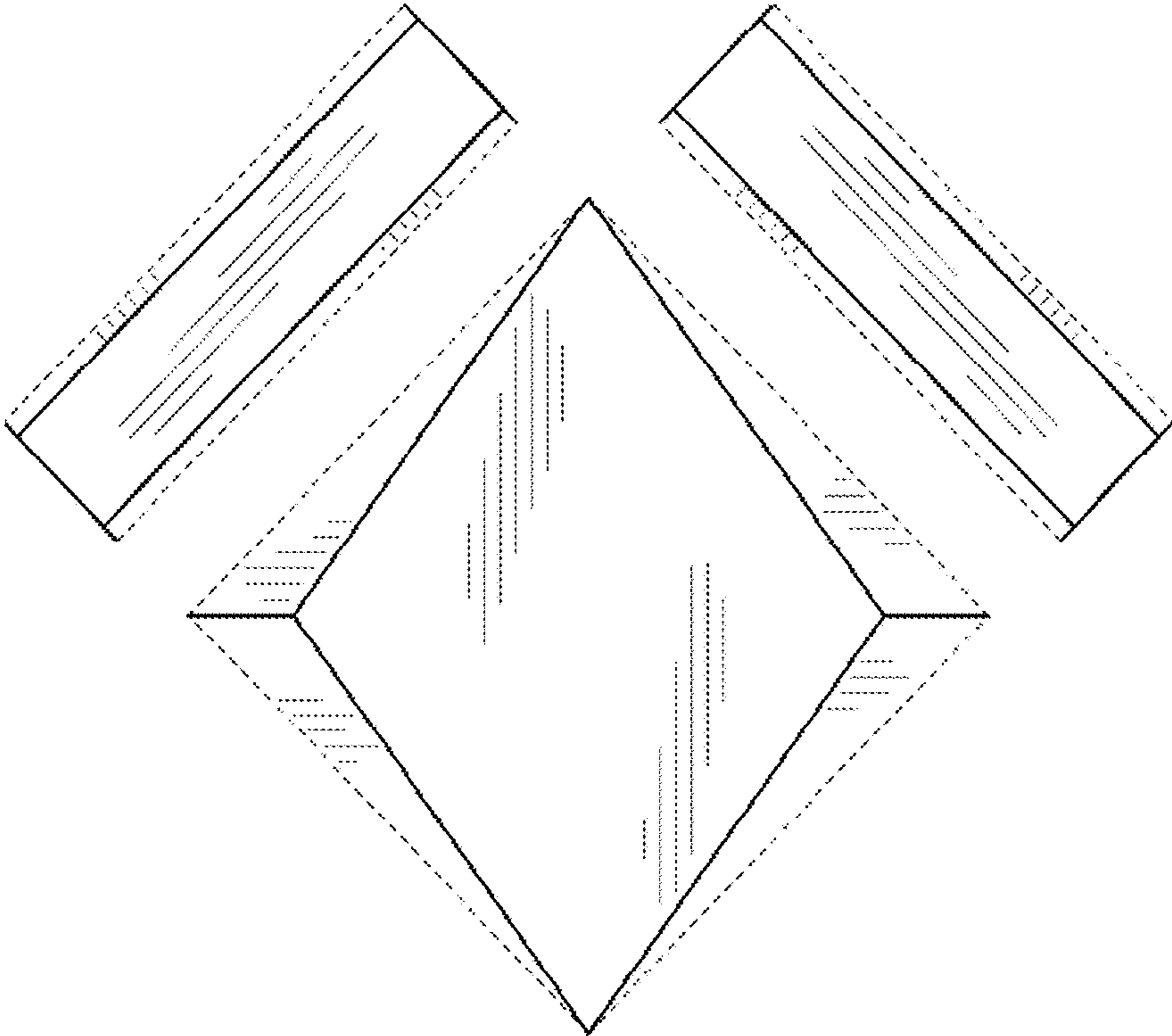

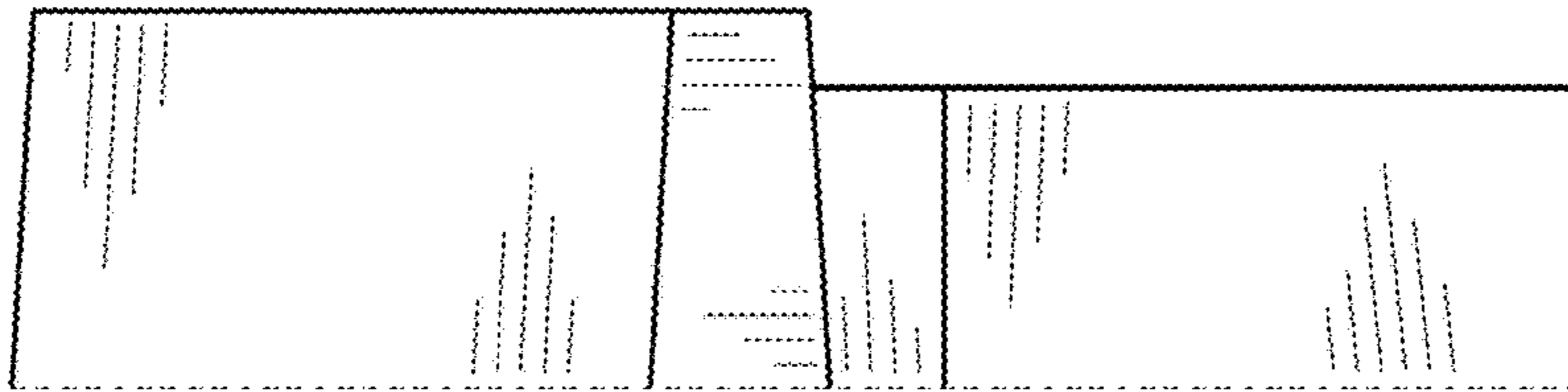

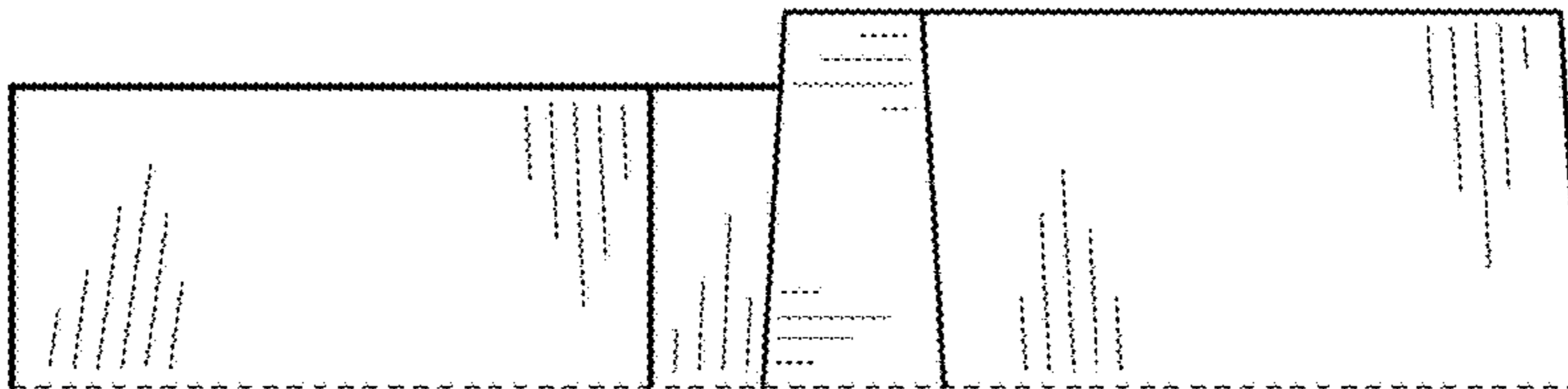

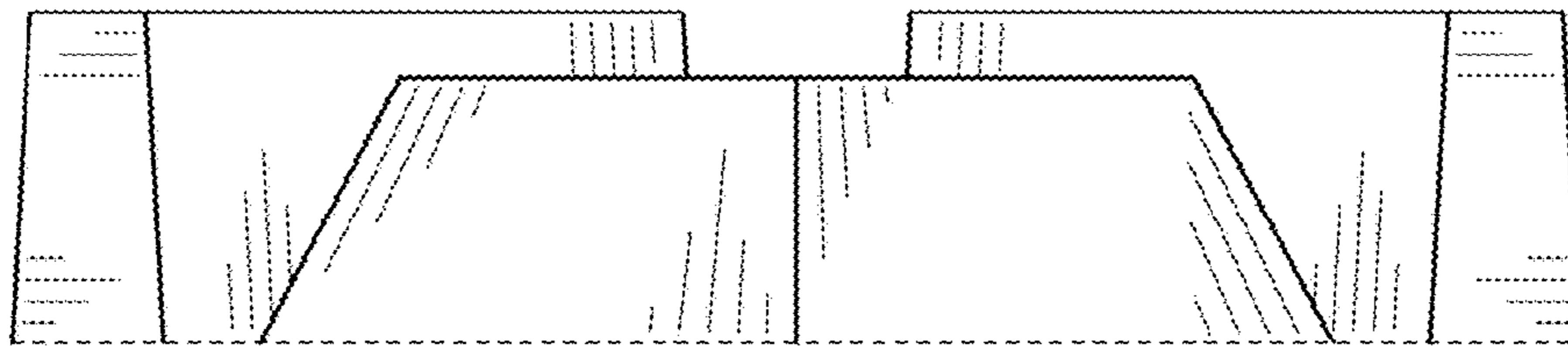

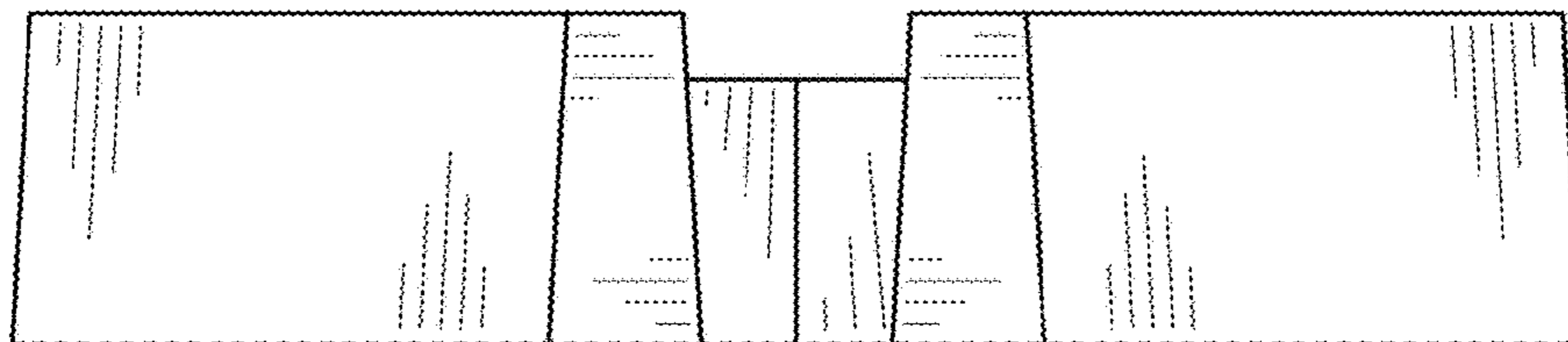

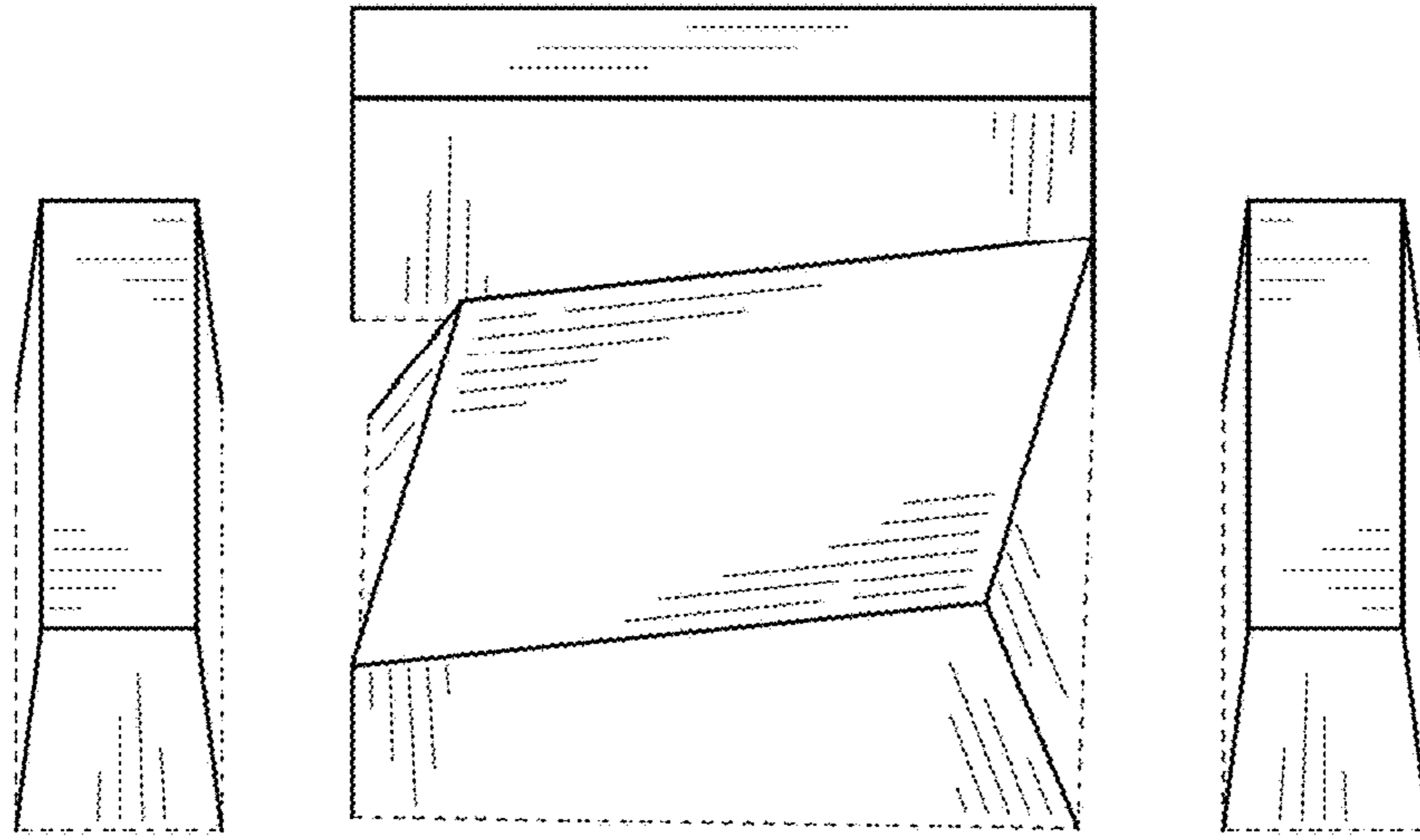

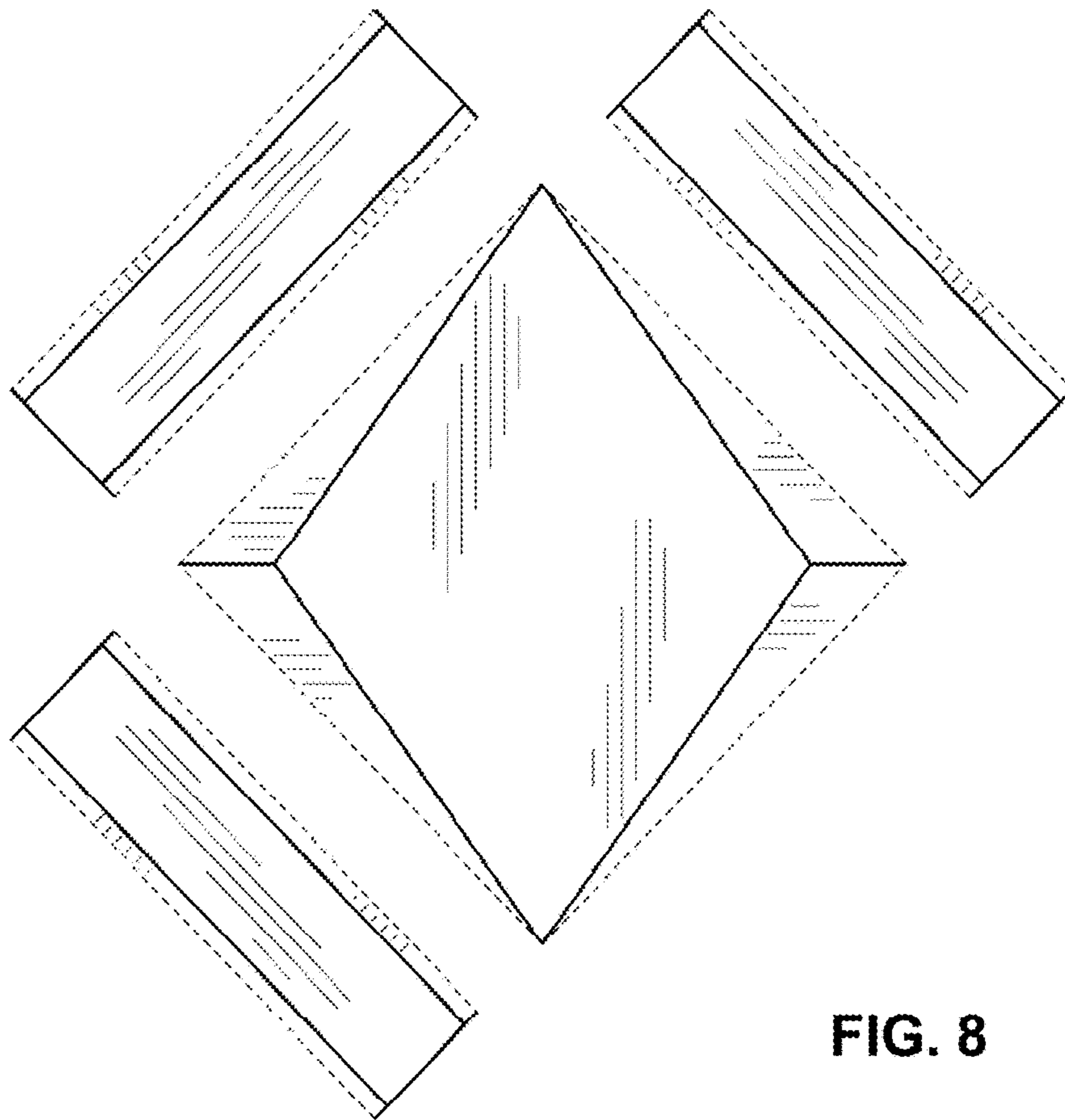

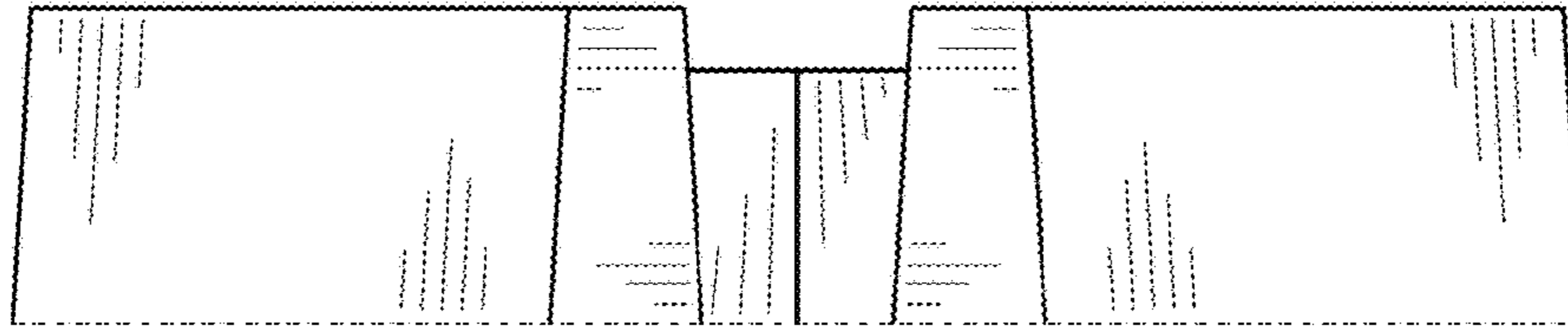

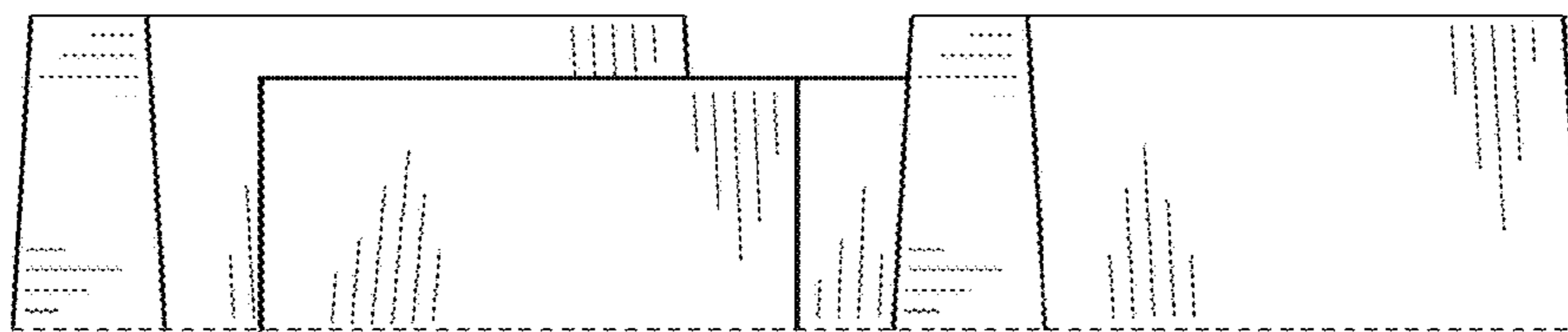

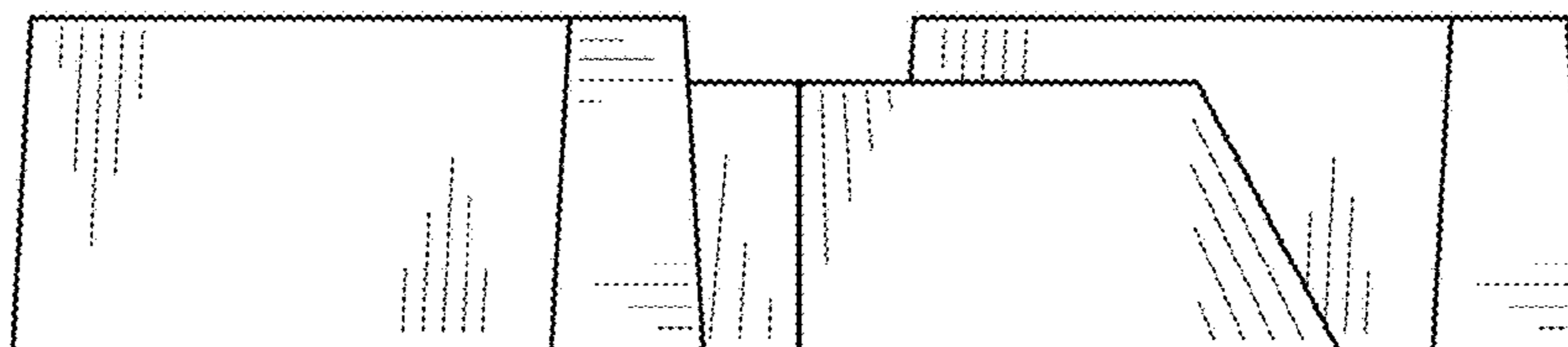

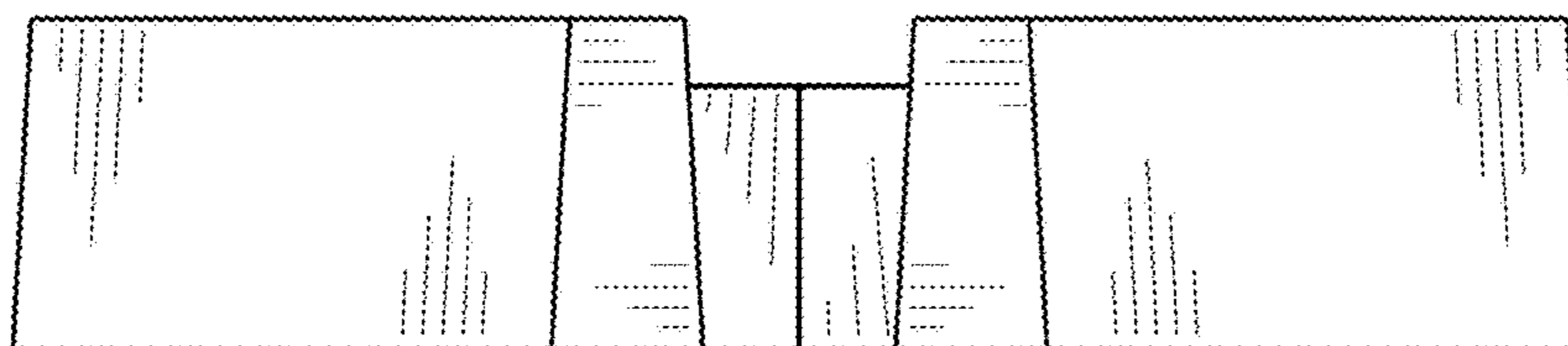

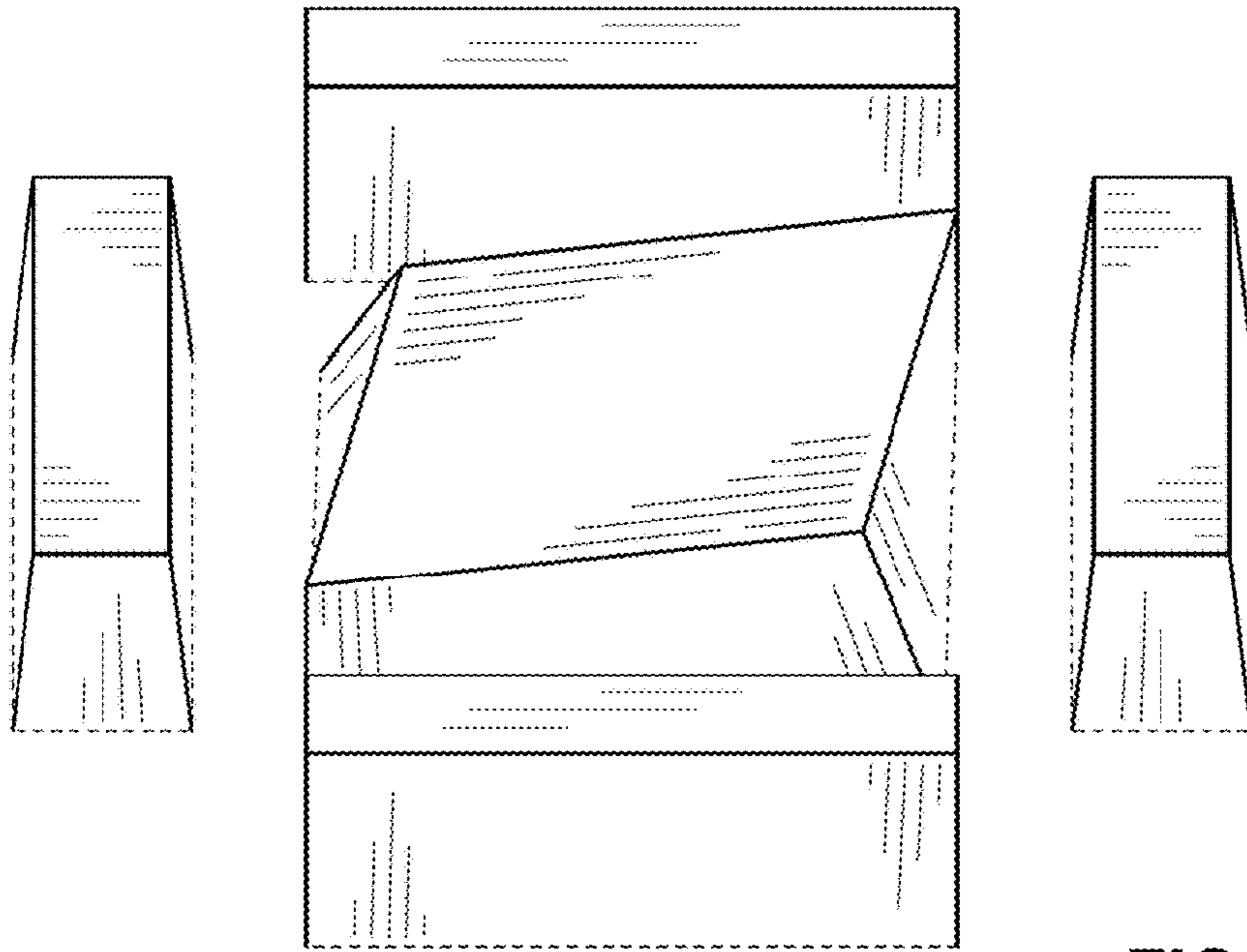

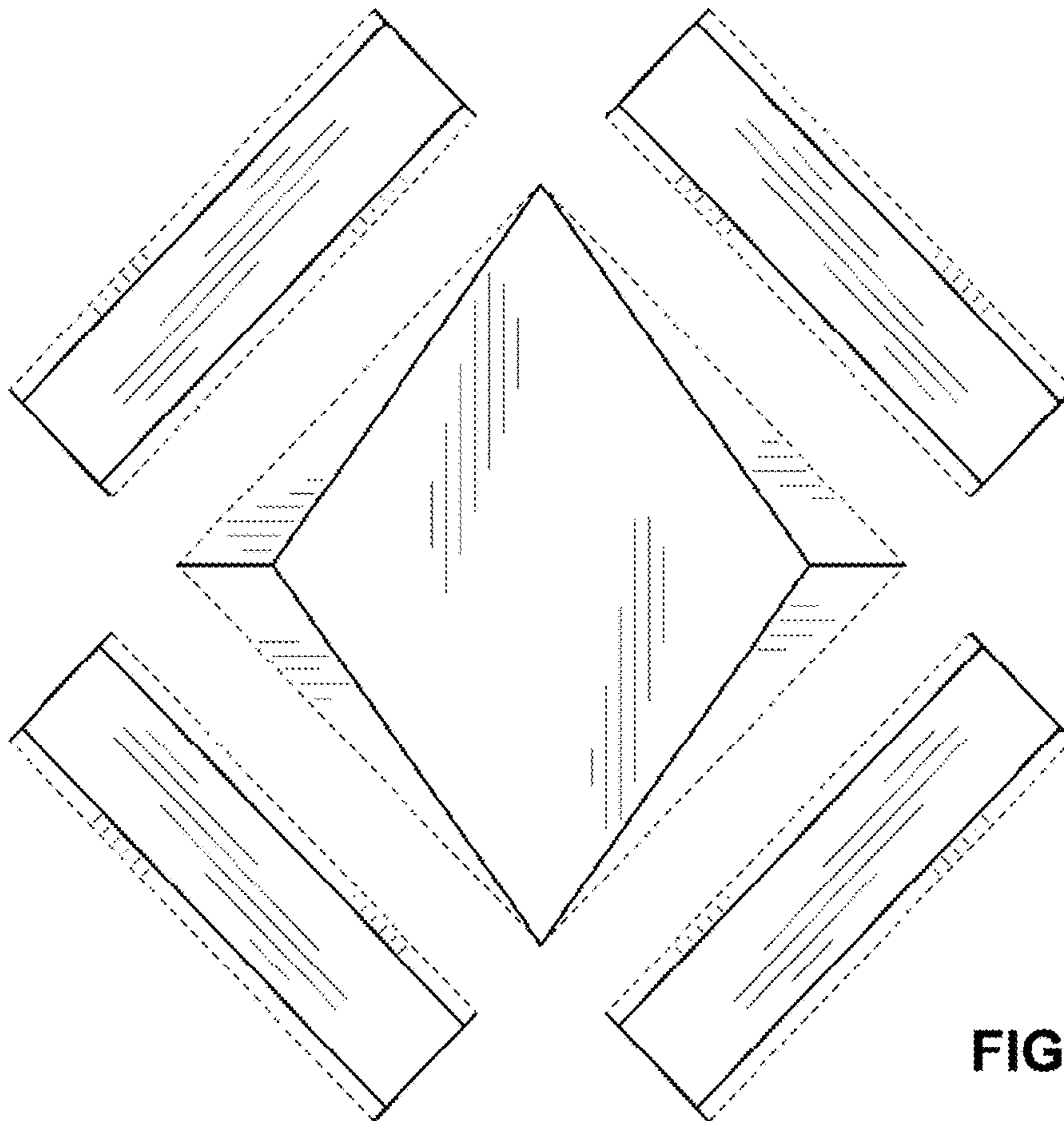
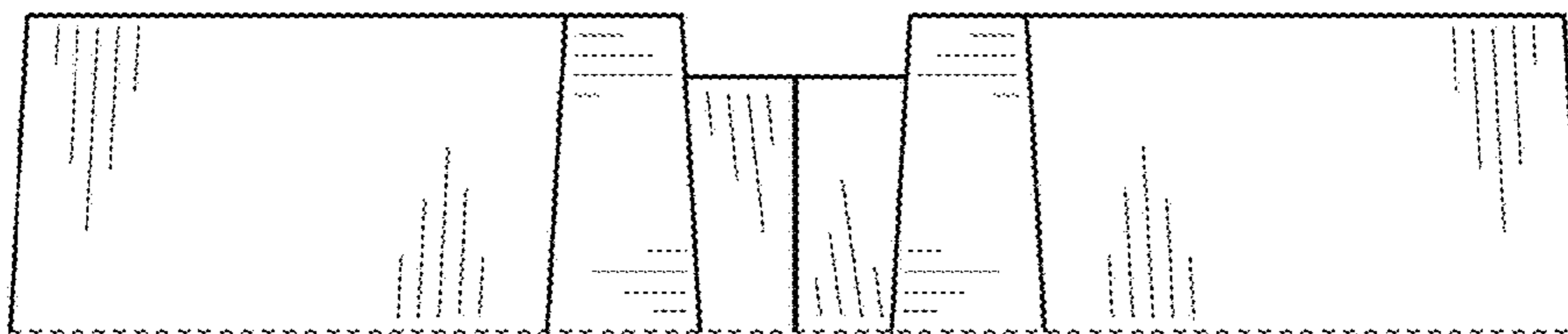
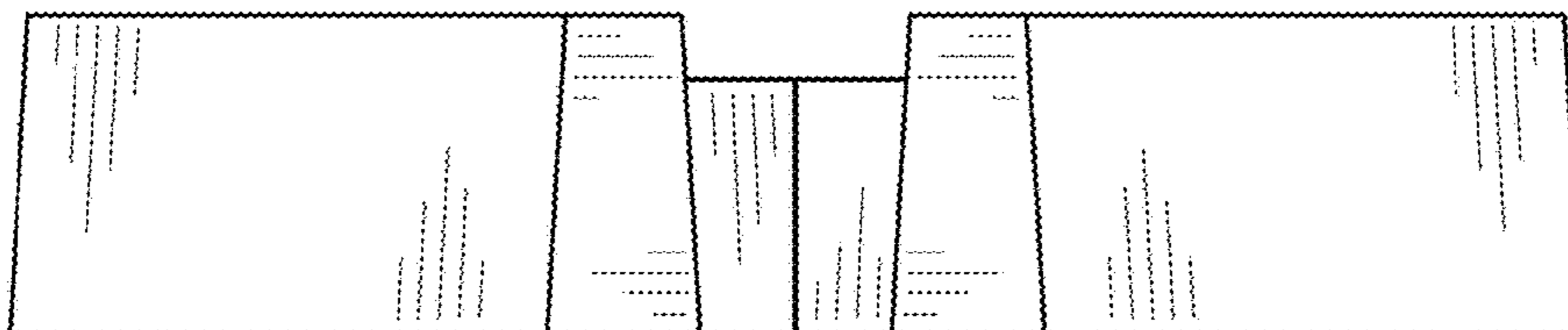


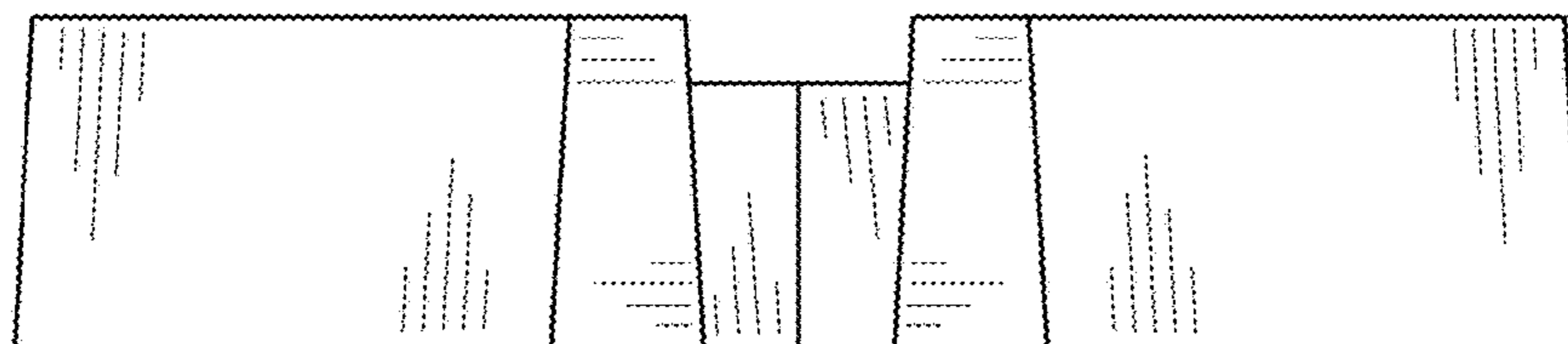

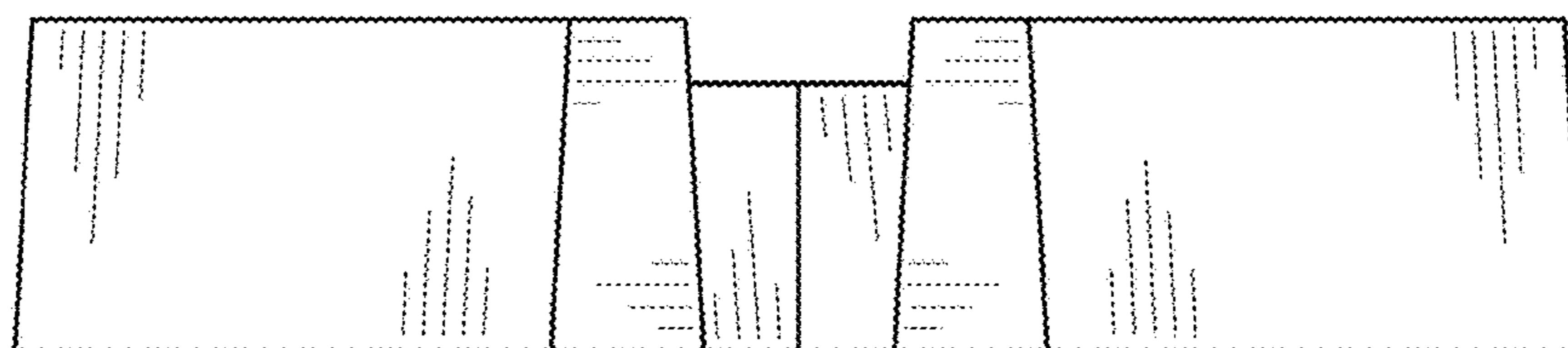

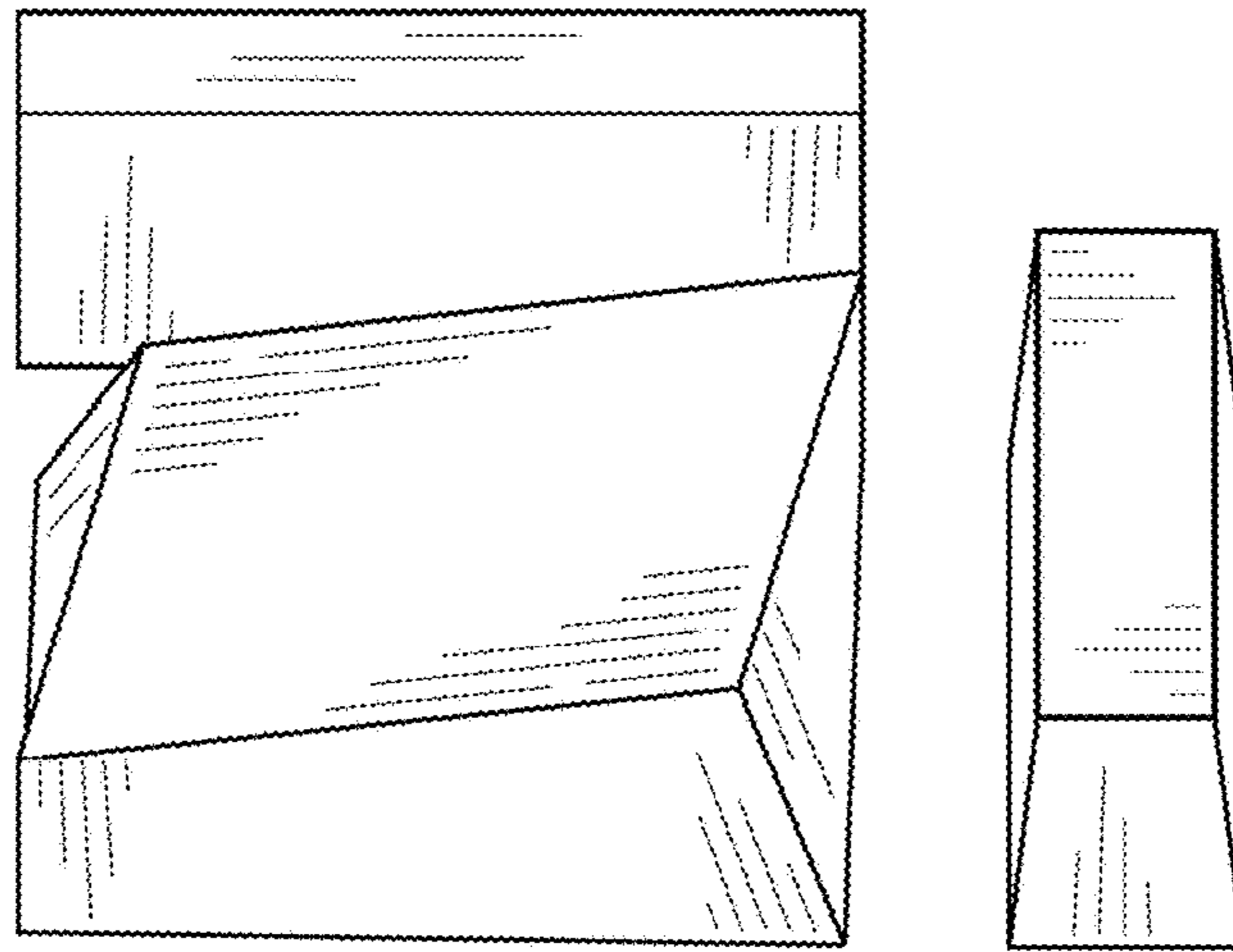

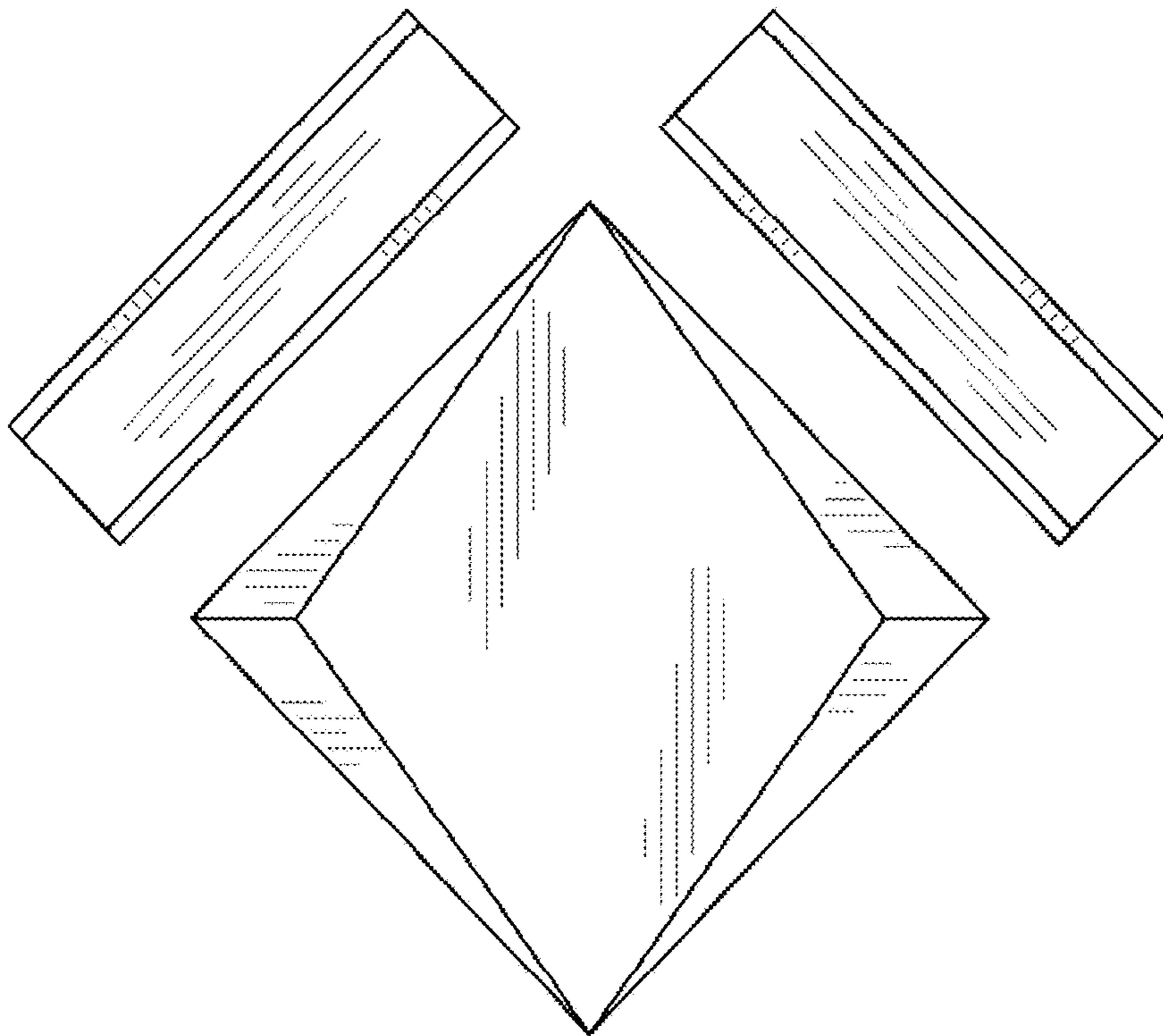

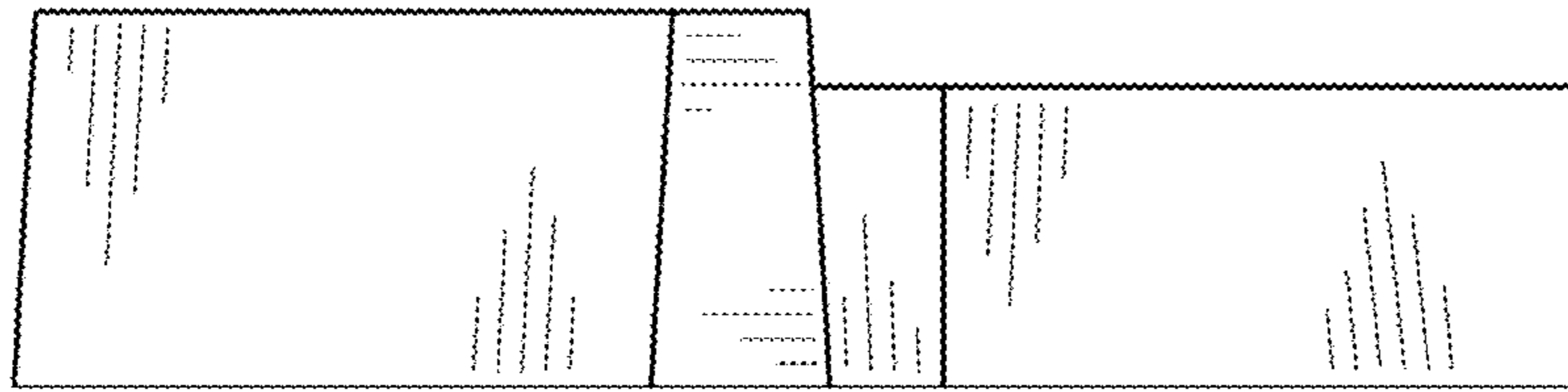

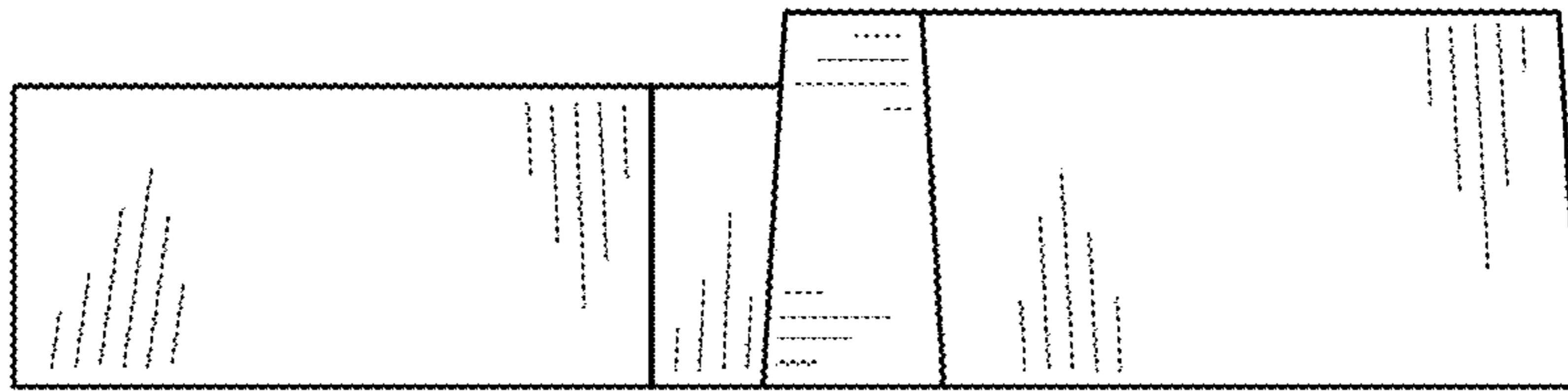

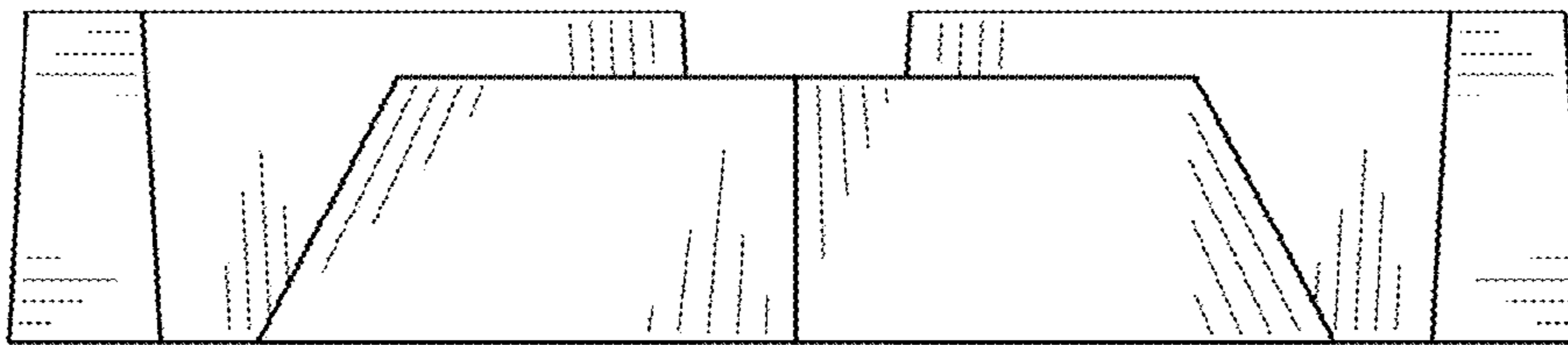

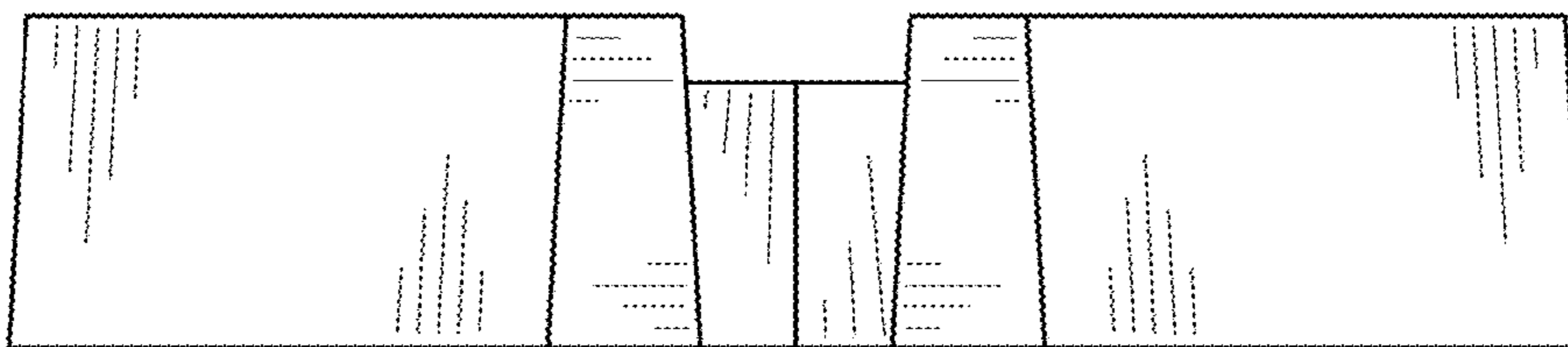

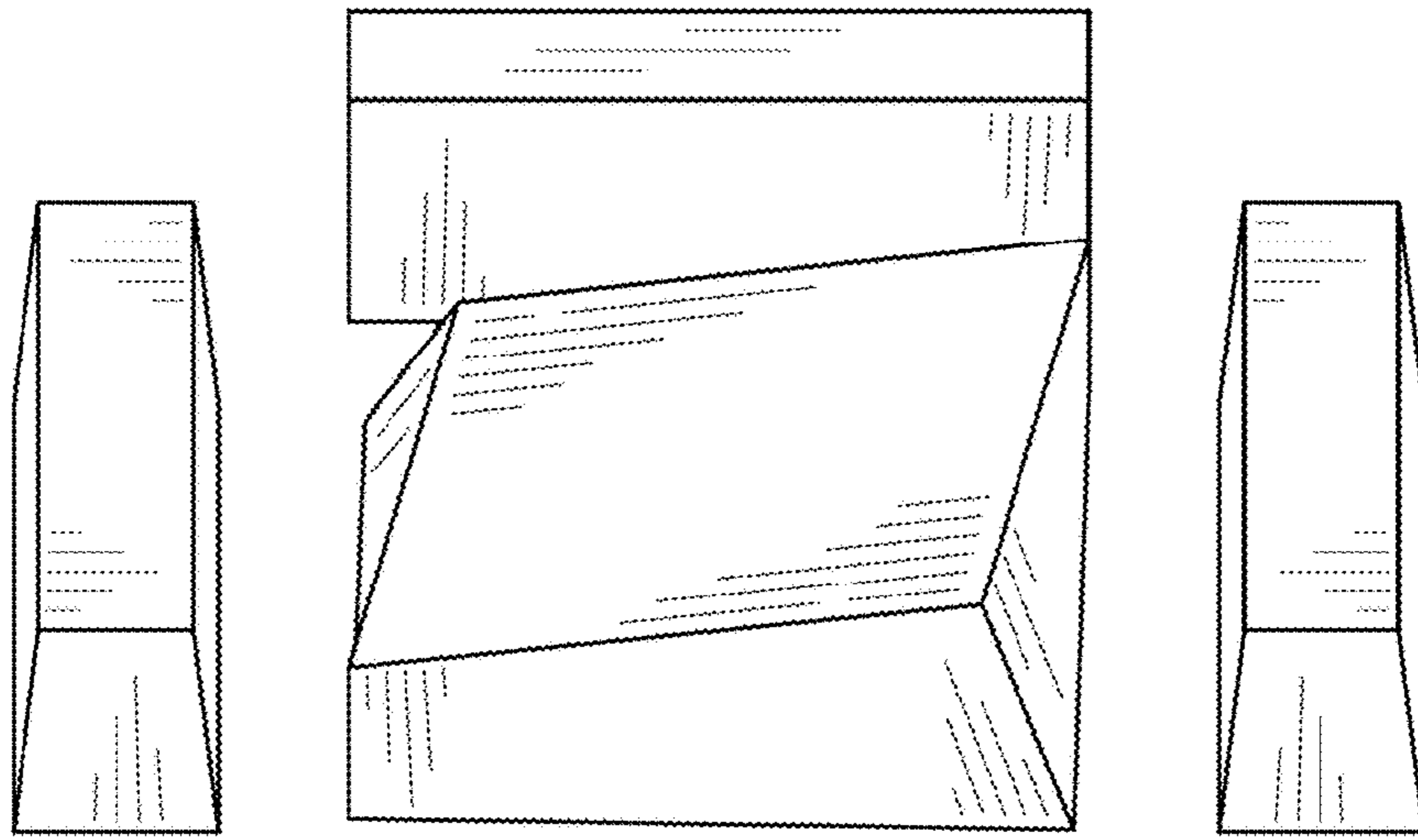

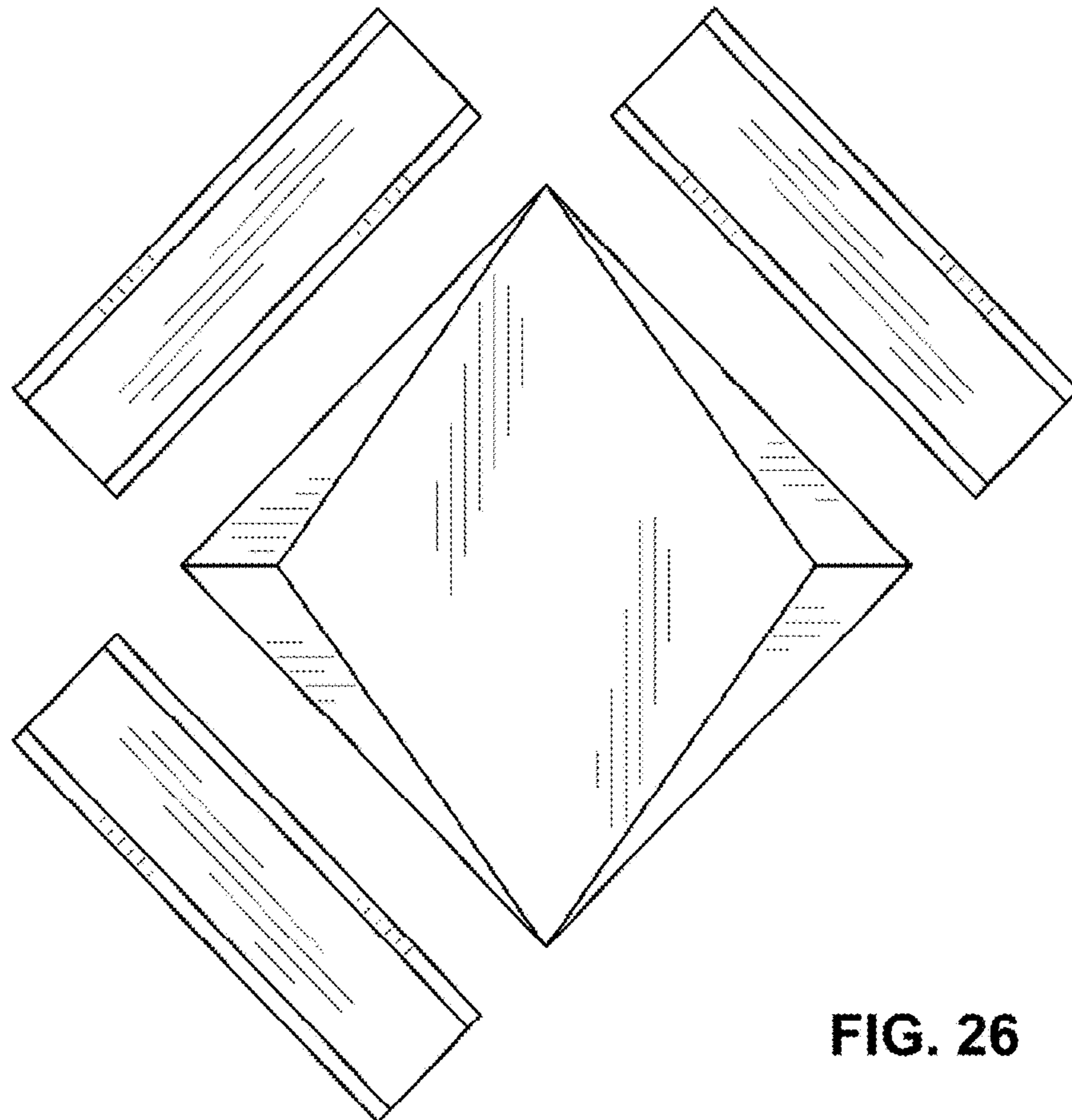

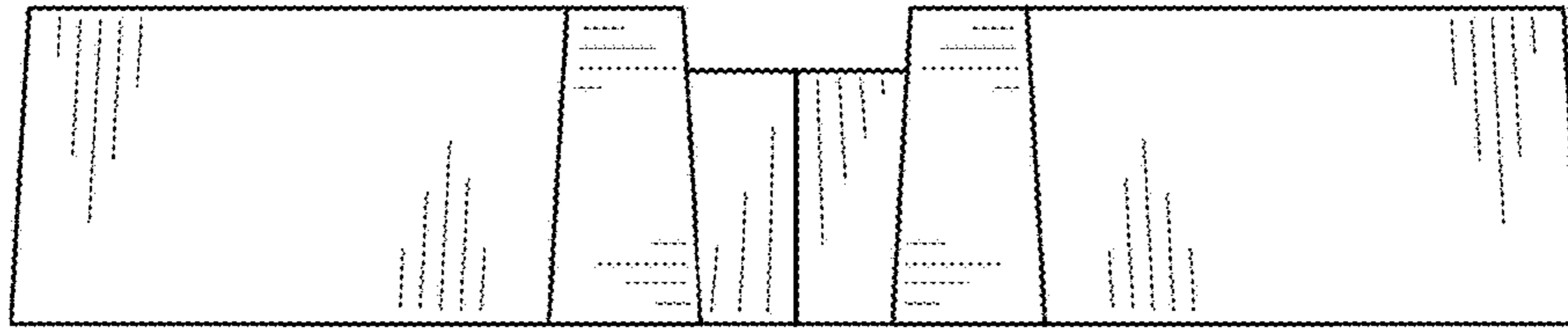

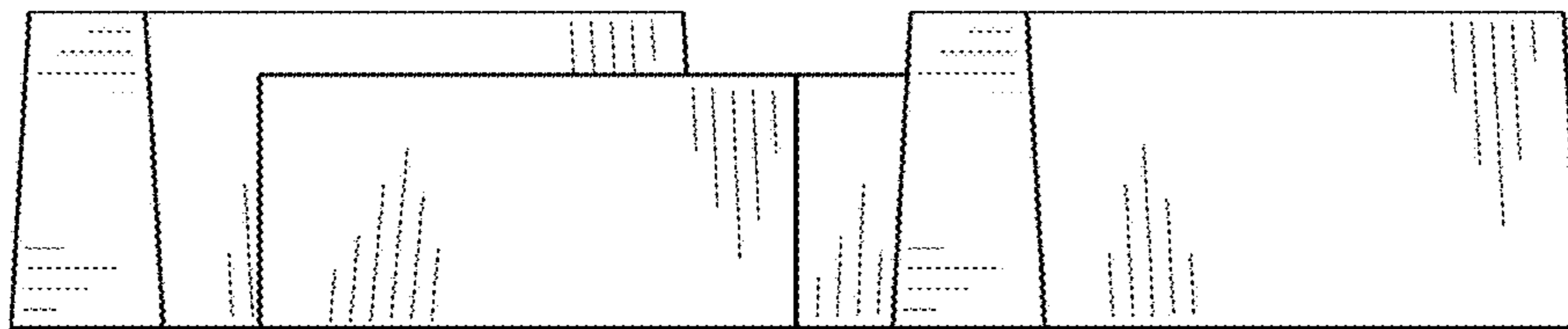

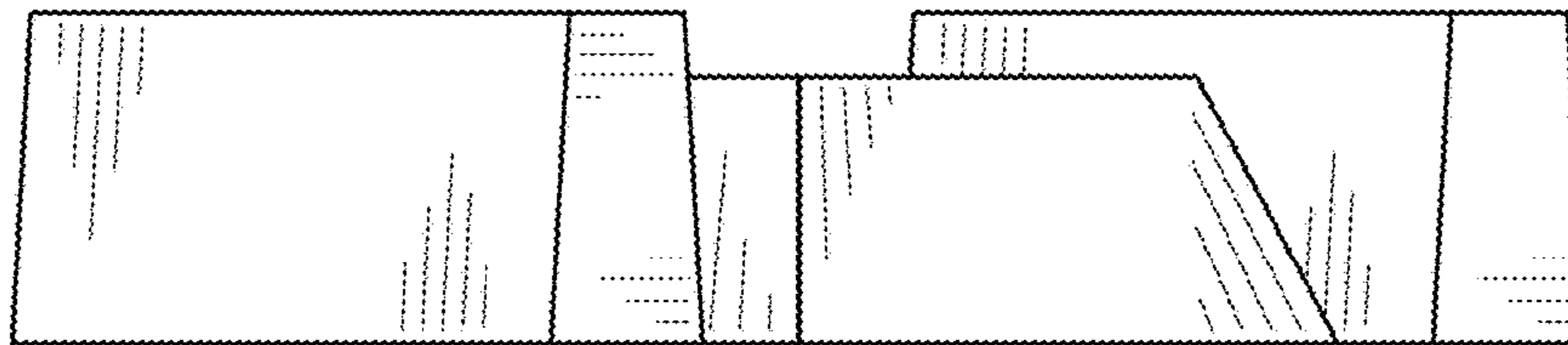

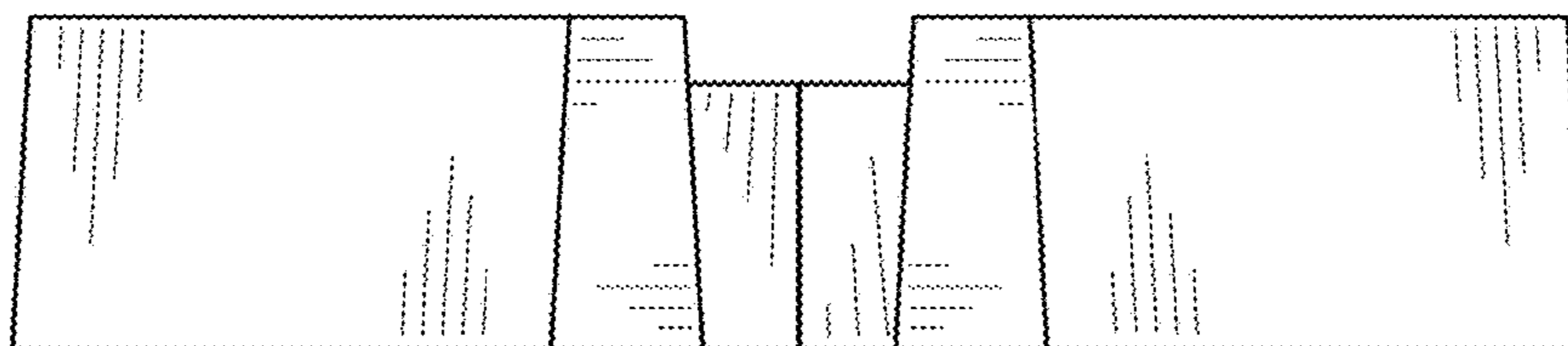

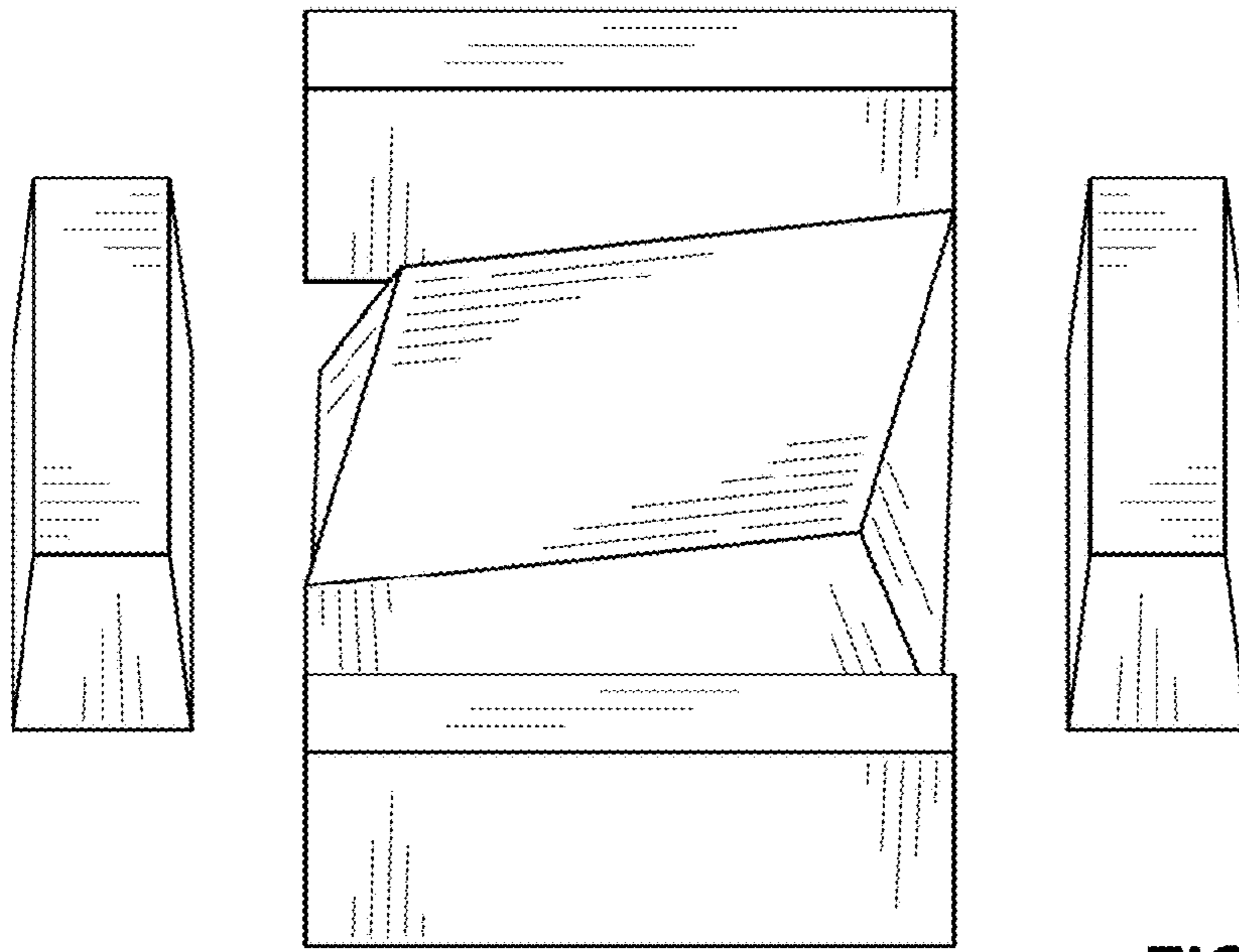

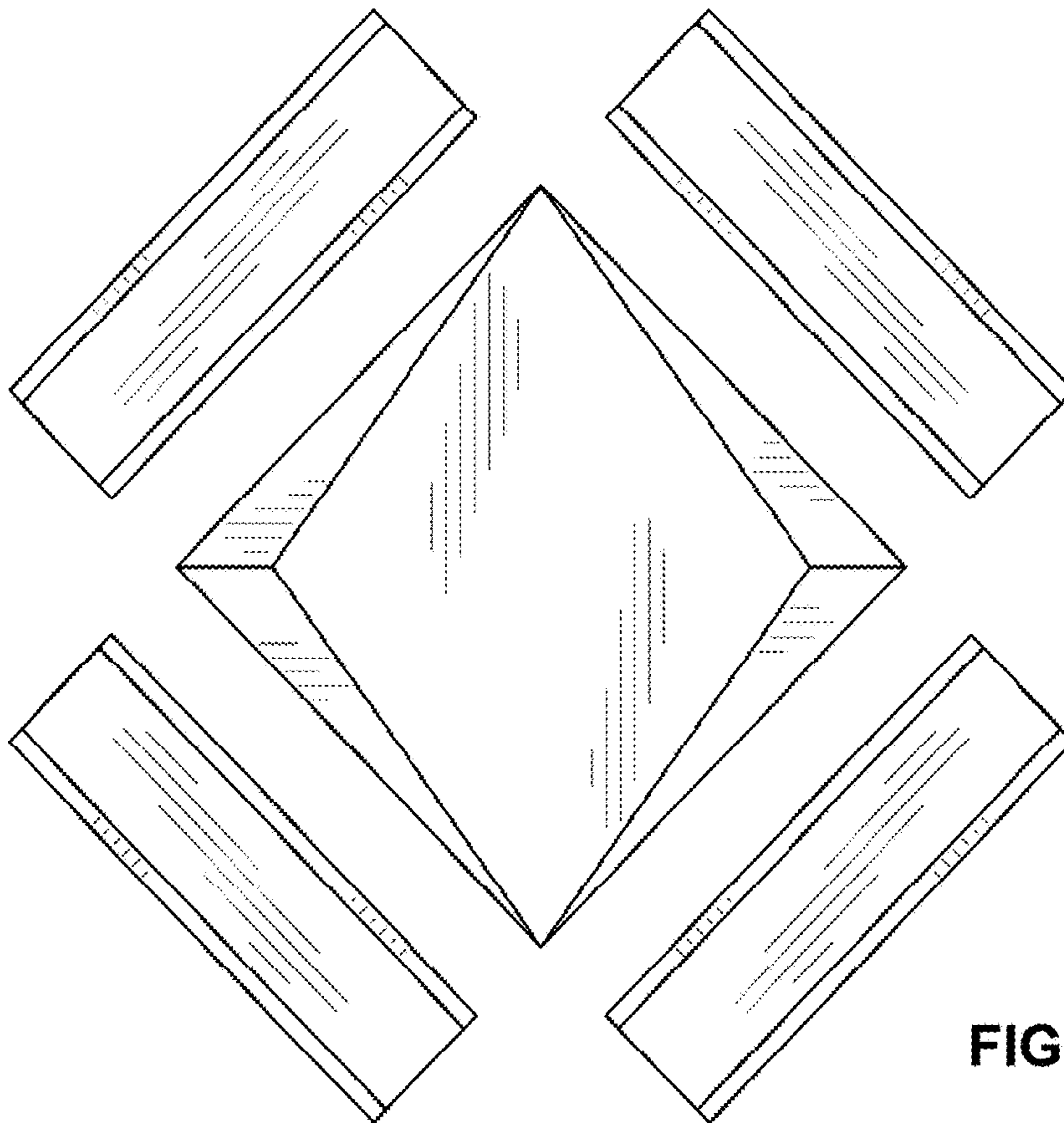

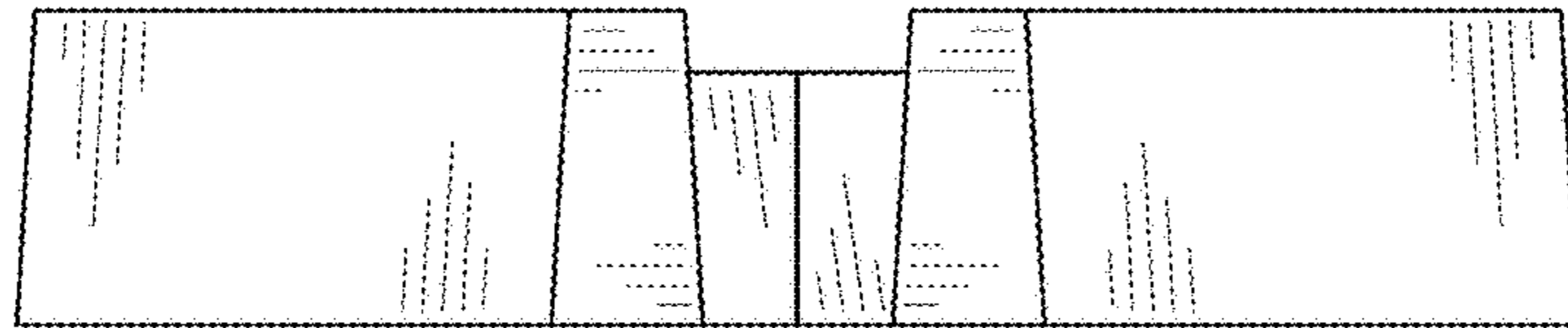

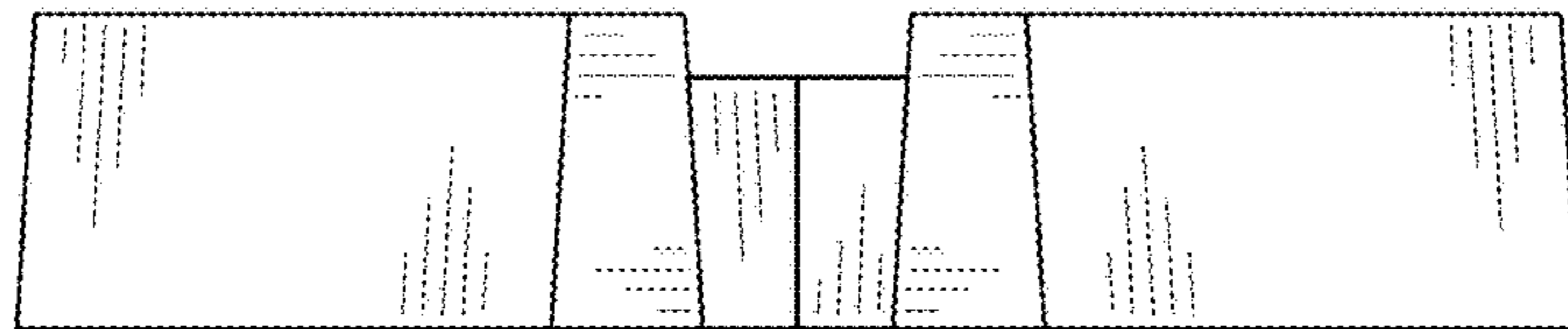

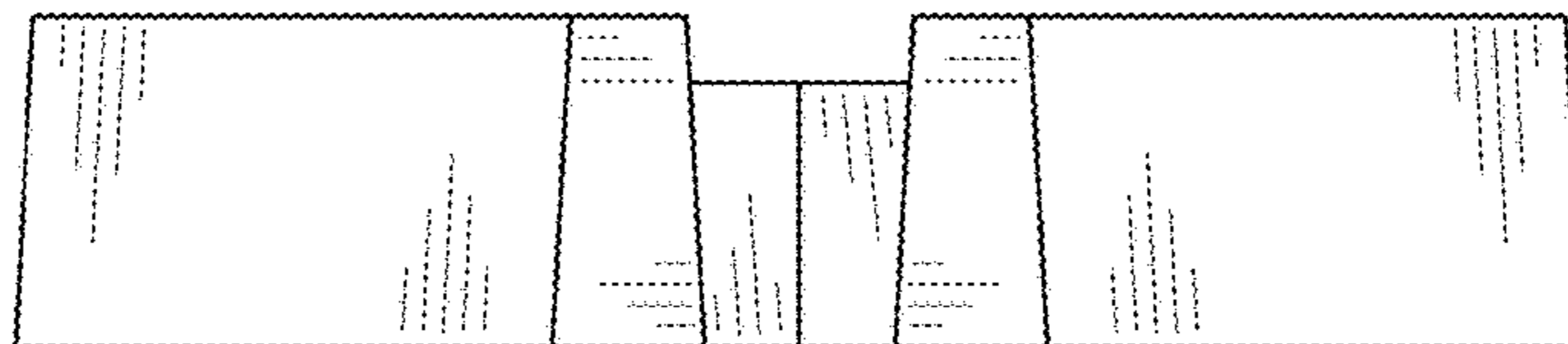

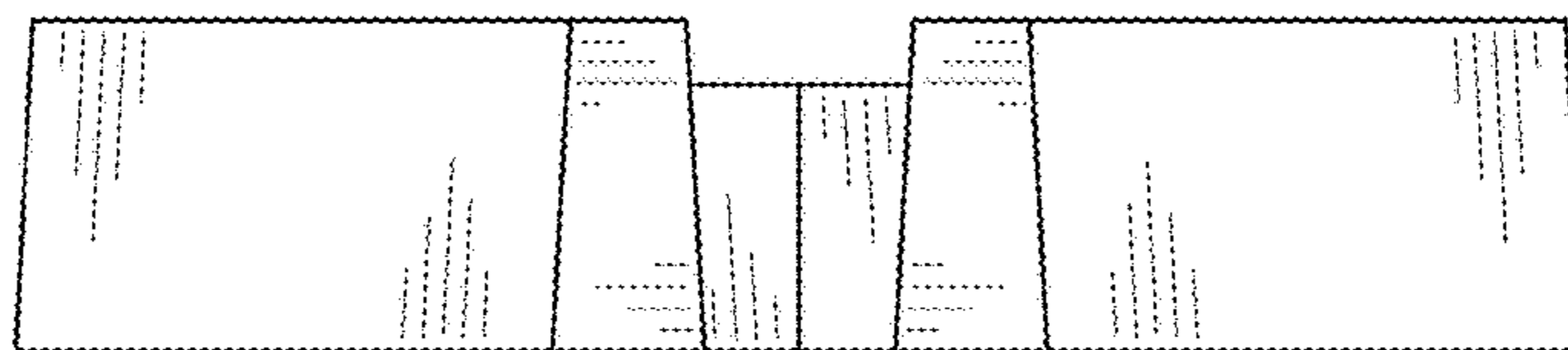
