**DESCRIPTION**

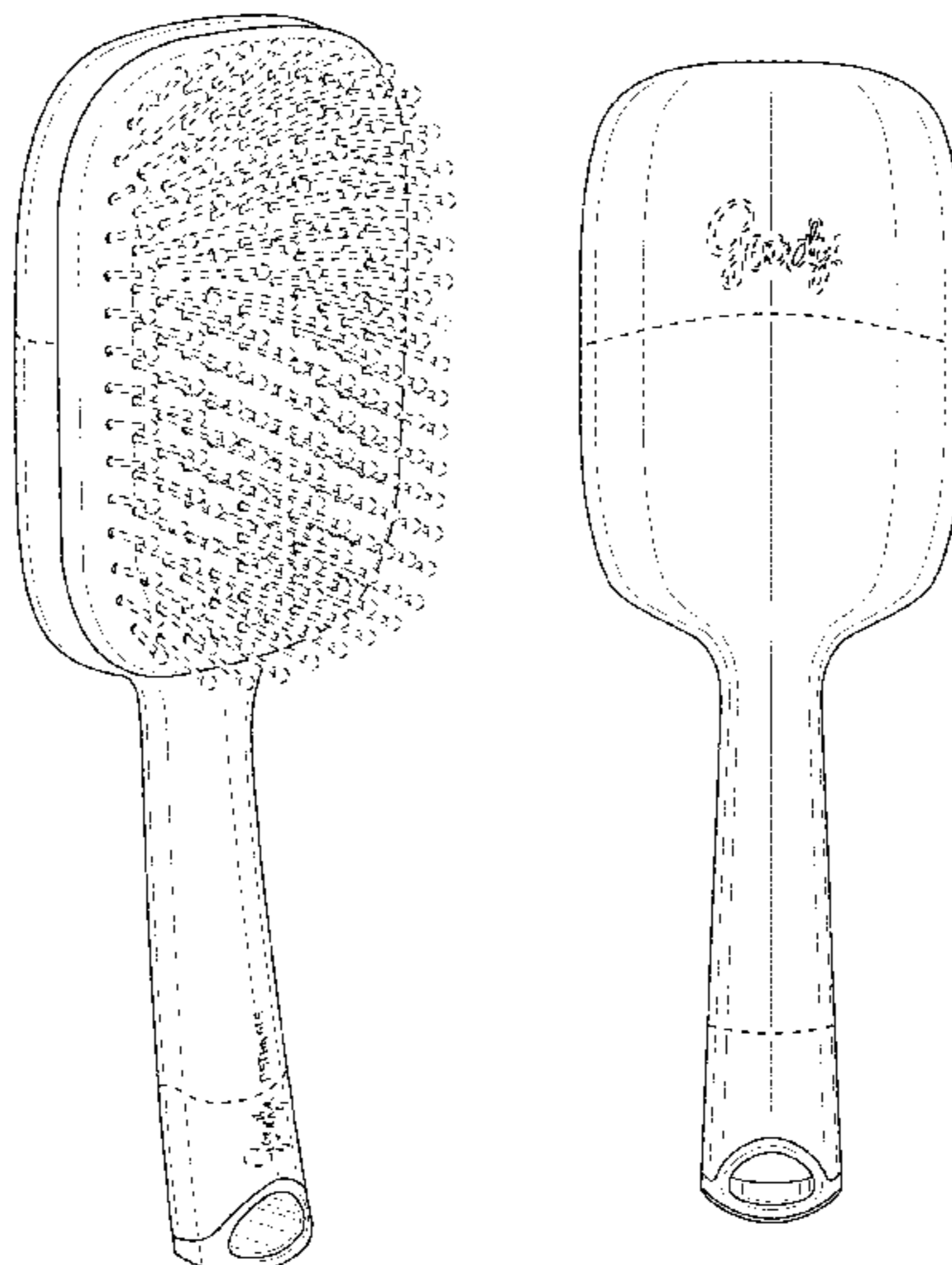
FIG. 1 is a perspective view of a brush showing a new design;

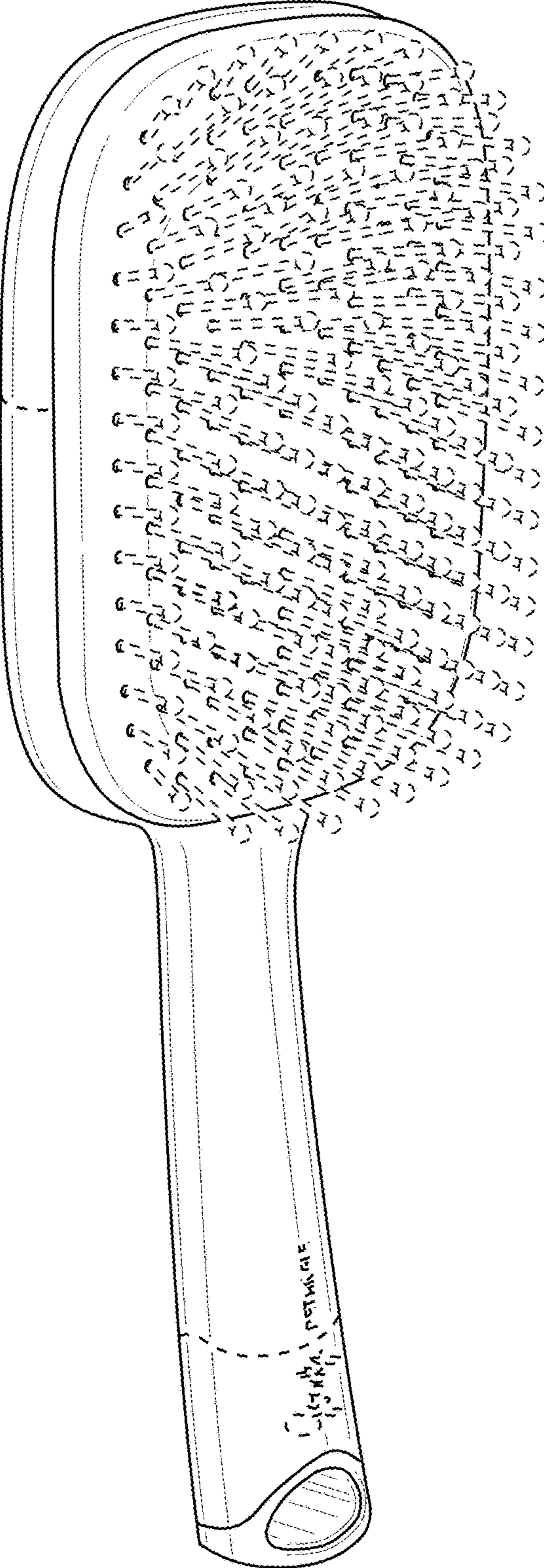

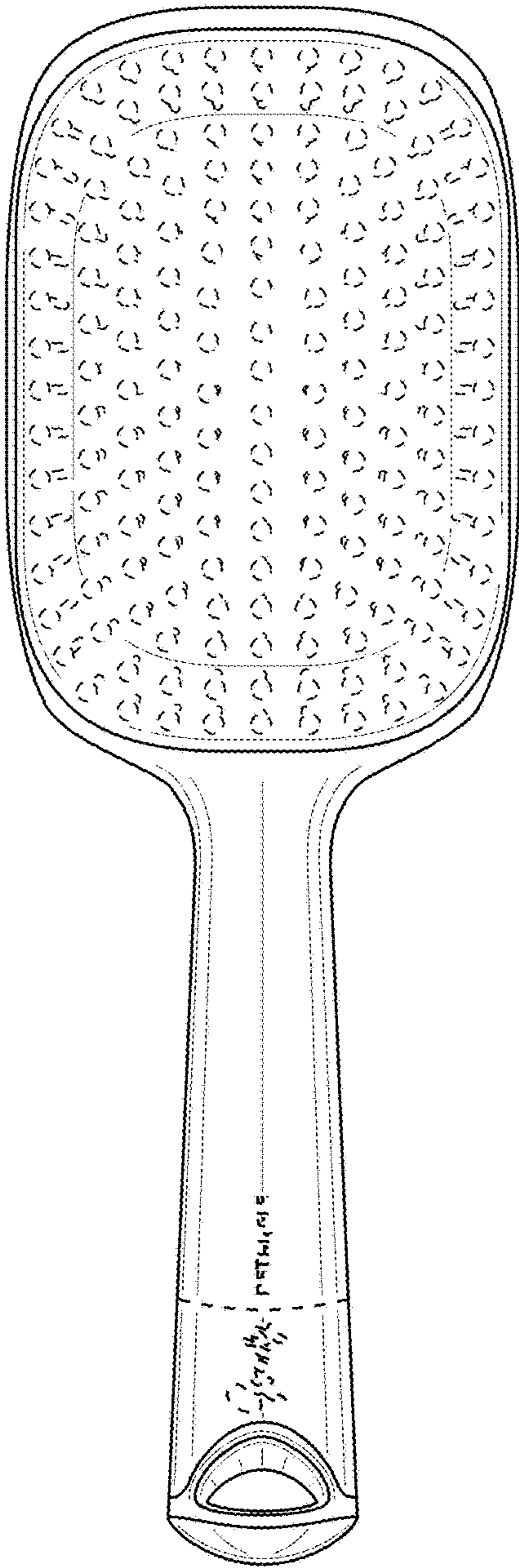

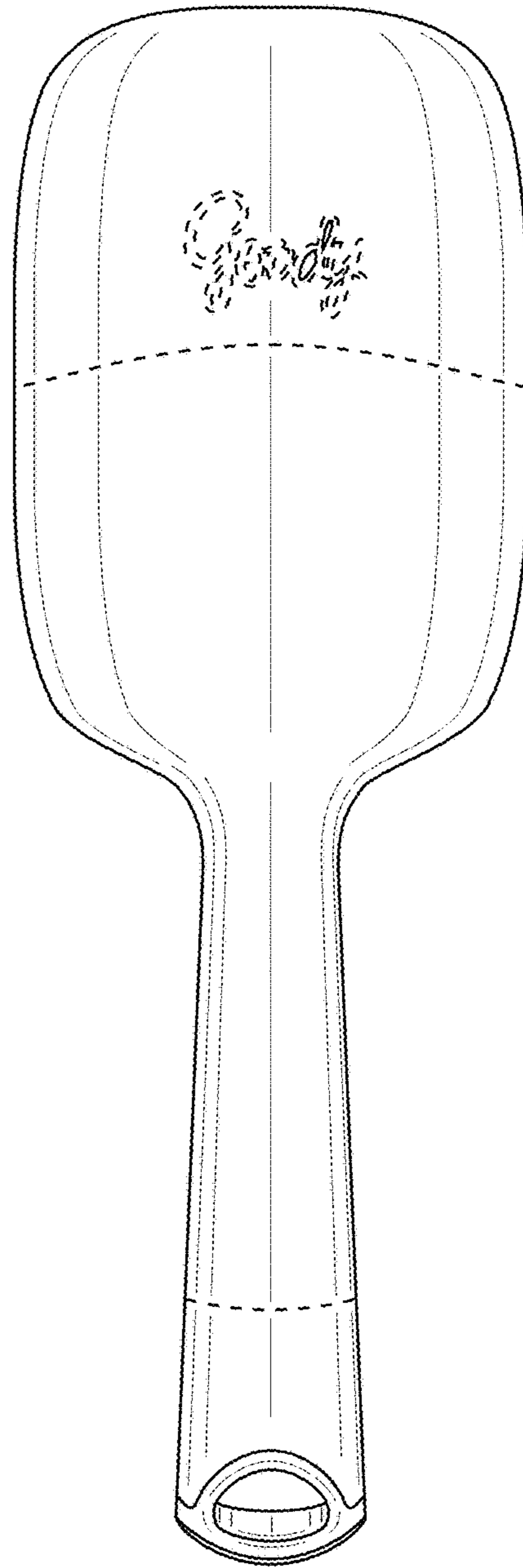

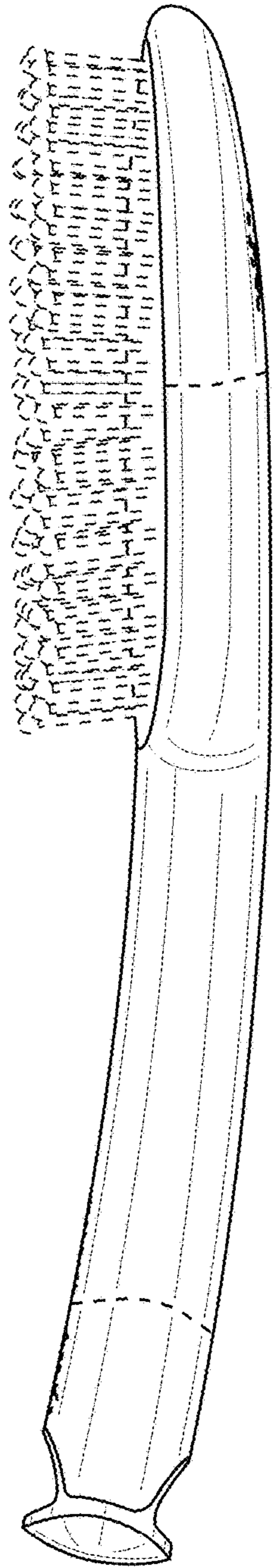

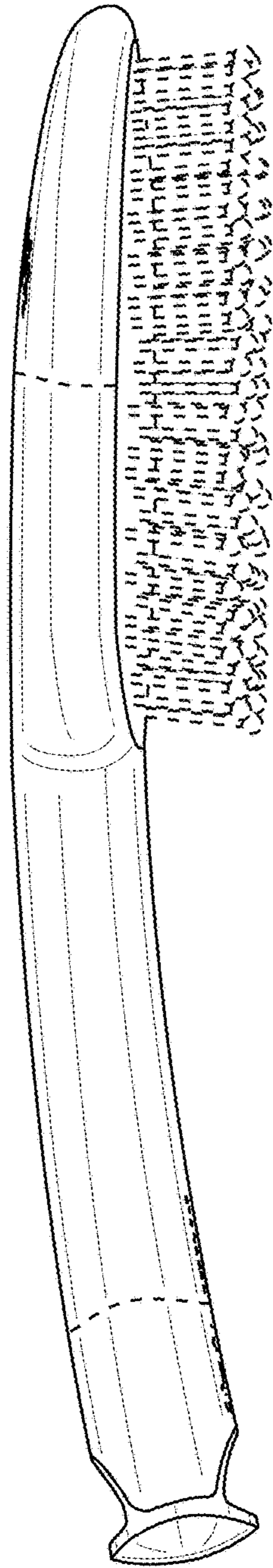

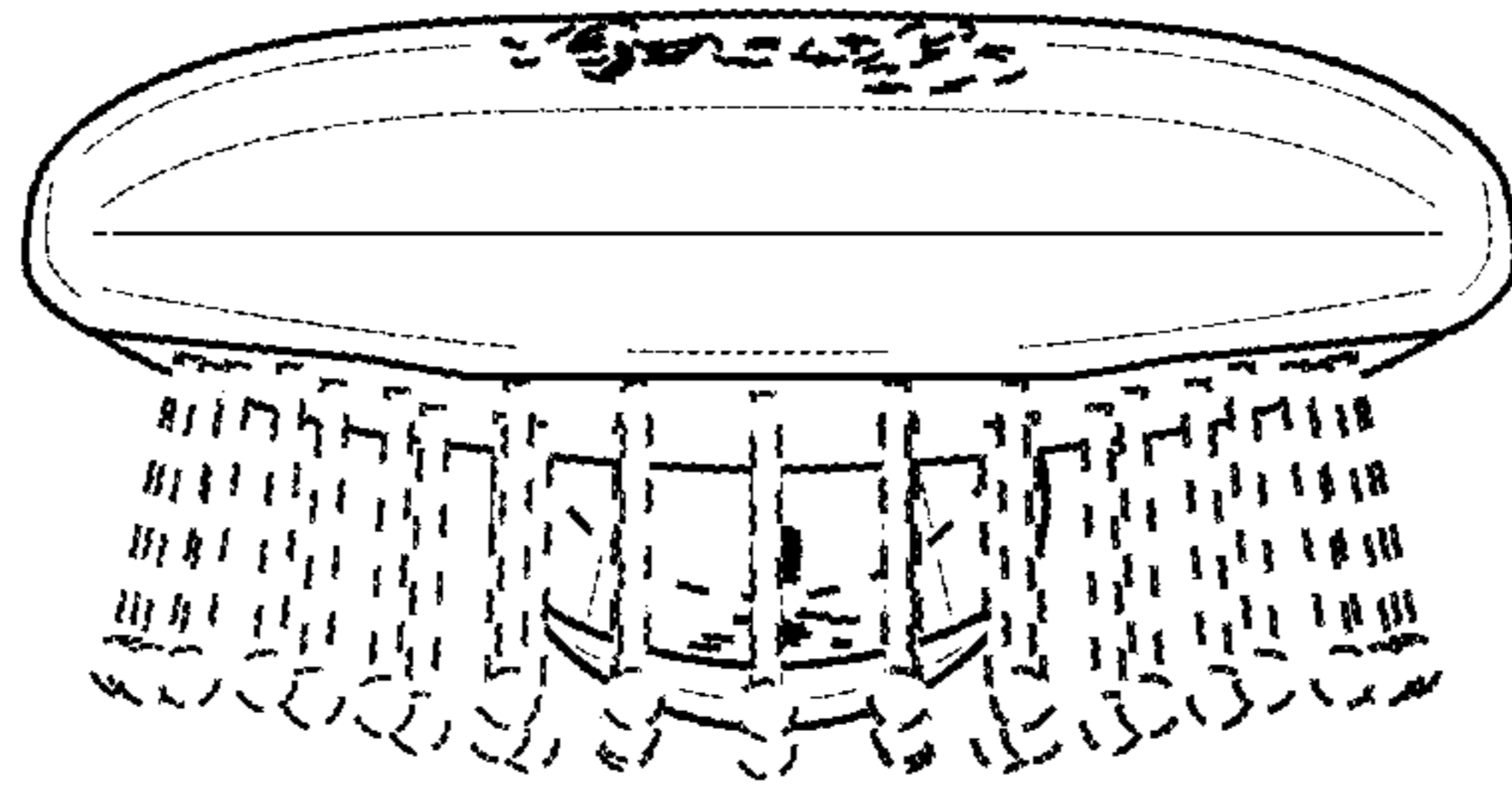

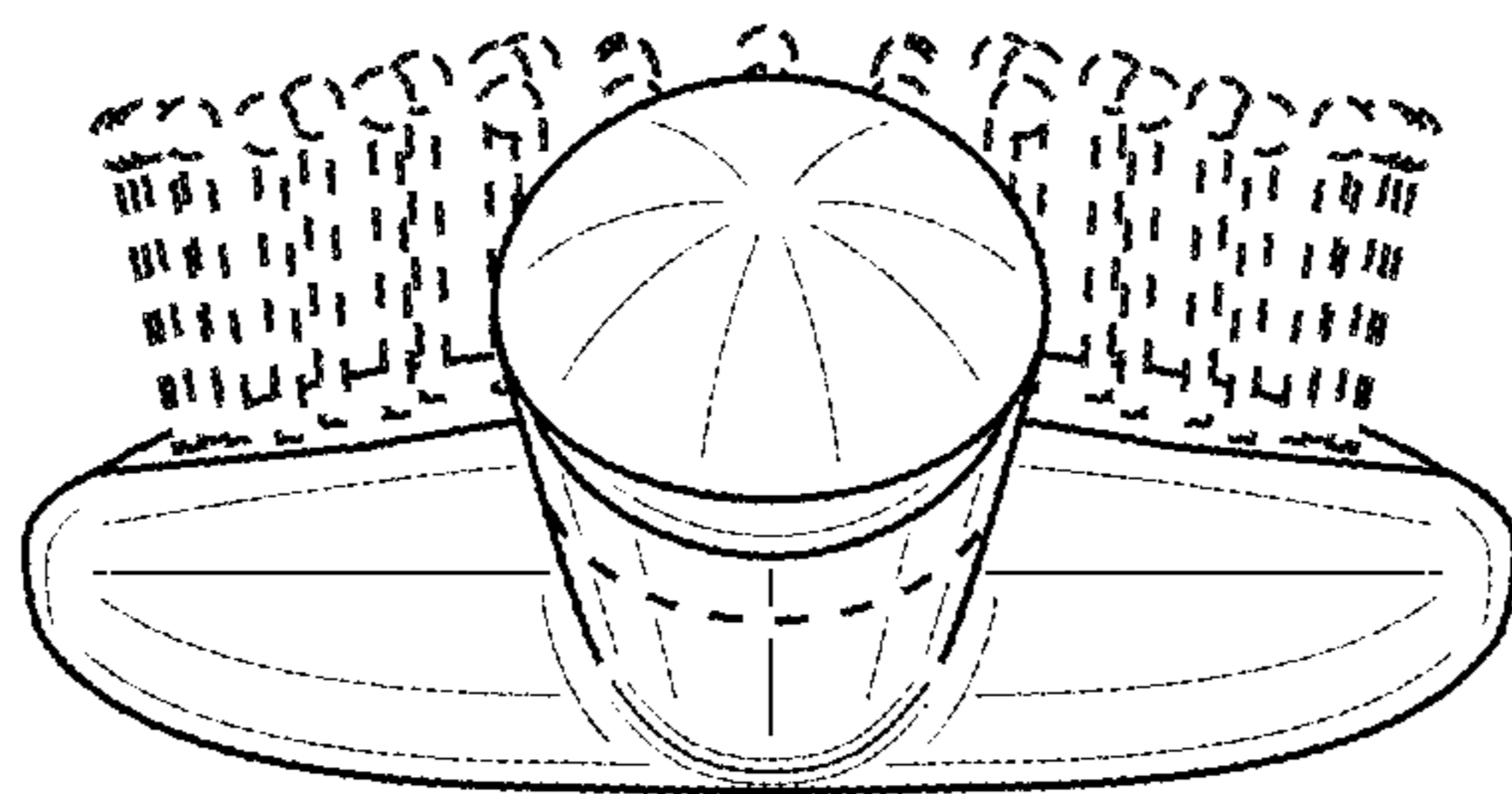
