The ornamental design for a grill mat, as shown and
described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a
grill mat in accordance with the subject disclosure.

FIG. 2 is a bottom perspective view thereof.

FIG. 3 is a top view thereof.

FIG. 4 is a bottom view thereof.

FIG. 5 is a left side view thereof.

FIG. 6 is a front view thereof.

FIG. 7 is a zoomed in top perspective view of the portion of
the grill mat that is marked off in FIG. 1.

FIG. 8 is a zoomed in bottom perspective view of the portion
of the grill mat that is marked off in FIG. 2.

FIG. 9 is a zoomed in top view of the portion of the grill mat
that is marked off in FIG. 3.

FIG. 10 is a zoomed in bottom view of the portion of the grill
mat that is marked off in FIG. 4.

FIG. 11 is a zoomed in left side view of the portion of the
grill mat that is marked off in FIG. 5; and,

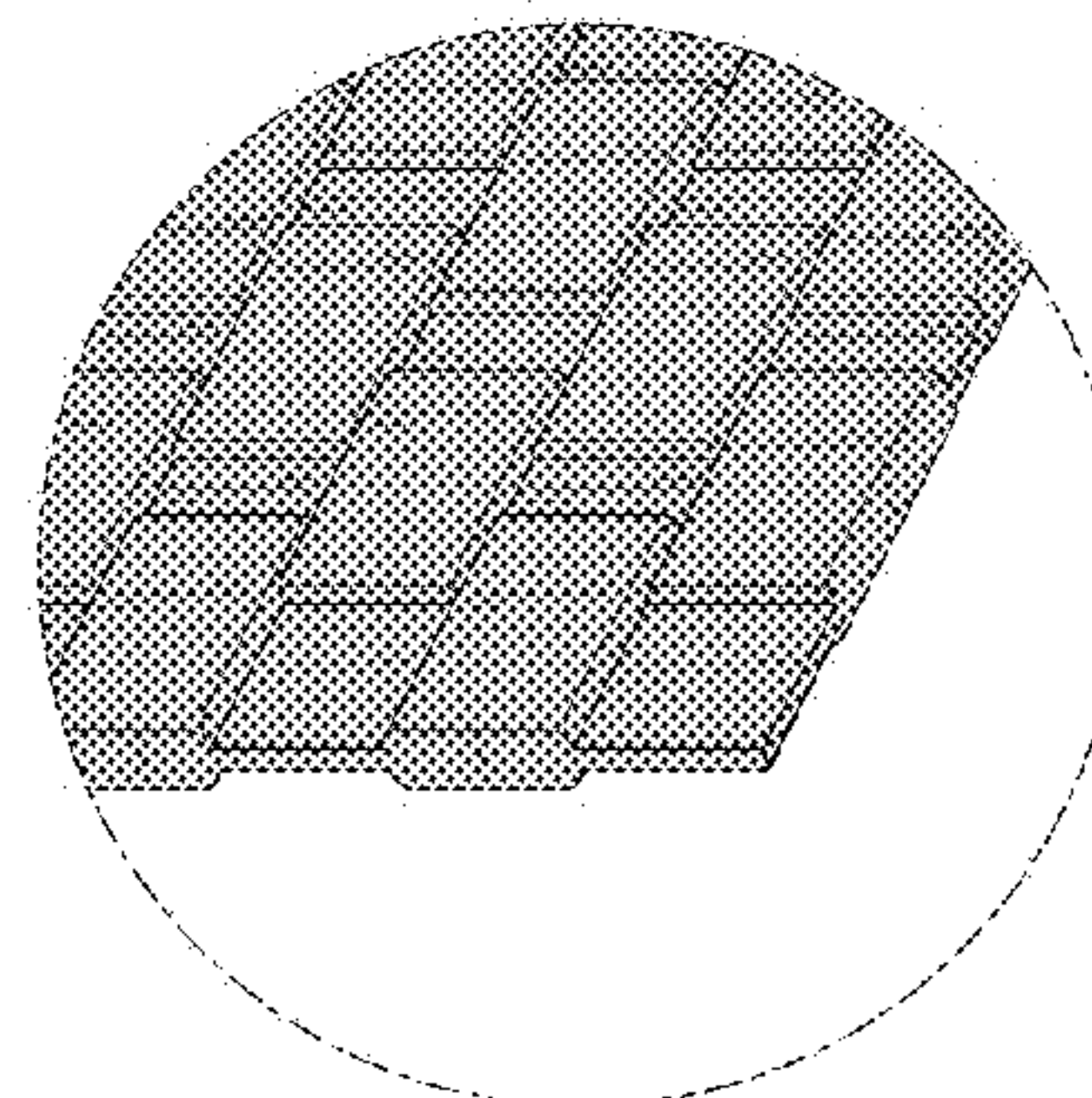
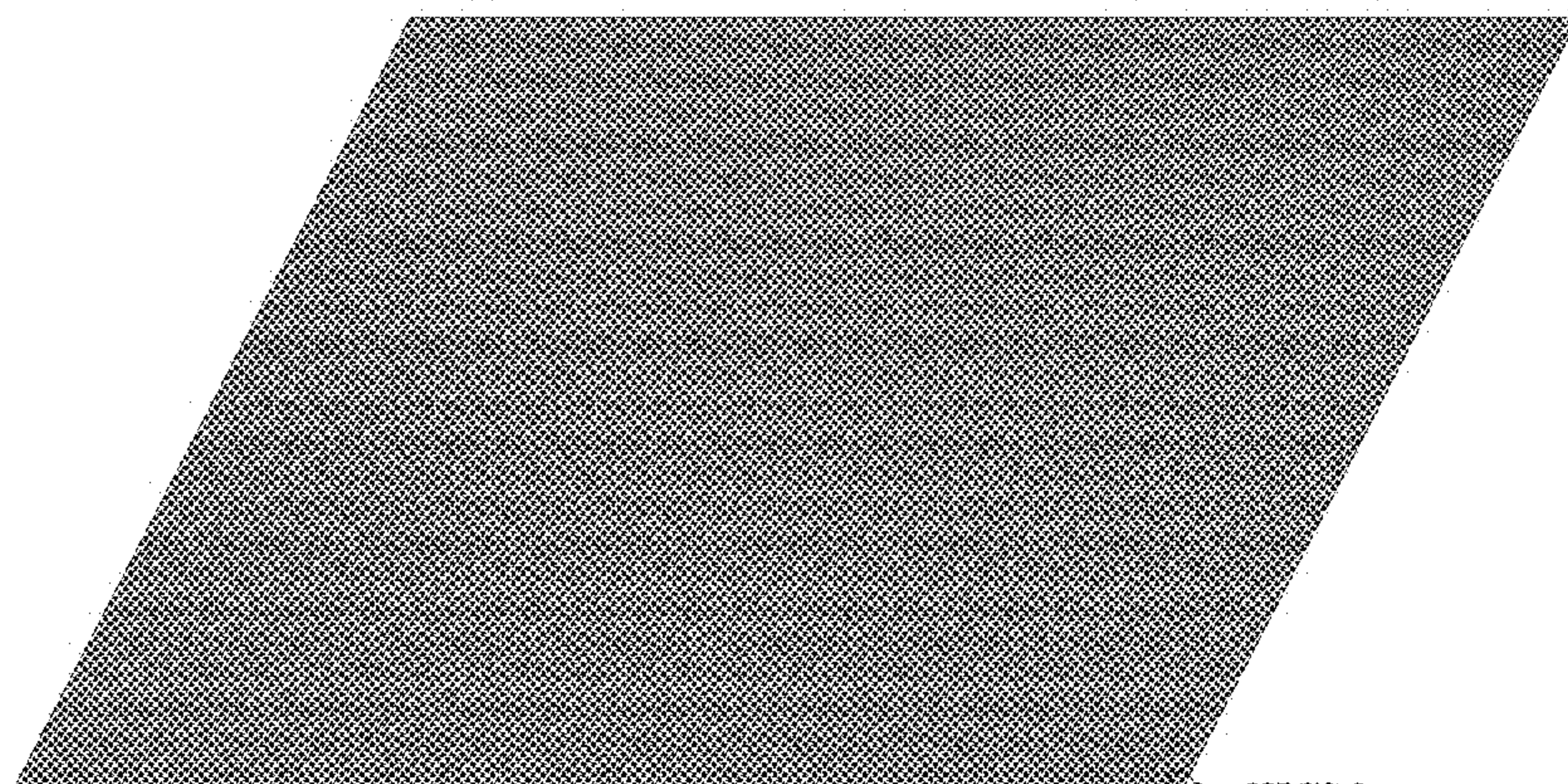
FIG. 12 is a zoomed in front view of the portion of the grill
mat that is marked off in FIG. 6.

No right side view is shown, the right side view being a
mirror image of the left side view of FIG. 5. Similarly, no
rear view is shown, the rear view being a mirror image of the
front view of FIG. 6.

The broken showings are for marking areas of the grill mat
shown in other drawings and form no part of the claimed
design.

All areas of the top and bottom surface of the grill mat are
similar to the zoomed in portions shown in FIGS. 7-12.

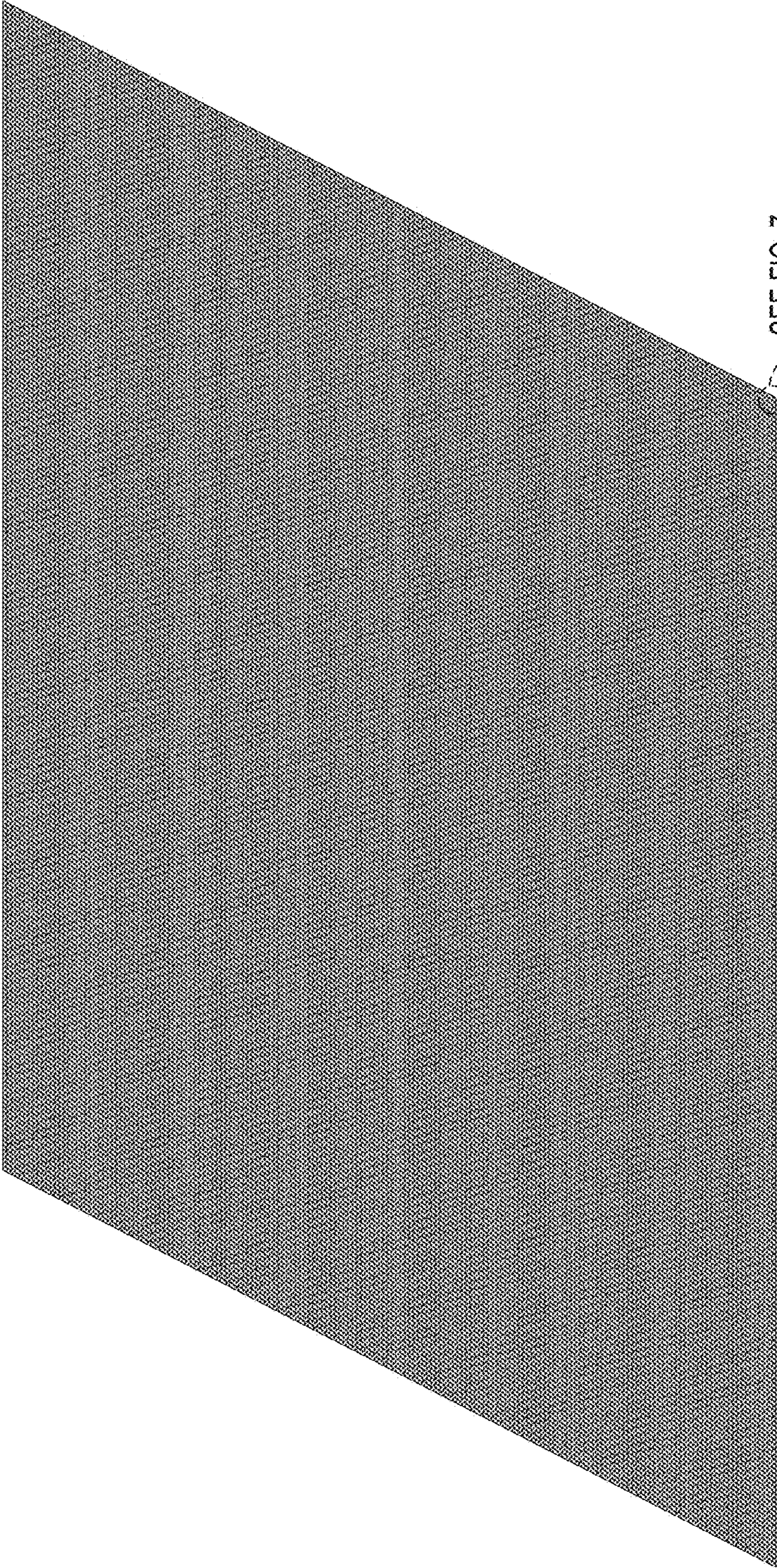

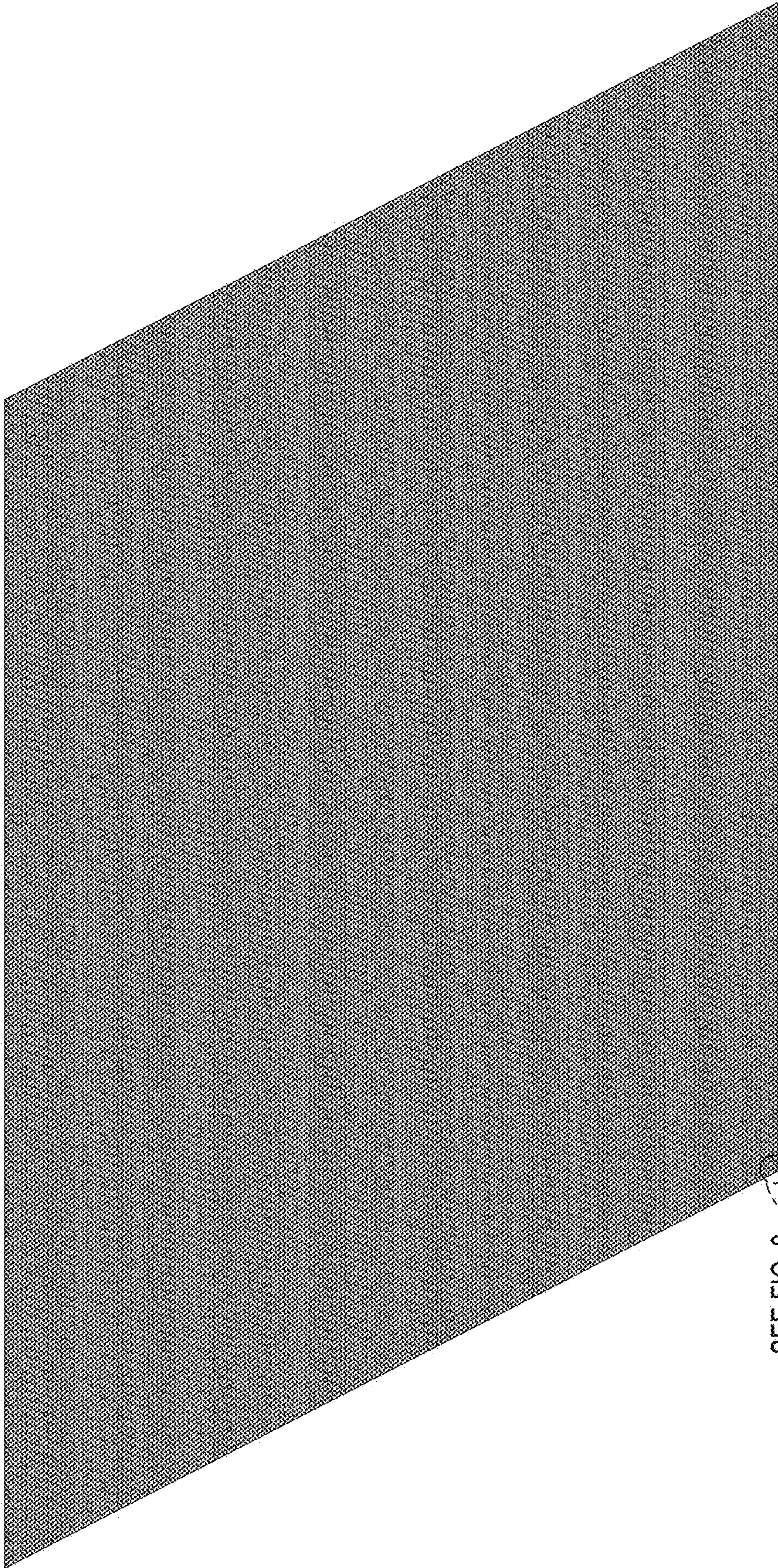

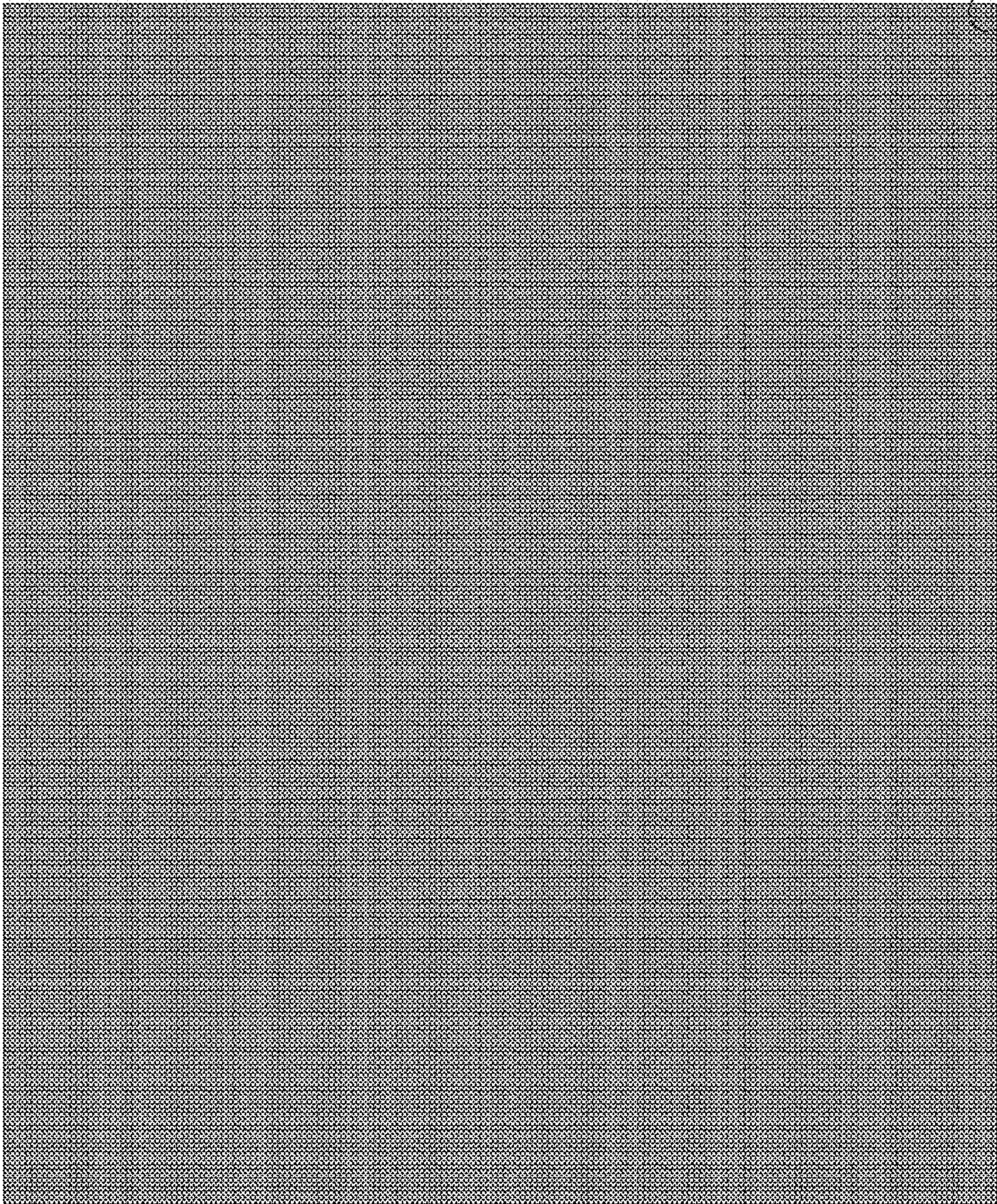

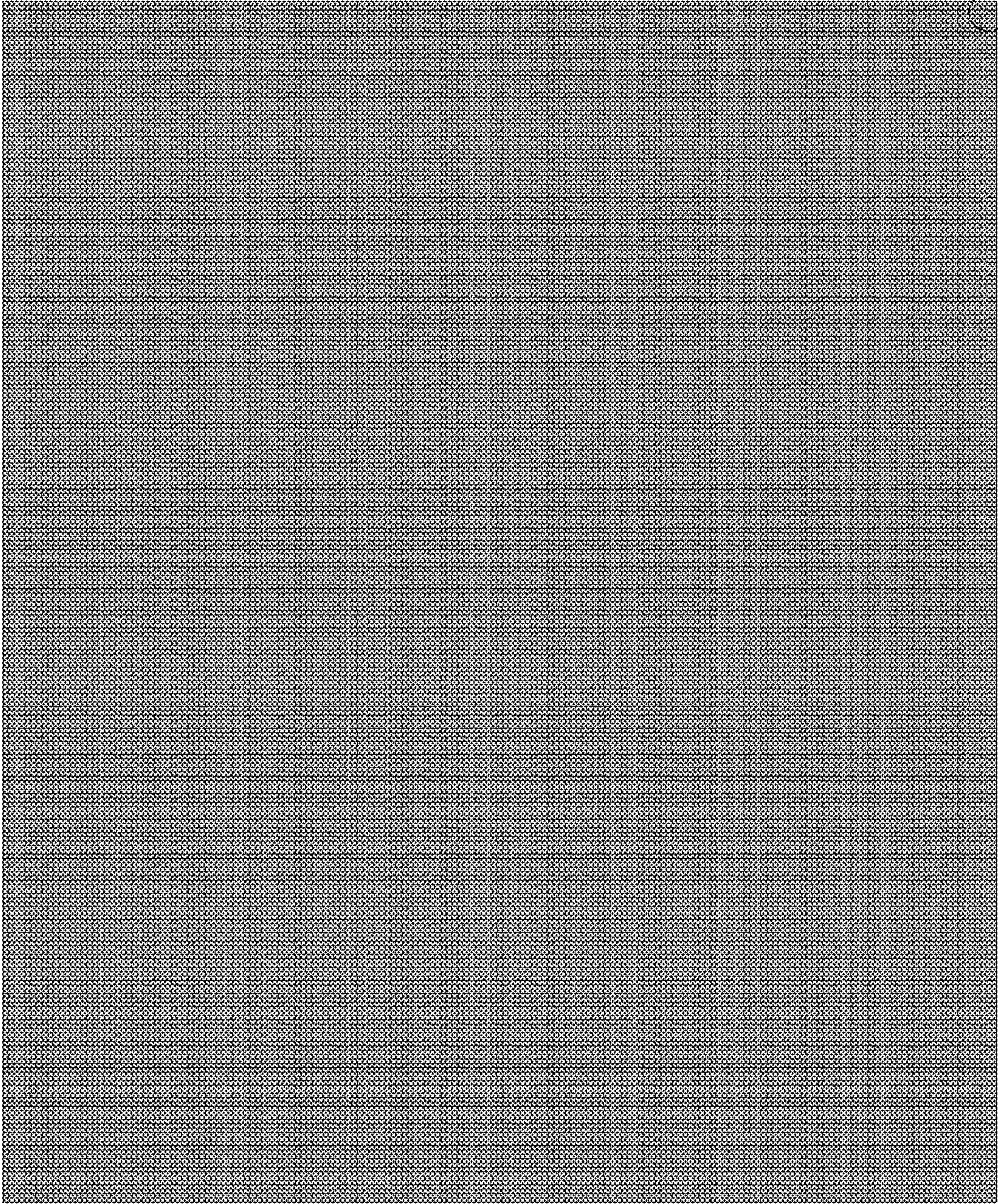

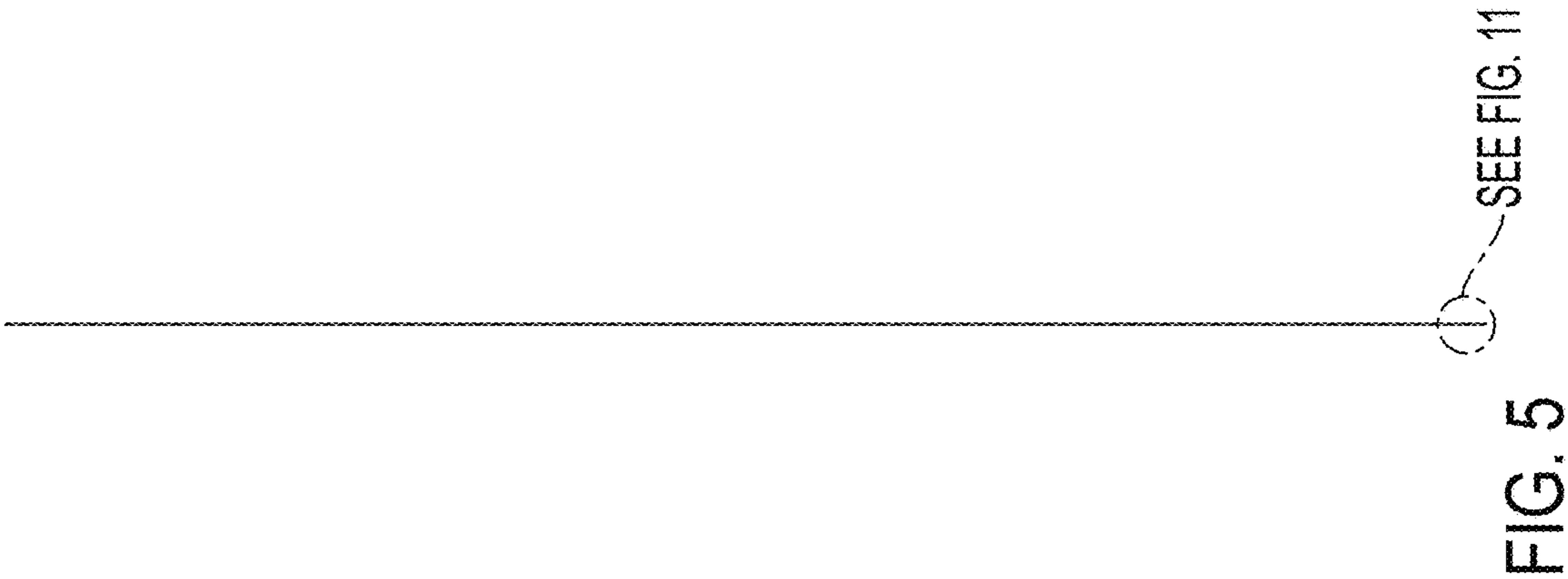

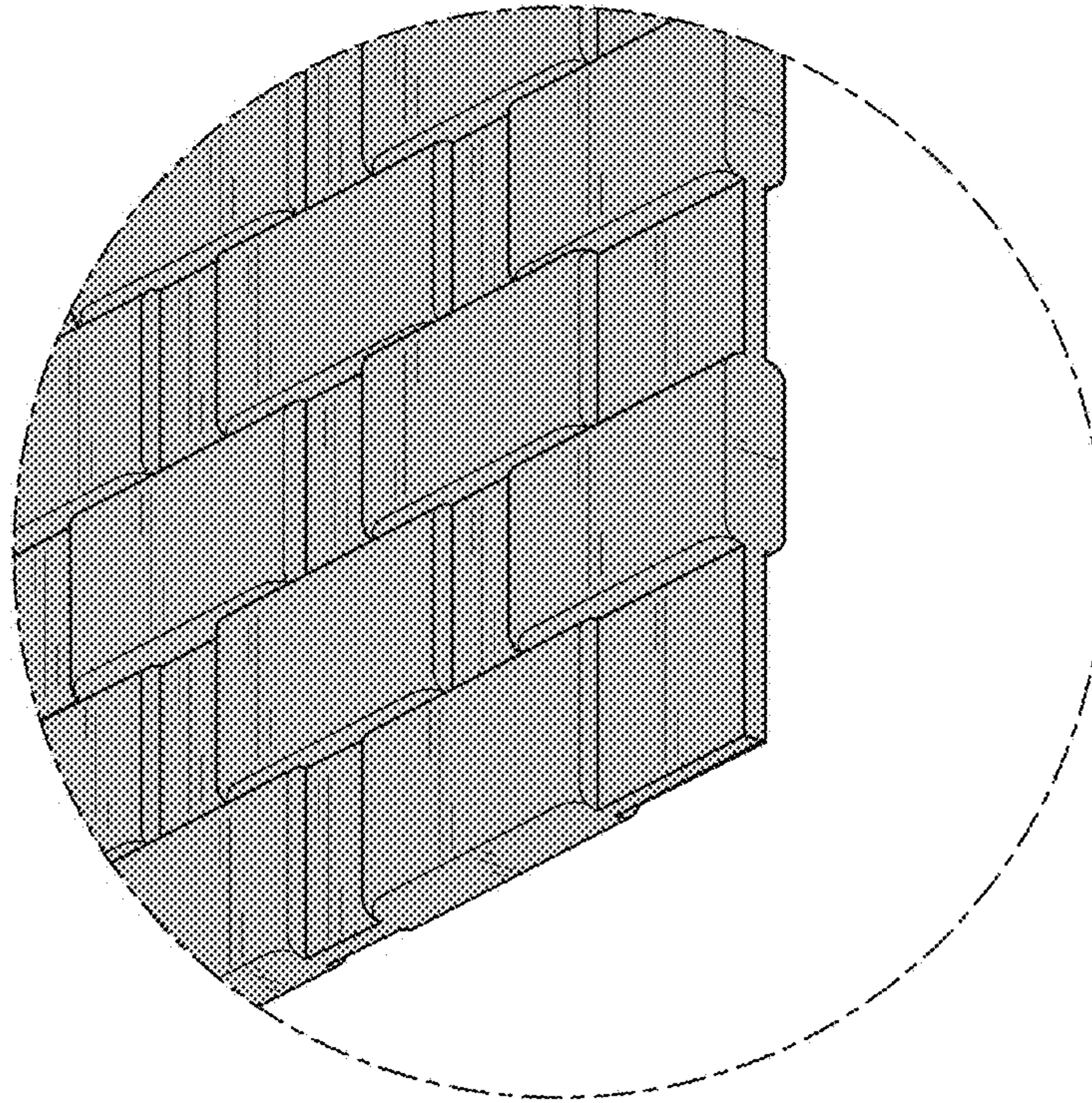

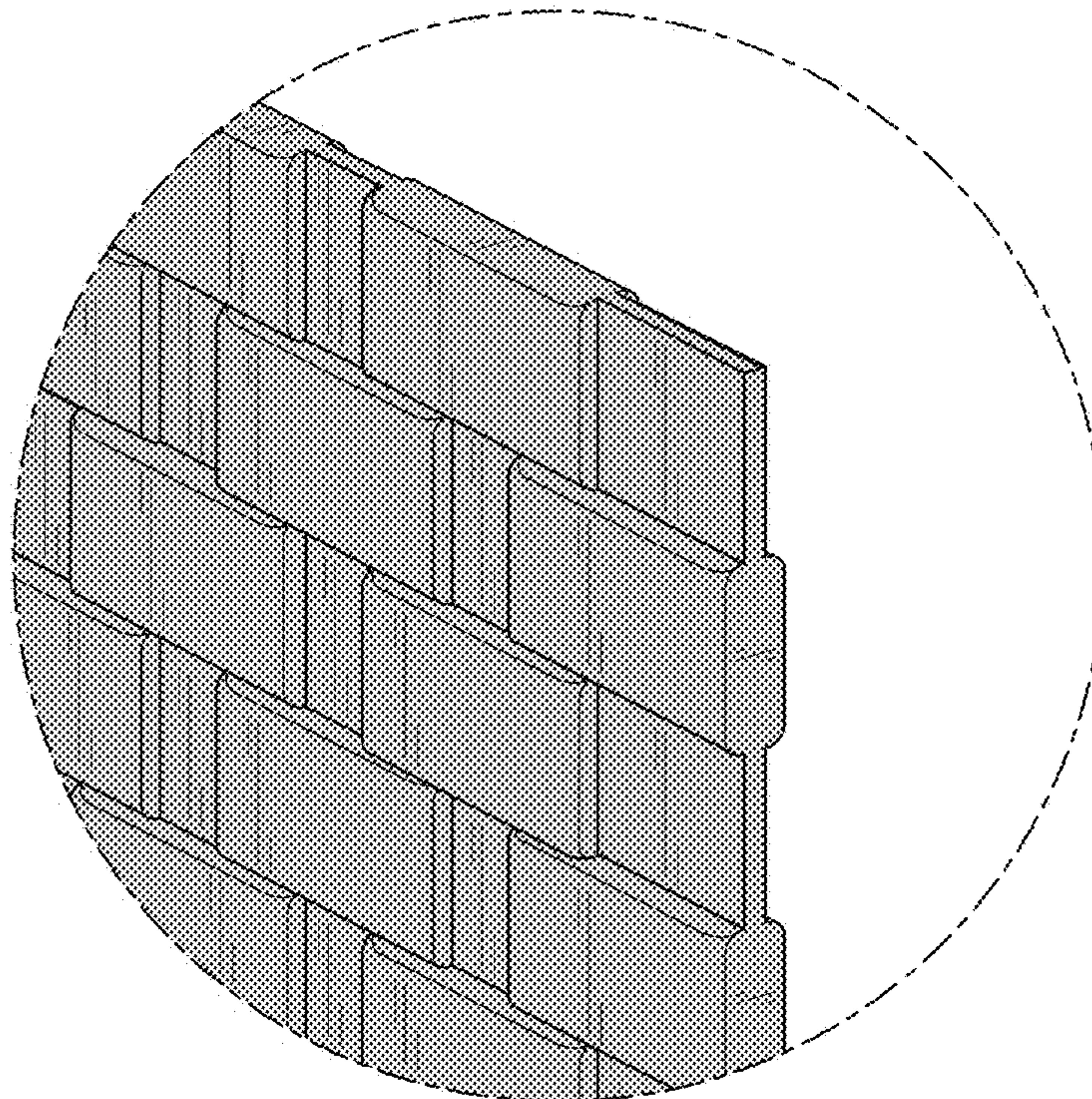

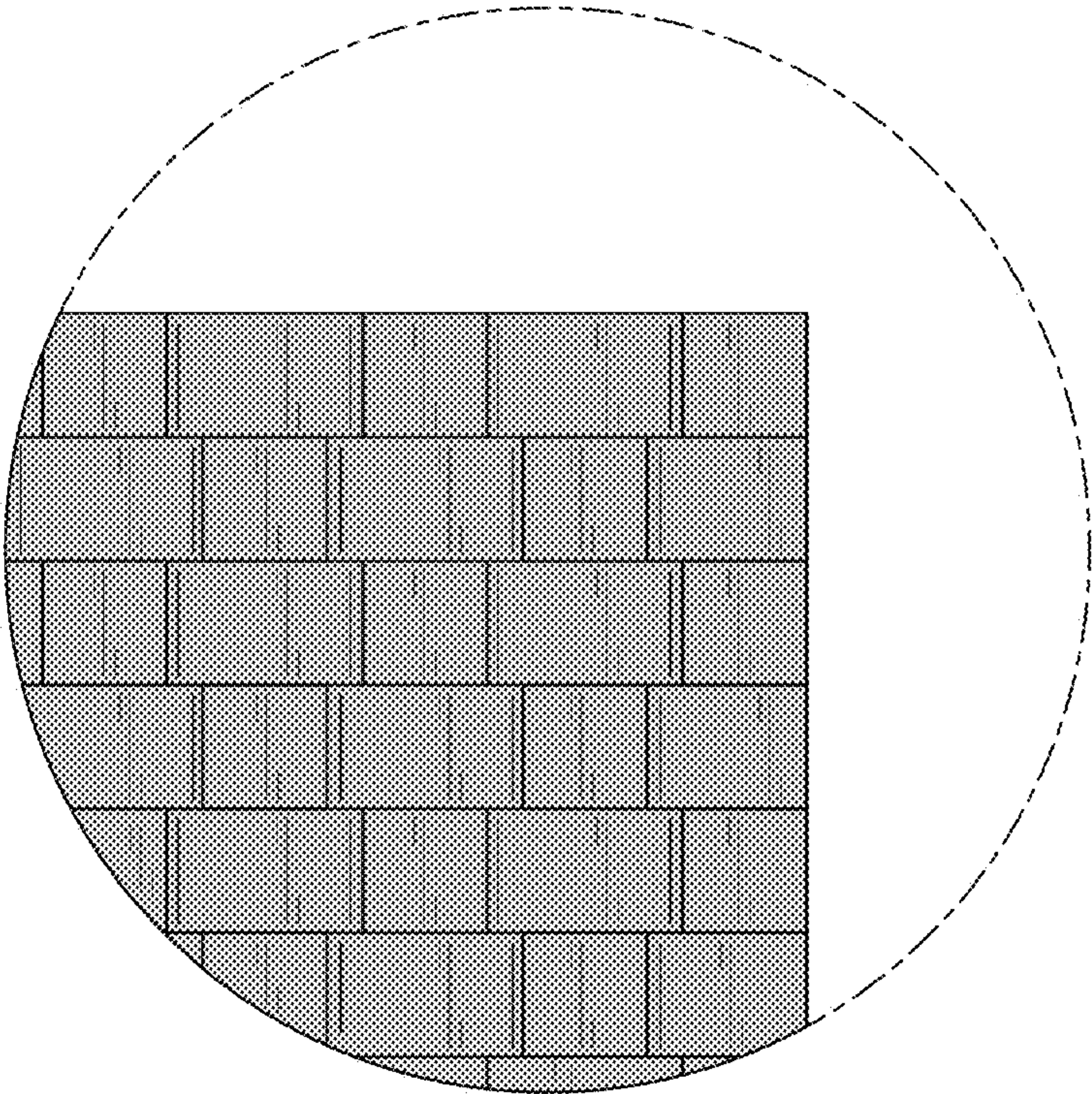

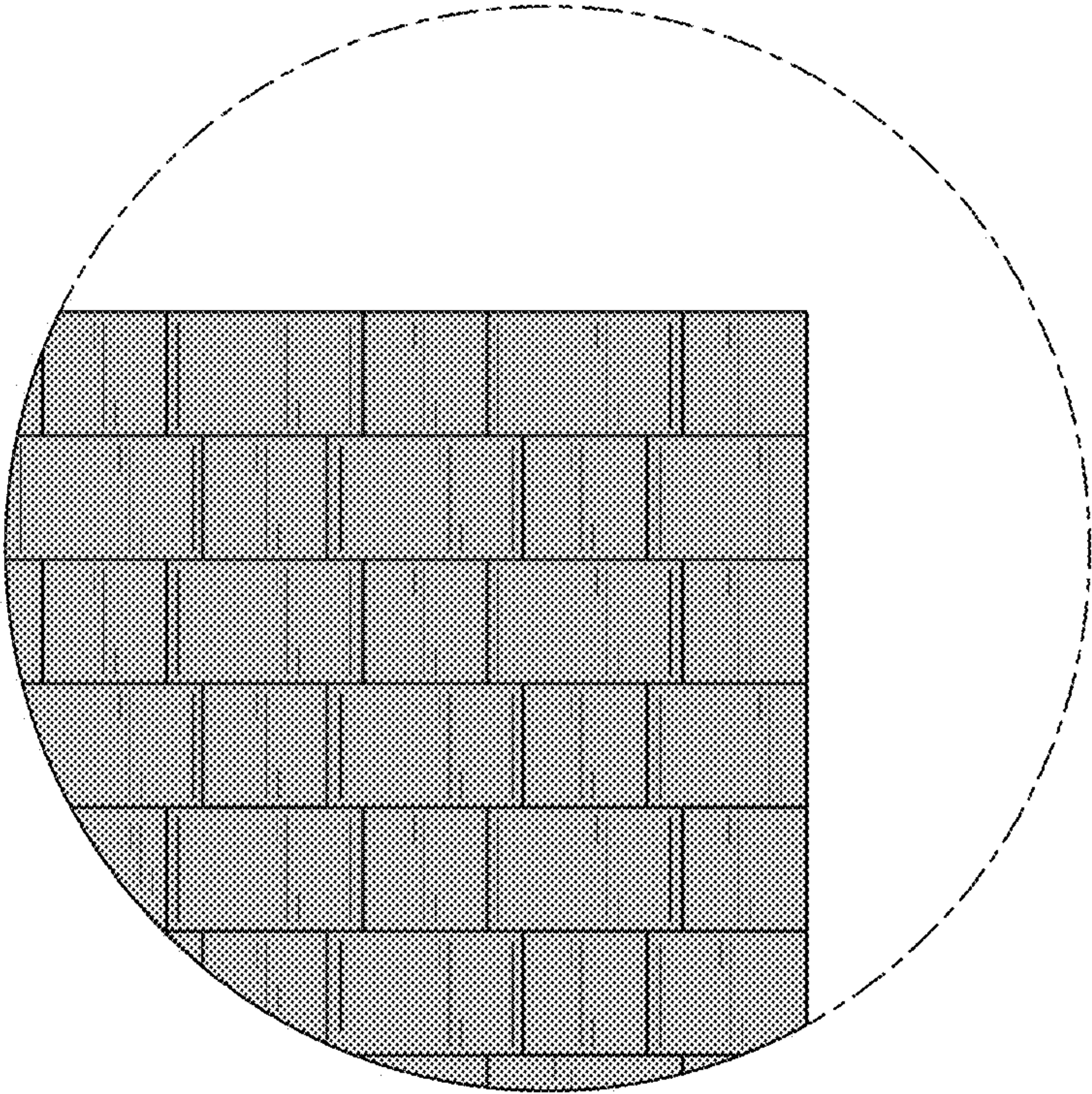

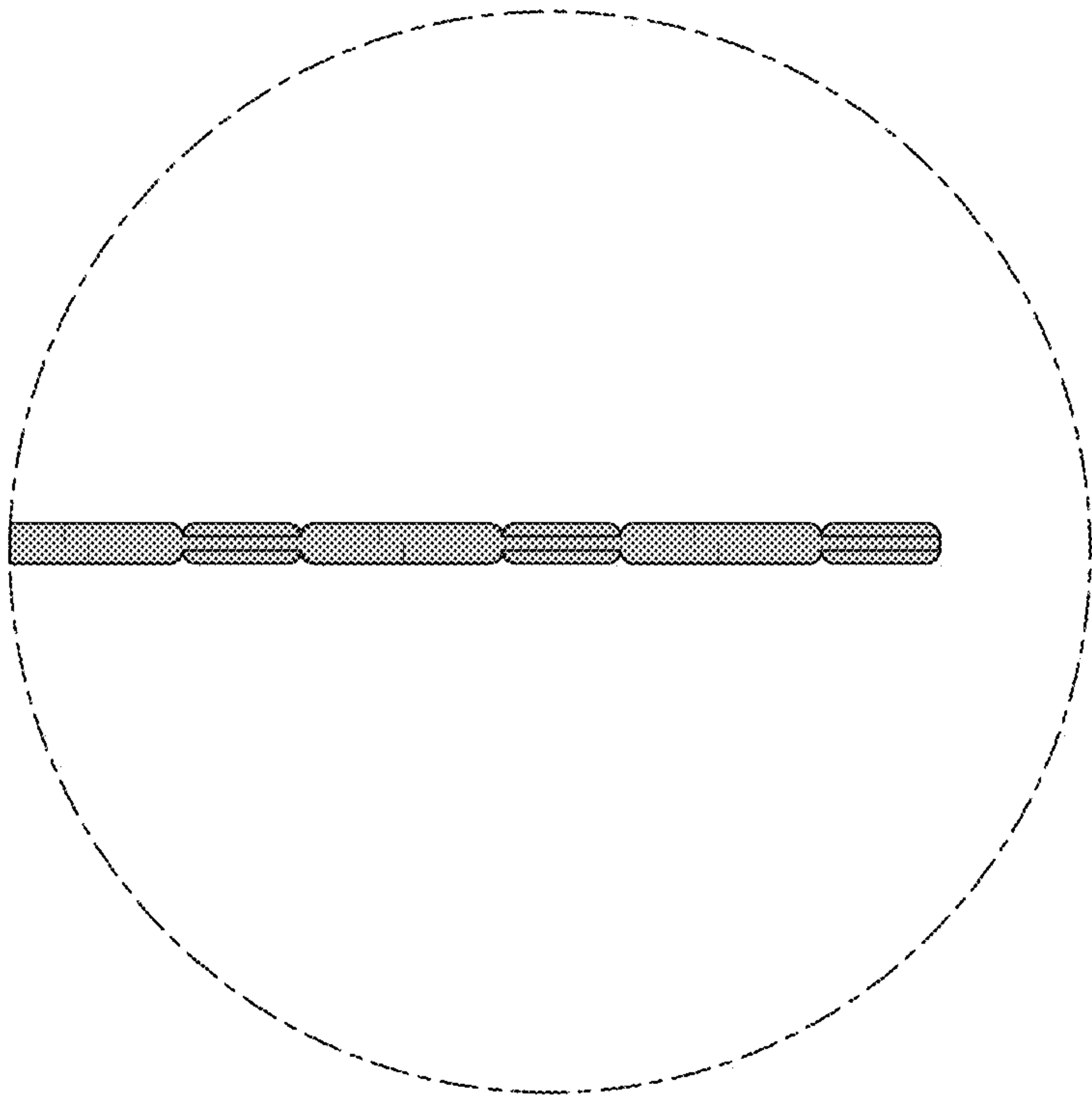

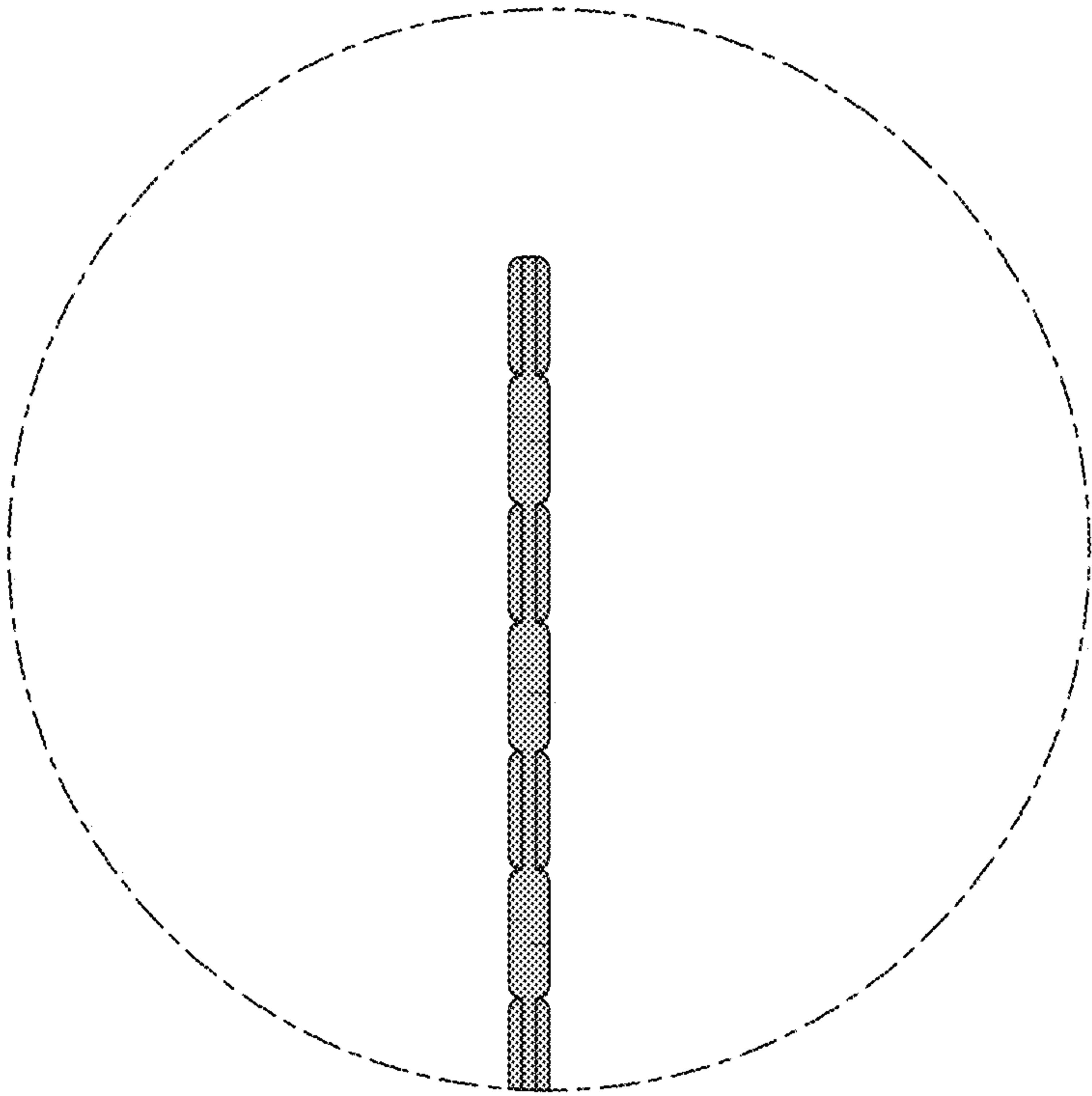
