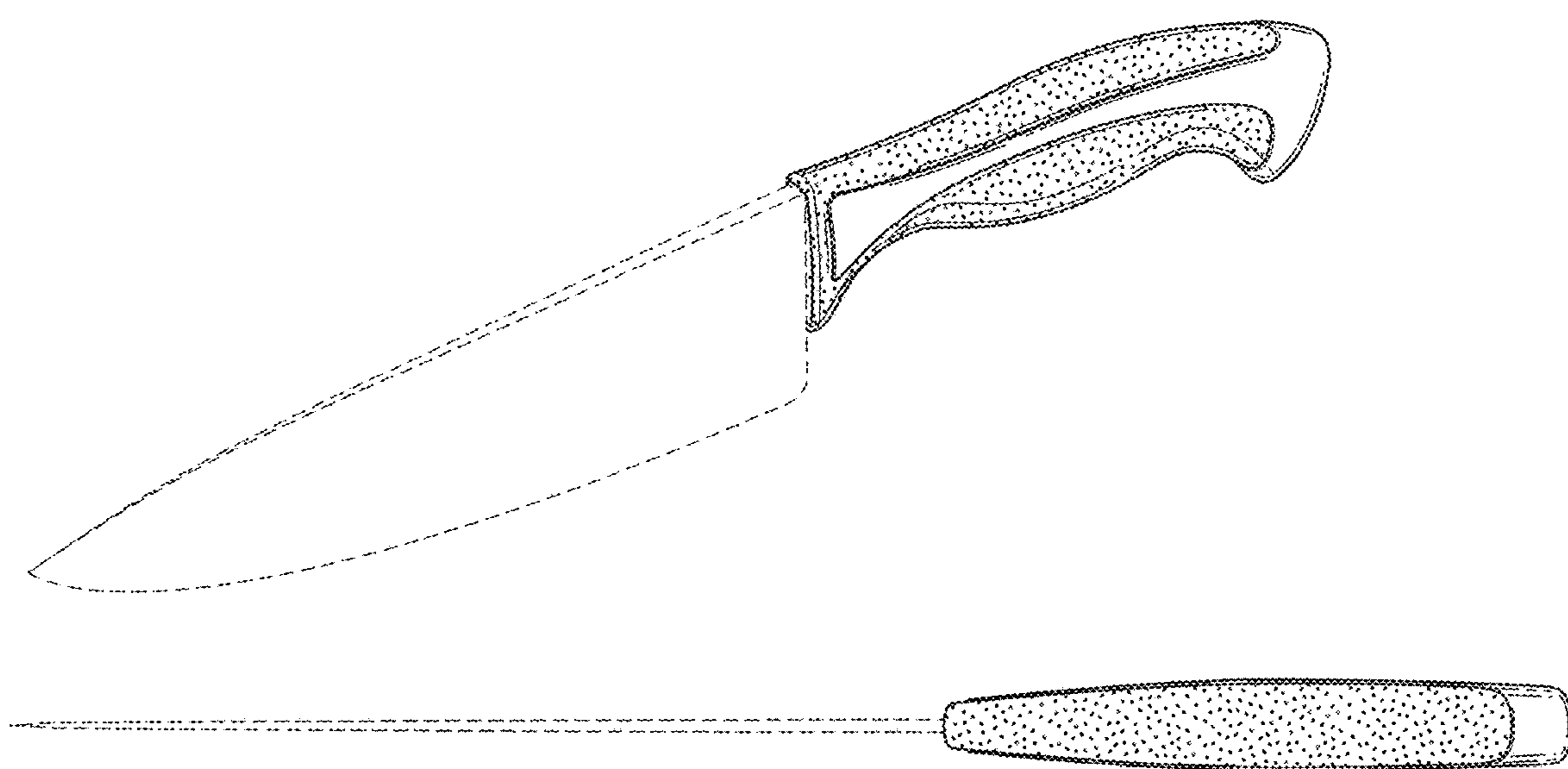

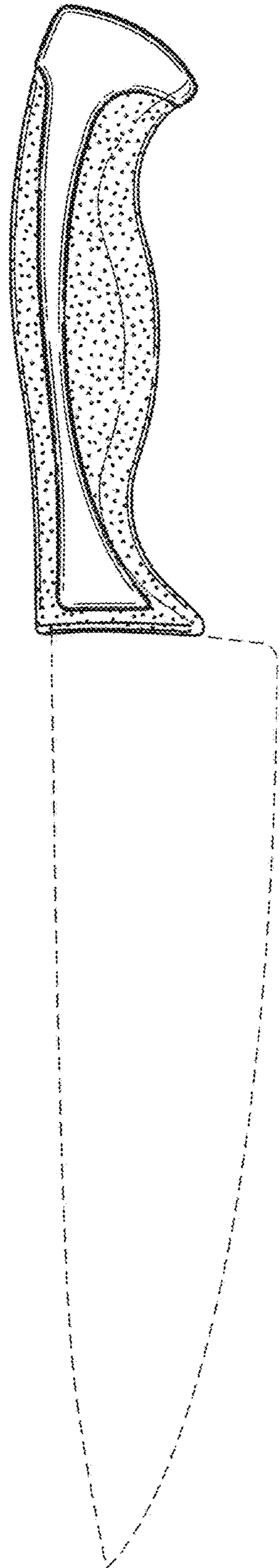
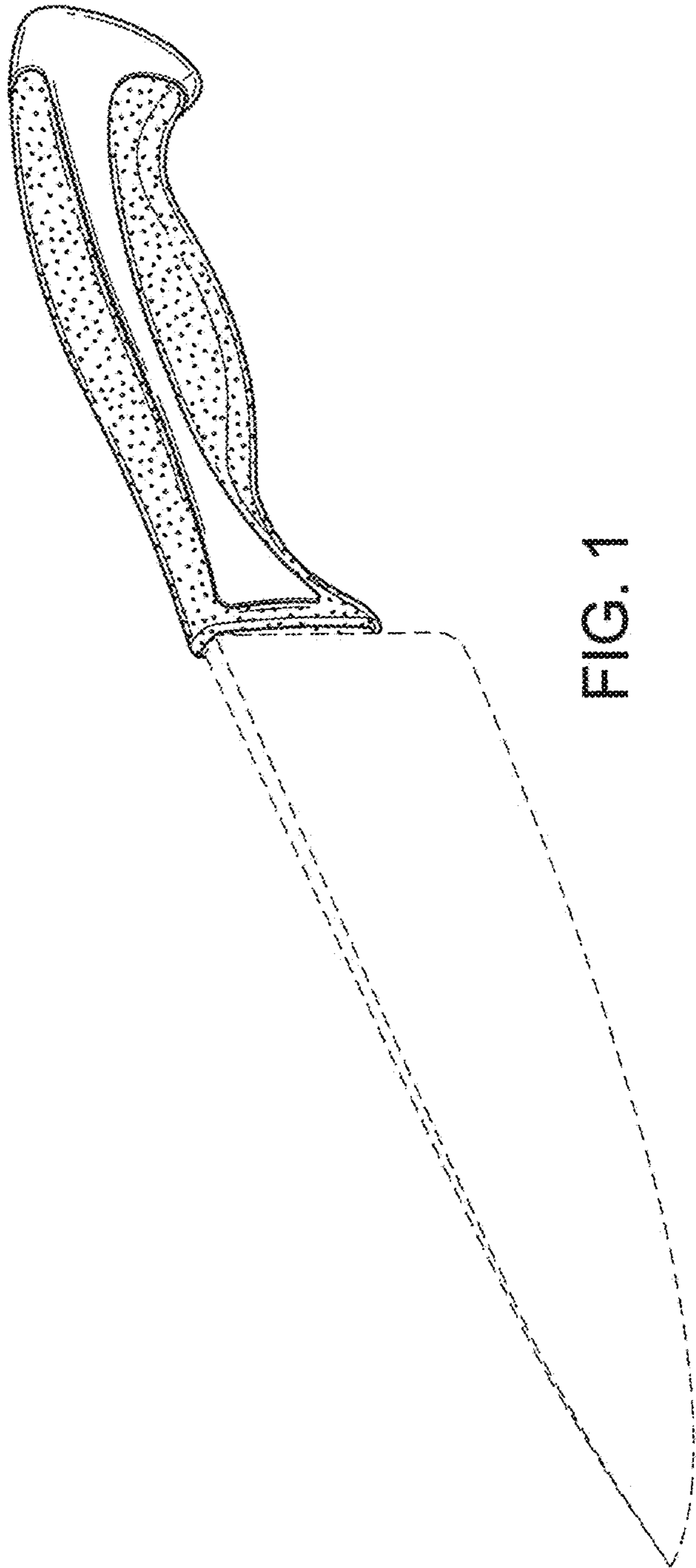
The ornamental design for knife handle, as shown and described.

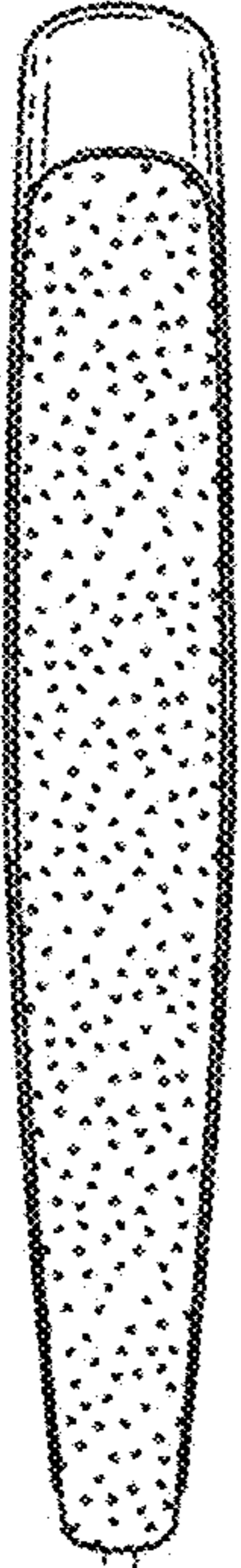

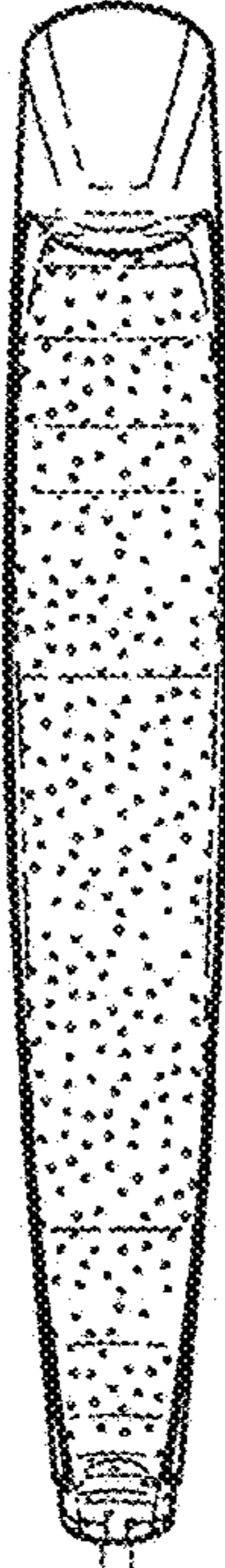

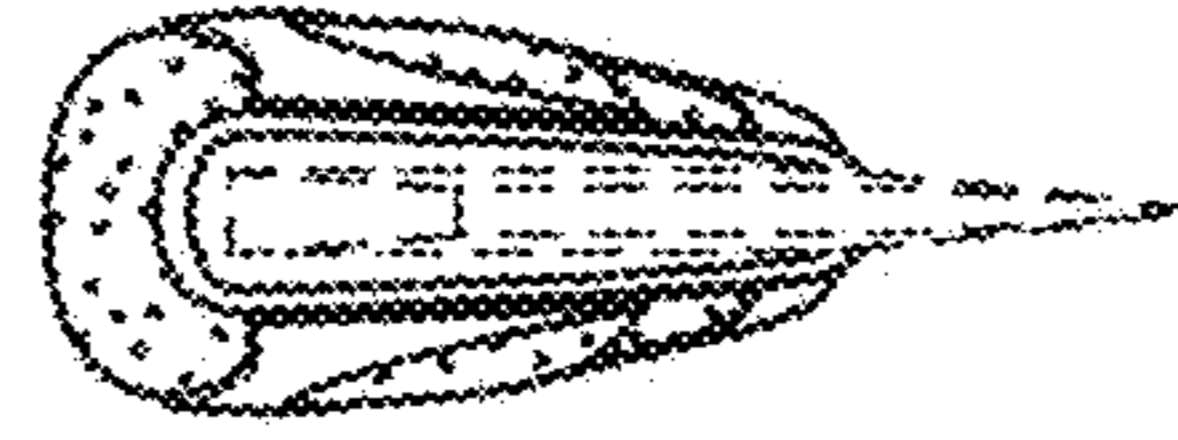

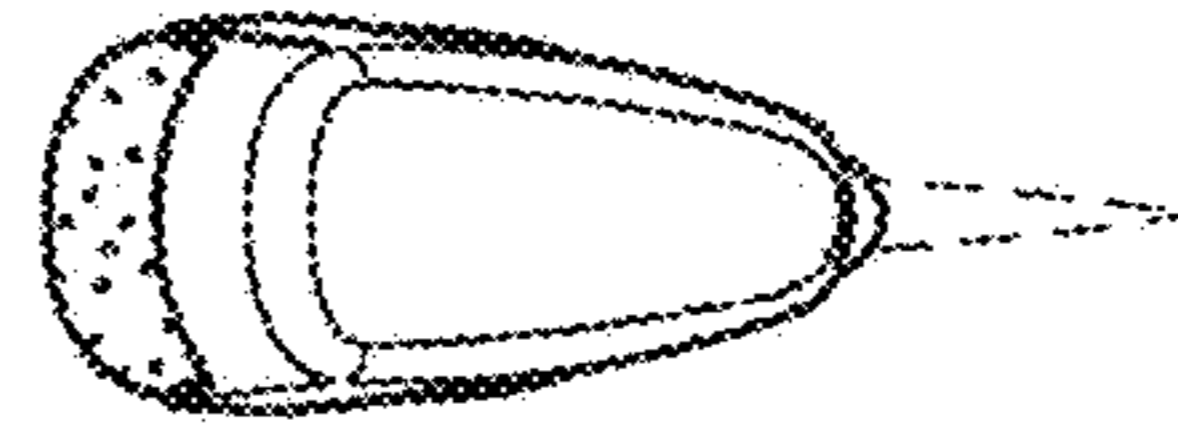
