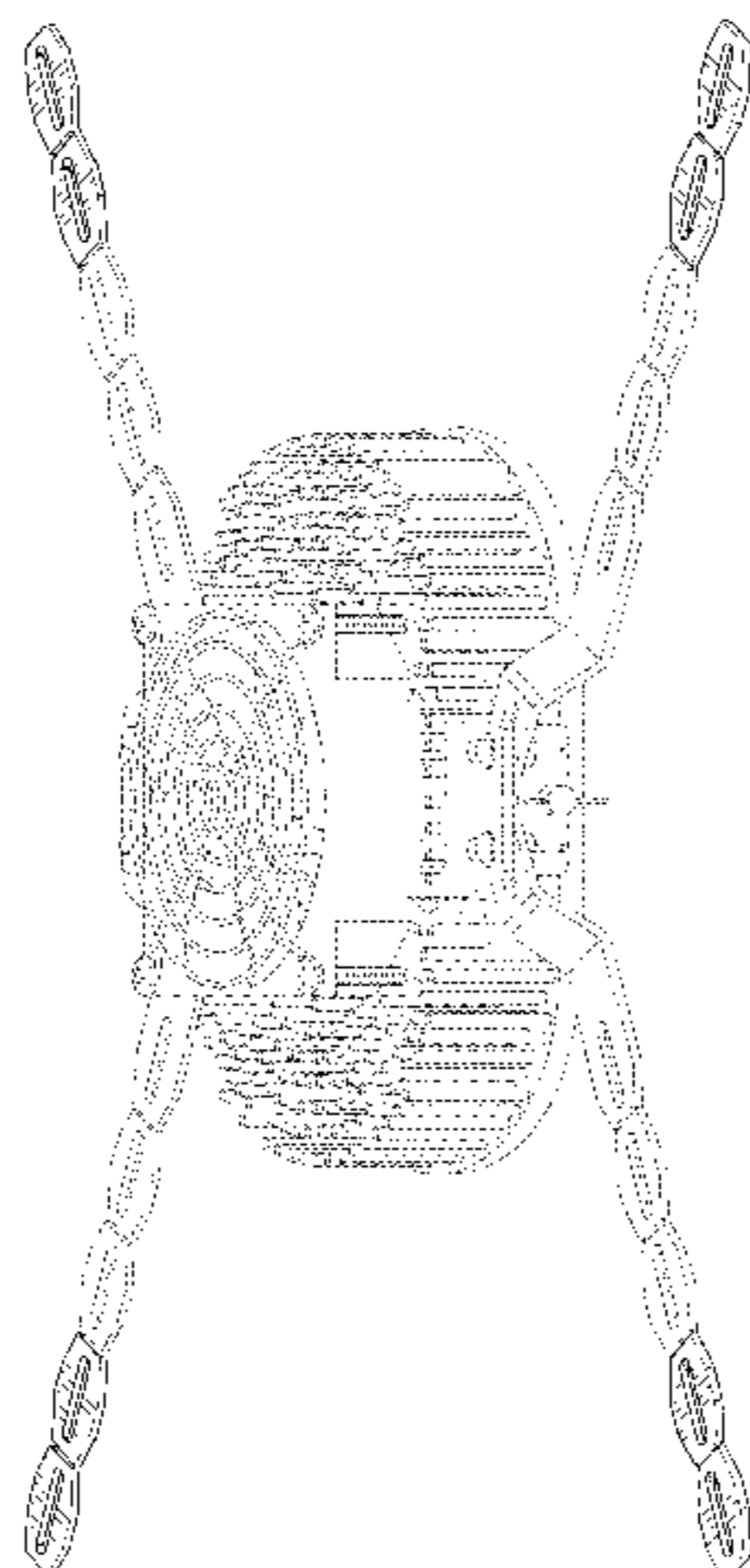


FIG. 25 is a front view of the bracket in FIG. 22.

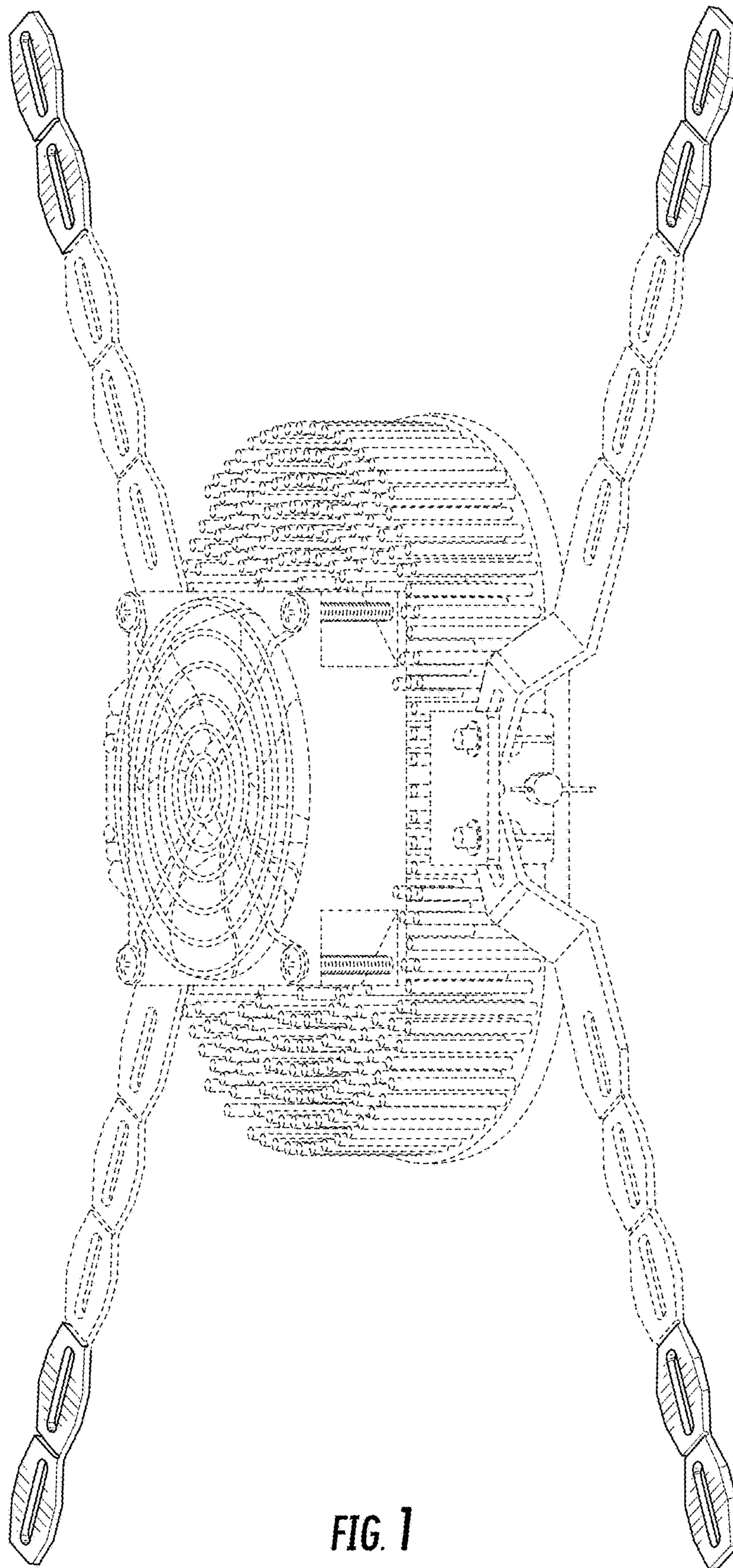

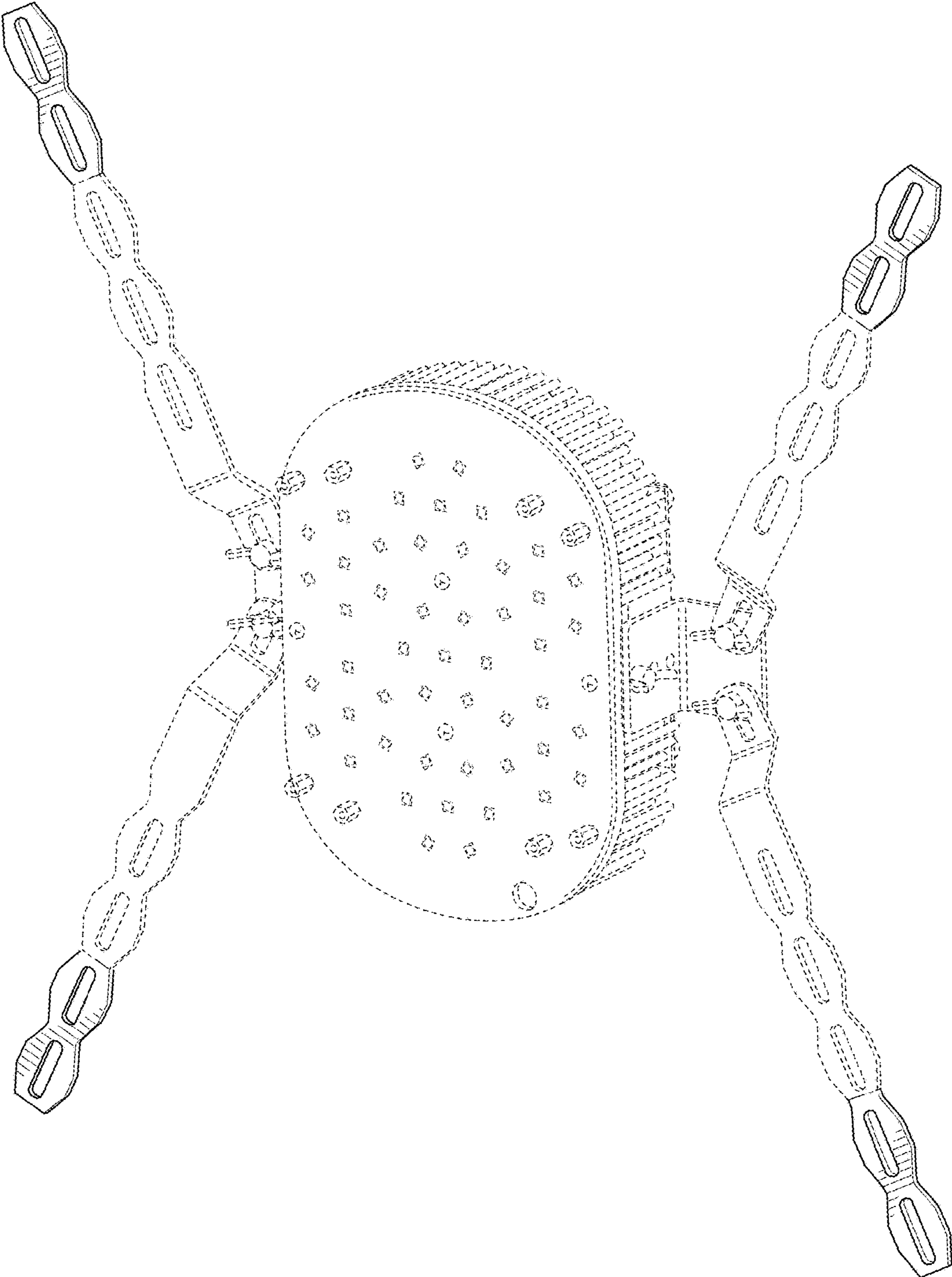

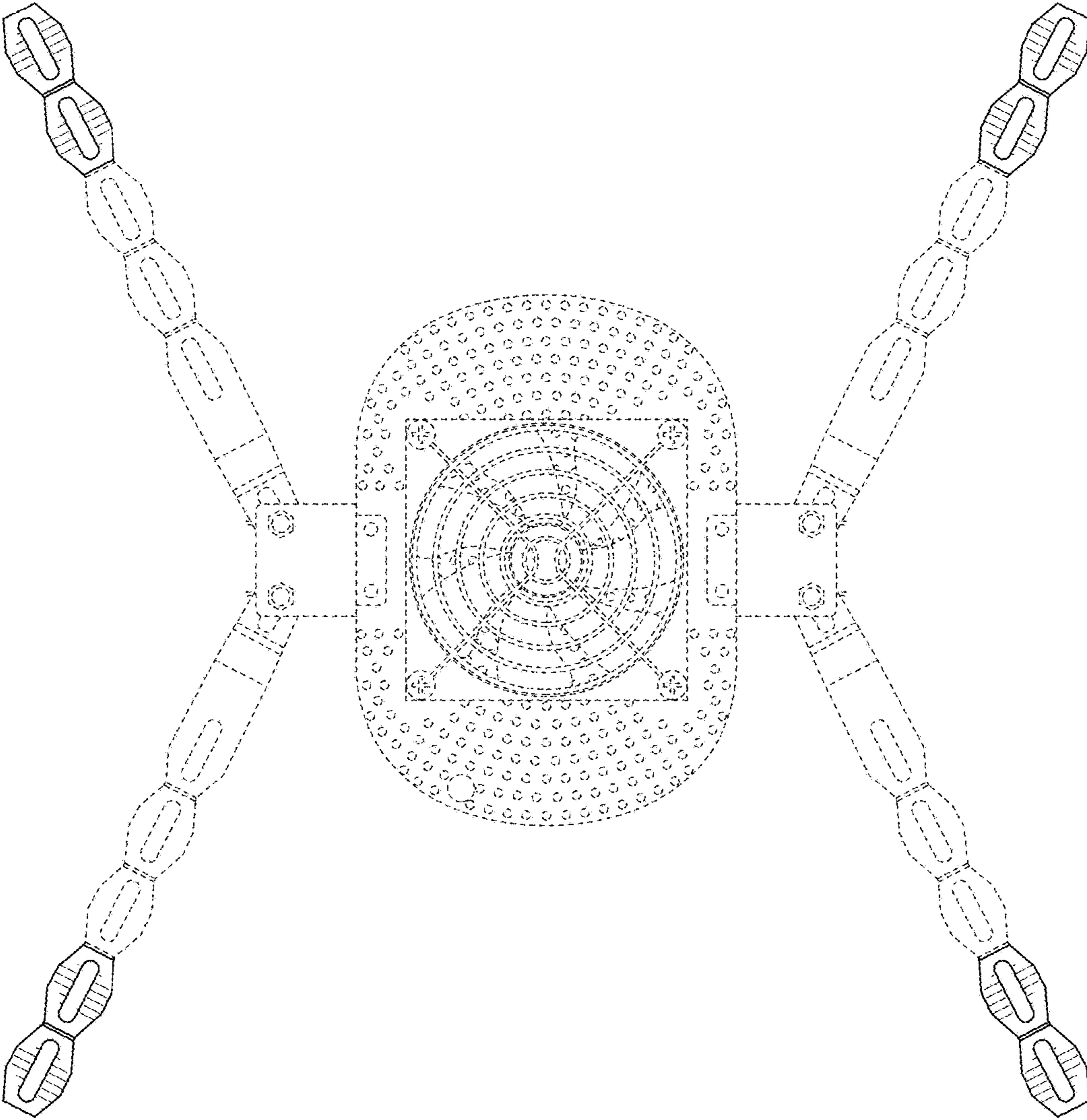

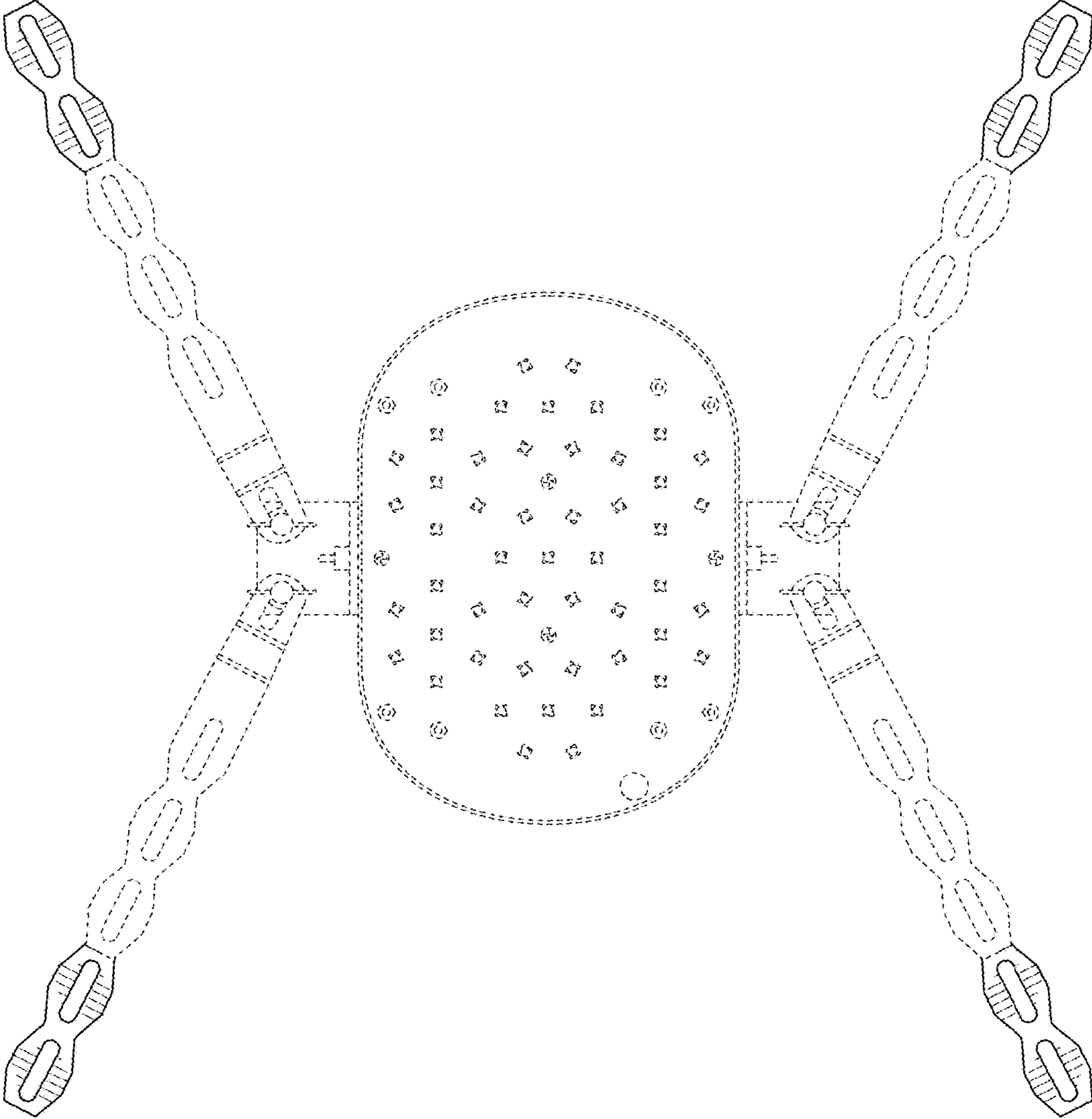

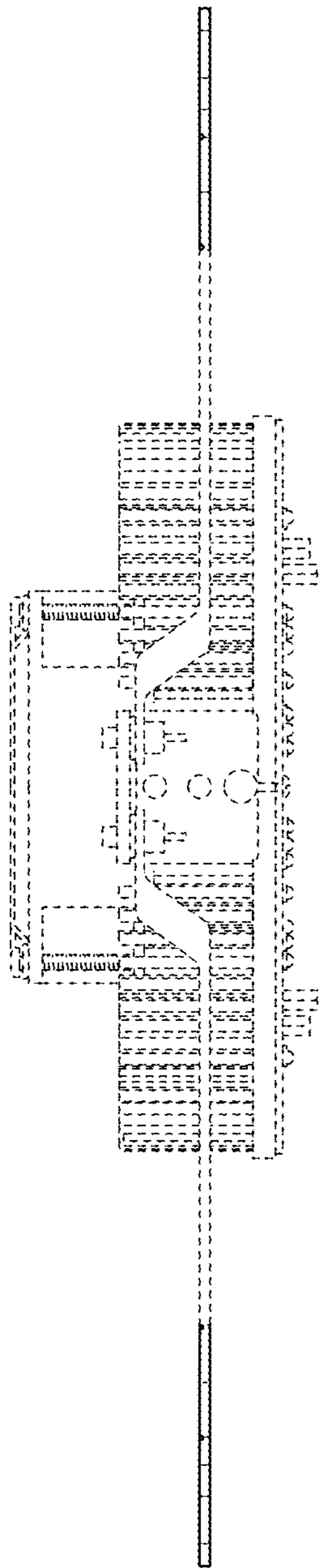

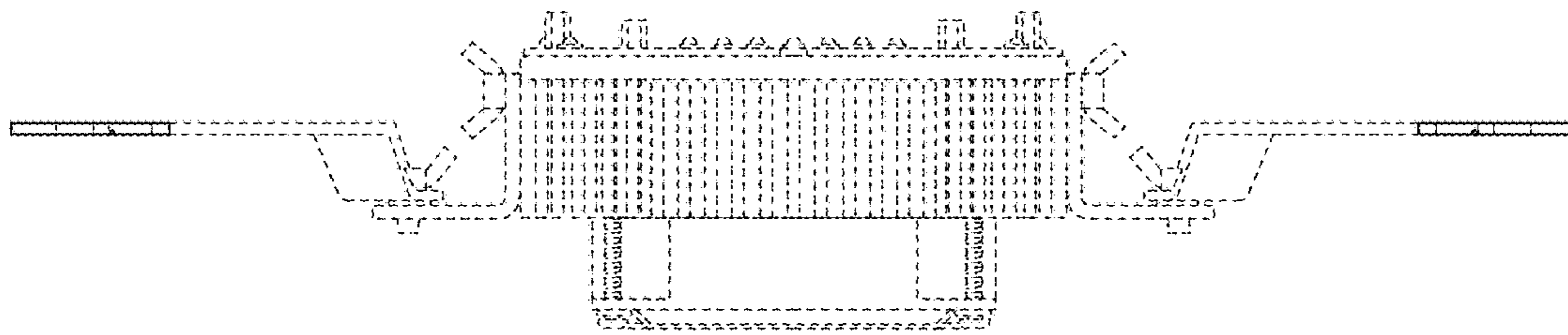

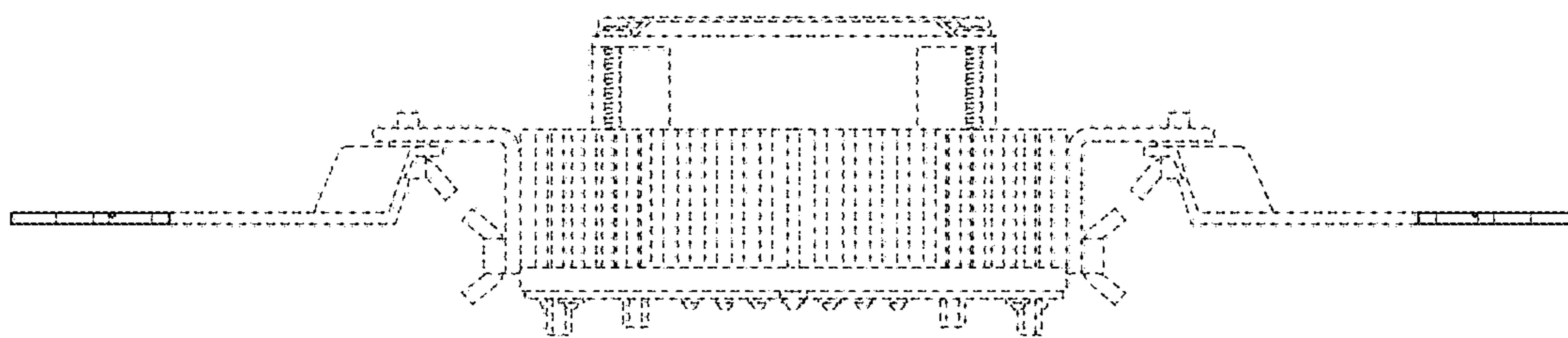

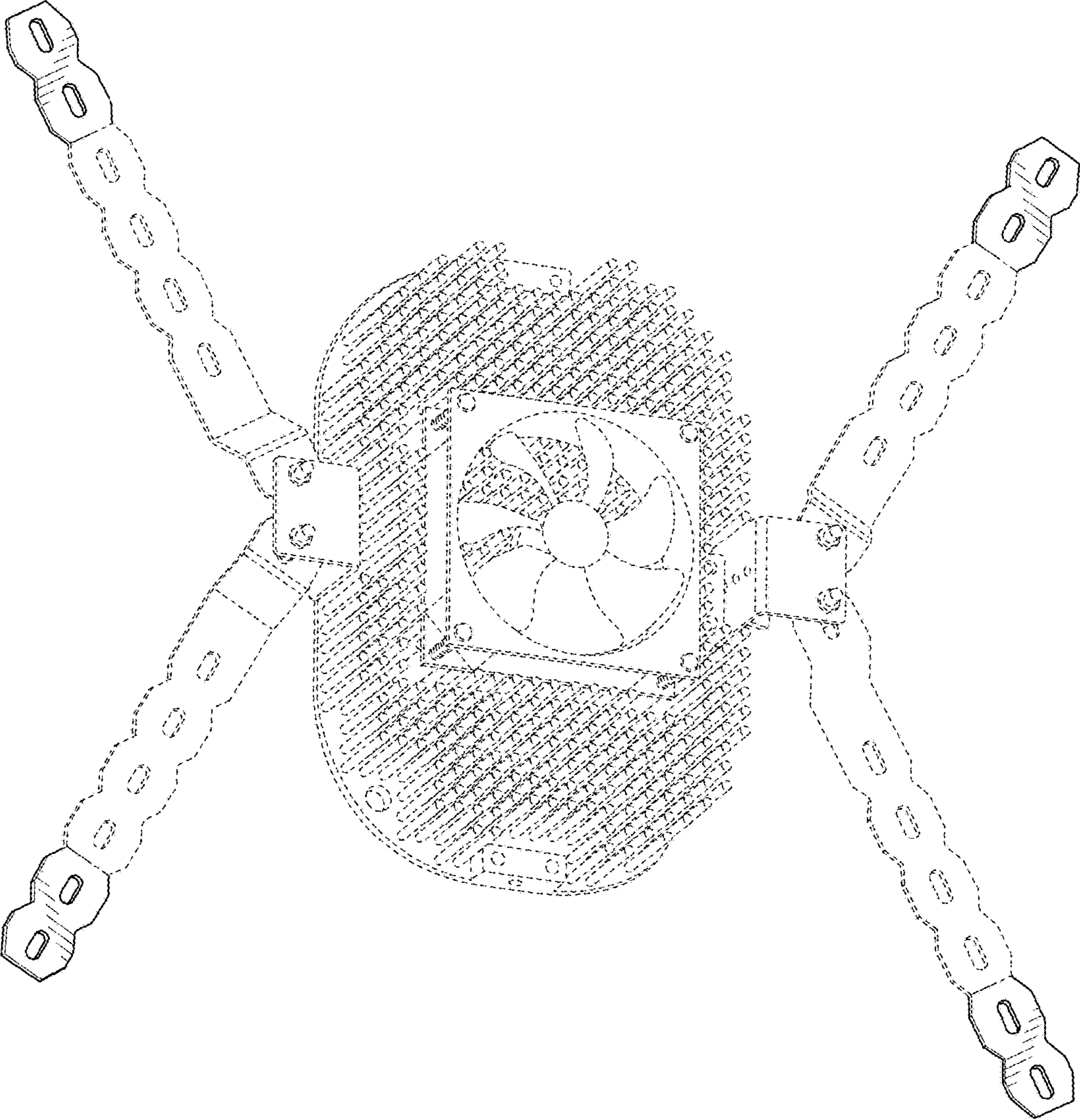

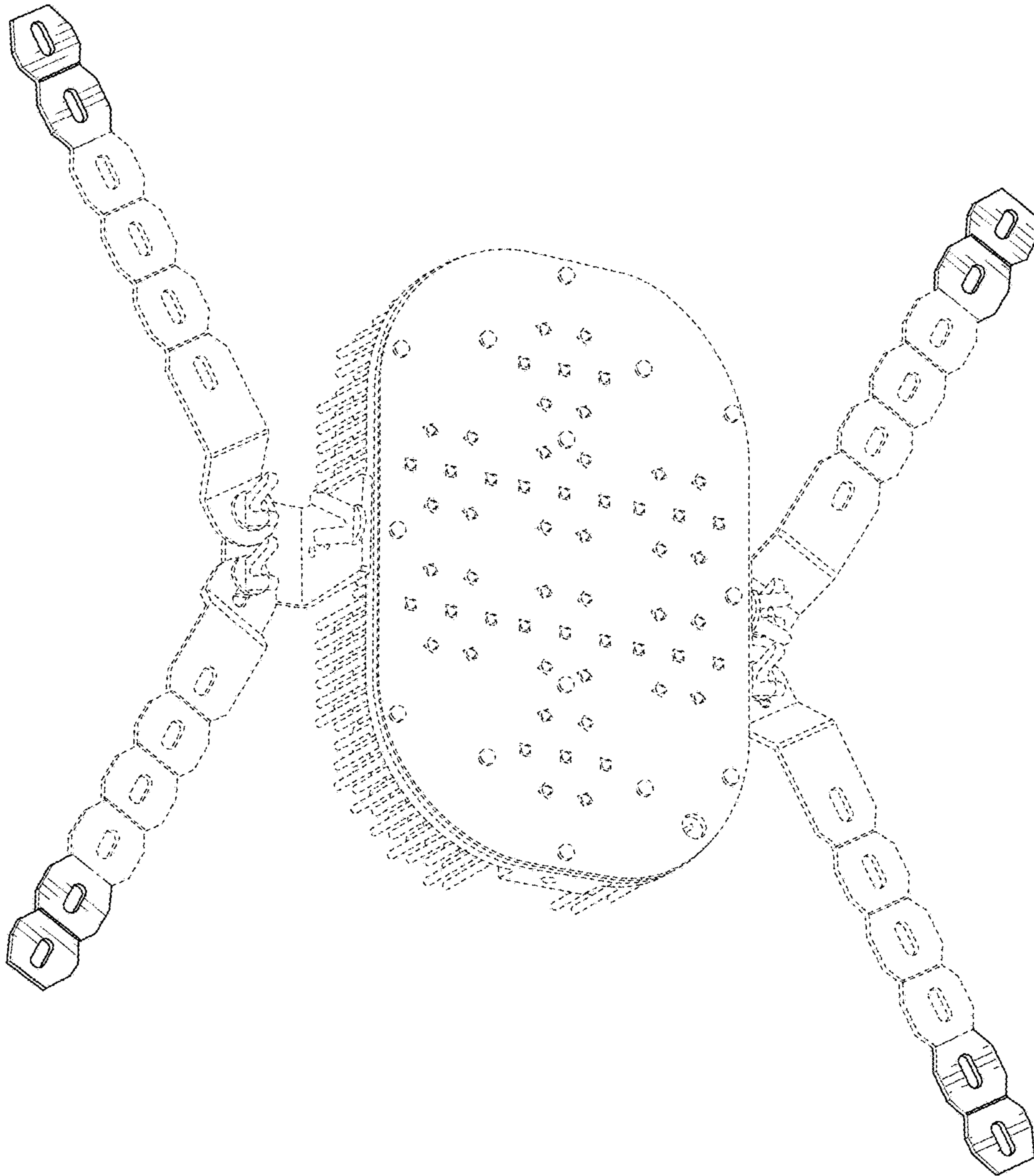

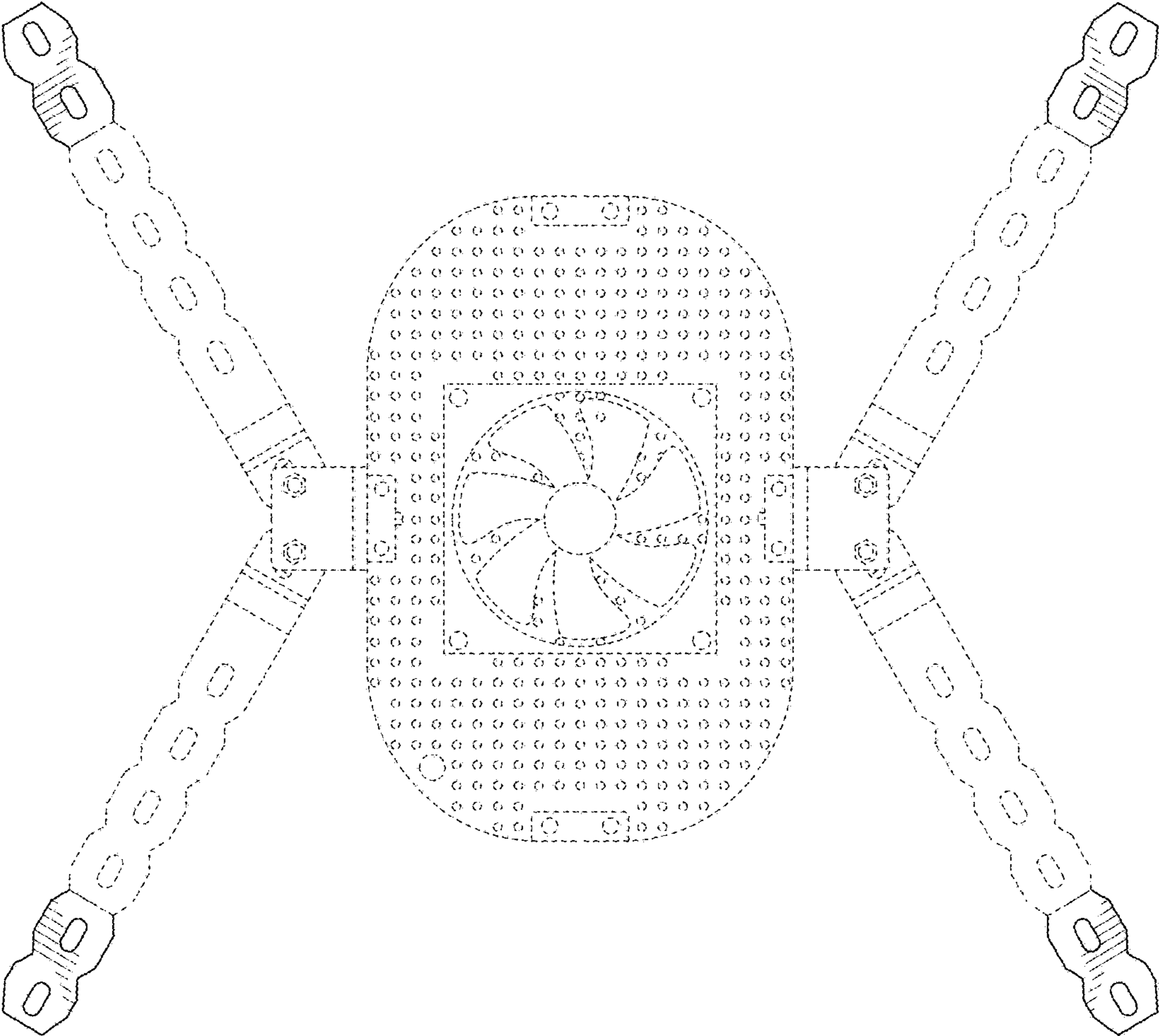

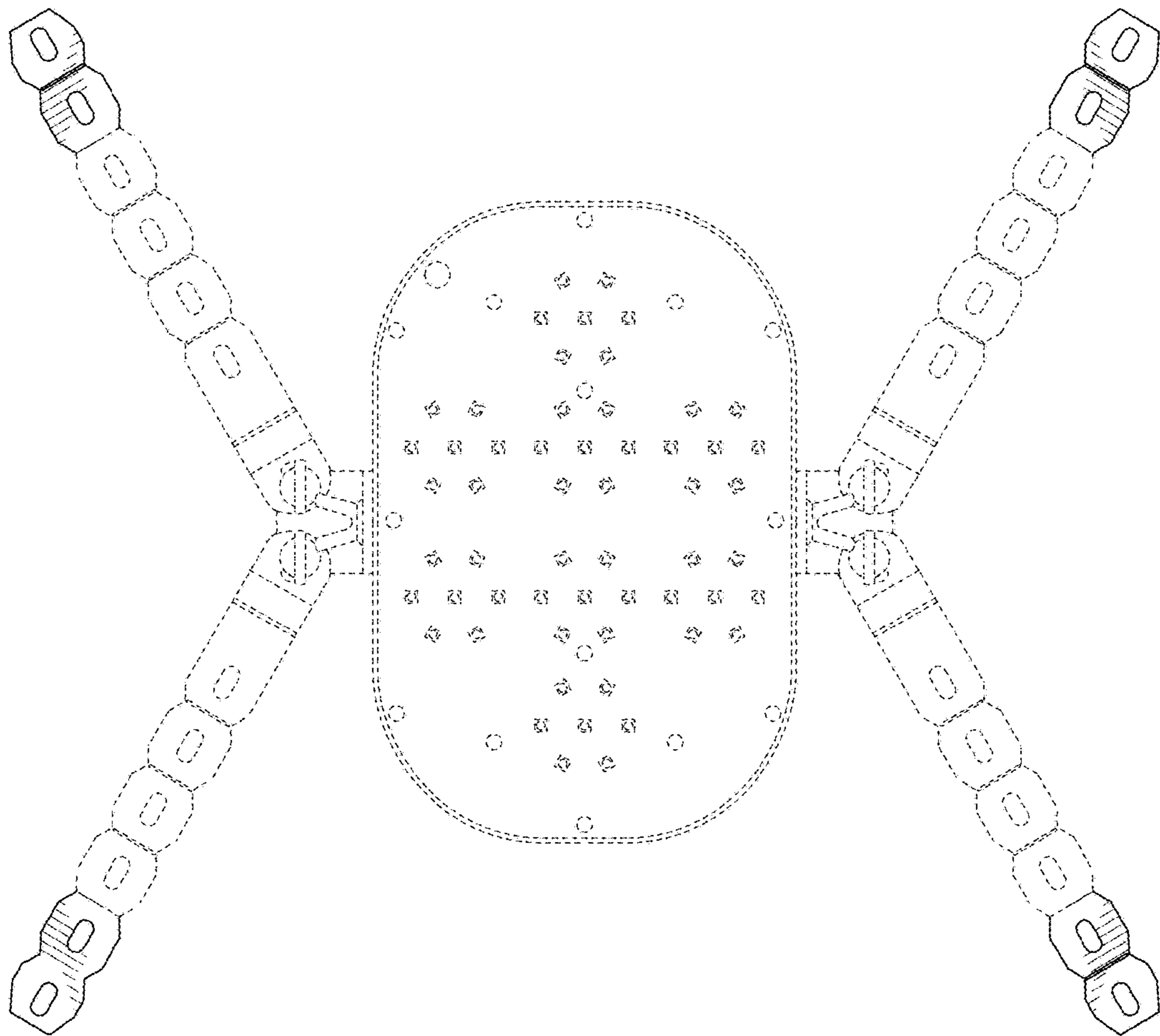

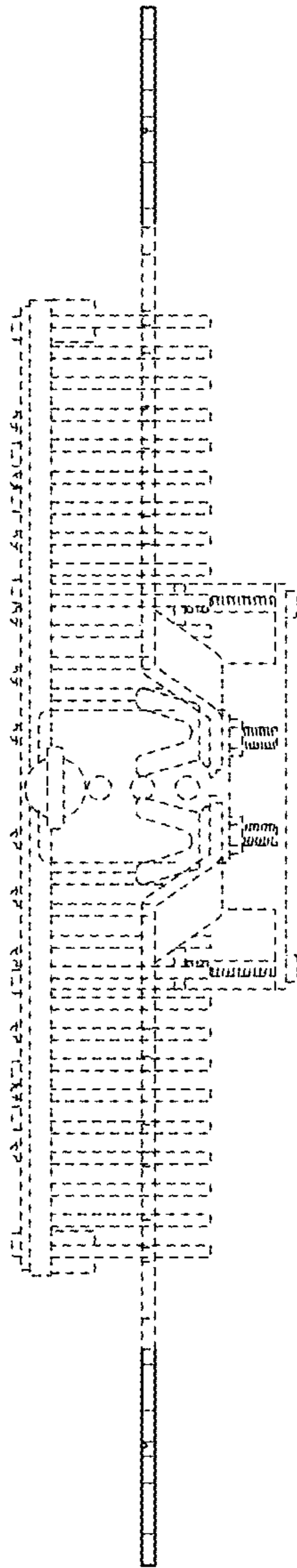

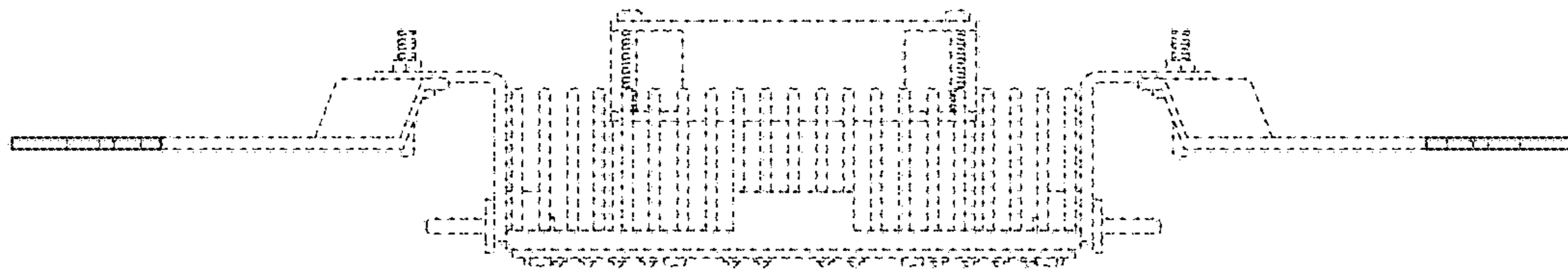

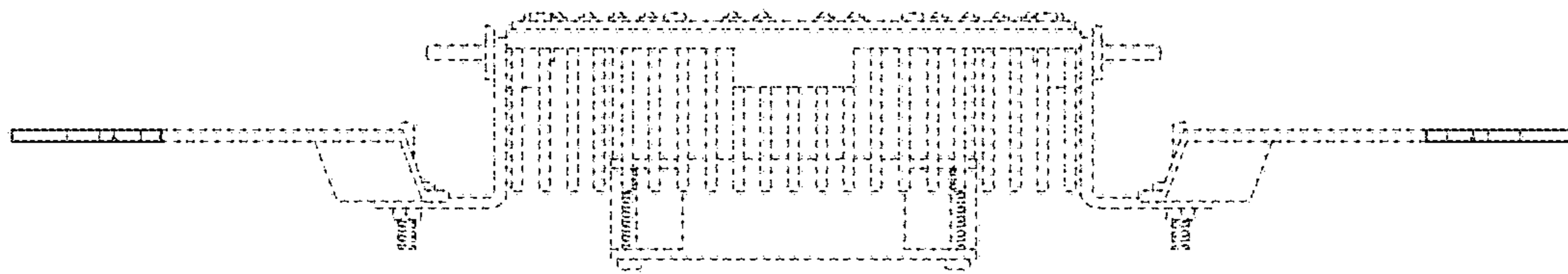

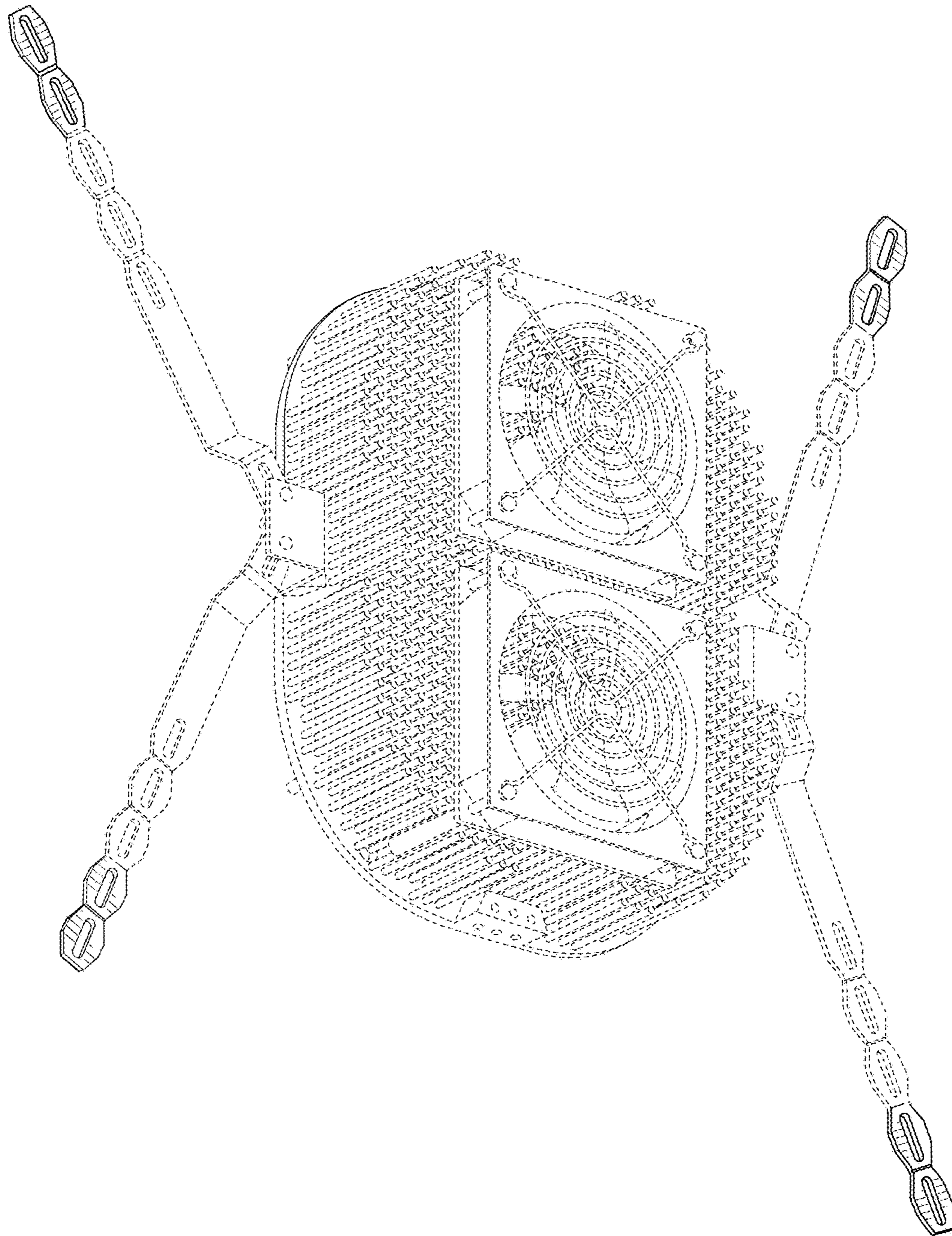

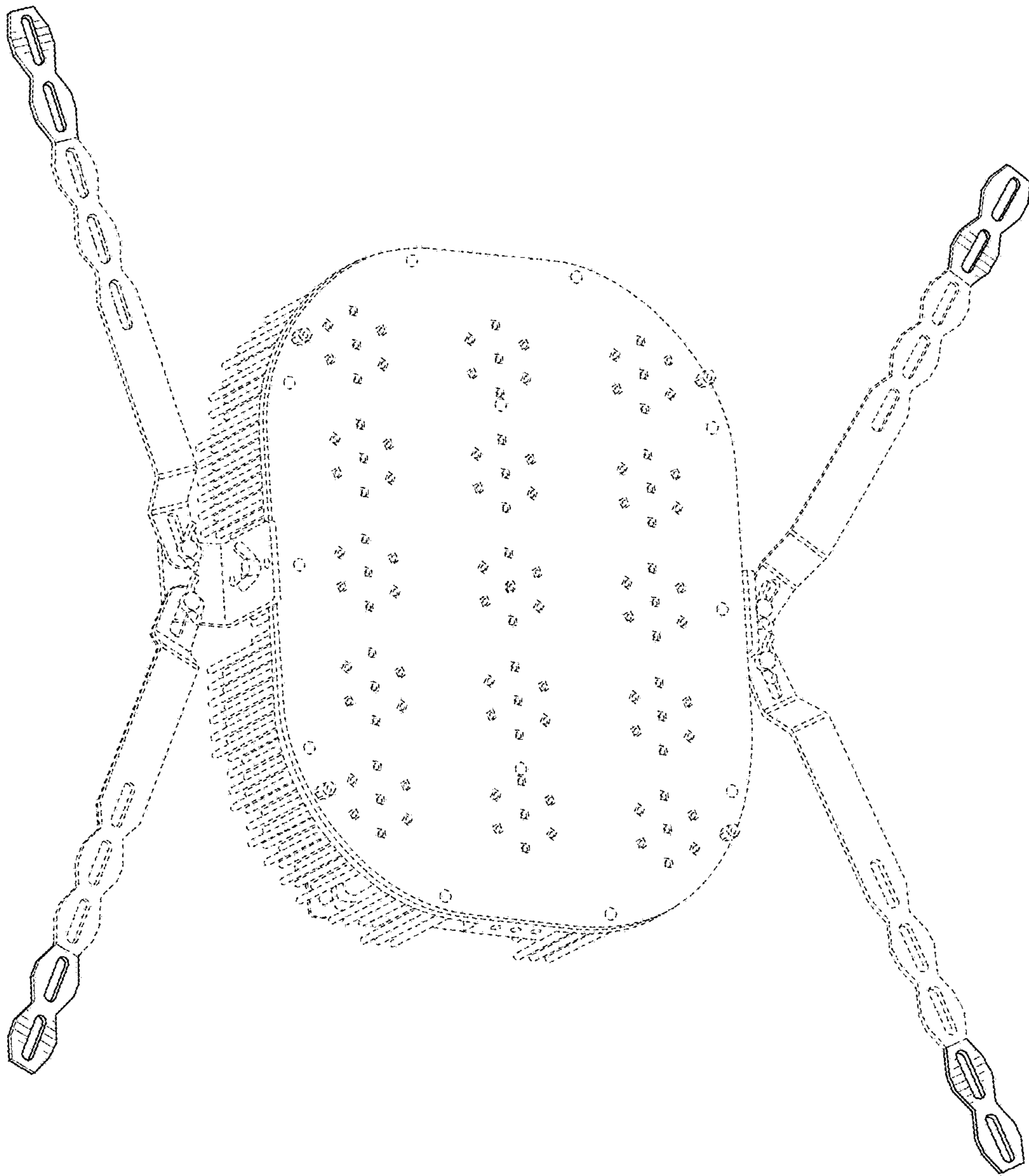

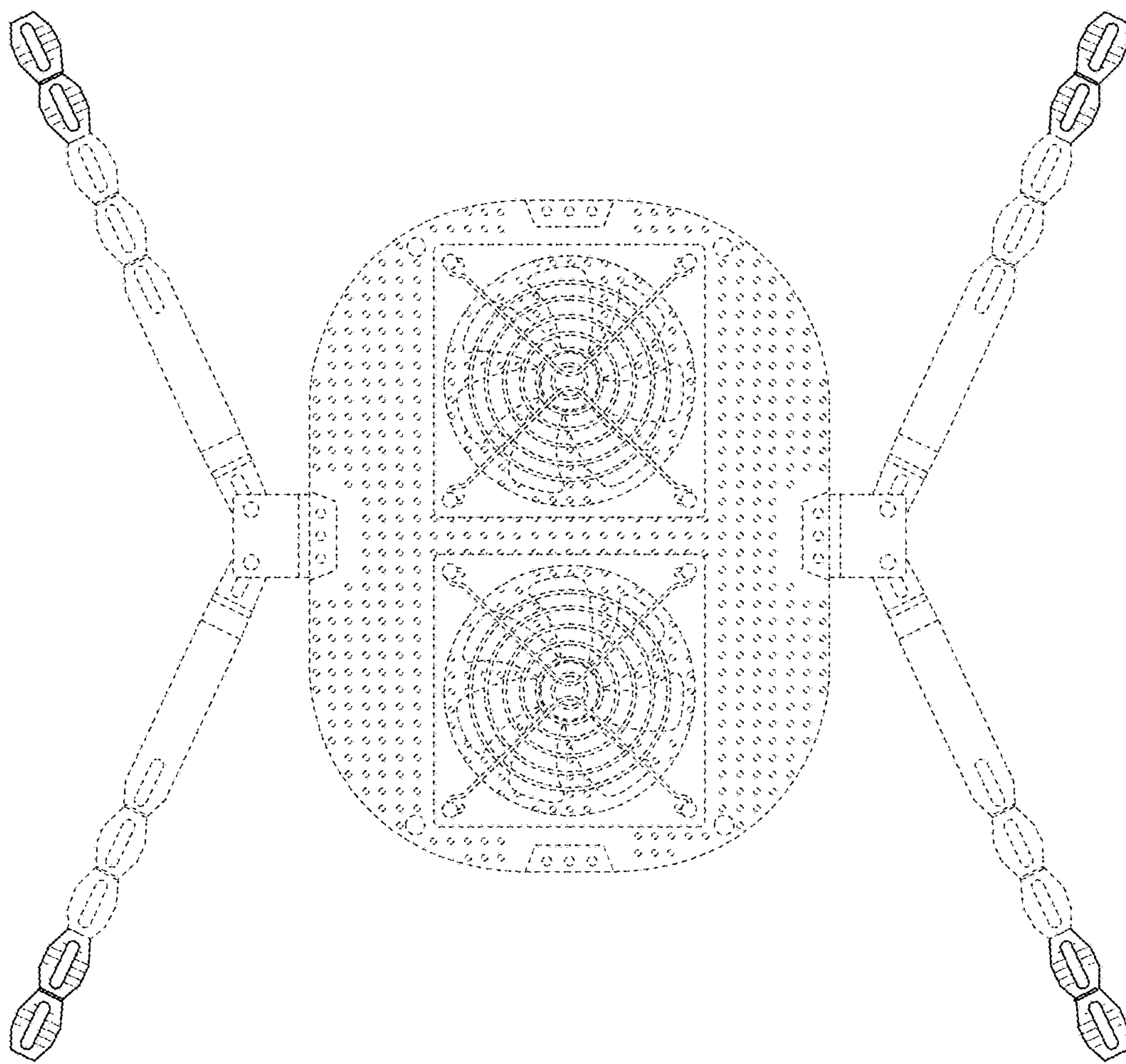

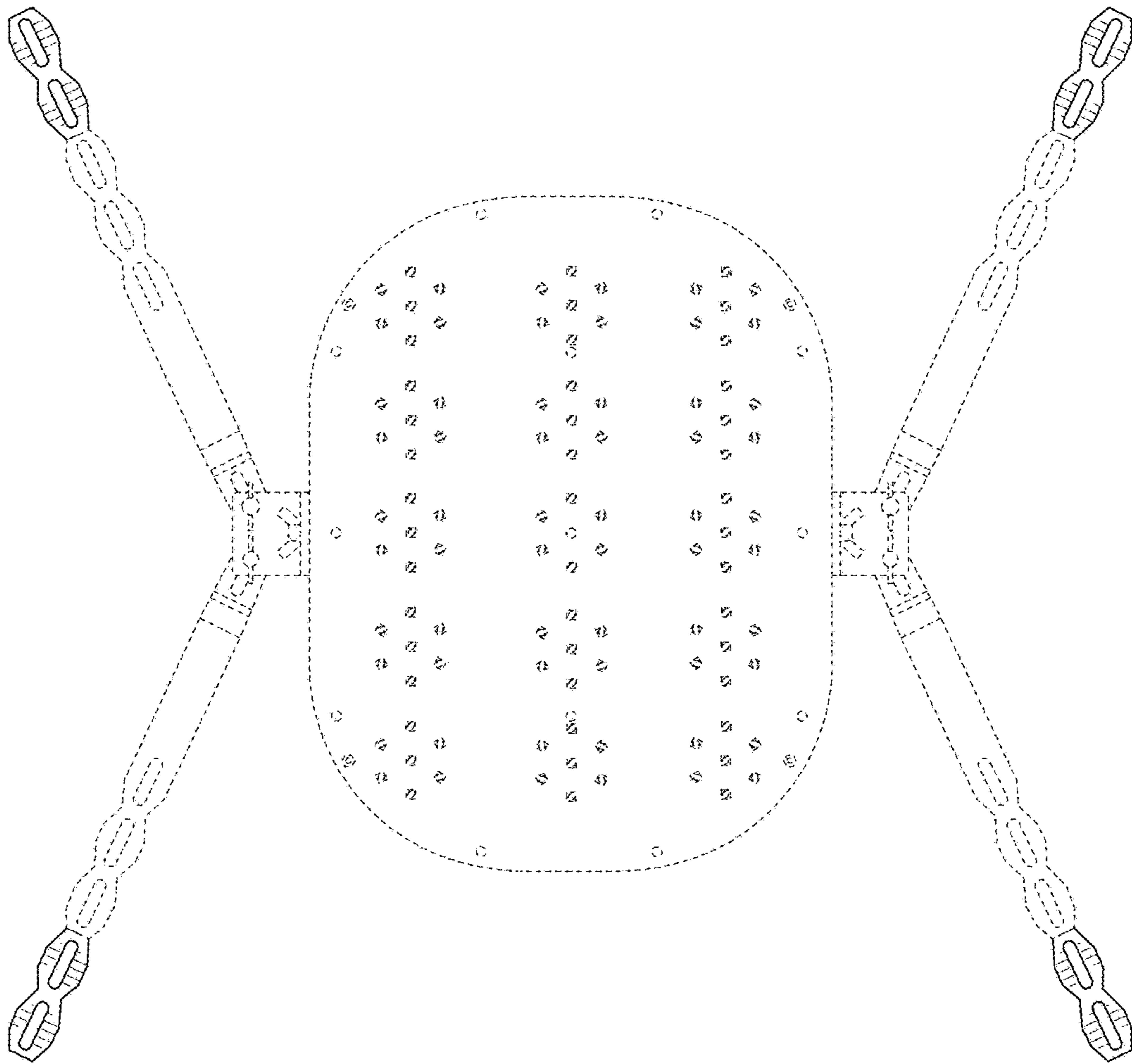
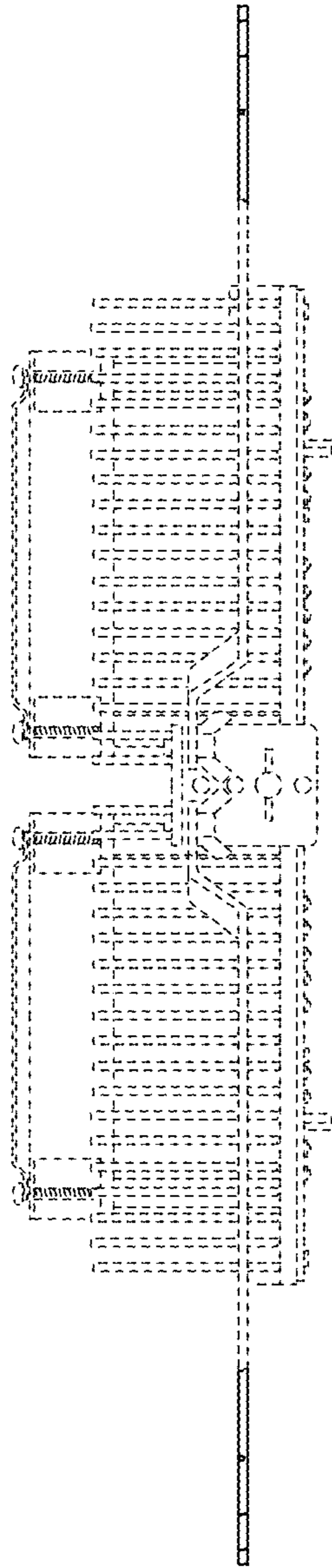

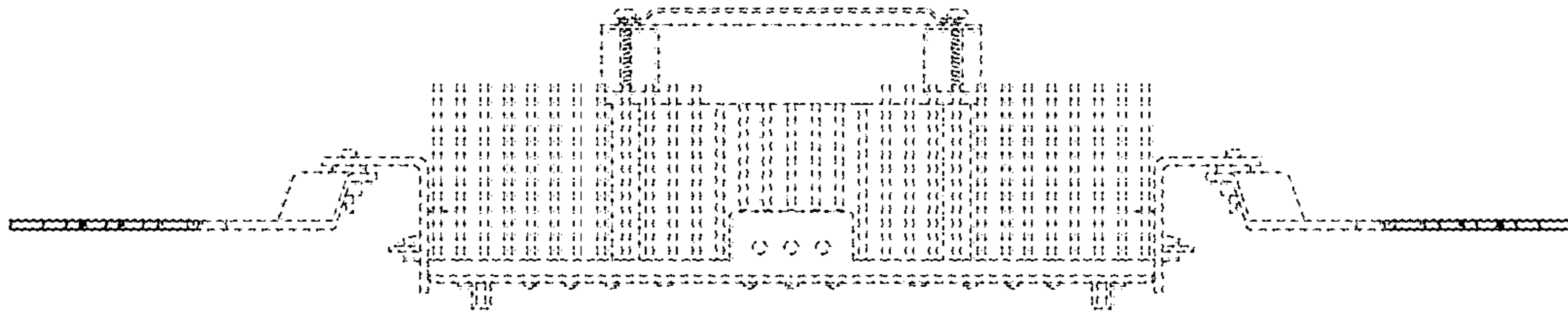

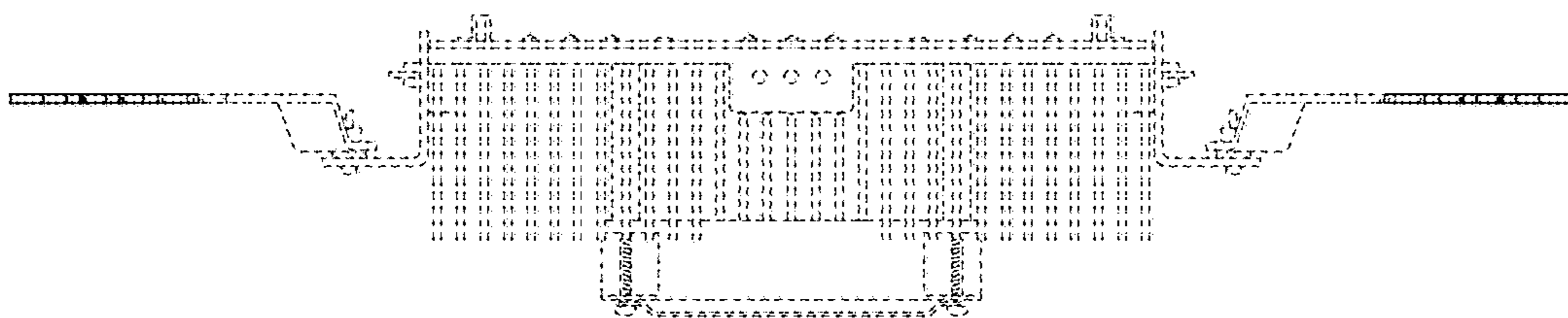

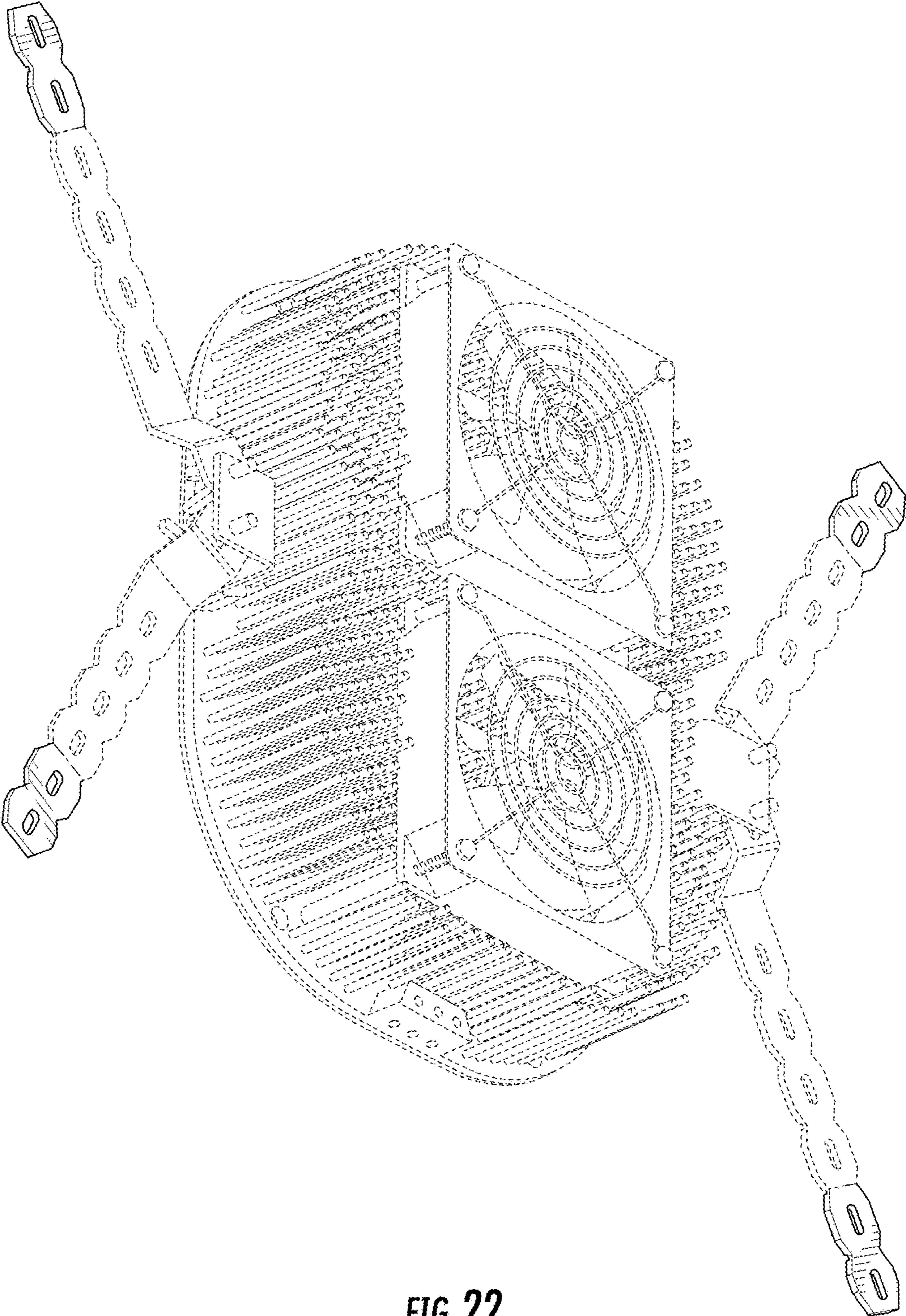

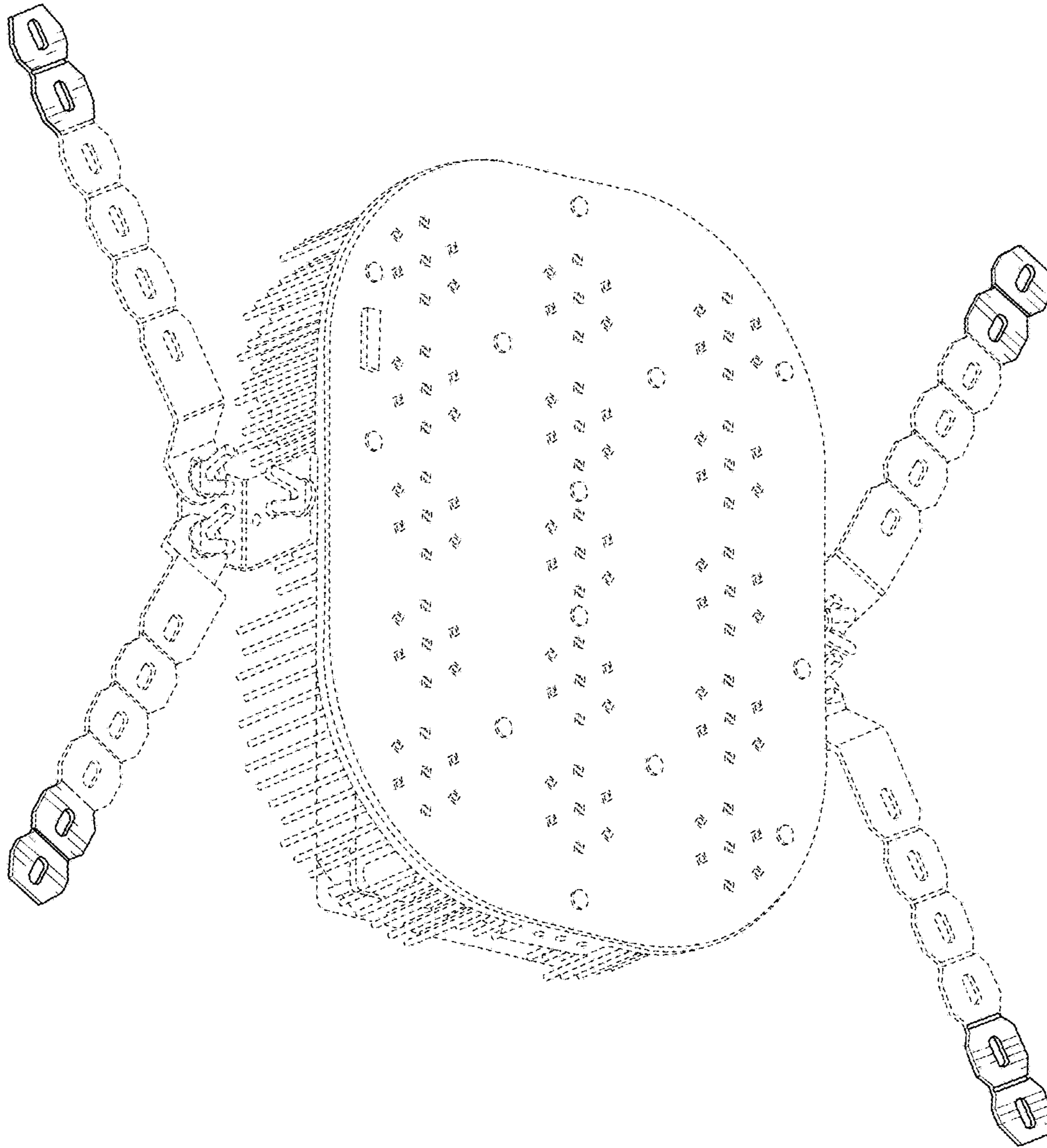

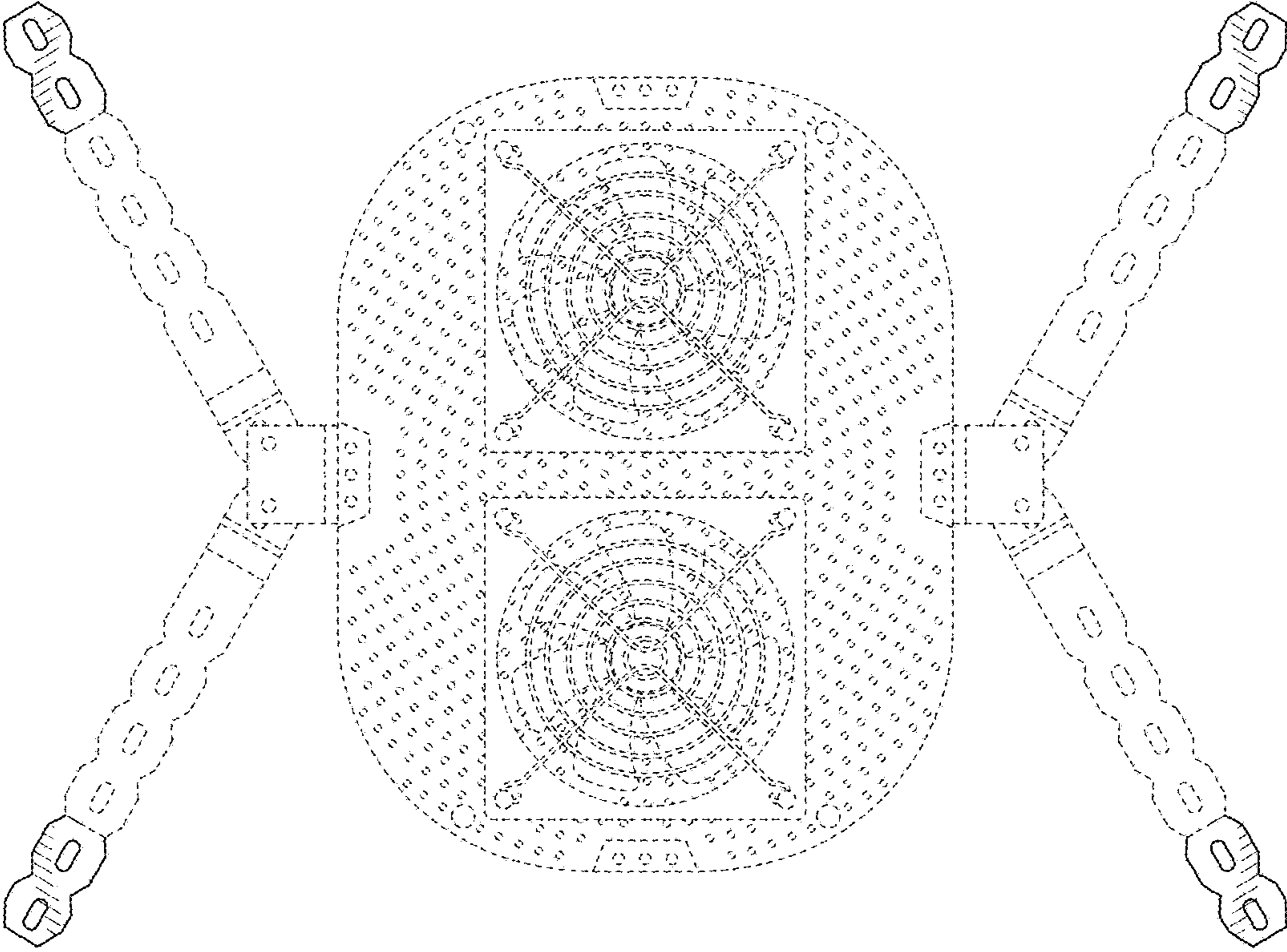

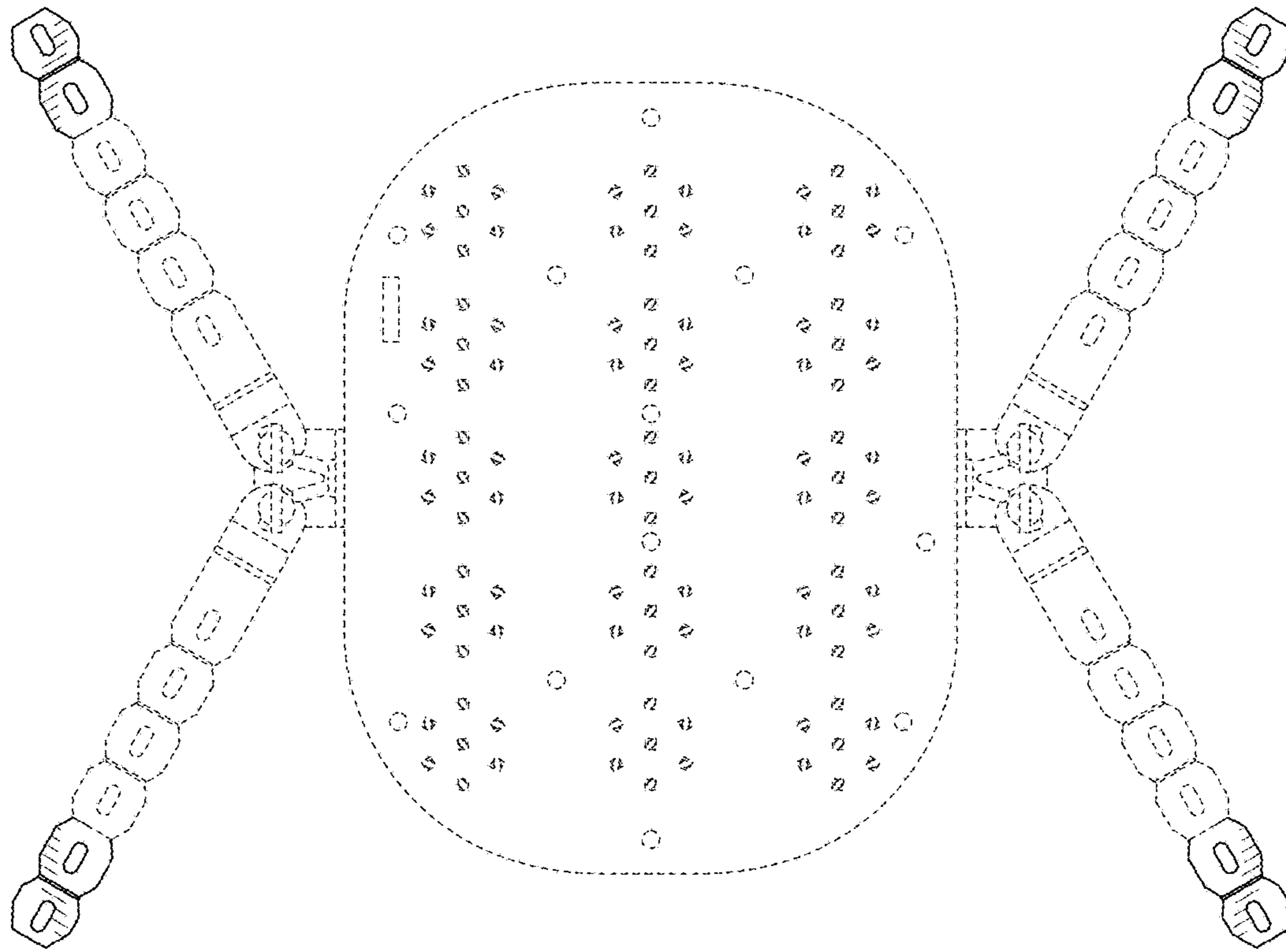

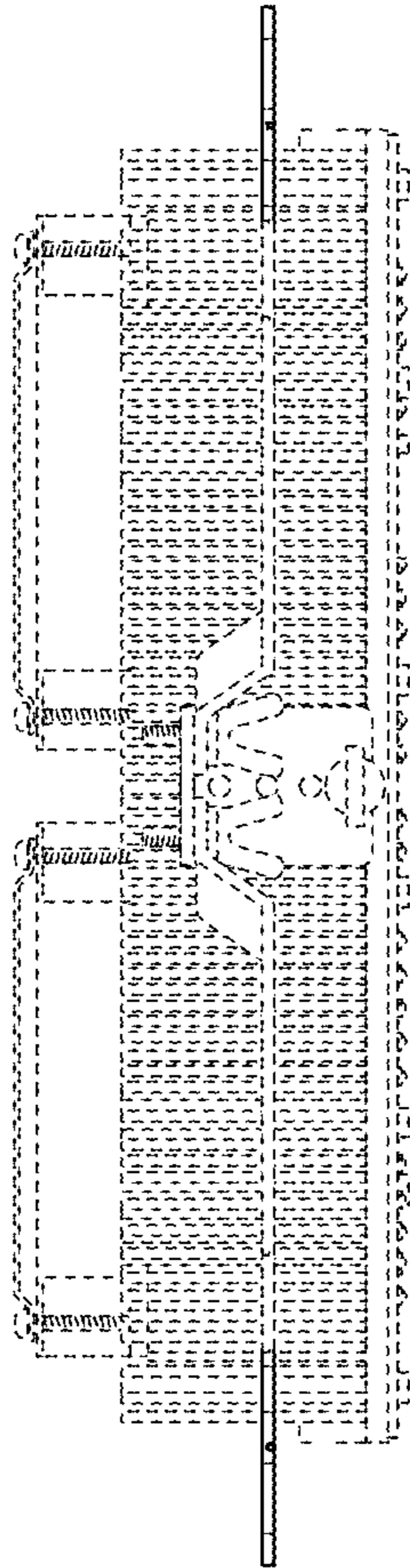

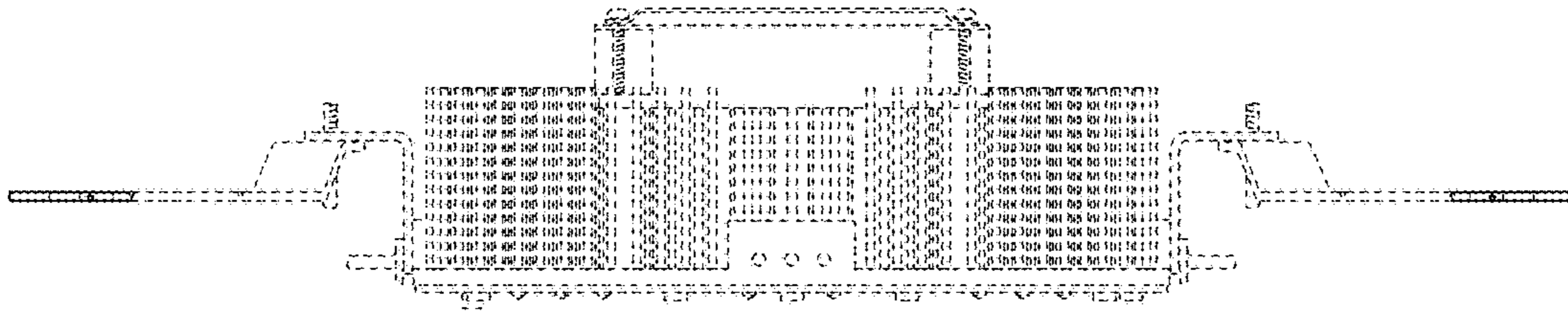

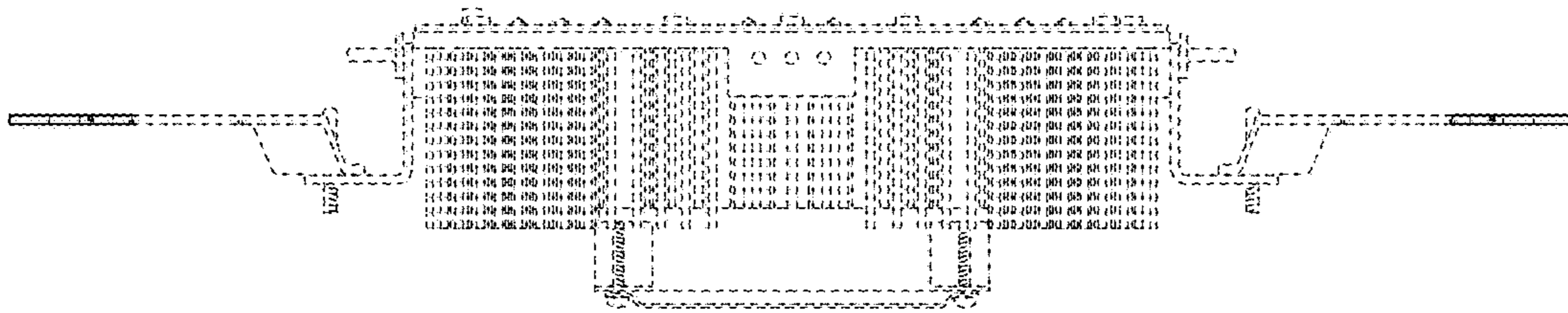
