(57) **CLAIM**

The ornamental design for a blank for packaging, as shown and described.

DESCRIPTION

The sole FIGURE is a plan view of a blank for packaging showing our new design, the reverse view being a mirror image thereof.

The broken line disclosure depicts environmental subject matter that forms no part of the claimed design.

The dot-dash line shown in the drawing FIGURE is used to show a boundary line of the design.
