(57) **CLAIM**

The ornamental design for a cosmetic container, as shown and described.

DESCRIPTION

1. Cosmetic container

1.1 is a front perspective view of the cosmetic container with a cap.

1.2 is a rear perspective view.

1.3 is a front elevation view.

1.4 is a rear elevation view.

1.5 is a left side elevation view, the right side elevation view being a mirror image thereto.

1.6 is a top plan view.

1.7 is a front perspective view, shown without the cap.

1.8 is a rear perspective view.

1.9 is a front elevation view.

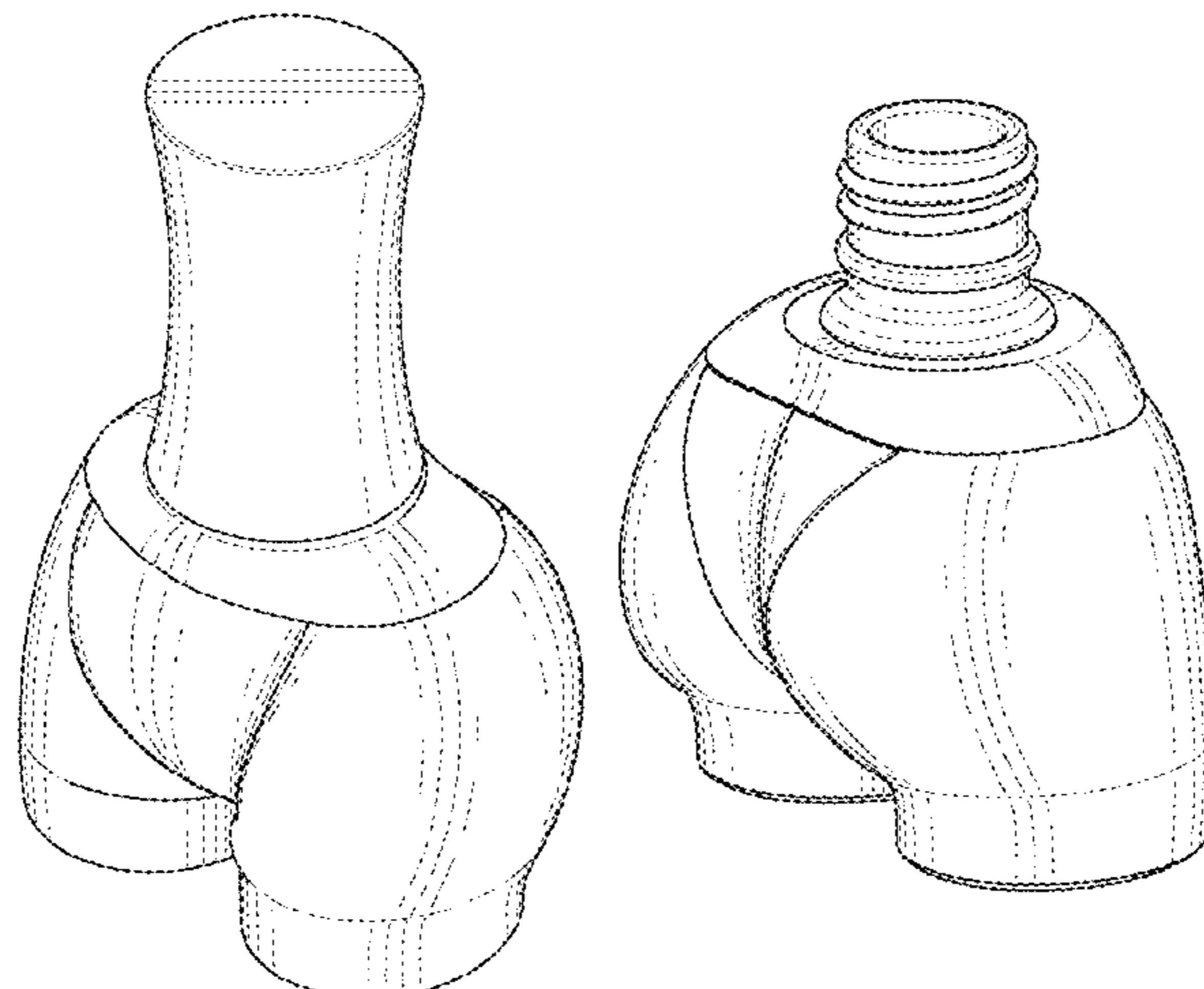
1.10 is a rear elevation view.

1.11 is a left side elevation view, the right side elevation view being a mirror image thereto.

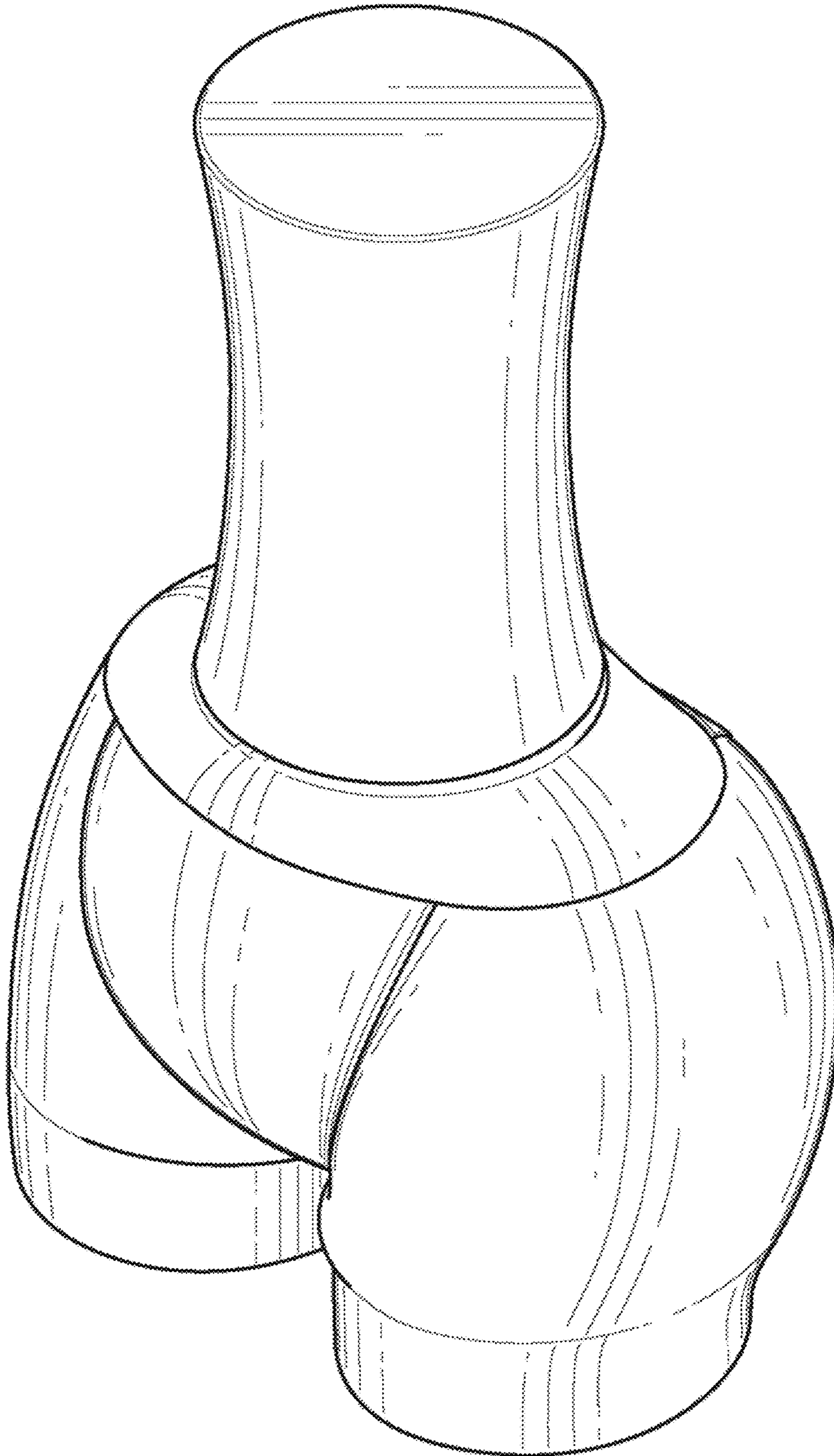
1.12 is a top plan view.

The broken lines shown in Fig. **1.12** are included for the purpose of illustrating portions of the cosmetic container that form no part of the claim.

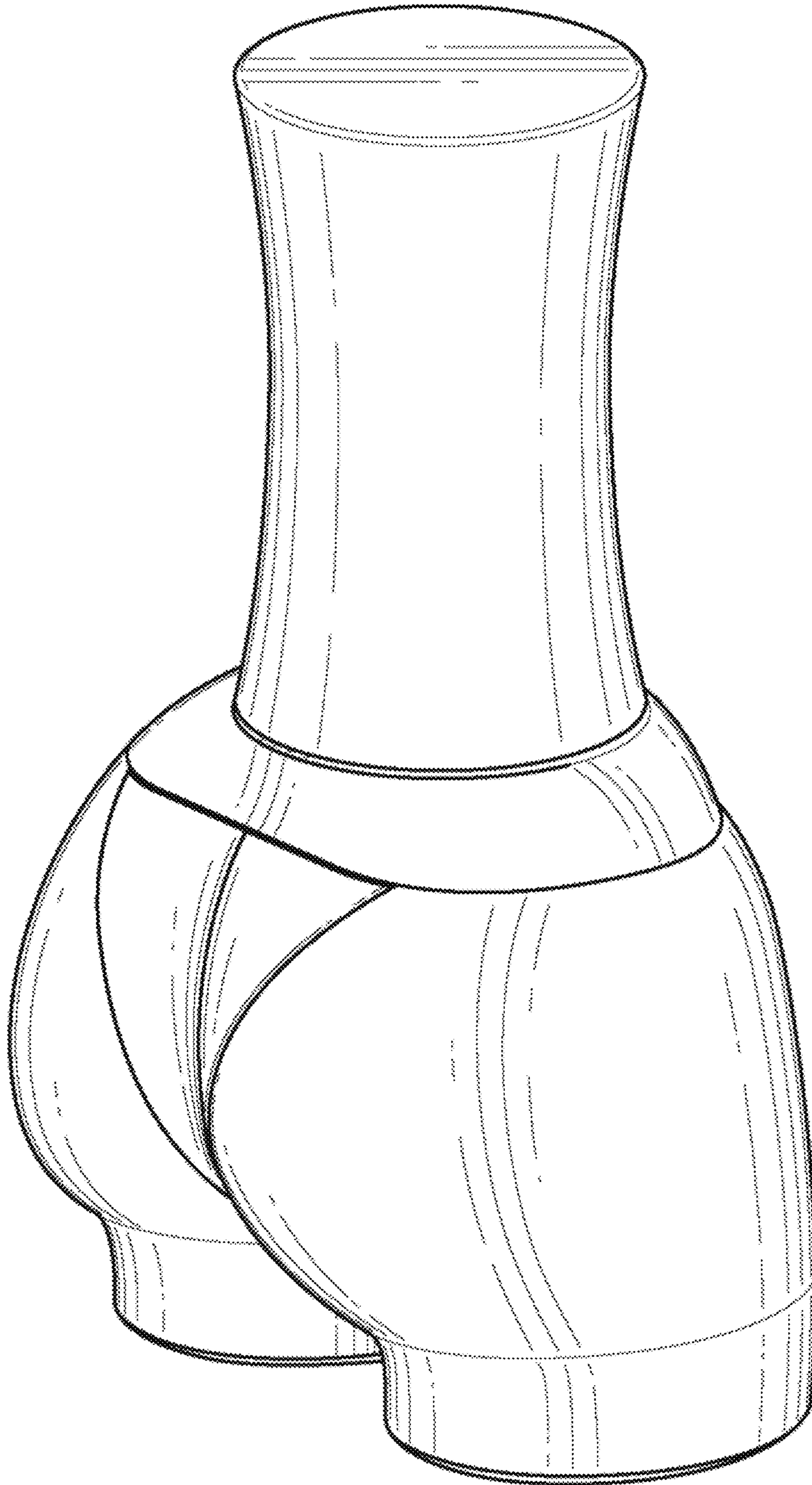

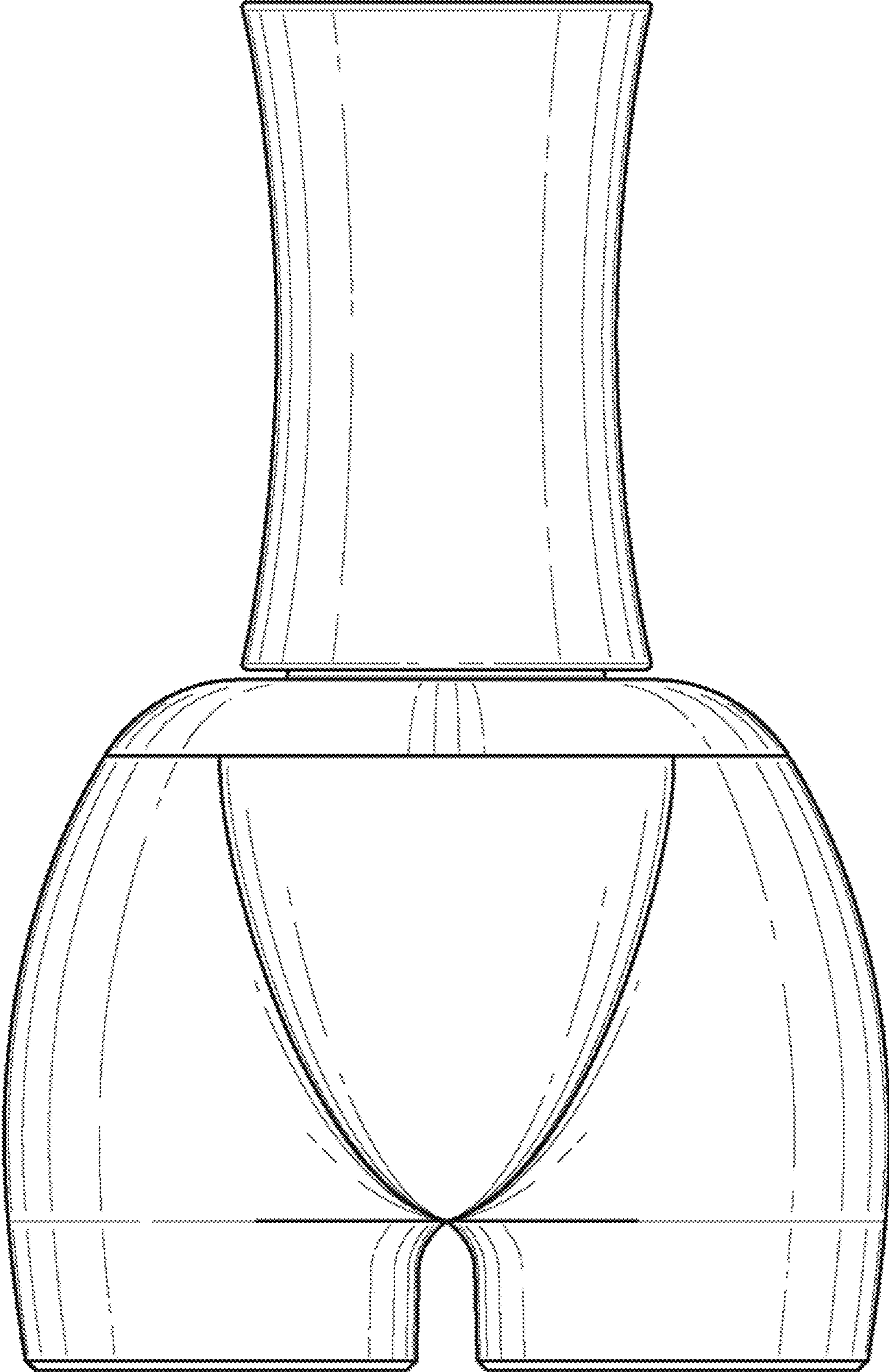

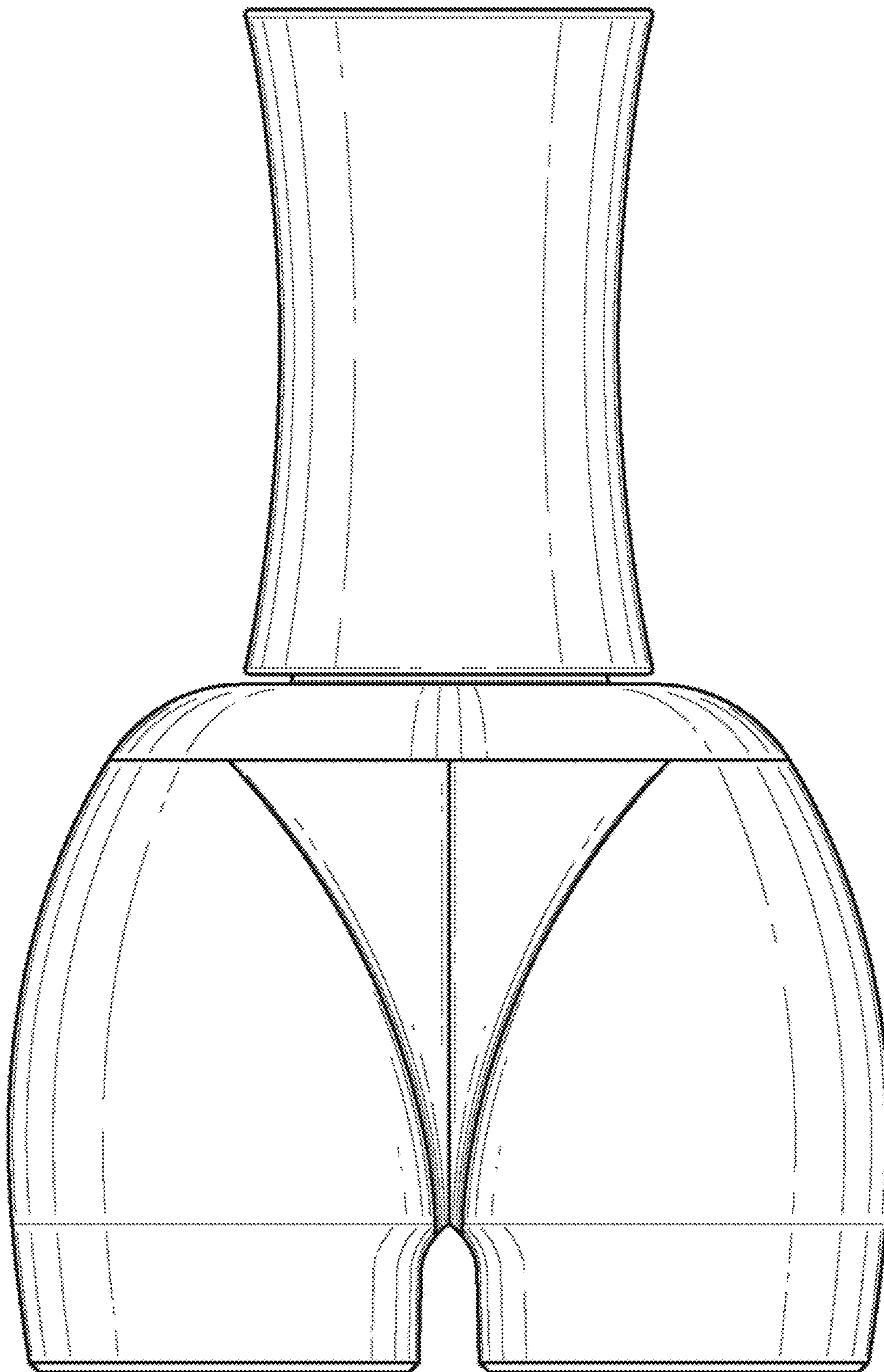

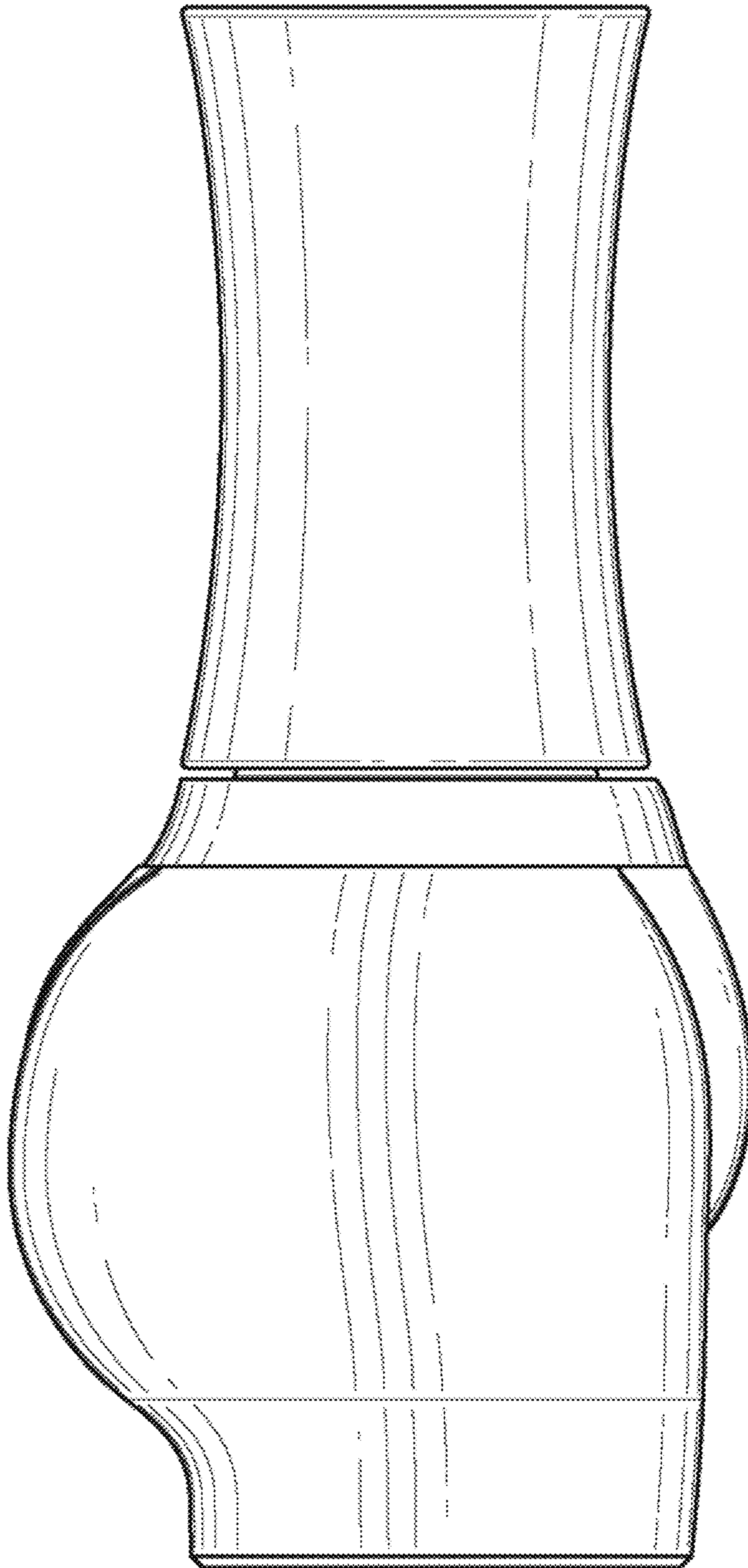

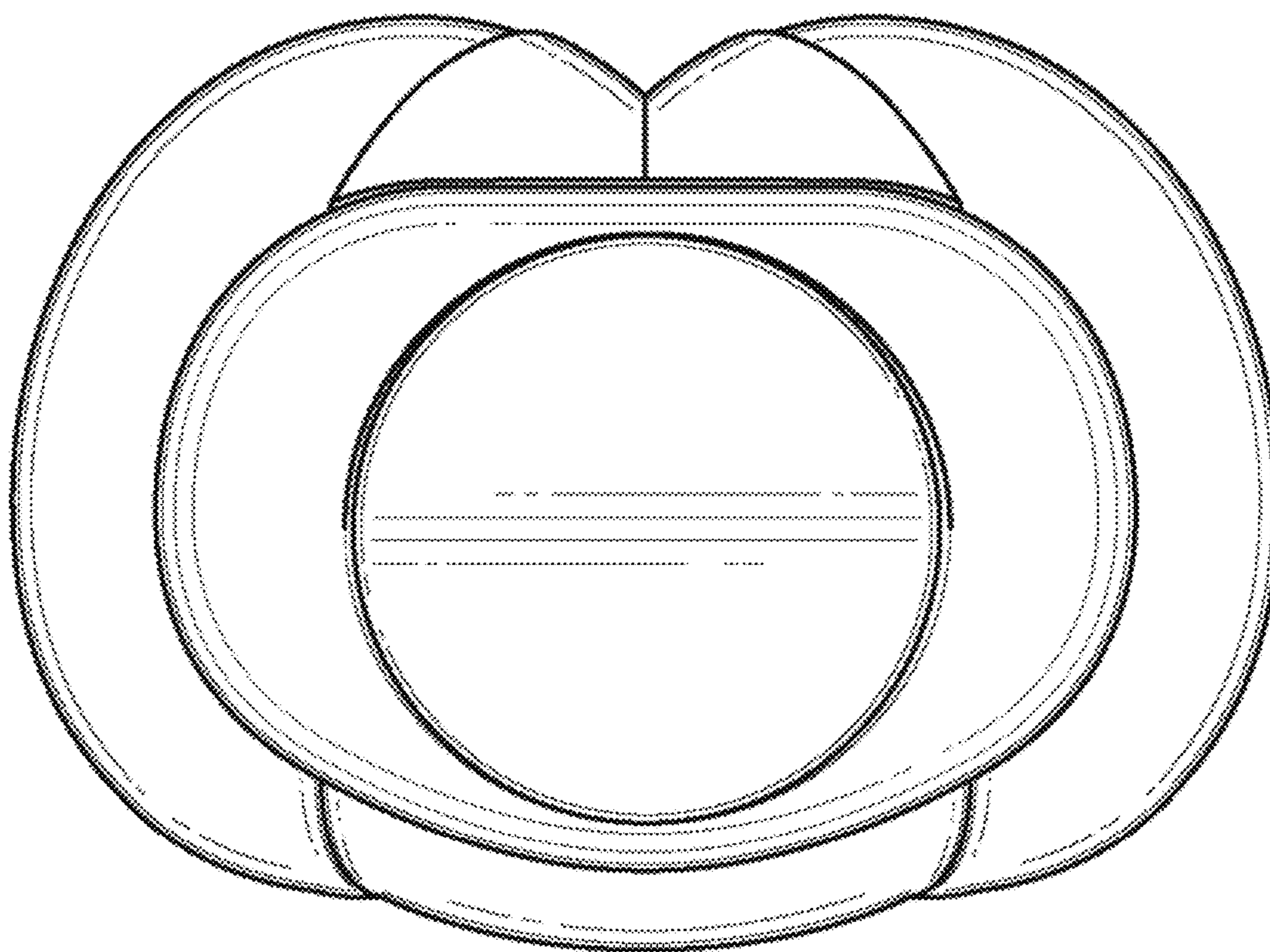

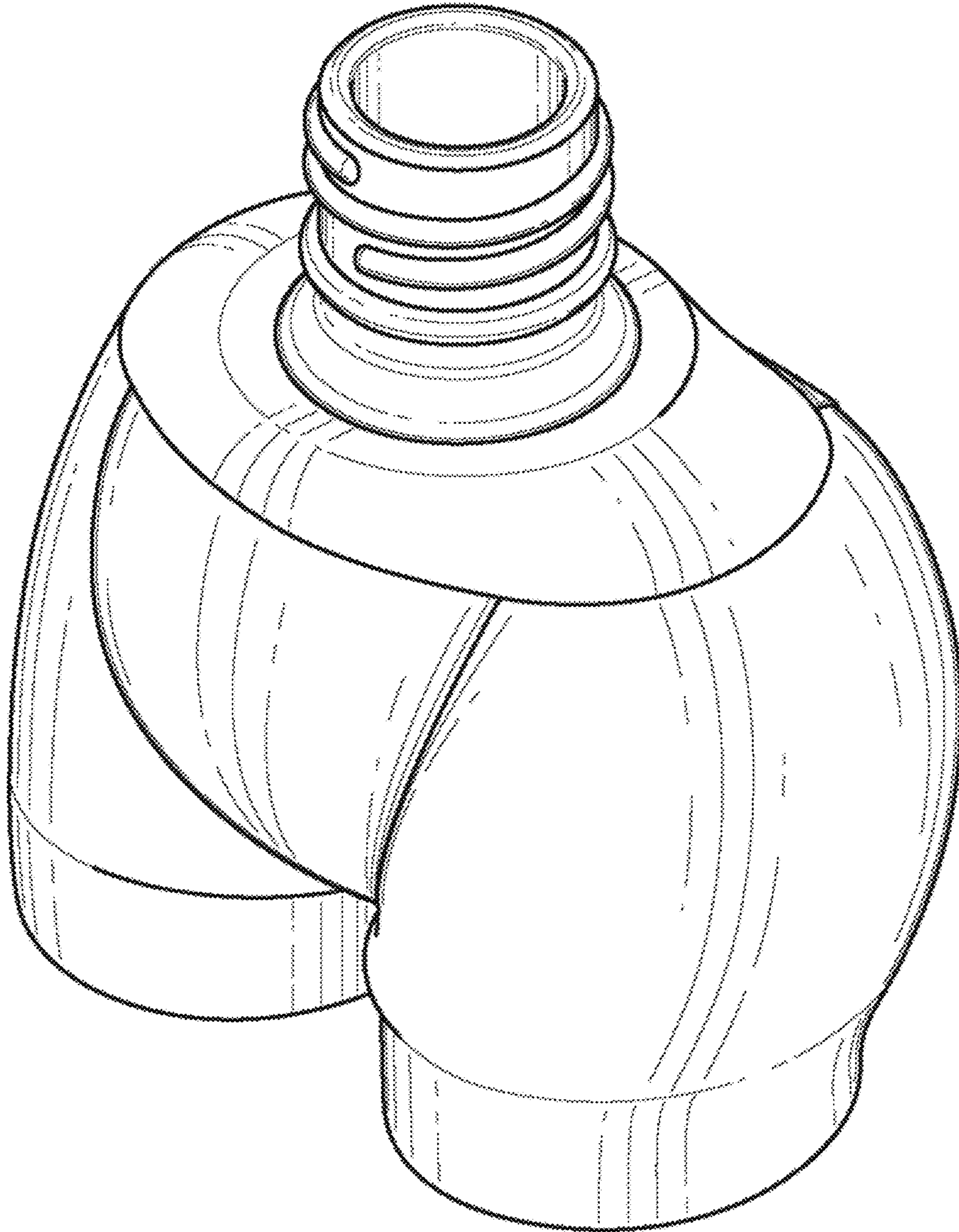

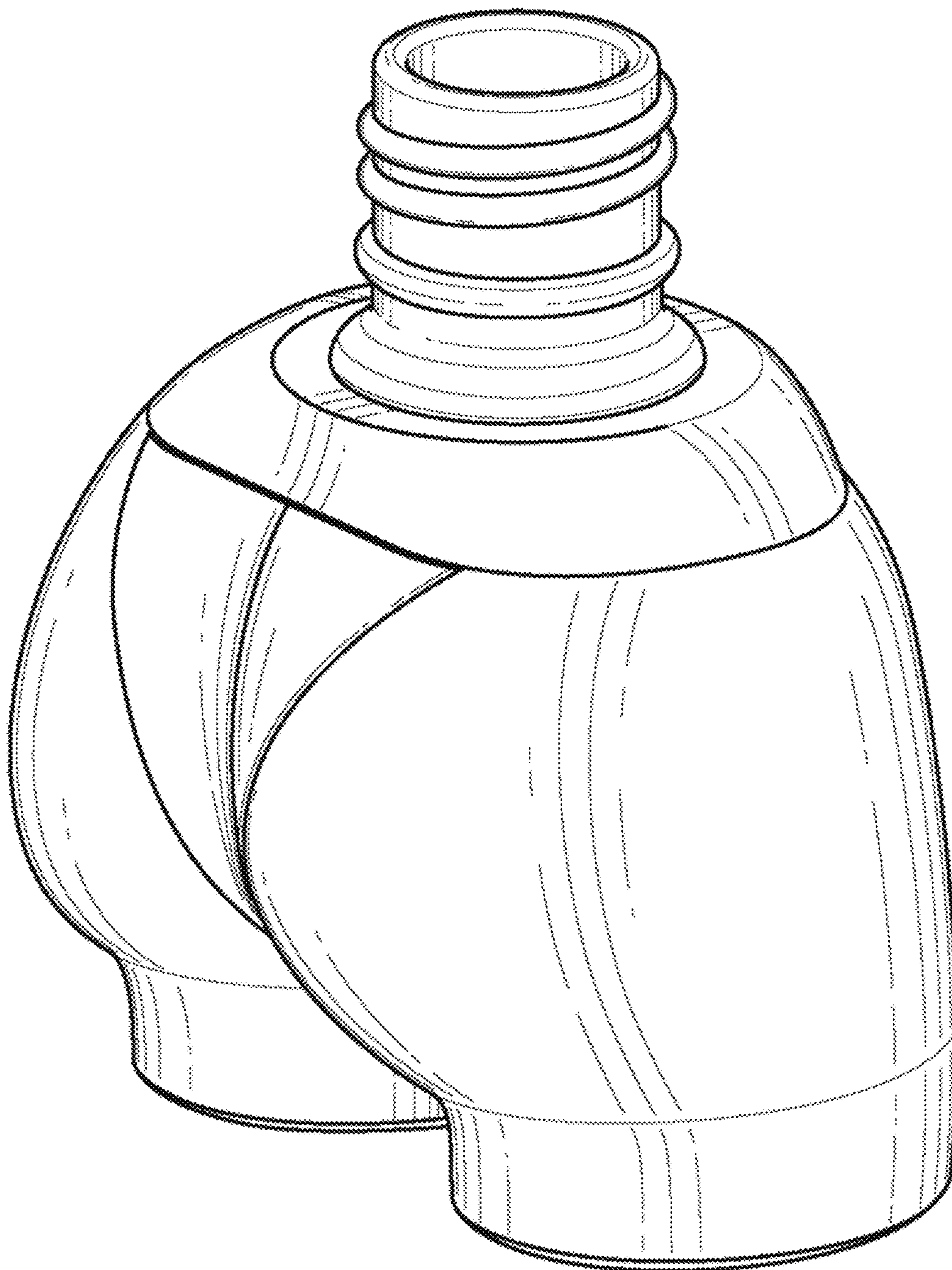

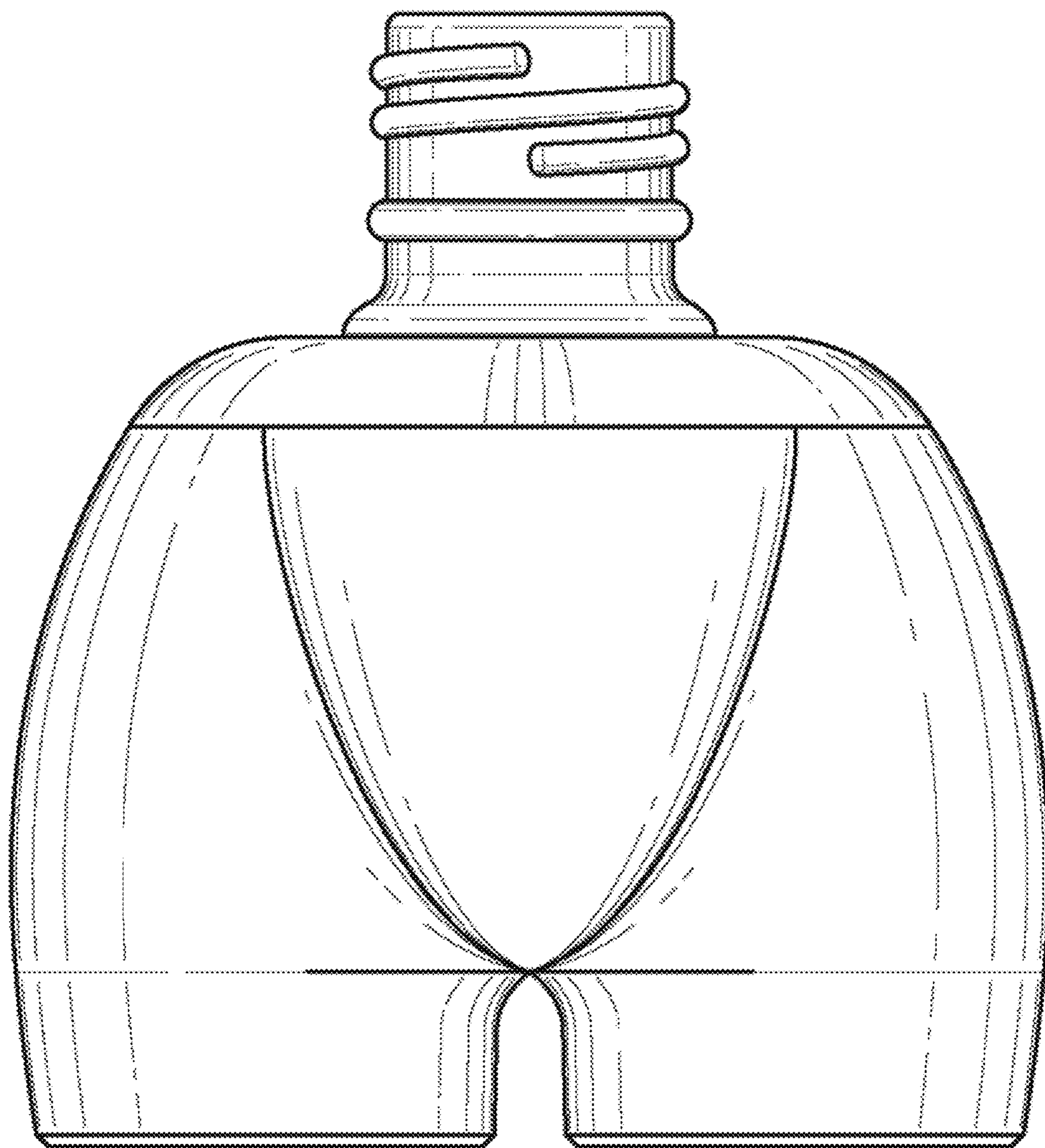

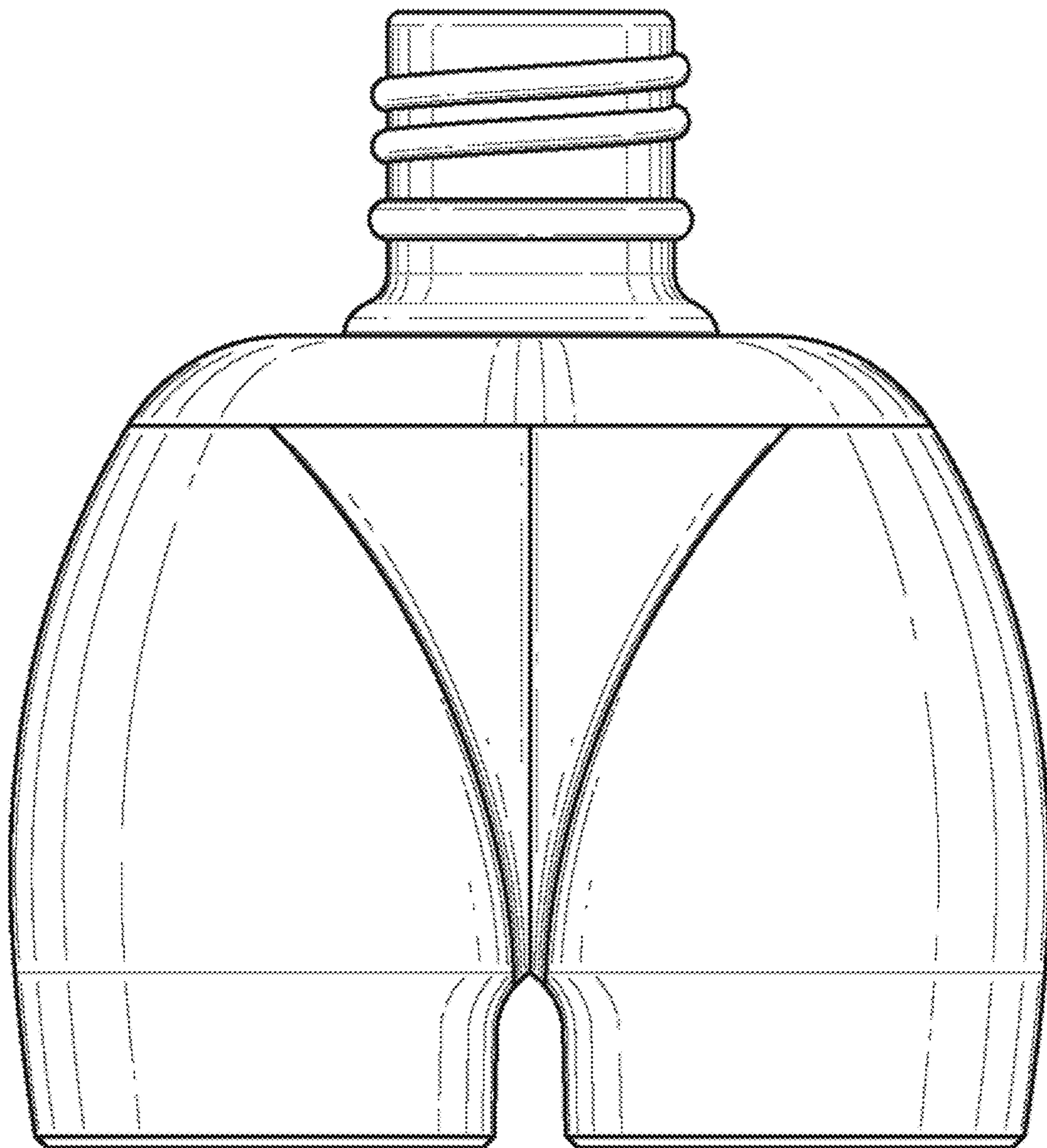

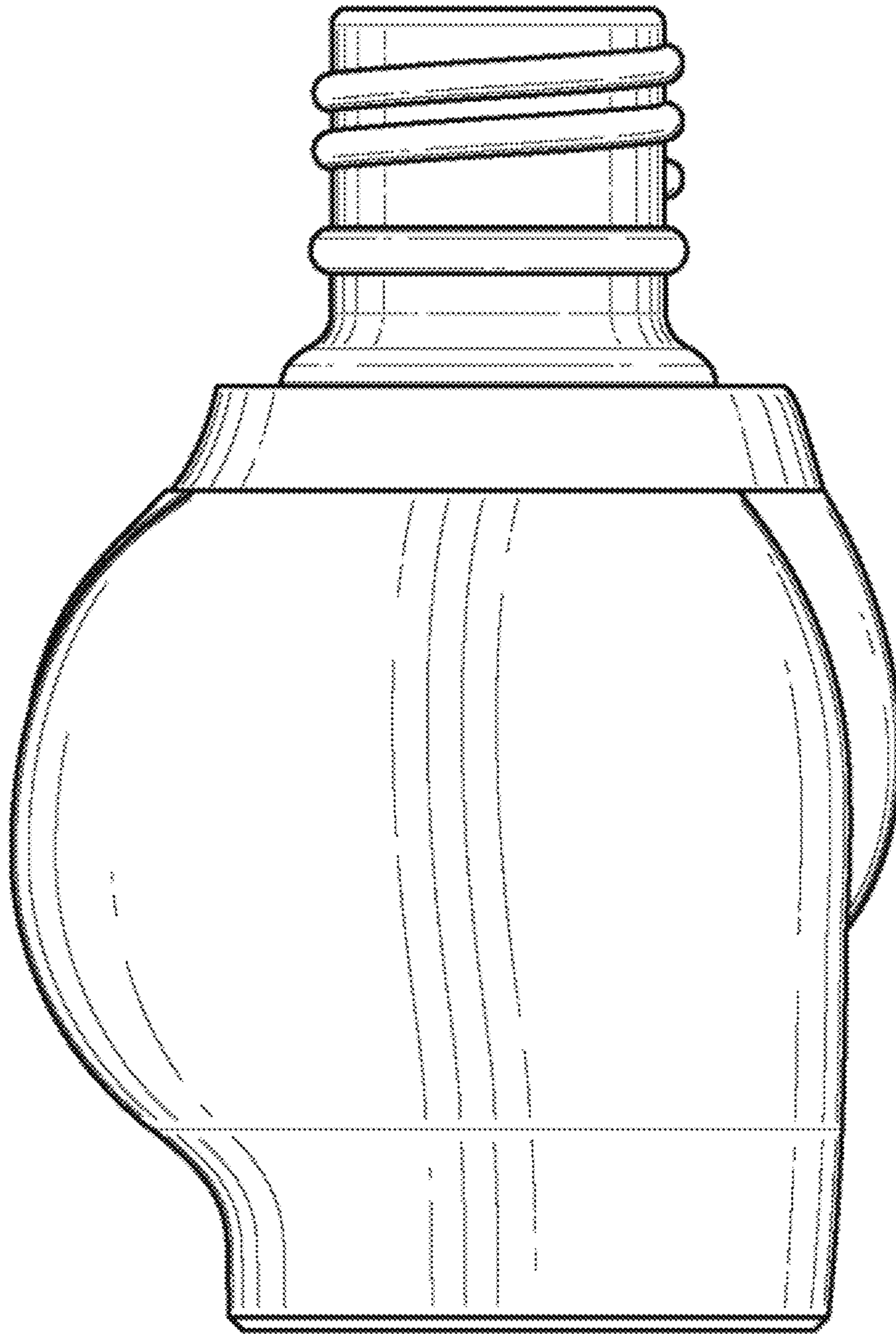
