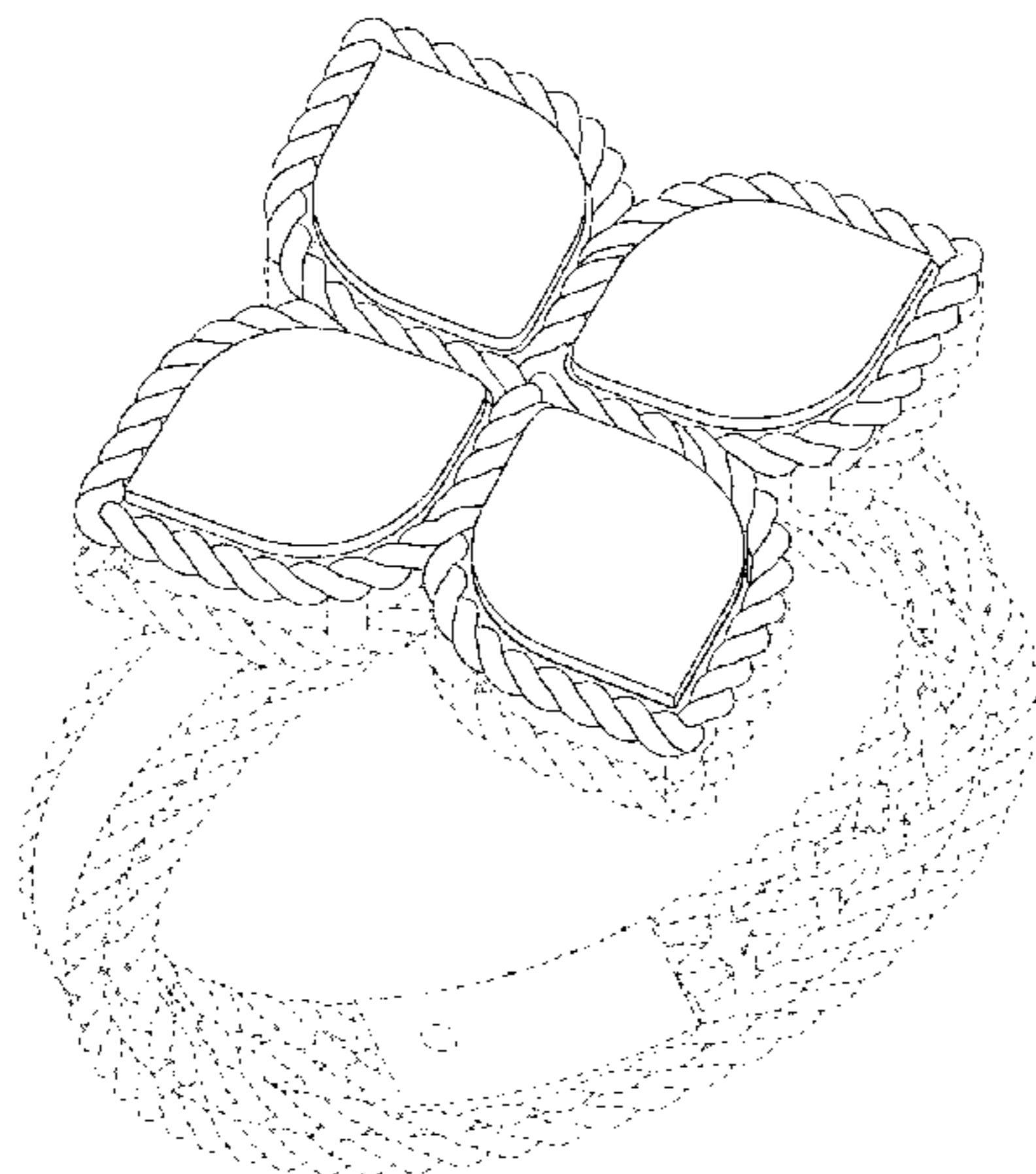
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of an article of jewelry in accordance with the present invention; FIG. 2 is a left-side view thereof; FIG. 3 is a right-side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. 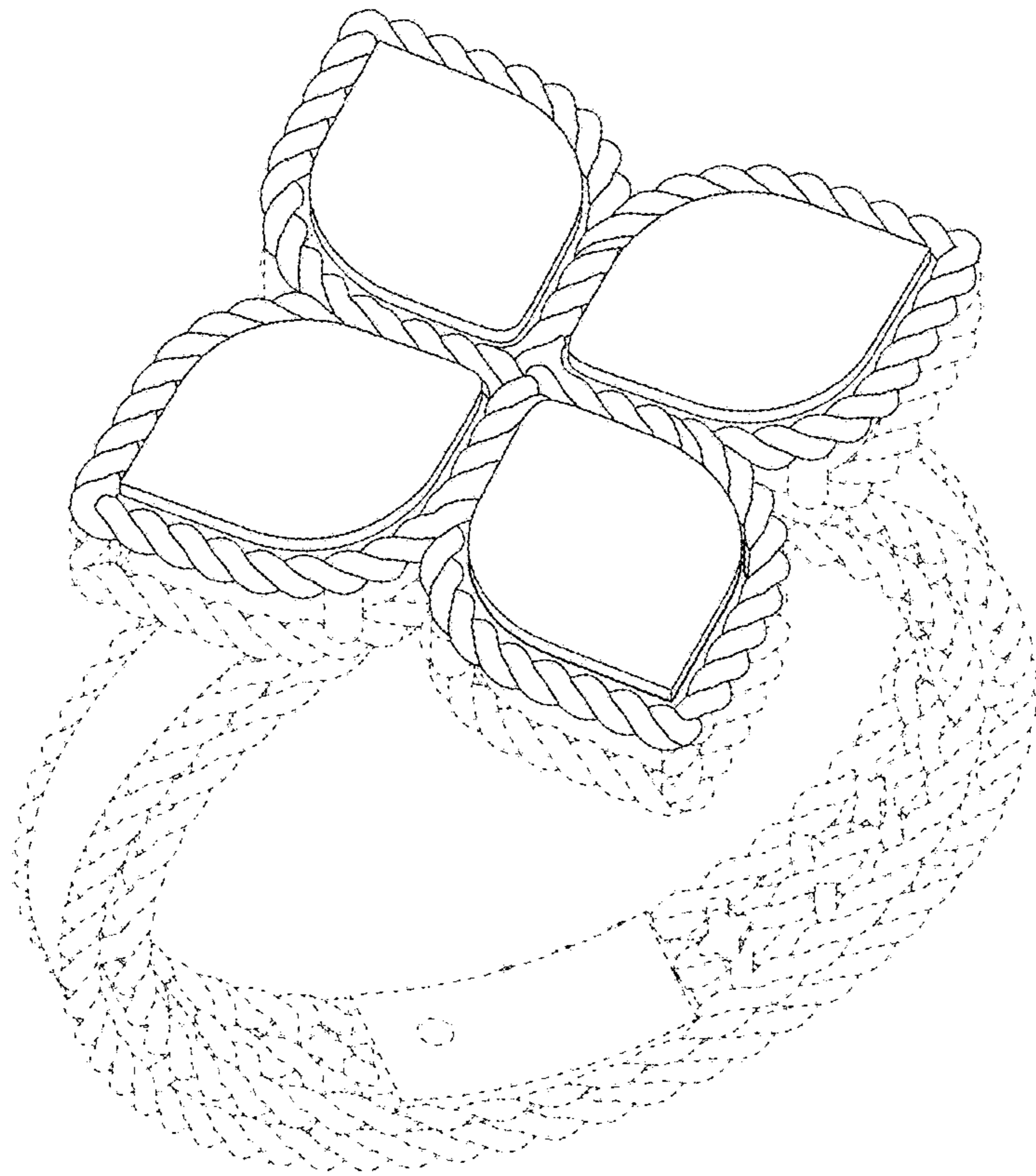

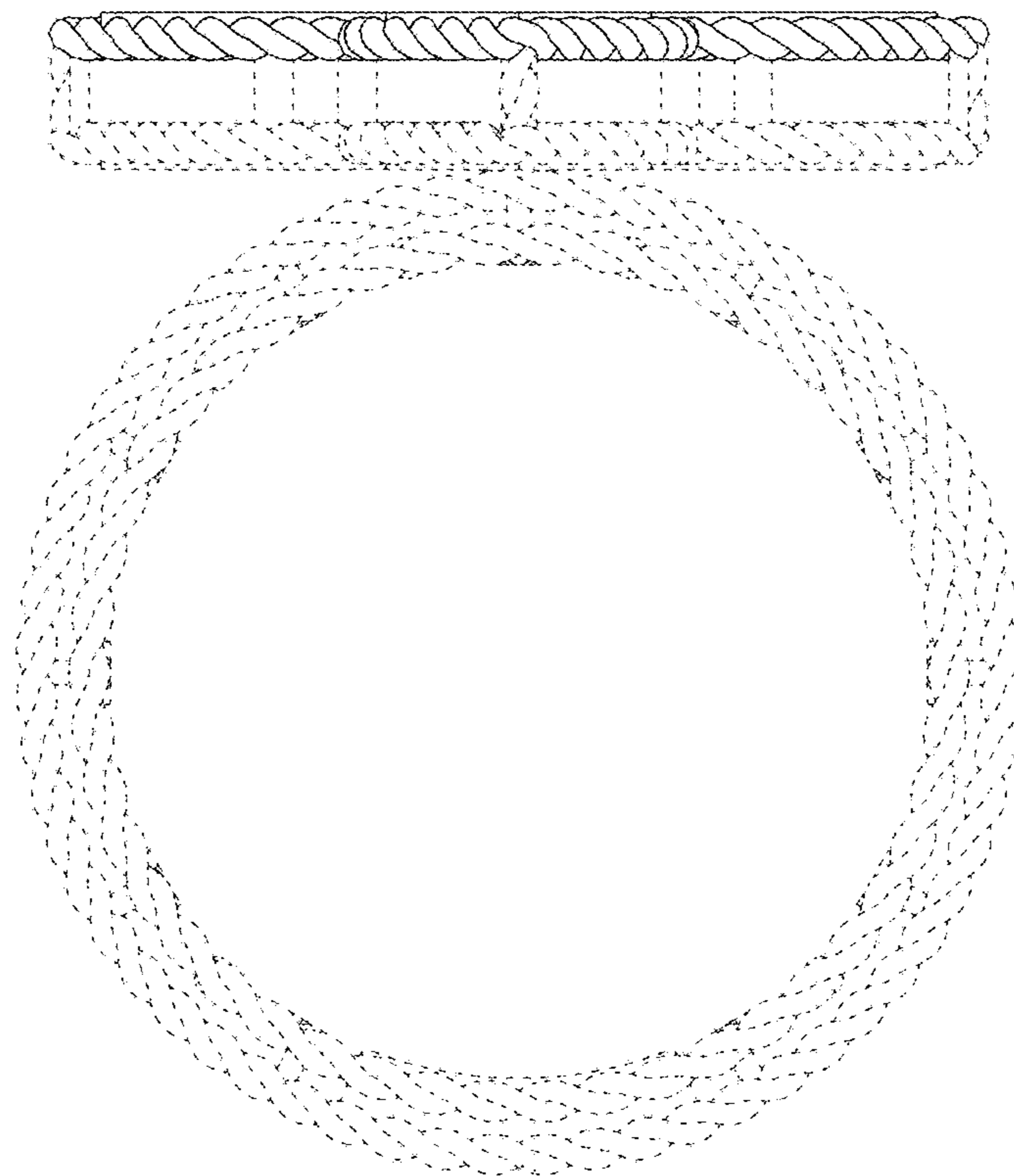

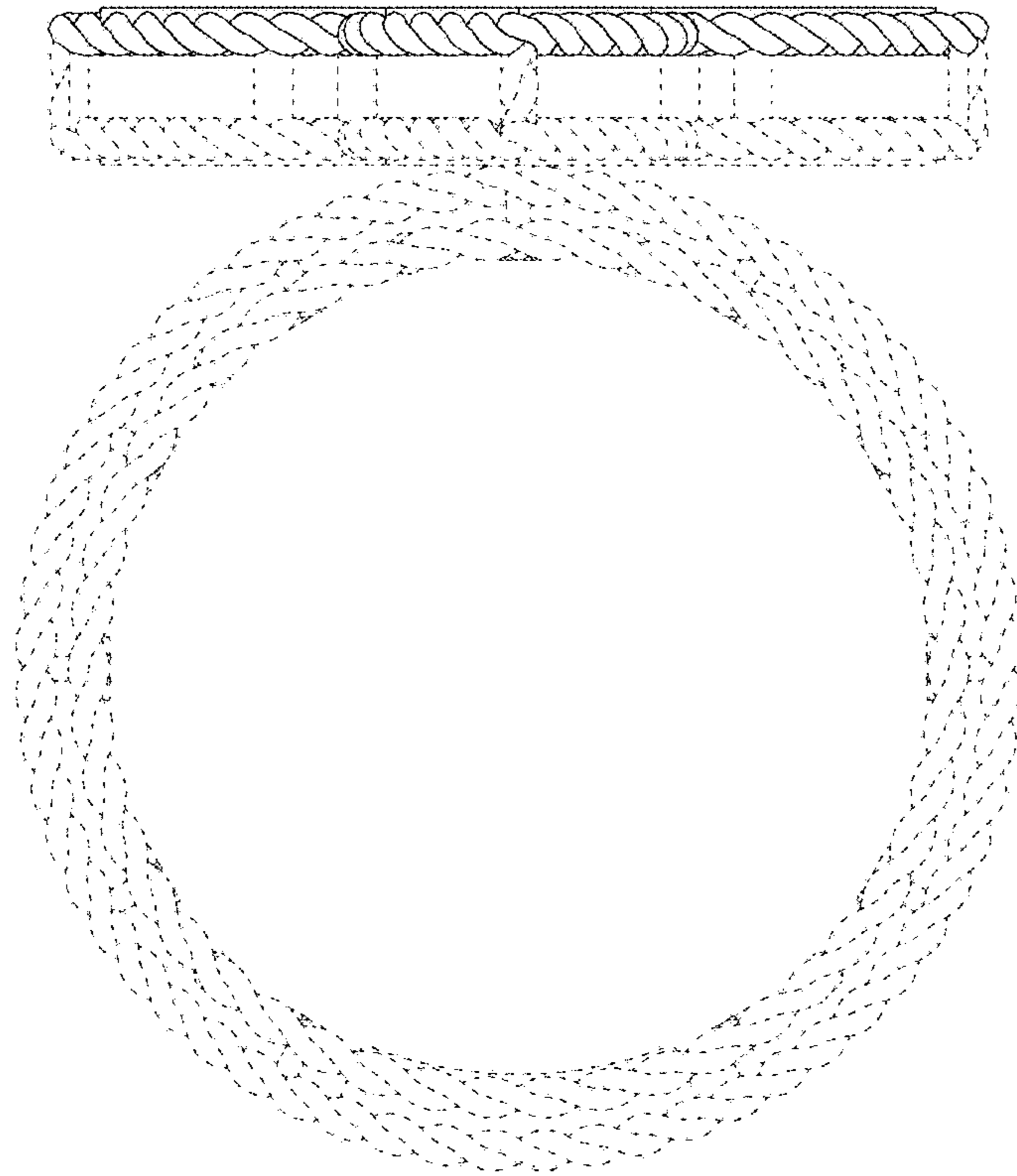

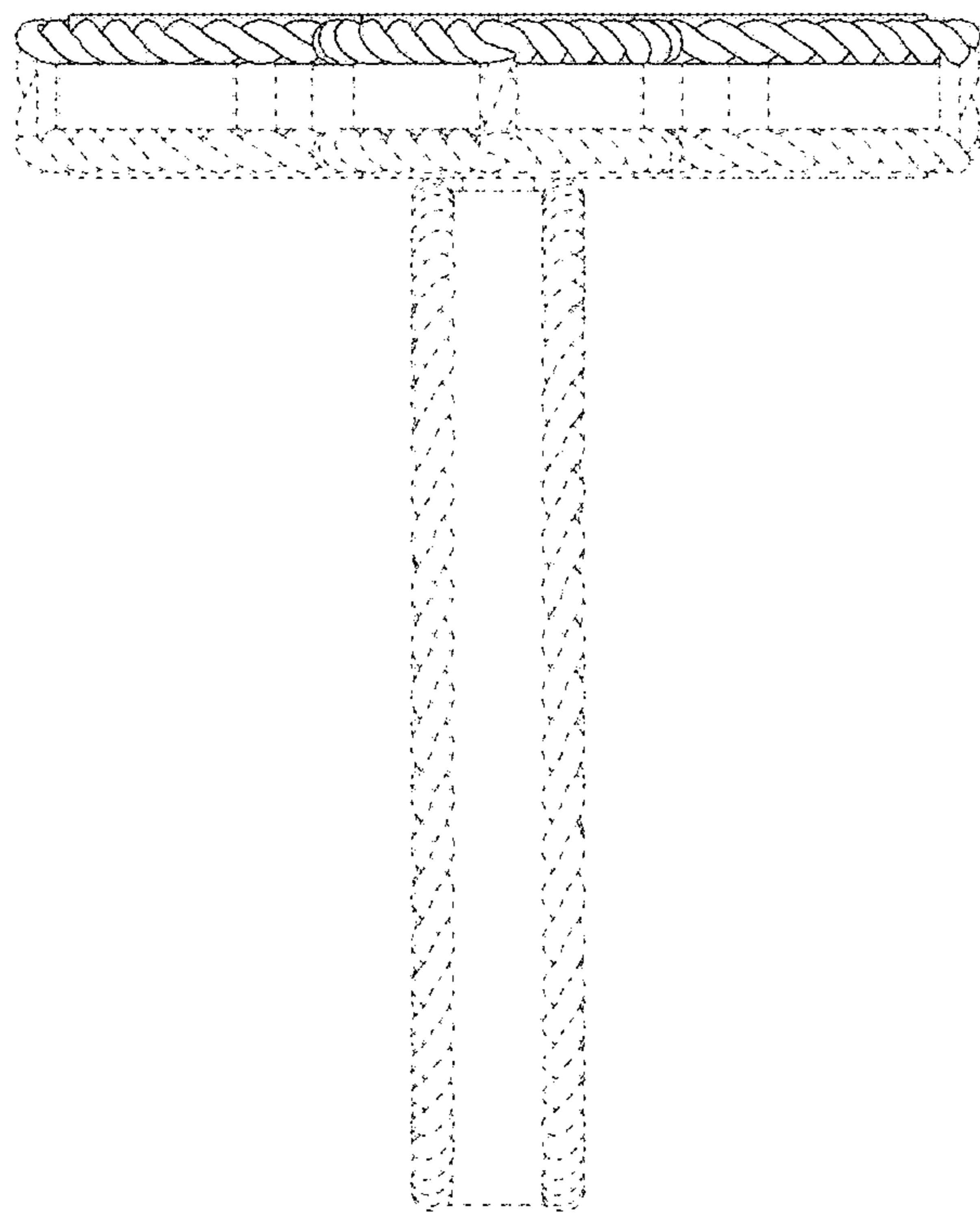

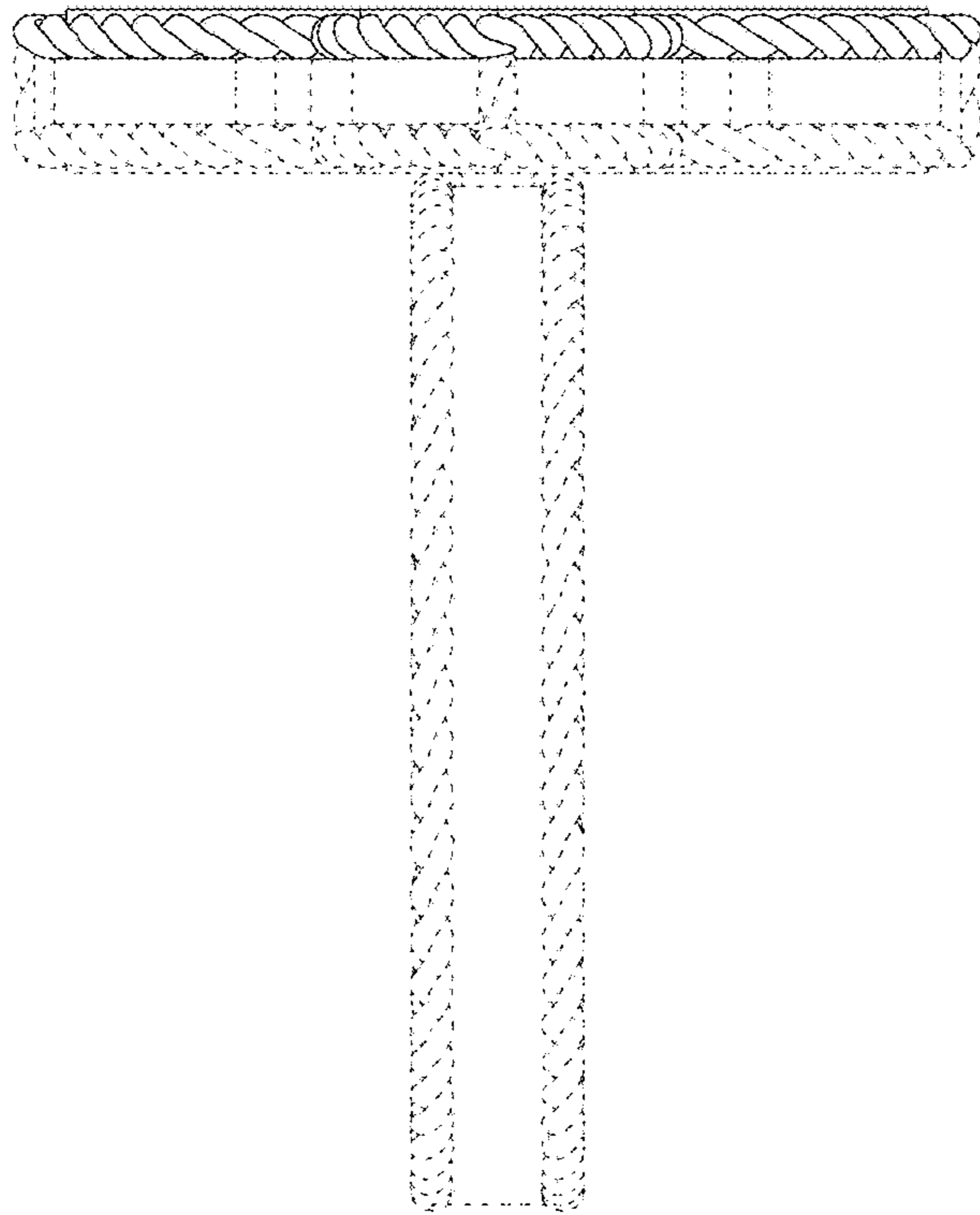

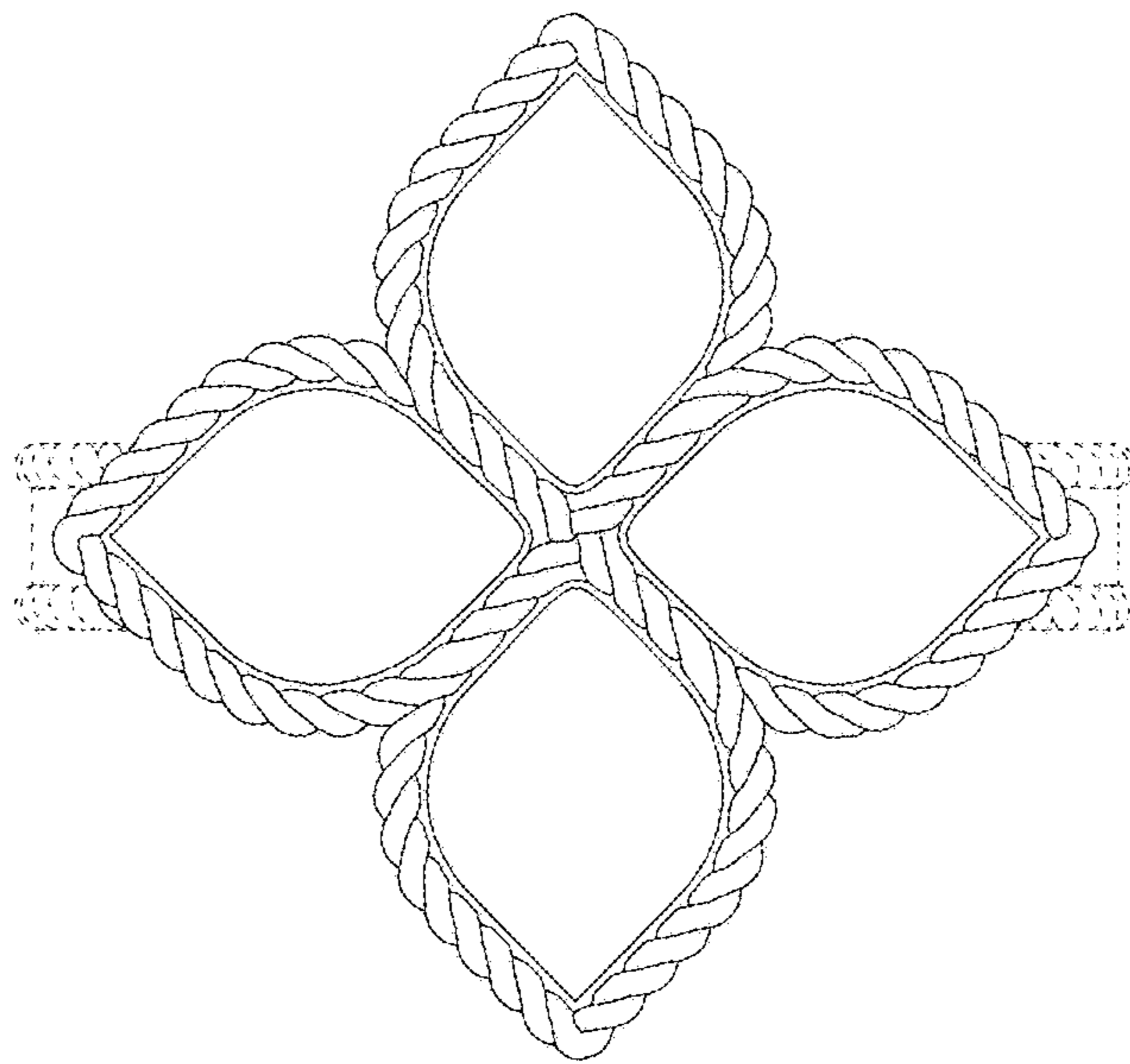

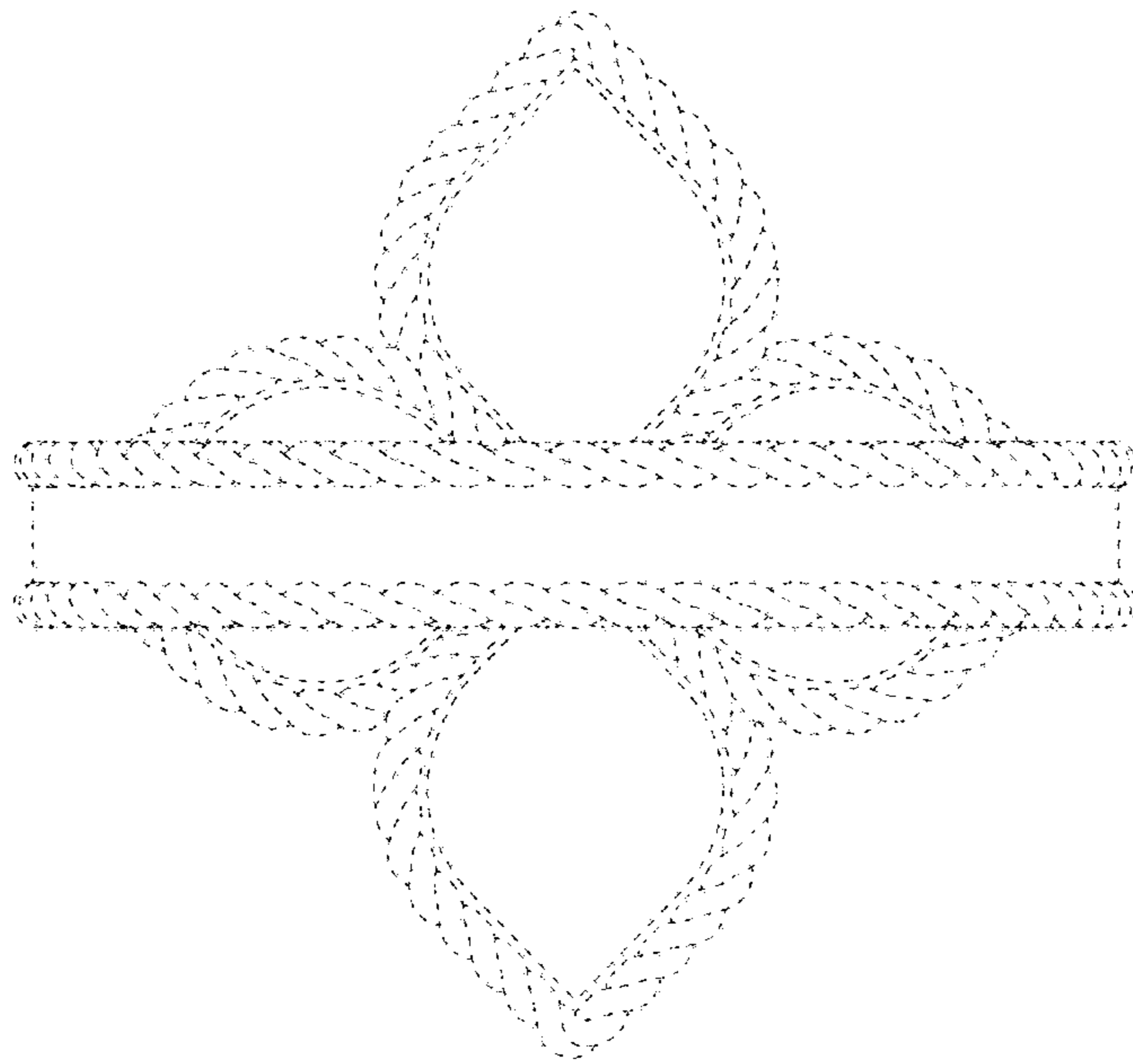
