(57) **CLAIM**

The ornamental design for a father figurine, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the father figurine of the present invention;
FIG. 2 is a front view of the invention of FIG. 1;
FIG. 3 is a back view of the invention of FIG. 1;
FIG. 4 is a side view of the invention of FIG. 1, as seen from the right side of FIG. 2;
FIG. 5 is a side view of the invention of FIG. 1, as seen from the left side of FIG. 2;
FIG. 6 is a top plan view in elevation of the invention of FIG. 1; and,
FIG. 7 is a bottom plan view of the invention of FIG. 1.
The broken lines showing hands and shoes illustrate portions of the father figurine that form no part of the claimed design.

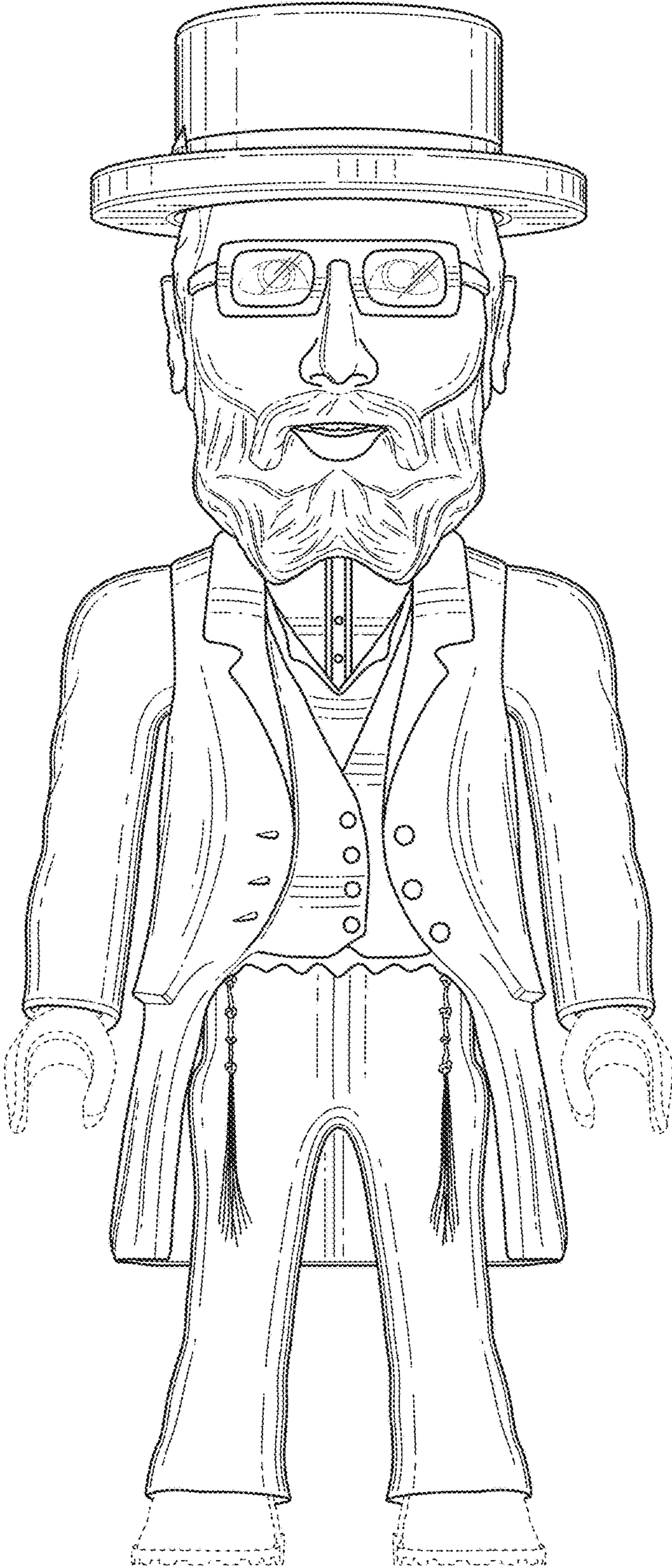

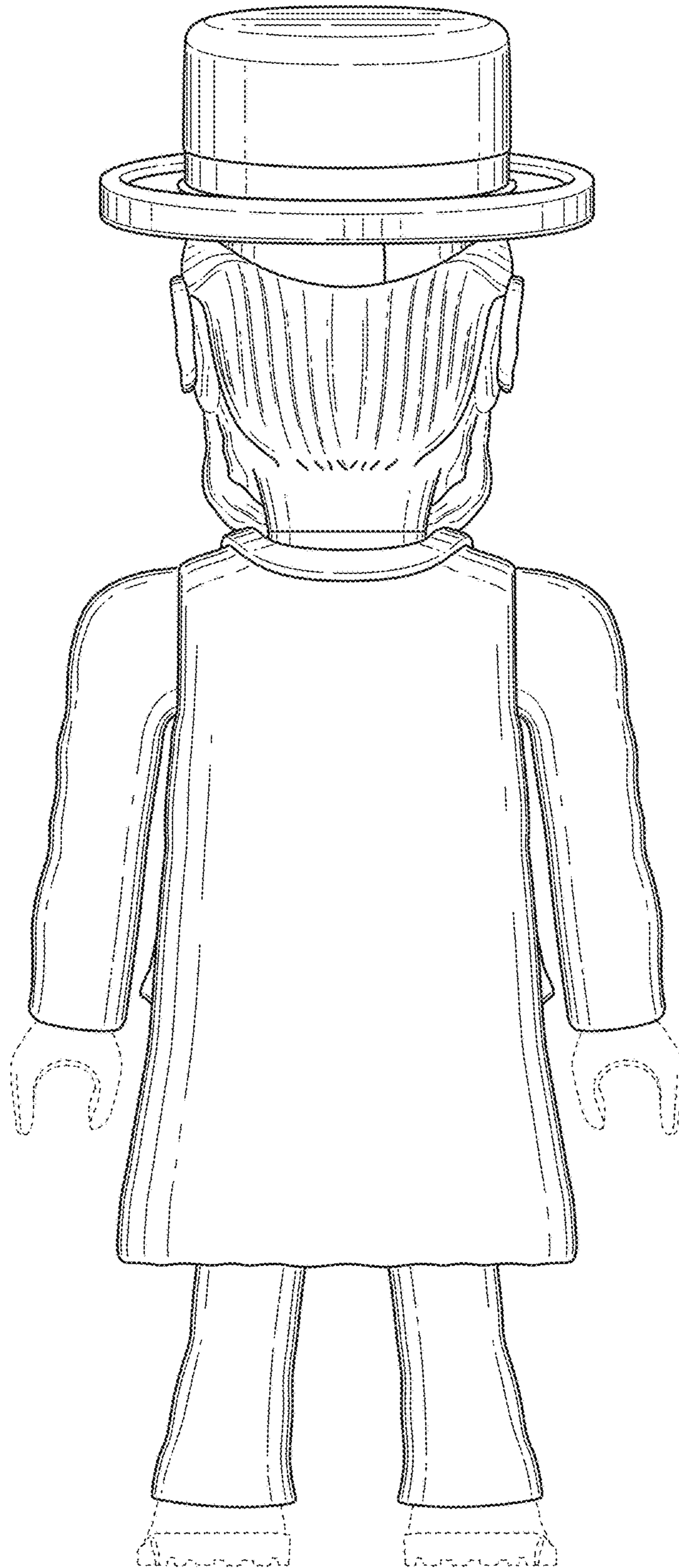

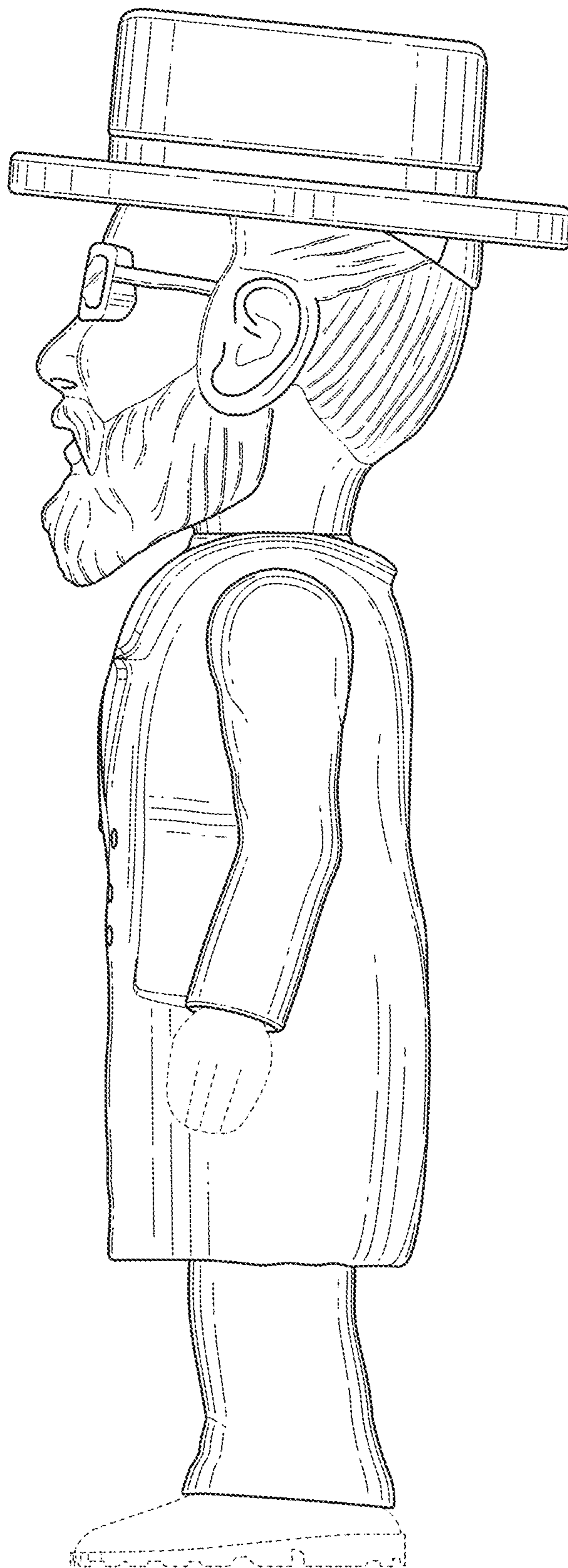

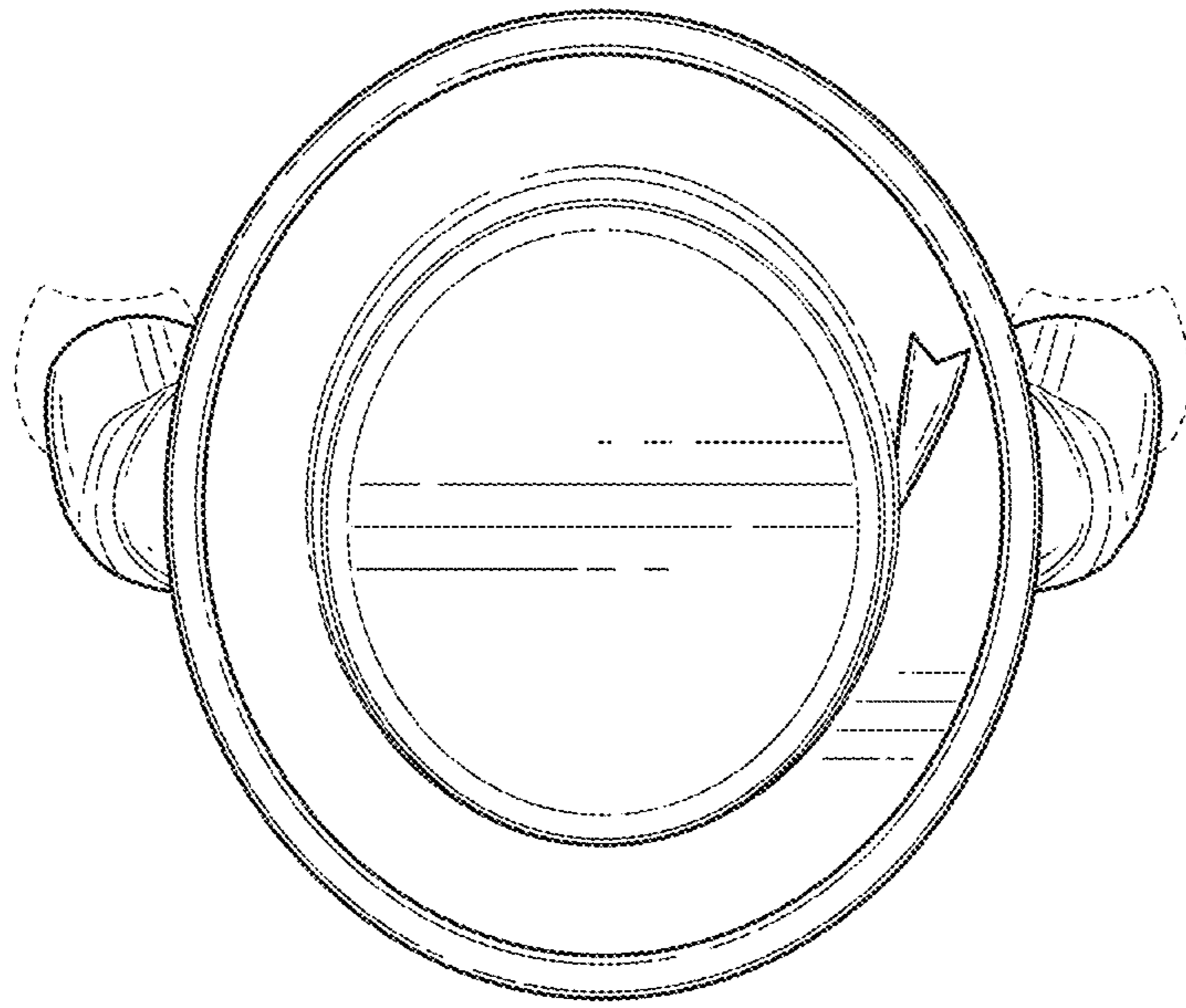

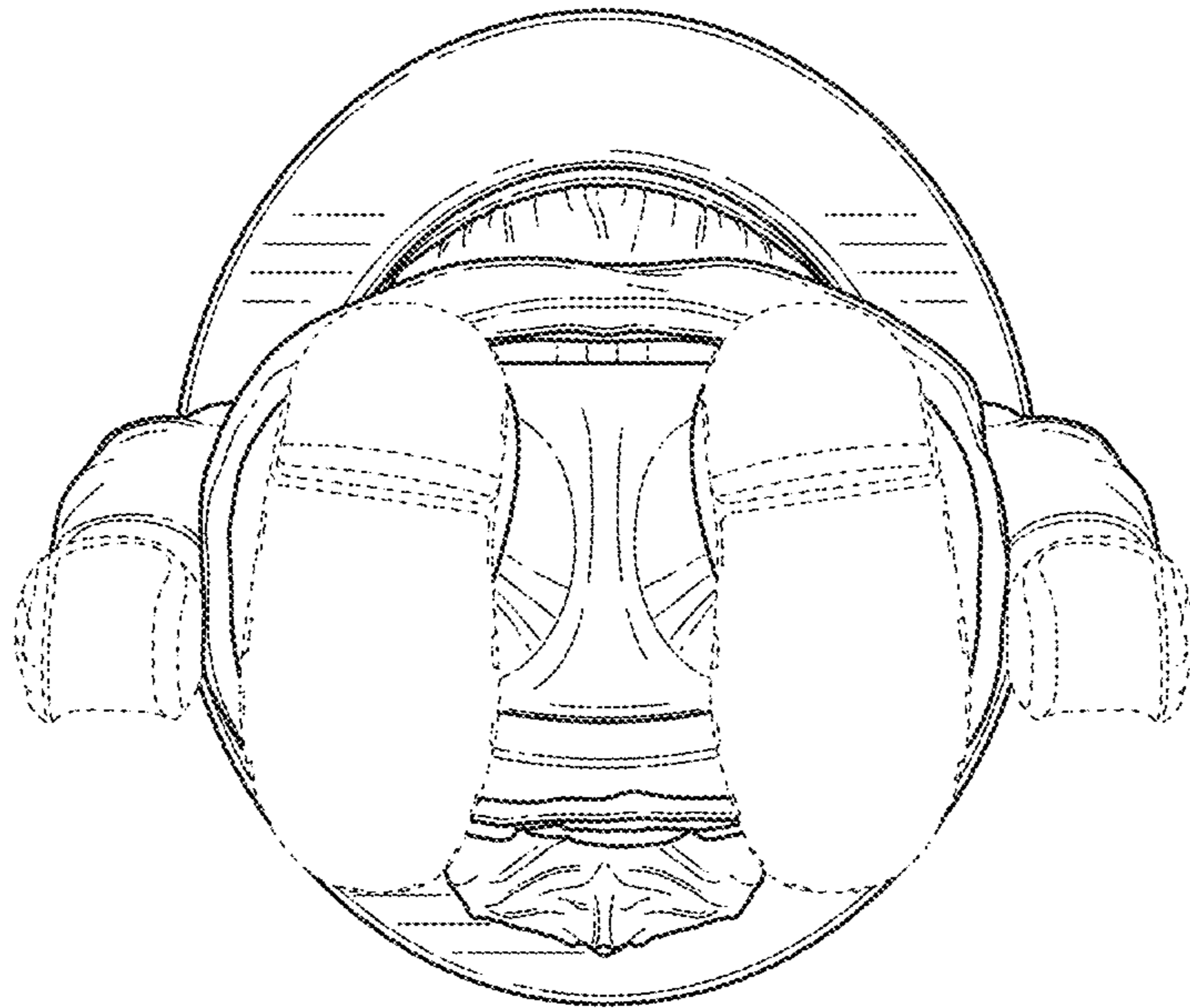
