(57) **CLAIM**

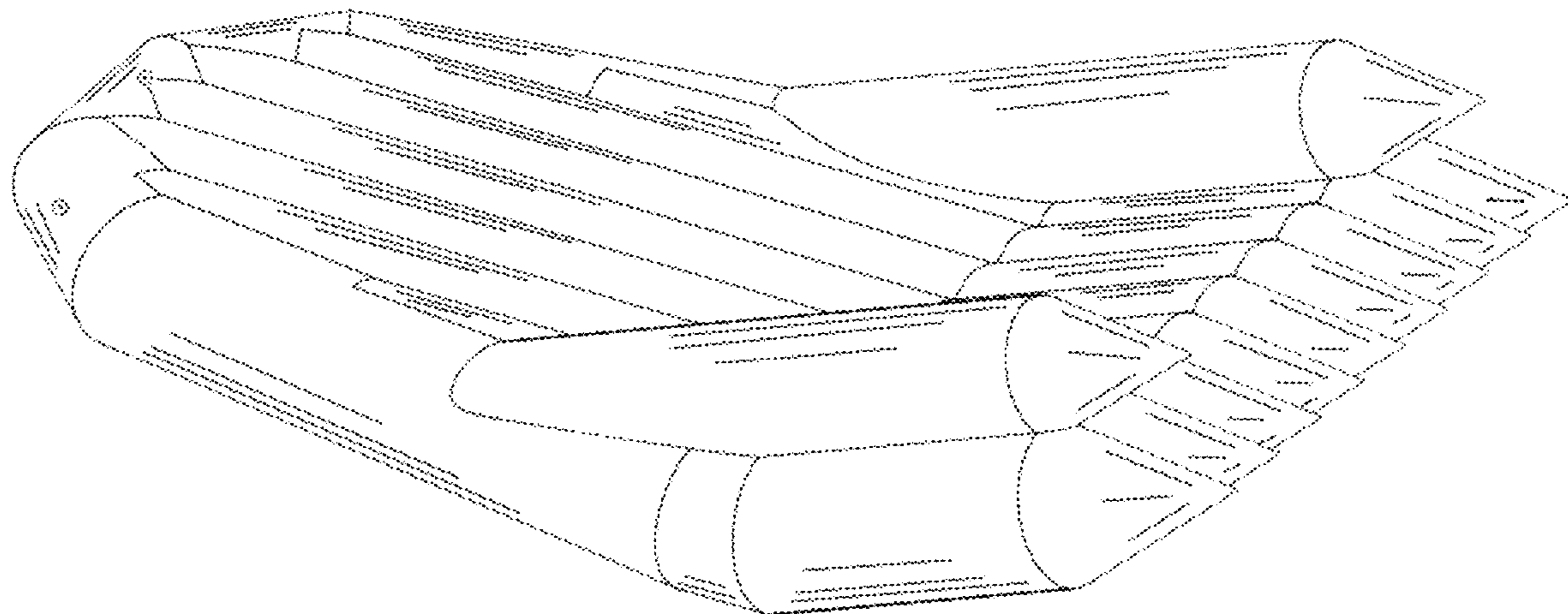
The ornamental design for the air-inflated vehicle, as shown and described herein.

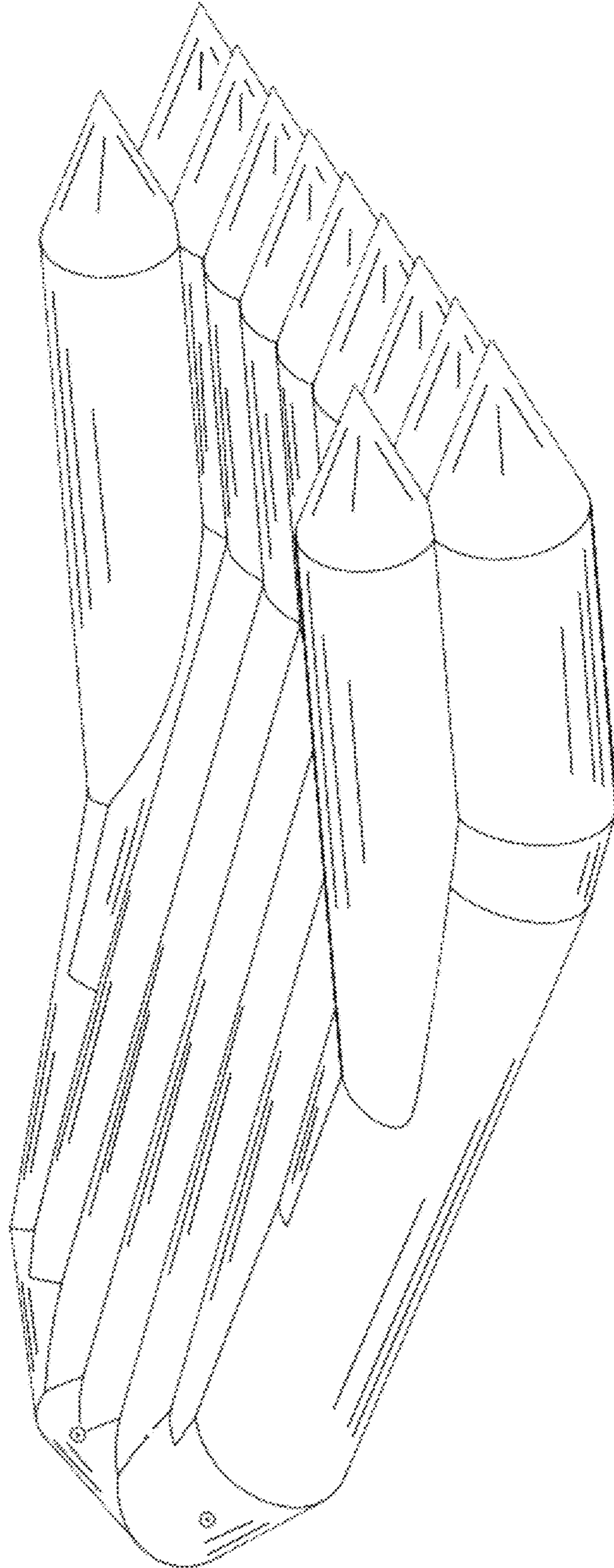

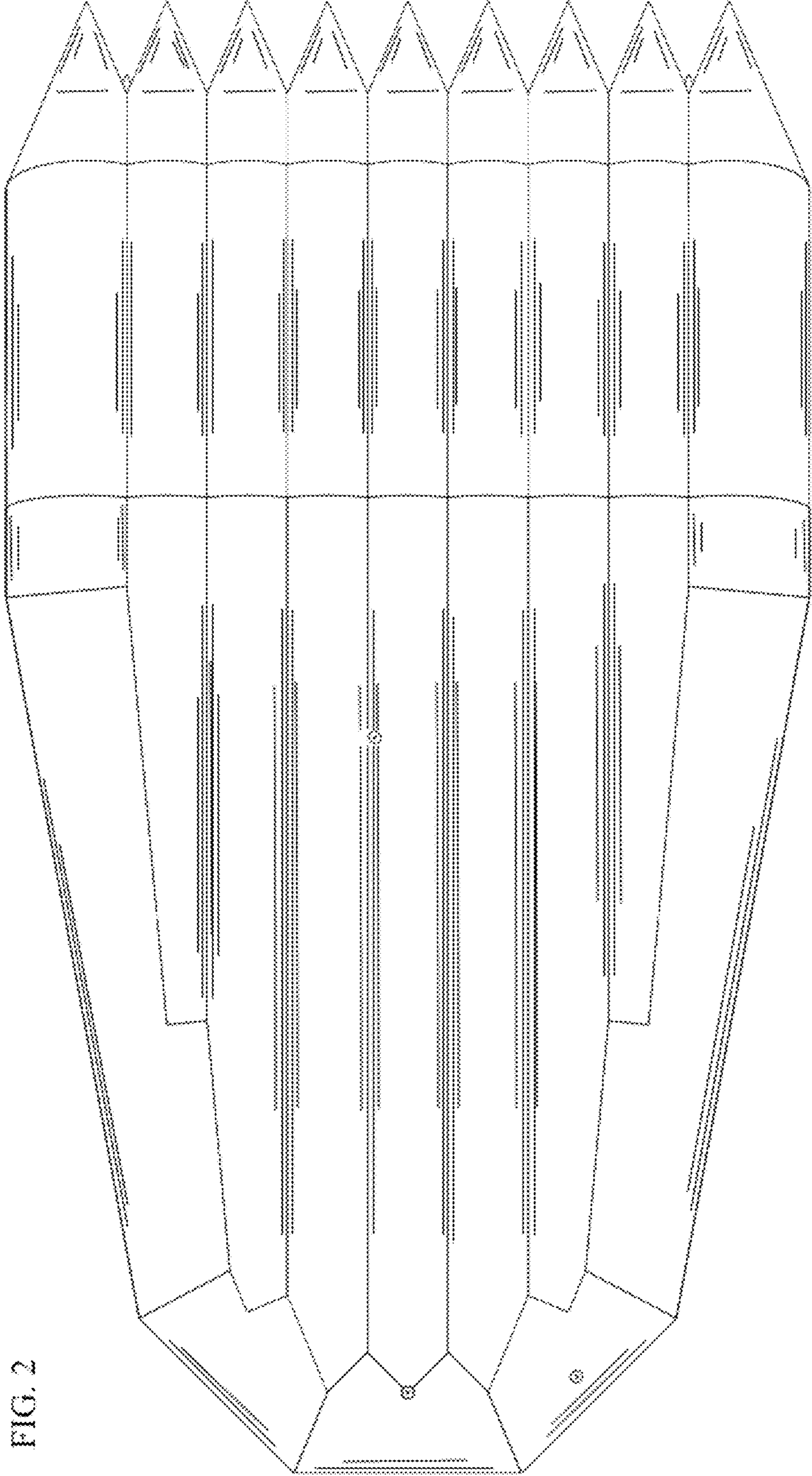
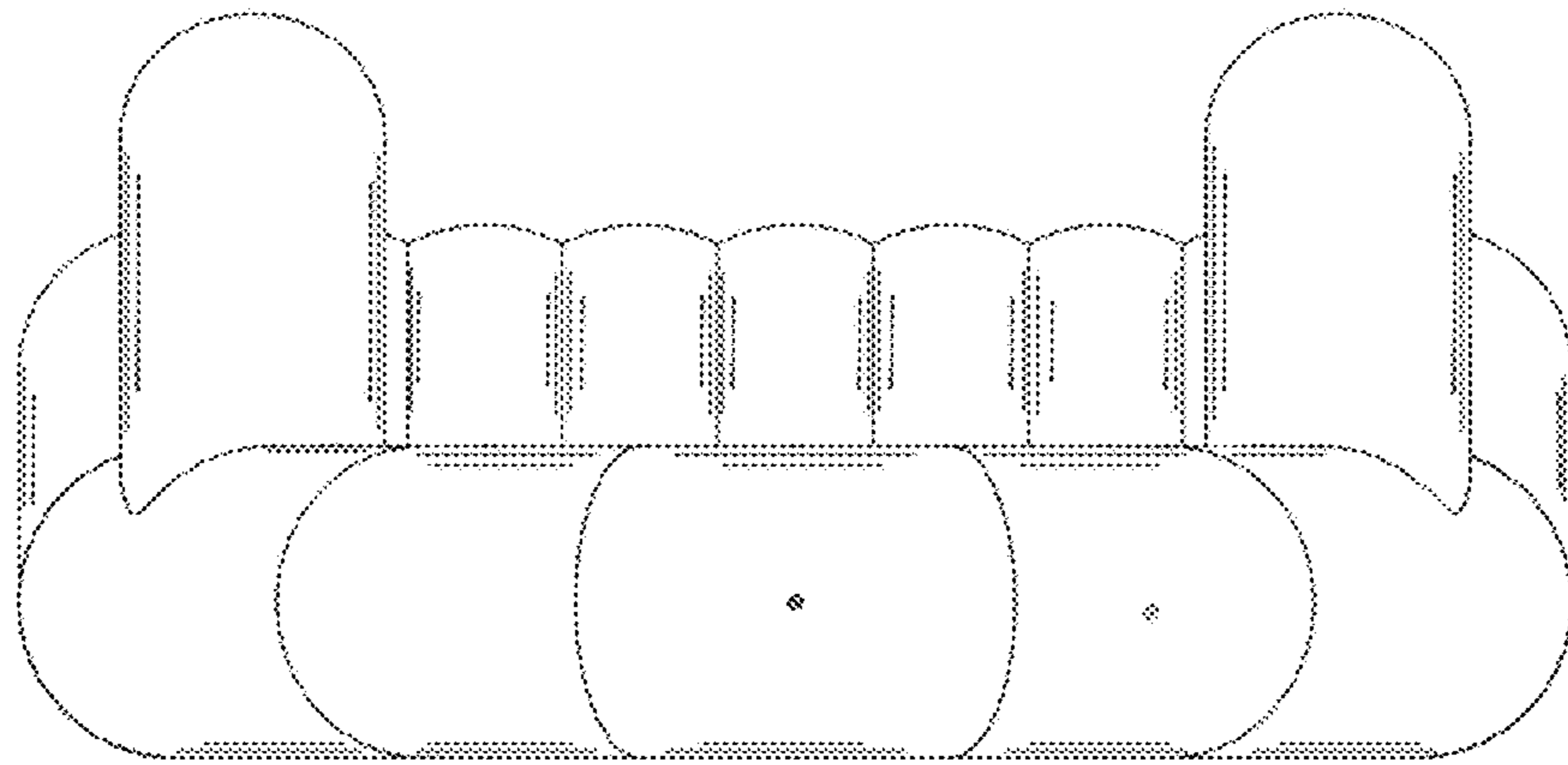

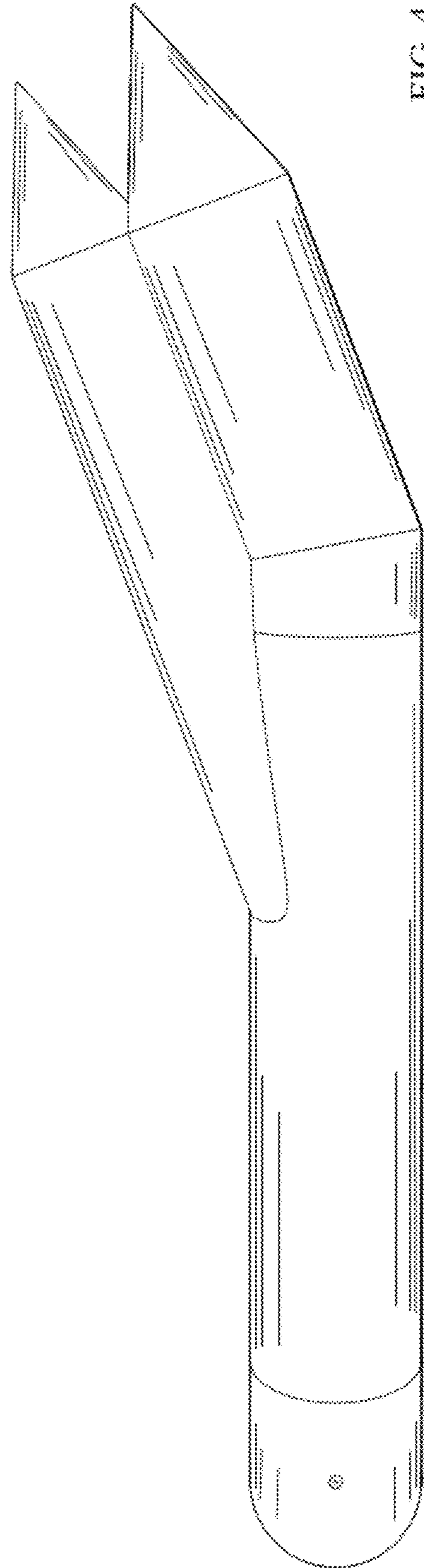
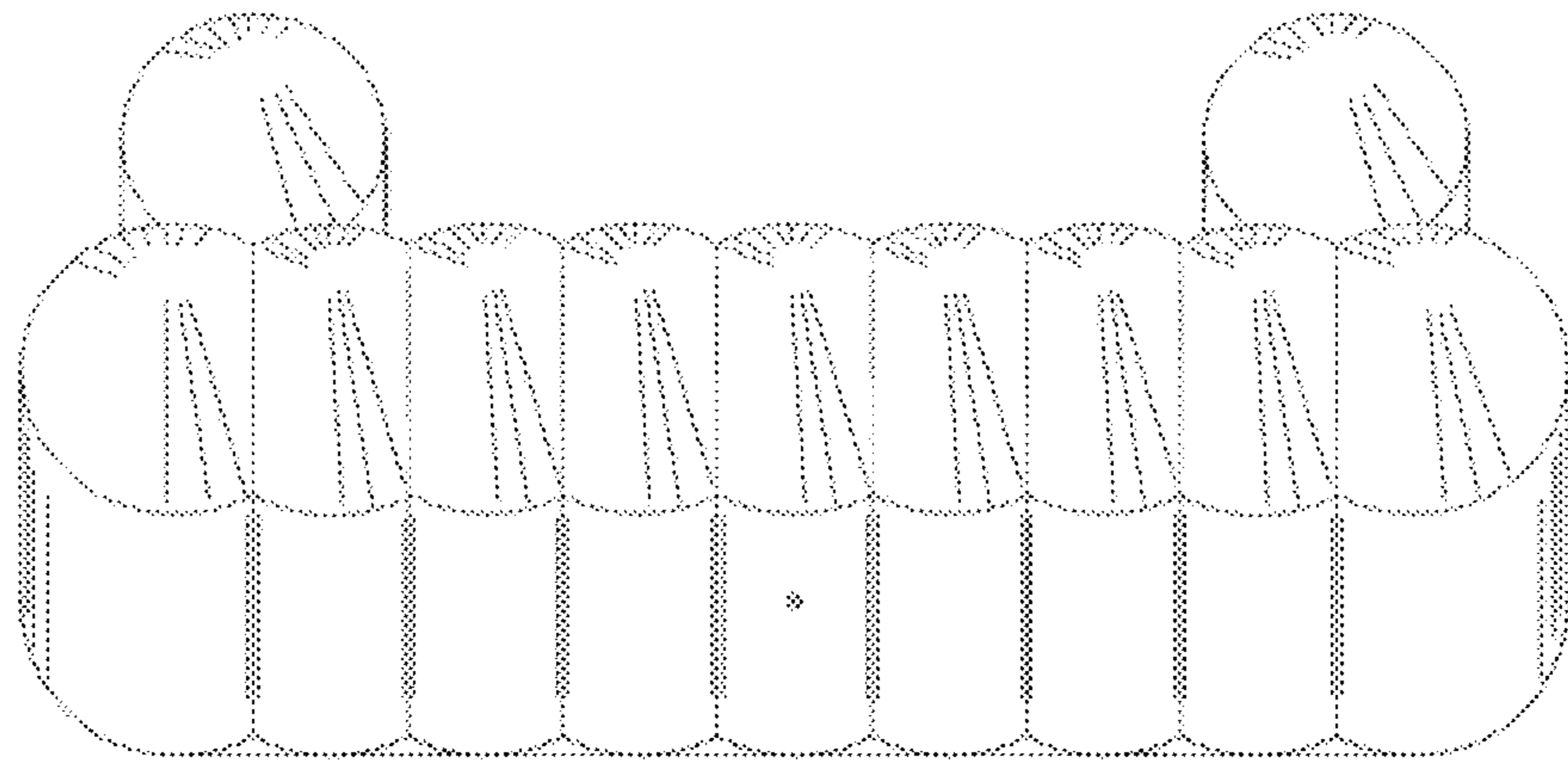

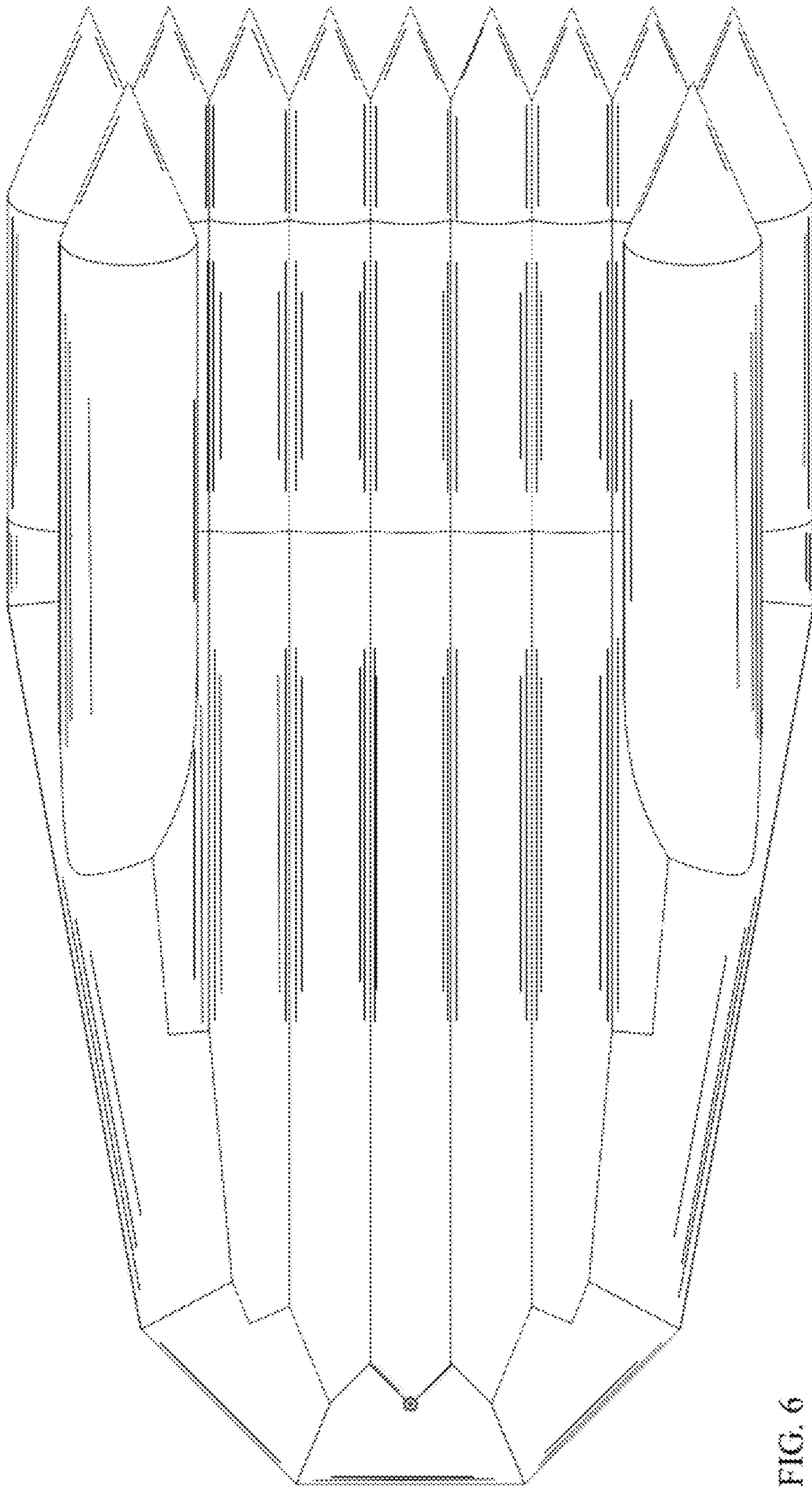
