(57) **CLAIM**

What is claimed is the ornamental design for a “deer shaped vehicle attachment,” as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing the deer shaped vehicle attachment of the Applicant’s invention.

FIG. 2 is a back perspective view of the deer shaped vehicle attachment of FIG. 1.

FIG. 3 is a front elevation view of the deer shaped vehicle attachment of FIG. 1.

FIG. 4 is a back elevation view of the deer shaped vehicle attachment of FIG. 1.

FIG. 5 is a left side elevation view of the deer shaped vehicle attachment of FIG. 1.

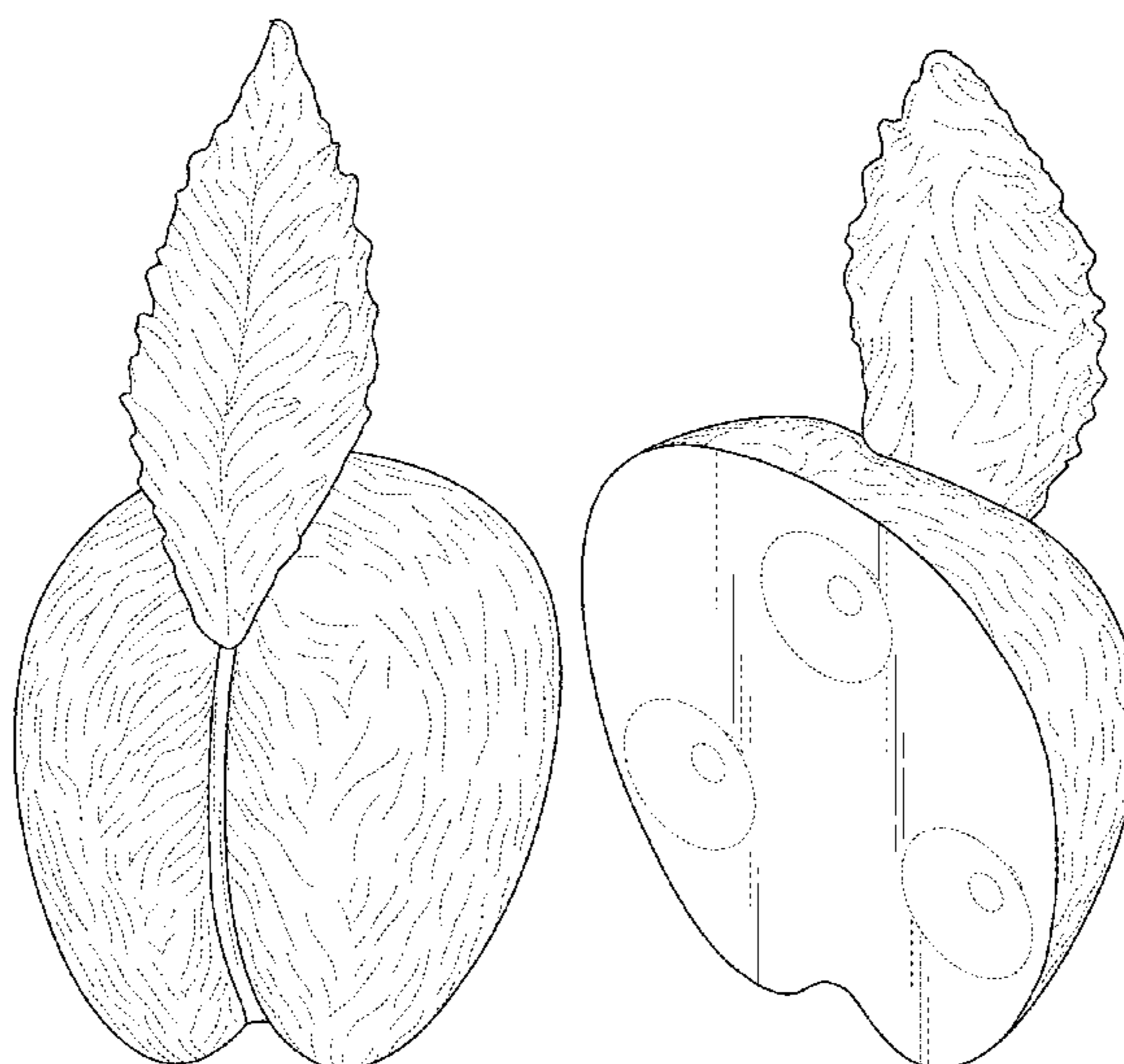
FIG. 6 is a right side elevation view of the deer shaped vehicle attachment of FIG. 1.

FIG. 7 is a top view of the deer shaped vehicle attachment of FIG. 1; and,

FIG. 8 is a bottom view of the deer shaped vehicle attachment of FIG. 1.

In FIGS. 1-8, the dashed lines on the body of the design represent various surface or texture lines which are not part of the claimed design. The dashed lines for the connection suction cups on the back of the deer shaped vehicle attachment are shown for environmental purposes only and form no part of the claimed design.

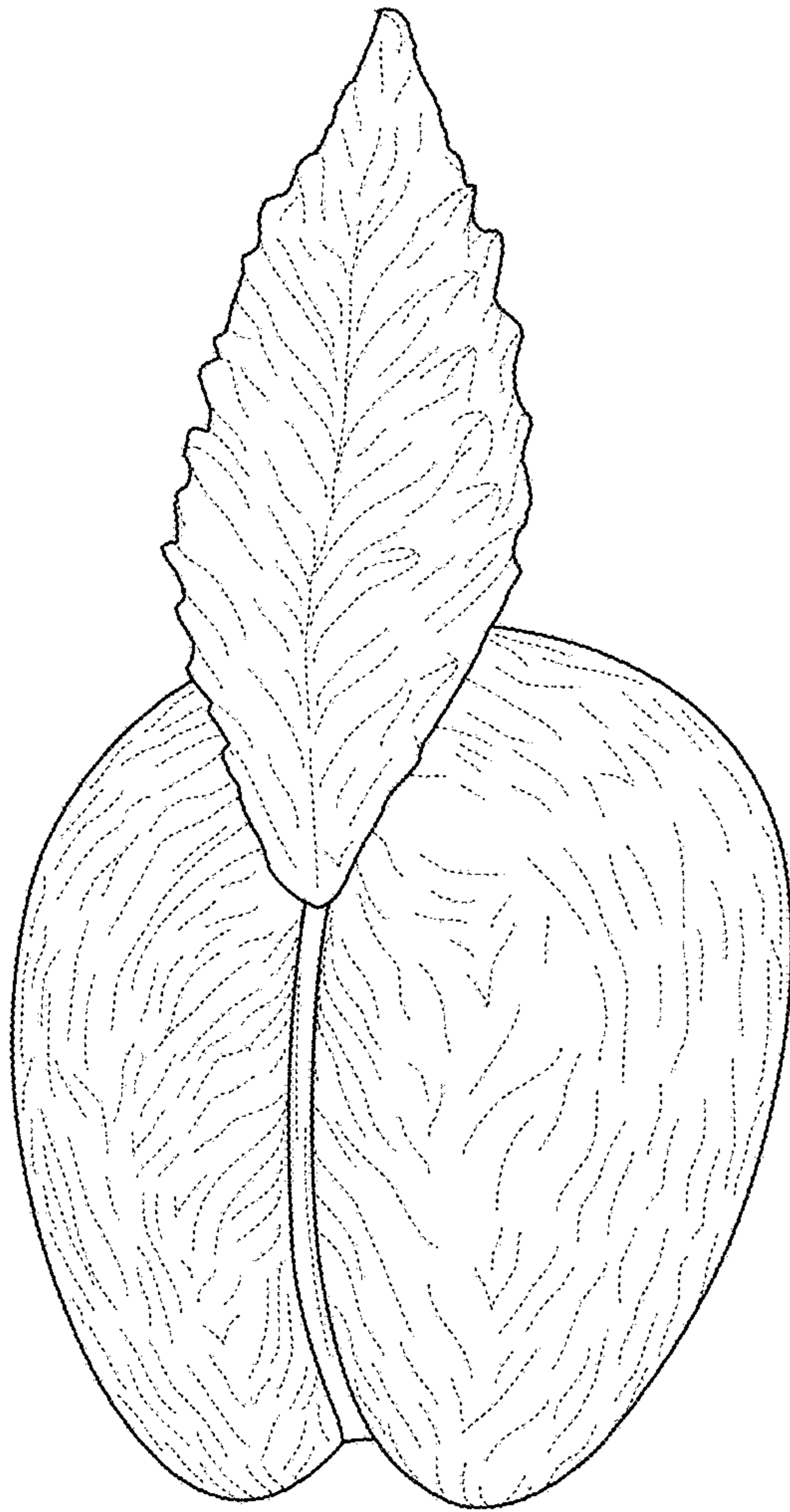

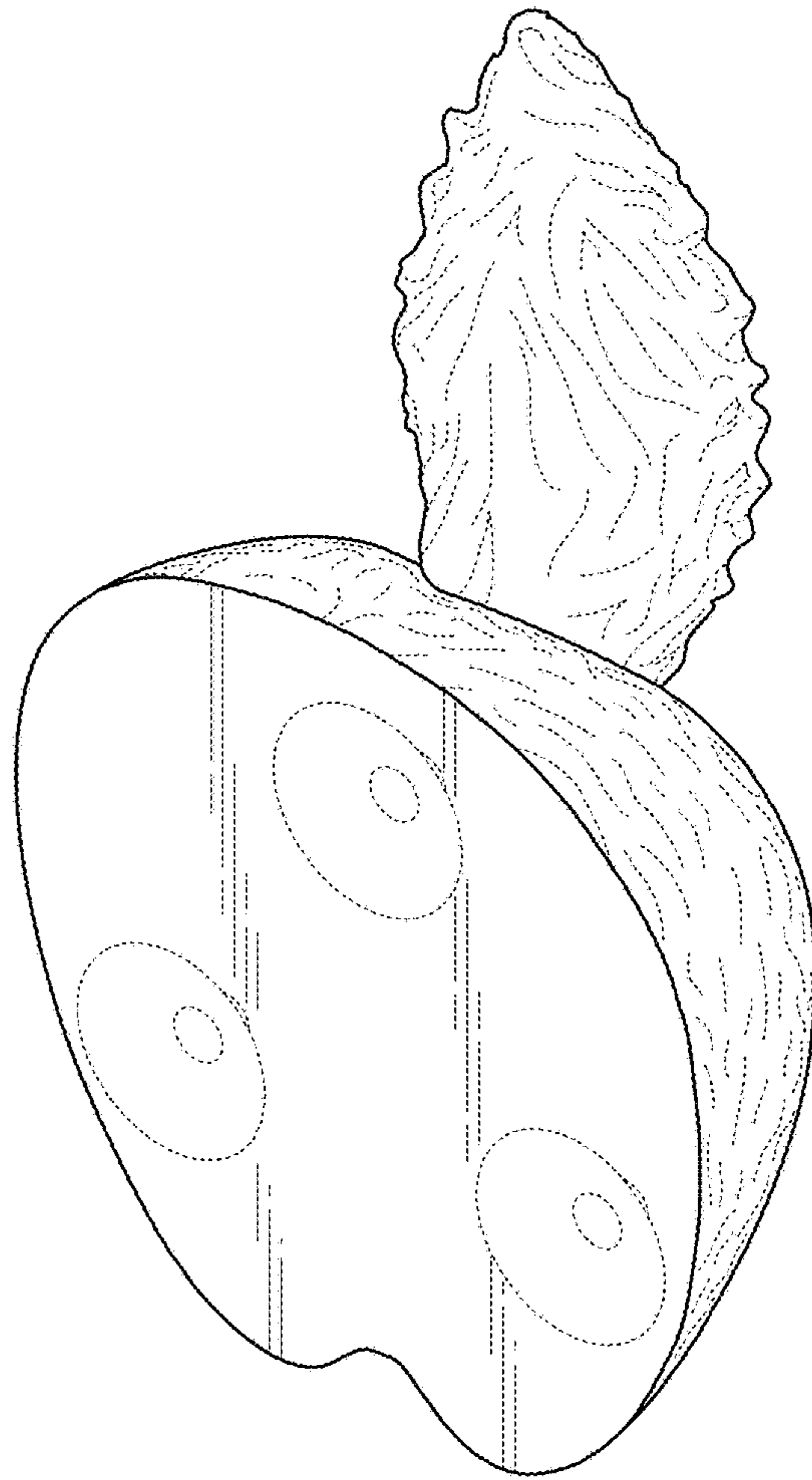

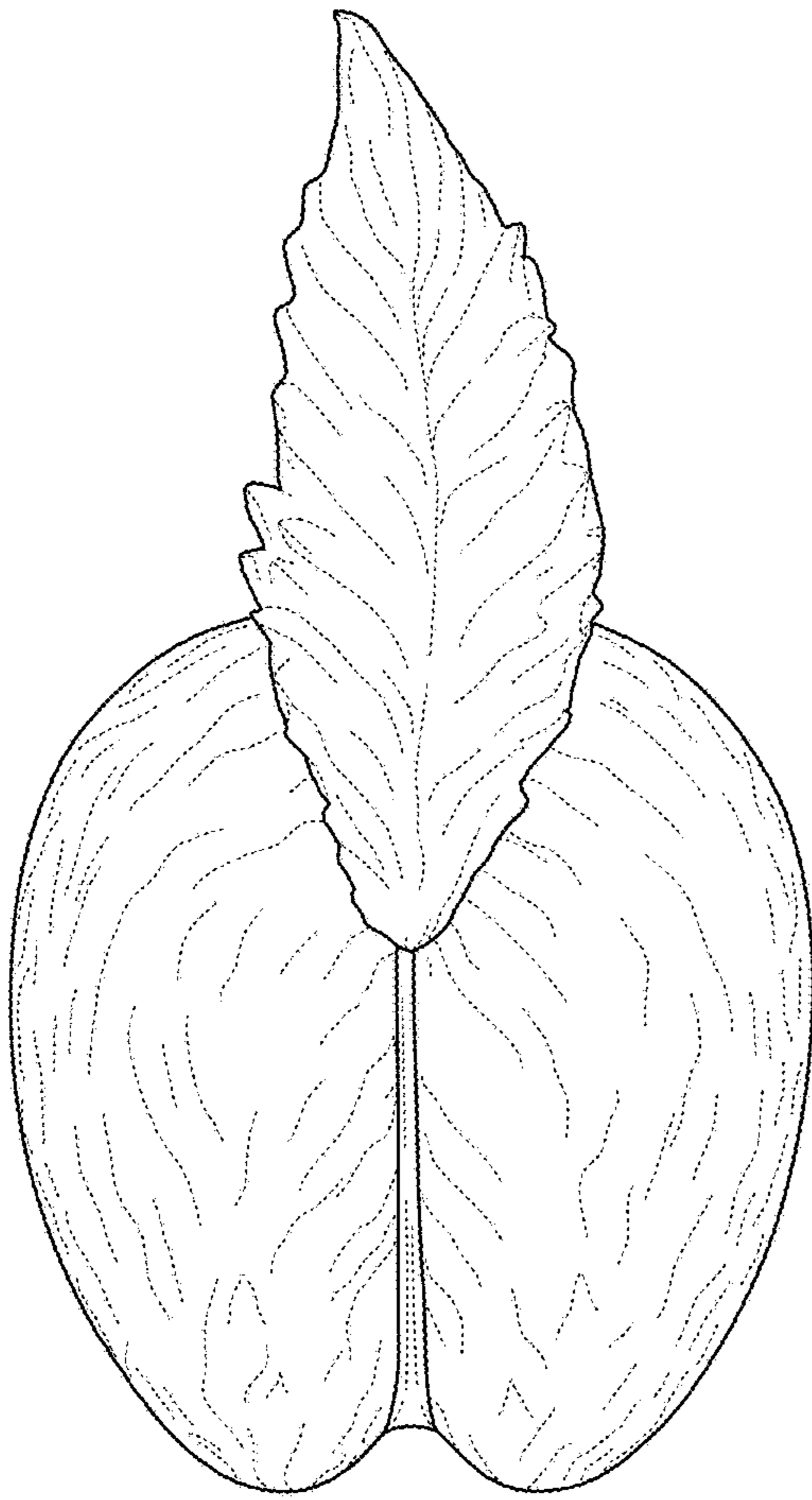

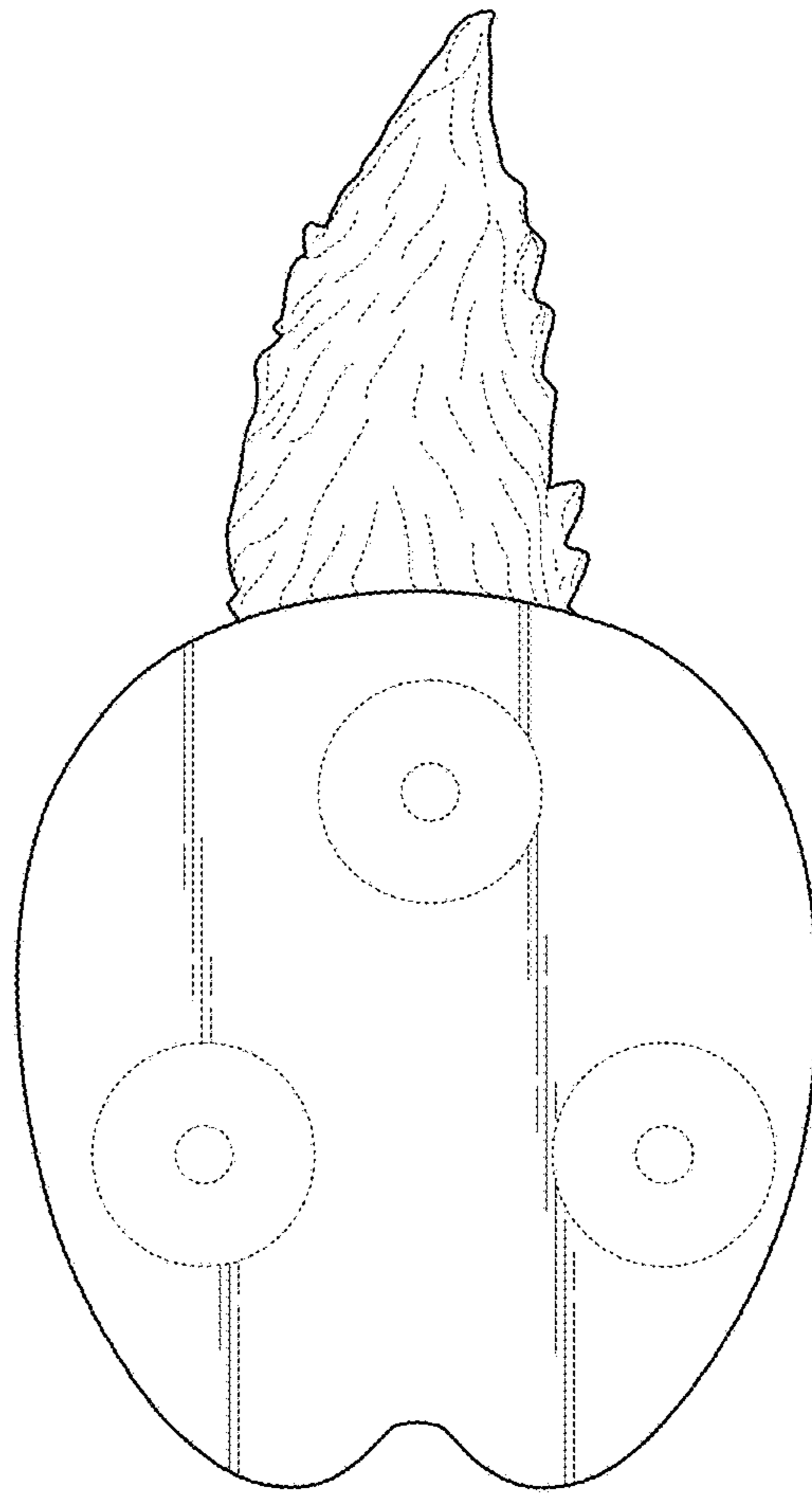

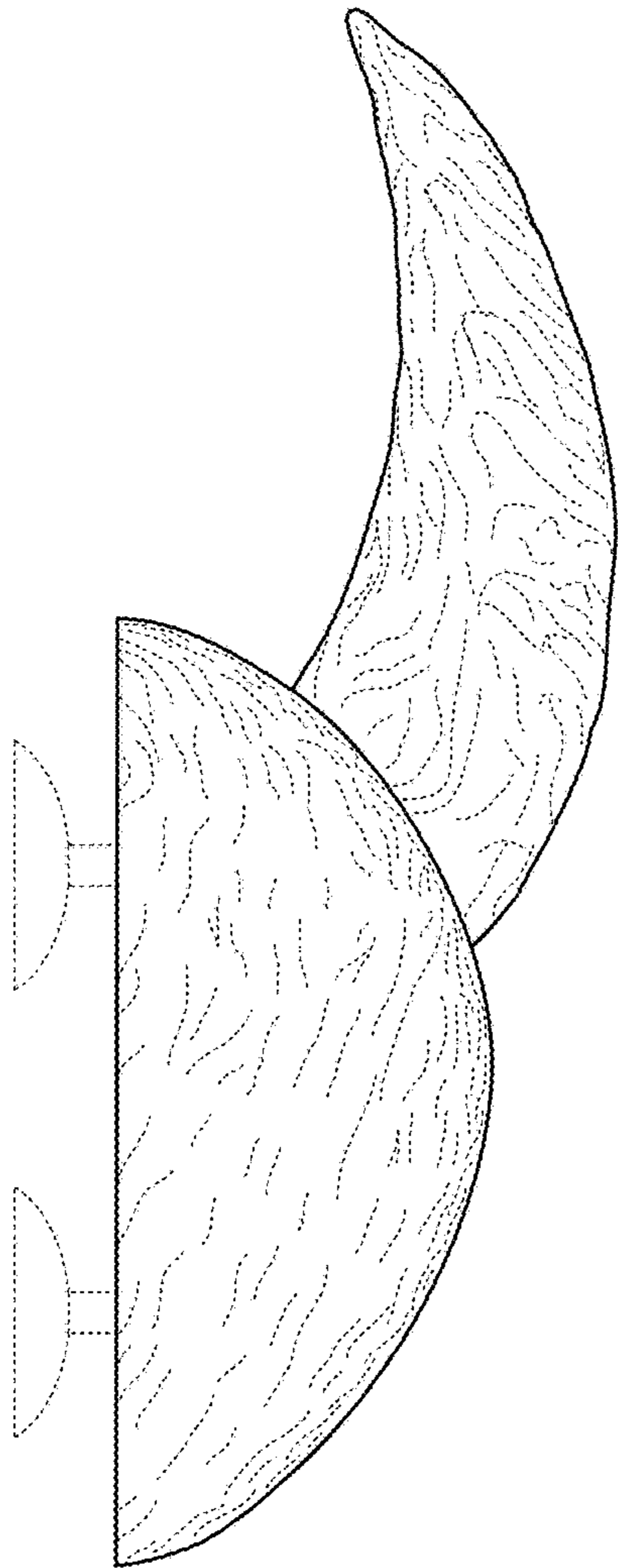

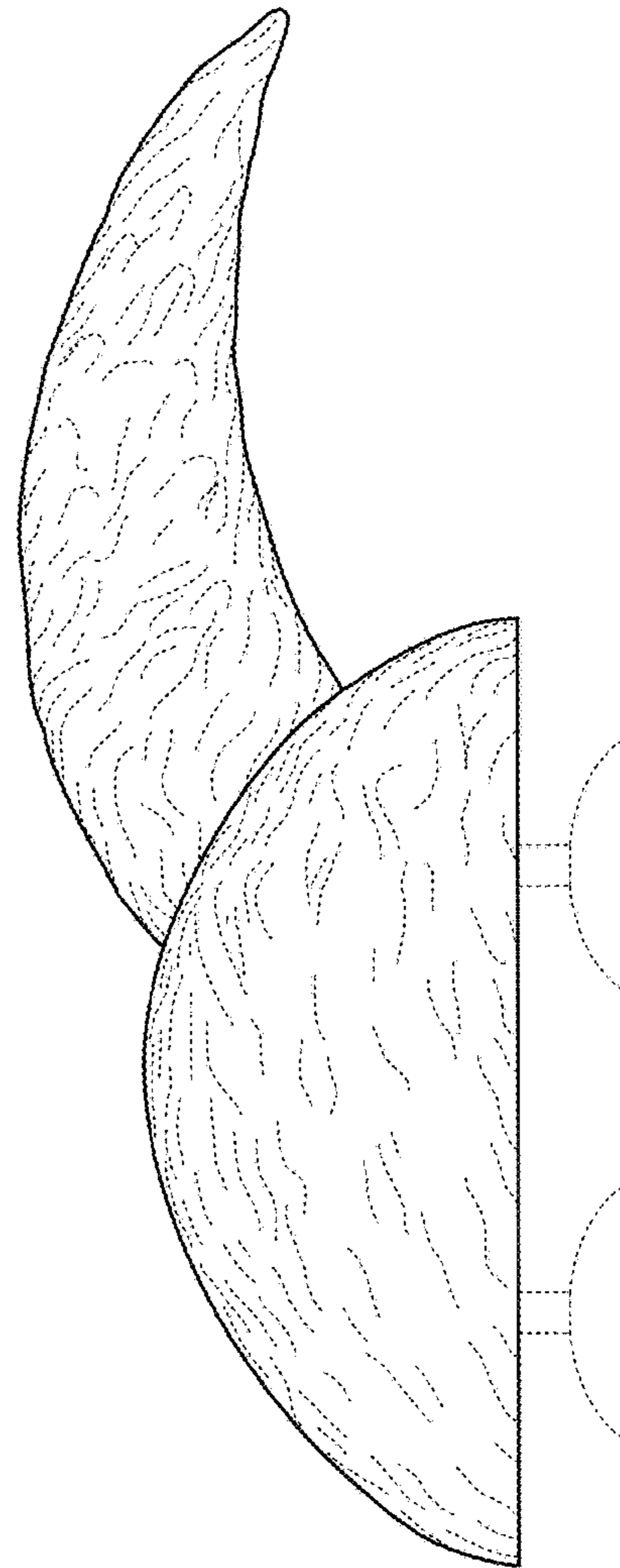

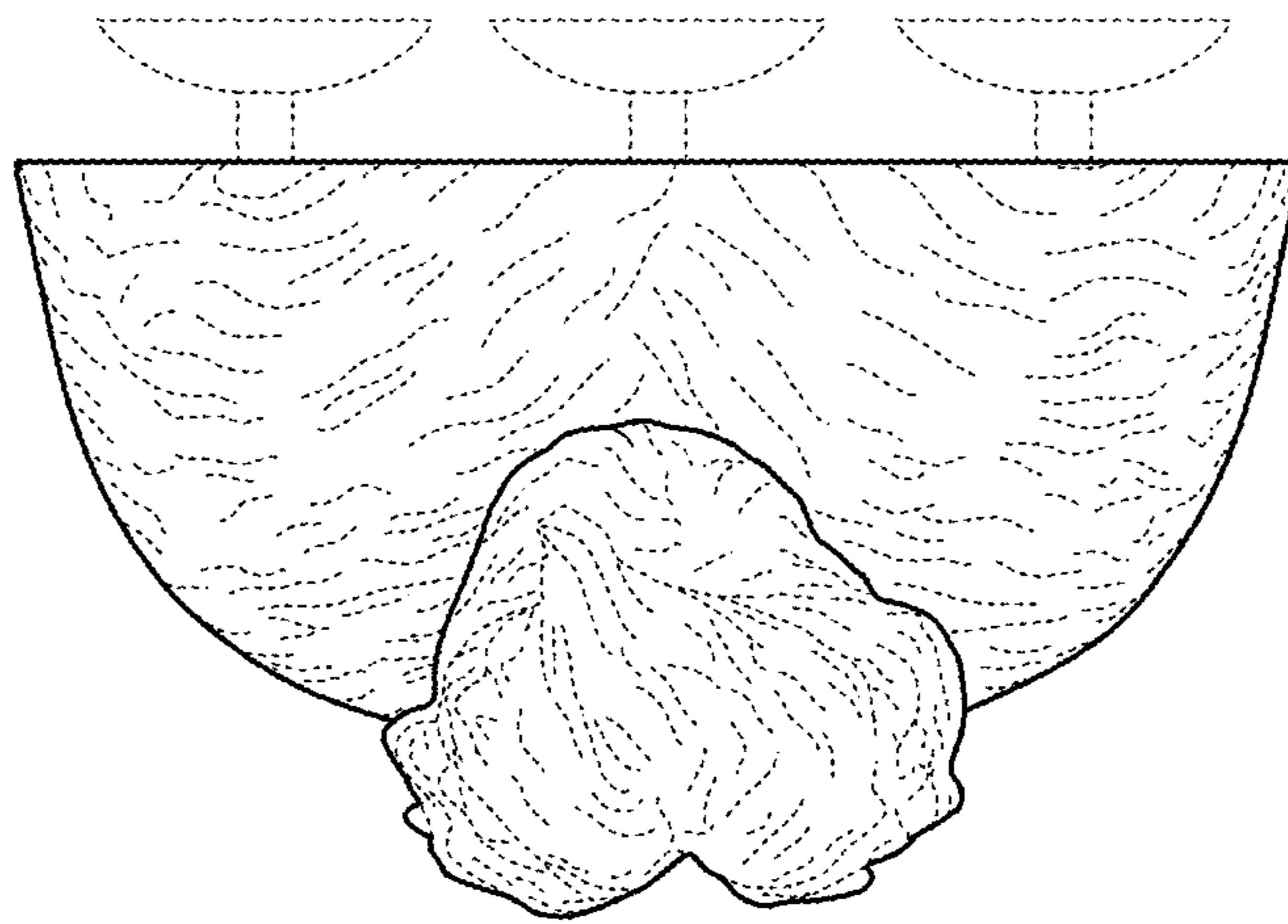

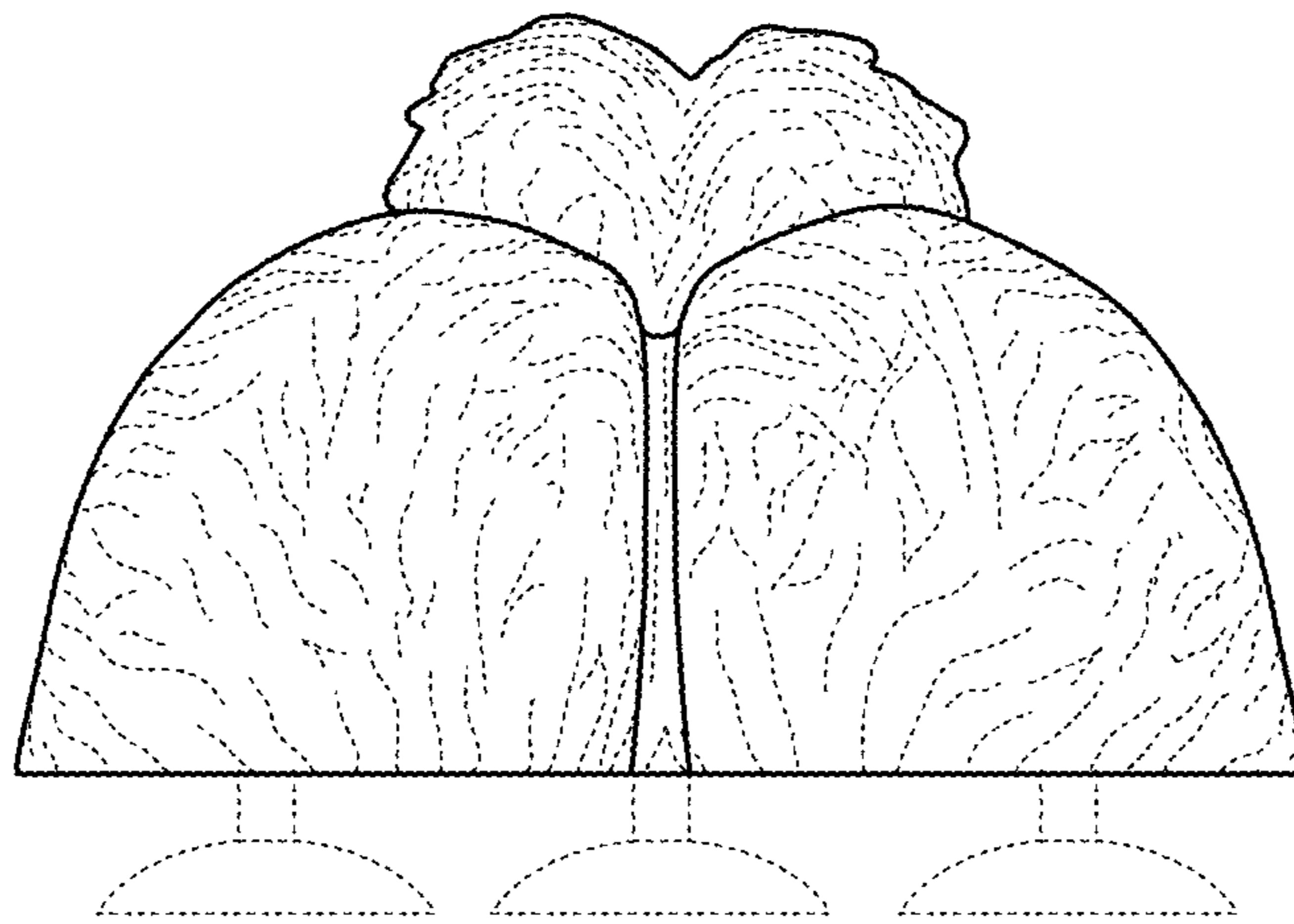
