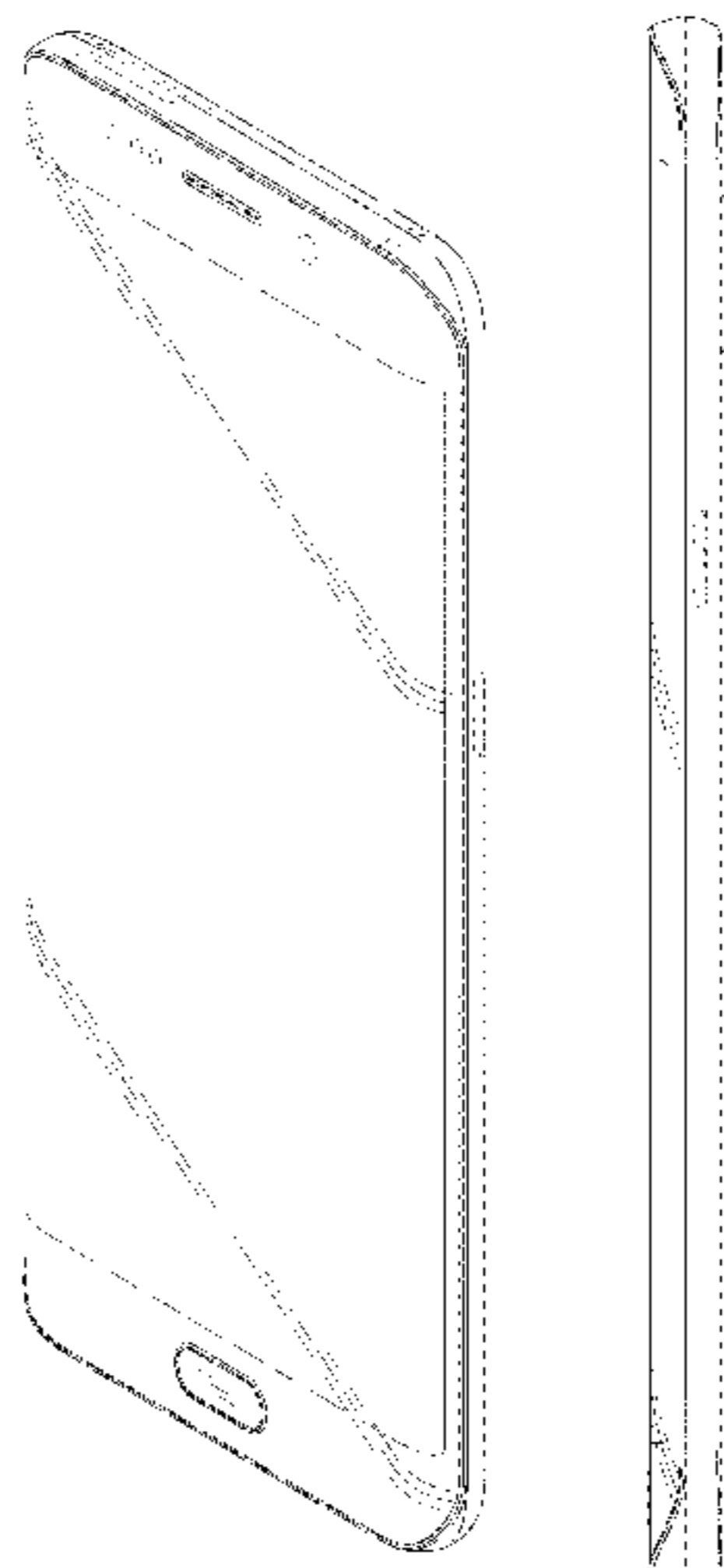
(57) **CLAIM**

The ornamental design for an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of an electronic device showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left-side elevation view thereof; FIG. 5 is a right-side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a rear perspective view thereof; FIG. 9 is a front perspective view of a second embodiment of an electronic device showing our new design; FIG. 10 is a front elevation view thereof; FIG. 11 is a rear elevation view thereof; FIG. 12 is a left-side elevation view thereof; FIG. 13 is a right-side elevation view thereof; FIG. 14 is a top plan view thereof; FIG. 15 is a bottom plan view thereof; and, FIG. 16 is a rear perspective view thereof. 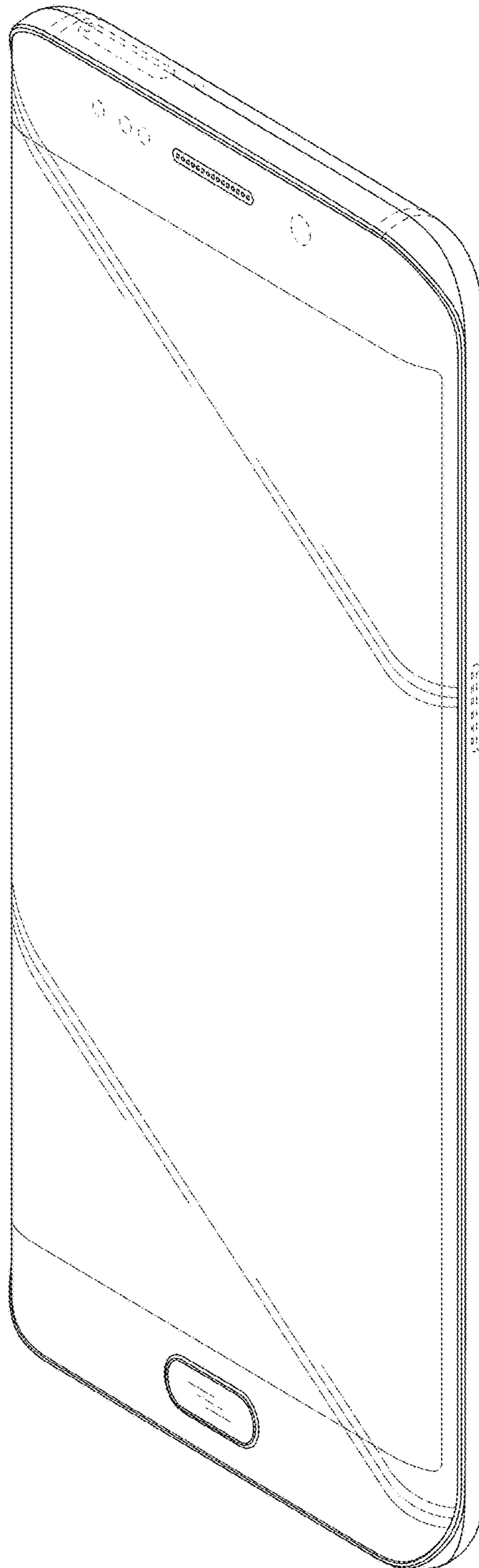

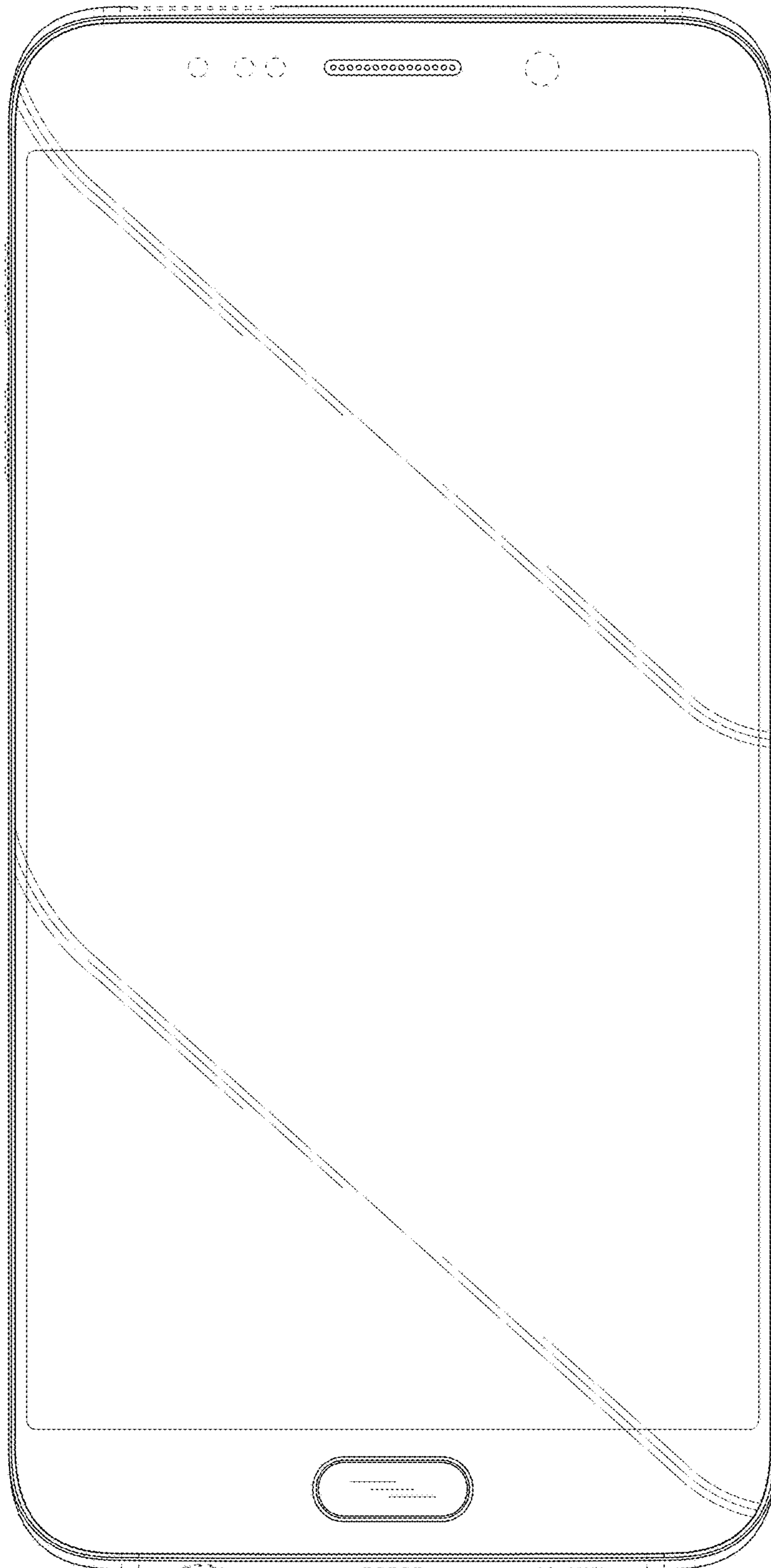

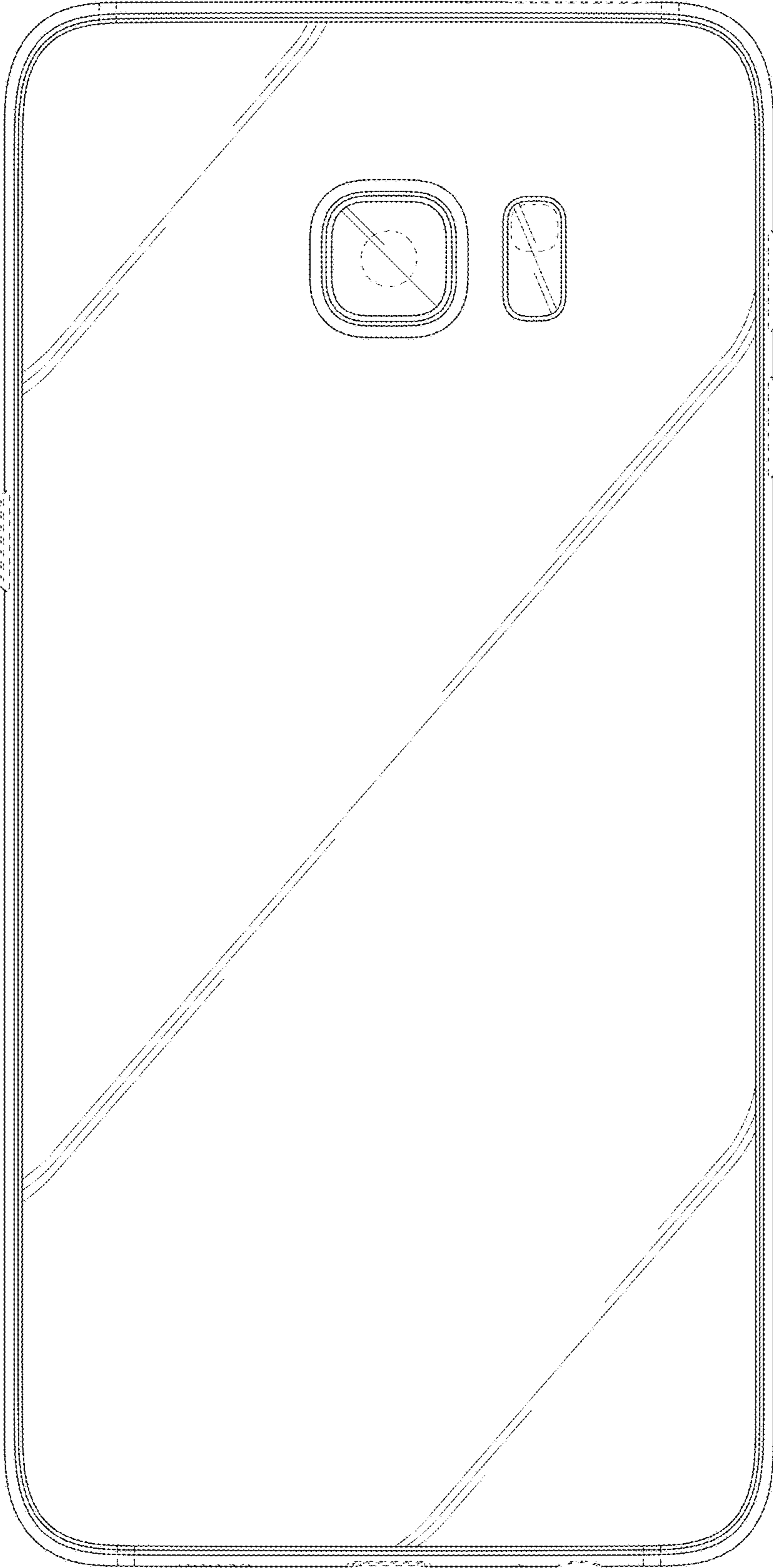

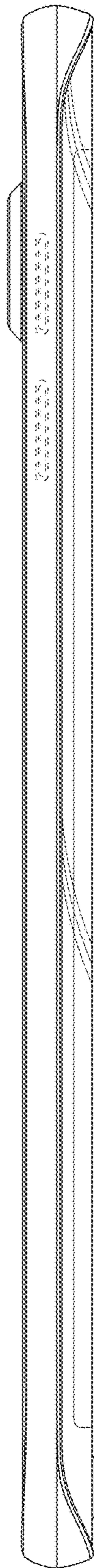

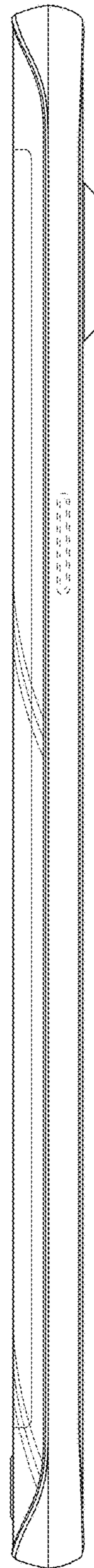

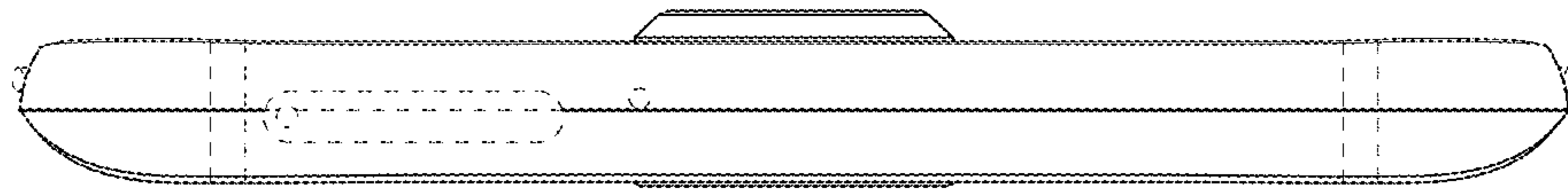

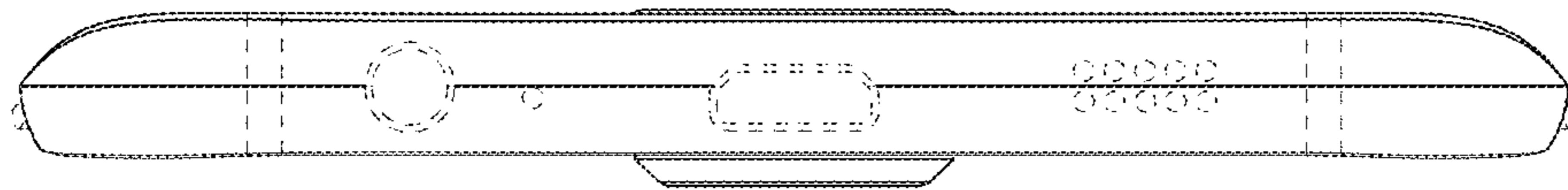

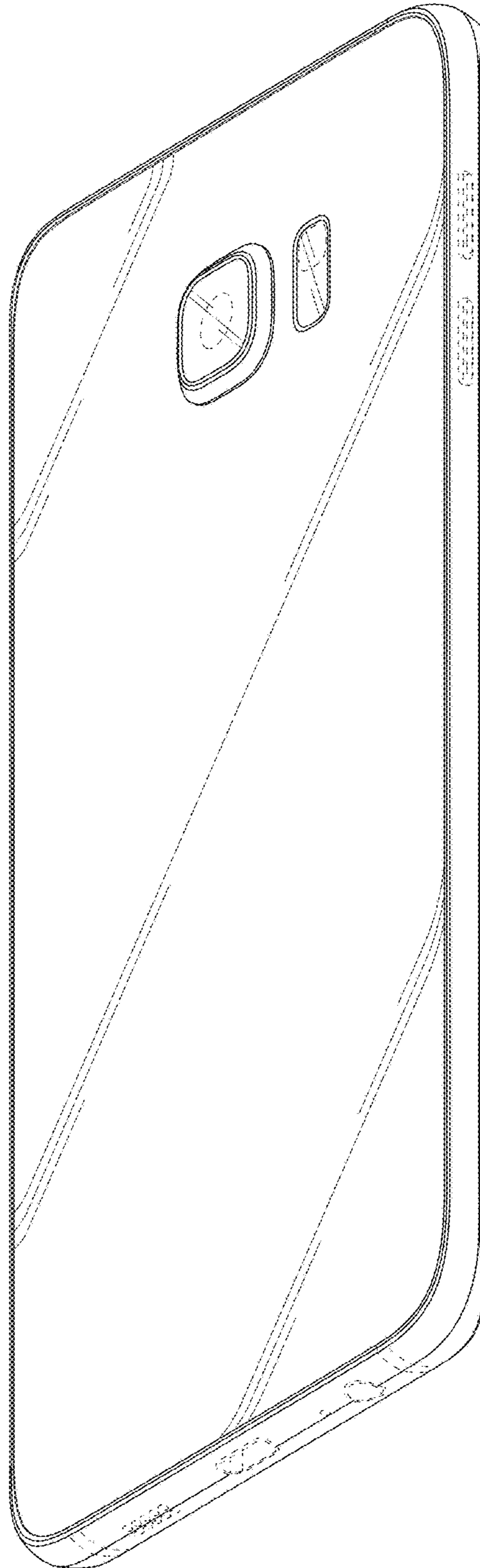

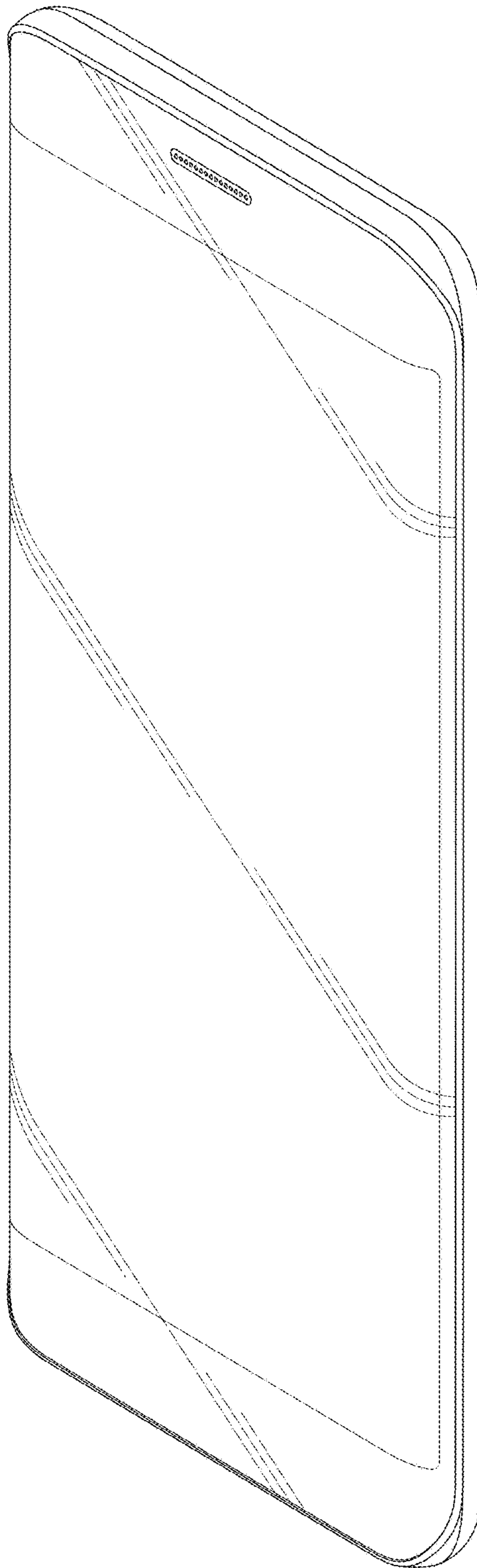

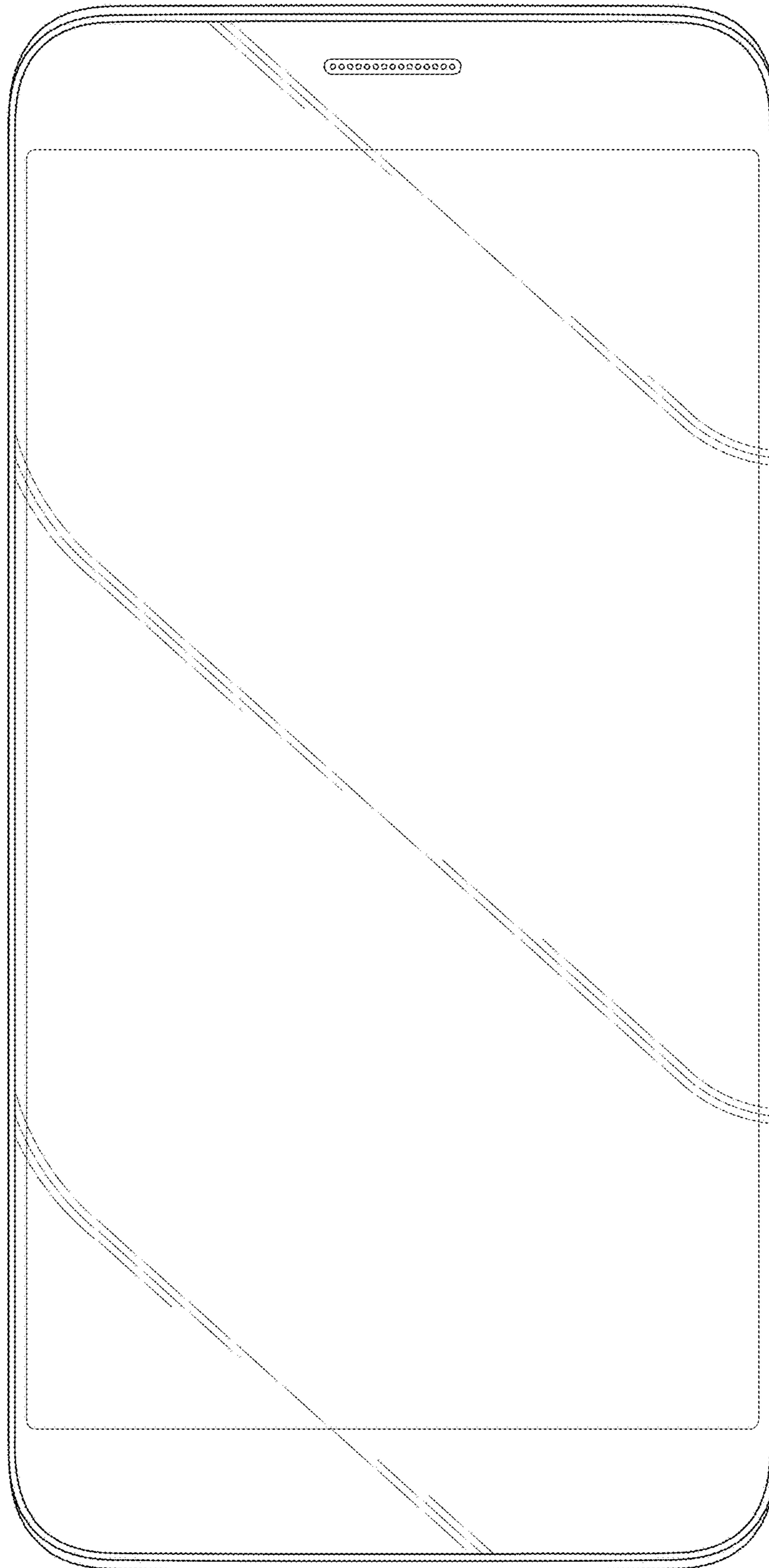

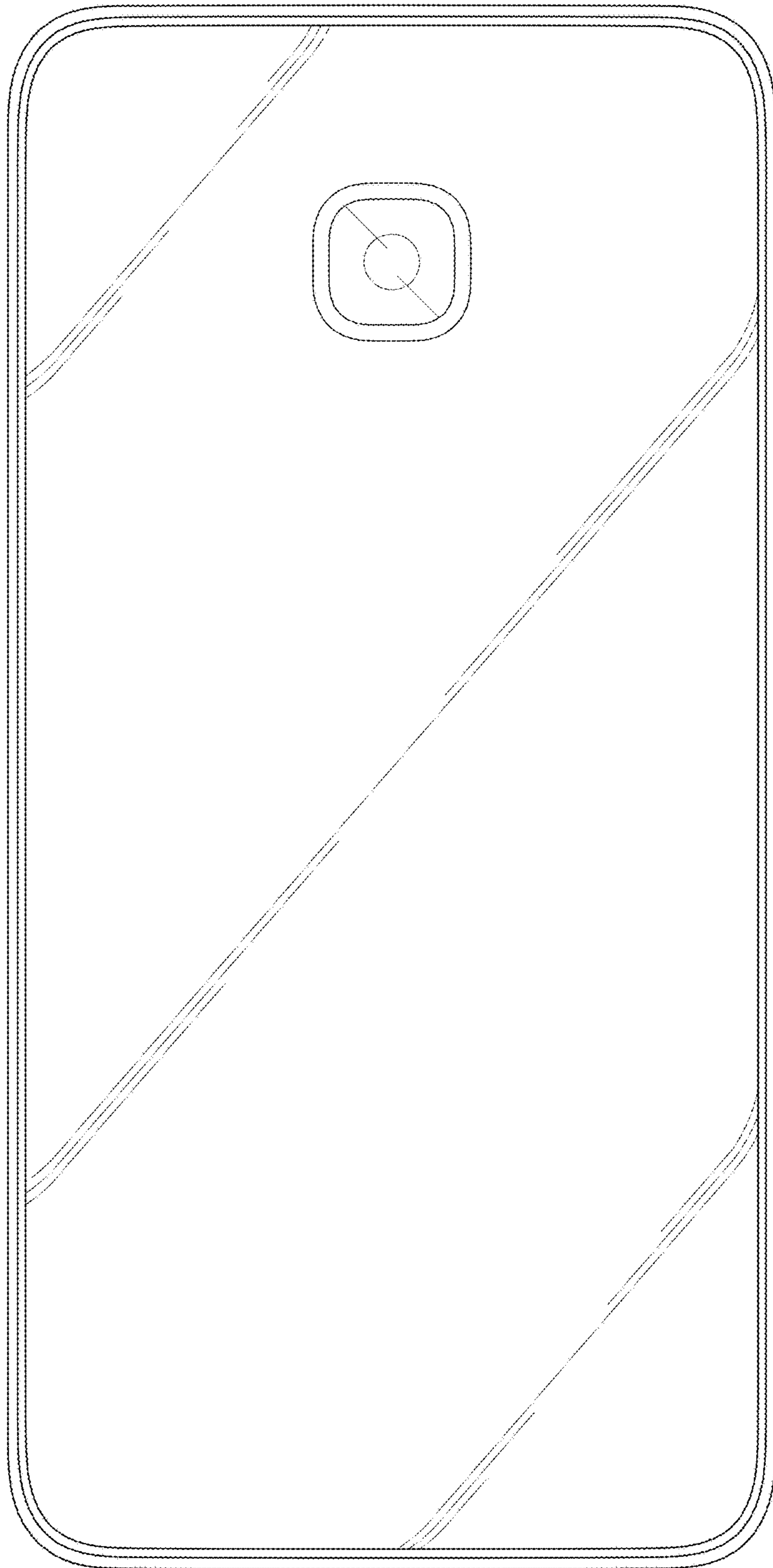

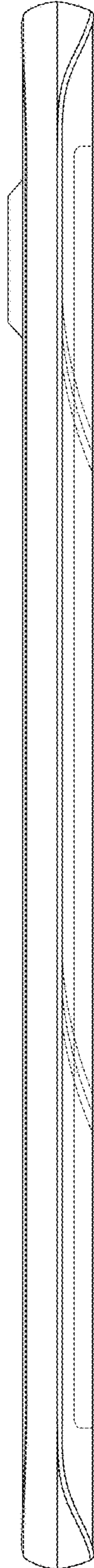

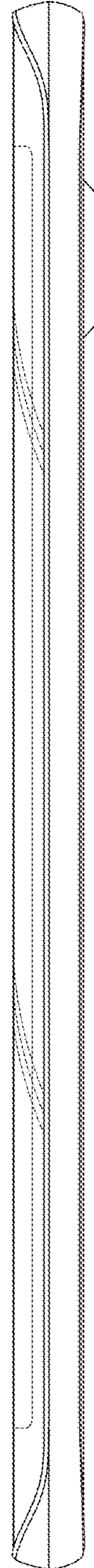

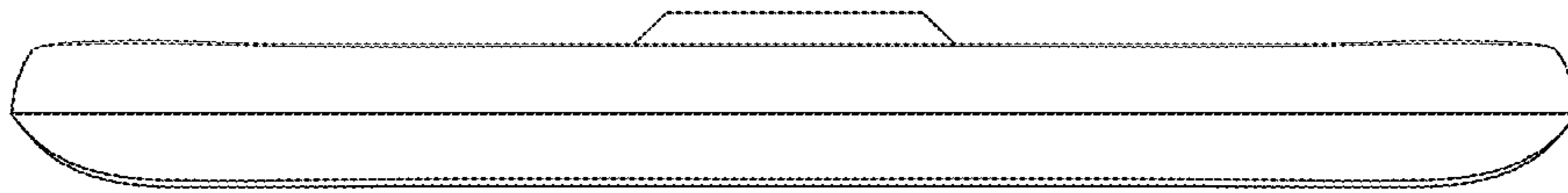

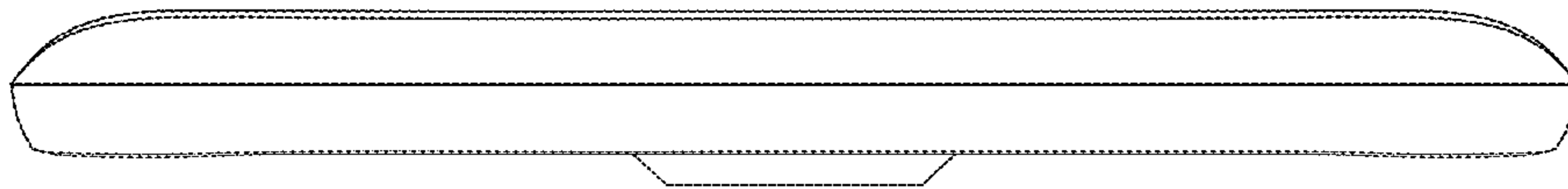
