FIG. 25 is a right side photographic view thereof;

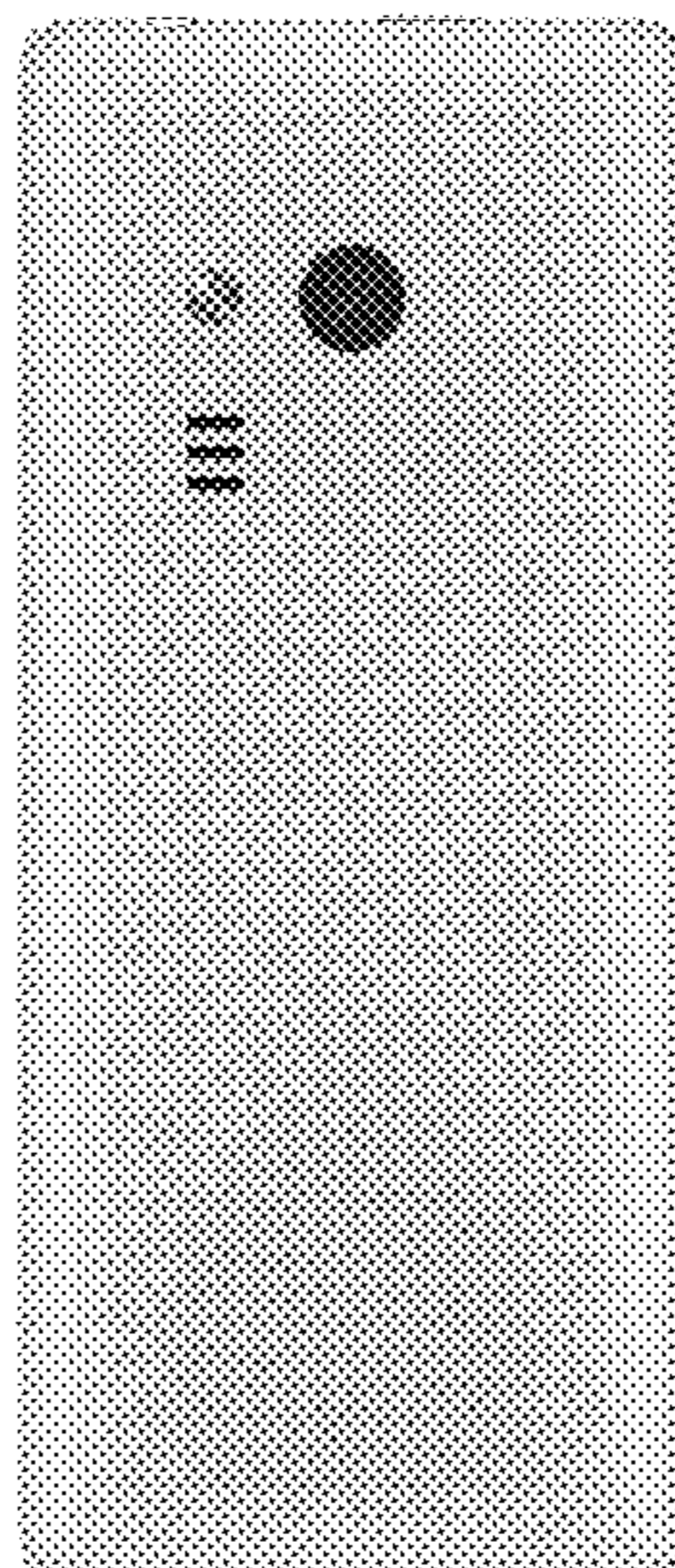
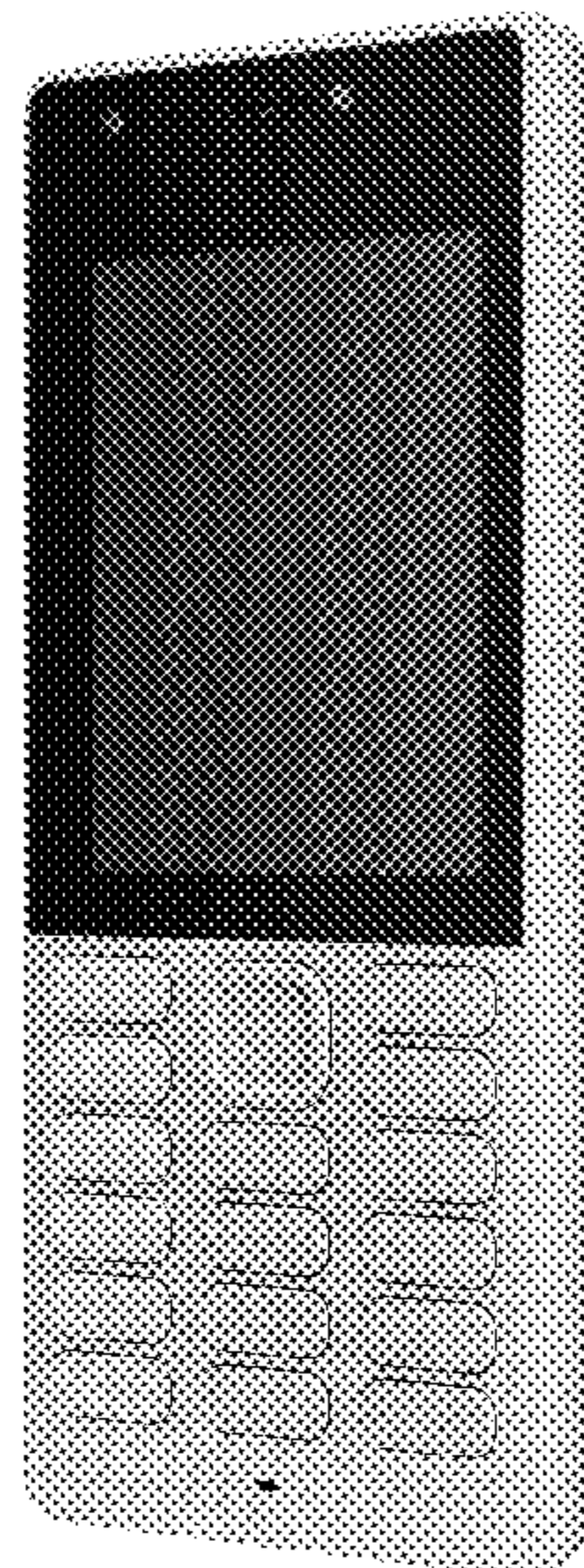
FIG. 26 is a left side photographic view thereof;

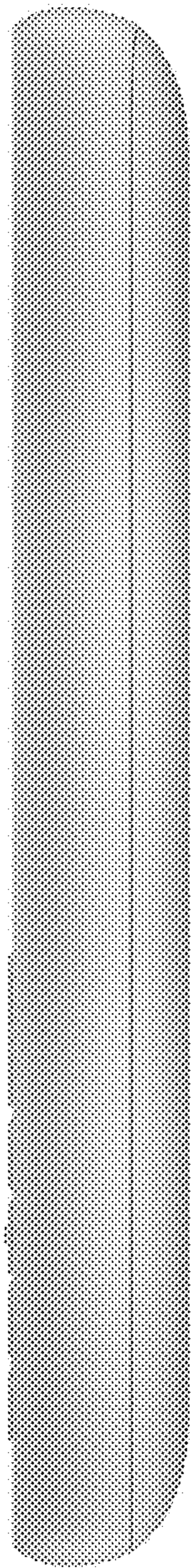

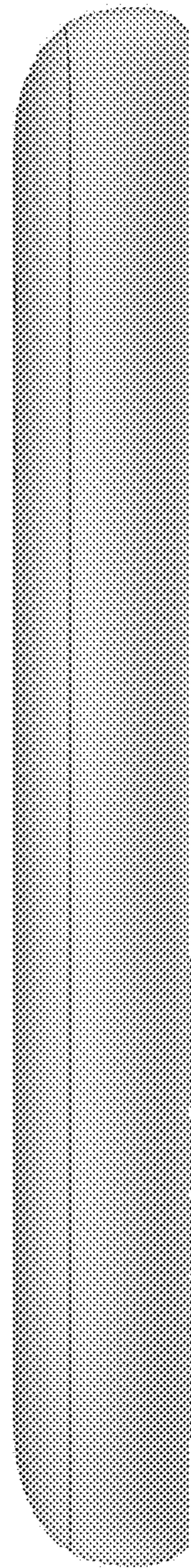

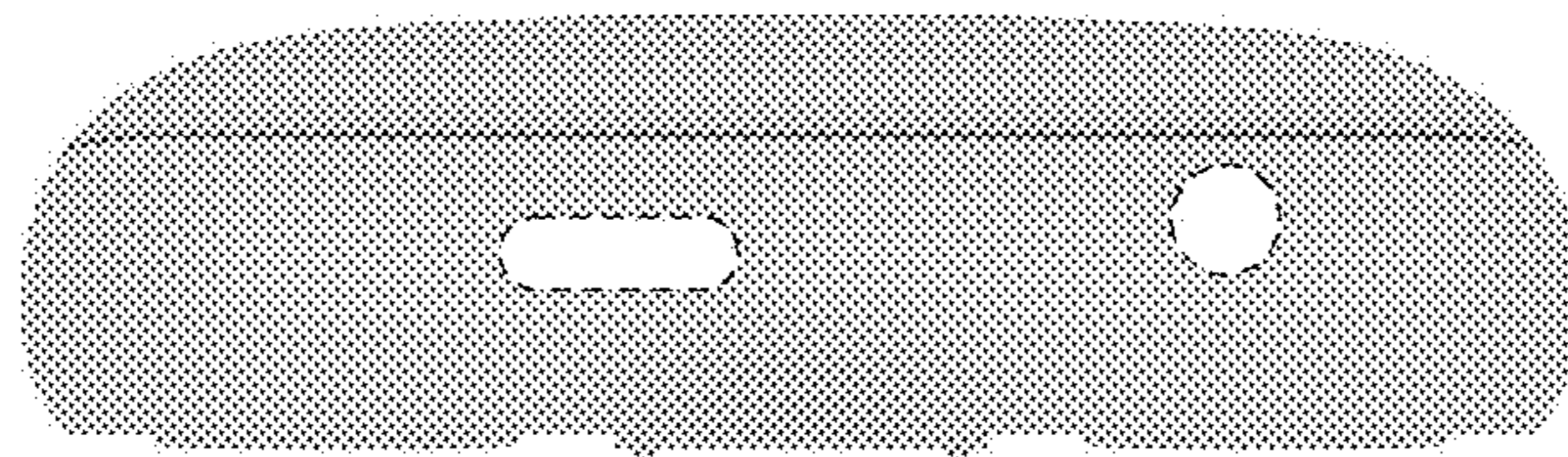

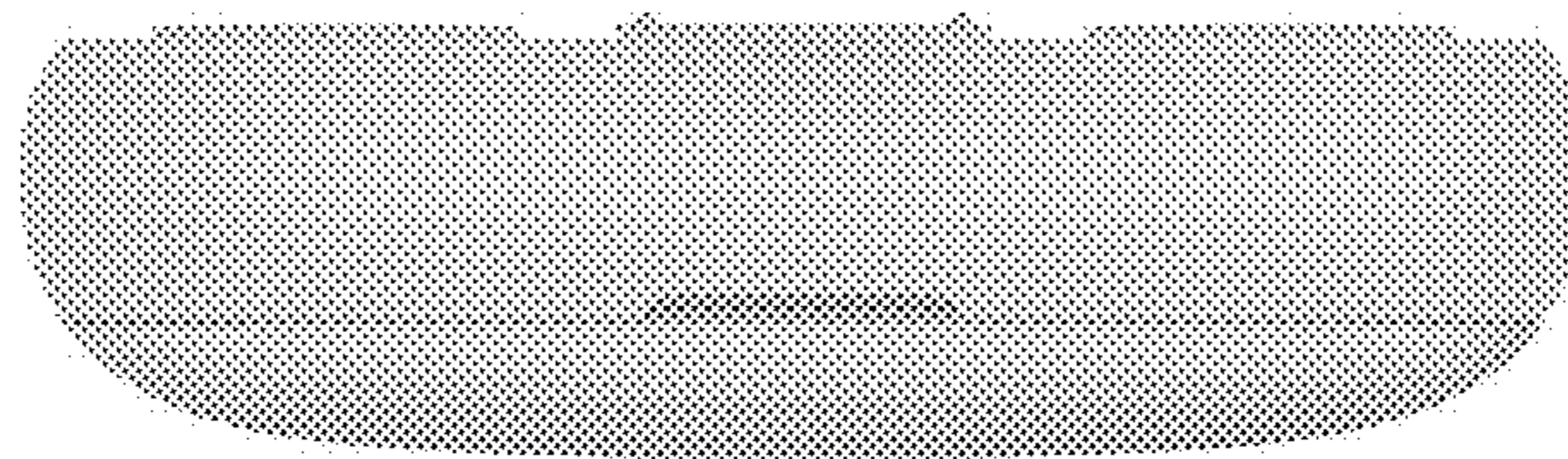

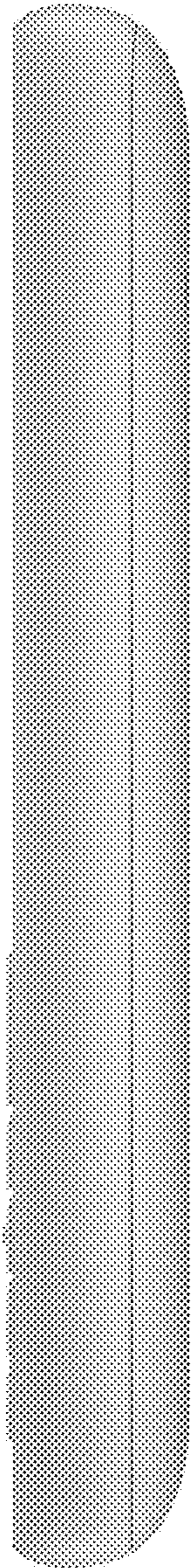

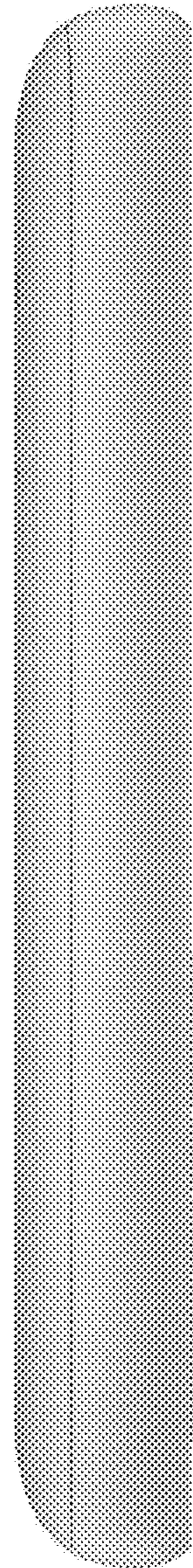

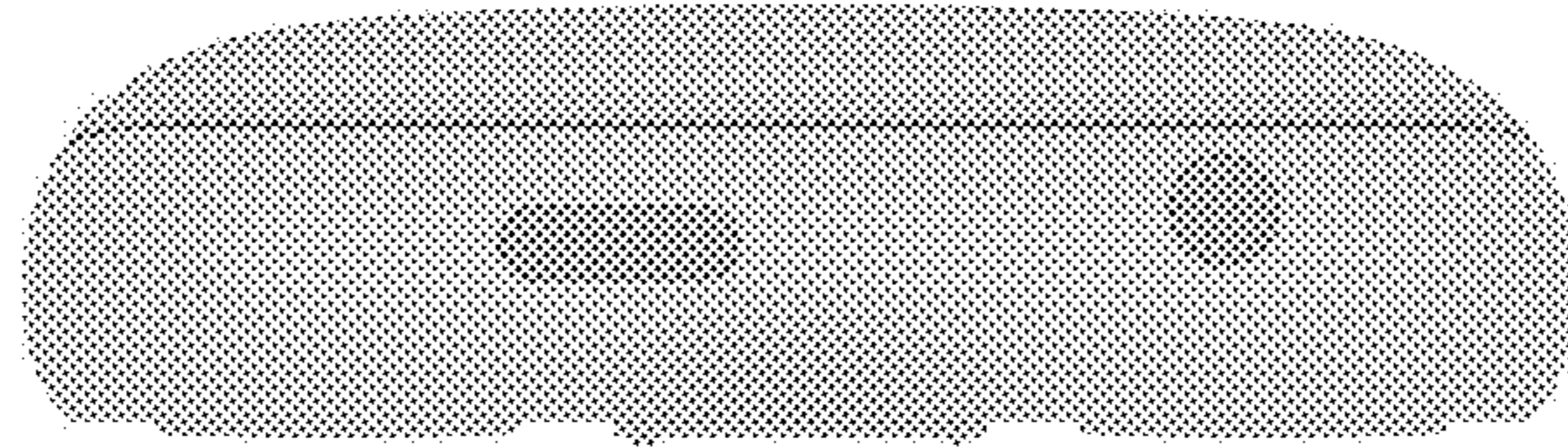

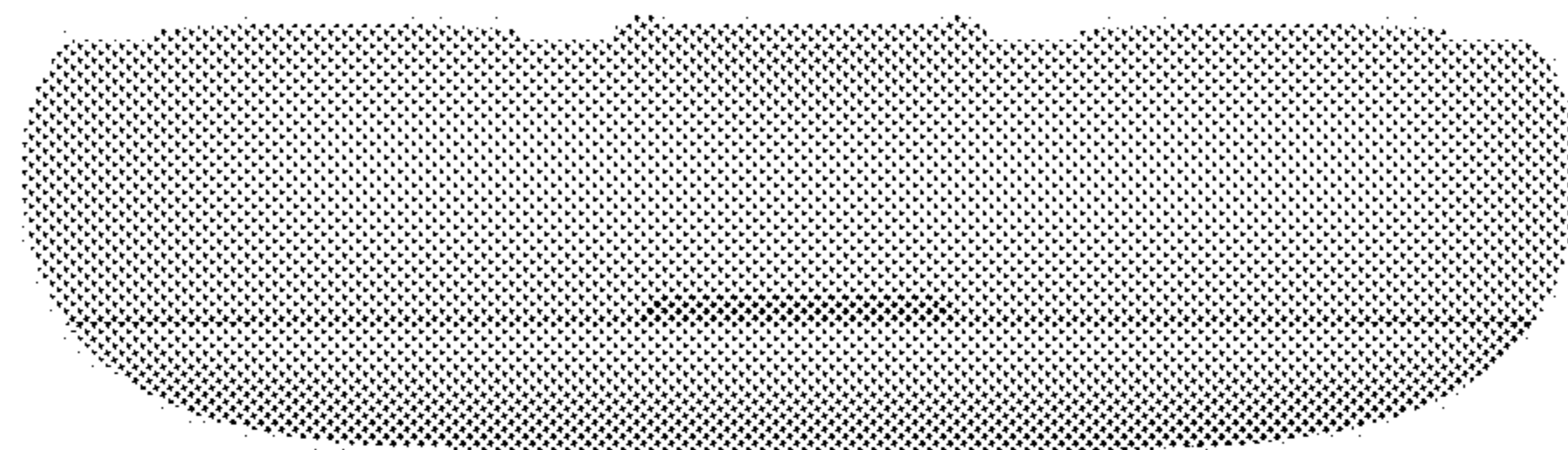

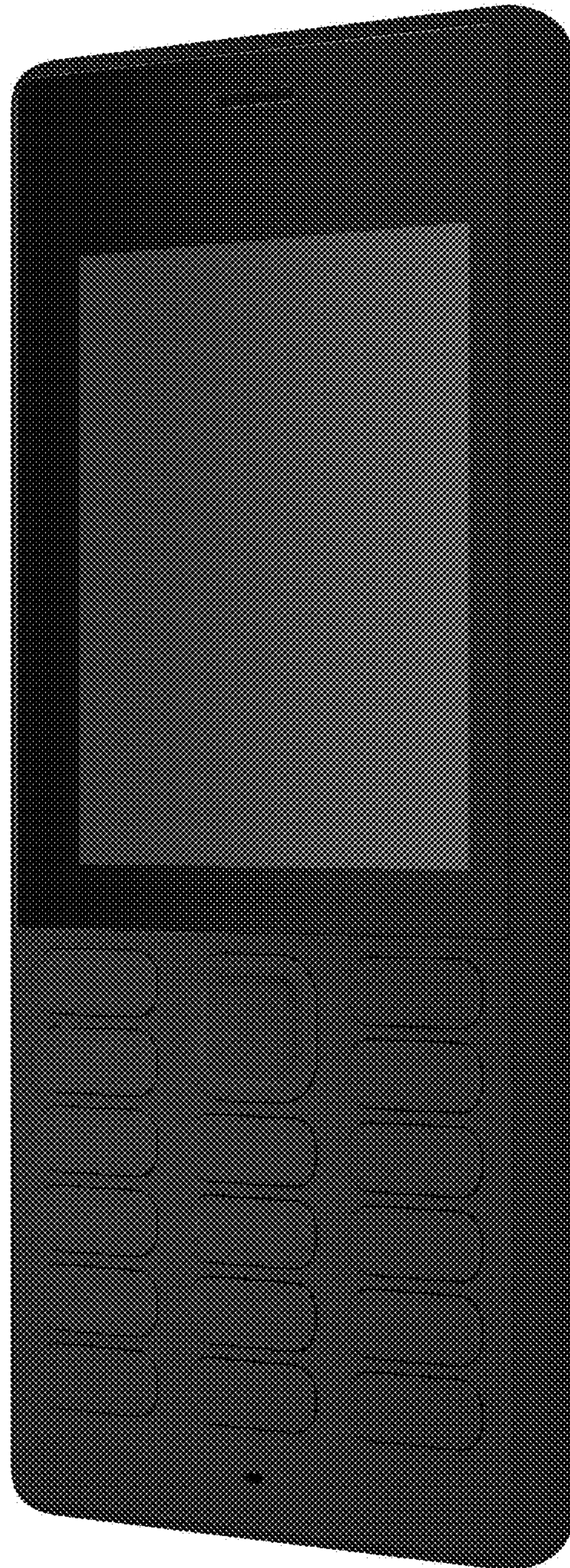

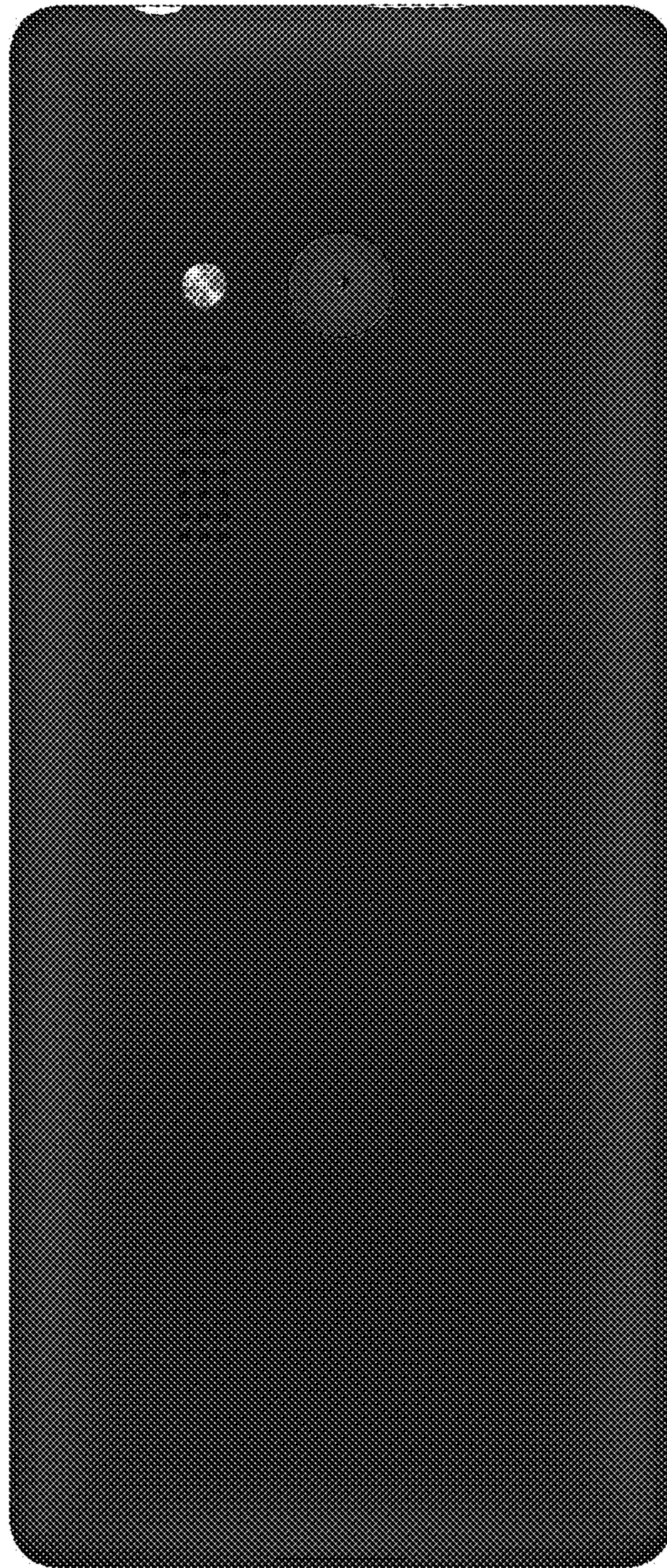

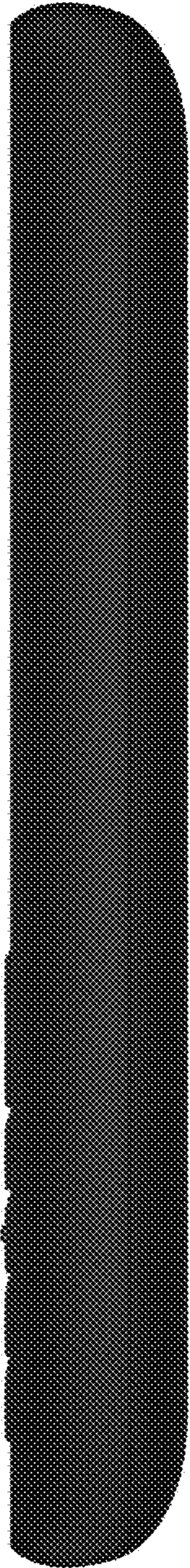

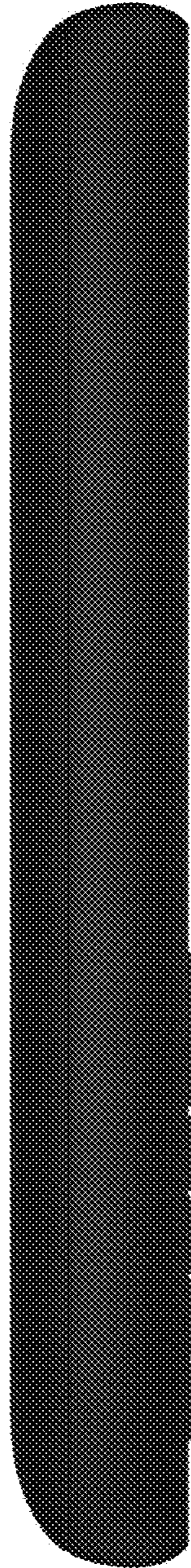

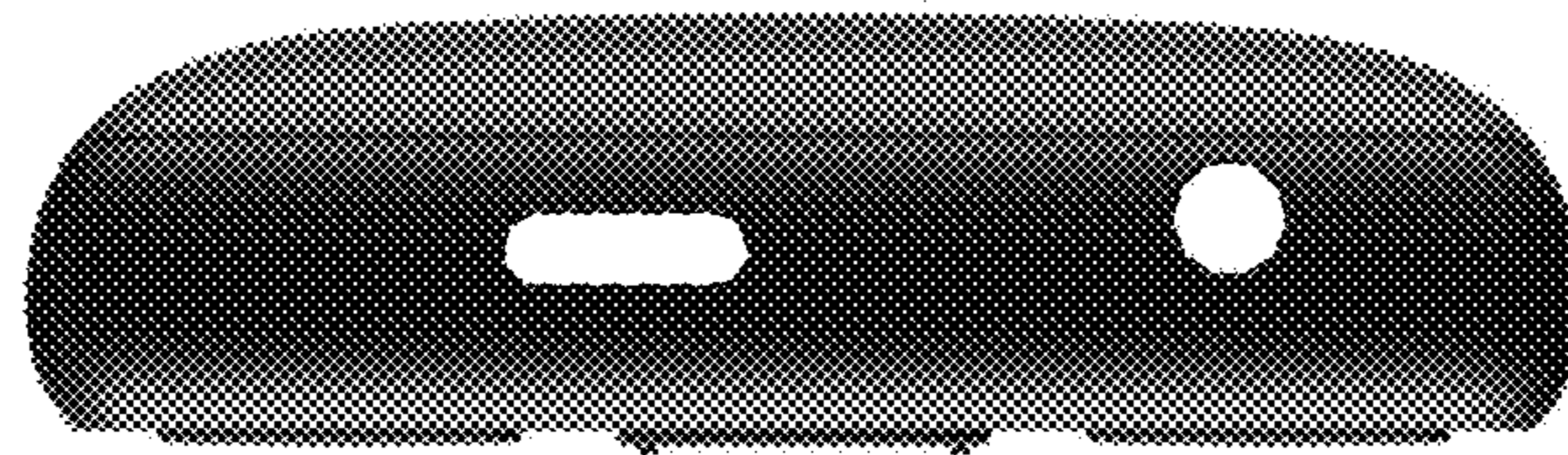

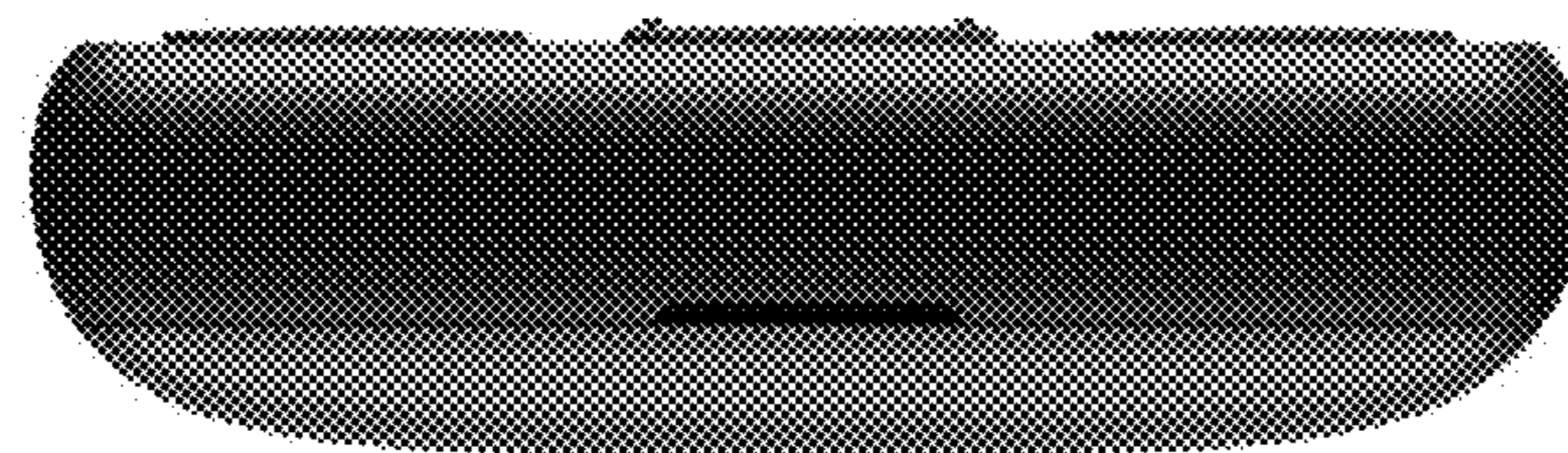

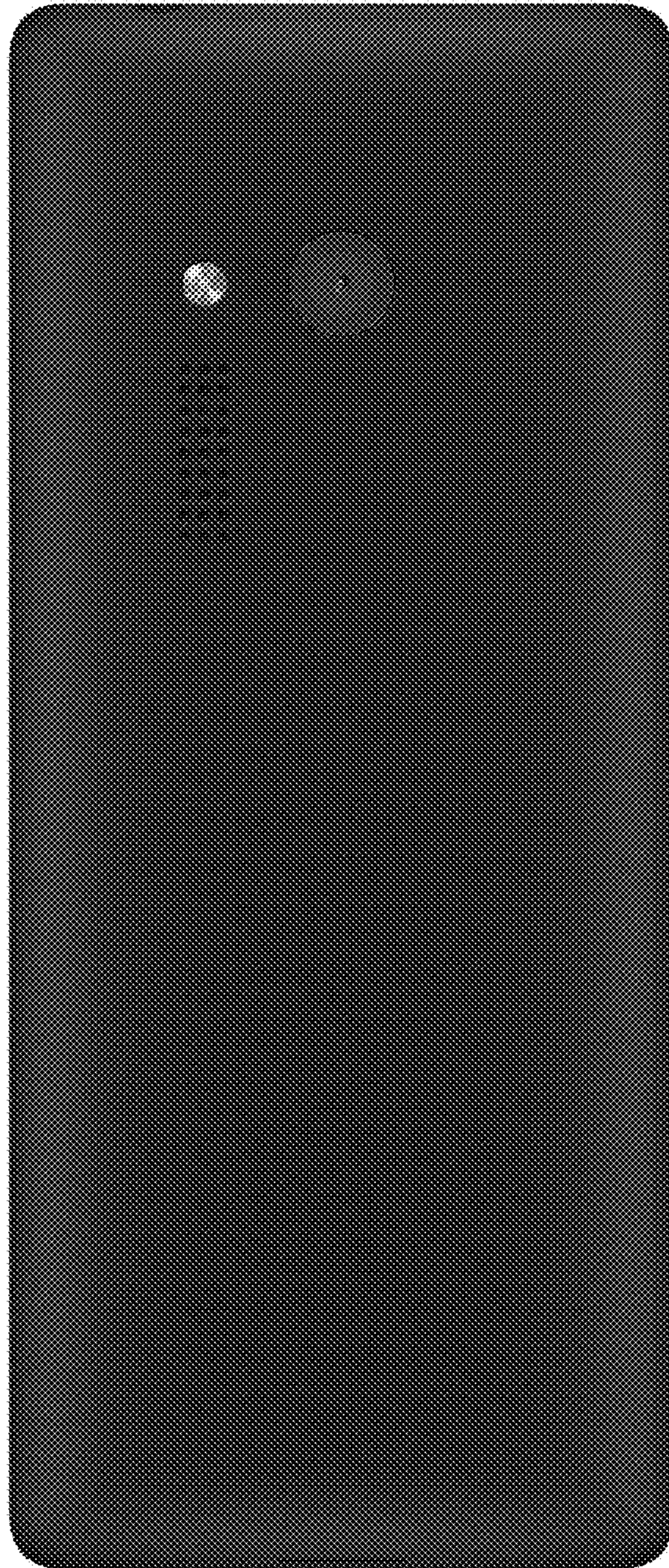

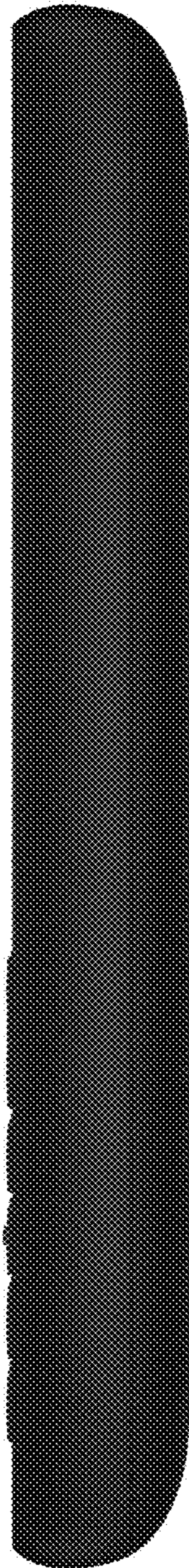

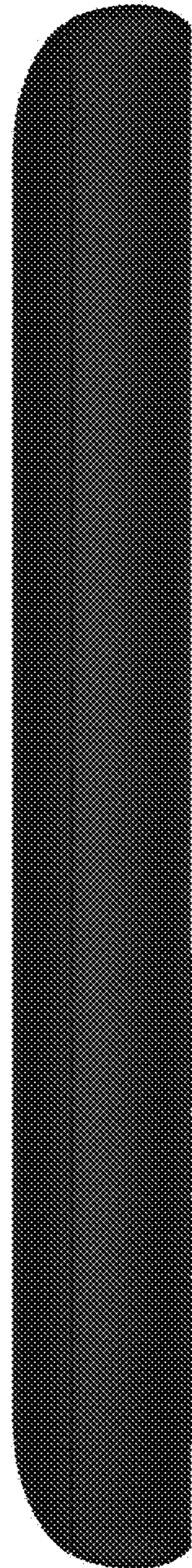

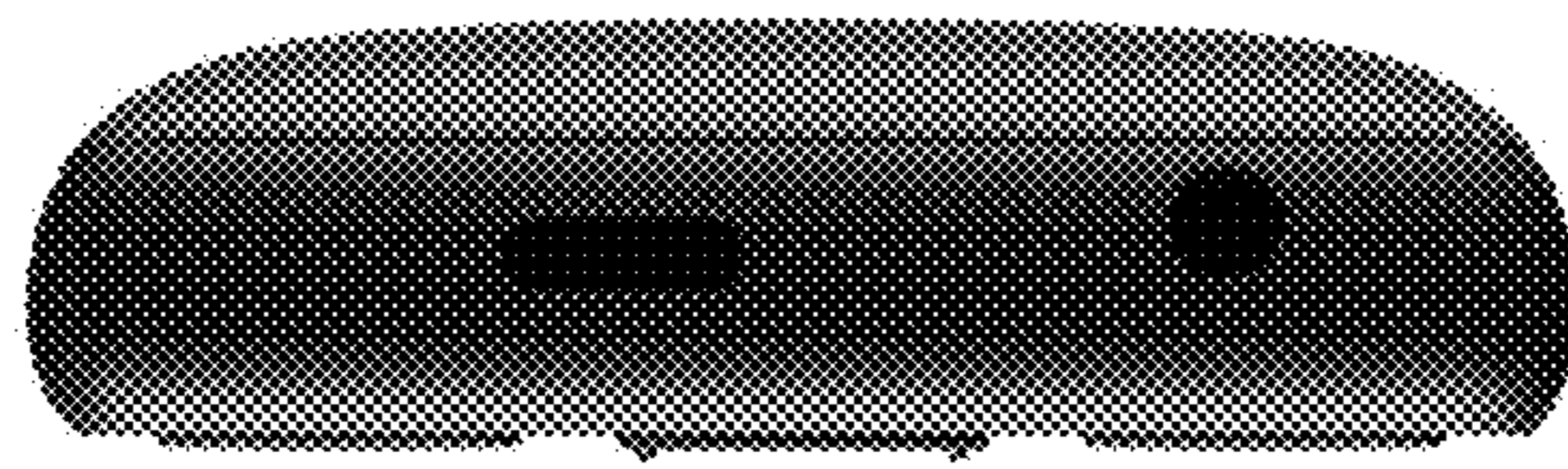

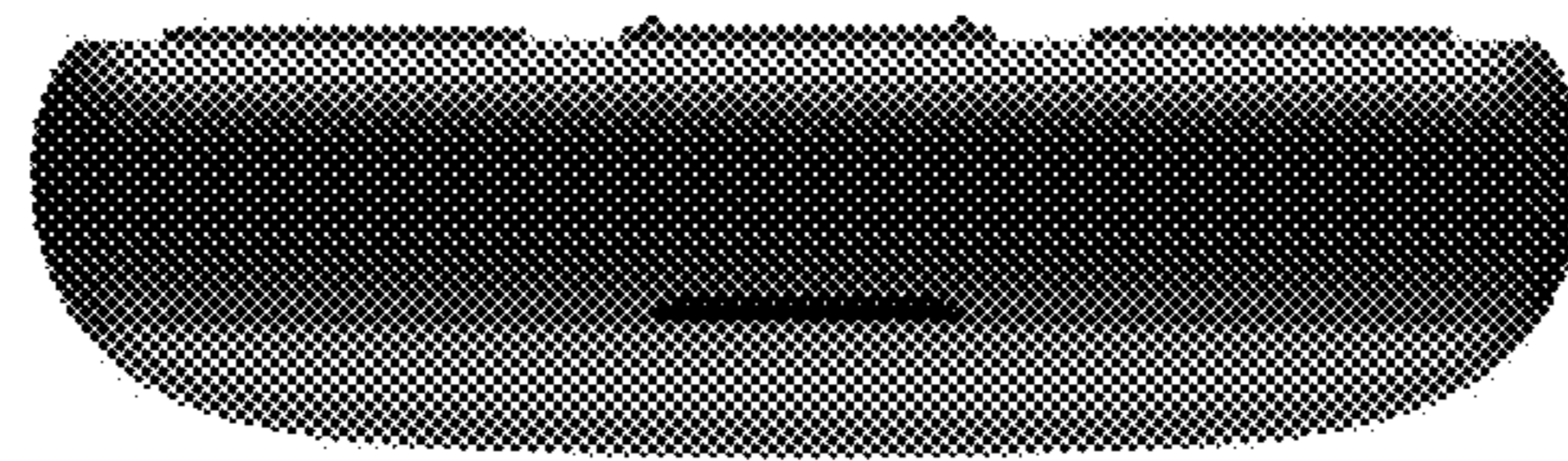
